AWAITING DEATH TO HEAR MRS. GRACE'S CASE

Prosecution Opposes Preliminary Hearing

CHANGE IN HIS CONDITION AWAITED

The Prosecution is Making Every Effort to Have Mrs. Grace's Preliminary Hearing Postponed Until a Decided Change Takes Place as Regards to Eugene Grace's Condition—Said to be Dying.

ATLANTA, Georgia, March 27.—On account of the condition of Eugene Grace, it is probable that the preliminary hearing of Mrs. Grace, which has been set in Justice J. B. Ridley's court for Thursday afternoon will again be postponed.

Reubin R. Arnold, with whom Mr. Hill is associated in the case, says that any attempt to hold the commitment trial before there is a decided change in Grace's condition will be opposed by the prosecution.

"Mr. Grace cannot get well," the attorney declares, "so, naturally any change in his condition will be for the worse. This means that he will die and when he does his widow will be arraigned not on a charge of assault with intent to murder, as the present warrant reads, but on a charge of murder."

Not a word of comment would Mrs. Grace make up on the statements given by her husband to The Journal representative in Newman Monday. She was seen for but a few moments in room No. 411, Kimball house. She was at the door bidding good-bye to John W. Moore, her leading counsel, who had spent two hours with her.

Mrs. Grace was attired in a blue Japanese kimono, which was decorated with white and red flowers. She shook hands with The Journal man, who accompanied her on the trip to and from Philadelphia.

RALEIGH, N. HENDERSONVILLE.—Charles McMinn, a poultry fancier of West Hendersonville, suffered the loss of one hundred and sixty thoroughbred White and Buff Orpington chicks yesterday morning at 3 o'clock by a fire originating from the lamp of a brooder in the chicken house and except for the heavy downpour of rain, would have probably lost his residence which was only fifteen feet from the chicken house, which was burned down. The house was enveloped in flames when the fire was discovered. The chicks were only a few days old and were highly prized by Mr. McMinn. Valuable goods stored away in the building were also destroyed.

CONDENSED NEWS FROM ALL OVER THE OLD NORTH STATE

Cleveland Democrats to Meet Monday.
SHELBY.—Chairman B. T. Falls of the Cleveland county Democratic executive committee has called a meeting here for next Monday for the purpose of fixing the date of the primary. At that time Mr. Falls will resign as chairman as he has announced himself a candidate for the legislature. It is not known who will be named as his successor. Mr. Falls has made a capital chairman and is responsible for the big majority his party lined up at the last election.

Worshippers Imprisoned by Falling Church

WILMINGTON.—During a severe windstorm which swept over the eastern section of the state yesterday Mount Rena, a negro church at Lane's Ferry, was blown down, imprisoning members of a large congregation of colored people under the roof, injuring a score of more severely but none seriously. A hole was cut in the roof as it lay upon the wreckage and all were dragged out.

Shooting Follows Ejection of Slayer From Deceased's House.

WINSTON-SALEM.—Hardy Brandon a negro, was shot and killed by another negro named John Burris, last night on North Liberty street, a bullet from a 44 caliber revolver taking effect in Brandon's abdomen. It is said that Burris had a quarrel with Brandon and his brother at the home of a Burris woman in a negro settlement and the Brandon boys put Burris out of the house. Burris went to his home and got his gun.

Death of Mrs. John A. Pugh.

GREENSBORO.—At Siler City yesterday, Mrs. John A. Pugh, mother of J. M. Pugh of this city, died of heart failure and infirmities of old age. The funeral was held today, relatives from here going down on the morning train. The deceased was 80 years old and is survived by two sons and three daughters. She was the relic of the late Capt. John A. Pugh, a prominent citizen of Chatham county.

MEAT PACKERS ARE FREED

NOT GUILTY OF VIOLATING LAW

AFTER A SEVERE LEGAL FIGHT THE CHICAGO "BEEF BARONS" ARE SET FREE

CHICAGO, March 26.—Chicago packers ended a ten year's legal battle with the government today when a jury in United States District Judge Carpenter's court found them not guilty of violating the criminal section of the Sherman anti-trust law.

Whether further investigations into the beef packing industry will be made District Attorney Wilkerson refused to say. He was overwhelmed by the verdict. He had been confident of convictions.

The verdict came after the jury had been out 19 hours. At no time during the deliberations were the packers in danger. Only three ballots were taken. The first was eight to four for acquittal, the second 11 to 1 and the third was unanimous.

Failure of the government to prove its case beyond reasonable doubt was responsible for the verdict, several jurors said. They did not review the exhibits in the case. The mass of figures and reports mystified them. To have attempted to untangle them would have been useless, it was agreed.

Men and Religion Movement.

HAMILTON, Ont., March 27.—Arrangements have been completed to launch the Men and Religion Forward Movement in Canada at a two days' meeting to begin in this city tomorrow. A dozen or more prominent evangelists and church workers from Canada and the United States will be included among the speakers.

Will Have Majority In Big Convention

Enemies of the New Jersey Governor Fear That Wilson Has Already Majority. Supporters of All Other Candidates United to Oppose Him

Wilson Only "National Candidate"

WASHINGTON, D. C., March 25.—The situation in the Democratic presidential contest has not been changed materially in the past few weeks except that lines then dimly discernible are now standing out in bold relief. The situation is that Woodrow Wilson is the leading candidate for the nomination; that the opposition to the New Jersey governor practically concedes that he will have a majority of the delegates when the Baltimore convention assembles and therefore, bases its whole hope on the two-thirds rule; and that the principal opponents of Governor Wilson, namely, Speaker Clark, Governor Harmon and Chairman Underwood are united in an alliance of desperation, hoping by their combined efforts to prevent Wilson's nomination on the first ballot.

The friends of Governor Wilson realize that they are not fighting opposing candidates but combination of opponents and the struggle between the New Jersey executive on the one side and the "allies" on the other side. A mere general denial of the existence of this "dreibund" does not dispose of the matter. It is obvious that no candidate would admit it, and it is entirely possible to form such an alliance without any direct negotiations.

Governor Wilson is a candidate in every state in the union. The allies have divided the field against him territorially and otherwise. For instance, in Texas, where the division of opinion between progressive and reactionaries is well marked, Clark and Underwood managers gracefully retire in favor of Governor Harmon. In Kansas, where the progressive sentiment is overwhelming, it was Speaker Clark who was pitted against Governor Wilson. In the neighboring state of Nebraska, where the Clark candidacy was announced as a progressive movement, the progressive Democrats requested the speaker's name to be withdrawn from the primary because the effect of his candidacy might throw the state to Governor Harmon.

In Georgia, Florida, South Carolina, Mississippi and other southern states Chairman Underwood alone opposed Governor Wilson—the erstwhile Harmon and Clark supporters going over to Underwood.

In other states, where the sentiment of the Democrats is supposed to be sharply divided between progressives and conservatives, the "safe and sane" Harmon is sent to the front.

Where it is a fight among progressives, the speaker is put forward. Where nothing but appeal to something outside the real divisions the realm of politics will suffice to weaken Wilson then Chairman Underwood is put up as a candidate in southern states as a southern man, the appeal being to sectional pride.

Farmers in Wilmington Great Damage at State Farm

Damage Done by the Late Rains in the State Farm at Tillery, Will Reach the \$50,000 Mark.

SCOTLAND NECK, March 27.—Reports from the flooded districts along Roanoke river, are to the effect that the damage caused by the freshet last week will be enormous. It is said that the damage at the state farm, at Tillery, alone will be more than \$50,000.

Those who have kept note of the freshets in the Roanoke river say that the one last week was the largest since 1877 and the gauge keeper at Weldon says that it was higher than at that time by several inches at the point.

Large areas of arable lands on the river will go uncultivated this year, because of the farmers not being able to prepare it for cultivation and some other because of the fear of another rise ruining the crops, the dykes along the river being broken in many places, thereby leaving the fields at the mercy of the waters.

Chicago Bench Show Opens.

CHICAGO, Ill., March 27.—The eleventh annual bench show of the Chicago Kennel Club opened in the First Regiment Armory today and will continue until the end of the week. Both in the number and high class of the entries the show this year surpasses all of the previous exhibitions given by the club. A special feature is the presence of Walter H. Reeves of London, England, and H. E. Packwood, president of the English Collie Club, who will judge a number of the prominent breeds.

Baltimore M. E. Conference.

BALTIMORE, Md., March 27.—The annual session of the Baltimore Conference of the Methodist Episcopal church convened in the First M. E. church in this city today, with Bishop Earl Cranston of Washington presiding. This afternoon the Womans' Home Mission Society held its anniversary meeting, which was followed by the conference sermon delivered by Dr. S. Parks Cadman of Brooklyn. The proceedings will continue until next Tuesday.

May Increase Capital.

NEW YORK, March 27.—At a special meeting called for tomorrow the stockholders of the American Agricultural Chemical Company will vote upon a proposal to increase the concern's capital stock by \$18,000,000 preferred and \$20,000,000 capital stock. Only \$6,000,000 of the preferred stock it is understood, will be issued at present. The proceeds will be applied to working capital.

Admiral Moore To Cavite

SAN FRANCISCO, Cal., March 27.—Rear Admiral C. B. T. Moore, recently detached from the command of the naval training station on Yerba Buena Island, sailed on the steamship Chiyu Maru today on route to the Philippines, where he is to become commandant of the naval station at Cavite and Olongapo.

AMENDMENTS BY SIMMONS

IMPROVE CAPE FEAR RIVER

SIMMONS ASKS FOR THREE HUNDRED THOUSAND DOLLARS FOR IMPROVEMENTS BELOW WILMINGTON

WASHINGTON, D. C., March 26.—Senator Simmons has been appointed a member of the subcommittee of commerce, to which the river and harbor bill has been referred. The subcommittee will take up the bill next Monday.

Senator Simmons today introduced in the senate a number of amendments to the bill, among them being an amendment providing \$500,000 for the beginning of work on constructing a harbor of refuge at Cape Lookout; \$245,000 to begin the work of improving the Chesapeake and Albemarle canal which the government has contracted to buy; \$300,000 for the improvement of the Cape Fear below Wilmington and \$30,000 for deepening the channel on Core sound by way of Harrot or Taylor slough route.

Joe Pogue, of Raleigh, believes the Malville bill, which would appropriate \$100,000 to provide for the encouragement of agriculture, horticulture and industrial exhibits in the various states will become a law either during this session of congress or the early part of the next. "If this bill becomes a law," said Mr. Pogue today, "it would mean so much to the farmers of the country. It would mean that the North Carolina state fair would be run on a larger scale and that the federal government would build a handsome building in Raleigh for the display of farm products."

Mr. Pogue says he believes all members of the North Carolina delegation in the house will vote for the measure.

COURT CONVENES IN CARROLL CO. VIRGINIA

Judge Staples, Massies' Successor Presides

NO MORE CAPTURES REPORTED

The Date of the Trial of the Captured Outlaws, Floyd and Victor Allen, Wesley Edwards and Byrd Marlow Will Probably be April 15th—Hearing on Motion to Attach Allen's Property.

HILLSVILLE, Va., March 26.—

With the twelfth day search for the fugitives, Allen outlaws, proceeding in the Blue Ridge mountains nearby, Judge Staples today opened Carroll county circuit court for the last day of the term so radically interrupted by the mountaineer gunners. The day's business was the clearing of the late Judge Massie's calendar and hearing arguments on motion of counsel for the Allen family to squash indictments on property belonging to the clansmen by relatives of the victims of the court house tragedy.

Judge Staples will empanel a grand jury tomorrow to return new indictments against all the alleged murderers. The date for the trial of Floyd and Victor Allen, Sidna Edwards and Byrd Mason will be set probably for April 15.

Detectives in the mountains reported today nothing further than that they had been close upon the heels of Sidna Allen and his nephews several times during the last day or two, and hoped to run them down soon. The posses' leaders think they will be able to starve out the outlaws by cutting off their communication with moonshiners and other friends.

Opens Campaign on April 12

Ex-Governor Aycock Has Announced Definitely That He Will Open Campaign in Raleigh April 12.

RALEIGH, March 27.—Ex-Governor Chas. B. Aycock will open his campaign for the United States senate April 12, in Raleigh's big auditorium. He has returned from Philadelphia where he took a special treatment the past month in a well known sanitarium there with a view to attaining full restoration to his old time health and strength, preparatory to getting into the campaign for United States senator that he will wage with Senator Simmons, Governor Kitchin and Chief Justice Walter Clark, of the supreme court, as his opponents. He is greatly improved in health and says that he will get into the race forthwith.

WITH OTHER EDITORS

REAL SAND-CLAY ROADS ALL RIGHT.

While discussions abound concerning the respective merits of sand-clay and macadam roads it is interesting to hear The Asheville Gazette-News assert that the road problem for most sections of Buncombe county has been solved, because a sand-clay road built through Beaverdam Valley meets every requirement and stands every test. The first section of this road was laid in December, 1910, and a second section was made the January-February following. It has been a good road since its first day. The terrific weather of last winter did practically no damage, it has never been either dusty or muddy in any considerable degree, and yet it has endured much heavy hauling from the very start. While automobiles play havoc with macadam, they positively benefit the sand-clay. "The sand-clay road leading from Grace up Beaverdam Creek," declares County Engineer J. C. M. Valentine in The Gazette-News, "is the best road in the county today". Mr. Valentine states that even the Biltmore roads, a model of macadam construction, have suffered heavily through the severe weather, whereas the sand-clay almost entirely escaped. The formula of this excellent road is given as follows: Six inches of sand and upon that a layer of clay three inches deep; on that four inches of sand; the whole finished with one inch of clay or gravel. It is stated that the gravel finish proved somewhat the better. Mr. Roland Wolfe, the supervisor of the road, says that to be kept in the best condition the surface should be dragged at a cost of about \$3 per mile each year. Regular dragging has not been practiced thus far. The belief is that with such care this highway would almost never wear out. And The Gazette-News editorially urges that sand-clay construction costs only about \$600 per mile, as against \$2,500 or more for the macadam type.

Experience had with another sand-clay road now building is suggestive of the causes behind many of the complaints we hear. "Mr. Valentine," it is stated, "said that considering everything this road is in good condition and that it would not be long until it would be in fine shape. The wet weather and the freezing caused a thorough mixing of the sand and clay, which was just what was needed, although he said some of the people became discouraged about the road and some said they wished it had been let alone as it was. They will probably sing another tune next winter."

All the condemnations of the sand-clay road which we ever heard came from people who had manifestly given it an incomplete or insufficient trial. In most cases they had not constructed a real sand-clay road at all, but had acted upon the assumption that any dumping of sand upon mud constitutes a construction of this type. In some other cases people who had little faith from the start lost that little by falling o make necessary allowances, as he Buncombepeople quoted by Engineer Valentine nearly did. For real sand-clay roads fully as good engineering service is needed as for the macadam type. Nor does it follow that because an engineer has built good macadam roads he has all the requisite experience for building good roads of other kind. We have been impressed with the fact that, notwithstanding the sand-clay type is comparatively a new invention, experienced road engineers everywhere pronounce well-built sand-clay roads good. They know what can be done, as the layman does not. Condemnation comes from people who have attempted the building of such roads without competent advice. Accustomed to placing faith only in rock, they generally made no more than half-hearted attempts at that.

There are sand-clay roads and roads called sand-clay roads which are not the type known to engineers. People who get the second kind complain. On its proved merits who ever it has had a fair trial the real sand-clay gains high favor and commends itself to all who seek an economical yet extremely serviceable road which endures severe weather and the conditions of modern travel as the far more expensive macadam does not.

Sir James Alfred Ewing.

Sir James Alfred Ewing, Director of Naval Education in Great Britain was born in Dundee, Scotland, March 27, 1855 and received his education at the University of Edinburgh. He engaged in engineering work until 1878, when he went to Japan to accept a position as professor of mechanical engineering in the Imperial University in Tokyo. He remained in Japan until 1883, returning to his native land in that year to become professor of engineering at the University College, Dundee. From 1890 until he became Director of Naval Education in 1903, he was professor of mechanism and applied mechanics at the University of Cambridge. The wife of the noted engineer is an American woman, the daughter of the late T. B. Washington of West Virginia.

West Indian Reciprocity.

OTTAWA, Ont., March 27.—Important and far-reaching results, affecting the commercial and manufacturing interests not only in Canada but of the United States as well, are expected to follow the conference begun here today between representatives of the Canadian and West Indian Governments, looking forward toward freer commercial intercourse between Canada and the British West Indies. It is the belief here that a small preference given to the West Indies by Canada over the United States would result in a few years in diverting to this country a large part of the American export trade with the islands.

The West Indian colonies represented in the conference are British Guiana and the islands of the Trinidads, St. Kitts, Dominica, Barbadoes, St. Lucia, St. Vincent, Antigua and Montserrat. Jamaica, the largest and the most important of the British possessions in the West Indies, declined to participate in the negotiations owing it is said, to fear of imperilling her extensive commercial relations with the United States.
