SITUATION IN MEXICO CITY VERY CRITICAL

WILSON ASKS FOR HELP

1,000 Rifles and 1,000,000 Rounds of Ammunition are Sent

WASHINGTON, D. C., March 31.—One thousand Krag-Jorgensen rifles and 1,000,000 rounds of ammunition were shipped by the United States Government on the steamer Monterey of the Ward line, which sailed from New York yesterday, to Henry Lane Wilson, the American Ambassador at Mexico City.

With the shipment of arms went a telegram from President Taft to Ambassador Wilson instructing him to distribute the arms and ammunition among those Americans in Mexico City who were able to bear arms and could be mustered to the defense of the American colony there in case of emergency.

In addition to the arms and ammunition the Government sent to Ambassador Wilson medical supplies, the the injured packages, lint, gauze. These supplies consisted of "first aid" bandages, etc.

NEW BERN, March 30.—The gunboat Elfrida, with Capt. Thomas C. Daniels in command and with a crew on board of 25 men of the naval brigade, came into port early this morning for the purpose of coaling up. During the past few days the Elfrida has been cruising around the waters of Albermarle and Pamlico sounds for the purpose of enforcing the laws in regard to fishing with nets. At one or two points the fishermen have been given until a certain time to take up the nets which they have down. They have promised to do this and trouble may be avoided. The boat will return tomorrow afternoon and remain until matters are in to the scene of the violations of the some way settled.

David Smith, an influential old colored man, recently came into possession of the property and went in person to the meeting of the ladies and presented the grounds to them to hold, improve and mark as they deem proper. The ladies accepted the gift and will take steps at once to beautify and improve this already too long neglected spot.

Supreme Lodge, Knights of Pythias Makes Change in Meeting Place.

WILMINGTON.—Capt. Thomas D. Mears, city clerk and treasurer and Supreme Master of Exchequer of the Knights of Pythias, has returned from New York where he went to attend a meeting of the officers of the supreme lodge, called for the purpose of determining the question of changing the meeting place of this year's convention from Fort Worth, Tex. It was decided to change the place of meeting to Denver, Col., on account of unsatisfactory railroad rates to Fort Worth and information as to the prevalence of contagious diseases in the latter city.

CONGRESS MAY FIX RATES ON ALL EXPRESS COMPANIES

CONGRESS MAY PASS ADAMSON BILL—TO CHARGE ACCORDING TO DISTANCE

WASHINGTON, D. C., March 31.—Democratic leaders of the House have planned out a constructive program of railroad regulation which they will make a part of the Democratic record here. An important step was taken today when the house committee on interstate commerce by a party vote, ordered a favorable report on the Adamson bill authorizing the interstate commerce commission to enter upon a physical valuation of the railroads of the country, a task which has been frequently urged, but which has always been discouraged on the ground that it will cost the government \$3,000,000 to do the work.

Another Adamson bill on the cards to be reported at the next meeting of the committee is the measure fixing the maximum rates for express companies on the following basis:

"Between any two points in the United States more than 2,000 miles apart, \$1.21.

"Between any two points not more than 2,000 miles apart, 75 cents.

"Between any two points not more than 1,000 miles apart, 50 cents.

"Between any two points not more than 750 miles apart, 35 cents.

"Between any two points not more than 500 miles apart, 25 cents.

Should this latter measure become a law it would materially reduce express rates from Washington, Richmond and other points to North Carolina points.

CLEVELAND, O., March 29.—President John P. White of the United Mine Workers of America issued today a suspension order by which 170,000 anthracite miners in the Pennsylvania fields will cease work at midnight Sunday and remain out until the differences between the workers and mine owners are settled or a general strike is ordered.

An hour later President White, together with District Presidents Fahey and Dempsey, sent a joint telegram to George F. Baer, chairman of the operators' committee of ten, in Philadelphia, asking for a further conference. Word was received here tonight from Mr. Baer that he would be glad to grant the request and another parley is now assured.

The suspension order was signed by the three district presidents and was formal. Had it not been sent, the men would have automatically quit, for the reason that their contracts expire at the close of the working day March 31. The document read:

The Suspension Order.

Suspension Order to All Anthracite Mine Workers: Your committee to whom was delegated authority by the Pottsville convention to negotiate a wage contract on the basis of the demands of said convention have up to this time been unable to do so, and inasmuch as the present wage agreement expires March 31, after which no contract is provided for governing wages and conditions of employment, therefore, all mine workers except engineers, pump men, firemen, stablesmen, watchmen and such other men as are absolutely necessary for the proper protection of the property, are hereby instructed to suspend work, beginning April 1 and remain idle until further notice."

N. C. Woman Lawyer Assigned to Defend Negro

New York, March 30.—For the first time, so far as is known in the legal history of the country, a woman lawyer today was assigned as chief counsel to defend a negro accused of murder. The attorney is Miss Lucile Pugh, more than ordinarily good looking and a member of the exclusive Pugh family of North Carolina. The person she will defend is Leroy Poindexter, a negro who was arrested for shooting to death Thomas Brown, a white man, on March 7, after a dispute growing out of a crap game. Poindexter also came from North Carolina, where it is said he once worked for the Pugh family.

When arraigned before Judge Swann, in General sessions, today, Poindexter pleaded not guilty and announced that he had no money to employ counsel. Judge Swann sent

for Miss Pugh and asked if she would undertake the case. She consented and was formerly assigned, the assignment carrying with it a fee of \$500 from the State. She then formally entered the plea of not guilty.

NICE BEEF CATTLE.

Shipment Made by Mr. O. L. Joyner From Ingeltarra Farm.

We have heard the remark made that Pitt was not a good stock raising county and that the heavier grade of beef cattle could not be successfully raised here. That the contrary is true has been demonstrated by Mr. O. L. Joyner, proprietor of Ingeltarra farm two miles from town. Mr. Joyner has engaged quite extensively in stock raising with an eye to the best breed and has as fine a herd of Hereford grade cattle as any section can show. Last Friday he shipped a carload of steers to a butcher in Raleigh. The ages of the steers was from two to three-and-half years and several in the lot weighed from 1200 to 1300 pounds. It strikes us that it takes fine beef cattle to grow that weight in three years.

City Election in Chicago.

CHICAGO, Ill., April 1.—The polls at 6 o'clock tomorrow morning for what is looked upon as one of the most important elections held in Chicago for some years. Keen interest is displayed in many of the thirty-five wards, each of which will elect a member of the new city council. Reform organizations are putting forth their usual efforts to defeat the candidates who are believed to have personal gain at heart rather than public good. In addition to electing aldermen the voters have an opportunity to pass on a \$9,000,000 bond issue.

General Buckner's 89th Birthday.

Simon Bolivar Buckner, formerly governor of Kentucky and now the only remaining corps commander of the Confederate army, received today many of his friends who called to congratulate him in his eighty-ninth birthday. Still hale and strong for his age, Gen. Buckner entertained his visitors with old time hospitality and responded to the toasts in the usual happy style.

Ready For Cotton Men's Meet

WASHINGTON, D. C., April 1.—Delegates have begun to arrive for the sixteenth annual convention of the American Cotton Manufacturers' Association which will open here tomorrow for a three day session. At the headquarters of the convention, in the New Raleigh, everything is in readiness for the reception of the visiting delegates. It is expected that every one of the cotton producing states will be fully represented. Among the features of the entertainment program is a visit to the White House on one of the afternoons.

CLOSING IN ON ALLENS TO ARREST SIDNA ANY HOUR

WILL SHOW NO MERCY WHEN FACE TO FACE WITH ELDER ALLEN MAN

HILLEVILLE, Va., March 30.—With detectives close on the trail of Sidna Allen the ring leader of the Allen clansmen and his nephew, Wesley Edwards, known hereabouts as a dangerous man, the prospects tonight were that before day break the two outlaws would be captured, dead or alive and the entire band who ridled with bullets the Carroll county courthouse killing five people and wounding two others, would be in the hands of the law to await trial for murder.

Early today the posse under Detective Thomas Felts, got a definite clew of the remaining outlaws' whereabouts. Newly turned tracks in the rain-soaked mountain side about fifteen miles from here and in the vicinity of Floyd Allen's home, were discovered. They led back to a crevice overgrown with ivy and laurel, where a cover of leaves laid over scraps of food gave unquestioned evidence of the outlaws' last hiding place. A receipt for seventy dollars made out to George Obter, a resident of this section and signed by Sidna Allen, lay near, apparently having dropped from Allen's pocket. The detectives believe the men had left the place not more than an hour before the posse discovered it. The approach of the posse, some think, caused the outlaws to flee further into the mountains.

FIGHTING IN STREETS

ROCKINGHAM OFFICERS IN GUN AND CLUB FIGHT

LINESMEN START A RIOT

Blind Tiger Whiskey Sets Linemen Crazy and Attack Officers Who Oppose Them

ROCKINGHAM, March 31.—A pistol battle occurred on the streets of Rockingham at 8 o'clock tonight between several linemen in the employ of the Yadkin River Power Company and the local officers and as a result of which Deputy Carl C. Shores is seriously shot, Deputy Sheriff Martin Brown is shot in the left hand and Lineman George Hinson is wounded twice in the neck and in the lower part of the body. Three of the linemen as in jail with their heads more or less severely pommelled by clubs in the hands of the policemen. The linemen have been in Rockingham constantly for the past three weeks overhauling the electric light plant lines and poles recently purchased by the Yadkin River Power Company from the town of Rockingham, getting ready for the current from Blewit Falls, which was turned into the city wires today. The linemen some dozen or more in number, have encamped on the outskirts of the town and have been right much of a nuisance on account of boisterous and rowdy conduct. Today Downey & Wheeler's circus showed here, drawing the usual crowd, and there was much drinking of blind tiger liquor and considerable drunkenness on the part of whites and blacks.

Attempts Life of Sen. Gore

Crazy Foreigner Makes an Attempt on Life of Oklahoma's Blind Senator—Was Delivering Speech in Waukesha, Wis.

WAUKESHA, Wis., March 30.—Senator Gore, of Oklahoma, narrowly escaped death this afternoon when a crazed Pole, Charles Schomulk, attacked him with a club while the Senator was speaking. The pole was sitting near the stage and in the midst of the Senator's speech suddenly leaped to the platform, drawing a club from under his overcoat, as he jumped and swung instantly at the Senator's head. One of the men on the stage, Judge P. C. Mamlin, was quicker than the maniac, however, and knocked Schomulk off the stage before the blow landed. The Senator, who could not see his danger as unaware of the incident until later.

THE FARMER IS TIRED FROM HIS KNEES DOWN.

But There is Nothing Tired About His Brain—And the Editors That Talk to Him Have the Most Intelligent American Audience—It Would be Well if Editors Could Learn From Farmers Some of the Modern Methods of Self Protection and Combination.

Homer Davenport, known to millions of Americans for his cartoon work, understands especially the people that live in the country.

The man who lives in the country sees the sky and the rising sun and watches the passing seasons has a brain better fed than the city man who lives on cobblestones and scarcely knows the difference between moonlight and electric light.

In Chicago two days ago Davenport was discussing with the well known "Buffalo Jones" and some others the different kinds of American citizens.

"People not raised on the farm don't realize," said Davenport, "that the farmers do the thinking and the clear thinking in this country.

"Ignorant city folks think of the farmer as an exhausted man at the day's end too tired to think.

"The farmer may be tired from his knees down and he generally is, when in the evening he gets off his boots and has a few minutes rest.

"But from the eyes up he is not tired. His is the brain that takes a wide view of public questions, just as it takes a wide view of the fields and the sky and that is the man worth talking to."

Davenport said this in discussing the importance of local newspapers read especially by the farmers that produce the national wealth.

The local editors of the country are to be congratulated that they, to a large extent, stimulate and direct by their presentation of facts and ideas the most important thinking class in America.

Until very recently the farmers of the country, like the local editors of the country, suffered from lack of combination, of modern methods and they lacked their share of prosperity.

For nearly a generation past there has been in the country a feverish rush of organization, co-operation, elimination of waste, economy of production, use of byproduct.

In ten thousand ways intelligent big workers have made their efforts more remunerative to themselves, more economical in methods, greater in productive capacity.

The story of this organization, co-operation and greater reward is familiar to every editor.

Unfortunately the local editors of the country, the most useful and in the masses by far the most powerful, have not done their part for their own benefit in the work of com-

bination, organization and higher profit.

The farmers were among the last to adopt these modern methods, for they live scattered and isolated, as in a sense, the local editors live.

And they, the farmers, for many years and many centuries had simply competed with each other, carrying the heaviest load and getting the poorest reward.

But at last, the change
But at last, happily, the change has begun in the lot and in the methods of the farmer.

Various granges and political organizations have shown the farmers' realization of the power of co-operation.

Various farmers' plans for co-operative marketing, seen in the case of the fruit dealers and others; the plans for withholding entire crops for good prices and "modern methods" show that the farmer is not contented any longer merely to fight against his neighbor farmer and let the whole world stand at his back.

The farmers' thoughts and methods are becoming, luckily, as modern as the gangplow, the reaper and the automobile that replace old fashioned tools.

And one great consolation in the high cost of living so much deplored is the fact that part of this high cost of living comes of the farmer's determination to have a decent reward for the work that he does.

The high cost of living is due in part to the fact that the farmer no longer practically gives away his crops, no longer lets them rot on the ground as used to happen in old days of burning corn for fuel or losing the apple crop because it would not pay for the barrels.

The higher cost of food means that the farmer is getting something for the food he produces. And seen from that point of view the high cost of living is welcome since it means that good pay and prosperity are no longer the exclusive possessions of merchants, middlemen, jobbers, bankers and high priced union mechanics. The farmer's intelligence at last is giving him his share.

Lieutenant Governor, W. C. Newland, of Lenoir, who has been prominently mentioned as a candidate for governor in the present campaign, announces that he will not present himself for the nomination, giving as a reason that he thinks Hon. Locke Craig, of Asheville, is entitled to it by acclamation. Mr. Newland's action is commendable, in that it ruins the possibility of a fight in the state convention for the nomination. I also puts him in line to be honored with the nomination by acclamation four years hence.

Here is Bob Phillips of the Greensboro News, talking about pie, turnip greens, corn dumplings, et cetera, and right in the same column inquiries for the old fashioned folks who used to keep fast. What's the matter with Bob, anyway? He ought to know that such tempting things and fasting do not go together.

A Democrat From Dixie

The Augusta Chronicle is very anxious to have "a Democrat from Dixie" nominated for president of the United States.

Certainly; why not? We like the won't have to go far to illustrate its admirable suggestion. During the war between the states we have the picture of the village pastor surrounded by the Telfair square of elms and oaks. There were suffering and privation in that community, as there were in all southern cities. Yet the good preacher and his faithful wife prayed and worked with the people, burying their dead who were brought home from the war, comforting the afflicted and binding up as best they could the broken hearts. And then came the era of reconstruction, following, like blackness, the fierce blast of war, and "the time which tired men's souls." We still have the picture of the sturdy minister and his gentle wife visiting and ministering and petitioning in Augusta just as the good Bishop Elliot did and the sanely Dr. Axson did in Savannah.

Then there was the only son, thoughtful and studious, sharing in his young heart the sadness and pity of it all, and wondering what it was all about; trudging to school learning lessons of sympathy and love for the south, which follow him to this day and which have made him port and parcel of this people. Then we watched him go to school in Columbia S. C., and Wilmington, and finally apply for a college degree at Davidson, in the Old North State, the Presbyterian school which has turned out ministers' sons for generations. Then we saw him as his career broadened out, graduated from the University of Virginia and John Hopkins, all southern colleges, until a big northern university claimed him first as preceptor and then as president—a most unheard of thing to reach down in the heart of the south and select for one of its oldest and proudest institutions this "Democrat from Dixie." But the lesson learned in the old Telfair grove in Augusta and the suffering witnessed among the people there are shows which wily by him still. His instincts are southern, this young

Democrat from Dixie; and in spite of the environment at Princeton he went to work to democratize this great institution, and then he began a broader campaign of education among the people of his country.

Born in Staunton, at the head of the Valley of Virginia, where Stonewall Jackson rode and prayed and fought, walked sturdily through life, not this young Democrat from Dixie raw and sectional ever, but broad and Democratic always. As the ideal Democrat from Dixie we offer the Augusta Chronicle an Augusta boy, Woodrow Wilson, who probably spelled out his first lesson of Democracy from the pages of that good old paper, as he used to sit upon the steps of the Presbyterian manse in the early 70's, watching the sunlight and the shadows in the old church yard on Telfair street. A Democrat from Dixie? Yes, every time.—Savannah Press.

Sergius Rachmaninoff.

Sergius Vassilievich Rachmaninoff, the celebrated Russian composer, was born in the government of Novgorod, April 1, 1873. His musical instinct was discovered at an early age and carefully developed. When he was nine years old he was sent to the Conservatory of St. Petersburg, where he studied the pianoforte under the best masters. In 1891 he was awarded the highest honors as a pianist and in 1892 the highest honors in composition, the gold medal of honor for his opera "Alecko." He then traveled for some years and gave many concerts in Russia. In 1899 he visited London at the invitation of the Philharmonic Society. In 1902 he appeared at Vienna as a pianist and in 1907 he was appointed first conductor at the Imperial Theatre of Moscow and it is said that he accepted the position with the condition that he should conduct only Russian op-

eras. In 1906 he resigned the position to devote himself to composition and has since made Dresden his home. In 1909 the celebrated pianist and composer appeared with the Boston Symphony Orchestra in a number of American cities.

Fads and Fancies

NEW YORK, March 30.—The coming season will, undoubtedly, be noted for the unusual vogue of taffeta. The shops are full of models showing taffetas of every description employed as the principal material of the frocks. Unfortunately taffeta is difficult to manage in such a way as to avoid fussiness. Nine out of ten of the taffeta frocks shown in the shops are ungraceful and freakish. The tenth is undeniably charming, but the charm usually goes hand in hand with a high price, for it means material of beautiful quality and very skillful making.

Some of the new taffetas are really lovely, supple though never attaining the following suppleness of the crepes and satins, wonderfully light and lustrous, exquisite of line. The Jouy taffetas, which quaint in the best sense of that word, are winning favorable attention, though chameleon effects still hold first place. Tolle de Jouy or antique cretonne designs have invaded many classes of materials, and whether in cottons, shiftons, crepes, radiums or taffetas have a distinct charm, though they must be handled knowingly to give satisfactory results and are quite hopeless if made up along lines unsuited to their peculiar character.

This is especially true of the Jouy taffetas. Many of the prettiest have a ground of white checked or striped by hair lines of black, and over this surface quaint spring designs in odd soft colors are scattered. Admirably pipant little summer frocks these will make for a certain type of wearer provided the frocks are made with artistic skill. Among the taffetas attractive striped effects may be found, usually in white and color-soft-rose, dull old usually goes hand in hand with a blue, violet, cherry, etc. These striped taffetas are successfully made up alone but the French designers like to combine them with plain taffeta, usually though not invariably in the color of the stripe and sometimes with changeable taffeta in the stripe color shot with whites and perhaps one other tone. There are two sorts of "lingerie" fabrics in the market now—the heavier linens, crases, piques and bedford cords of which tailored costumes are fashioned and the clinging soft as chiffon stuffs like batiste, mull, voile marquisette and crepe which go into the making of diaphanous frocks. There is a fancy for garnishing even the tailored costumes with quantities of lace this season, and yards of broad insertions of filet, cluny and other heavy laces make simply cut linen suits very dressy affairs indeed.

Neuse River Begins to Fall

Traffic in the River, Owing to the
Last Heavy Rains Has Been Large
and Much Freight Has Been Haul-
ed in This Manner.

KINSTON, March 30.—Neuse river
opposite this city continues to fall at
the rate of an inch an hour. This
indicates that the flood waters up-
stream have not yet reached Kinston.
Although it was expected that the
danger stage would be reached at
onetime, the rise still lacked several
feet of this when the river began to
fall. River steamers are taking ad-
vantage of the increased depth and
there has been more traffic on Neuse
river in the past week than in years
between New Bern, Kinston and Sev-
en Springs.

Michigan Votes On Liquor

DETROIT, Mich., April 1.—The
"wet" and "dry" measured strength
in Michigan today, when the voters of
twenty-five counties of the lower
peninsula went to the polls to cast
their votes for or against the saloon
under the county option law. Interest
centers largely in the eighteen coun-
ties that have been "dry" for two
years and are now having the ques-

ponents of the prohibition movement
believe that a change in sentiment
will result in swinging several of the
counties that voted out the saloon two
years ago back into the "wet" col-
umn. The anti-saloon campaign man-
agers on the other hand, predict that
the number of "wet" counetis will be
materially cut down as a result of
today's election.

NEWSFORECAST FOR THE PRESENT WEEK

WASHINGTON, March 30.—T h e
Wisconsin primary election Tuesday
is expected to furnish the leading sub-
ject for political discussion of the
week. Delegates to the national con-
ventions of both parties will be elec-
ted in the primaries, under the new
Wisconsin law. The best impartial
judges of the situation in the Bad-
ger state concede that LaFollette will
carry the majority of the state dele-
gation, with delegates reported in
many cases to favor Roosevelt for
second choice. The state is strongly
progressive. The Taft men are active
but their hope apparently is not to
get a majority of the delegation, but
to prevent LaFollette from having a
unanimous vote from the state.

On the Democratic side, Wisconsin
seems to present about the same sit-
uation as Oregon and Nebraska, al-
being primary election states with
three tickets in the field. Harmon is
supposed to be stronger in Wisconsin
than in the other two states and,
backed by the solid conservative vote
it is thought possible the Ohio Gov-
ernor may win over Wilson and Clark,
who will have to divide the "radical"
vote between them.

Democratic primaries will be held
in Alabama Monday for the selection
of delegates to the Baltimore conven-
tion. The voters will express their
preference for president in the pri-
maries, but the delegates will be nam-
ed later in the state convention. There
is no doubt but that Alabama will
give a decided vote for Congressman
Oscar D. Underwood, and the delegat-
es will be positively instructed for the
Southerner first, last and all the time.
At the same primaries candidates for
Congress will be named, also minor
state officers to be voted for next fall.
The tours of the presidential aspir-
ants will be watched with interest.
Col. Roosevelt is to be heard in sev-
eral cities in the middle West, while
Sen. LaFollette plans to invade New
England. The reception of the Wis-
consin senator in New England will
afford an opportunity for an interest-
ing comparison, as both Taft and
Roosevelt visited that section.

Champ Clark has accepted an invita-
tion to speak at a Democratic ban-
quet in Louisville Saturday night,
while William J. Bryan and other par-
ty leaders will be heard at a similar
gathering in Des Moines.

Also of political interest will be the
local option election in Illinois and
Michigan, the municipal election in
Milwaukee, where the socialists are
fighting for a continuance of power;
the aldermanic elections in Chicago,
and the Republican district conven-
tions in Maine, Missouri, Iowa and
several other states.

Some important decisions are ex-
pected to be handed down by the Su-
preme court of the United States,
when that body convenes Monday af-
ter a two weeks' recess.
Political New York is awaiting with
much interest the trial of former City
Chamberlain Charles H. Hyde, which
is scheduled to begin Monday. Hyde
was indicted for alleged bribery in
connection with the financing of the
Carnegie Trust Co., and the Joseph
G. Robin banks. He will be the fourth
of a coterie of prominent politicians,
bankers and promoters to be tried on
charges growing out of the failure of
these institutions.
A large number of officers, direct-
ors and employes of the National Cash
Register Company of Dayton, O., have
been ordered to appear in the United
States court at Cincinnati Tuesday to
plead to the indictments charging
them with conspiracy to obstruct and
monopolize the cash register business
in violation of the criminal provisions
of the Sherman anti-trust law.
The launching of the torpedo-boat
destroyer Henley, which is to take
place at the Fore River yards on Wed-
nesday, will be of considerable impor-
tance in naval circles because of the
fact that this ship will be the first of
the destroyers to be fitted with both
turbine and reciprocating engines.
Other events of the week will in-
clude the celebration of the Jewish
feast of the Passover, the annual con-
vention of the American Cotton Man-
ufacturers' Association in Washing-
ton, the situation with regards to the
coal strike, the annual conference
for Education in the South, at Nash-
ville, and the observance of the semi-
centennial anniversary of the battle
of Shiloh and the death of the confed-
erate leader, Albert Sidney Johnstone.
