Roosevelt Loses by Popular Vote in Bay State But the Delegates Will Support Him

Results of Election Still in Doubt as President's Majority Over Third Term is Very Small.

TAFT CARRIED 9 OF HIS 15 CONGRESSIONAL DISTRICTS

BOSTON, May 1.—The refusal of the Republican delegates at large to accept Colonel Roosevelt's decision today that they should vote for President Taft at the Chicago convention, although elected as Roosevelt delegates have further complicated the situation arising from the state primaries yesterday. The situation is acknowledged by party leaders of both sides to be without parallel in the political history of the commonwealth.

Although the Republicans of the state selected Taft as their candidate for re-nomination by a majority of 3,605 over Colonel Roosevelt on the presidential preference ballot, at the same time they elected by a decisive vote the entire slate of eight delegates at large pledged to the former president. Colonel Roosevelt secured ten more delegates in the district elections and the president carried nine districts so that Taft and Roosevelt each have 18 delegates from the state to the national convention.

A somewhat similar situation was created on the Democratic ballot. Speaker Clark, who had no pledged delegates on the ticket, won a 2 to 1 victory over Governor Wilson in the presidential preference contest. At the same time delegates at large pledged to Governor Foss, of Massachusetts, were elected to attend the Baltimore convention though the name of Governor Foss did not appear in the presidential preference column.

Roosevelt followers have announced their intention of asking a recount in the Eighth district while Taft men will do likewise in the Ninth, on account of the closeness of the vote. In his request to the delegates at large, Colonel Roosevelt declared it to be his wish to abide by the will of the people and that therefore, the delegates though elected as pledged to him, should vote for Mr. Taft, who had received the presidential preference vote. One by one the delegates, as they were heard from today, however, protested that under no circumstances would they cast their ballots other than they had pledged.

Senators Would Keep Japs Out of Bay

Monroe Doctrine Advanced by Bacon and Lodge

WASHINGTON, May 1.—The United States should either enforce the Monroe doctrine or formulate a new one broad enough to prevent Japanese commercial interests from securing control of territory about Magdalena bay is the opinion of Senator Lodge, Bacon and other members of the foreign affairs committee of the senate.

In a debate today following the receipt of President Taft's message transmitting the correspondence covering Japanese activity in western Mexico, leading members of the senate declared that the control of so great a strategic position even by commercial interests wholly Japanese in character could not be permitted without menacing the safety of the United States.

The Magdalena bay papers were referred to the foreign affairs committee which is expected to consider the case with a view to outlining the attitude of the United States on the subject of the acquisition of land on this hemisphere by foreign nations or by their subjects.

Asheville Hears Woman Attorney

Local Bar Sees Woman Join Body of Lawyers. First Lady to Practice Law There. Mrs. A. M. Fry Co-partner in Husband's Law Firm.

ASHEVILLE, May 1.—The first woman attorney to appear in the courts of Asheville, so far as the members of the local bar can remember, is Mrs. A. M. Fry of the firm of Fry and Fry, of Bryson City, the husband being a co-partner. Mrs. Fry was in the city and went before referee in bankruptcy F. W. Thomas in behalf of certain creditors of the Nantahala Transportation company, at a meeting of the creditors of the bankrupt company. Although her duties were not very considerable, Mrs. Fry showed herself to be "mistress" of the situation and won the admiration of the members of the bar who were at the hearing. She appeared to be at home and familiar with the legal technicalities. Mrs. Fry read law for some time in the office of her husband and then took a course at the state university where her ability was quickly recognized. She was admitted to the bar last fall, since which time she has been practicing in the courts of western North Carolina.

Nutmeg Democrats for Baldwin.

BRIDGEPORT, Conn., May 2.—Practically all of the delegates are here for the Democratic state convention which is to name the delegates from Connecticut to the national convention at Baltimore. The convention meets tonight for organization and will then adjourn until tomorrow, when the real business will be transacted. The convention is not expected to disclose the real preferences of the Nutmeg State for the presidential nomination. The present programme is for the Connecticut delegates to cast a complimentary vote for Governor Simeon E. Baldwin when the balloting begins at Baltimore and then to await developments.

Educators Confer on Bible Study.
RICHMOND, Ind., May 2.—Faculty members of the leading universities and colleges of the United States assembled at Earlan College today for their annual conference in relation to the student's volunteer Bible study movement. Shaller Matthews, dean of the University of Chicago and a number of other well known educators and religious workers are scheduled as speakers during the two days session.

College Orators to Meet.

CHICAGO, Ill., May 2.—Before a great representative college audience that is expected to fill Fisk Hall, Northwestern University, the seven orators of as many great western institutions will contend for supremacy tomorrow night. The occasion will be the annual contest of the Northern Oratorical League.

Mississippi Pedagogues.

GULFPORT, Miss., May 2.—An army of Mississippi school teachers invaded Gulfport today for the annual convention of their state association. The convention will remain in session three days, during which time the teachers will discuss every phase of school work and listen to addresses by a number of widely known educators.

Texas Tooth Pullers Meet.

ABILENE, Texas, May 2.—With a large attendance of prominent members of the profession the State Dental Association met in this city today for its annual convention. The sessions will continue through the remainder of the week.

Santa Rosa Carnival.

SANTA ROSA, Cal., May 2.—Santa Rosa's annual rose carnival opened today under auspicious conditions. The city is gayly decorated and thronged with visitors. The program of festivities extends over three days and is much more elaborate than in previous years.

New England College Orators.

PROVIDENCE R., May 2.—College orators accompanied by delegations of student rooters gathered at Brown University today for the third annual competition in the New England Intercollegiate league.

TO STOP TRAFFIC

Attorney General appoints Man to Make Investigation.

WASHINGTON, May 1.—Attorney-general Wickersham today appointed Stanley W. Finch, chief of the bureau of investigation of the department of justice, a special commission to suppress the White slave traffic.

Mr. Finch will begin a various campaign in every state in the union for the extermination of the vice. He will cooperate with societies and individuals interested to wipe out the traffic by a systematic and comprehensive plan of investigation and prosecution and by placing agents in every state in the union. About 600 special officers will be employed in this active campaign.

A various investigation of conditions in Virginia, West Virginia, Maryland, North Carolina and the district of Columbia have already been started.

Father Will Oppose Son.

POTTSVILLE, Pa., May 2.—Much interest is manifested in the trial of the seven residents of Minersville who are in jail, here charged with killing Michael Sweldaw during a quarrel over religion. The cases are among the first on the calendar of the May term of the criminal court, which will convene next week. An unusual feature of the trial will be the spectacle of father and son opposing counsel. District Attorney C. A. Whitehouse will act as prosecutor, while his father, W. J. Whitehouse will appear as counsel for the defense.

Drum Fish Landed at Wrightsville Beach Weighing 32 Pounds.

WILMINGTON.—The fishing season at Wrightsville Beach has opened up and almost every day fine catches are being made. Thought it is yet a little early for blue fish, the drum, Virginia mullet, trout, black fish, pig fish and flounders are beginning to bite in great fashion. The record drum landed so far was caught at Moore's inlet several days ago by Paul L. Cantwell and pulled the scales for 32 pounds.

Hotel Man Falls in Business.

ROXBORO.—Much to the surprise and regret of the citizens of Roxboro, E. R. Higgins, proprietor of the Jones hotel, made an assignment yesterday F. O. Carver being named as trustee. It is understood that the liabilities are \$800 and assets the same. Mr. Higgins came here from Durham and took charge of the hotel February 1, and has been running a high class house.

Interurban Expected to Reach There Friday.

GASTONIA.—Unless something unforeseen occurs the first car over the Piedmont and Northern Line, the interurban, will reach Gastonia some time Friday afternoon, running from Charlotte via Mount Holly, McAdenville, Lowell and to the subway under the Southern tracks near the Avon mill, within the corporate limits of the town.

Charlotte Attorney Will Make Memorial Day Address

CONCORD.—E. R. Preston of the Charlotte bar has accepted an invitation to deliver the memorial day address here May 10. The exercises will be in charge of the Daughters of the Confederacy and a most interesting program has been arranged.

FIVE MEET DEATH.

All Employees of Great Lakes Towing Company.

CLEVELAND, O., May 1.—Five men all employees of the Great Lakes Towing Company, were burned to death and damage estimated at \$450,000 done to boats and gasoline on the docks when a Standard oil barge exploded late today.

The barge, which was at the Jefferson avenue docks on the Cuyahoga river, was being filled with gasoline from a ten thousand tank on the bank. Leaking oil on the surface of the river ignited and set fire to the barge. A terrific explosion immediately followed.

The men killed were caulking another barge alongside and were enveloped in the flames.

Noted Churchmen to Visit Canada.

LONDON, May 1.—A party of more than one hundred noted clergymen and religious workers of the United Kingdom sailed from Bristol today for Canada. They are officers and members of the Federated Brotherhoods of the Old Land, which has a membership of 750,000 and the primary object of their trip is to attend a meeting soon to be held in Toronto for the organization of a similar brotherhood to embrace all of the existing evangelical brotherhoods and societies in the Dominion.

Underwood Forces Sweep Georgia State Over all Other Aspirants for the Presidency

Deprives Pennsylvania Boss of His Rule

Penrose Machine Suffers Defeat At Teddys' Hands

HARRISONBURG, Pa., May 1.—The Republican state convention, under the leadership of former State Senator William Flinn of Pittsburgh, today wrested control of the party machinery from United States Boise Penrose who has led the regular organization in the state since the death of Matthew Stanley Quay; named 12 delegates at large and 12 alternates instructed to vote for Theodore Roosevelt for the Republican nomination; nominated all the progressive candidates picked in caucus by the Roosevelt delegates; named Henry G. Wassen, of Pittsburgh, as state chairman to succeed former Speaker Henry F. Walton and adopted a new set of rules for the governing of the party in the state. In fact, "The majority is entitled to everything," said Senator Flinn when temporarily presiding while a minor contested seat case was before the convention.

"And when a vote is a tie the benefit of the doubt will be given to the Roosevelt men," he added amid cheers.

Senator Penrose, although a delegate did not attend the convention, but his chief lieutenant, State Senator James P. McNichol, the Philadelphia leader, remained throughout the six hours the convention was in session and saw his wing of the party shorn of power.

Senator Simmons Concludes Revision

Tar Heel Finishes Speech Advocating a Revision of the Metal Tariff. Refers to Millionaire Schwab as "Petted Child of Fortune."

WASHINGTON, May 1.—Senator Simmons today concluded his speech in advocacy of a revision of the tariff schedule and notwithstanding it was the first speech of a long series in the tariff fight, Senator Stone found it necessary to mildly lecture the senate on its lack of interest.

The Missouri senator could see no reason for continuing the general discussion except for campaign purposes.

"I had assumed that to be the purpose of Democratic senators," remarked Senator Gallinger.

"They can pursue that course with better reason that the Republicans," replied Mr. Stone.

Mr. Simmons referred to Charles M. Schwab as a "petted child of fortune," and said that he would like to see reduced the extortionate profits obtained by him through the employment of a horde of cheap alien laborers.

Interest in Klaus-Dillon Bout.

NEW YORK, May 2.—The ten round bout between Jack Dillon of Indianapolis and Frank Klaus of Pittsburgh which is to be pulled off in Madison Square Garden tomorrow under the auspices of the Garden A. C., is the big event of the week for local boxing enthusiasts and is already attracting much attention. Interest in the match arises from the fact that the result will have an important bearing on the dispute over the middleweight title, for which both Klaus and Dillon are aspirants. The winner will be matched for an early ring encounter with Eddie McGoorty, another prominent claimant to the middleweight championship and thus it is hoped to determine "who's who" in the 158 pound class. Aside from this phase of the contest, the mill between Dillon and Klaus is expected to attract a big crowd on its merits alone, as both men are fast fighters and may be counted upon to furnish a lively and interesting battle.

Woodrow Wilson Only Dangerous Opponent of Alabama. Harmon and Clark Fall Short.

84 DISTRICTS FOR UNDERWOOD, 24 FOR WILSON

ATLANTA, Ga., May 1.—Early returns from the presidential preference primary held in Georgia today indicate that Oscar Underwood of Alabama, will carry a majority of the counties. Returns from 113 counties show that in 84 Underwood has a majority over Wilson, of 11,335, while in 29 counties, Wilson gets a majority over Underwood of 3,482. In five or six counties heard from the vote is so close that an official count will be necessary to decide the winner. The Atlanta Constitution, an Underwood paper, in its editions, is claiming the state for their candidate by 10,000 majority.

Warm, sunny weather throughout the state resulted in unusually heavy votes in the cities and towns, but in the country precincts the vote was light the farmers taking advantage of the weather to continue their farm work.

While the names of Judson Harmon and Champ Clark also appeared on the ballot today only a scattering vote was cast for them, the fight in this state being between Underwood and Wilson.

A state convention to ratify the action of the voters will be held here on May 10.

First Train Order by Wire.

HARRIMAN, N. Y., May 2.—With interesting exercises and in the presence of a distinguished gathering, a tablet erected by the Association of Railroad Telegraph Superintendents and the Old Time Telegraphers Association to commemorate the sending of the first telegraphic train order in 1851 was unveiled here today. It was from the Erie Railroad station at this place, which was then known as Turner, that the first telegraphic order was sent by Charles Minot, the railroad's general superintendent.

The tablet commemorating the event is of bronze and was designed by Charles Keck of New York city. It is six feet high by three feet, three inches wide, and cost \$4,000. The \$2,000 base upon which the tablet rests was quarried from the Harriman estate and was given by Mrs. E. H. Harriman. The next largest contributor to the fund was Andrew Carnegie, who became a telegraph operator when he was 14 years old, and who is said to have sent the first telegraphic train order on the Pennsylvania railroad at Pittsburgh in 1852.

DARLINGTON, S. C., May 2.—Darlington is entertaining for three days the annual convention of the South Carolina division of the Travelers Protective Association. SOLICITOR ABERNETHY.

Court is over, or rather the criminal term of court which promised so much in the way of "excitement" has come and gone and we no longer need rush through our work in order to be present at the proceedings. The last term of court was fruitful. It gave us ten days of more than something to do; it gave us a great deal to listen to and it did more than convince us of the fact that glory be to the choice of the selector, we have some officials doing their duty. It was our satisfaction and very much to the county's benefit to have with us an exemplary judge and a solicitor worthy of his office. The judge "was a new one us" and a mighty pleasant official to have. The solicitor, we have been having for some time and may we have for a longer period.

We can hardly tell how the man awaiting trial feels about the coming to town of the solicitor, but we can certainly say that we are always glad to have him with us. Thorough in the discharge of his duty, pleasant in the meeting of friends and acquaintances, Solicitor Abernethy is always welcome to Greenville.

Mr. Solicitor has an ever-ready greeting for all those he met once and almost always has something nice to say for the fellow he means to punish. It would be presumptuous for us to say he is a very good lawyer, for we are not of the profession, yet he has a worldly way about him when in the court room that inspires you with an acknowledgment of his capacity to hold his office to the benefit of the society he was elected to defend. By this we mean that Solicitor Abernethy has strangled himself from all those mannerisms that mark the lawyer in the discharge of his duties. Not by any means that any brother lawyer "on the other side" "has anything on him" when it comes to getting a point. Far from it, for the solicitor is never asleep. Unlike other men holding a similar position Solicitor Abernethy does never betray the slightest nervousness or inclination to feel the heat of an argument. Rather possessed in manner, he wins point after point in his argument by logical attacks on his opponents with an occasional injection of "horse sense," which goes a very long way to single him out as a practical man.

We have often heard him say in addressing a jury directly after a lawyer for the defense had made an eloquent talk in favor of his client, that he is not going to entertain the members of the jury with the eloquence of his learned brother, etc., etc., yet before he is through he impresses you with having as much if not more eloquence than the brother about whom he speaks in such terms of admiration. Perhaps Solicitor Abernethy will some day believe he is very eloquent; that his address to a jury, no matter what the case may be, is very interesting; that the at-

tendants at court listen to him as silently and as attentively as they do when the distinguished broker has his something to say, only perhaps more so. On the other hand it is likely that Solicitor Abernethy is well aware of all this, yet his good manners forbid him from admitting it to the outsider.

How a man following the profession he does and holding the office he does hold can keep his well of wit as well supplied as he manages to, is a mystery that would be worth a great deal to us to decipher. Still he draws from his supply of wit at will and always finds more and more. We all remember him when he addressed the crowd of homeseekers some time ago. Hardly if ever did we hear as pointed and witty a talk as Solicitor Abernethy made in the court room that night.

When the solicitor begins to talk to his jury the unenunciated would imagine that he was a member of counsel for the defense. The defendant himself must think him a God send. But that's only his way. Half way before his talk is over the defendant has lost a brother and the attendants realize that in Solicitor Abernethy law and its enforcement is first and last, with nothing but kindness and smiles in between. That his interpretation of right and wrong according to the law is flawless and that with such men holding the office of prosecuting attorneys, the safety of the people is insured.

Never vindictive, kindly when doubtful of the commission of crime, inexorable when convinced that the law has been broken. Such is Solicitor Abernethy.

Again let us remind you that a new series of shares in the Home Building and Loan Association will be opened Saturday. That date begins a new year with the association and the next series should be a large one. The first series will soon mature to be followed by another series maturing every six months. It will be a mighty good feeling to step up to the secretary's office and draw \$100 for every share you had, or receive a canceled mortgage if you have been a borrower.

Greenville real estate will hardly reach a lower figure than it now is. When people price property and conclude to wait to see if it will get cheaper, they usually find the contrary true. Not a few have experienced this in recent years and it will continue to be that way. The town will not go backward.

This is My Birthday

Graham Taylor.

Professor Graham Taylor, one of the best known sociologists in America and a pioneer worker in many movements looking to the uplift of the masses, was born in Schenectady, N. Y., May 2, 1851. His education was received at Rutgers College and the Reformed Theological Seminary at New Brunswick, N. J. After graduating from the last named institution he was ordained to the ministry of the Reformed church in 1873. For twelve years he was pastor of a church in Hartford, Conn., and during a part of the time he was also professor of practical theology in the Hartford Theological Seminary. For the past twenty years Professor Taylor's activities have been identified chiefly with the University of the Chicago Commons, one of the most noted social settlements in the country.

The Section of a Nominee

Nothing could be more fallacious than the belief that any democrat, no matter who he is, can be elected president next Nov. when between now and then a campaign education such as this country has never seen will be waged. The vote, we predict, will be the most intelligent vote cast. The summer months will witness a chance for the personal methods of campaigning now in vogue to real consideration of the great problem to be solved. The next president will be elected because he stands for something, stands for it squarely, sincerely, honestly, intelligently. No man who gets his position through oily utterance or passionate appeal to animosity and prejudice; no man who lacks the necessary bulk, the personal character, the seriousness of purpose can be elected, no matter on what platform he stands - or under what party banner he wages his fight.

There is a crisis in the history of the republic. To the democracy men everywhere are looking with hope. It offers the chance of rescue. But as yet the election of delegates, the light manner in which they are being selected, does not augur well for the party. In the first place, many delegates are being sent to Baltimore pledged. Through the whole nature of affairs may change in the next month, and is very likely to do so, these delegates must vote for the candidate who seemed best yesterday or the day before. They must cast their ballots for the man who on the day of the nomination seems best fitted to lead the democratic host. In the second place, between the rival candidates there has been up to this time practically no discussion of issues only bitter accusation, personal attacks, invective of one kind or another. The selection of delegates has not been made with this wise consideration which is so necessary. There seems to have been too much frivolity, if we may use the term, too little study of the practical phases of the situation.

We are hopeful that the South Carolina delegation will be uninstructed. The fight for uninstructed delegates is also being made in other states. Men are beginning to realize the crises that is at hand. It is not time for playing, no time for experimenting. Serious-minded statesmen are saying that the Baltimore convention must be influenced largely by what the Chicago

convention does. They are beginning to realize that on the result in Baltimore may depend the very existence of our government, as we have known it. The fight may be more than a contest for control. It may be a fight for liberty itself, as we have known and cherished liberty. With the choice of a leader so important, it is necessary that the convention have some power of discretion, that it be permitted to deliberate, that it be allowed to select.

There is yet time. Enough uninstructed delegates can be sent to determine the result. South Carolina in particular should seize this opportunity to magnify her influence. The state's delegation should be uninstructed.—News and Courier.

Virginia for Wilson

That Woodrow Wilson will get the Virginia delegation is clearly indicated by the result far recorded in counties and towns where delegates to the convention have been chosen. The following have elected Wilson representatives:

Staunton, Elizabeth City county, Suffolk, Nansemond, Lunenburg and Wise counties. Only three counties have taken action, and in two of these a majority of delegates are for the New Jersey governor. Delegates from the other county are said to be non-committal.

From this resume of the situation, it can be seen readily that if the drift of the past few weeks continues without serious interruption, Wilson will have an overwhelming majority in the Norfolk convention.

In many quarters an earnest effort is being made to exclude the issue. Supporters of Clark, Harmon and Underwood apparently are banded together in an effort to prevent the Virginia delegation from being instructed. To accomplish this result they are delivering all manner of preachments, the chief of which is that Virginia should place its delegation in the hands of Senator Martin and let him do with it as he pleases. An effort somewhat similar to this was launched four years ago, when some of the leading politicians of the state united in a plan to throw Virginia against Bryan. The plan suffered inglorious defeat. Seemingly the same fate is in store for the anti-Wilson movement.—Roanoke Evening World.
