Floyd Allen Made Threat Against Foster, According To Testimony of Witness

Second Act of Hillsville Tragedy Being Enacted in Quiet Virginia Town, Extraordinary Precautions Taken

THREE WITNESSES HAVE SO FAR GIVEN THEIR TESTIMONY

WYTHEVILLE, Va., May 2.—"I'll kill Bill Foster before the sun goes down tomorrow night if I'm convicted."

Floyd Allen, the first of the Hillsville court house assassins now on trial here for his life, was charged with making this remark before the shooting on March 14, according to the testimony of I. B. Weddell of Montgomery, one of the first day's witnesses for the prosecution.

Six witnesses, three of them spectators at the shooting affray testified. The first D. W. Bolen, a lawyer who was defending Allen in the court where the murders occurred, testified that he saw Claud Allen fire the first shot and that it struck Judge Massie.

Prosecutor Wysor, opening the case said he would show there was a conspiracy among the Allens to shoot up the court if Floyd Allen was convicted. Attorney Willis, for the defense retorted that reports of the tragedy had been grossly exaggerated and that he would introduce testimony to show that Bettie Ayers was killed by a bullet from Clerk Dexter Goad's revolver and not by the Allens.

Report of Meeting of Board of Aldermen

The board of aldermen met in regular monthly session, last night with the mayor and six members of the board present.

C. T. Munford appeared before the board in regard to having the culvert near the Yellow Hill on Third street extended the full width of the street. The street committee was authorized to make the extension.

H. A. White appeared in regard to free mail delivery. The mayor and chief of police were authorized to have all houses of the town numbered and streets marked so the free delivery can be established.

The chief of fire department was authorized to purchase a sliding pole for the firemen's quarters in the municipal building and a fire alarm whistle to be placed at the water and light station.

The board donated \$15 to pay the per capita tax of Hope Fire Company for membership in the State Firemen's Association.

The water and light commission was authorized to extend water pipes through Sutton lane. A proposition to settle the claim of the Sutton heirs for property used in extending Eighth street was confirmed.

The standing committee had no reports of interest.

The formal call was made for an election to be held on the first Monday in June to elect one alderman in each ward. The names of registrars and judges of election in the several wards will be found in a notice published in this paper.

Coal Miners Situation Complicated

Operatives Will Not Accept Terms Offered

NEW YORK, May 2.—"The outlook, while rather complicated, is not discouraging. It is hoped all differences may yet be adjusted."

This was the statement made early tonight by William Green, representing John P. White, president of the United Mine Workers, shortly before the convening of an evening session of the general committee representing the mine workers of the anthracite coal regions which today rejected the tentative agreement for settlement of the miners wage and other demands which had been approved by sub-committees representing the operators and the mine workers.

The proposal for settlement of the wage dispute was voted down by the miners while in conference with the operators. After adjournment of the conference, William Green, representing President John P. White, of the United Mine Workers of America, announced that a conference would be held tonight to determine whether the tentative agreement, rejected by the general committee of the miners, should be submitted to a referendum vote or to a convention of representatives of the 400 local unions in the anthracite regions.

The contest will take place over the usual twenty-five mile course, starting at Freeburg, Ill., and finishing at the clubhouse of the Missouri A. C. in this city.

NEW B. AND L. PLAN. Association Just Organized at Winston-Salem Will Follow Plan Similar to Ohio System. Winston-Salem is to have another building and loan association on the most approved and up to date plan.

It was organized yesterday afternoon and is to be known as the Citizens Building and Loan Association of Winston-Salem. Its capital is five million dollars and it is so fixed that shares can be bought in it at any time and one distinguishing feature that differentiates it from all other associations of like character is that it is going to charge no entrance fee to shareholders.

Besides the fact that it will charge no entrance fee and will have shares of stock on sale at any time, a special feature will be the selling of permanent shares, not subject to withdrawal, which are to remain as permanent stock in the company so as to enjoy the benefits of its surplus. Another special feature is the lending of money for other purposes than the building of homes. A shareholder who may need money can get it upon a pledge of his stock and is entitled to a loan of 90 per cent of the value of his stock. This is a great inducement to a poor man, who is likely to have to borrow money, to own stock in this association.

It is said that many applications for shares have been filed and the sale of stock is expected to go head at a rapid rate.

Some of Taft's Leaders Disappointed Over Showing of Executive in Bay State

May Limit Pastorate To Five Years

Preachers Do Not Agree With Measures

MINNEAPOLIS, Minn., May 2.—Limitation to five years as the longest time any minister shall remain in a given church, it is expected, will be recommended to the Methodist Episcopal general conference by the bishops tomorrow as a means of stimulating the church.

Much opposition is expected to arise over the proposal. At present are 19,000 Methodist Episcopal ministers scattered over the world are allowed to remain in any pulpit indefinitely. The new plan, supported by the 24 active bishops at the conference will mean a restoration of the time limit abolished in 1900. In favor of the change the bishops have received these arguments:

"Because some of the churches will not have the less able ministers all the time and none of the churches will have the better ministers exclusively; because the prominent pulpits, now held by a few, will be thrown open to younger men."

Against the change these objections were made: "That preachers who plan great work will not be in a pulpit long enough to accomplish it; that many great preachers have left the church because hampered by a time limit; that large congregations cannot be built up from a pulpit where there are frequent changes."

Taken to State Prison.

Deputy Sheriffs K. W. Cobb and V. E. Staton left this morning for Raleigh to take the five prisoners who were sentenced to the state prison at the last term of court. Two of these William Nichols and Knapp Burnett, are white and the other three colored.

Extraordinary Case at Oxford

Defendant Invites Two Jurors Trying the Case to Spend the Night With Him. Whiskey Partaken by Accused and Jurors While Case is Going on.

OXFORD, May 2.—Quite an unexpected turn was taken in the case being tried here state vs Dock Aiken and Paul Tingen for breaking in the Seaboard depot at Creedmoor. About 12 o'clock when the solicitor was speaking in the case it was discovered that the defendant Aiken had engaged a room the night before at a boarding house for himself and friends as he expressed it to the landlady. It turned out that these friends were two of the jurors sitting on the case. One of the jurors had received by express a package of whiskey and both last night and this morning the three were known to have been drinking together in the room, one of them having slept last night with the defendant.

As soon as the matter was presented to Judge Carter he dismissed the case and ordered the defendant Aiken and two jurors J. A. Adcock and J. D. Burchett in the custody of the officer. He also ordered bills of indictment to be drawn to be presented to the grand jury. The jurors were put under bonds of \$300 each and Aiken \$500 in addition to the bond in the original case against him.

It is Asserted That a Number of Them Are Looking Over the Field Endeavoring to Locate Another Candidate

MANAGER MCKINLEY WAS HOPEFUL UP TO A FEW WEEKS AGO

WASHINGTON, D. C., May 2.—One would not be warranted tonight in saying the Taft campaign had reached a state of utter collapse. It is true, nevertheless, that there has set in a very definite process of disintegration. A few weeks ago Manager McKinley "knew" that Mr. Taft would have a majority of 600 or 800 at Chicago. Today he is entertaining the "hope" that the President will have a majority of 100. Last night one of the press associations attributed to Mr. Taft the statement that he felt fairly well satisfied over what had happened to him in Massachusetts. No such feeling has for a moment been experienced in Taft headquarters here. The Baltimore Sun is of the opinion that Mr. Taft's weakness is fatal. The Saturday Evening Post, issued today, says enough primaries have already been held to make it plain that the President is not the choice of his party. John R. McLeon's Washington Post, always pro-Taft, is speechless. The New York Sun, faithful Wall Street and Taft court circular that is, feels that the worst has already happened. In an editorial today, which read like the writer had just emerged from a Welch rabbit dream, it lamented that Massachusetts was divided equally on essential declarations of the bill of rights and it is impelled to the belief that the commonwealth fasting and prayer, all of which should proclaim a day of humiliation, dictates how much the Sun thinks Mr. Taft will be nominated. Washington correspondents of Indiana papers are tonight sending out the story that the Hoosier State supporters of the President, while the New York World hears that William Barnes of New York, in his search for a dark horse, is sounding sentiment among Republican leaders in the south, in the hope that the southern politicians will not all turn to Roosevelt.

Expect 25,000 in Suffrage Parade. NEW YORK, May 3.—The women identified with the suffrage movement in this city are in a flutter of excitement over the great suffrage parade which his scheduled to be held here tomorrow. For many weeks the great event had been planned and a great amount of work had to be done to put everything in proper shape and to arrange every detail, so as to avoid everything that might be construed into any confusion. The organizers of the parade were in honor bound to prove to the world that they knew how to arrange a parade just as well as men could do it.

There was a parade last year, but there were only about 300 men and women in line. Tomorrow, however, it is expected that fully twenty-five thousand suffrage sympathizers will take part. The parade was planned by the Woman's Political Union of New York city and it was decided to make it as grand and cosmopolitan in character as it could be made.

The distinction between thankful and appreciative is unmistakable and although the two should always walk hand in hand yet we neglect their natural affiliation and most times are content to be thankful.

To thank is to express our gratitude, to appreciate is to value intrinsically that which is given us or is earned by us.—That's the difference.

Now you'll remember with us how strenuous our efforts to obtain something. We labor incessantly after the coveted object. The greater the difficulty experienced in the chase after "that something" the greater our satisfaction in its ultimate possession; the more sincere our words of thanks. "Thank goodness," "Thank Heavens," etc., etc. You know them all.

Yet how do we proceed to appreciate the possession of that coveted something? Remember the hours of overtime put in at your work in order to let the "folks" see you in that brown suit Easter Sunday? How did you stick to your resolution of maintaining that rule drawn crease in the pants? How many days elapsed until you treated the well fashioned coat with less regard than a transfer man devotes to a trunk? You see, that's appreciation or rather want of appreciation.

Archbishop Prendergast

Most Rev. Edmund F. Prendergast, archbishop of Philadelphia, was born in Clonmell, Tipperary, Ireland, May 3, 1848. He came to the United States in 1859 and studied for the Catholic priesthood at the seminary of St. Charles Borromeo in Philadelphia. He was ordained in 1865 and was assigned as assistant at St. Paul's church in Philadelphia. He served in various charges in eastern Pennsylvania until 1874, when he was made rector of St. Malachy's church in Philadelphia. Fourteen years ago he was made auxiliary bishop of Philadelphia and several years later Archbishop Ryan appointed him administrator of the archdiocese, to take effect at the death of the archbishop. Upon the death of Archbishop Ryan a year ago Bishop Prendergast succeeded him as archbishop and metropolitan of Pennsylvania.

Bully

In his "American Ideals" Theodore Roosevelt wrote, "the worst offence that can be committed against the Republic is the offence of the public man who betrays his trust; but second only to this comes the offence of the man who tries to persuade others that an honest and efficient public man is honest and unworthy." The New York Evening Post thinks that this would have been a good motto for the speech made by Taft in Boston in which he "made a terrific exposure of Mr. Roosevelt's personal character. The story which he recited," says The Evening Post, "was one long account of unfairness, base misrepresentation and absolute falsity and betrayal. One knows not which to pronounce more base: Roosevelt's eating of his own word about Canadian reciprocity, or his profession of devoting to his friend whom he was even then seeking to undermine and supplant, and against whom he has since used the weapons of an assassin. . . . It is the President of the United States who speaks. It is his (Roosevelt's) old friend, William H. Taft, who knows him through and through—the patient, forbearing man slow to anger, the man who has been reluctant to speak out all, who has at last felt it a public duty to warn the American people that Theodore Roosevelt is one whose word cannot be trusted, who for his own ends will stoop to any treachery, any device, who is false to his friends and dangerous to the country."

There has never been in American public life one who has received the condemnation of so many of the conservative and respectable people as Mr. Roosevelt. Nearly the entire press of the country—the respectable press of the country—has spoken out against him in the most unmistakable terms. There is no longer any mincing of words, no effort to soften criticism, to conceal the real sentiment of the press and the people. The Evening Post stands for well thoughtful folk and speaks for them. The New York Sun, which represents a very considerable number of those who are engaged in great financial and industrial undertakings, speaks of Mr. Roosevelt as the "captain general of malice, and arch hypocrite of politics," and views with satisfaction Mr. Taft's temperate analysis of the Colonel's moral dishonesty and intellectual vagueness. Violets are growing where formerly filth and garbage and trash were heaped in the back yards of many of Charlotte's citizens. This is due to the campaign which was lately in progress in the interest of cleaning up the city.—Charlotte Observer.

Those words carry a word of meaning, and furnish the very best argument for the necessity of cleaning up back lots and vacant spots in a city.

This is the situation that confronts the citizens of Durham today; will you inhale unpleasant odors, spend sleepless nights fighting mosquitoes and gaze at unsightly spots covered with trash, or will you rest your eyes on beds of violets, sleep free from mosquitoes and inhale pure air, wafted from flowers? This is a question for you, and tomorrow is the day for you to answer it.—Durham Sun.
