Model Prisoner Is Richeson In Death Cell

Alienist Have Not Made Their Report to Gov. Foss, Result Anxiously Awaited

PRISONER ASKS RELIGIOUS BOOKS OF PRISON CHAPLAIN

BOSTON, May 15.—No inmate of Charleston state prison gave Warden Bridges less trouble today than did Clarence V. T. Richeson, poisoner of Avis Linnell. Since his removal yesterday from the Charles street jail to the death house in the prison, the former clergyman, who is sentenced to die next week has preserved the calmest demeanor and submitted to discipline with perfect composure.

In view of the fact that Richeson is known to be of a highly emotional and nervous nature, his self possession is a puzzle to his guard and the authorities. As the reports of the alienists employed by Governor Foss have not yet been filed and the case has not been submitted to the executive council, those who are watching the prisoner believe that he may still hold some hope of reprieve or commutation. Again he may have become resigned to his fate and stands ready to die in explanation of his crime. Whichever is sustaining him is a question no one seems able to answer.

Late today he asked the prison chaplain to get several books of a religious nature for him. These the chaplain procured from the prison library. He declined to give the titles of the volumes. The daily papers were also supplied to the prisoner. The information given out from the governor's office tonight was that the reports of the three alienists had not been filed with the governor and that further he had not been able to form any decision as to whether he would make a recommendation to the council for clemency. The council met today following the usual custom, but the Richeson matter was not brought up.

Large Cotton Fire in Charlotte

CHARLOTTE, N. C., May 16.—Fire originating in the plant of the Charlotte Compress Company, shortly after 7 o'clock this morning has burned two compartments, with the contents of seven hundred and fifty bales of cotton, the estimated loss at this stage is about \$35,000.

The fire at ten o'clock is reported to be under control and power cut off temporarily from the lines of the Southern Power Company, killing out the motors at the pumping station. The warehouse covers over an acre of ground and is owned by the Southern Railway and is leased to Sanders, Oorr and Company.

News of Our Native State Briefly Told

Conference at Raleigh Make Recommendations.

RALEIGH.—At a conference of the North Carolina Child Labor Committee, a number of cotton manufacturers of the state here continuing until after midnight, it was agreed to compromise differences as to what changes the 1913 legislature should be asked to make in the labor law and seek changes only that shall prohibit women and girls and children under 16 years from working at night, to provide efficient non-political factory inspection and leave the age limit as at present at 13 for day labor.

Will be Headquarters of State S. S. Association.

GREENSBORO.—Greensboro was chosen over Raleigh last night as the place for the future location of the executive offices of the North Carolina Sunday School Association. The decision was made by the members of the state executive committee, who held a long session following a luncheon tendered in the banquet room of the Y. M. C. A. Chairman N. B. Broughton of Raleigh presided over the deliberations.

Meet in Wilmington and Elect New Officers.

WILMINGTON.—With a large attendance of members from this city and other points in the state the annual meeting of the Colonial Dames of North Carolina was held today at Orton Plantation the beautiful summer home of Mrs. James Sprunt, the retiring president. Following the reading of the different reports, some of which were very interesting, the election of officers followed.

Cumberland County Defeats Measure For Good Roads.

FAYETTEVILLE.—Complete returns from 13 out of 20 precincts and estimated majorities from seven precincts indicate that the good roads bond issue was lost by a majority of 108. Only three precincts outside of Fayetteville have the honor of returning majorities for good roads.

Henderson Grand Jury Returns Bill of Indictment.

HENDERSONVILLE.—Charging the alleged murder of Myrtle Hawkins, the Hendersonville grand jury returned indictments against Nora Britt and Lizzie Shaft.

Southern Commercial Secretaries.

HOUSTON, Texas, May 17.—Nearly 1000 men bonded together by their common interest in the welfare and development of the south faced Pres. J. S. Warren of Memphis this morning when he called the fifth annual meeting of the Southern Commercial Secretaries' Association to order. The convention met in the new municipal auditorium, which was handsomely decorated for the occasion. The roll call showed delegates present from the commercial organizations of nearly every southern city of importance. Governor Colquitt, Mayor Rice and President Peden of the Houston chamber of commerce gave cordial welcome to the visitors. President Warren responded and delivered his annual address which dealt with the science of city building. The convention will conclude tomorrow.

PRESBYTERIAN SERVICES.

Mr. Richard Lancaster has come to Greenville to hold services this summer at the Presbyterian church. The many Presbyterians in town are glad to have the opportunity of holding regular services in their church during the coming months and large attendances are expected. In connection with the services Mr. Lancaster plans to have weekly meetings to discuss subjects of interest to all church goers.

Gov. Jarvis at the Training School.

Gov. Jarvis made an inspiring talk at assembly exercises at the Training school this morning. He told some incidents in his early life that made the students realize that a handicap cannot keep a man from success. He urged the students to go on and get all the training possible and to keep faith in themselves, their fellowman and God.

CONVENTION CLOSES THE CHAIRMANSHIP IS STILL VACANT

RALEIGH, May 16.—The net result of the Republican state convention yesterday was the final clinching of the North Carolina delegation for solid vote for Roosevelt in the national convention, the determination to elect the national committeeman by the convention instead of leaving his election to the delegation at the national convention and the restricting of the activities of the national committeeman to the state and national party policies, leaving the questions of federal appointments to local officers with the local committees who are recommended to the state executive committee. And the election of a new national committeeman in the person of Richmond Pearson, of Buncombe, to succeed National Committeeman E. C. Duncan. The convention refused to go into the matter of the election of a state chairman to succeed Chairman J. M. Morehead, although it was clearly the purpose of many of the Roosevelt leaders when they went into the election of a new national committeeman to carry the work through the changing of state chairman also.

Last Session of the Convention.

When the convention re-convened at 2:15 o'clock it was reported that it would be yet another hour before the credentials committee would be ready to report and the time was spent in speechmaking that developed the fact that neither Taft or delegates friendly to Taft would have any show in the convention. Temporary Chairman Walser was called up and stirred enthusiasm by declaring that he and others were for Roosevelt before he had a band wagon, but that it was still not too late and for everybody to get on the band wagon for him.

There were calls for Walter R. Henry, of Charlotte, but when he shouted that he was three hundred pounds for Taft, he was cried down and not allowed to proceed until another delegate appealed that it should not be allowed to go out that any man had been discourteously treated. Then Henry had an opportunity to add that if Roosevelt is nominated he would join with the others in fighting for his election.

Underwood Speaker Jury in Allen Case Is Admits Trust Still Out

Representative Heflin, of the Fifth Alabama District Tacitly Admits Combine Against Wilson in Charlotte Speech

CHARLOTTE, N. C., May 16.—Representative James Thomas Heflin, of the Fifth Alabama District, speaking here tonight in the interest of Underwood's candidacy in North Carolina for the presidency, tacitly admitted the alleged conspiracy between other candidates against Wilson, when he declared that as a master of practical politics, since Clark would not have strength enough to win in the convention his strength would go to Underwood rather than risk a contest with Underwood for the speakership of the House, should Underwood also be defeated in the convention.

Fully a thousand people heard the address in the Academy of Music, but a large proportion were Wilson supporters. His speech was in substance an appeal to sectional feeling.

Heflin at Durham.

DURHAM.—Hon. J. Thomas Heflin of Alabama opened the Underwood campaign last evening in the city with a speech that is acknowledged by both Democrats and Republicans as being the best ever delivered here.

Tar Heel Congressman, John H. Small Says That Underwood's Votes Are For Clark

GIVES REASONS FOR SUPPORTING WOODROW WILSON

RALEIGH, May 16.—The Washington correspondent of The News and Observer yesterday secured an interview with Congressman John H. Small, wherein the congressman asserts that the Underwood vote will eventually be turned over to Champ Clark. Mr. Small is quoted as saying:

"The New York Herald in its issue of Sunday, the 12th inst., in a comprehensive review of the status of the contest for the presidential nomination in both parties contains this significant statement:

"That Representative Underwood now has 84 delegates in his column, which, it is generally understood, will be turned over to Speaker Clark, should it develop that Mr. Underwood stands no chance of getting the nomination."

"It has been asserted, and it is generally believed that there is a combination opposed to the nomination of Gov. Wilson, or in other words, that the field is against him. Every effort has been made to conceal this purpose, but some of the conspirators have not been discreet in their conversation, and besides, there are too many circumstances in evidence that support this statement. In the main the New York Herald is impartial, although in its review it does not fully state the number of votes which ought to be accredited to Wilson. At any rate it is certainly not partial to the New Jersey Governor, and the above quotation reflects the information which has been obtained by the New York Herald.

"Nobody believes that Mr. Underwood could be nominated under any conditions and it is perfectly well understood, so far as my information extends, that those who are behind the candidacy of Underwood expect to and will do all in their power to induce delegates who have been elected from states favorable to Underwood to cast their vote for Clark, when the name of Mr. Underwood shall be with drawn after the first ballot.

Underwood Speaker Jury in Allen Case Is Admits Trust Still Out

Up to Last Night the Jury in the Trial of Floyd Allen Had Not Agreed On a Verdict and Was Locked up Over Night.

WYTHEVILLE, Va., May 16.—The jury deliberating the fate of Floyd Allen, of the mountain clan that shot up the court of Carroll county was locked up at 9 o'clock tonight, after six and one-half hours of consideration of the case. If a verdict is reached during the night it will not be reported until court convenes tomorrow.

The case went to the jury early this afternoon when Commonwealth's Attorney Wysox concluded his argument. After three hours deliberation the jury returned to the court room. The foreman announced that no verdict had been reached, but that Juror W. T. Williams desired to ask further instructions regarding the possibility of a verdict for a lesser crime than first degree murder. The court outlined the law at length and the jury again retired.

Holland Pleads Guilty.

ASHEVILLE.—Walter J. Holland, charged with killing J. M. Edwards here last summer, submitted to being guilty of manslaughter before Judge Long today and received a nine months sentence on the roads.

Alabama Bankers Convention.

MOBILE, Ala., May 17.—Many well known men in financial circles filled the Battle House auditorium this morning at the opening of the annual convention of the Alabama Bankers Association. President F. H. Mody of Tuscaloosa delivered his annual address, following the usual exchange of greeting. Other speakers of the day included Prof. J. Lawrence Laughlin of the University of Chicago, A. E. Walker, state bank superintendent of Alabama, G. Grosvehor Dawe, director of the southern Commercial congress, and R. F. Kolb the Alabama commissioner of agriculture and industries.

Norwegians Keep Holiday.

MINNEAPOLIS, Minn., May 17.—Norway's great national holiday, "Syttende Mai," was celebrated as usual today by the thousands of the sons and daughters of Norway scattered over the northwest. The day is the 98th anniversary of the promulgation of the constitution of Norway by a popular assembly which convened at Eidsvoll, and after drafting a constitution, gave it official pronouncement and declared Norway a free and independent nation. In many Norwegian centers in Minnesota, Iowa, Nebraska and the Dakotas the festivities in observance of the anniversary will continue over Saturday and Sunday.

New Jersey Club Women.

MONCLAR, N. J., May 17.—Large and representative attendance marked the opening here today of the annual convention of the New Jersey State Federation of Women's Clubs. The programme for the gathering extends over two days and provides for papers, addresses and discussions dealing with a wide variety of subjects. The local club women have prepared elaborate entertainments for the visitors.

To Row for Historic Cup.

PRINCETON, N. J., May 17.—The vascity eights from Columbia, Pennsylvania and Princeton will compete on Carnegit Lake tomorrow in a race over a course of one and three-quarter miles. Experts who have watched the work of the various crews in practice agree that the contest is likely to be very close. The winner will be awarded the Childs Cup, which was presented in 1879 by the late George W. Childs of Philadelphia. It will be the first contest for the trophy since 1889.

Missouri Valley High School Meet.

KANSAS CITY, Mo., May 17.—High school athletes from far and near streamed into Kansas City today to compete in the annual Missouri Valley interscholastic track and field championships. High school stars from cities and towns throughout Nebraska, Iowa, Missouri, and Kansas are entered in the various events and in the number and high class of the entries the meet this year surpasses all of its predecessors.

Sutton vs Morningstar.

CHICAGO, Ill., Devotees of the "gentlemen's game" are anticipating a rare treat tomorrow night when George Sutton of this city and Ora Morningstar of Pittsburgh meet in Orchestra Hall in a contest for the 13.1 balk-line championship, which Sutton wrested from Willie Hoppe a short time ago. Both the title-holder and the challenger have made good performances in their practice work and appear to be in excellent form for the title. Fred Conklin, the former amateur champion, has been agreed upon as referee.

BUILDER IN TOWN.

Mr. B. Riddick, Jr., of Suffolk is back in Greenville to look after the repair of some of C. T. Munford's properties. Mr. Riddick says that he has a strong leaning for Greenville. He has built both sides of Evans street twice. In connection with his coming to Greenville it might be well to mention that Mr. Munford is thinking of re-building very soon. S. C. Endorse Wilson, To Go Uninstructed

Supporters of Governor Make a Strong Plea for Instruction But Fail To Obtain It

HIS ENDORSEMENT HOWEVER, ALMOST UNANIMOUS

COLUMBIA, S. C., May 15.—After voting to send the state's 18 delegates to Baltimore uninstructed, the Democratic state convention tonight adopted by a vote of 241 to 91, a resolution endorsing Woodrow Wilson for president. It was remarkable for its brevity: "Resolved, that this convention endorses Woodrow Wilson without instruction."

From the minute the convention formed its permanent organization tonight, it was apparent that the line of battle had been drawn between those advocating instructions for Wilson and those favoring an uninstructed delegation. The fight lasted for three hours of five-minute oratory. According to the speakers who were opposed to instruction, no attack was directed against Wilson. They simply wanted the state's delegates to be untampered, free to act, according to their best judgment if developments showed that some other candidate had a better chance to win than Wilson.

The anti-instructionists fired the first gun, scoring the first hit. They put through an agreement that any resolutions referring to the instruction of delegates should be taken up by the convention direct without the customary reference to the resolutions committee.

The instructionists came right back with a resolution exhorting Woodrow Wilson and instructing its delegates to vote for him. Back came another resolution in the form of a substitute providing for an uninstructed delegation. Some staunch Wilson adherents offered an amendment to the substitute that was in effect an endorsement of the New Jersey governor.

Taft "Not Even Mentioned" in W. Va.

HUNTINGTON, W. Va., May 16.—The West Virginia Republican convention tonight named six delegates at large to the Chicago convention; gave Roosevelt its unqualified endorsement and neglected to mention President Taft or his administration. Former Gov. Wm. O. Dawson had been made chairman of the convention today and it was apparent from the beginning that the friends of Colonel Roosevelt were in control.

The delegates at large: Gov. Wm. E. Glasscock, C. A. Swearingen, W. P. Hubbard, D. B. Smith, S. B. Montgomery, Wm. S. Edwards, Alternates, Jos. H. Taylor, Jas. E. Law, C. C. Beckol, Dawson McNeill, E. L. Hays and C. C. Barnett.

The action of the state convention tonight in instructing the six delegates at large for Colonel Roosevelt gives the former President a solid delegation of 16 votes from West Virginia. Yesterday ten delegates favorable to him were chosen in the five congressional districts.

WHO SHALL NAME DEMOCRACY'S CANDIDATE?

A philosophy that enables us to accept the verdict of the ballot in South Carolina and elsewhere with a fair degree of equanimity—with neither gloom in reverse, nor "gloating" in success—is not proof against a feeling of outrage at the mental contemplation of an agent representing a syndicate of men whose interests probably run over the billion dollar line, sitting in an office in New York and attempting to manipulate the Southern states in their preference for a Democratic president as he would move the pawns upon a chess board.

Woodrow Wilson made the charge that there is a powerful "money trust" that controls the credits and consequently dictates where and where not in this great country there may be great industrial developments. Woodrow Wilson is opposed to the pernicious tariff system that saps financial strength from the millions to suckle the favored few.

Stupendous, therefore, is the power of those whom Wilson has offended in his championship of the people's cause. Those who fear him are closely organized. Let us suppose that the spokesmen for a thousand million dollars come together—as they may readily do any day in New York—and determine that the election of a progressive Democrat whose motto is publicity and equal rights, would reduce the value of their illegitimate capital ten per centum, or \$100,000,000 and that to prevent his nomination they feel justified in investing one-half of one per centum of their capitalization or five million dollars.

These gentlemen who control immense interests know nothing about politics and are free to express their disinclination to mix in "such a dirty business" but several of them do know "just the man" to handle their money and direct the campaign in their interest. In other campaigns, industrial and political, that man has been their manager and distributed their half millions in most satisfactory manner. He knows all the public men in the country and is a past-master at "publicity". Let us imagine, then, that he whom we shall designate, for the sake of brevity, as C., is called into consultation and put in charge of the fighting forces. He is given a schedule of subscriptions money to be called for pro rata, as needed. The twenty-million-dollar man in the syndicate pledges himself for \$100,000; the fifty-million-dollar man is jotted down for \$250,000.

Any special orders for the agent of aristocracy of the plunderbund, with five million dollars to spend and the forty-odd states of this Union as his field? Nothing except, "Defeat Woodrow Wilson in the Baltimore Convention." Whom do the members of the syndicate wish elected President of the United States? None but Taft. To defeat Woodrow Wilson in the

Baltimore convention, indeed to prevent his winning on the first ballot, it was absolutely necessary to push the fortunes of other Democrats in localities where those Democrats are strongest and so wear away Wilson's strength. And it is along this line the work has been done. That idea of the newspaper supplements to blanket the South harmonizes perfectly with C's bold publicity work. Some of the foregoing is inference; all is logical. We do know those interests referred to are separately opposed to Wilson. We do not know they contributed several millions to defeat him. We do know that in other cases where these people fought that was their exact form of fighting. We do not know that C. is handling the funds. We do know that he has handled immense sums for those interests in other cases. We do know that C. was actively interested in the fight against Wilson last fall and that he was in the confidence of Colonel George Harvey during the Wilson-Harvey-Watterson incident.

We believe that C. is furnishing the brains and is in supreme financial command of the campaign against Woodrow Wilson and so believing, we vehemently protest against any agent or combination of agents pressing a button in New York and influencing the Democratic voters of the country by indirect and covert means. Shall the Democrats name their standard-bearer or shall a syndicate of New York wielders of the money power do so for them?

We entirely agree with Charity and Children in the following reference to two men whom the state should take pleasure in honoring:

We may be permitted to remark that two of our citizens ought to be sent as delegates at large to the Democratic convention at Baltimore. They are Mr. Edward J. Hale, of Fayetteville, and Gen. J. S. Carr, of Durham. We say this with no partisan thought in mind, but wholly on account of the service rendered to the state by these admirable citizens.

Marion Butler has about become a man without a party the Republicans having repudiated him. He led the party almost by the nose for years but the convention in Raleigh threw him overboard. A letter has got in print which Dr. Cyrus Thompson wrote Butler a few days before the convention in which he told him flatly that his (Butler's) "attempted leadership was the most serious impediment and obstruction in the way of its (the party's) growth."

The man who loves his home, that is his home town and feels that he owes something in return for the opportunity of making a living and the support it gives him, is the right kind of citizen. But the man who is a hanger on, simply grasping all in reach and bestowing nothing in return, profiting by the efforts of his neighbors, yet doing nothing to help others, is not worth the room he takes up. Greenville has some of both these classes.

The Kinston Free Press is anxious to know why there are so many candidates for lieutenant governor, being that the salary is not sufficient to be tempting and the honor a great thing. Possibly the aspirants have an idea that it is a stepping stone to the governor's chair next time and as the candidates out for lieutenant governor so far are eastern men, they may be looking to following of precedent and coming to the east for the governor in 1916, hence want to put themselves in line.

On the Republican side of the house it certainly looks like Roosevelt.

Nature of Food Prices

At last a rock-bottom, fundamental explanation of the high prices of food-stuff has been reached. It's not a case of too much profit to middlemen, or any question of "concerning" products of the farm and the ranch, or artificial manipulation of markets and prices by a beef trust or a butter trust. Far from it. Anybody who tries to reach a satisfactory solution of the problem presented by the high cost of living along those lines will have only his trouble for his pains, and a headache the next time he scans his bills. As the latest bulletins on the subject present the case, it is nature herself who's at fault. Butter and eggs and potatoes and the spring vegetables are unusually dear because spring is about a month behind time. Nature is guilty. The discovery will be gratifying to the ultimate consumer. He has not been helped by the pounredous investigations of legislative commissions and governmental investigators. The corner grocer testifies that he was hardly making a living, even if his prices were mounting year by year. The commission merchant and the wholesaler in various lines testified that their business was going to the dogs, and they really weren't making enough to pay them for their work. The beef barons testified, that they weren't profiting by sudden and amazing raise in prices of meats, for they had to pay so much more to the ranchmen for meat on the hoof. And the ranchmen and farmers in turn testified that they were being squeezed in the economic press, and that the profits were being distributed among the dealers. Now, all this has proved disquieting to the man who pays the bills. He hasn't been able to reason it out to his satisfaction, or even to take comfort in cursing his fellow-mortals who swear they're in as bad a case as he. Grumbling has been his only resource. Hence the advantage of the new light on the problem.—New York Times.

Negro Mortality.

The figures furnished by the board of health of the death rate in the city for the three months just closed gives the public a very serious matter for studious reflection. The number of deaths from all causes, was: Whites, 130; negroes, 171. The ratio of white to colored population is 2 to 1, so that the number of negro deaths on a mortal ratio should have been sixty-five. Instead

When King Edward, her grandfather, came to the throne, he raised her rank and she became Princess Alexandra Fife. And now, her father, who died several months ago while traveling in Egypt, having left no son to succeed him, she has become Duchess of Fife, though she is still known popularly as Princess Alexandra. She is the only duchess in her own right in the kingdom and even if she were not of royal blood, would take precedence of every duke except his grace of Westminster.

This frightful discrepancy not only appeals to the negroes themselves, but to the whites. What is the matter? Why this appalling disparity? Those questions may be answered in a general way by the explanation that the vast majority of negroes are careless, slothful, indifferent to proper sanitation, ignorant of the necessity of cleanliness and incapable of taking care of themselves when sick. All this may be true, but on the score of humanity it would seem to be somebody's duty—the negro leaders, white philanthropic associations, the city authorities, one or all—to cure these deficiencies. Instead of decreasing the negro mortality rate is increasing.

We should respectfully suggest that Commissioner Evans ask the co-operation of his colleagues for the appointment of a commission to investigate the living conditions in the various negro quarters and ascertain, if possible, the cause for this lamentable condition. It is a reflection, not only upon the negro citizenship, but upon the city.—Chattanooga Times.

The Morton Case

The Sun and Tribune both suffer from a lapse of memory when, referring to the case of Paul Morton, they say that when President Roosevelt gave an immunity bath to a member of his cabinet who confessed to having violated, knowingly and repeatedly the federal statutes against re-bating.

The case was worse than that. The offense of Paul Morton was committed when he was a high official of one of the trunk line railroads. Confronted with the accusation he made no denial and made no plea in extenuation except that the interests of his road necessitated the offering of rebates in order to obtain a fair share of the business in the face of sharp competition. On this the president, in the face of protests from the prosecuting attorneys in the employ of the government, ordered the proceedings stopped. The attorneys, indignant at Roosevelt's action resigned their special commissions; and not long afterwards President Roosevelt called the confessed lawbreaker to a seat in his cabinet thus offering to the American public the object lesson that lawlessness and dishonesty in a corporation official constitutes no bar to political advancement in the eyes that are too prone to look upon iniquity.—Virginian-Pilot.

NOTES FROM THE LABOR WORLD

The California Drug Clerks Association enjoys the distinction of being the only pharmaceutical organization in the United States maintaining a sick and death benefit fund.

The recent strike of grave diggers at the Glasgow (Scotland) cemeteries was settled and the men returned to work after the companies conceded to them an increase of 1 shilling a week.

At the end of 1910 there were 669 registered trade unions in the United Kingdom; with a membership of above two million. These totals compare with a membership of 211,091 in 1886 union in 1886.

Organization among the cooks of Chicago is showing exceptional returns. The various cooks organizations, which heretofore have been purely social and benevolent organizations are now looking to the international union for relief.

British trade unions gained but 16,000 members, or less than 1 per cent during the three years 1908-1910. The income of the hundred principal unions reached a total of \$40,005,000 and expenditures exceeded the income by \$2,610,000. Strike pay amounted to \$5,600,000.
