Manufacturers in Session.
NEW YORK, May 20.—Representatives of the business interests of the country from nearly every state in the Union assembled at the Waldorf-Astoria today for the opening of the seventeenth annual convention of the National Association of Manufacturers. The sessions today were devoted principally to executive business, but during the next two days the manufacturers will discuss a wide variety of subjects. Present economic conditions, and the developments during the past year in such vital activities as labor, politics, currency reform, industrial relief and trade education will be given attention. Employers' liability and workmen's compensation will be exhaustively discussed also the national eight-hour bill and the Clayton bill providing trial by jury in certain contempt cases. At Wednesday's session, the election of officers will take place. John Kirby, Jr. of Dayton, O., whose term as president of the association expires, is not seeking reelection, but it is probable he may be pressed to serve again.

Brewer's Case Goes to the Jury

Man Accused of the Murder of Policeman E. C. McConnell to Know His Fate Soon. Lawyer for Prosecution Closes Jury Address.

ASHEVILLE, May 18.—The arguments in the case of Wes Brewer, charged with the murder of Patrolman E. C. McConnell, were concluded at the morning session of superior court and Judge Long began his charge to the jury about 1 o'clock.

The concluding argument was made by J. W. Haynes for the private prosecution but before he began Judge P. C. Cooke of the defense concluded his argument which he began yesterday afternoon. His able presentation of the case received favorable comment and right here it may be said that whatever the outcome of the case the prisoner has had most masterly defense. Every point has been hotly contested and apparently nothing has been overlooked by his counsel that would help the cause.

Probably the most comprehensive argument was made by Mr. Haynes. He reviewed the case from start to finish and clearly showed it to the jury. An interesting phase of his argument was the tracing of the prisoner from point to point. This had of course been given in the evidence but it was more or less disconnected but Mr. Haynes summed it up in a most convincing manner.

The case was given to the jury at 2 o'clock and at 9 o'clock a verdict had not been rendered. A mistrial is freely predicted. The weight of opinion is that Brewer is the murderer but that he has not been proven guilty.

Officer Shot By Negro in Wilmington Richeson is Anxious to Reach Chair

Mounted Policeman R. J. Thompson Shot By Negro is in a Serious Condition

TROUBLE MAY RESULT IF THE OFFICER DIES

WILMINGTON, May 19.—Mounted Policeman R. J. Thompson, who was shot and seriously wounded early this morning in an alley in the eastern section of the city by a negro whose identity at the time was not known, but has since been arrested, is regarded as in a very precarious condition at the hospital and it is said that he has small chance of recovery.

Policemnn Thompson was called to the home of a woman by a disturbance it being alleged that two negroes had broken into the house. As the officer approached one of them fired at the officer, who quickly returned the fire. The officer was struck in the breast the bullet penetrating the left lung and barely missing the heart. He fell. The negro did not stop. A fellow officer who heard the shooting came up and notified headquarters.

This morning Beattie was arrested as he was about to board an outgoing train at Hilton Bridge. He attempted to take the "billie" and pistol from Officer Wood, who arrested him and who was forced to shoot him. It was found that the negro was wounded in the knee from a bullet from Officer Thompson's revolver the night before.

Feeling is running high against the negro, who was taken to jail, after his wounds were dressed and should the officer die it is not at all probable but there would be a serious demonstration.

C., May 20.—Charlotte today opened her annual celebration in observance of the anniversary of the signing of the Mecklenburg declaration of independence, a document said to have been promulgated here on May 20, 1775, nearly a year in advance of the celebration at Philadelphia. The celebration will last nearly the entire week and is expected to attract thousands of visitors. The annual exhibition of manufacturers, together with baseball games, parades, aeroplane flights, band concerts and other features of entertainment make up the program.

Has Made Peace With His God And is Resigned to Meet His Fate

PRISONER RECALLS THE DAYS OF HIS BOYHOOD

BOSTON, Mass., May 19.—"I have made my peace with God; I am resigned to my fate. I wish now to go to my death as soon as possible, the quicker the better."

These words, spoken by Clarence V. T. Richeson, former Baptist minister and confessed slayer of Avis Linnell, to the Rev. Herbert H. Johnson, his spiritual adviser today expressed the mental condition of the condemned man, whose tenure of life is now measured only by hours.

There is much reason to believe that he will go to his death in the electric chair shortly after midnight Monday.

Reclining on a cot in his death cell, Richeson talked long and earnestly with Mr. Johnson and the prison chaplain, the Rev. Herbert W. Stebbins.

"I do not want to sleep. I have so little time to live and so much I want to say that I must talk, talk," he said. Part of the conversation was of meditative and religious nature, and part was reminiscent. The prisoner reviewed countless incidents of his boyhood in Virginia; his college days at Liberty, Mo., furnished topics.

When the hour of execution arrives, Mr. Johnson, his spiritual adviser, will precede him in the short walk to the electric chair. Three physicians, the prison doctor, the county medical examiner and the surgeon-general of the commonwealth will attend as the legal witnesses. The prison chaplain also is entitled to attend.

In Memory of Mecklenburg Signers

RALEIGH, N. C., May 20.—A tablet commemorating the signing of the Mecklenburg declaration of independence was unveiled at the capitol this afternoon with interesting exercises. The tablet was presented to the state by the North Carolina Society of Colonial Dames of America. Chief Justice Walter Clark delivered the principal address and Governor Kitchin accepted the tablet in behalf of the state.

New Presbyterian Minister.

Mr. R. V. Lancaster, of Ashland, Va., who is to serve the Presbyterian church here as pastor during the summer, preached in that church both Sunday morning and night and made a most favorable impression upon our people. Out of esteem for the new minister the other churches of the town closed Sunday night and the congregations worshipping together in the Presbyterian church.

Jenkin Lloyd Jones of Chicago addressed the annual meeting of the Ministerial Union in Channing Hall. Daily sessions will be held during the week and the anniversary is expected to be one of the most memorable ever held by the association.

For Murder in Lowell Strike.

SALEM, Mass., May 20.—A special venire of 100 jurymen reported to the Essex county court here today in readiness for the trial of the several men indicted on a murder charge as a result of the killing of a woman in the street riots during the recent textile strike in Lowell. Joseph Caruso, who is accused of having fired the fatal shot, is to be tried as principal and Joseph J. Ettor, a Socialist editor and agitator and his assistant Giovanniotti, are to be tried as accessories.

Coffee Men Going to Brazil.

New York, May 20.—A delegation of ten members of the American Coffee Roaster's Traffic and Pure Food Association sailed on the steamer Vassar today for Brazil to investigate the coffee plantations in that country with a view to bringing about a system of co-operation among the coffee dealers of America and Brazil where three-fourths of the coffee imported into the United States is grown. The visit of the Americans is in response to an invitation from the Brazilian government.

Cotton Storage House.

Moseley Bros., have recently purchased what is known as the Chas. Johnston lot, near the Norfolk Southern depot, their intention being to erect there a large brick storage house for storing cotton. We like to see improvements of this kind going on.

Col. J. C. L. Harris for the Senate

RALEIGH, May 18.—Colonel J. C. L. Harris, who placed a big chunk under the steam roller operated by former Chairman Lester F. Butler in the interest of party harmony, was this afternoon nominated by the regular Republican convention for the state senate. Colonel Harris blushing accepted the nomination and promised to do his best—especially if Roosevelt is nominated—to redeem Wake county. Colonel Harris said that if the Democrats had reached that stage where they can meet argument with argument, he would be glad to go about the country with his friend, J. C. Little, whom the Democrats will name at the same time the Republican confirm in a primary election the nomination of the convention today.

The candidates for the house are: J. R. Chamberlain, of Raleigh; Alf Pempleton, of Cray, and D. T. Bryan, of Auburn. Walter R. Ferral, of St. Mathews, was nominated for the house but declined, promising, however, to do all in his power for the success of the ticket.

The convention today was all harmony. There was but one of the unseated crowd in the hall—the convention was held in the assembly room of the Electric building—and he was a welcome visitor. Mr. George Glenn is the name of the representative of the other faction and if he came on a mission of peace he did not let it be known. He seemed to be counting heads and this led one of the delegates to remark that there were enough present to take care of the county.

Neither Taft Nor Roosevelt Have Proven Their Qualifications for Re-election

G. H. PERKINS HAS IMPORTANT PART IN GAME

Special Correspondence WASHINGTON, May 20.—When thieves fall out, just men get their dues, and when Republican presidents and former presidents fall out the people learn how they have been mis-governed.

Since President Taft and former president Roosevelt entered upon the wild scramble to obtain delegates to the next Republican convention, the people have come into possession of the following information, which they never knew before; except as it came to them through unproven charges or unverified rumors.

That Mr. Taft, by his own admission, has been "a man of straw." That Mr. Taft, in his advocacy of Canadian reciprocity, was not thinking, primarily of any benefits that would come to the American farmer and wage earner, but that he believed reciprocity would make Canada an "adjunct" to the United States, which would transfer her important business to New York and Chicago. By his own confession the president was thinking of the big business interests when he was advocating reciprocity.

That George W. Perkins, organizer of the harvester trust and member of the board of directors of the steel trust was highly pleased with the present administration's methods of prosecuting the trusts.

That there is a close political alliance between Mr. Perkins and Theodore Roosevelt, as evidenced by the fact that Perkins in a sworn statement to the Secretary of State of New York, admits he spent \$15,000 to help Roosevelt in the primary election in New York city this spring, thus revealing that the big interests would be perfectly satisfied to have either Taft or Roosevelt as president.

That Mr. Taft, in the present campaign and Mr. Roosevelt, in his campaign of 1908, made free and unrestricted use of federal office holders to obtain the nomination.

That Mr. Roosevelt's trip to Africa was paid by Andrew Carnegie, the greatest beneficiary of a Republican high tariff that ever lived.

That Mr. Roosevelt was so frightened by the possibility of tariff agitation during his more than seven years of office that in all his messages and official papers he never made any mention of tariff except to say once, that he would discuss it in a future message; which statement he withdrew from the message before it reached Congress.

If the present scramble for delegates continues a while longer it may safely be said, therefore, that both Mr. Taft and Mr. Roosevelt, at the present rate, will thoroughly demonstrate that neither of them is fit to be president.

WILL DEMOCRATS INVITE DEFEAT?

Surely no well informed Democrat can be deluded into the belief that it would be party policy to nominate a reactionary. While the division in the Republican ranks seems to insure success, unless the Baltimore convention makes some egregious mistake, still the party's chance of success rests entirely upon the nomination of a progressive Democrat, upon a progressive platform. In no possible contingency would it be politic to nominate a man suspected of reactionary tendencies.

The Republican national convention may do one of three things and no one at this time can say which. It may renominate President Taft, but if it does so, it will be through the influence of the southern delegates. For Mr. Taft is not likely to have a majority of the delegates from the northern states. In case Mr. Taft is nominated, the progressive Republicans—that is, the rank and file—would be likely to support any Democrat known to be progressive; but as between Mr. Taft and a reactionary Democrat, they would naturally prefer Mr. Taft, and thus, with the slump that would follow along progressive Democrats, would insure Mr. Taft's election.

But the Chicago convention may nominate Mr. Roosevelt for a third term, in which case the nomination of a reactionary Democrat would be equally fatal because Mr. Roosevelt would draw enough progressive Democrats to offset his loss among the stand-pat Republicans, so that his election would be assured. The nomination of a progressive Democrat, on the other hand, would insure the defeat of Mr. Roosevelt, because a progressive vote, and the Republicans who oppose Mr. Roosevelt would have nowhere else to go and would vote the Democratic ticket from necessity.

But a third contingency is possible. The fight between Taft and Roosevelt has become so bitter, that they may be put aside and a dark horse nominated. If LaFollette should happen to be the lucky man, it would take a very strong progressive Democrat to hold all of the Democratic votes. A reactionary Democrat would be defeated before the battle was begun. If the dark horse proved to be a man satisfactory to both the Roosevelt and the Taft element, Democratic chances would be very much lessened and no one could hope for success, unless he was in a position to take advantage of the progressive sentiment of the country—a reactionary would have no possible show of election. This is the situation as anyone must clearly see who will give a moment's time to the serious consideration of politics.

Why, then, are the Democrats willing to invite defeat by encouraging the candidacy of a reactionary? It is easy enough to understand the tactics of Wall street, because Wall street has no politics. It does not

matter to Wall street whether the president is a Democrat or Republican, provided, he goes to Wall street for advice. What Wall street wants is to nominate both tickets and then elect the Republican ticket; for it is beyond Wall street's power to elect the Democratic ticket, even if it wanted to. It can not throw its entire influence to the Democratic ticket, for however satisfactory the candidate himself may be to Wall street, Wall street is afraid of the Democratic party and it knows that a Democratic president could not carry out Wall street's policies, even if he used all the patronage in his effort to do so. The most that Wall street could do is to nominate a Democrat who would be easily defeated; and having nominated a man whom the rank and file of the party would not support, it would then abandon him to his fate, and leave the party where it left it in 1904.

Can it be possible that the Democrats who have fought so loyally for twenty years against the predatory interests, can be duped at this time, and are they willing to throw away the best chance they have had of victory, merely to please the element that has brought defeat to the party for sixteen years. Will the Democrats risk the election of Mr. Roosevelt for a third term, with all that that means in the overthrow of the traditions of the nation? Will they, by nominating a reactionary, enable Mr. Taft to regain the confidence of the people—confidence which he has lost as few presidents have lost it?

The road would seem to be a plain one—leading to victory, with all that victory would mean to our party. Both principle and policy point the way. The party needs only to have faith in the wisdom of doing right, it needs only to stand firm and retain the confidence that its splendid fight has won.

If the Republicans had authorized the Democrats to map out a course for the Republican party with the view of securing the overwhelming defeat of that party, a Democratic committee could not have advised all of the mistakes that the Republican leaders have made and the Democrats would not have been ashamed to ask the president and the ex-president to enter into the unseemly fight in which they are now engaged. Surely the circumstances favor the Democrats, unless the Democrats themselves deliberately destroy the hope of Democratic victory and they can destroy it in but one way, viz., by surrender to the interests, by retreat from the high position that they have occupied, by compromise with those who are exploiting the masses.

In the township primary here Saturday afternoon the only idea displayed in the selection of delegates to the county convention was based on who the delegate favored for United States senator. There would have been some reasonableness in this if either the county convention or the coming state convention had any bearing upon who is to be senator. As the senatorial matter is to be settled in a state primary, the question should have no place in the conventions. The party has more important matters before it this year than who is to be senator.

Socialism and Anarchy

The Industrial Workers of the World, says the Kansas City Journal are seeking for some creditable organization to tie it. Having no principles themselves, acknowledging no authority in law or morals and being incapable of the exertion required for intelligent organization, they have endeavored to engraft themselves on the national body of organized labor, and also on the national Socialist party. They have had poor success thus far in both attempts.

William D. Hayward, former labor leader and member of the Socialist executive committee, is the acknowledged head of the Industrial Workers.

Wherever there is trouble, lawlessness and destruction, there is Hayward. When he proposes that the Socialists in convention at Indianapolis endorse the Industrial Workers, Congressman Berger worked hard against it. This fact seems to have split the Socialists. The rank and file will have to choose between rampant anarchy as represented by the Industrial Workers and the more law-abiding and idealistic theorists who espouse the cause of Socialism. Speaking of the present situation, Congressman Berger said: "Ten to one the delegates (to the Socialist convention) are opposed to direct action and other violent principles of the Industrial Workers. The Socialist party cannot afford to continue to be embroiled with this riotous organization. There has been too much of this on the Pacific coast and elsewhere."

This is very sensible talk from one of the leading Socialists of the country. Mr. Berger is both wise and cautious in this matter. He knows that more anarchy cannot win sympathy or support from the great mass of the American people. The most formidable criticism of Socialism is that it is utterly impracticable. Its theories, many of them, are beautiful, its highest ideal being the brotherhood of man. Socialism, as advocated by the better class of Socialists, means peace, protection and prosperity for all. That is directly opposed to the Industrial Worker's program. Pure Socialism has nothing in common with anarchy. Professed Socialists sometimes make the mistake of attacking the American flag and inciting strong opposition to their cause by reason of their tactless and unpatriotic activities.

Every time a crime is committed in the name of Socialism, that cause is weakened. Every time some alleged Socialist tears down the American flag and insults it he erects a barrier for Socialism to overcome. Socialism

can never gain many recruits adopting educational methods. And education is opposed to bloodshed and disorder and does recognize the necessity for some form of authority and laws for society.

A Feminine Difference.

In England yesterday, there began what is perhaps the first serious and determined prosecution of those militant dames and damsels who resort to violent methods in their campaign to secure the ballot. These of the haughtiest of all the suffragettes were arraigned on the charge of having conspired together "to incite the malicious damage of property" and as the emboldened attorney general declared, to launch a movement "which, had it succeeded, would have meant nothing less than anarchy."

The British males are plucking up courage. Heretofore they have been content with simply imprisoning their pugnacious Amazons and forcing them, willy-nilly, to eat. The prevailing opinion, however, has been that it would not do to take the suffragettes too seriously or to treat them other wise than with bored toleration. What if they throw bricks at officers of the house of commons and break upon the proceedings of that body with their terrible din? The men should preserve an austere and truly masculine dignity. They should not be drawn into more than a cursory rebuke of such conduct.

But when the women went so far as to throw bricks at plate-glass shop windows, why, then the time for drastic reproof had arrived. And so the prime movers in the famous London affray are now on trial, if convicted they will be punished in a truly exemplary fashion.

The curious thing about the suffragette cause in England is that it seeks such uncomfortable means to accomplish its ends. In six or more states of this country, the ladies have won the precious privilege of voting without the slightest recourse to turbulent or painful methods. Is this because our own suffrage leaders are fairer to look upon than their English cousin or because they are more essentially feminine in their tactics and hence more potent in their appeal to the trousered half of society? We recall that in a certain western commonwealth, the ladies dispensed pie among the crowd prior to the election that was to decide the suffrage issue. Doubtless, the English dames would get farther and fare better, if they followed this delectable example.—Atlanta Journal

ter being called to the bar in 1868 he practiced his profession for some years in his native place and in 1870 removed to Montreal, where he became law partner of the late Sir J. J. C. Abbott. He was appointed to the Superior court of the Province of Quebec in 1887 and since 1906 he has held the position of chief justice. Knighthood was conferred upon him in 1897 in recognition of his distinguished services on the bench.

News Forecast For Present Week

WASHINGTON, D. C., May 18.—Ohio, the home state of President Taft, candidate for renomination on the Republican ticket, and of Judson Harmon, who aspires to head the Democratic presidential ticket, will have a practical monopoly of the political stage the coming week. With the exception of the Democratic state convention in Virginia, the primaries to be held by both parties in Ohio Tuesday will furnish the only event of the week for the selection of delegates to either of the national conventions. Immediately after the close of the Ohio campaign President Taft and Colonel Roosevelt will turn their attention to New Jersey, which is to furnish the battleground one week later. Both the leading Republican candidates and Senator LaFollette also will be heard in New Jersey toward the end of the week.

To demonstrate the evolution of transportation methods, especially in the United States and Canada, a Travel and Vacation Exhibition will open Thursday in the Grand Central Palace in New York City, to continue for one week. The exhibition will be the first of its kind ever held in the United States.

The great concrete causeway at Galveston, Texas, connecting the island with the mainland, will be formally opened Saturday with elaborate ceremonies. The completion of this great engineering achievement marks the final completion of all the monster protection works undertaken since the flood that devastated the city ten years ago. The cost of the work aggregating \$10,000,000.

The annual regatta of the American Bowling Association, popularly known as the Amerocean Henley, will be held Saturday on the Schuylkill River course in Philadelphia. The contestants in the several events will include crews of all the leading schools and colleges in the immediate vicinity.

Passing of Old Landmark.

WASHINGTON, D. C., May 20.—The rap of the auctioneer's hammer resounded today through the corridors, parlors and chambers of the Arlington Hotel, marking the beginning of the end of that famous old hostelry. The entire furnishings of the hotel are being sold at auction and when the sale is finished the old buildings will be dismantled and out of the debris will arise the new Arlington, expected to be one of the finest hotels in the country.

Washington hotels possess an interest of their own. To the great traveling public they are more than mere commercial institutions—they invest themselves with an historic interest which hardly attaches to public hostleries in other great cities. For many years the Arlington has been one of the landmarks of the national capital. The hotel is situated on Vermont avenue, almost on the corner of H street, opposite Lafayette square. Diagonally across is the famous home of Dolly Madison. Three stately residences formerly occupied the ground where the main body of the hotel now stands.
