Two Terms Are Enough For Anyone

Parting Shot Delivered by Taft
Against Teddy in Closing Ohio
Campaign

**IN ALL TAFT
SPOKE 145,000
WORDS IN OHIO**

DAYTON, O., May 21.—Having spoken in the last of approximately 145,000 words, six hours after Col. Roosevelt had rounded out his 130,000, President Taft brought to a close here tonight his extraordinary appeal for the endorsement of the Republican party in his native state.

It was the last of ninety-eight speeches made by the president, which is twelve more than made by the Colonel. Just before the president left for Cincinnati, where he will vote tomorrow, he expressed complete satisfaction with the situation.

He said: "I believe that my fellow citizens of Ohio will vindicate my action in being compelled to take the stump to defend my honor and the interest of the country."

The president continued to flay the Colonel through his long day of speech making in the stretch of farming country between Cincinnati and Dayton. His last word to the 3,000 people he addressed in Memorial Hall here was in derision of his old cabinet chum. Even after he had made an impressive appeal to the voters of Dayton for their support he indulged in a fling at the Colonel.

Ridiculing the egotism of the Colonel he made what his hearers interpreted to be a promise that he would not seek a third term if he was elected for a second.

He said, "I believe that two terms are enough for any man. I believe that no man should seek a third who has been honored by his country with two. And I want you, the people of Ohio, to stand by me and you will find that I will keep my word. And there will be no equivocation about it either."

The president made three speeches here in winding up his campaign. The first was to the 1,000 inmates of the soldier's home, the second to 2,500 people from a motor car and the last in the hall. The local militia turned out in his honor, there was a torchlight procession and even the rowdism of the Dayton police force could not prevent the great ovation given him in the hall.

The Wards are father and son and the Youngs are brothers.

News of Our Native State Briefly Told

Car Overturned Injuring Occupants.
CHARLOTTE.—A large touring car, en route from Asheville to New York, overturned three miles from the city on the Salisbury road this morning. J. I. H. Raedecker of Parkersburg, W. Va., was pinned under the car and painfully bruised and hurt. Miss Ida Hamilton of Asheville suffered an injury to her shoulder and W. P. Artz of Old Point, Va., was bruised.

Underwood Leads.

WILMINGTON.—Certain Wilson partisans throughout the state persist in making misleading statements that Wilson carried New Hanover. The night of the primary the Wilson leaders only claimed thirty-nine delegates and in this number were two from a country precinct that had not been heard from. When the vote from the precinct in question was received both were for Underwood.

Says Reports Shows the State for Underwood.

LEXINGTON.—Reports from different sections of North Carolina, says H. B. Varner, indicates that Hon. Oscar W. Underwood has won the state 24 votes to the Baltimore convention beyond any question. The only hope of the Wilson forces is to use the party machinery to manipulate the delegates and suppress the will of the people at the county convention, Saturday, May 25.

Durham Hospital to Inforce Rule

Institution Has Been Treated More Like a Charitable Hospital, But From Now on, Patients Must Give up That Idea.

DURHAM, May 21.—George W. Watts, president of the board of trustees, signed a statement regarding some changes in the management of the hospital. The statement calls attention to the fact that the hospital lacked about \$10,000 of paying expenses last year and attributes the shortage to the fact that the charity feature of the institution has been greatly imposed upon by people who have received treatment at the hospital. About 60 per cent of the patients have not paid for their treatment at the hospital. Durham physicians have been bringing their charity patients to the hospital and treating them there, and there is an intimation in the statement of the chairman of the board, that the hospital has been giving its services free, while some physicians have been collecting their fees from these so-called charity patients.

Hereafter charity patients will be requested to sign the following statement: "In becoming a patient at the hospital, I certify that neither I nor my family are able to pay anything for treatment to the hospital or physician and I wish to be placed in a charity ward."

In the future the policy of "no pay at the hospital, no pay to physician," will be strictly enforced at the Watts hospital.

Judge Lane Opens Court.

STATESVILLE.—Judge H. P. Lane of Rockingham county, the youngest judge on the bench, is presiding at the term of Iredell superior court, which began yesterday by exchange with other judges. Mr. D. J. Craig of Statesville, was made foreman of the grand jury. A number of cases of the criminal docket have been disposed of, but none of more than local interest.

Destructive Fire in Fertilizer Plant.

CHARLOTTE.—The main dump shed of the Charlotte branch of the Virginia-Carolina Chemical Company, valued at \$30,000 and its contents of fertilizer, valued at \$50,000, was destroyed by fire originating at a late hour last night. The loss is understood to be fully covered by insurance.

TAFT GRINS NO MORE AS REPORTS FROM HOME STATE FAVOR ROOSEVELT

Third Term Will Have a Majority of Fifty Thousand Over Erstwhile "Dear Bill" So Dixon Says. Harmon Leads Democrats With Wilson a Close Second

COLUMBUS, O., May 21.—On the face of the early returns in Ohio's first presidential preference primary today, Col. Theodore Roosevelt led the Republican ticket by 3 to 2 over Taft and Governor Woodrow Wilson of New Jersey, led Governor Harmon, of Ohio, on the Democratic ticket by about the same percentage.

These returns, however, were given on a basis of complete figures from little more than 250 precincts out of a total of 5,192 precincts in the state.

President Taft appeared to have carried Cincinnati by a large margin and also Toledo and Dayton, among the larger cities. This was more than offset by the vote given Colonel Roosevelt in Cleveland and other cities. The Roosevelt lead in the north end of the state, it seemed, would give the former president an advantage which Mr. Taft could not overcome by his vote in the south end of the state including Cincinnati, his home and the rural districts.

Senator LaFollette received a larger vote than state politicians had predicted for him, getting a considerable fraction of the vote cast in the northern end of the state including Cleveland.

Governor Wilson, like Colonel Roosevelt was given his biggest vote in the city of Cleveland and the surrounding counties. Governor Harmon polled a heavy vote in Columbus, the capital and also in his home city, Cincinnati.

Harmon's campaign managers, despite the early figures, declared that their candidate had carried the state through the heavy vote they expected had been given him in the country districts. Governor Wilson's math strength they said, had been in Cleveland, where Mayor Newton I. Par-

ker had waged a strong fight against Harmon. Mayor Baker, however, in a statement issued by him at Cleveland insisted that Governor Wilson had carried Ohio by a vote of 2 to 1.

Both Champ Clark and Mr. Bryan, although their names were not on the preference ballot and they were not represented by delegates were given a scattering vote throughout the state, which, when final returns have been received, may effect the outcome of the Wilson-Harmon race.

Washington, May 21.—At midnight Senator Dixon issued the following statement from the Roosevelt national headquarters:

"There is no further room for argument. On last Thursday at Columbus, Mr. Taft in his speech said:

"The vote of Ohio, my home state, will be the deciding one, and will settle the question of the nomination." Ohio has spoken.

"By a majority of probably 50,000 she has declared her preference for Theodore Roosevelt as the Republican nominee for president. Roosevelt will have 44 of the 48 delegates in Mr. Taft's own state.

"Theodore Roosevelt will be nominated as the Republican candidate for president on the first ballot at Chicago and will be elected in November by the biggest majority ever given a presidential candidate. This is the end of the contest."

No statement was issued by the Taft managers tonight. It was stated at the president's headquarters that more complete returns would be awaited before comment would be made. Both headquarters were besieged by members of Congress and political leaders tonight for news of the Ohio fight.

ST. LOUIS, Mo., May 22.—The cases of J. J. Beall and Frank Quinn, who were convicted in the Federal court in Oklahoma on charges of conspiracy to prevent negroes from voting for Congressmen were called for argument today in the Federal court of appeals in this city.

Three Big Colleges in Boat Race.

BOSTON, Mass., May 22.—The most notable aquatic event that is likely to be seen hereabouts this season will take place on the Charles River Basin tomorrow, when the varsity crews of Cornell, Princeton and Harvard will engage in a two mile race. It will be the first time since 1874 that Harvard and Princeton have met on the water. As a curtain raiser to the big triangular race there will be a contest between the freshman crews of Cornell and Harvard.

New York Man Takes English Bride.

LONDON, May 22.—At one of the most fashionable weddings London has seen this season Miss Julia Sanford Capin, daughter of Robert Capin, today became the bride of R. E. Alsop of New York. The ceremony was performed at St. Margaret's church, Westminster and was followed by a large reception.

Richeson Pays the Penalty for His Crime

**Murderer of Avis Linnell Goes to
Chair Prepared to Meet His
Maker**

**ATTENDED TO
THE LAST BY
DIVINE ADVISER**

BOSTON, May 21.—The body of Clarence V. T. Richeson who was executed early today for the murder of Avis Linnell, lay at the North Grove street morgue tonight. Earlier in the day Dr. George B. McGrath, medical examiner of Suffolk county, performed the autopsy required by the law and declared that Richeson's brain was normal. Douglas Richeson, of Chicago, brother of the dead man, was undecided regarding the disposition of the remains and the matter probably will be settled tomorrow. It was the understanding, previous to the execution, that the body would be taken to Richeson's boyhood home in Virginia for burial, but circumstances arose today which prevents the plan being carried out.

The Rev. Herbert S. Johnson, who as spiritual adviser accompanied Richeson to the electric chair, issued a statement today explaining that certain questions were asked the condemned man as he was being strapped in the chair for the purpose of taking Richeson's mind off his ordeal and to meet Richeson's wish to leave some religious testimony for the witnesses. Mr. Johnson's statement in part was as follows:

"The warden said that he wished I could make the man talk from the death chair as they would take his thoughts off himself and his passing could occur without a period of distressing suspense. The warden explained to me how he would give the signal for the application of the current when the man's breath was exhaled. He also requested me, so far as possible, before the execution to keep Richeson from talking about it and to keep his mind engaged with other things."

Make Another Effort to Capture Allen

**Reward on Sidna Allen's Head In-
creased to \$1500. That of Edwards
to \$750. No Clue Whatever to
Their Whereabouts.**

ROANOKE, Va., May 21.—Tonight W. G. Baldwin of the Baldwin-Felts Detective agency which has in charge the matter of running to earth the members of the Allen clan who are under indictment for the Hillville murders, announced an increase of rewards in excess of that already offered by the state, the additional rewards being offered for Sidna Allen and Wesley Edwards. The offer was made on the authority of Governor William Hodges Mann.

The additional offer puts \$1,500 on the head of Sidna Allen, dead or alive, and \$1,000 is offered for any information leading to his arrest or capture dead or alive.

Seven hundred and fifty dollars is placed on Wesley Edwards, dead or alive and the person furnishing information leading to his arrest will receive \$500.

Boys Killed In Freight Wreck

**TRAVELLING A LA JACK
LONDON MEET DEATH**

HENDERSONVILLE, May 21.—Otto Edney and Ernest Hill, aged 15 and 13 years, respectively, both of Hendersonville, were killed in a Southern railway freight wreck at Naples, four miles north of here, this afternoon while hobnobbing from Asheville. Medical attention was given them, but both died about the same time while being brought to this place in an auto truck. Their bodies were badly bruised and cut. The cause of the wreck is unknown. The track was torn up for some distance and traffic will be delayed for several hours. There were no further injuries.

Death of Col. Taylor in Wilmington

**CLERK OF THE SUPERIOR
COURT PASSES AWAY**

WILMINGTON, May 21.—After an illness of some weeks, following a fall received on January 7, Col. John D. Taylor, clerk of superior court for 22 consecutive years, resigning March 4, last, on account of ill health, died this evening at his home here, in the 82nd year of his age. His death was due to infirmities of old age rather than to any malady. Up to the time of his fall he was at his office nearly every day. He served throughout the war and had a splendid record as a soldier and officer. He was captain of company K, Brunswick artillery of the 36th North Carolina regiment and was there when the fort fell. He went from there with troops under him to Bentonville, the last big battle of the war in which Colonel Taylor lost his left arm.

Colonel Taylor was a devout Christian and was a man of most genial disposition, beloved by all who knew him. He is survived by several children, as follows: Mrs. P. B. Manning, J. A. Taylor, Walker Taylor, of Wilmington; Mrs. A. M. Scales, of Greensboro; Mrs. C. E. Borden, of Richmond, Va.; Mrs. W. H. Pemberton, Miss Fannie Taylor and E. T. Taylor of Wilmington.

NATIONAL CAMPAIGN FOR INDUSTRIAL BETTERMENT

Employers and Workers Gather at 17 Annual Convention of National Association of Manufacturers

Several thousand employers, factory superintendents, managers and workmen from every section of the country gathered at the seventeenth Annual Convention of the National Association of Manufacturers of the United States at the Waldorf-Astoria Hotel New York City, on May 20, 21 and 22. The convention marks the opening of the greatest constructive campaign ever inaugurated in this country to improve the efficiency of American industrial methods by educating both workers and employers.

Among the special features which were arranged for the occasion three motion picture films, each of which has its own lesson on the cause, effect and remedy. The first shows the occurrence of an accident in a factory with its attendant injury, and the logical effect of the casualty both upon the worker and his family or relatives. This film was especially prepared for the National Association of Manufacturers and was followed by a film showing the practical application and the use of accident prevention devices on a great number of machines in the plant of the Brown & Sharpe Manufacturing Company, of Providence, Rhode Island. The pictures prove as clearly as would a personal visit of inspection to any plant the practicability of adopting remedies for at least seventy-five per cent of the total number of industrial accidents which occur in the United States every year.

The other motion picture film is entitled "Insuring Safety at Sea," and comprises the result of a careful investigation into the field of practical life-saving apparatus, as promoted by the various trans-Atlantic steamship companies. The pictures also include some of the latest and most adaptable forms of rescue apparatus which are of particular interest at this time.

This convention was the first of a series which the Association will hold primarily for educational purposes, on the question of promoting industrial efficiency. For more than two years the organization has been actively engaged in the field of accident prevention and compensation for the workers; during that period its Committee on Accident Prevention and Workmen's Compensation has completed and published in book form the result of an exhaustive first-hand study of the various European safety appliances, and systems of workmen's compensation insurance. The work has been widely commended and its recommendations have rendered valuable assistance to the numerous State Commissions considering the subject

for purposes of legislation. The Committee has also given much personal assistance to these bodies and will make a full report at the convention. Besides the motion picture films there was arranged in the Colonial Room of the hotel an Accident Prevention Exhibition, consisting of almost 2,000 photographs, a large number of working models of safety appliances and the greater portion of the safety-at-sea apparatus shown in the motion pictures. The Wisconsin State Industrial Commission has contributed to the photographic exhibit, and the United States Steel Corporation has arranged an extensive array of working models from its various plants. The trans-Atlantic steamship companies will have experts on hand to explain the details of the safety-at-sea exhibition.

Addresses on the various branches of the efficiency campaign were delivered by Fred. C. Schwedman and James A. Emely, of the Association's Workmen's Compensation, together Committee on Accident Prevention and with an address by J. Philip Bird, general manager of the Association. A special department of cooperative information has also been organized to afford the employers in attendance, an opportunity further to equip their plants and understand the operation of practically safety appliances.

Another branch in the national campaign to promote the welfare and efficiency of employe and workers which will be touched on at the coming convention is the question of fire prevention. In this connection there will be a symposium of information recently obtained from the fire chiefs of more than twenty of the largest cities in the country, giving their views on the practical methods of reducing the annual losses of fire. This symposium was presided over by Frank H. Wentrow, secretary of the National Fire Protection Association. The report of a special committee on the regulation of the sales and high explosives was also received.

Another feature in the motion picture entertainment was the presentation of a highly instructive film showing the actual construction and present state of the Panama Canal. This was accompanied by an address by Charles A. Conant, of New York, on the relation of the Panama Canal to commerce and transportation, as well as its probable effect on our American trade with South and Central America.

John Kirby, Jr., of Dayton Ohio, president of the Association delivered his annual address and officers were elected for the ensuing year. Among the committee reports which were received at the convention, are Industrial Education, Immigration, Patents, Banking and Currency, Merchant Marine and Union Label. The Convention closed with the annual banquet on the evening of May 22nd.

WITH OTHER EDITORS

"Who Burned Columbia?"

Whether or not it is worth while for the State of South Carolina, through its General Assembly, to publish, the official deliverance of the Commonwealth, a revised and final account of the burning of Columbia—as suggested by Mr. W. D. Woods of Darlington in a letter to The State—is a question depending largely for its answer upon the demand which exists for such a publication. Unquestionably it would be desirable to have a reliable and authoritative account of the conflagration, but the imprimature of the state would not alone invest any publication with that character. An exceedingly careful investigation, comprising the taking and digesting of direct testimony, as well as the collation and analysis of documentary evidence, would be pre-requested to the compilation of the report. This would take time and talent, besides being expensive. The work would stand or fall in the estimation of the general community by its candor and accuracy, which would be judged more from the reputation of the compiler, and the care exercised by him in assembling and verifying his data, than by the official documents, even those of an historical type, are not infrequently lurking places of error. The question, then in view of the expense, and the lack of assurance that the work would be so done as to make it acceptable and conclusive, is chiefly one of demand; and on the point it is desirable that free discussion be had. It would be at least interesting, whatever came of it, to have a general expression of opinion upon Mr. Woods' suggestion.—Columbia State.

Good For Car-Fare.

Some time ago there was a story of a boy somewhere who offered a worn and defaced nickel to pay his car fare, which the conductor refused to accept and ejected him. The matter got into court and The Dock, a law magazine, presents the following report of the case: "Little Howard Rosnagle boarded a street

car with only a worn and cracked nickel in his pocket. The conductor refused to accept it and ejected the terrified little fellow from the car. The coin was issued by authority of law to circulate as money, and was merely worn, bruised and cracked in the process of circulation. It was not apparently diminished in weight and retained the evidence of its being of genuine coinage. The supreme court of Ohio, in Cincinnati Northern Traction company vs. Rosnagle, 95 Northeastern Reporter, 384, holds that under the fact the nickel was legal tender and that Howard could maintain an action of damages against the company, even though the conductor in good faith believed that it was not legal tender. The court also holds that, even though he had had another nickel, it would not have been necessary for him to have tendered it in payment of his fare." This is national law and good in every state. It should also be noted that a nickel coin, not being made of precious metal, is only token or representative money and is not deprecate by having lost weight, providing enough of it is left to make it recognizable. The rule is different in gold and silver coins.—New Orleans Picayune.

World's Congress of Navigation.

PHILADELPHIA, Pa., May 21.—Delegates representing more than 20 nations and consisting of the most noted experts in inland and ocean navigation of their respective countries have already arrived in this city and additional delegations are to reach Philadelphia today and tomorrow in time for the opening on the twelfth international congress of navigation, on Thursday. In accordance with the arrangement of the local committee in charge of the congress the greater part of tomorrow will be devoted to a general reception and mutual introduction of the delegates. The congress will hold its first general meeting at the Metropolitan Opera House on Thursday and it is expected that President Taft, who has accepted the honorary presidency and has promised to attend the opening session, will deliver the opening address. Response will be made by M. Alexis Dufourny of Brussels, a high officer of the Belgian Engineer Corps, who is one of the former presidents of the international congress.

This time will be the first time that one of these congresses is held in the United States. Previous congresses have all been held in Europe, the last at St. Petersburg in 1908. Preceding this there were similar congresses at intervals of three or four years in Belgium, France, Italy, Germany, Holland and Austria. With each congress interest and attendance increased as the nations realized the valuable work being done. The discussions of these gatherings from the best existing guide for all navigation problems that may arise, because they represent the world's best consensus of opinion of the greatest experts.

The invitation to hold the twelfth congress in America was accepted with enthusiasm, because this country offers what is largely a new and quite enormous field for the attention of navigation experts and a great number of new and highly important problems growing out of the Panama Canal, Cape Cod Canal and the numerous inland and waterways planned or in course of construction in the United States. The recent Titanic disaster has made the safety of ocean travel a subject of the most intense interest to all seafaring nations and the discussion of the various problems suggested by the unfortunate event will form part of the program and will undoubtedly occupy the attention of the congress for some time. In view of the many new and exceedingly important questions to be considered during the five day's sessions of the Congress and in view, also, of the unusually large attendance, it is expected that this congress will greatly surpass its predecessors in interest and importance.

It is expected that more than thirty nations of the world will be represented at this congress by official delegates and in addition by a large number of unofficial delegates, mostly navigation experts and engineers prominently identified with the respective countries.
