## Uncle Sam Sends Battleships to Cuba

### Intervention in Island Most Likely as Internal Warfare Spreads. Several Towns Ransacked

## IT MAY MEAN ANNEXATION IN THE END

NEW YORK, May 26.—The armored cruiser Washington, flagship of Rear Admiral Osterhaus, commander-in-chief of the Atlantic fleet and four battleships of the fourth division sailed south, supposedly for Key West, on hurry orders today for a few hours after arrival in port from Provincetown, Mass. The battleships following the flagship were the Ohio, Missouri, Mississippi and Minnesota.

The gunboat Yakton accompanied the squadron to serve as a dispatch boat. The battleship Delaware of the first division remained in port all day taking aboard her complement of marines and field equipment and together with the hospital ship Solace, was expected to sail during the night.

It is understood that the battleships have on board several hundred marines and that by the time they reach Hampton Roads, the battleships Georgia, New Jersey and Rhode Island of the third division will be ready to join them on the trip south.

## Asheville Man Shot by a Policeman

ASHEVILLE, May 26.—The condition of George Cathey, the well known Asheville young man who was shot at Waynesville Saturday afternoon by Chief of Police Bialock, was reported practically unchanged at the Meriwether hospital here tonight. It was stated that Mr. Cathey was resting fairly well and that he has a fighting chance for recovery.

An operation was performed by Asheville physicians immediately after the arrival of the wounded man here Saturday evening. It was found that the bullet from a 38 calibre pistol had entered the abdomen and passing through the intestines lodged in the back just beneath the skin. It is said that Mr. Cathey accused the officer of watching and following him and then struck him in the face, after which, it is alleged, Chief Bialock drew his pistol and fired. Mr. Cathey is a powerful man physically and is well known in North Carolina for his fighting spirit and nerve.

## News of Our Native State Briefly Told

### International Safety Congress.

MILAN, Italy, May 27.—Eighteen nations, including the United States, are represented at the first International Safety Congress which opened here today. The conference is for the purpose of promoting a world wide movement for the conservation of human life in industry. It will consider technical means and safety devices tending to protect the life and limb of the laborer, as well as the hygiene of industry. The United States is represented by a committee from the American Museum of Safety, in New York headed by its director, Dr. W. H. Tolman.

### To Take up Kentucky Feud Case.

PACKSON, Ky., May 27.—The Callahan-Deaton feud, which resulted recently in the assassination of Ed Callahan, the former sheriff of Breathitt county, will be investigated by the circuit court which convened here today. Numerous members of both factions are here from the mountain districts and it is feared that any action of the court looking to the punishment of those responsible for the killing of Callahan may result in an immediate reopening of the feud.

### Charged With Libelling Congressman.

WASHINGTON, D. C., May 27.—The case of Henry W. A. Page, the New York merchant who was arrested some time ago on a charge of libelling Chairman Clayton and the members of the House Judiciary Committee, was called for trial today in the district supreme court. The charge is based upon Page's alleged authorship and circulation of a pamphlet in which various members of Congress were termed dishonest scoundrels.

### Red Men Meet in Birmingham.

BIRMINGHAM, Ala., May 27.—Several hundred delegates are in Birmingham for the annual meeting of the great council of Alabama, Improved Order of Red Men, the sessions of which will be held tomorrow and Wednesday. The great council of the Degree of Pocahontas, the women's branch of the order, held its annual meeting today.

## Further Effort Made to Increase Reward

### Forfeited Bond Money May be Applied to Increase Reward Offered by Authorities For the Capture Dead or Alive of the Missing Allens.

WYTHEVILLE, Va., May 26.—With a view of making the price on Sidna Allen's head a sufficient incentive to cause a renewal of the activities of regular officers and possibly entice special detectives into the chase, an effort will be made by officials of the United States District court here to have the government offer a supplemental reward of \$5,000 for the capture of the leader of the band of Virginia outlaws who shot up the Carroll county court and for which crime Floyd Allen is now under sentence of death.

Sidna Allen is under a \$5,000 bond to appear at the regular term of United States district court which convenes here next Monday. Allen had been convicted in this court for perjury in connection with evidence in a case in which he was charged with counterfeiting. He was convicted on the perjury charge a year ago and sentenced by Judge Boyd to serve a term in the federal prison. Pending appeal his bond was fixed at \$5,000. A month before Sidna Allen led his band into Hillsville the circuit court, sitting at Richmond, granted a new trial and this was to have been given at the term of court beginning next Monday. The \$5,000 bond is signed by Sidna Allen and Floyd Allen and three other Carroll county men. When it is declared forfeited it is said District Attorney Holton will recommend that it be offered by the government as a reward. This recommendation will also it is said, have the approval of Judge Boyd.

## Lorimer Ought to Resign His Seat

WASHINGTON, D. C., May 25.—Senator Lorimer, of Illinois, will receive word direct from his friends in the senate that they cannot hope to save him in his fight for the retention of his seat. While it is not admitted that Lorimer will be urged to resign, it was said he might decide on that course.

## Hurriedly Enter Hampton Roads.

WASHINGTON, May 26.—Captain George E. Clark, commanding the Missouri, commands the fourth naval division which left New York today for Key West, Admiral Usher being in the hospital. The vessels will arrive at their destination some time Wednesday.

The battleship Nebraska, en route from New Orleans to Hampton Roads, was spoken by radio in the Gulf of Mexico late today and instructed to stop at Key West and join her division, the third, when it arrives.

The Georgia, New Jersey and Rhode Island, which with the Nebraska, from the third division, steamed hurriedly into Hampton Roads at 5 o'clock today.

## Damaging Fire in Neighboring Town

### Washington, N. C. Handicapped by a Poor Supply of Water as Factories Burn Down

## SMITH'S SHIRT FACTORY, HOSEIERY MILL DESTROYED

WASHINGTON, N. C., May 27.—The M. A. Smith Shirt Manufacturing Factory and the Tar River Hosiery Mill building located on Market street, were entirely consumed by fire this morning and at one time due to the scarcity of water and the inability of the Ocean Fire Company to secure sufficient hose, several other buildings adjacent seemed to be doomed. Mr. M. A. Smith, proprietor of the shirt factory states that his loss will be approximately about sixteen thousand dollars and the loss estimated for the hosiery mill building, including the boiler and engine, will add at least three thousand dollars more to the loss.

The fire was first discovered by the employees in the shirt factory about nine thirty o'clock and when first seen was issuing from the vacant second story.

The building was occupied as the machinery, excepting the boiler and engine had only recently been moved to Robersonville. The building and boiler and engine was the property of Mr. J. E. Kennett, of Raleigh, N. C. Whether he carried insurance or not is not known at this writing.

Immediately after the blaze was discovered the alarm was given and the fire department responded promptly.

Due to their being only a four inch main located in that section of the city and being three blocks away water adequate to the demands of the Ocean Fire engine was not coming and for some little time the department was at a standstill.

Upon investigating the cause of the delay in securing water the Daily News man was informed there was water, although the pressure was low, but the main cause of the delay was due to the fact that the Volun-

## Put County Officers on a Salary

STATESVILLE, N. C., May 26.—After having last Saturday defeated the three candidates for the state legislature who were making their campaign upon a platform of salaries for county officers, the Democrats of Iredell county, in county convention, Saturday, passed a resolution instructing the legislative nominees of the party to have enacted a law placing the county officers on a salary, the total amount to be paid to the officers not to exceed \$10,000 a year.

This action is expected to save what was threatening to become a serious split in the ranks of the party in the county.

The resolution as adopted provides that the salary law shall be passed to take effect at the expiration of the terms of the county officers who are elected at the approaching election. An effort to have this amended so that the law would take effect in next April, but this was lost.

Bishop Bashford

Dr. James W. Bashford, bishop of the Methodist Episcopal Church, was born at Fayette, Wis., May 27, 1844. His father was a minister of the Methodist Episcopal church and the son, after graduating from the University of Wisconsin in 1876, attended the theological school of Boston University. During the several years following his ordination to the ministry he was pastor of churches in various New England cities and in Buffalo, N. Y. In 1889 he gave up his pastorate in Buffalo to accept the presidency of Ohio Wesleyan University. He continued with the university until 1904 in which year he was elected a bishop and sent to China. Bishop Bashford is regarded as one of the most learned bishops of the church. He has traveled in many parts of the world and is the author of a number of books.

Western Yale Clubs Meet.

ST. PAUL, Minn., May 25.—The Twin Cities were blue, very blue today, not the blue that goes with the "this is certainly a tough old world" feeling, but the bright blue that arouses a spirit of youth enthusiasm in the breast of every "grad" of Yale University. Both in Minneapolis and St. Paul the colors of Old Eli were much in evidence for the two cities are acting as joint host to the 8th annual convention of the Associated Western Yale Clubs. The several hundred of delegates to the gathering got together at the Minnikakaha Club this morning for a brief business session. The entertainment program covers two days and has as its chief feature a banquet at which President Hadley of Yale, President Vincent of Minnesota and E. J. Phelps, of Chicago, president of the Western alumni, are to be the chief speakers.

Knights of Templar at Pittsburgh

PITTSBURGH, Pa., May 27.—Pittsburgh has capitulated to an army of Sir Knights of Templar, who have gathered here from all directions for the fifty ninth annual conclave of the grand commandery of Pennsylvania. Indications point to the greatest gathering of its kind ever held here. The big event of the week will be the parade Wednesday morning in which 20,000 members of the order from Pennsylvania, Ohio and West Virginia will participate.

WITH OTHER EDITORS

The Cause of Olsson.

There has been more or less excited discussion of the action of Judge Handford, of the United States district court of the state of Washington annulling the citizenship of Leonard Olsson on the ground that he is a socialist. The excited feature of the discussion, while it has had the effect of bringing Judge Handford into the limelight, has at the same time induced quite general consideration of his action along less brainstorm lines.

Such discussion discloses the fact that the public is not well informed concerning the exact evidence on which Judge Handford bases his decision. Until this is at hand, it would necessarily appear that any intelligent opinion of the righteousness of his decision is impossible. If Olsson admitted that he took part in socialist meetings at which resistance to the established order was advocated, and that he favored such resistance or was unwilling to obey the law as it stands the judge was apparently within the law in excluding him from citizenship; and this is also the cause of Olsson's stands was proved in other ways than by his own admission.

The New York Commercial, commenting on the incident, very concisely states the merits of a case in which such action by the court would be justified when it affirms that if Olsson advocated recourse to arms to bring about a change or resistance to due process of law, or the collection of taxes, he is not fit for citizenship. If, however, he simply wishes by argument to change men's minds to his way of thinking and thus to win over a majority of the voters of the United States to socialism, his exclusion was unlawful and unjust.

"To say that a man's views apart from his acts, regarding political questions should debar him from citizenship," says the Commercial, "would threaten the liberty of the subject. Once established such a precedent and it might be extended to include those holding certain religious beliefs and opinions regarding the tariff policy of the country! This is a land of free speech and any infringement on that right is fraught with danger to the state. The distinction between free speech and incident to riot, resistance to the law or armed rebellion is clearly drawn, and was very accurately stated by the court which convicted and sentenced Tom Mann the English labor leader, to six months' la-

bor for inciting soldiers to mutiny." So long as the existing order of government stands, it has all needed energy to protect the rights of the humblest citizens whether he be a socialist or something else unpopular; hence the public should not become unduly excited over the Olsson incident. The facts will soon come out, as the case is certain to be appealed to higher court.—Houston Post.

"Expect to Stay Until I Die."

William Jennings Bryan made a speech to the General Conference of the Methodist Episcopal Church, North, in Minneapolis on Wednesday, in which he spoke in a lightsome way about his political aspirations, declaring that he is no candidate for no office, did not expect to be a candidate for any office and hoped that no unfriendly newspaper would say that he was a candidate for Bishop. Mr. Bryan, in fact, would make a fine Bishop, and we should be glad to share with the churches the trouble we have had with him in the State. In his speech to the General Conference, Mr. Bryan said, "I got into politics when young and expect to stay until I die. I can do more by remaining in politics as a private citizen, for then my friends never are pulling at my coat tail telling me not to do that or this for fear it will hurt me."

We "suspected" as much. There does not appear to be any possible chance of escaping from Mr. Bryan until the angels come to take him to a happier land than this. Of course we should hate to see this, but we could on such an occasion steel our hearts to submit to the decree of Providence. Mr. Bryan has really been killed three times, but the trouble with him is that he won't stay dead and now when he tells us that "I got into politics when young and expect to stay until I die," there appears to be nothink that can sustain us in the circumstances except the gift of Christian resignation.

The idea of Mr. Bryan's "remaining into politics as a private citizen" is really one of the most remarkable statements he has ever made. There are over 6,000,000 of the private citizens in this country professing the Democratic faith and not one of their number, except Mr. Bryan, has assumed to himself the authority to speak for the whole Democratic host. There is pleasude in all that we do pity it is for the party that he will not give it a chance.—Charlotte Observer.

As had been previously planned, having landed at Red Banks, lunch was spread in the moonlight. After a half an hour's stay at this garden spot, in which time several delightful pieces of band music were heard on the graphophone, it was 11 o'clock.

The homeward journey begun, the good feeling of the crowd had not abated and there was much laughing, talking and singing aboard. Half the journey had been made and all seemed to be going well; when suddenly the wild cry of a frightened woman was heard above the merriment and in a minute all was confusion. Then it was noticed that one of the "unsinkable" raft was under water. Immediately the captain stopped the boat at the same time. And in the noise raft and take the boat.

There was a wild rush and much commotion. Everybody was seeking to pass through the opening into the boat at the same time, and the noise and confusion then was heard the powerful voice of Major Archibald Butts Horne "women first". Like magic his command was obeyed and the men fell back. When all women were safely aboard the launch the water pump was brought out of the raft that it might be used for the remainder of the trip. When it was seen to be impossible, the captain decided to put into shore and cut loose from the raft, to take those aboard the launch to safety and return for the others. Again Major A. E. Horne was conspicuous, "all men off the launch" he shouted and most of them obeyed again. But one hid on top the launch, others hid under the seats and there is a report that one coward disguised himself in a Middy blouse. However this may be, three of the most stalwart of the men were required by the captain to remain aboard in case of further trouble; for the manly little craft had taken on much water by this time and was none too safe.

As the launch cut loose and drifted out into the stream for the trip to safety, a sound was heard on that craft never to be forgotten, a mixture of cries and laughter and above it all the strains of J. B. Kittrell's harp playing "Nearer My God to Thee".

But luckily the first trip was made without further trouble and then the launch returned for those on the raft. Soon she returned with all aboard—not one life lost.
