ARM OF LAW DESCENDS HEAVILY UPON BECKER'S SHOULDER

Lieutenant Leader of the Strong Arm Squad Arraigned Before New York Judge And Charged With Rosenthal's Murder

JACK ROSE TELLS WHITMAN BECKER "ORDERED CRIME"

BECKER'S POLICE CAREER

NEW YORK, July 30.—Lieutenant Chas. A. Becker, whose arrest last night came as a dramatic climax to the past fortnight's investigations of the Rosenthal murder, has been a member of the New York police force for nearly twenty years, his appointment dating back to November 1, 1893. He remained a private in the ranks for ten years, being promoted to a post roundsman in 1903.

A few months after he became a roundsman Becker came in to public view as the hero of a sensational drowning rescue on the East side water front. For this rescue he received a hero medal. Two years later, however, during the trial of Inspector Schmittberger, the man whom Becker had rescued from the water, is said to have made an affidavit stating that the rescue was faked and that he received a certain sum for his part in it.

The first serious case in which Becker was concerned was the shooting dead of a young plumber's helper, John Fay, who was killed by a bullet fired duriecker and another policeman were suspended following an investigation, but were later reinstated.

Becker was placed in charge of the so called strong arm squad on June 30, 1911. Since that time he has been much in the public eye, making many spectacular raids. Last March a man was killed by a bullet fired during one of his raids. Becker was relieved from charge of the squad for a time, but was later re-assigned to it. During the year he was in charge of the strong arm squad Becker made more than 75 raids, including the attack on Rosenthal's place on April 15.

NEW YORK, July 30.—While Chas. A. Becker, for nearly twenty years a member of the New York police department and later commanding the so called strong arm squad, paced his cell in the Tombs today protesting his innocence of murder, New York officials from Mayor down went forward with the investigation into the death of Herman Rosenthal, the gambler, whose murder Becker is alleged to have instigated to frustrate Rosenthal's threat of revealing an alliance between the lieutenant and gamblers of the tenement.

In different cells, fearful of the lieutenant's vengeance and begging for protection are Jacob (Jack) Rose, Louis (Bridgie) Webber, erstwhile gamblers and workers of the underworld, who confessed last night they set the stage at Beckers bidding and hired the assassins who put Rosenthal to death in front of the Hotel Metropole.

The indictment and arrest of Police Lieutenant Becker for the murder of the gambler, Herman Rosenthal, soon after the confessions of Bald Jack Rose, Bridgie Webber and Harry Vallon, revealed to District Attorney Whitman the police system in all its hideousness.

The public prosecutor, following the trail of the three confessions, continued his search for evidence that would implicate those higher up than Becker, and more indictments of police officials are expected by the district attorney.

The arrest of Becker lays bare a scandal in the police department that threatens to shake it to its foundation, for District Attorney Whitman believes the story of police graft has only been half told. Taft Republicans, Wilson Republicans, Lily White Roosevelt Republicans and straight black Roosevelt Republicans are now before the public in Virginia.

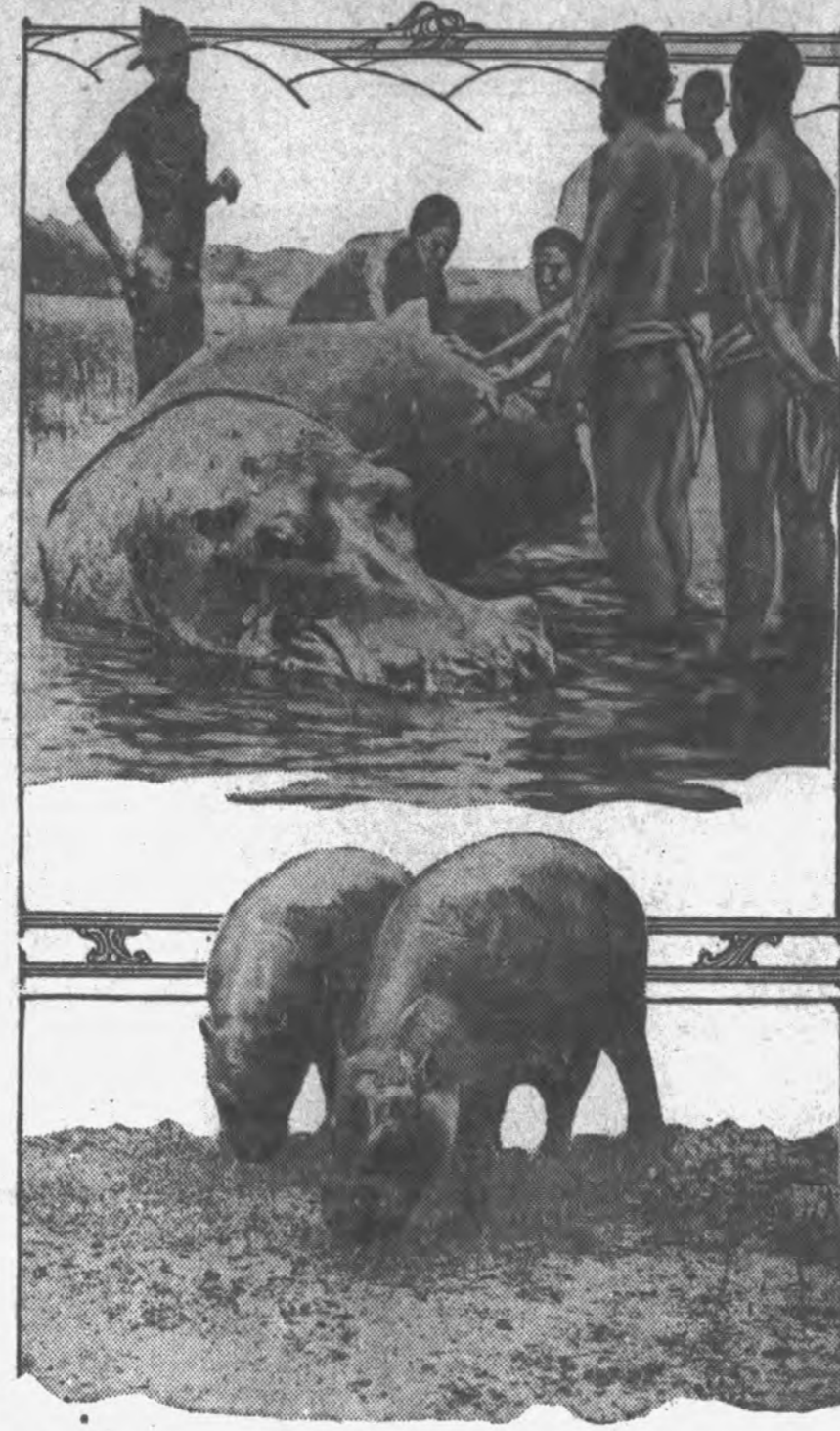
Serious Accusation Against Asheville Man

Hippopotamuses—The Pygmy And the Ordinary Size

A PAIR of pygmy hippopotamuses has been acquired by the New York Zoological park at a cost of \$12,000. They are the first pygmy hippopotamuses to be exhibited, the pygmy animal having been regarded as almost mythical. They were captured in Liberia by an intrepid hunter and explorer in a country reeking with cannibals. An ordinary hippopotamus will weigh more than 6,000 pounds and measure some eleven feet in circumference and twelve feet in length. The male of these pygmy hippopotamuses weighs 419 pounds, is thirty inches high at the shoulders, seventy inches in length from end of nose to base of tail, and the tail itself is twelve inches long. The female stands eighteen inches high at the shoulders and weighs 178 pounds. The skull of the pygmy is more convex or rounded on its upper surface, its legs are longer and more slender in proportion, and its eyes do not protrude like those of the giant species. The face of the pygmy is relatively smaller than that of the large species. The lower jaw bears only two incisors, while the large species has four. The eyes are not set as high in the head of the small animal as in the large one.

MYSTERY FOLLOWING FINDING OF BODY

Was Miss Snodgrass a Suicide?
Body of Young Woman Who Disappeared on Eve of Marriage Found in a Creek

CATSKILL, N. Y., July 30.—Murder pure and simple is the verdict of the people in this little village of Catskill in the case of Dorcas Ija is Snodgrass, the missing Mount Vernon nurse, for whom a search has been conducted during the last 12 days.

Miss Snodgrass' body, so badly decomposed that it could hardly be handled, was found in a remote recess of Du Bois creek and brought to the receiving vault in a local cemetery, its condition precluding conveyance to the undertaking rooms. At the request of a local newspaper man the undertaker examined the garments very carefully and found them marked plainly with the name D. Snodgrass. This convinced even the most doubting that the dead woman was the missing nurse.

Later a party of newspaper men, accompanied by the coroner and the district attorney, made a thorough search of the creek in the vicinity where the body was found and were rewarded by the hat worn by the dead woman at the time she disappeared, with the hatpins still sticking in it. Attached to the hatpins were strands of hair and some flesh, which would furnish a basis for the idea that the hat, lying at a distance from the body, had been torn from the head during a struggle. If there was a struggle, all marks were erased from the ground surrounding the place where the body was found.

HIGH SPEED CAUSED TITANIC DISASTER

Is May Exonerated by The Court?
British Board of Inquirers Find That Arrangements For Manning Life Boats Were Inadequate

LONDON, July 30.—The judgement of the British Board of Trade Court of inquiry into the disaster to the White Star liner Titanic, which sank in mid ocean with 1,517 souls after collision with an iceberg on April 14th, was pronounced today by Lord Mersey, the presiding judge, before a large audience.

The court finds that the collision of the Titanic with the iceberg was due to the excessive speed at which the ship was navigated; that a proper watch was not kept; that the ship's boats were properly lowered but that arrangements for manning them were insufficient; that the Leyland liner California might have reached the Titanic if she had attempted to do so; that the track followed was reasonably safe with proper vigilance and that there was no discrimination against third class passengers in the saving of life.

The court of inquiry exonerates J. Bruce Ismay, chairman and managing director of the White Star Line and Sir Cosmo Duff-Gordon, one of the passengers, from any charges of improper conduct.

The judgment recommends more water-tight compartments in sea-going ships, the provision of lifeboats for all on board and more efficient drills of the crew as well as a better lookout.

MORE EVIDENCE IN ATLANTA TRIAL

Defence Accuses Husband of Shamming

DO NOT BELIEVE PHYSICIANS

Mother of Accusing Husband Tells Court That Mrs. Grace Wanted to Place Blame on Negro Butler. Court Crowded

ATLANTA, Ga., July 30.—How Mrs. Daisy Grace, on trial here accused of having attempted to kill her husband, once declared that if any body had shot Grace it was "J. C." a negro butler, was recited on the stand today by Mrs. S. L. Hill, Grace's mother.

Mrs. Grace arrived at the Hill home in Newnan, Ga., testified Mrs. Hill, and was informed that Grace had been shot in his home in Atlanta. After I had told of the shooting, testified Mrs. Hill, Daisy said she did not believe it. I told Daisy that I was afraid Gene had accidentally shot himself.

If anyone shot Gene, she said, Mrs. Grace declared, it was J. C. (the negro butler). Yesterday he nearly beat Martha to death and Gene told him if he touched her again he would wear his cane out on him.

Mrs. Hill said Daisy asked her where Eugene had been shot. Through the lung, she replied. When later she told Daisy that Eugene was still alive and had been taken to the hospital, Mrs. Hill said Daisy asked as to the proximity of the lungs and the heart and remarked that she did not know anybody who had been shot through the heart could live.

Asked as to whether Mrs. Grace had ever spoken about insurance, the witness said Mrs. Grace remarked in November, 1911, that she thought Gene should have his life insured for her protection.

Next month, Mrs. Hill said, her daughter told her that Grace had had his life insured.

The witness was asked: Why didn't you tell during your preliminary examination what you have just said about Mrs. Grace's remark concerning the proximity of the heart and lungs?

Developments are expected when the status of Rebecca Sams, a mulatto dressmaker, is explained. Her name was brought into the record yesterday, but her connection with the shooting was not indicated.

Also, it is intimated that Mrs. Grace will try to show that her husband is not paralyzed from the waist down. During the proceedings yesterday she created a mild sensation when she remarked to an attorney: Watch Gene's legs move.

When questioned about the twitchings of his limbs Grace attributed it to reflex action. If anyone thinks I am feigning helplessness, he said, I'll allow them to stick a pin in my body. If I bat an eye, I'll submit to any punishment.

Grace was again present at the trial today in spite of the intense heat in the courtroom. Mrs. Grace came to court unaccompanied. She wore a black silk dress, a new Parisian pompadour panner creation. Her head was almost completely hidden from the curious crowd, mostly women, by an expensive Panama hat.

JUSTICE CLARK IN GREENSBORO

Does Not Refer to Contestants Abusively

HIS HAT ALSO IN THE RING

Chief Justice Walter Clark Delivered Opening Speech Before Large Crowd in Greensboro—Clearly Outlines His Platform.

GREENSBORO, July 30.—In open his campaign for the senatorial nomination, Chief-Justice Clark addressed a Greensboro audience last night. He spoke, in part, as follows:

"I wish to state unequivocally that I shall say nothing in this canvass that will reflect upon the personal character of either of my competitors. They have lived clean lives. They have been, and I hope still are, my personal friends. It is no reflection upon them that I aspire to the same office which they desire. Their characters are not in question and will not be an issue in this campaign. Their public acts are public property, and we have a right to scrutinize closely the measures which they have advocated and for which they will stand if elected to the senate.

"Senator Simmons was chairman of the Democratic executive committee back in the nineties and he retained that position long after he became senator and indeed, I believe until his second election to that high position. He has a large acquaintance and indeed I may say, organization among those who organize voters in the different townships and counties in behalf of the candidates.

"Governor Kitchin for 12 years represented the Fifth congressional district in Congress and of course, had an organization to aid him. In his canvass for governor he extended this throughout the state and since he has been governor he has added to this the natural gratitude of the men whom he has appointed to office and their friends and also without reflecting upon his exercise of the pardoning power in any way, he has in many cases the good will of men at whose instances he has granted pardons. For many years it was understood that these two gentlemen were as pirants for the office of senator and that these strong battalions, well organized by their friends expected to face each other in this contest. When a year ago Governor Aycock and myself announced ourselves candidates, it caused intense astonishment to both sides. They considered it as rash and inconsiderate on our part. . . .

"The road to the United States senate is open to any man whom the people shall wish to send there. I do not need to have any hat chalked by any set of men. In the language of Mr. Roosevelt, it is in the ring and will be there when the sun goes down on November 5.

Navy Yard Men on Better Footing

WASHINGTON, July 30.—Representative Redfield of New York has found that very nearly every good mechanic employed by the government in the navy yards is discriminated against in the matter of vacations and sick leaves and to put the employe in a fairer position has introduced a bill giving employes of navy yards, gun factories and arsenals fifteen days leave of absence with pay every year and fifteen days sick leave.

ELIZABETH CITY, July 30.—During the severe electric storm that swept this section last night the home of T. B. Wilson in Burgess street was struck by lightning. The bolt struck the south end of the roof of the house near the chimney, tearing away a few shingles. It then skipped to the northeast corner entering a second story room, knocking down a large square of plaster about a foot from the ceiling—tearing off a window facing and throwing it across the room in an opposite direction and completely demolishing the woodwork of a picture frame.



THEY'RE ALL DONG IT NOW

The trusts have found out that nothing pays so well as dissolution. Following the decree of the Supreme Court which ordered the Standard Oil trust to dissolve, the value of that corporation's stock rose rapidly. The court decree, without changing the trust except in a matter of administration, amounted practically to a governmental guarantee to violate the laws. After the decree was issued the trust owners discovered that the monopoly stood in no further danger of prosecution and as this always has been the great menace to the trust, it was a great boon to have it removed. Accordingly the value of the shares went skyward. As a result, other trusts have begun to dissolve. The beef trust has announced a dissolution plan, so that it, too, will conform to the Supreme Court's notion of what constitutes a law abiding trust. The powder trust did likewise, the terms of the dissolution decree, in its case, being written by the trust's own lawyers and later approved by the Federal Court of Delaware. Dissolution is, next to the high tariff, the best thing that ever happened to the trusts.

WHAT WILSON SAID

Much criticism has been directed against Governor Wilson by uninformed men and newspapers because of his alleged antagonism to immigration. In one of his books Governor Wilson deplored the artificially stimulated immigration from Southern Europe and he particularly deplored the practice of steamship companies holding out false promises to people on the other side in order to induce them to come to this country. These steamship companies, through advertisements and huge placards, gave out the impression that every man who came here would be given a farm free by the government and other ridiculous promises. Governor Wilson wrote that this had the effect of bringing a lot of people here who would not have come had they understood the real situation. Mr. Wilson is not opposed to immigration. He takes the position that this country always has been and always will be a haven for the oppressed peoples of the earth and she has

only a sane and reasonable immigration regulation.

THE HUGE EXPRESS GRAFT

The Interstate Commerce Commission's report on the express monopoly sets forth that while the express companies are paying dividends on a capitalization of \$106,000,000, their actual investment is only \$7,000,000. This report also shows that the express companies are all owned by the railroads on whose lines they operate, so that by maintaining the express companies, the railroads simply collect a higher price for carrying certain classes of freight than they should collect were they required to conduct the express business themselves.

The express graft is one of the main reasons for the high cost of food, as much food stuff, especially the fresh variety, is carried by that method.

Former Congressman John G. Shaw of Fayetteville, is president of the Law an Order of that town and has been quite active after violators of the prohibition law. Recently he received an anonymous letter threatening to burn his property. He had the anonymous letter published together with a reply in which he said he intended to prosecute the violators to the fullest extent of his ability and that no amount of threats nor acts of incendiarism would deter him in the discharge of his duty. The anonymous letter and threats is evidence that men who engage in "blind tiger" business will stoop to any crime rather than be thwarted in their purpose.

Leslie Combs
Leslie Combs, who is taking a leading part in the organization of the

Progressive party in Kentucky, was born in Little Compton, R. I., July 31, 1852, the son of Gen. Leslie Combs, a distinguished soldier of the civil war. After completing his education at Transylvania University, Kentucky he engaged on an extensive scale in stock raising and tobacco planting. He also acquired large ranch interests in Texas and Indian territory. At an early age Mr. Combs became active in Republican politics in Kentucky and in 1898 he was appointed pension agent for the state. Two years later he was elected chairman of the Republican state committee. In 1902 he was appointed United States minister to Guatemala and Honduras and from 1906 to 1911 he served in a similar capacity in Peru. In March 1911, he resigned from the diplomatic service to return to Kentucky and devote his attention to his business interests.

The greater part of Charleston's import consist of fertilizer material and of the 13 plants now in operation ten are situated on the banks of the Ashley river within six miles of the city. Thousands of dollars each year will be saved to these plants when the new canal has completed.

Editorial of Human Interest

THE TOLL OF LIFE IN THE HIGH COST OF LIVING

With business conditions fairly favorable, with no very great disaster or serious political catastrophes recorded, a wave of self-murder swept over the land during 1911 that is puzzling the statisticians of life insurance companies.

Figures drawn from various sources show that, while there was a marked decrease in the ratio of suicides in cities of 250,000 and more, the in-

crease of suicides of less than 250,000 far outstripped the decrease and has given the country a slightly increased average of suicides.

What is the reason for this? Why should the smaller cities feel the pressure of life more than the greater towns?

Actual physical causes, such as bodily disease, insanity, alcoholism, etc., can be dismissed at once, for these are fairly constant factors. One theory is to be found in the slightly obscure phrasing of a report submitted by Frederick L. Hoffman, statistician of a leading insurance company.

He says: "This voluntary tribute of human life to early death is equivalent to a contempt for a tolerable existence without a parallel in history." In other words, he says Americans are so well off that it is amazing they should kill themselves.

Another view is that the prosperity is specious and that the increased pressure on the individual through the increasing cost of providing for the family is growing so heavy that men and women of tense balance are unwilling to see themselves thrust backward from the advanced position their struggle has won for them.

And this is probably the real explanation of the increase of suicide. It is not that we are too prosperous. It is because the prosperity is taking too heavy a toll on those who seek livelihood.

ARMY WORM IN THIS STATE

Mr. Franklin Sherman, state entomologist, has given out the following with regard to "the army" worm:

The army worm that is now attracting attention in this state and parts of South Carolina, is probably known as the fall army worm, as this name distinguishes it from the ordinary army worm of the northern states, which appears earlier in the season.

The fall army worm is also entirely different from the cotton leaf caterpillar which defoliated cotton all through the southern states last fall. So much to get our information "straight."

This fall army worm in a caterpillar and when grown will go underground and transform to a flying moth or miler, emerging after about ten days.

The caterpillar usually hatch out most abundantly in low grass lands, and as they grow they devour more an more of this vegetation and appear over wider acres. Corn on low land is subject to severe damage by them. Although preferring grasses and grain they will also feed on peas, garden crops etc., if their preferred food is lacking. They are hungry, eat ravenously and grow rapidly, which accounts for their seemingly sudden appearance. They usually disappear quite as suddenly as they come,—and this disappearance may be due to their becoming mature and changing to the moth,—or in some cases it is due to the good work of parasitic insects and diseases, predaceous insects and birds which feed upon them. Or both these factors may cause them to disappear.

What Can Be Done

Watch for them in the low grass lands so as to detect them before they attack cultivated crops. When found, use paris green in water at rate of one-half pound to the barrel, keep it thoroughly stirred and spray or sprinkle it on the grass not only where they are but immediately surrounding. If they are in the corn do the same,—always taking care to poison a little ahead of the worm. Of course, stock must not be allowed to eat this poison-en corn, at least not until after one or more heavy rains have fallen. If you cannot spray or sprinkle, then mix paris green with dry lime or land plaster at rate of one ounce to the pound and dust it from a sack or tight can which is punched with fine holes like a peppered castor.

What else? A drag or o rooled drawn over the infested grass lands will crush many of them, though it is by no means a perfect remedy, especially if the ground is rough.

Anything more? If they are moving,—crawling along in army fashion,—a deep furrow plowed ahead of them will cause them to accumulate in the bottom and a log dragged lengthwise in this furrow will crush them.

When these worms appear in the numbers that they some times do, and do the full extent of damage they are capable of, it is well worth while to put every hand on the place to work with them for a day or two. Fortunately the duration of their attack is short. This is not a new pest, it is an native, the moths are plentiful every year, but it is only in occasional years that the season that the season forrs their appearance in such numbers.

One thing more. Last winter was unusually cold. Many persons reasoned that insects pests would be scarce this season, but complaints at this office have been far above normal both in number and variety. There are only a few (if any) of the insects pests of this state that are noticeably reduced in number by any such winters as we ever experienced. I warned farmers against that mistaken idea at many farmers' instater last winter.

200 Vacationists

Have Narrow Escape

BOSTON, July 30.—The sidewheel steamer City of Rockland, from the Kenebec river to this port with some 200 returning vacationists, had her own stove in so badly that she sank to her guards in a collision at midnight with the eastbound steam collier William Chisholm of New York.

The accident took place off Boone Island, about twenty miles from York, Me. The passengers of the City of Rockland were all transferred to the Chisholm which had not been materially damaged by the collision. In the operation one of the boats upended spilling 15 or 20 women into the sea, but all wer rescued. Later the west-bound steamer Belfast took the passengers of the collier and landed them in this city.

Before the Belfast arrived on the scene the Chisholm had taken the City of Rockland in tow with the idea of putting into Gloucester, the nearest harbor. Soon, however, three tugs came up and took the disabled vessel in charge.

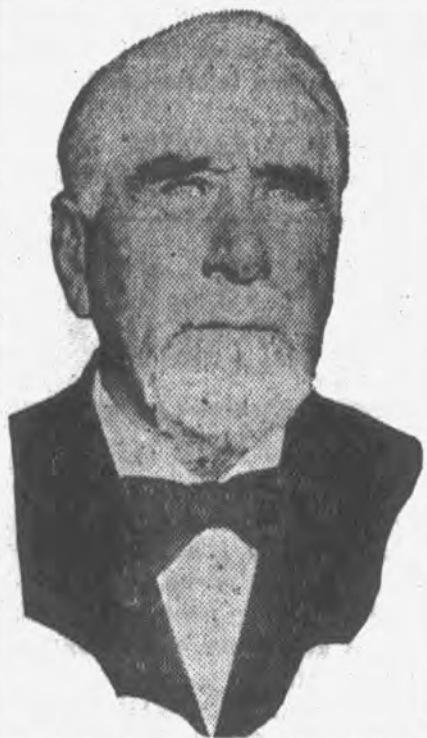
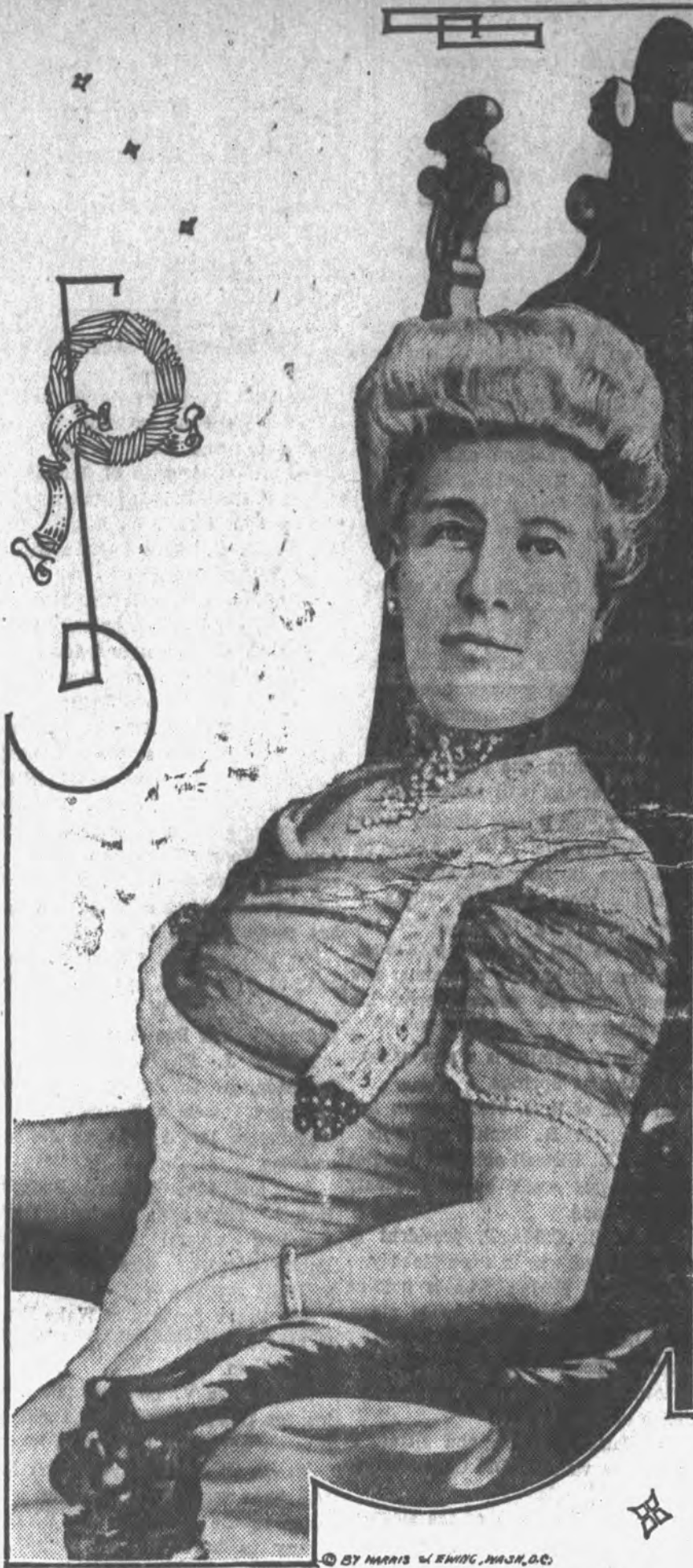

Afternoon costumes, especially those imported from Paris show greater elegance than ever before. Many of these costumes are made from extremely beautiful and costly material and are elaborately trimmed. Yet, there are some of these afternoon toilettes that have an extremely dressy air without being necessarily extravagant. They owe their smartness more to clever selection of material or hading of line detail and color than to expensive elaboration.

Flowered taffetas are largely used for these costumes. Many of these flowered taffetas are quaint at the expense of summery daintiness and gaiety, showing blurred designs on grounds of dull old fashioned lines. These are good looking for certain purposes, but on a midsummer afternoon the more delicate colorings have a greater charm and there are plenty of the light toned taffetas to choose from. Those with white grounds strewn with nosegays in Dresden colorings or in soft rather dull shades of blue and rose and violet, etc., are perhaps the most satisfactory, but there are others, equally attractive, of pale toned grounds, faint rose, blue de ciel, maize, lilac, with scattered floral design in harmonizing colors.

Such a tageta worn by a pretty blonde woman at a recent lawn tea had a ground in pink so pale and creamy that it was almost flesh color, with a rather large prim nosegay design in soft net clear blue violet and was relieved by a bodice almost entirely of blue creamy and pink tulle.

The draped skirt of silk with bodice almost or entirely of very sheer material figures very conspicuously among the summer toilettes, the skirt of course being so much a part of the design that there is no suggestion of separate skirt and bodice. With the popular draped frock of supplest black satin, for instance, there may be a bodice of white or achre tulls or sheerest linon and

lace, the black of the skirt running up a little on the white or perhaps invading the bodice only in connection with the train, which starts in a point between the shoulders or from the top of a high girdle. A new arrangement of dark skirt and sheer white bodice showed the fulled skirt of tulle rising above a narrow girdle in what may perhaps be best described as a deep upstanding frill tacked in its folds to a soft draped bodice of white mousseline de soie and malines.

Black and white, despite all that has been said to the contrary, has been as popular as ever in Paris during the present season and in almost any of the chic afternoon reunions fully half of the most successful costumes were usually in black and white.

Other the black and white frocks show several layers—white satin, veiled in black mousseline de soie embroidered in white, with a second tunic drapery of white mousseline de soie embroidery in black, or a close skirt of black satin showing but a little below a tunic of white satin with white satin waistcoat and lace frills. Simpler effects are exploited in the useful and popular one piece frock of supple black satin. Some of these frocks are as straight and narrow as ever, with buttons down the front and tight long sleeves, but with a becoming suggestion of color in some sort of smart big collar arrangement of fine hand embroidered muslin or muslin and lace, leaving the throat bare.

HOW TOM McCARTHY SAVED A FLAG

In short, he would hardly think of anyone who better fitted the specifications than Tom McCarthy. McCarthy of Boston. McCarthy of the firm of Nichols, Duffy, Long and Company, who won championships so many years in succession that Boston came to be known as the home of the pennant. Fans of other cities gave up hope and used to go out to see the champions when the Bostons came to town, as they would to a menagerie, to see the strange animals.

Now and then some upstart organization would be taken with pennant fever, and for a time the champions would get good exercise. This malady broke out in the early weeks of the season, and by July 4 was well spent, but in 1893 the Philadelphia team under the management of Henry Wright had a very serious attack. As the season advanced the spell grew on the Phillies, until numbers of the Quaker fans began to believe that precedent would be broken and Philadelphia win a pennant. Vain hope. McCarthy, the ruthless, rushed swiftly in to extreme left center field on the afternoon of September 30, and as the sound of a fierce line drive from the bat of Pitcher Taylor died out, and the ball was seen to settle in Mac's gloved hand, the dream was dispelled and the Quakers woke up.

It was none too soon. The slugging Phillies had given the home team a strong argument. They had already scored four runs in the ninth inning off "Kid" Nichols, and the bases were full when Taylor, batting for Bob Allen, hit the ball. The loss of the game would almost certainly have cost Boston the flag, as the season had only a few days to run. McCarthy's catch saved it. Boston's next pennant was won in 1897, and Tom was still on the job.

In spite of the shameless desecrations of recent years, the faithful Boston fans repair to the South End grounds—one of the nurseries of organized ball—and as they recall the familiar scenes of triumph the green of the old field is fair to look upon.
