ACCUSING FINGER OF EVIDENCE POINTS TO THREE INSPECTORS; EVEN HIGHER

Over Two and a Quarter Millions Exact by "System" From Manhattan Underworld, Says "Bald Jack" Rose

MAYOR GAYNOR "SHOWN UP" BY GOTHAM'S PRESS

NEW YORK, July 31.—Money supplanted murder as the chief issue in New York's police scandal today. Stirred by the amazing stories of Jack Rose, the gambler, that the Tenderloin's tribute to the system for protection reached \$2,400,000 annually, the murder of Herman Rosenthal was thrust temporarily into the background while the authorities bent their energy toward confirming Rose's assertion.

He maintains that besides Becker, the police lieutenant charged with instigating the Rosenthal killing, three higher police officials and a civilian employe of the department were sharers of the graft.

District Attorney Whitman will hold another conference with Rose and his associates this afternoon.

Far from discrediting the tale of \$2,400,000 as a fantastic yarn of a gambler seeking to ease his own plight, Mr. Whitman believes the amount to be conservative. The police authorities, on the other hand, said that the story was ridiculous.

A statement made with the authorization of Commissioner Waldo said that with the system of checks and counter checks employed in the department it was impossible for any individuals or any branch of the service to collect blackmail in anything like the enormous sum mentioned by Rose.

Inspectors and other officials below the commissioner were quick to deny that they had any finger in any funds collected. It was conceded that gambling exists in the city, but it exists, so the police authorities maintain, because of the attitude of the courts which, they say, makes conviction of gamblers well nigh impossible.

Corrupt individuals within the department, it was admitted, might be able to levy blackmail. However, it was held that Lieutenant Becker when in charge of the strong arm squad and engaged in gambling raids, never had authority that would enable him to go ahead with the wholesale collection of graft, such as Rose and others have described.

The police department announced today that it was ready for the most searching investigation. While the heads of the department admitted that in the ramifications of the organization unworthy individuals might be discovered, they declared that never before in its history had the department been better able to stand a thorough probing.

Although the gunmen who did the actual shooting of Rosenthal are still at large, one more of these directly or indirectly involved in the crime, came within the reach of the authorities today. He is Samuel Schepp, an occupant of the gray car in which the murders rode. Bernard H. Sandler, counsel for Schepp, appeared at the District Attorney's office today and said his client was willing to surrender provided he were accorded the treatment given Rose, Vallon and Webber.

He was told that Schepp would be used as a witness if he could show that he was not an accessory to the shooting, and it is probable that Schepp will surrender.

Lieutenant Becker maintains his silence in the Tombs, receiving no visitors except his wife and counsel.

Every trail and lead is to be followed persistently, no matter where it ends, by District Attorney Whitman to learn to whom it is asserted \$2,400,000 money was annually distributed.

Jack Rose, whose confession put Lieutenant Becker behind the bars, for the alleged murder of the gambler, Herman Rosenthal, has told the public prosecutor that this huge sum of money was obtained by police blackmail, from gambling and disorderly houses and that Lieutenant Becker told him the money went to four police officials.

The public prosecutor has arranged to keep the grand jury in session all summer to investigate the relations between the gamblers and the police which, in the opinion of the District Attorney, is a matter of more public importance than the Rosenthal murder.

Money Will Shrink in Size Only

WASHINGTON, July 31.—The size of all United States currency and national bank notes probably will be reduced by one-third and their designs revolutionized by Secretary of the Treasury McVeagh for the sake of economies to the government, convenience to the public and safety against counterfeiting.

This decision has practically been reached by the Secretary.

It is proposed to make the dimensions 6x2 1-2 inches. The paper money now in circulation measures 7.28x 3.04 inches. The designs of all paper money—United States notes and certificates and national bank notes—would be systematized and made uniform in every denomination.

This move is expected to save the government about \$900,000 annually and the national banks which pay for the plates for their notes and part of the cost of redemption about \$200,000. The economies would be affected in steel for the plates, in paper and labor.

Governor Wilson Welcoming Speaker Clark to Sea Girt

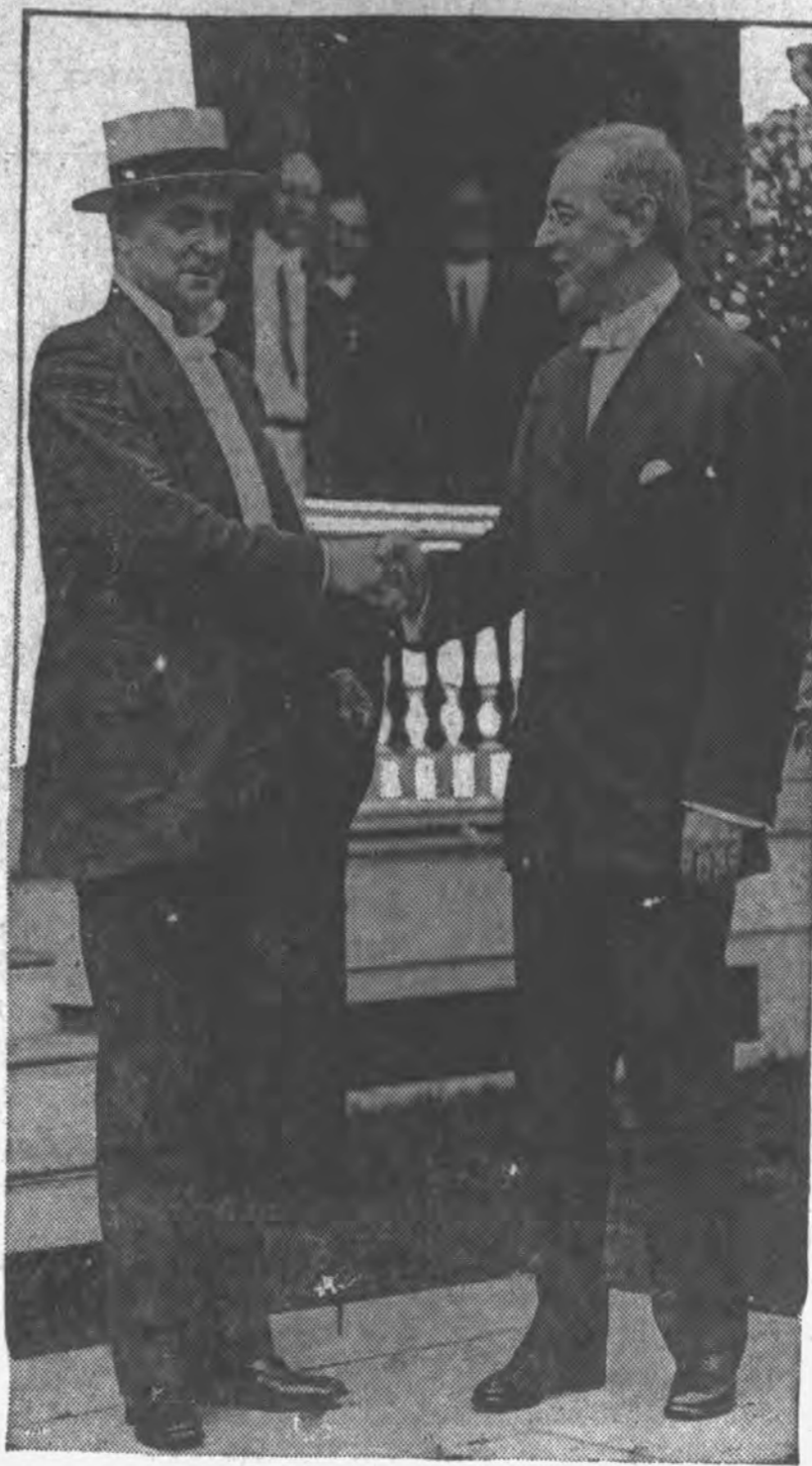

SIMMONS AFTER PAPER'S SCALP

To Institute Suit Against the Shelby Highlander

"CORN CRACKER" IS INVOLVED

Immediately After Simmon's Attention Was Called to Slandorous Article He Wired Lawyers to Institute Proceedings

WASHINGTON July 31.—Senator Simmons' attention was called late yesterday evening to an article in the Highlander of Shelby by July 17, an independent paper with a Republican editor strongly supporting Governor Kitchin for the senate, signed "Corn Cracker", containing the following statement: "How long has Simmons been feasting at the public crib? How about the \$100,000 he has been paid for voting 19 votes wrong, according to the tenets and traditions of Democracy out of a possible 43?"

Immediately upon reading this charge Senator Simmons sent the following telegram to Ryburn and Hoey, attorneys at law of Shelby: "Have just this minute read infamous slander in the Highlander, July 17, signed 'Corn Cracker'. I wish to employ you to at once institute criminal and civil proceedings against both the writer and the publisher of this slanderous charge."

The 19 votes to which Corn Cracker refers in his charge of bribery against Senator Simmons are the 19 votes given by him, one against reciprocity, 16 in favor of the amendments to the reciprocity bill and 2 in favor of motions made by Senator Overman with reference to taking up the cotton bill. These amendments to the reciprocity bill for which Senator Simmons voted were in part amendments to put the products of the trusts such as cotton and agricultural implements on the free list; in part votes cast by him in favor of an amendment to add to the reciprocity bill the farmers list putting all kinds of agricultural implements and machines, boots, shoes, leather, harness and lumber on the free list, and in part votes cast by him in favor of amendments to the reciprocity bill reducing duties on 38 enumerated articles of household and farm supplies which the farmer does not produce but buys. They were votes against the trusts and protected manufacturer and in favor of the consumer.

They are the 19 votes Governor Kitchin refers to in his speech without telling what they were about. Speaking of this outrageous charge Senator Simmons said today that it was in line with the numerous utterly unfounded innuendoes, insinuations, falsehoods, suppressions, and misrepresentations of fact which characterized the campaign being made against him and illustrated a reckless disregard without a shadow of justification, to do what was necessary to arouse prejudice even to the point of deliberate assassination of character.

WILL PROBABLY SUCCEED LAMB

Man in Charge of Baltimore & Ohio Spoken Of

MAY MEAN BOOM TO N. C.

A. W. Thompson, Now Third Vice President of Baltimore & Ohio, in Charge of System, and That Road May Come Here

RALEIGH, N. C., July 31.—The report, credited by the best informed railroad men here that Mr. A. W. Thompson, now third vice president, in charge of the operating department of the Baltimore and Ohio railroad, is to succeed Mr. E. T. Lamb, as president of the Norfolk Southern Railroad Company, brings a strong impression that the Baltimore and Ohio is coming into North Carolina through control of the Norfolk Southern system, and that it is Baltimore and Ohio interests that are pushing the construction of the Raleigh, Charlotte and Southern, now under way as a division of the Norfolk Southern.

If this is the case, as members of observant business men believe it is it means renewed and vast development for eastern central and western Carolina through greatly multiplied freight and passenger facilities, and establishment of competitive conditions.

The Baltimore and Ohio, with trunk lines from Chicago to Baltimore and network of lesser lines through a Bay line of steamers come down to Norfolk, connecting there with the Norfolk-Southern system that has a network of valuable lines throughout Eastern Carolina, extending west to Raleigh, and now building rapidly to Charlotte. Poor "John D." Only Makes 81 Millions

NEW YORK, July 31.—Wall street saw the highwater mark of \$1,000 a share made for old Standard Oil stock today.

A great many "I told you so's" following the advance for the financial district has been looking forward to this event ever since the dissolution of the trust, which was ordered by the United States Supreme Court last December, following a long drawn out trial under the Sherman anti-trust law.

In the meantime, the subsidiaries have advanced, in some cases as high as 2,000 per cent, but Standard Oil has been comparatively slower in its boom.

At \$1,000 a share the market value of the old company, including subsidiaries, is represented by approximately 1,000,000, the capital outstanding of the disintegrated trust being about \$100,000,000.

When the dissolution took place the market value of the old stock was \$675 a share, or a total market value for the entire capital of \$675,000,000.

John D. Rockefeller owns about one quarter of the old stock, or 250,000 shares. Therefore, the increased valuation has meant \$81,250,000 more for him.

The Standard Oil Company of New York today announced an advance of 1 cent per gallon in the export price of all grades of naphtha except benzene, which was raised 2 cents.

THE BIG ISSUE

United States Senator LaFollette, in the closing chapter of his autobiography, which has been running in the American magazine and which soon is to be published in book form, gives what he considers to be the one big issue now confronting the American people. He says:

"In twelve years of political struggle I have found one great issue overshadowing all others—the encroachment of the powerful few on the rights of the many. All the issues of today are phases of this one great question. How shall the individual farmer, the worker and all those who pay tribute, be set free from the unjust exactions of the tariff, the railroads and other famous forms of oppression by special interests.

"When Roosevelt became president the total stock and bond issue of the trusts was \$3,784,000,000. When he turned the country over to Taft this total had grown to \$31,672,000,000, seventy per cent of which is water.

"The people of this country are paying dividends on all this watered stock, in the form of unnecessary high prices for the things they eat, use and wear."

WILSON'S BROAD APPEAL

The practical wisdom of Governor Wilson's nomination is asserting itself more every day. Of all the men that were available for the Democratic nomination, none was so well fortified as the New Jersey governor to meet the requirements of the country and the party.

That he has the confidence of the business interests is shown by the fact that his nomination did not cause the slightest disturbance in the financial centers that are supposed to be barometers of the business welfare.

All of the big corporations are working almost to the limit of their capacity. The Baldwin locomotive works, of Philadelphia, which employs 15,000 men in one plant, announced within the week that it would work to capacity for a year to come on present orders.

Every day sees the conversion of influential Republicans to the government's allegiance, notable among them is C. R. Crane, the Chicago

millionaire who long supported Roosevelt.

Added to those favorable signs the government crop reports point to a bumper yield, so it would seem that even Providence approved the selection of the noted Princeton man to lead the Democratic hosts to victory.

HOW DISSOLUTION HELPS

The Standard Oil Company's profit figures for the six months since January—the first six months of operation under the terms of the Supreme Court's dissolution decree—show that the trust has piled up profits of \$46,611,628. Last year, the Standard Oil company of New Jersey, the corporation which distributed dividends for the trust, paid out profits of \$39,335,320.

Thus it is apparent that dissolution suits are highly beneficial to such law defying monopolies as the Standard Oil Company.

This month ought to mark a general shaking up and improvement in business locally. The tobacco market will open about the middle of the month which is going to mean good employment to quite an army of people and the turning loose of much money among farmers for their tobacco. It brings a time in which everybody should be on the lookout for business and the merchant who gives the best attention to his advertising will be the one who reaps the greatest benefit.

There seems to be some speculation in financial circles as to who is behind the Norfolk Southern railroad in its great extension and development through North Carolina. We don't care who is behind it or who is furnishing the money; the pleasing thing about it is that the Norfolk Southern keeps extending and development follows in every direction it reaches.

Your Uncle Sam has spoken and said to Mexico that the attacks and raids of the rebels on Americans must come to an end. That is just what the rebels seem to be after, as they have been threatening to hasten intervention by a massacre of Americans. It will be best for all concerned that the troubles over there be brought to an end.

When Greenville gets her Proctor Hotel completed we are going to put in a bid for the State Press Association to hold one of its meetings here. There are no sky scrapers nor roof gardens to show the boys, but they will find here the best school and the best town its size in the state.

We do not know that any North Carolina editors aspire to places on the staff of magazine writers, but on the trip from Morehead City to Cape Lookout, last week, many of them became contributors to the Atlantic. The lamented Zeb Vance's sea-sick story was also revived.

The judgment of the British Board of Trade court inquiry, that the loss of the Titanic was due to excessive speed, is just what the world already knew.

The Charlotte Chronicle very neatly calls the attention of the governor to the fact that the people who do things are the ones who are most talked about.

TOO MUCH FOR ONE—TOO LITTLE FOR MANY.

Part I.

All of the political parties and a great many scattered wise men, are asking themselves or telling others what it is that causes scarcity and anxiety in this country; whence come what we all call just now "the high cost of living."

There is one answer, and a very simple one, that fits the conditions. Those that are responsible for law and that are working for progress should know the answer which is this:

A FEW OF US—VERY FEW—HAVE A GREAT DEAL TOO MUCH. AND A VERY MANY OF US HAVE TOO LITTLE.

We have tens of millions of citizens worried about the future and worried about the present as well.

There is in this country not only wealth enough for all—if it were intelligently developed and distributed—but wealth enough for a population ten times and a hundred times as great as the population of today.

Millions of acres are uncultivated. Millions upon millions are cultivated badly and yield half a crop or less—because the workers lack money and tools and knowledge.

Power is going to waste in the great waterfalls—or if it is used as a monopoly, to make a few rich instead of making the millions free from bodily slavery.

There are machines enough to clothe the whole population—but the mills and the sewing machines stop, when a small percentage are well and beautifully clothed—the others haven't the money.

The production of food is already ample—but intelligence and cunning scheme to make millions by the sale of food at high prices—and there is no counteracting benevolent wisdom to work for wide distribution at low prices.

The crops of the nation this year will be wonderful in their abundance—the corn and wheat and oats will be garnered and manipulated. This broker, that speculator, an endless army of middlemen and profit takers will take their millions.

And when the distribution of the great crop is over, those that store up wealth and take more than their share will have new millions. And those that produced the wealth from the soil will be about only as well off as they were before—having just enough to keep going. And those that consume the earth's products will pay the top price for only as little as will keep them going, and worry and fret as they pay for that little.

Wherever you see great wealth in this country you see the same picture. A great army of consumers paying the top price for what they get!

A great army of workers struggling to get fair wages for what they produce!

And between the two the far-seeing manipulator and organizer who has put a dam across the stream of wealth—who dips out his millions, his TOO MUCH, while the others must be contented with their TOO LITTLE.

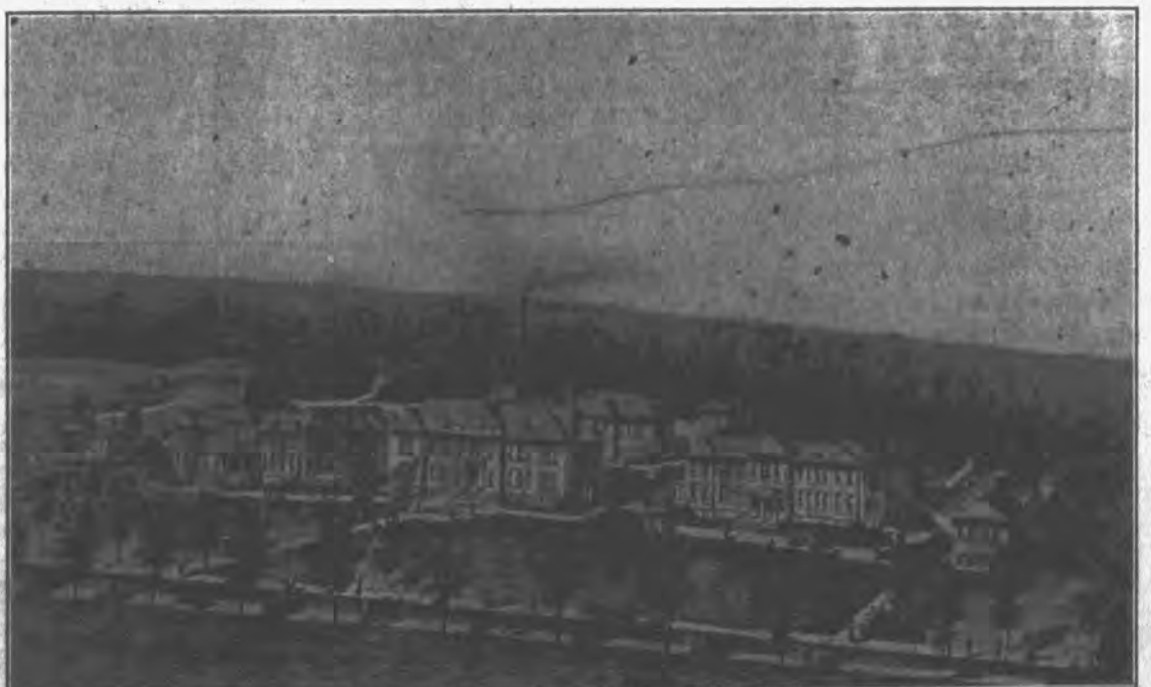

After the long days of almost too continuous sunshine, we may expect eventually the days of rain. If our wardrobes are supposed to be equipped for all conditions, we should have as suitable rainy day attire as we had for the blue sky and the golden sunshine of our mid-summer.

There is nothing more absolutely essential than a good rain coat. This does not mean to prohibit its being stylish as well as servicable.

I have been making quite a study of rain coats. Where I formerly felt that it was necessary to spend at least \$10 for a good one, I have discovered that they can be purchased as low as \$3.98. Ask your dealer for them.

At this price I saw a smart tan colored rubberized cloth, and odorless too, which is the exception in cheap rain coats generally.

It had a snappy plaid lining and those desirable straight lines from the broad shoulders to the skirt hem. There was a high button military collar, and cuffs to match.

When you are buying a rain coat let me recommend strongly the high buttoned collar, in preference to lapels or revers. The former is much better protection, even though the revers can be turned up.

The only difference that I could see between this coat and one at \$5.74 was in the pockets. The lower priced garments had slashed pockets, the others had deep, convenient real pockets and came in black and navy blue as well as tan.

The subject of ventilation is important, so that you want to note if there are ventilation eyelets under the arms.

Some rain coats are by no means rain proof. An inner yoke lining hadria is additional protection.

There is no reason why a woman should not look as smart and as appropriately attired on a rainy day as on a clear one. Therefore instead of considering anything good enough for a rainy day, you see that you have a coat, hat and footwear, too, as neat and as stylish as when you go out on dry streets or roads under clear skies.

Add to one pint of lemon juice two pounds of sugar and one quart of water which has been flavored with the grated rind of three lemons. When partly frozen add the whites of four eggs beaten to a stiff froth.

Orange Ice
Use the juice of six oranges and two lemons, one pound of sugar and one pint of water. Freeze in the same way as for lemon ice, adding the whites of two eggs only.

Pineapple Pie
Pare and grate two large pineapples; add one pint of water and sugar sufficient to make a very sweet syrup; strain through a colander and mix gradually with the stiffly beaten white of one egg.

Cherry Water Ice
Strain the juice from a quart of cherries through a lemon Yop cherries through a linen ag and the juice from two lemons, over a pound of sugar. Add a pint of water and freeze.

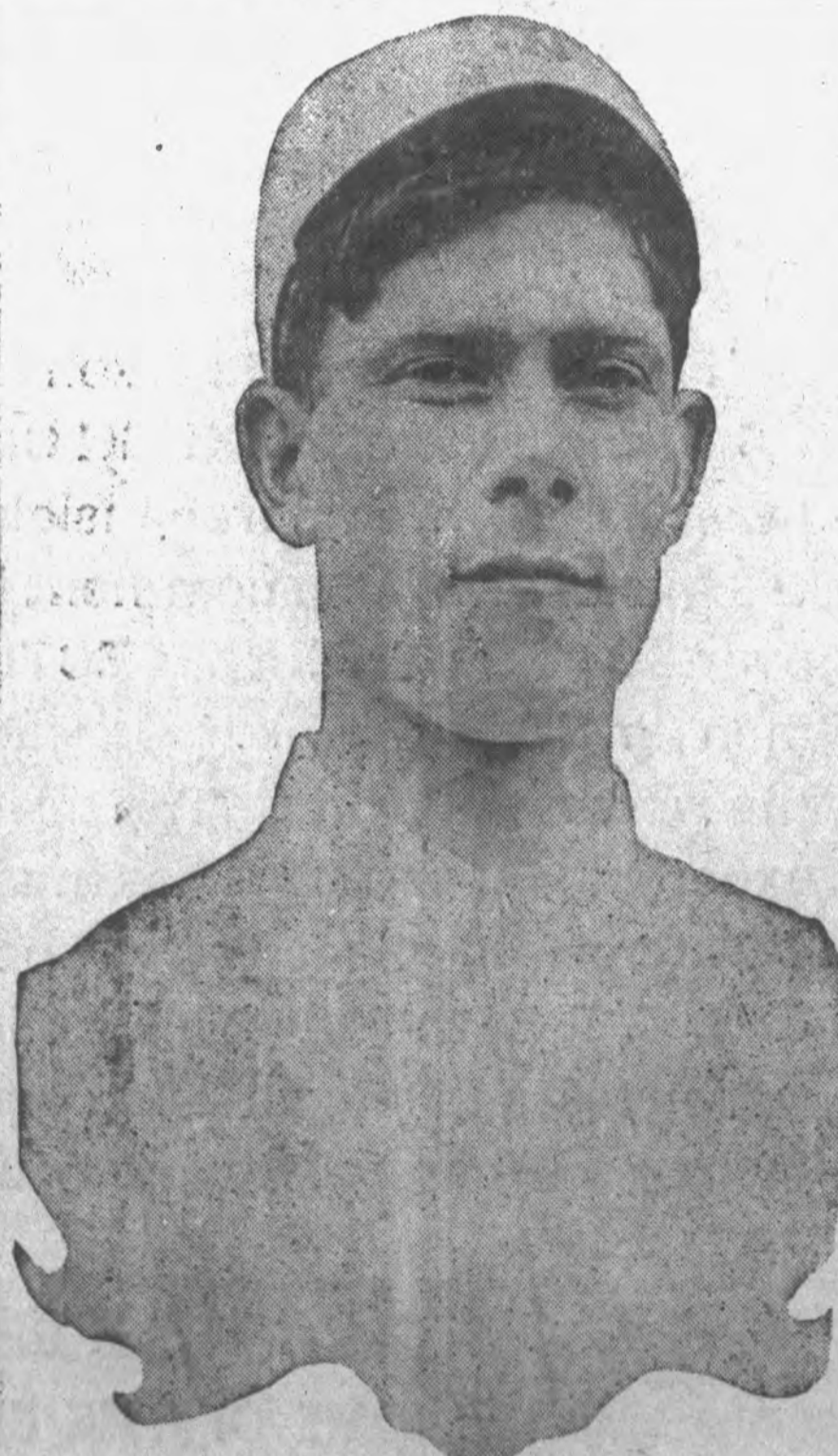
