"Bull Moosers" Have Beveridge For Temporary Chairman of Feast

Roosevelt Cheered By Vast Crowd on Arrival in Chicago

WILL ATTEND CONVENTION TODAY

Teddy Tells Admiring Friends He is Glad to be at Birth of New Party Rather Than at the Death of an Old One

CHICAGO, August 5.—The National Progressive party began its active career here today when the first session of the national convention was held in the Coliseum.

Former Senator A. J. Beveridge, of Indiana, was elected temporary chairman and made a keynote speech. Colonel Roosevelt will not attend the convention until tomorrow.

Mr. Beveridge was cheered through out his speech, a tumultuous interruption coming when he assailed the boss ridden old parties. The rulers of the old parties, he said, were invisible.

They are the invisible government behind our visible government, he declared. It is this invisible government which is the real danger to American institutions.

Colonel Theodore Roosevelt arrived at 8:53 a. m. He was given an enthusiastic welcome and hurried to headquarters in the Congress Hotel. The crowd cheered as the Colonel stepped from the train. He was received by a delegation of Progressives headed by Geo. W. Perkins and Governor Hiram W. Johnson of California.

The crowd massed in front of the station waved bandana handkerchiefs as the party entered automobiles and a chorus of cheers was merged in the blare of a brass band when the trip across the city was begun.

The streets along the route were lined with crowds and as the Colonel swept past cheer after cheer was raised.

The delegates formed in procession and followed their chief to their national headquarters. In front of the hotel another crowd was encountered and for a time the street was blocked. Standing in his automobile in front of the hotel, Colonel Roosevelt said: "I am very pleased to be with you in Chicago again and this time at the birth of a party and not at the death of one. I am convinced that the people will not stand for the convention of seven weeks ago, especially as it was against the interests of the people. By November the men nominated at that convention will not be a factor in the race.

The days of the corrupt political boss and the crooked financier who stands behind the boss and the newspaper owned by the boss and financier are over.

The channels of information have been choked by the opponents of popular government in the effort to prevent the people from finding out what we stand for. I intend to see that the facts are known and that the people find out what this movement really is and decide for themselves what their government shall be.

After completing his speech Colonel Roosevelt went to his headquarters, where he said he would remain all day, consulting with his lieutenants concerning the convention. He said he did not intend to go to the Coliseum today.

The matter of a platform had particularly been left in abeyance. And in view of Colonel Roosevelt's statement upon leaving New York last night that the convention must accept his views in full if he was to be the nominee the convention leaders felt today they had been wise in not taking the matter up in any definite shape.

ROCKFORD, Ill., Aug. 6.—The Rockford team of the Wisconsin-Illinois baseball league has made arrangements for the pennant raising at the local park tomorrow. Efforts are being made to bring out a record breaking crowd. Many factories and stores have agreed to close for the afternoon to enable the employees to attend the game.

Negros At Moose Convention Protest

CHICAGO, August 5.—Contesting negro delegations from Florida and Mississippi were barred from the Progressive convention today by the national committee.

Under the decision of the committee not a negro delegate will sit in the convention. While the committee deliberated the negroes gathered in the corridors outside the committee room and raised their voices in indignant protest. When the decisions were made known the leaders declared that they would continue the contest for seats before the credentials committee of the convention.

In the Florida cases a sort of compromise was reached. The so called lily white delegates, headed by H. L. Anderson, provisional national committeeman from the state were seated in the convention as the regular chosen representatives of the state.

The contesting delegates, headed by C. H. Alston, a negro, were invited to sit in the convention as supplemental delegates, but without a vote.

You're Another Says Uncle Cannon

WASHINGTON, Aug. 5.—The lie was passed on the floor of the House today when former Speaker Cannon denounced an unqualifiedly untrue charge by Representative Burnett, of Alabama, Democrat, that when Speaker of the House, Mr. Cannon had deliberately led his followers from the chamber to break a quorum and in that way defeat immigration legislation.

Before impeaching, Mr. Burnett's veracity Mr. Cannon twice asked him to retract. There was no outbreak.

\$1,500,000 Concern For Hendersonville

HENDERSONVILLE, N. C., August 5.—The financial arrangements are all in shape for the development of a gigantic power plant with not less than 50,000 horse power, according to those who are in touch with this movement.

With reference to this transfer an afternoon Hendersonville paper here said: This gigantic transaction assures Henderson county one of the greatest water power developments in the entire south and one capable of furnishing more than 50,000 horse power to the manufacturers who are awaiting to locate here. Widely known financiers are connected with the company.

The company's financial arrangements are complete and the estimated cost of the 50,000 horse power development will be one and one half million dollars.

Battleship New Hampshire's Stern Battered by Collision With Steamer

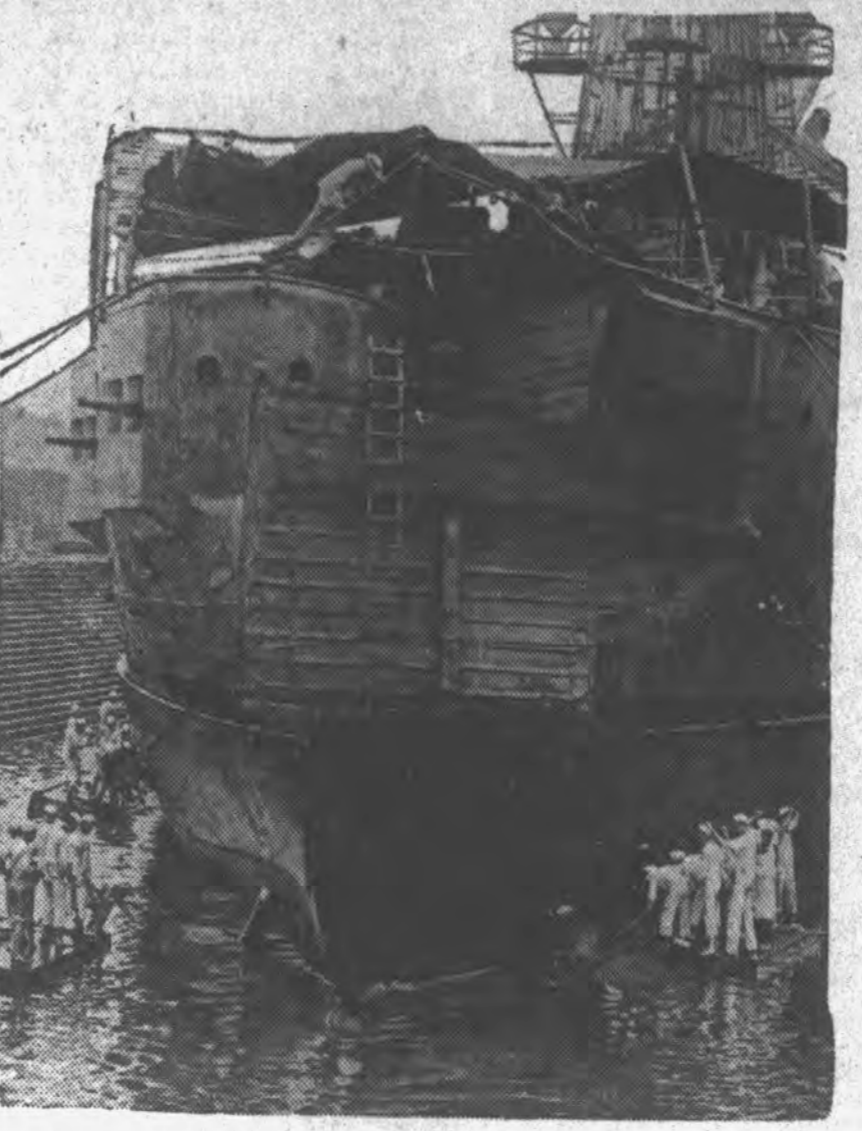

OFFICIALS of the New York navy yard, where the battleship New Hampshire was put in drydock after her recent collision with the Fall River line steamer Commonwealth, estimate that the repairs to the battleship will require two months and will cost upward of \$40,000. The collision occurred in Narragansett bay, and the New Hampshire's stern plate on the starboard side was jammed in about four inches, and the plate was sprung. A court of inquiry will report to Washington on the responsibility for the accident. Officers of the battleship charge that it was due to the high speed of the steamer through the fog that prevailed at the time. While the New Hampshire is out of commission her place in the fleet will be taken by the Alabama, which has been out of commission for the past two years and which is now in the first reserve.

ELIZABETH CITY VISITED BY \$125,000 FIRE YESTERDAY

ONE STEAMER AND SEVERAL R. CARS DESTROYED BY THE FLAMES

ONLY ONE DEATH IS REGISTERED

ELIZABETH CITY, August 5.—Fire early yesterday morning destroyed the steamer Virginia, ten freight cars owned by the Norfolk Southern railroad, that company's freight sheds, the wholesale grocery of W. J. Woodley and company, the offices of the Pasquotank and North River Steamboat Company, the Standard Oil Company and the People's Navigation Company, all situated on the water front.

The fire, which started on the Virginia, had gained considerable head way before it was discovered, the crew of the steamer with the exception of Herman Bowe, being compelled to leap in the river to escape. Bowe was burned to death in his bunk.

Hard work by the fire department prevented the destruction of other big buildings nearby. The loss is estimated at \$125,000.

APPROACH OF MEXICAN REBEL ARMY CAUSES FLIGHT WITH THE SETTLERS

GUERRILLAS DESTROY RAILROAD

JAUREZ, August 5.—Inez Salazar, the rebel leader responsible for the disarming of the American colonists, is heading for the border with his 1,000 rebels.

On his way Salazar is destroying the Mexico Northwestern Railway.

In this way he hopes to delay pursuit by the federal armies which temporarily pocketed him at Casas Grandes. The oncoming insurgents will join their chief, Pascual Orozco, who with about 500 men remains here. Salazar's arrival at Jaurez would combine practically all of the rebels operating in Chihuahua and the next problem would be to proceed successfully into Sonora, the corner state to the west where other rebel groups are operating. On account of the scarcity of water supply the trip directly along the international line is almost impossible.

The northern movement of Salazar's forces has not been agreeable to American capital. Conditions are deplorable, all is lost, wires Juan Amador, manager of the Corralites cattle company ranch on American property, to officials of the company at El Paso.

The Elusive Virginia Outlaws Trailed to Seattle, Washington

Fatally Stabbed During Drunken Brawl

GOLDSBORO, Aug. 5.—Benjamin F. Coley, a young white man of the Eureka neighborhood, about 16 miles north of Goldsboro was shot in a row at that place Sunday morning about 11 o'clock and died at an early hour this morning. Coroner C. E. Stanley and Sheriff Edwards were notified at once of Coley's death and hurried to the home of Coley, where he had been carried. The jury which the coroner empanelled placed the killing on Ernest Cook. He was arrested after a long chase by the officers in their automobile just as he was attempting to board a train at Boston on the Norfolk Southern and is now in the Wayne county jail. Josiah Roe, a friend of Cook, who drove him through the country to the station was arrested for aiding him to escape and is held in default of \$1,000 bond. The officers are on the hunt for Arthur Cook and expect to arrest him tonight.

Secret Service Men Locate Them in the Pacific Coast

EXPECT TO CAPTURE THEM SOON

Sidna Allen and Wesley Edwards Pressed Hard by Secret Service Men—Watching Them For About Two Weeks

SEATTLE, Wash., August 5.—Sidna Allen and Wesley Edwards, leaders of the murderous Allen gang of Carroll county, Va., have been traced to this city, according to a statement made by United States Marshal R. H. Jacoby. Federal officers and the police have definitely determined that Allen has been in Seattle proper within the last week and within the neighborhood for two weeks. The secret service men have been on the lookout for two weeks.

Allen and Edwards were traced to Salt Lake City, but they cleared that city just ahead of the government officers. Allen is known to have been in Ballard, a suburb of Seattle within the last two days. At that time he was secreted at the home of a relative, but was seen and recognized by men whose names, W. R. Bryan agent of the Department of Justice, refuses to divulge. His hand is not yet healed from the gunshot wound he sustained during the killings at Hillsville in March.

The government secret service men are indignant that the story has leaked out. Marshall John Anderson, at Salt Lake, passed on word that Allen and Edwards are bound for the ranch of a man named Hatfield in or near Everett, Wash. This tip resulted in a serious delay on the part of the government officers, for when Hatfield was really located in Snohomish county which was combed by possees Allen and Edwards had come on to Seattle. Hatfield was finally located in the big bottom country between Elbe and Morton, and there were located several families who had come from the Allen's home in Virginia. Among them was 'Devil' Hatfield, as he is known. He is a close friend and former associate of Allen, who has relatives and friends in Puget Sound County.

Allen was here on an extensive visit eight years ago. It is believed that both fugitives are trying either to get north to Alaska or south to Mexico. Seattle is being thoroughly scoured, as both men are dressed like laborers, and hundreds of cheap lodging houses below the dead line are being given particular scrutiny. The big bottom country is being closely watched in order to prevent them from getting back among the foothills and mountain fastnesses, where they can be protected by their former neighbors and friends in Virginia.

The entire police department as well as the full strength of the sheriff's office, the United States Marshal's office and a score of special agents of the department of justice, augmented by several secret service men, are on the job, and Marshal Jacoby and the Captain of Detectives Tennant are confident their arrest is only a matter of a few hours.

Finnish Businessmen Organize

DULUTH, Minn., Aug. 6.—In response to a call sent out some time ago several hundred Finnish businessmen from Michigan, Minnesota, Wisconsin, the Dakotas and Montana gathered here today to discuss the suggestion of forming an organization of the Finnish merchants of the North west. The number of Finnish merchants is quite large in the copper region of Michigan they actually outnumber the merchants of all other nationalities. It is expected that the association will be able to start with a membership of about 500.

Oklahoma Tennis Tourney

MCALISTER, Okla., Aug. 6.—With an entry list comprising some of the best talent of Oklahoma, Kansas, Texas, Missouri and Arkansas, the annual open tournament for the lawn tennis championship of Oklahoma opened here today with some keen competitions in prospect. The matches are being played on the courts of the McAlester Country Club and will continue through the week.

What Gov. Wilson thinks of the Press

SEA GIRT, N. J., August 5.—Governor Woodrow Wilson's sudden entry into the political limelight with a squad of correspondents and telegraphers camped in tents on the meadow near his cottage, has given him a novel experience. The Governor remarked today that while he recognized the sincerity of most newspapers he could not understand some misrepresentations and inaccuracies.

For instance, related the Governor laughingly, when I was president of Princeton University I delivered an address in a certain city in which I said that public opinion was not developed in great congested communities. I said that public opinion was developed in the cross roads store, where the farmers sat around, chewed tobacco, spit into the sawdust and exchanged ideas. I added, jokingly, that no matter what might be said against tobacco chewing it must be admitted that it made men think and that wherever you found men chewing tobacco together you found the real public opinion of the country.

Imagine my horror when the newspapers the next day ignored the rest of my speech—which I thought not without merit—and gave prominence to what I said about tobacco chewing, declaring in the headlines that I said tobacco chewing made thinkers.

The Governor added that a big tobacco company also made a photograph of one of the newspaper reports and used it in their advertising, stamping him as a college president who advocated tobacco to develop the mind.

That's the sort of thing I think is wrong, remarked the governor and should in some way be made impossible; for even though untrue, I doubt if it were libelous.

BUILDING AND LOAN SHARES MATURING

In a talk with Secretary H. A. White, he told The Reflector that the first series of shares in the Home Building and Loan Association will mature sometime this month. This means that something like \$47,000 in cash and cancelled mortgages will be paid to the shareholders of that series and it is no small item.

The Home Building and Loan Association began business the first of May, 1906 and matures its first series of shares in six years and four months, showing that it has been conservatively and economically conducted, with the proper safeguard around the interest of every shareholder. Greenville has never had an institution of which The Reflector felt more proud or watched its progress with greater interest. It was through the efforts of the editor and the cooperation of a few citizens enlisted at the time the association was organized and being in small measure sponsor for it led to increased interest in its career. We believed such an institution would accomplish much for Greenville and that belief has been fully verified in the result.

The association is excellently officered. Nearly all of those directly connected with its management have been with it from the beginning and it is due to their zeal that such splendid success has been reached as to rank the association among the best in the state. They have worked in utmost harmony, carefully investigating every applicant for a loan and looking well into the value of property offered in security. By this care the association has not sustained a loss nor has it been necessary to foreclose a mortgage.

There are numerous houses in Greenville that have been built or purchased through the aid of the association and in other ways many shareholders have been aided through loans. And this good work will go on from year to year as the succeeding series of shares develop and mature. As a new series opens every six months, it means that hereafter a series will mature each six months and twice a year considerable sums of money will be paid to shareholders in cash and cancelled mortgages.

CAUGHT ON THE WING

Some Notes Picked Up By The Reflector Solicitor

Greenville, Aug. 5. Editor Reflector: Just a word about my trip in the country last Saturday and what I picked up by the way. Apart from taking in a nice little sum for The Reflector, I kept my ear to the ground and thus gathered up a good bit of information concerning the political situation in the banner Democratic township in the county.

At Black Jack a goodly crowd had assembled to hear Mr. D. M. Clark on the senatorial situation. His speech in advocacy of Judge Walter Clark's nomination was brilliant, effective and well received. Mr. Clark was careful not to abuse any one, but to point in glowing terms, with splendid emphasis, the excellent qualifications of the gentleman whose candidacy he was advocating and right well did he do it.

In concluding his speech in which he had outlined the progressive policies for which the Chief Justice stands, he gracefully told his audience that he was firmly standing on the same platform and that he wanted all who believed in said policies to vote for him on the 17th as he was a candidate for the House of Representatives. This announcement was gladly received and if I mistake not, the temper of the people, "Reddy" Clark will get a big vote in Chicod township.

Mr. Clark was happily introduced by J. Marshall Cox, who expects to be high sheriff of Pitt county immediately after our efficient Dudley steps aside.

As to the contest that is on in this county for state senate wherein Messrs. Blow, Brown and Evans are contestants, I found the feeling much the same as I found it over the river last week. While Will Evan's un-

warranted attack on honest men has weakened, rather than strengthened his case, in fact, has made him odious and his candidacy a by word and a jest, still there is a painful lacking in enthusiasm for either of his opponents. For this many assign the reason that so far as they are informed neither Blow nor Brown, have publicly announced any definite program or platform of policies and by reason of such failure so to do, they reluctantly conclude that they—Brown and Blow—are doing the straddler's act. It would seem from what one gathers in talking with the people that they demand of a candidate to know in a public way, his position with reference to certain issues.

In this campaign the repeal of the stock law passed by the last legislature has unfortunately been made an issue by Candidate Evans. The persistency of his advocacy of this issue has naturally drawn to him a certain following of the anti-stock law persuasion. By this Evans has taken a stand. Now what the people demand is how Brown and Blow feel about it. If they are not in sympathy with the cussings that Evans has and is putting on the Democratic party and at whose hands he is seeking an office and the lambasting he is giving certain of our honored citizens and officers of Pitt county, why don't they have the courage to say so? It is a part that they have had ample time to prepare answers to charges preferred by Evans but so far they have been as speechless as a dummy. Besides, as some express it, it would seem that any man desiring to be promoted by his party would demonstrate his worthiness by repelling the attacks of the enemy whether emanating from within or without the party. So far, in this respect, Evan's opponents have not come up to what the voters of the party have reasonable grounds to expect. Still it is not too late and we hope that Blow and Brown will loose no time in declaring themselves on the issues agitating the people and being vociferously agitated by Evans in his campaign for the nomination for the state senate.

The campaign for the United States senatorship is resting easy in Chicod just now but the boys tell me that there will be not only many interesting stunts pulled off down there pending the senatorial primary in November, but that a landslide to Kitchin is imminent. However, at this time, taking a surface view of the situation one would judge that Simmons and Clark had the township in their pockets. I shall watch developments in an eagle-eyed way and keep them certified to the readers of The Reflector.

Here is a splendid ticket for county commissioners handed me just before leaving Black Jack Saturday by one of the leading citizens of the township: Messrs. J. R. Spier, Ben Lewis, J. J. Elks, Jno. 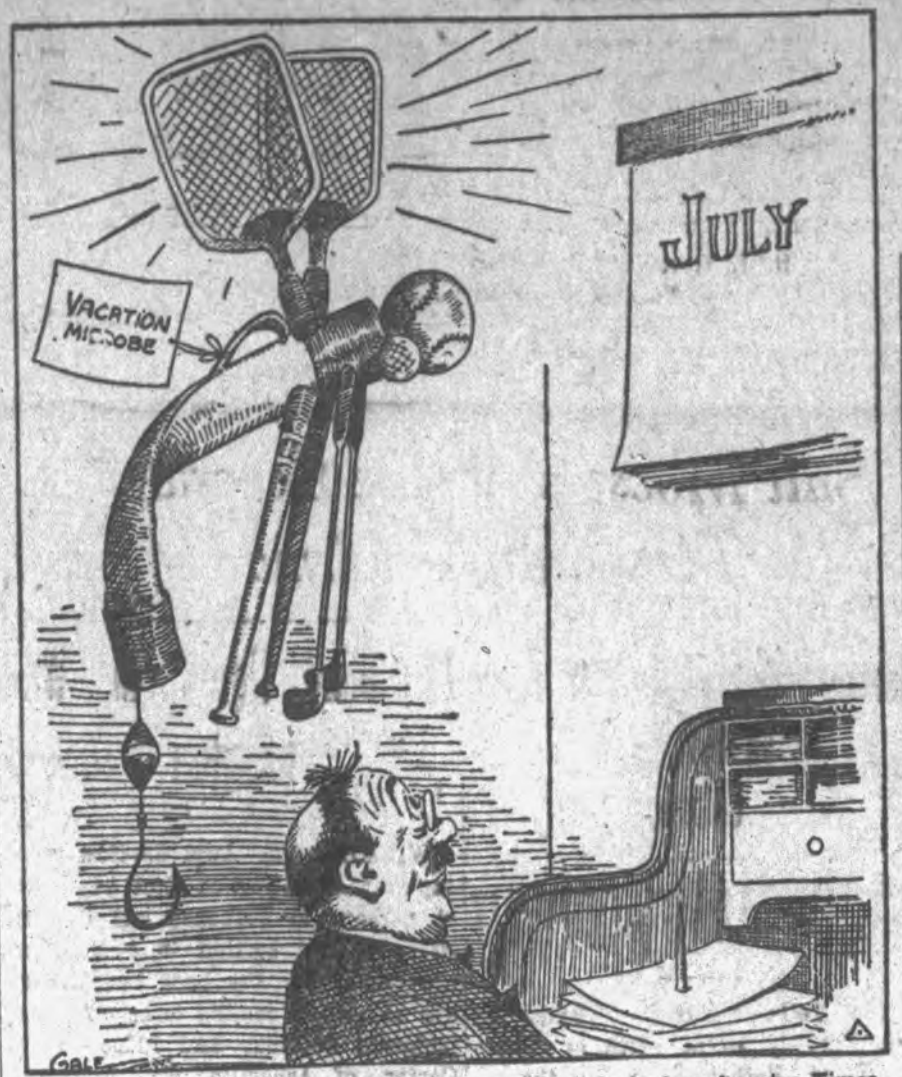

New York, July 13.—Women's fashions are at present in a state of transition and the result is that is present a greater variety of styles may be seen than for many years. The pannier has been made to serve as name for a host of drapery movements that have little in common with the original pannier and there is a prevailing impression that the lower on the skirt this drapery movement is introduced the less does it detract from the slenderness of the silhouette. With some figures that is true, but oddly enough it is often the shorter and more bouffant drapery that gives the impression of slenderness, provided the wearers figure does approximate slenderness. The underskirt or main body of the skirt is clinging, narrow, limp, and the short panniers are so evidently extraneous, stuff put on without regard to figure lines, that they do not distract the eye from the real outlines.

Even where flounces are much in evidence the makers often rely upon this same theory, and instead of carrying the flounces all the way round the skirt, allow the unbroken line of the clinging skirt foundation to appear in front or at the sides. Occasionally among the latest French models one sees odd illustrations of such treatment, things piquant in themselves but exacting much in the wearer.

There was, for example, a frock in white charmeuse. The front of the skirt was plain and clinging. The back breadth was plain and unbroken in line, but full. On each side four rather deep flounces of very fine lace were set on overlapping each above the knee. Below the flounces the sides were straight, the lower part of the skirt being as narrow as that of the ordinary frock of last winter. There

were long sleeves with lace frills, a lace frill collar and on the front of the bodice a simple embroidery motif in clear green. The soft lace flounces of this costume gave much the same lines as subdued side panniers.

One French designer has a liking for flounce arrangements in the back of the skirt and the idea works out prettily in some instances, though sitting down in such a skirt is likely to muss the flounces sadly unless they are of such lace as Alencon which is not easily crunched.

An interesting example of such flounce treatment occurred in a garden party frock of fine dotted muslin over which was a tunic of lettuce green tulle. The front breadth of the softly full untrimmed muslin skirt was uncovered, but most of the bodice was of satin, and below a green velvet girdle tied to a Japanese bow at the back a clinging overskirt of satin fell straight to the floor at the sides and in the back. On this satin tunic were set two very deep flounces of Alencon, beginning low at the sides and running up in points at the middle of the back, the upper flounce point raising to the waist line. Lace trimmed the bodice falling over an inset front of the muslin.

Frequently panniers and bodice in pannier models are in material different from that of the narrow skirt, and sometimes panniers and trains are of one material over a contrasting underskirt. In such a case the panniers may disappear under a train that is merely a full breadth or wide bo plait quite separate from the skirt or may merely melt in jabotting folds into a trouncing train or may be knotted in a graceful way low on the ordinary train.

Low panniers and other draperies above sun pleated flounces of some soft sheer material such as tulle, lace or marquisette are often seen, the flounce falling so straight and soft that it gives the skirt bottom no more suggestion of width than attaches to a plain skirt.

Fine cottons are having an unusual vogue abroad and there are many novelties among them. A cotton resembling the tissue-epong very sheer fine version of eponge which is enormously popular, is attractive and many of the glace or mercerized cotton of high class are altogether lovely, retaining their lustre even after the laundering.

Most of these fine cottons are expensive, often quite as expensive as corresponding sheer silks and wools, but they are ideal summer stuffs and the frocks made from them are suitable even for the most formal afternoon functions. Much open work embroidery on linen or batiste is used, the handsomest lingerie frocks often being made almost entirely in this fashion with trimmings

of heavy lace, and a muslin frock a four with tunic of colored chiffon or silk muslin or with a coat of silk is as smart a garden party toilet as one could wish.

Taffeta continues to claim first place among the summer silks and it is said that its vogue, at least so far as house and evening wear are concerned, will hold over into the winter.

There is no more graceful adjunct to the summer costume than the scarf, when it is properly manipulated. The scarf, as a summer wrap, is as fashionable as ever, for it has been found to be an indispensable item of the wardrobe. It is not used with tailored street costumes of the serge or linen, with tub morning frocks or with short skirted outing frocks, but with trailing evening gowns and the type of afternoon costume that is worn upon semi-formal occasions it is ideal.

The longer the scarf is the more easily and gracefully may it be managed, and if the weights in the ends are properly adjusted, so much the better. Very pretty bridge scarfs for summer piazza wear are made of flowered silk, weighted at the ends with silver tassels. Such a scarf, drawn about the shoulders over a thin lingerie frock, will afford just enough protection when sitting still over the bridge table, out of doors, and will also make a very becoming accessory of the costume.

Embroidered silk gloves scarfs are also charming for afternoon piazza wear. These scarfs are made of a very soft, supple silk and have texture like the long silk gloves worn with summer frocks. These frocks

come in lovely subdued colorings and in white and some of them are embroidered across the ends in harmonizing colors.

Evening scarfs of maline or tulle are the summer craze in Paris. These scarfs are selected in form a harmonizing note with the color scheme of the costume, and when a great counterterier makes the selection the effect is apt to be exquisitely beautiful and artistic.

Lace blouses are worn, but they are no longer veiled with chiffon, although trimmings, collars and revers of chiffon, usually black, are allowed.

Roses of satin ribbon are modish for trimming the corsage or girdle. Those fashioned from two shades of pink or two shades of red are extremely pretty.

ANGEL PUDDING.
Boil together one cupful of sugar and one-half cupful of water until the syrup will spin a short thread and when dropped from the tines of a fork. Have ready the stiffly whipped whites, beating steadily. Stand in a pan of cool water and continue to beat until cold, then add two teaspoonfuls of vanilla, and one cupful heavy cream whipped to a solid froth. Pour into a mold with tightly fitting cover, bind the edges with the greased cloth and bury in ice and salt for fully four hours. When turned on the serving dish sprinkle with finely chopped candied fruits.

FROZEN PINEAPPLE.
Peel, eye and grate or chop fine a good-sized pineapple. Pour over it a cupful of cold water and let stand while boiling one pint of sugar and one pint of water for five minutes. Stir into this the fruit and let stand until cold. Strain, squeezing out all the juice and freeze. When half

frozen add one cupful of thick cream, whipped to a solid froth, and finish the freezing. Let stand for at least two hours to ripen.

CURRENT LOAF.
Take two small cupfuls of sponge out of the general baking and before it is kneaded, add half cupful of butter with a half cupful of sugar, one well beaten egg and a cupful of currants. Stir all together and add the sufficient flour to knead lightly. When light bake half hour. Raisins may be substituted for currants.

Break Land Early For Fall Grains.
In no case would we wait until just before seeding to break the land for fall-sowed crops. Our falls are too dry and there is danger of losing so much moisture that there will be enough left to bring up the crop, there is also another reason for breaking the land some time before sowing fall crops: The land is apt to be dry and break up in clods so that a good seed-bed is nearly, if not quite, impossible, or if obtained, will require too much work. level, so that washing is not troublesome, we would break the land two or three months before time to sow the seed and harrow it once or twice a month to keep the top soil pulverized. This will not only aid in securing and holding moisture for the fall seeding, but it will also tend to break the clods and insure a good seed-bed. If the soil is hard, or has any considerable growth of weeds or other vegetable matter on it, we would risk it before plowing and immediately after. This will prevent and also break clods, will insure the vegetable matter being turned under better and will steel the soil so that it will take in and moisture better. This early breaking of the land for fall crops partakes largely of the nature of the oldtime summer fallow. It would be better to grow a crop of legumes on the land; that is more added to the permanent fertility of the soil; but when legumes are not grown, a better crop of wheat or oats will be obtained if the land is broken early and cultivated several times before sowing in the fall, because this cultivation will help to set free or make available more plant foods and destroy weeds, in addition to saving moisture and making a better seed-bed.—Tait Butler, in The Progressive Farmer.

"Please tell me how to exterminate 'cow itch' cines?" The only way to kill out any plant that continually sprouts from the root is never to allow a green shoot to grow. Digging only spreads these things, but if the tops are kept cut off persistently the roots will die. This is the case with all perennial weeds. Three years ago I bought the land where my garden is. It was infested with nut-grass. I raked up all out I could after the first plowing, and then went for it every day. Chopped off today it was up smiling tomorrow. But I kept it at it day after day. The next season there was much less, and I kept after it again not allowing a plant to escape. Today nut-grass is the scarcest weed in my garden. It is necessary to the life of the plant that they make green tops, and without these roots must die.—W. F. Masseé, in Progressive Farmer.
