

Not An Ounce Of Truth in Report That Tobacco Market Has Been Temporarily Closed

UNFOUNDED RUMOR FINDS ITS WAY TO FARMERS CAUSING A SLIGHT DROP IN SALES AT ALL WAREHOUSES—WAREHOUSEMEN DENY THE REPORT.

Rumor to the effect that the Greenville Tobacco Market was to be temporarily closed, to allow all hands a period in which to catch up with the output of the market in the last few days, is WHOLLY UNFOUNDED, and its source is totally unknown.

While it is true that the market was pushed to the limit during the beginning of the week, and that factories were working overtime to cope with the tremendous output of the market, this was no more than was expected since the opening of the sales on August 15th. With the big crop in prospect and later with the fine prices obtained on the warehouses by the weed, everybody connected with the market expected as much, and while for a time it looked as though the shortage of hogsheads would enforce a lull, this has been dispelled by a reinforcement of coopers, four of them coming to Greenville yesterday. The market is practically as strong as it was at the opening, bidding by the buyers being just as keen as it ever. Greenville can easily dispose of from 250,000 to 300,000 pounds of tobacco every twenty-four hours. Naturally such enormous sales as were witnessed here last Friday and Tuesday were bound to push all hands to the limit, without however, damaging the market in the least, as this would be impossible with the excellent system in force in this market.

All grades of tobacco are commanding prices the like of which has not been witnessed in this part of the country for many a good year, all warehouses making averages little short of wonderful when it is considered that in these general averages, all tobacco is counted, scrap and all. A slight decline in soft-in-order tobacco has been noticed in the last few sales.

The rush at the end of last week and the beginning of the present one prompted somebody to express the belief that this market would be forced to close down temporarily, the belief being strengthened by the report that neighboring markets had made a proposition to that effect. However this temporary closing was never considered here, where no matter how hard pushed the biggest breaks can be taken care of to the entire satisfaction of the farmers selling their weed in the Greenville warehouses, for the simple reason that by the opening of the season warehousemen had equipped themselves to take care of any amount of business. Thus farmers would have to go far to find more competent forces than are doing the work here, every man having an active part in the market being experienced beyond all doubt.

We wish to repeat that THERE IS NO SUCH THING IS CONTEMPLATED AS A TEMPORARY CLOSING.

ONE MORE AEROPLANE DEATH

Chicago Meet Furnishes Two Fatal Thrillers.

CHICAGO, Sept. 12.—Caught by a sharp gust of wind, when about two hundred feet above the ground, Aviator Paul Peck, of Washington, and his Columbia bi-plane were hurled to the ground yesterday at Cicero flying field and the brilliant young birdman was so terribly crushed that he died in St. Anthony De Padua Hospital.

He was descending from his last contemplated flight of the day in the bi-plane which he personally developed and which was expected to perform wonders in the aviation meet. Twice during the afternoon he had made brilliant flights. On his last flight he had descended to a height of about nine hundred feet and with the eyes of one thousand spectators fixed upon him, began his long descent. He descended in long sweeping spirals until he was scarcely two hundred feet from the ground. Suddenly something went wrong and from the long, birdlike swoop, the biplane suddenly swerved, quivered and then tipped sharply downward.

Peck struggled with his controls and for an instant appeared to have regained the mastery of the air, but an instant later the machine again dipped and as the spectators groaned in horror, bi-plane and aviator dropped like a plummet.

Curtiss Aviator Has Miraculous Escape at Winchester, Va.

WINCHESTER, Va., Sept. 12.—W. S. Luckey, an avator of the Curtiss Exhibition Company of New York, had a miraculous escape from being dashed to death against rocks yesterday when his bi-plane, in which he had started a flight, struck a tree in the northern suburbs of Winchester and fell into a deep cut on the Baltimore and Ohio Railroad.

The machine was smashed to pieces but Aviator Luckey was not dangerously injured. His knee was badly gashed and he was cut and bruised about the body, but was able to walk back to the Winchester Fair Grounds, the starting point of his flight.

Ready to Begin Reaper Quiz.

CHICAGO, Sept. 13.—The government will begin the taking of evidence in this city next Monday of the International Harvester Company, which is charged in a dissolution suit filed last May in St. Paul with violating the Sherman anti-trust act. R. S. Taylor of Duluth has been appointed special master to take evidence. The testimony obtained by him will be reviewed by Judge Sanborn of the United States Circuit Court of Appeals.

The government charges in its suit that the I. H. C. controls between 85 and 90 per cent of all the Harvester Machine business in the country, 75 per cent of the mower business, 50 per cent of the bindery twine business, and 30 per cent of the sales of all kinds of farming implements.

The Government further alleges that the company not only has a virtual monopoly in the manufacture of all lines of agricultural implements, but that the agencies for distribution and the retail implement dealers and others are rapidly coming under the company's undisputed control. The Government expects to show that unless this control is prevented and restrained the I. H. C. will have complete, unchallenged dominion of all the branches of trade and commerce in agricultural implements of all kinds.

LAWYER GIBSON UNDER ARREST

Enough Evidence Gathered to Issue Warrant

MURDER IS THE CHARGE

New York Attorney Had Expected Arrest But He Would Not Be Taken Like a Criminal.

NEW YORK, Sept. 12.—Burton W. Gibson, the New York lawyer whose client, Rosa Menchik Szabo, lost her life while boating with him on Greenwood Lake, N. Y., on July 16th, was taken into custody today by Deputy Sheriff DeGraw, of Orange county, on a warrant charging Gibson with murder in the first degree.

Gibson was arrested in his office. Gibson declared his innocence as he was about to leave his home in Rutherford, N. J., for this city, where Deputy Sheriff DeGraw, of Orange county, was prepared to arrest him as soon as he set foot on New York soil.

DeGraw was steady, however, to arrest Gibson at his home in Rutherford in the event that he did not appear in this city.

All night long private detectives hung about the Gibson home, while the headlights of an automobile were turned on the Gibson house so that all exits could be watched.

Evidence submitted before County Judge Royce of Middleton, N. Y., upon which a warrant charging Gibson with murder in the first degree was issued, was most sensational.

Dr. Schultze, coroner's physician, of this city, swore that Mrs. Szabo was so injured before she fell into the water that she never breathed after she sunk below the surface.

The surgeon said there were tricks of jiu jitsu whereby Mrs. Szabo could have suffered a sharp blow in the throat which so affected a nerve as to close her air passage thereby making it impossible to breathe. Dr. Schultze said there was not a single sign of water in the lungs and no congestion. Only expert knowledge was required to do the trick, said Dr. Schultze, who then asked Judge Royce to permit him to show how it could be done.

Quickly the surgeon pressed a point on the judge's throat. The judge gasped and not long after that issued the warrant. It was planned to arraign Gibson before Judge Royce tomorrow.

Gibson came to this city this morning trailed by private detectives and a squad of newspaper men. As he walked through the streets his office a crowd of several hundred people followed him.

Gibson with a private detective, went to Gibson's office and awaited the arrival of Deputy Sheriff DeGraw. Gibson said to the Detective:

"I should like very much to go to Middleton and surrender myself if it can be arranged. Cannot you see the sheriff and arrange to have this thing done in as gentlemanly way as possible?"

The private detective said he would talk to Deputy Sheriff DeGraw when he arrived. The detective waited for some time for DeGraw to arrive and then, leaving Gibson in the company of the newspaper men, remarked: "I guess I'll have to go out and hunt up DeGraw; he seems to be lost!"

Gibson issued a statement just before his arrest, reasserting his innocence and insisting that there had been no struggle either in the boat or in the water. "I am prepared," he said, "to believe that the report will show that Mrs. Szabo died of strangulation. There certainly was no struggle in the water between Mrs. Szabo and myself which would result in her being strangled. When she came up she did not hit the boat in such a manner that would cause her to die of strangulation, I certainly did not clutch her by the throat and there was no way by which she could have died in that manner."

BIG CAR CONCERN GOES TO THE WALL

CORPORATION CONTROLLING TEN AUTOMOBILE FACTORIES A BANKRUPT FIRM.

WAS CAPITALIZED AT \$42,000,000

NEW YORK, Sept. 12.—Receivers were appointed today for the United States Motors Company, a \$42,500,000 holding corporation organized in 1908 to control ten automobile and gas engine manufacturing companies.

Its directors number some of the best known capitalists in the country. The receivers, W. E. Strong and Robert Walker, were appointed by Judge Hough in an insolvency suit brought by the Browne and Sharpe Manufacturing Company, of Providence, R. I., in its own behalf and that of other creditors.

In addition to the appointment of the two receivers for the holding company, five of its constituent companies were involved, namely: The Alden Sampson Manufacturing Company, of Detroit; the Brush Runabout Company, of Detroit; the Columbia Motor Company, of Hartford, Conn.; the Dayton Motor Car Company, of Dayton, O., and the Maxwell-Briscoe Company of Tarrytown, N. York.

The receivers' joint bond was fixed at \$100,000.

Bankers identified with the company say that the proceedings are friendly and brought with the purpose of clearing up the company's affairs with a view of protecting creditors. Plans for reorganization are said to be under way.

The securities of the United States Motor Company have been declining on the curb market for some time, and it was generally reported that the company was in difficulties.

Printer Injured Yesterday Resting As Well As Could be Expected

Mr. Howard Hux, the young man who was injured in the Reflector office yesterday is resting as well today as could be expected. Upon his removal to the doctor's office it was discovered that his hand had been so badly crushed in the cog-wheels of the press that amputation was necessary, so the hand was taken off at the wrist. "Mack" as the boys know him, is very popular and the nerve with which he underwent the suffering, is the subject of much comment. If no complications set in he will be able to be out in a week or ten days.

Meeting to Promote Safety.

KANSAS CITY, Mo., Sept. 13.—A "safety rally" in which 15,000 persons are expected to take part is to be held in Kansas City tomorrow under the auspices of the Sante Fe Railway. The purpose of the meeting is to impress upon railroad employees the necessity of putting safety ahead of all other considerations. Lessons on how care will promote safety will be given by motion pictures, and speakers will tell the story of the pictures and discuss the safety habit. The Sante Fe road claims that as a result of its safety habit campaign the number of accidents to its employes has decreased 20 per cent within the past 12 months.

CHARGE UNTRUE ANSWERS NOLAN

Merely Befriended Newport News Girl

ON WAY BACK TO SCOTLAND

Secretary of Legation at Panama Does Not Regard the Abduction Charge Seriously.

NEW YORK, Sept. 12.—The charge of abducting 16-year-old Marian McVicker of Newport News apparently weighs lightly upon the mind of Harry E. Nolan, recently appointed Secretary of the American Legation at Panama, who was arrested here last Monday.

Upon his release in \$1,000 bail in the Tombs court he sent this telegram to his father, John N. Nolan, general manager of the Traveler's Insurance Company in Chicago:

"No foundation whatever to charge. Simply assisted unfortunate girl. Case continued for a week. Have employed influential attorney who assures me that the matter will come to nothing. Will remain here until case is dismissed."

Nolan, 38 years old, graduated from Yale in 1897, was assistant general manager of the Traveler's Insurance Company up to a few months ago, when he entered the examination for the post he hopes soon to fill. Whether he will be able to qualify, now that he is so unhappily situated, depends largely upon the outcome of proceedings here. The state department has received no official report of the case.

Nolan was arraigned Tuesday morning before Magistrate Murphy in the Tombs court. With him was his lawyer, Sumner Gerard, of No. 60, Broadway, who, like Nolan, is a Yale man. The girl, pretty and neatly dressed, was there with Miss Smith, a matron, who had brought her from the Florence Crittendon mission, on Bleecker Street.

The absence of an Assistant District Attorney from the room caused a delay in calling the case, and this angered the Magistrate into a long criticism of the methods of the District Attorney's office.

Then, when Assistant District Attorney J. B. Reynolds responded to the call, Mr. Gerard asked for an adjournment of two weeks. The court granted one week and then, when argument was started as to whether the bail should be \$2,500 or \$1,000 the Magistrate ordered the detectives to draw up a short affidavit.

When this had been done the court called for Nolan. Yet, of the vast number of persons in the court, Nolan at that time was not one. Nor was his attorney another.

Nolan came along later with his lawyer, Gerard made it clear to the Magistrate that the flurry was due absolutely to a misunderstanding so the bail was reinstated, thus bringing the proceeding to a very charming and satisfactory close.

The McVicker girl had been taken back to the mission. On Thursday evening she will be arraigned in the Womens' Night Court to answer to the charge of vagrancy.

Anniversary at First Tin Mill.

ELWOOD, Ind., Sept. 13.—Hundreds of visitors, among them Vice-President Fairbanks, United States Senator Kern, Daniel G. Reid of New York and other men of wide prominence, came to Elwood today to take part in the celebration of Tin Plate day, the 20th anniversary of the building here of the first tin mill in America. It was on September 13, 1892, that the first tin mill was formally opened here with an oration by Wm. McKinley, at that time the governor of Ohio. The mill opened with a small force of tin plate makers from Wales, from which country practically all the tin used in the United States up to that time had been imported. The pioneer mill proved successful beyond the expectations of its promoters and the buildings of other mills here speedily followed. Within a few years thousands of workmen were employed in the new industry and Elwood has grown from a mere hamlet to a thriving city.

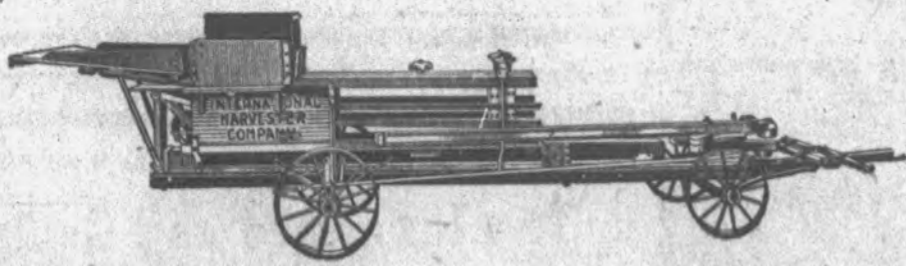
