BALKAN SITUATION ECHOES IN N. Y.

Steamer About to Sail Ordered
to Unload

SENT TO PHILA. FOR AMUNITION

Passengers Ready to Sail For Home
Are Made to Give Their Berths
Up For a Cargo of
Ammunition

NEW YORK, Oct. 3.—The steamer
Macedonia, scheduled to sail at noon
for Piraeus with 2,000 passengers
aboard, was commanded shortly be-
fore sailing time by the Greek con-
sul general at this port.

All the passengers with their bag-
gage were hurriedly sent ashore and
the vessel prepared to sail at once for
Philadelphia to take on a cargo of
ammunition.

From Philadelphia the Macedonia
will return to New York, the consul
general said, for the reservists of
Greece and the Balkan States, who
plan to sail on her to take part on
the threatened war with Turkey.

The Greek consul announced today
that he had received a cablegram
from his government instructing him
to notify all the Greek reservists in
the United States to return to their
colors. This includes all members of
the reserve class of the Greek army
from 1900 to 1910.

Similar notices were received by
leaders of the Bulgarians, Serbs and
Montenegrins. None of these nations
has an official representative here. It
is estimated that there are 100,000
men of the four nationalities in this
country, who are capable of bearing
arms.

The Greek quarter in New York
seethed today with talk of war.

France and Russia in Accord
Paris, Oct. 3.—The governments of
France and Russia are in complete
accord on all questions relating to the
Balkan situation. The program they
are to follow has not been divulged.

The entire situation brought about
by the mobilization of the armies of
Bulgaria, Serbia, Greece and Monte-
negro on the one side and the Turkish
concentration of troops on the other
side, was fully discussed.

The delicate condition created by
the presence of nearly a million armed
men on the frontier lines is recog-
nized here and the govern-
ment, in the same way as the other
European powers, is considering the
best means of preventing a conflict.
It is hoped in all quarters that should
hostilities break out they will be con-
fined to the Balkan peninsula.

The refusal of French and other
European financiers to advance loans
to the Balkan States is appreciated
as a factor in favor of peace.

It is admitted, however, that the
crisis is a serious one.

Windy City Begins to Clean Out Red Light District

CHICAGO, Ill., Oct. 3.—Mayor Har-
rison has issued a statement that a
systematic police investigation against
vice in the city was about to begin
under his supervision. He said that
already steps had been taken to re-
duce the south side "levee" and in-
timated its total abolition was the end
sought. This is the first official
declaration that total elimination of the
segregated vice district is con-
templated.

The efforts of the civic and reform
organizations and religious bodies
have been chiefly directed against the
"levee." Mayor Harrison made his
order for the total suppression of the
"levee" contingent on the express-
ed will of the people and a referen-
dum vote on the subject will be urged.

PASSENGER KILLED, MANY IN-
JURED AS STREET CAR
CRASHES AGAINST
POLE

BREAKS FAILED TO ACT THAT TIME

PITTSBURG, Oct. 3.—With a re-
port like a pistol shot the brakes
on a city bound street car gave way
this morning as it passed down the
Greenfield avenue hill.

Men and women, startled by the
sounw, rushed for the door and bud-
dled together while the car sped along
the grade for eight squares. Then
they were tossed in a bruished and
bleeding heap as it left the rails and
collided with a telephone pole.

John Sanders, a mechanical draughts-
man, was killed and fifty-five other
passengers injured.

Doctors and ambulances were hur-
ried to the scene and more seriously
injured were removed to hospitals,
while others were taken to their
homes.

N. Y. DEMOCRATS NOMINATE SULTZER

Woodrow Wilson Supports His
Candidacy

NEXT OPPONENT FOR LIEUT.

New York Congressman For Eigh-
teen Years is Honored by the
Empire State Demo-
cracy

SYRACUSE, N. Y., Oct. 2.—When
the Democratic state convention re-
assembled at ten o'clock today the
principal work remaining for it to
do was the completion of nominations
for state officers.

William Sulzer, representative in
Congress from New York city for
eighteen years, was last night nomi-
nated for governor on the four bal-
lot and later Martin H. Glynn, of Al-
bany, former state controller, and
Mr. Sulzer's leading rival for first
place, was named for lieutenant gov-
ernor.

The convention today selected the
remainder of the state ticket as fol-
lows: Secretary of State, Mitchell
May; Attorney General, Thomas Car-
mody (renominate); State Comptrol-
ler, William Sohmer, (renominate);
State Engineer and Surveyor, John
A. Benschel (renominate); State Treas-
urer, John J. Kennedy (renominate).

Associated Judges of the Court of
Appeals: John W. Hogan, of Onon-
daga and W. H. Cuddeback, of Erie.

Wilson Pleased

Richmond, Ind., Oct. 3.—Governor
Wilson commended the nomination of
Congressman Sulzer for Governor and
Martin Glynn for Lieutenant Gov-
ernor of New York in the following
statement issued from his train.

"The freedom of the action and of
choice which the convention exer-
cised must afford every Democrat
great satisfaction. In choosing a can-
didate it named a man whose reputa-
tion for integrity and independence
is unquestionable, a man of high
principles, devoted to the public in-
terest. Mr. Sulzer as the chairman
of one of the most important com-
mittees in Congress, has shown capacity
and discretion of a very fine sort. He
certainly deserves the suffrages of in-
dependent men of every caste. His
running mate, Mr. Glynn, has a very
enviable reputation for capacity and
independence and the ticket as a
whole is of a kind to gratify pro-
gressive Democrats very deeply. Both
candidates have already shown char-
acter and capacity in the service of
the great state of New York.

Mexican Rebels Defeat Fed- erals Killing Ninety

LAREDO, Tex., Oct. 3.—Mexican
rebels said to have been commanded
by General Pascual Orozco, Jr., are
reported to have been defeated in one
of the most serious battles of the re-
bellion near Musquiz, Coahuila. The
Federals brought ninety dead and
wounded to Monterey last night.
No accounts of the rebel losses have
been reported. The federals, com-
manded by General Blanquet number-
ed six thousand. Orozco had four
thousand soldiers.

EVERYTHING POINTS TO MOST
SATISFACTORY OCCASION IN
FIFTY YEARS, MANY
ATTRACTIVE

UNUSUALLY GOOD NUMBERS ENGAGED

Fair week at Raleigh, the occa-
sion which annually draws the big-
gest crowds in North Carolina, will
be October 14-19 this year and the
news from the office of the great
state fair is that everything points
to the most satisfactory fair in all
respects in the fifty-two years' his-
tory of this beloved institution.

Entries are pouring in to compete
for the increased premiums on farm
products, fruit and live stock and
the unusually long list of special
prizes in other departments. No less
than \$350 is offered on tobacco alone.
The great premiums are still on the
contests in corn, cotton, tomatoes,
county and individual agricultural ex-
hibits and the fair has been desig-
nated to furnish exhibits to the na-
tional corn exposition.

State superintendent of Public In-
struction J. Y. Joyner and co-work-
ers have made special efforts to make
the educational exhibits representa-
tive of the state's tremendous strides
in public school work.

A feature exhibit will be models
of road machinery sent from the
United States department of Agri-
culture.

The new poultry building, 60 by
150 feet, has just been equipped with
modern steel-wire coops, and com-
petition has been thrown open to the
world. Entries are coming thick and
fast.

Grandstand Facilities

The capacity of the grandstand
has been increased approximately 80
per cent by the building of seats
from its front almost to the race track
fence. An arcade has been construct-
ed running under this tier of seats.
A running event is on the race
program for the first time in sev-
eral years.

Free Attractions

In the list of free attractions are
balloon races, man making double
parachute drop from one balloon, and
woman single parachute drop from
another; New York hippodrome races
on the track, with four-horse Ro-
man chariots, teams of from two to
six with riders standing bareback,
guideless horses racing by themselves,
relay races, and ladies' and gentle-
men's running race; James E. Hardy,
king of high wire walkers, who out-
blinded Blondin at Niagara Falls;
the flying Gilmour troupe, two women
and three men leaping, vaulting and
double somersaulting from bar to
bar at dizzy heights; novelty trick
pantomime, two eccentric clowns and
balancing and frolic of all kinds, il-
lusion of cutting off heads; man and
woman in fancy riding with bicycle,
unicycle and breakaway, man riding
down a long ladder, blindfolded, on

will dispense music.

The grounds will be open Wed-
nesday and Thursday nights, Octo-
ber 16 and 17. The midway will
be a glorious blaze of brilliant lights
and big electric lamps will illumi-
nate the infield in front of the grand
stand for the free acts. The admis-
sion will be 25 cents.

big shows will be Bill Miller's wild
west aggregation, with life-like re-
productions of exciting scenes of the
golden west of old.

J. P. Morgan's Contribution in 1904 Increased by Fear of a Democratic Victory!

Biggest Financier in the Country Had Intended to Give Only (?)
\$100,000, But He Added \$50,000 Because of the

Ready for MacFarland Trial

NEWARK, N. J., Oct. 4.—Prosecu-
tor De Mott announced today the prac-
tical completion of all arrangements
for the second trial of Allison Mac-
Farland, the alleged wife poisoner.
The case had been set for next Mon-
day, but owing to a rearrangement of
the docket the trial will not begin un-
til a week later. The first trial re-
sulted in MacFarland's conviction
and sentence to death. At the com-
ing trial the most important witness
for the defense will be Miss Florence
Bromley of Philadelphia, for love of
whom MacFarland is alleged to have
brought about the death of his wife
by placing a bottle of cyanide where
she would mistake it for headache
powder. Miss Bromley did not tes-
tify at the first trial of the case.

Roosevelt Back in Oyster Bay Refuses to Be Interviewed

OYSTER BAY, Oct. 3.—Colonel
Roosevelt shut himself off from the
outside world today to rest at Saga-
more Hill. He gave instructions that
no one should be permitted to see
him. He spent the day riding and
playing tennis.

Colonel Roosevelt had nothing to
say regarding George H. Sheldon's
testimony before the Clapp committee
yesterday that corporations contrib-
uted the major portion of the Re-
publican campaign fund in 1904, re-
serving his comment on campaign
contributions until he should appear
before the committee.

Frank Pollock has been engaged as
the principal tenor for the perform-
ance of Walter Damrosch's comic op-
era, "The Dove of Peace."

It is announced that Minnie Dupree
will appear in a new play in January
next. Until then she will remain
in vaudeville with a sketch.

WASHINGTON, Oct. 3.—J. Pier-
pont Morgan proved a willing witness
today before the Clapp committee in-
vestigating campaign expenditures
and testified that he had given \$150,-
000 to the Republican campaign of
1904, and \$30,000 to the Republican
campaign of 1908.

In an hour's questioning Mr. Mor-
gan denied emphatically the charge by
Charles Edward Russell, of New York
that President Roosevelt had once
telephoned for a campaign contribu-
tion; declared he never had any com-
munication with President Roosevelt
and asserted that he knew of no con-
ferences among financial men in 1904
or in 1908, to agree on supporting Re-
publican or Democratic Presidential
candidates.

His first appearance on the wit-
ness stand for many years, Mr. Mor-
gan appeared willing to answer fully
any questions. He confirmed the tes-
timony yesterday of George R. Shel-
don, that he had contributed \$100,-
000 to the Republican national cam-
paign fund of 1904 and added that he
later gave \$50,000 to the so-called
"Harriman" fund of \$240,000 raised
for the New York state committee.

Mr. Morgan asserted that no con-
tribution had ever been given by his
firm or himself with the idea of se-
curing any favors thereby. He was
especially interested in the 1904 cam-
paign, he said, solely for the welfare
of the country and the people at
large. That was the only interest he
said, that had guided him in making
contributions to political parties.

The testimony of Morgan supported
that of Mr. Sheldon yesterday, that
so-called "Harriman" fund of 1904 had
been raised as an emergency fund to
help the New York state committee.
Mr. Morgan said he understood that
to be the fact when he gave \$50,000 to
the fund of November 1, 1904. Mr.
Morgan had said it was raised at the
request of President Roosevelt.

"Give the stenographer your name,
please," said Chairman Clapp.

"John Pierpont Morgan."

"Your address?"

"219 Madison avenue, New York."

"Your business?"

"A banker."

Chairman Clapp called Mr. Mor-
gan's attention to a published article
by Charles Edward Russell, charging
that President Roosevelt had deman-
ded that Mr. Morgan raise \$100,000 for
his campaign and that Wayne Mac-
Veagh had been present when Mr. Mor-
gan talked with the White House over
the telephone.

"Do you remember any such inci-
dent?" asked Chairman Clapp.

"Nothing whatever," replied Mr.
Morgan, emphatically.

"I never corresponded over the tele-
phone, telegraphed by mail with Pres-
ident Roosevelt that I know of," Mr.
Morgan added. "Nor with anyone at
the White House."

"Did you make any contributions to
the Republican national campaign in
1904?"

Mr. Morgan adjusted his glasses and
looked at a paper.

In October, 1904, I gave \$100,000;
on November 1, I gave another \$50,-
000.

"Any more?" asked Chairman Clapp.

"No, that is all I know of."

He said he supposed that first con-
tribution was paid to Cornelius N.
Bliss as treasurer of the Republican
committee.

"To whom was the second contribu-
tion made?"

"I don't remember. It was paid in
cash—in money."

DELAYED WEDDINGS AND THE MONEY QUESTION

It seems a strange thing that with all the varied discussion of suffrage and the sex question, none of the enthusiasts for sex equality has mentioned the money question as it affects marriage. The Continental theory that marriage is family business and that it is the duty of the parents to see to the marriage welfare of the young couple, finds no echo on this side of the ocean.

The American idea of marriage is still the pioneer idea. In old days, when women were scarce and the question of organizing a home resolved itself merely into a mating of the men of this land were glad to win anything that wore a petticoat. But with the present day dense population and the struggle for existence in keep competition with other men, this crude form of family life must of necessity give way.

A crying evil of the present day is the delay of marriage until one or both of the couple reaches middle age. More and more it is the fashion for a man to wait until he is thirty-five or forty before he enters matrimony. That means that a man is forty or forty-five before his babies come along and that when his sons and daughters are passing through childhood he is too old to be a companion to them. And these delayed marriages are nine times out of ten caused by material financial considerations. It is becoming harder and harder as the years go on for a young man to earn enough to start and provide for a family. But if the bride brought with her an income equal to that earned or possessed by her husband this condition would be changed instantly and more youthful marriages would take place. In all seriousness, this is a question that the American father of the future must consider.

Kentucky has a new law under which convicts receive regular wages for the work they do while serving sentence. If the convict has a family, 75 per cent of his earnings are turned over to his family and 25 per cent held in reserve and paid to him on his release. Under this law some men are worth more in prison to their families than they are on the outside. That is the trifling fellow who obviously does not support his family.

If you send away from home for things you can buy at home, you have no right to expect the home people to patronize you or give you employment. Keeping your money at work at home is the way to build up your community and make it prosperous.

for his vast wealth and literary attainments. About that time he began to attack with his pen upon the alleged abuses of the Diaz government and this brought him into public prominence. Soon he came to be regarded as a leader of the opposition to Diaz and in 1910 he became a candidate for president of the republic.
