SUBMARINE SINKS WITH 15 ABOARD

The British Craft Goes Down a Mile

ALL OCCUPANTS DROWNED

Hamburg-American Liner, Amerika, Crashes Into British Submarine, B2, and Sends It Under Water

DOVER, Oct. 4.—The British submarine "B2" was run down by the Hamburg-American liner Amerika, here today. It sank at once, drowning fifteen of the crew. One officer was rescued.

The disaster in which the "B2" was sunk occurred while the third patrol flotilla of submarines consisting of six vessels was maneuvering off the South Portland on the coast of Kent. The liner Amerika appears to have cut the submarine completely in halves.

Lieutenant Richard I. Pulleyne, who was second in command was the only man among the crew of fifteen who was saved. He was found floating in the sea too exhausted to say more when he was rescued than: "The submarine is cut in two. I went down a mile."

Nothing has been heard from the Amerika up to the present.

The "B2" had left Dover harbor at 5 o'clock this morning to participate with the other submarines in a series of maneuvers. The accident occurred just an hour later, although none of the sister submarines knew anything about it until Lieutenant Pulleyne was picked up from the sea.

The young lieutenant collapsed after he was taken from the water and conveyed to the parent ship.

The liner Amerika stood by after the accident and threw life buoys overboard while a number of torpedo boats, after being informed of the accident by wireless telegraphy, searched the sea for hours. None of the other members of the crew, however, was found and no sign of wreckage was discernible in the vicinity.

The Amerika then proceeded on her voyage to Southampton and Cherbourg on her way to New York.

This is the sixth disaster to British submarines, each of them involving the loss of from eleven to fifteen lives.

Lieutenant Percy B. O'Brien was the commander of the "B2".

Saw Submarine Too Late

Southampton, Oct. 4.—The second officer of the steamship Amerika, on his arrival here this afternoon, said he was on the bridge at the time of the collision with the submarine "B2". The Amerika was proceeding on her course when the red light of the submarine, which had just come to the surface, was seen. An effort was made to avoid collision, but too late. She sank immediately. Boats were lowered from the liner, but failed to find any of the crew.

Raleigh Water Company is Now In Receiver's Trusty Hands

RALEIGH, Oct. 4.—Three receivers, William B. Grimes and John A. Mills, of Raleigh, and Fred C. Boyce, of Baltimore, were this afternoon appointed by Judge Ferguson to conduct the affairs of the Wake Water Company until the plant is sold by order of the court or it meets the conditions set forth in the charter given it by the city. Mr. Grimes was the choice of the water company, Mr. Mills, of Raleigh, and Mr. Boyce, of the Mercantile Trust Company, of Baltimore, which holds \$250,000 in bonds. They were instructed by the court to employ an expert to make a complete investigation of the plant and facilities and report back to the court. The real fight was over the question of allowing Raleigh a voice in the matter.

TURKISH SULTAN ACCEPTS ITALY'S TERMS

LONG DRAWN WAR OVER TRIPOLI IS PRACTICALLY AT AN END AS RESULT

TURKEY NOW OTHERWISE BUSY

LONDON, Oct. 4.—Peace between Italy and Turkey was signed at Ouchy, Switzerland, last night, according to a news agency dispatch received here from Paris.

Constantinople, Oct. 4.—That the Turkish cabinet voted yesterday to accept Italy's proposals for peace was the announcement made today from an authoritative source.

The preliminary agreements are to be signed upon the arrival at Ouchy of a special Turkish emissary who left Constantinople immediately after the cabinet meeting.

Jubilee of Sunday Schools

PHILADELPHIA, Pa., Oct. 5.—The Jubilee of State Sabbath School convention, marking fifty years of Sabbath school work in Pennsylvania, was ushered in here this afternoon with a parade of 79,000 teachers and scholars. The convention will continue an entire week. On Monday there will be a testimonial to John Wanamaker, for many years chairman of the board of directors of the Pennsylvania Sabbath School Association.

Senator Simmons Makes a Strong Appeal For Democracy

FAYETTEVILLE, Oct. 4.—Senator F. M. Simmons spoke here today in advocacy of the Democratic ticket and his own candidacy for return to the senate, making what was generally conceded to be a strong and able plea.

The senator was met at the railway station by a reception committee appointed by J. B. Underwood, the Simmons' manager for Cumberland county, and was escorted to his hotel and thence to the LaFayette theatre by these and other citizens and a band.

Before H. L. Cook introduced Senator Simmons, A. J. McKinnon, of Maxton, made a short address to the crowd, telling them that Robeson county would give Simmons a big majority. The senator, who was very hoarse, made much the same as his Charlotte speech.

To Enthroned Bishop Weller

FOND DU LAC, Wis., Oct. 5.—The enthronement of Rt. Rev. Reginald Heber Weller, who succeeds the late Bishop of Grafton as head of the Protestant Episcopal diocese of Fond du Lac, is to take place tomorrow in St. Paul's Cathedral. The service will be simple, at the special request of Bishop Weller.

Colored People Disorderly

There came near being some trouble at the 5 o'clock Norfolk Southern train Friday evening. It was just after the circus and a large crowd was going away. There were enough colored passengers to overrun the coach reserved for that race and several of them bolted into the car for white people. They refused to leave the car when ordered to do so by the conductor and he had to call policemen to his aid. Some of them were so obstinate that the officers had to threaten force to eject them.

TORPEDO BOAT IN BARGE COLLISION

DESTROYER BEALE RUNS INTO A BARGE WHILE SAILING DOWN DELAWARE AND IS DAMAGED

BARGE FAILED TO SHOW LIGHTS

PHILADELPHIA, Oct. 4.—The new torpedo boat destroyer Beale, while proceeding down the Delaware river last night from this port for Newport, R. I., collided with a barge and tore a large hole in her bow.

The collision occurred near Newcastle, Del., about thirty nautical miles below this city. The hole torn in the ship measures about 20 feet by 10 feet. The Beale was in command of Lieutenant Parker and had a crew of 52 officers and men, most of whom were asleep, but the shock of the collision awoke all on board. None of the crew was injured.

As quickly after the collision the watertight compartments were closed and the Government tug Samoset was summoned and the Beale was towed back to the navy yard here, arriving today. Preparations were immediately made for an examination and the destroyer was placed in the dry dock.

A. C. L. Agent Has Big Sum of Money Missing From Office

WILMINGTON, Oct. 4.—Claude Murray, union ticket agent here, lost or had stolen from him this morning a sack containing \$805.12 which he was taking to the general office of the Coast Line to be deposited with the Treasurer of the road. He had the money with him down town and visited a barber shop, the postoffice and the Murchison National Bank and started toward the Coast Line office before he missed the money. Police and county officers have been working on the case all day but so far no clue has been found as Mr. Murray is not certain where he left the money.

Board of Aldermen Held Regular Monthly Meeting

The board of aldermen met in regular monthly meeting Thursday night with all but one of the members present.

The different committees reported the work done in their respective departments during the past month.

S. T. White asked permission to install a safety gasoline tank, which was granted.

W. H. Ward, agent of the Atlantic Coast Line, asked for an amendment to the train speed ordinance through town, changing the limit from 16 miles to 15 miles an hour. The change was made as requested, trains also being required to give signals at all street crossings.

Several citizens requested extension of the water main out Fifth street near the Training School so that those soon to build out there may be provided with water. The matter was referred to Superintendent Allen to make an estimate of the cost for such extension.

A street light was ordered placed at the corner of Twelfth street and Greene Mill road.

An order was passed that the sidewalk paving on Evans street be extended from Tenth to Twelfth street.

Citizens on Dickinson west of the Atlantic Coast Line, petitioned for concrete sidewalks from the railroad to the town limits, and order was made accordingly. A similar order was passed in regard to Third street westward from Evans street to Pitt street and on both sides of Fourth street from Evans street to Cotanch street and the north side of Fifth street from Evans to Cotanch.

Winter uniforms were ordered purchased for the policemen.

An ordinance was passed requiring contractors for inside wiring to give bond in the sum of \$1,000.

At Present Receiver of Road in Michigan

WONT DISCUSS APPOINTMENT

Headless Road May Decide to Elect Son of Norfolk and Western's President for President at Early Date

NORFOLK, Va., Oct. 4.—It is now stated that the presidency of the Norfolk Southern Railway has been offered to George P. Johnson, at present receiver for the Detroit, Toledo and Ironton Railroad and that Mr. Johnson is expected to be formally elected by the Norfolk Southern directors at New York within two weeks. Mr. Johnson is the son of L. E. Johnson, president of the Norfolk and Western Railroad and before his appointment several months ago as receiver for the Detroit, Toledo and Ironton Railroad was general superintendent of the Western division of the Norfolk and Western Railway at Portsmouth, Ohio. Mr. Johnson is 41 years of age.

The presidency of the Norfolk Southern has been vacant since the resignation August 1st of E. T. Lamb to become operating head of the Atlantic, Birmingham and Atlanta Railway at Atlanta, Ga. It was said for some time that Frank S. Gannon, former president of the old Norfolk and Southern Railway Company, would again head the system, but later the names of T. F. Whittlesey, former general manager of the Seaboard Air Line Railway was mentioned. It was also said that the Norfolk Southern was offered to C. H. Hix, at present general manager of the Seaboard.

The report that Mr. Johnson is to come from the Detroit, Toledo and Ironton receivership to the Norfolk Southern seems well founded. Mr. Johnson's headquarters are now in Detroit, Mich.

Women Temperance Leaguers Hold Forth In Asheville

ASHEVILLE, Oct. 4.—Today's meeting of the state convention of the Woman's Christian Temperance union was featured by the address of Judge Jeter C. Pritchard who declared that North Carolina had prospered under prohibition and it would be a great mistake to the return to the open saloon.

The president's address was delivered this morning by Mrs. T. Adelaide Goodno, of Raleigh. Numerous reports were made by various committees and officers at the day's sessions. Last night was given over to addresses of welcome and responses.

The action of the Republican party in resurrecting the prohibition question as an issue of the present campaign was condemned. Mrs. Ellen J. Y. Preyer, of Greensboro characterizing the plank as a rotten one which reserves to bear down all those who stand upon it.

Tomorrow's sessions will be given over to the addresses of superintendents and the election of officers for the coming year.

Bull Moose Chief Before Committee Emphatically Denies Soliciting Funds

Colonel Roosevelt Cheered as He Entered Building Where Sessions Are Being Held. Offers Important Documents to Prove Statements

READS LETTERS ADDRESSED TO BLISS AND CORTELYOU.—NEVER ASKED HARRIMAN'S HELP

Record Crowds Look On Delighted at Circus Stunts

C., Oct. 5.—The most distinguished Masonic gathering of an international character that has ever met in the United States will assemble in this city next week for an international conference of supreme councils of the fraternity. The foreign delegates, a number of whom arrived in the city today, include Masons of the highest degree from France, Italy, Egypt, Belgium, Greece, Mexico, Switzerland and from several of the countries of South America and many of the larger cities of Canada.

Wilson the Guest of Bryan

LINCOLN, Neb., Oct. 5.—William J. Bryan welcomed Governor Wilson upon the latter's arrival in Lincoln today to deliver an address. The will remain tomorrow as the guest of Mr. and Mrs. Bryan at Fairview.

WASHINGTON, Oct. 4.—"I asked

no men to contribute to the campaign fund when I was elected President of the United States, and I wish to reiterate that Mr. Bliss and Mr. Cortelyou, both assured me that no promise had been made as a return for any contribution. Neither they nor any one else having authority asked me to act or refrain from acting in any matter while I was president, because any contribution had been made or withheld.

"Gentlemen, could I put it more sweepingly?"

In those words Colonel Theodore Roosevelt summarized his testimony today at the close of the first part of his hearing before the Clapp committee of the senate investigating campaign funds.

The principal part of Colonel Roosevelt's testimony was concerning the \$100,000 Standard Oil contribution to the Republican national campaign fund in 1904.

While on the stand Colonel Roosevelt emphatically denied the charge that corporations had been "blackmailed" or promised favors for campaign funds.

In replying to the allegations that \$3,000,000 was used in the Progressive primary campaigns, the witness suggested that Republican National Chairman Hillier and Congressman Bartholdt who made the statement, be summoned and asked for proof.

He also demanded that Democratic National Chairman McCoombs, W. B. McKinley, manager of the Taft campaign and Charles P. Taft be summoned and Chairman Clapp assured him that this would be done before the election.

Colonel Roosevelt read a letter written Chairman Cortelyou, of the Republican Committee in 1904, protesting against receiving contributions from corporations and demanding that those received be immediately returned.

A murmur of applause culminating in a cheer greeted Colonel Roosevelt as he entered the building about five minutes before the time set for his appearance. He forced his way through the crowds in the corridors with some difficulty and found his way to Senator Clapp's private room.

There he met the members of the committee. The crowd continued to grow and every door of the big room was surrounded by an anxious crowd.

Colonel Roosevelt learned this morning that Governor Hadley, of Missouri, had declared in favor of President Taft. He would make no comment upon the governor's action, but would express an opinion upon the nomination of Congressman Sulzer as Democratic candidate for Governor of New York.

"I have nothing to say upon any subject," said the Colonel.

The spectators applauded vigorously as Colonel Roosevelt entered the room, followed by a secretary lugging a big valise filled with papers.

The Colonel took his place in the witness chair and the secretary with the big grip between his knees seated himself beside him.

"You were a candidate for president in 1904?" asked Senator Clapp. "I was," answered the Colonel shortly.

"Geo. B. Cortelyou was chairman of the committee that year?"

"He was."

"And Cornelius N. Bliss was treasurer?"

"He was."

Senator Clapp asked Colonel Roosevelt if his attention had been called to certain statements made by John D. Archbold.

"It has," replied Colonel Roosevelt, tersely.

Senator Lodge Presides

BOSTON, Mass., Oct. 5.—Senator Henry Cabot Lodge occupied the chair and delivered the keynote speech at the Republican state convention which met today in Tremont Temple to nominate 18 presidential electors and frame a platform for the state campaign.

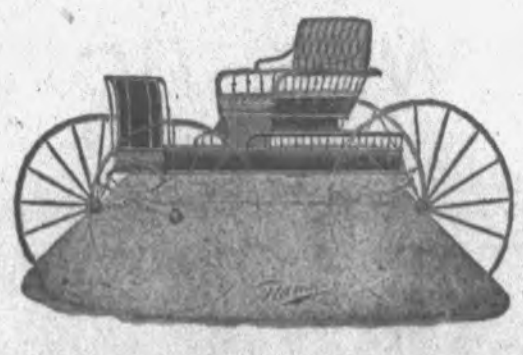
