Colonel Roosevelt Improving Rapidly Talks of Continuing Campaigning--Bullet Not to be Extracted

Last Bulletin Issued by Attending Physicians Give His General Condition as Splended, Removing All Doubt as to Speedy Recovery

May Not Complete Full Week in Hospital

CHICAGO, Oct. 17.—The most reassuring bulletin issued yet concerning Colonel Roosevelt's condition was given at 1 o'clock. It read "Pulse, temperature and respiration normal. Blood count has dropped to normal."

The third day of Colonel Roosevelt's stay in the hospital was quiet. The dread of serious developments was largely allayed. His physicians said it would require another day before the medical men, if there is no change for worse, will be able to say: "All is well."

Mrs. Roosevelt maintained watch at the bedside of her husband established a quiet, smooth running routine which it was agreed, was the best possible thing for the Colonel. At noon she decided that no visitors were to see Colonel Roosevelt during the day, because he had not slept during the morning. Her decree was accepted without question, although the colonel complained, smilingly, that she did not give him the opportunity to say anything about it.

Chicago, Oct. 17.—Six doctors, making the most extended survey of Colonel Roosevelt's condition, attempted since his arrival at Mercy Hospital, this morning found his condition as near normal as a wounded man's could be and renewed their assurance that there was no longer cause for worry.

It also was announced positively Colonel Roosevelt would not leave the hospital until next week at least.

The physicians were Dr. Murray, Dr. Beven, John F. Golden, Scurry L. Terrell, Alexander Lambert and William B. McCauley. The last named dressed the Colonel's wound.

The following bulletin was issued: Pulse 72; temperature 98.3; respiration 18, all night. Wound dressed and looks well, some oozing. Examination by Dr. Lambert shows lungs in good condition; general condition splendid. The case is progressing so favorably that unless some complications occur the bullet will not be removed at present.

Colonel Roosevelt already is feeling so much better and has shown so much improvement that on awakening today he began planning for a continuation of his campaign trip. Most of last night the Colonel spent in restful sleep.

Dr. Lambert, the family physician, explained that there was no significance in the fact that the bulletin that said the bullet would not be removed "at present."
"You see," he said, "when you talk of the future, we must be indelicate. Suppose sepsis were to set in after we had said the bullet would not be removed, then the previous assertion would appear either misleading or misinformed. So we say the bullet will not be taken out now. It depends on two things whether it will ever be removed. One is, if it starts causing trouble. The other is if Col. Roosevelt had rather carry his 'souvenir' in his pocket than in his chest."

Dr. Golden said that no move might be made by the patient until Sunday. "As long as he is here," said Dr. Golden, "we feel we might as well keep him. If he remains quiet until the rib knits sufficiently to be a reasonable guarantee that it will not break again, that will remove another unpleasant possibility."

Mrs. Roosevelt is pleased with the situation and agrees that he should not leave the hospital until at least after Sunday.

Theodore Roosevelt, Jr., was the first of his children to call on Col. Roosevelt today. He came at 9:30

and helped the stenographers in arranging the telegrams which had been received during the night.

With a pocket full of these he felt the Colonel would be most anxious to read, he went into the patient's room.

\$50,000,000 CIGARETTE COMPANY FORMED AND GRANTED CHARTER

RICHMOND, Va., Oct. 17.—The Tobacco Products Corporation of Virginia has been chartered here by State Corporation Commission with an authorized capital of fifty million dollars. The concern will engage in the manufacture of cigarettes wholly and will become a competitor of the American Tobacco Company for that business.

None of the promoters has been or is connected with the old company.

EXPOSURE OF GUN IN CARNIVAL GETS A MAN IN SERIOUS TROUBLE

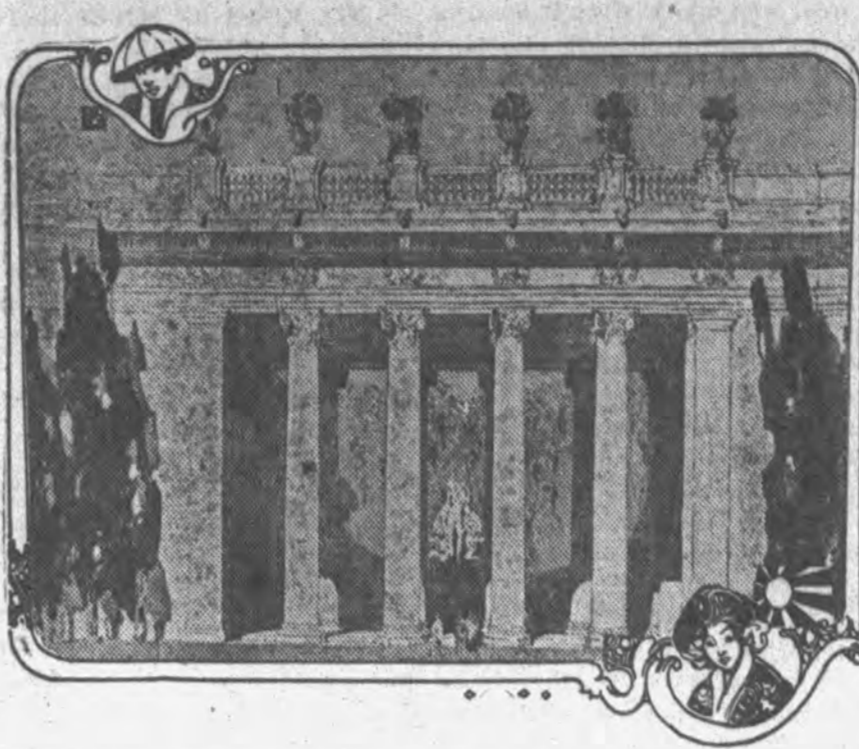

STUDY OF THE COURT OF THE FOUR SEASONS, PANAMA-PACIFIC INTERNATIONAL EXPOSITION.

TO the west of the great Court of Honor at the Panama-Pacific International Exposition will come the Court of Four Seasons, one of the most elaborate and beautiful of the great interior courts that will lie between the huge exhibit palaces of the main group. The walls of the court will be partly formed by the palaces of Liberal Arts and of Education and by the two great wings of the Palace of Agriculture and partly by the classic colonnades and peristyles that will connect these buildings. The Court of Four Seasons, in classic Italian architecture, is designed by Mr. Henry Bacon of New York, designer of the Lincoln Memorial. In harmony with the title of the court there will, in each of its four corners, be set groups of statuary symbolical of the seasons—Spring, Summer, Autumn and Winter. The sculpture will be set in niches screened by colonnades. Mural paintings, also suggestive of the seasons, will form the background for the setting. Mr. Jules Guerin, the noted artist, has charge of the color plan. The Court of Four Seasons will be 340 feet square.

A ten inning game was necessary to decide the series. The largest score was 11 to 4 and the smallest 2 to 1. The score of the tie game was 6 to 6.

The attendance and receipts broke all records for similar events.

BARE MICHIGAN CAMPAIGN GRAFT

Delegates Bought Like a Bill of Goods

ROTTENEST PRIMARY PULLED OFF

Supporters of President Taft Spent Large Sums of Money Lavishly in Favor of the President

WASHINGTON, Oct. 17.—Lavish use of money by the supporters of the president in the Michigan primary was charged before the Clapp committee today by James M. Murfin, a Detroit lawyer.

Murfin said that when he and Captain Alger raised \$1,500 and offered it to J. D. McKay, in charge of the Taft campaign, Mr. McKay said he had plenty of money—more than he had ever had before in any campaign.

Murfin testified he understood McKay to say that candidates for delegates to the county conventions were "holding him up" for as much as \$300 each.

It is a matter of general knowledge that the primaries in Detroit this year were the most corrupt on both sides that was ever known," said Mr. Murfin. "It was just about as bad on one side as on the other, but as our people were the most skillful and we got the delegates. Both were absolutely rotten.

"I asked Mr. Warren how much money was to be used in Wayne county. He asked me how much was necessary. I told him not more than \$2,500 could be honestly spent. He told me Mr. McKay insisted on having \$5,000 before he started.

"Well, I said, 'we'll have a rotten campaign,' and we did. It was the worst campaign I ever saw."

"Why Senator," he exclaimed, answering Senator Pomerene, "both sides bartered for these delegates like so many sheep. Some of them accepted money from both sides. Of course I don't know the details, but that was the general situation."

"Who would know the details?" asked Senator Pomerene.

"John D. McKay."

Chairman Clapp placed in the record a copy of the bank account for the Republican national committee in 1904 at the fourth National Bank of New York. It showed deposits among others, of \$240,000 in the last few days of October; \$35,000 on October 27; \$100,000 on October 28; and \$105,000 on October 31. This was about the time the so-called Harriman fund was collected.

Pierre Loti Sails For Home

NEW YORK, Oct. 17.—Pierre Loti, the distinguished French author and playwright who came over to attend the first performance in this city of his play, "The Daughter of Heaven," sail for home today on the Provence. On the eve of his departure M. Loti expressed himself highly pleased with what he had seen of America and the Americans.

AVIATORS CONTINUE TO FALL AND BE KILLED; FRENCH MAN DIES

CHALONS, France, Oct. 17.—Another French military aviator, Lieutenant Bianco, was killed today. He was flying in his monoplane over the entrenched camp here when one of the wings broke and he was thrown from a height of 1,200 feet.

GOV KITCHIN ANXIOUS TO MAKE A RECORD AT ISSUING PARDONS

RALEIGH, Oct. 17.—Gov. Kitchin yesterday granted clemency to two convicts, one of them a woman by the name of Charlie Welch, of Stokes county. H. L. Pierce, of Wilkes county is the other pardoned one. Pierce as convicted and sentenced to ten months on the roads for selling liquor.

GUNMAN'S WIFE ON WITNESS STAND

Lefty Louie Better Half an Interesting Witness

ATTEMPT TO BAR HER TESTIMONY

Mrs. Lillian Rosenberg, on Witness Stand Tells of Visit Paid to Her Home by Rose and Schepps

NEW YORK, Oct. 17.—Mrs. Lillian Rosenberg, wife of "Lefty Louie," one of the four gunmen charged with shooting Herman Rosenthal to death, was a witness for the state today in the trial of Police Lieutenant Charles Becker as the instigator of the murder.

The District Attorney's intention to place her on the stand was met vigorously but futile attempts from the defense to bar her testimony.

Mrs. Rosenberg's testimony was corroborative of a portion of the story told by Jack Rose on the witness stand last Saturday. She said that Rose had come with Sam Schepps to her home on May 12 to see Louie about helping get bail for Jack Zelig, the gang leader killed the other day, who had just been arrested on a charge of carrying concealed weapons.

"Louie was sick in bed," she declared, "and Schepps and Rose went into his room and talked twenty minutes with him. They talked about Zelig."

Mrs. Rosenberg added on cross-examination that she was not testifying to help her husband or with hope of his receiving leniency.

"Lefty new," she said, "that I would take the stand."

The wife of the gunman was one of the several witnesses who corroborated portions of Rose's story. Two telephone operators, one at a public station, the other at the apartment house where Becker lived—testified regarding the murder.

A tentative outline of the defense called for the appearance in Becker's behalf of William Travis Jerome, former district attorney of New York, to refute Jack Rose's testimony concerning his (Rose's) last telephone conversation with Becker after the murder. Rose, in telling of this conversation quoted Becker as having guilty knowledge of the murder.

THE BULL MOOSE CAMPAIGN WAS FINANCED BY FRANK MUNSEY

WASHINGTON, Oct. 17.—Frank A. Munsey, the publisher, today testified to the Clapp committee that his total contributions to Col Roosevelt's campaign this year had been \$118,005.72.

His pre-convention contributions to the National campaign totaled \$67,000 and the balance as given to state committees.

Mr. Munsey estimated the total expenditures of the Roosevelt pre-convention campaign at about \$574,000 given by several large contributors.

"That does not include dribbles of \$5,000 and \$10,000," he said. "I do not think that was excessive, judging from my experience. Excluding the expenditures in Ohio, Pennsylvania, California, Roosevelt's total pre-convention expenditures for the whole country were about \$350,000."

To Attend Consecration

MONTREAL, Oct. 17.—Prelates and clergymen from various points arrived in this city today to attend the services of consecration of Rev. Heber J. Hamilton, the bishop-elect of the new Canadian diocese in Japan. The consecration is to take place in Christ Church Cathedral and will be attended with all the pomp and ceremony prescribed for the occasion by the ritual of the church.

THE TARIFF

(By WOODROW WILSON)

We stand in the presence of an awakened nation. Plainly it is a new age. There are two great things to do. One is to set up the rule of justice and right in such matters as the tariff, the regulation of trusts and the prevention of monopoly. The business of government is to separate special and particular interests of wide communities. The initial task this year is to get our government in such shape that we can use it for our own purpose, not against anybody in particular, but for everybody in general. We want to establish a real partnership between all the people and the Federal government instead of between special interests and the Federal government. We must effect a great readjustment and get the forces of the whole people once into play.

The tariff question, as dealt with in our time, has not been business. It has been politics. The tariff has become a system of favors. Tariff schedules have been determined in committee rooms and conferences. The tariff becomes a matter of legitimate business only when the understanding it represents is between the leaders of Congress and the whole people of the United States, instead of between the leaders of Congress and small groups of manufacturers, demanding special recognition and consideration. That is the heart of the whole affair. It is at bottom a question of good faith and good morals.

Our conviction as Democrats, is that the only legitimate object of tariff duties is to raise revenue for the support of the government. We denounce the Payne-Aldrich Tariff Act as the most conspicuous example ever afforded the special favors of monopolistic advantages which the leaders of the Republican party have shown themselves willing to extend to those to whom they looked for campaign contributions. The changes which we make should be made only at such a rate and in such a way as will least interfere with the normal and healthful course of commerce and manufacture. There should be an immediate revision downward. It should begin with the schedules most obviously used to kill competition and raise prices in the United States, and should be extended to every item which affords opportunity for monop-

oly and special advantage. Until special favors shall have been absolutely withdrawn and our laws of taxation transformed from a system of government patronage into a system of just and reasonable charges which shall fall where they will create the least burden.

The Republican party doesn't propose to change any of the essential conditions which mark our present difficulties. Mr. Roosevelt proposes in his platform not to abolish monopoly, but to take it under the legal protection of the government; and to regulate it, to take the very men into partnership who have been making it impossible to carry out these great programmes by which all of us wish to help the people. We don't want to disturb the industry of other people which these men have established and which makes it impossible that we should give ourselves a free field of service.

So many politicians when they are out after office declare they are friends of the farmer. Even President Taft has got to saying so about himself. The friends of the farmer are the ones who do something to make his condition better and give him an equal chance with other folks. President Taft cannot claim that he has done this. On the contrary he has helped to make the farmer a prey of the protected interests

SIMMONS AND LUMBER

You have read the speeches of Simmons defending the 7 per cent lumber tariff for which he admits voting in 1909, but a careful analysis of the bill shows that the average ad valorem duty carried by that bill was 11.42 per cent (instead of 7 per cent) as compared with 12.61 per cent under the previous act.

The duties carried by the 1909 act vary from 9 to 45 per cent, the lower duties being on the heavy articles.

Some reduction was made on ordinary grades of lumber, but the average duty was left at about \$2.00 per M feet.

The following are some of the articles covered by the lumber tariff and the duty on same:

The 1909 act also advanced the tariff on shingles from 30 cents to 50 cents per 1,000.

The method usually adopted by the Simmons forces is to draw attention away from any unfavorable statement by making an attack on its author, but in this case the above is from a public document of which Simmons is one of the authors.

They might, however, go to Washington and get a line on the Public Printer who sent out the document and cast aspersions on his character and political affiliations.

While you are home today get out your pencil and paper and write down the cost of your tables, beds, chairs, and all your household furniture that is made of wood and then figure 35 per cent of that cost.

If you own the house you live in, figure \$2.00 per M feet on the lumber use and 50 cents per 1,000 shingles

and add this to the 35 per cent on your furniture.

Your family has probably used very few railroad ties and telegraph poles so you will not have to take account of the reduced tariff on them.

Call your wife and children around you and show them what the tariff cost you. Tell them that it is what you have paid by reason of the lumber tariff for which Simmons voted and is what you would have to give them if a man like Judge Clark had been in the Senate.

Your wife may ask you if Simmons did not write a platform at Denver pledging free lumber and such a question from a Clark or Kitchen man would constitute an "abusive attack," but your wife is thinking of what she could buy for the home and the kids with the money which went to the Lumber Trust by the vote of Simmons.

In spite of all this, you will go out and vote for Simmons just because you have a "spite" against Kitchen and just as many men are voting for Kitchen because they have a "spite" against Simmons.

Since the beginning of this fight the politicians supporting both Kitchen and Simmons have purposely nourished and cultivated every source of hard feelings because they know from experience that when you get bitterness into a man's soul, he does not stop to think and can be led to the polls and made to vote against the interests of himself his home and his family.

They know that if the people ever stop and think for themselves and take a look at the platform upon which Walter Clark is running, he will be nominated by an overwhelming vote.

Every man in North Carolina knows absolutely where Judge Clark stands on every important issue and how he will vote on every clash between the interests of the people and the interests of the trusts.

Send Walter Clark to the Senate and he will go after the 35 per cent duty on the chairs and beds and tables which the poor man has to buy, even if he has to neglect those railroad ties and telegraph poles.

This is straight talk but if you will get away from the harangue of the politicians and the newspapers and think for yourself, you will know that it is the truth.

Editor Bivens of The Wadesboro Ansonian suggestively remarks that North Carolina gives \$344,000 to three of the higher educational institutions of the state, the benefits of which are enjoyed by less than 3,000 students, most of whom are able to help themselves. To the public schools of the state in which there is an army of more than 500,000 boys and girls, only \$275,000 is given. It looks like helping the strong and neglecting the weak. Is it right?—Charlotte Chronicle.

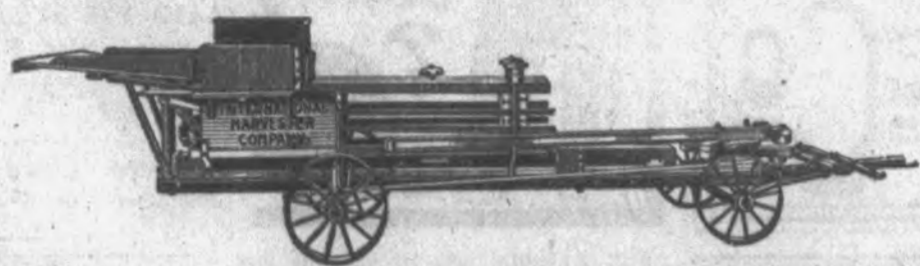
