TURKS RETREAT AS ENEMY ADVANCE

Big Battles Are Expected to Begin Within a Few Days

BOMBARD BULGARIAN FORT

Montenegrins Lose Six Officers and Fifteen Men in Sharp Fighting in District of Grevitza and Ogra-Kimineh

LONDON, Oct. 21.—Three and perhaps four big battles will begin within a few days if not a few hours on the territory of Europe and Turkey. The armies of the Balkan allies have now crossed the frontier on all sides while the Turks, as their opponents advance, are giving up their frontier posts and abandoning small and unimportant towns, falling back slowly on to their strongly entrenched positions, preparatory to giving battle there.

The Bulgarian army will, it is thought, probably be the first to strike at their objective point, the fortress of Adrianople. The main Turkish army is rapidly growing in strength and with time will outnumber that of the invaders.

The Servian armies have made some progress in their advance toward Prishtina and Uskup. They have taken a few more small villages with but little opposition. The Servian army operating in the district of Novipazar also reports some progress.

On the other side of Novipazar, near the Montenegrin frontier, both the Turks and the Montenegrins claim successes in slight skirmishes. The Montenegrins, however, have advanced no farther.

The Greek army is resting after its capture of the Turkish town of Elasona and preparing for the more strenuous task of attacking the Turkish army of forty thousand men concentrated at the town of Servia, a little to the north.

The Greeks are said to be 60,000 strong.

The grimmest fighting of the war is likely to occur out of sight of the armies as some 4,000 Albanians are arming and Greek and Bulgarian bands have taken to the hills, where they will engage in guerrilla warfare.

The navies of Greece and Turkey appear thus far to have contended themselves with blockading operations.

Turkish Success Reported

Constantinople, Oct. 21.—Several Turkish successes on the eastern frontier of Montenegro are reported in dispatches from Saloniki.

Sharp fighting occurred in the districts of Grevitza and Ogra-Kimineh, where the Montenegrins retreated with a loss of six officers and fifteen men killed. The Turkish casualties totaled two killed. They captured some ammunition and tents from the Montenegrins.

Turks Bombard Bulgaria

Sofia, Oct. 21.—Turkish warships today bombarded the Bulgarian fort of Kavarna. The customs house was destroyed and several shops and dwellings were damaged.

Kavarna is a Bulgarian town on the Black Sea, 28 miles northeast of Varna.

Postal Clerks C. H. Hughes, G. P. Shuler and A. D. Shuler were injured but not seriously.

None of the passenger coaches were derailed.

LEAVES FOR HOME AT OYSTER BAY

Roosevelt's Condition Very Gratifying to Physicians

WALKED OUTTO AMBULANCE

His Last Night at Hospital a Restless One, Which Was Due to Thoughts of His Coming Departure

FORT WAYNE, Ind., Oct. 21.—The following bulletin was issued at noon by Colonel Roosevelt's physicians: "Colonel Roosevelt is resting well and very comfortable."

Dr. Lambert said the patients condition was so favorable that it was deemed unnecessary to take a record of his temperature, pulse and respiration.

Dr. Lambert said: "There has been some further bleeding of the wound today but only the normal draining which shows that the wound is healing as we hoped it would."

At several Indiana towns there were crowds at the station but respecting the wish of the physicians before they left Chicago, that their patient be allowed to make his journey as quietly as possible they stood silently by without the cheers which the colonel is accustomed to hear.

Chicago, Oct. 21.—Colonel Theodore Roosevelt, Progressive nominee for president who was shot in Milwaukee by John Schrank and brought to Mercy Hospital here, left for his home at Oyster Bay, New York, this morning.

Preparations for Col. Roosevelt's departure from Mercy Hospital were completed early and he was placed in an ambulance at 7:15 for the drive through the city.

His train left the station at 8:08 o'clock. The Colonel's last night at the hospital was rather a restless one. He slept only about four hours in the aggregate from the time he first fell asleep at 11:15 p. m.

He awoke frequently and he seemed nervous. It was said by night nurse Fitzgerald that this was chiefly due to the excitement of his coming departure and not to any untoward symptoms that had developed in the course of the night.

Connecticut Field Trials

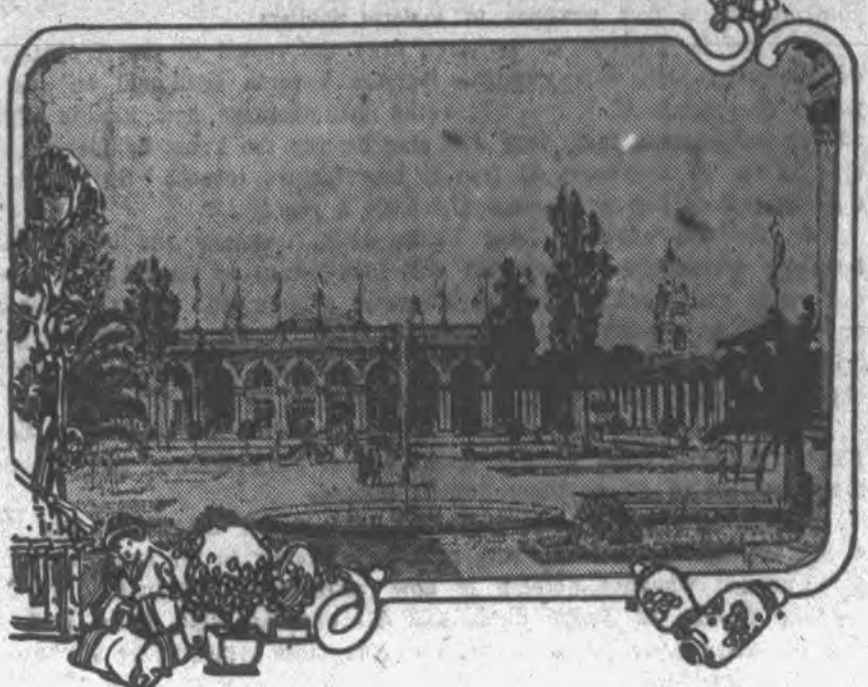

BERLIN, Oct. 22.—A flood of felicitous messages from all parts of the empire, together with many valuable presents from relatives and initiative friends, were received by the Empress Victoria Augusta today, on the occasion of her fifty-fourth birthday anniversary. The principal feature of the birthday celebration was a dinner at the palace, followed by a gala concert in which Caruso and other famous singers took part. The health of the Empress, which some time ago was a cause of considerable anxiety, is now reported to be much improved.



SERVICE BUILDING, FIRST STRUCTURE TO BE ERECTED BY THE PANAMA-PACIFIC INTERNATIONAL EXPOSITION.

BIDS have been let for the Service Building, the first structure to be erected upon the Panama-Pacific International Exposition site. The structure will be three stories in height and will be occupied by the exposition force during the building of the great fair. It will be 150 feet square with an interior court of 58 by 104 feet. The surrounding grounds will be picturesque with flowers, fountains and statuary. The first floor will be occupied by the auditor, treasurer, railroad exhibits, admissions and concessions, police, information, telegraph and emergency hospital departments; the second floor will be occupied by the architectural, mechanical, electrical and civic engineering departments; the third floor will be used for blue printing, photograph and color studios. It is expected that the building will be completed by the first of the year.

South Carolina Pastor Is Accused of Grave Charge

Former Superintendent of Odd Fellows' Orphanage Indicted For Assaulting Three Girls

WILL RECEIVE SPEEDY TRIAL

GREENVILLE, S. C., Oct. 21.—Rev. Thurston U. Vaughan, former superintendent of the South Carolina Odd Fellows' Home and a member of a prominent family, was today indicted on the charge of assault by a grand jury, upon three girls of the institution and performing an illegal operation on one last May.

Governor Blease had appointed a special judge and ordered a special term of the Court of General Sessions and no time was lost on the setting of the trial. The jury panels had been summoned, but it is said other ventremen will be necessary before a jury is obtained.

Seeks to Secure Release of Girl in Johnson Case

CHICAGO, Oct. 21.—Robert E. Cantwell, an attorney, today asked United States District Judge Carpenter for a writ of habeas corpus for Lucile Cameron, the Minneapolis girl, whose name has been connected with that of Jack Johnson, the negro pugilist and who is being held in the Rockford, Ill., jail in default of \$25,000 bond as a witness before the federal grand jury.

Judge Carpenter said he would be unable to hear the petition until tomorrow. Inasmuch as the girl is to appear before the grand jury tomorrow, Attorney Cantwell withdrew his petition.

He would not say whether he had been retained by Johnson, who is under charges of abducting the girl.

Federal investigation against Johnson moved swiftly today. Twenty-five subpoenas were served on the pugilist's associates ordering them to appear before the federal jury tomorrow. The government seeks to show that Johnson violated the Mann white slave act.

Prosecution also was started against Johnson for alleged violation of the one o'clock saloon closing act. This case was set for hearing October 29.

SCHRANK FAMILY ACTED INSANELY

Records of Three Generations Back Proves Same

JOHN ALWAYS "LITTLE OFF"

Insanity of Assailant of Colonel Roosevelt Traced as Far as His Grandfather's Days. His Father Afflicted Likewise

NEW YORK, Oct. 21.—That for three generations there has been insanity in the family of John Schrank, assailant of Colonel Roosevelt, was the statement today of persons who have known him all his life.

The grandfather of the attempted murderer was a rich Bavarian brewer who had to be guarded closely during the last few years of his life. The same unsoundness cropped out in Schrank's father and Schrank himself has always been taciturn and moody, spending much of his time broodings.

John Schrank was brought to this country by his uncle and aunt, Dominick and Anna Flammang, 29 years ago. Flammang opened a saloon at 370 East Tenth street and the boy was known to his schoolmates as John Flammang. When 15 years old he went behind the bar and in 1902 the uncle gave the place to his nephew.

There was surprise when the name John Schrank, instead of John Flammang, was put up by the new proprietor, but he explained that this was his own name.

Thomas Harris, president of the Liquor Dealer's Association, said that Schrank was a member of the organization and was always considered to be a little bit "off in his head." Schrank's aunt, Anna Flammang, died in 1907 and Schrank was so overcome with grief that fears were entertained for his sanity.

In 1911 Schrank's uncle, Dominick, died, leaving everything to him. It is believed he inherited about \$25,000.

Last year Schrank met financial reverses and got a job in the saloon of Edward Haberstro, in Brooklyn, was discharged and brought suit for \$11 wages. The suit was decided against him and he threatened the life of the judge.

ONE KILLED AND TWO WOUNDED IN FIGHT

Friends Make Futile Efforts to Rescue a Prisoner From Posse

LEXINGTON, Ky., Oct. 21.—A special from Somerset today says that Arthur Phelps was killed and two other men whose names have not been learned were wounded in a battle fought yesterday between the friends of James Phelps and a posse of officers who had arrested James Phelps on the charge of murdering Riley Price.

Hope to Induce Woodrow Wilson to Make More Addresses

NEW YORK, Oct. 21.—Governor Wilson's determination to make no more political speeches unless Colonel Roosevelt against takes the stump, is not accepted as final by Democratic national managers.

The fact that Madison Square Garden has been rented for the night of October 31 is being urged upon the governor as a reason why he should yield to the demands of his managers and speak in New York on that date.

Chairman McCombs of the National Committee, hopes to induce the candidate also to speak in Philadelphia October 26. Governor Wilson has agreed to send out a "message" to be read throughout the country November 2nd, on "Wilson-Marshall Day," but had not consented as yet to the plans for his personal appearance again on the stump.

BALLOON EXPLODES; AERONAUTS KILLED

German Airmen Meet Death in Attempt to Smash Record

OVER 15,000 FEET IN AIR

Gas Bag Explodes Which Was Probably Struck by Lightning. When But a Mile Away Became Unmanageable

BERLIN, Oct. 21.—The announcement of the death yesterday of Lieut. Hans Gericke, winner of last year's international balloon race in the United States and head of the team of German defenders in the races to be held from Stuttgart next Saturday, created a profound sensation here today.

He was thrown from his balloon at a height of three miles by the explosion of the gas bag which is believed to have been struck by lightning.

His aide, Lieut. Steeler, was also killed.

Gericke and Steeler were making a trial flight to test the new balloon which they expected to use in the international races. Just above the town of Grossenhain they met a thunderstorm which they attempted to avoid by rising above the disturbance. When a mile in the air their craft was caught in an eddy and became unmanageable.

After a terrific plunge straight upward the bag burst with a loud explosion. Both men dropped three miles to the ground and were dead when picked up.

The shattered instruments they carried on the flight were examined today. The recording apparatus showed that they were riding at a height of 6,000 feet when they were suddenly hit by a vertical gust of wind which pushed them up with the violence of a hurricane to a height of 15,000 feet.

At this altitude the bag burst, either from the sudden change in pressure or, as is more likely, from being struck by a lightning bolt.

The balloon embodied all the latest ideas in gas bag construction and was regarded throughout Germany as the likely winner of the international cup in next Saturday's contest.

Gericke and Steeler had expected to try for an altitude record in the course of yesterday's flight and had equipped their car with oxygen tanks and apparatus to assist them in enduring the rarified atmosphere of the high altitudes.

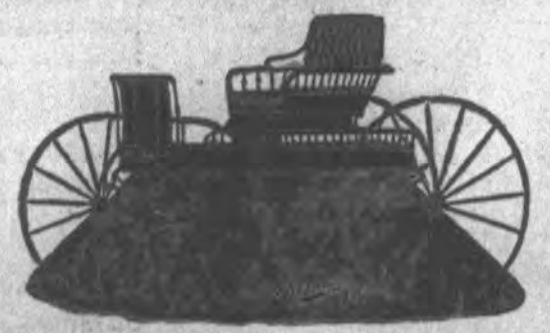

THIRD TERM QUACK PLANK

Fraudulent "Blanket Policy" Offered for Protection of Health and Life.

IN INTEREST OF FAKERS

"Theodore Rex" Promises to Shield Them Against Discrimination by Educated Physicians.

The political tentacles of the third term candidate have been extended in every direction from which might be gathered voters irrespective of sex, race, color or previous condition, of all vocations, factions and trades into the Progressive fold. By specious promises cunningly adapted to each the colonel beckons them to follow with bleating approval wheresoever his bellwether adjutants may lead in order that Theodore Rex may again sit in the White House.

Tempting bait is thrown to the working people in the minimum wage, to the Socialists in the enlargement of government ownership, to the women in the furtherance of suffrage aspirations, to the farmer in blissful betterment of rural life, etc. Now he appeals to the quacks, those true and hitherto despised men of predatory wealth, offering them tenderest regard and freedom from prejudice "for or against." The following "blanket policy" is offered for protection of our most precious possessions—health and life:

"We favor the union of all the existing agencies for fundamental government dealing with the public health into a single national health service without discrimination against or for any one set of therapeutic methods, school of medicine or school of healing, with such additional powers as may be necessary to enable it to perform efficiently such duties in the protection of the public from preventable diseases as may be properly undertaken by the fundamental authorities, including the execution of existing laws regarding pure food, quarantine and cognate subjects, the promotion of appropriate action for the improvement of vital statistics, the extension of the registration area of such statistics and co-operation with the health activities of the various states and cities of the nation."

Thus would votes for Theodore Rex be multiplied.

Insults Educated Physician.

This quack plank of the Progressive platform not only insults the intelligent voter, but wounds the educated physician, in that it places the latter in the same category with empirics of high and low degree, rubbers, sun curists, magnetic and other healers and all other pretenders who fatten upon the credulity of the helpless sick and their terrified relatives. The Sun has adverted to the outrageous violation of propriety and justice which characterizes the medical laws of several states in the Union, the last instance of which we deplore in the medical regulations of the canal zone and which the bull moose platform threatens to inflict upon all the states of the Union.

These legislative enactments require all persons who propose to become physicians not only to pursue a more or less thorough course of preparatory education, but also to be trained in all

branches of medicine and, besides, to be subject to a rigid examination by appointees of the state. All these serve to protect the public against ignorant pretenders and would be perfectly fair did not the very same enactments exempt the latter from the provisions applying to educated practitioners.

Favors for Cormorants.

Thus do our sagacious legislators stultify themselves in the interest of the cormorants to whom they grant special privileges, because, forsooth, they claim to "heal" without medicines! There is now no discrimination against "schools of medicine." Therefore the special protection demanded for them by the bull moose platform is gratuitous and intended only to entrap votes. The "healers" belong to no school. Now comes Theodore Rex and dignifies them by a special provision and, expressing a most tender regard for their sensibilities, promises to shield them against discrimination by educated physicians.

This platform would raise the quack and healer above the men who daily exemplify their personal and professional superiority by some unselfish devotion to the public weal. In his eagerness to placate the influential hord of empirics Mr. Roosevelt would have us oblivious of the fact that the educated physician is the only real altruist in the community. Instead of arousing the public conscience (T. R.'s favorite slogan) this self appointed reformer deepens the crying shame and thus exemplifies again that "under no circumstances" need he be bound by his prior professions.

President Taft has won the approval of the quacks and healers by his medical regulations of the canal zone; hence this Machiavellian policy. Future generations will substitute "Rooseveltian" for "Machiavellian." Politics make strange bedfellows indeed. Behold Taft and Roosevelt under the same blanket!—New York Sun.
