SERVIAN ARMY ON TO ADRIANOPOLIS

A Great Victory for Servians is Reported
MAKE OVER 5,000 PRISONERS

Turkish Town of Servia Is the Centre of the First Big Battle Against the Terrible Musulmen

LONDON, Oct. 24.—The Turkish fortress of Kirk-Killiseh has fallen, according to a news agency dispatch from Sofia. It is regarded as the key to Adrianople and is the headquarters of the Turkish Third Army Corps, commanded by Kenaan Pacha.

Seventy Christians Are Slain

Washington, Oct. 24.—Seventy Christians and a priest were massacred by the Turks before their retreat from Servia yesterday according to an official cable from the Greek foreign office to the legation here today.

Among the prisoners taken was one Turkish colonel.

"The fourth division of the Greek army," the dispatch states, "occupied last night the town of Servia and the only bridge over the Aliakmen river by which the army could pass to Kazna. The 5th Div. with cavalry occupies the heights along the river. All the Turkish troops have retreated along the right banks of the river. In Spirus, the Greek army has occupied Calafia and the pass and village of Countsades. The Greek army is in pursuit of the Turkish army through all the mountain passes of Camvouna and the valley of the Aliakmen. The Turkish army is quite routed."

Turks Rout Servians

Constantinople, October 24.—The Servian army operating near Kumanova has been defeated by the Turkish troops defending that town and which is on the way to Uskup.

The Servians suffered enormous losses, according to an official dispatch from the commander-in-chief of the Turkish western army.

The Turkish troops are pursuing them energetically.

The Servian army is believed to have comprised four strong divisions.

Servians Take Part of Turkish Town.

Belgrade, Servia, Oct. 24.—The Servian troops have occupied one part of the Turkish town of Kumanova, according to a telephone message received here today from Vranja. The Turkish artillery used against the advancing Servians had very little effect and after a short time was silenced by the Servian guns.

Desperate fighting is still going on in the vicinity of Kumanova.

The taking of the Turkish town of Novipazar was achieved only after three days of severe fighting, during which there was much slaughter both among the Servians and the Turks.

The small town of Strazin, between Egri-Palanka and Kamanova, was captured yesterday by the Servians.

Rain Impeded Operations

Rieka, Montenegro, Oct. 24.—The Montenegrin troops advancing in a southeasterly direction, reached a point about eight and one-half miles from the Turkish town of Scutari yesterday afternoon. Military operations have been greatly impeded by rain in the last two days.

King Nicholas, whose headquarters had been located here, provisionally crossed Lake Scutari yesterday and joined the troops at the Mallasori village of Skia, where he met his three sons and with them held a council of war. The outcome of this was that Prince Mirsky was appointed commander of the Montenegrin brigade which distinguished itself at Ditchitch and Tushli.

No News of Great Battle

LONDON, Oct. 24.—While the Balkan nations and Turkey are all generous with official statements as to the progress of the war in other parts of European Turkey, they maintain complete silence in regard to the great battle which has been raging for the last two days between Adrianople and Kirk-Killiseh, for news of which all the world is waiting.

QUESTION UP AGAINST "WHO IS A DEMOCRAT?"

COMMITTEE IN SESSION OFFERS AND REJECTS MAY SUBSTITUTES, AGREES TO DISAGREE

WEBB'S RESOLUTION TURNED DOWN

RALEIGH, Oct. 24.—For the third time in six months the state Democratic executive committee found itself at odds over the matter of prescribing rules governing voting in the senatorial primary. In spite of the efforts of Chairman Webb to secure a resolution satisfactory to the senatorial candidates, the committeemen were as much divided as at the March meeting. The Webb resolution, which was presented by R.H. Hayes, follows:

The resolution adopted at the last meeting of the Democratic states executive committee known as the "Hackett resolution," is hereby repealed and the following is adopted in lieu thereof:

1. That the "Democratic ticket" as used in the fourth and tenth rules governing the senatorial, congressional, state, legislative, county and township tickets.

2. That any elector shall be constructed to have sufficiently complied with said rules who shall vote the Democratic presidential, congressional and legislative tickets in full, and at least three-fourths of the Democratic state ticket, one of whom shall be the governor, and at least three-fourths of the county and township tickets; provided, however, that such elector shall not have voted for any candidate running on any ticket in opposition to the regular Democratic nominees.

A substitute introduced by L. S. Smith attempted, as he stated, to appease the objection to the Hackett resolution. It was as follows:

The resolution which was revoked. The Smith substitute provided that an elector should vote for the national, state, congressional, legislative, county and township tickets and that no elector who may fail to vote for every name on the ticket shall thereby be disqualified from voting in the senatorial primary. The elector must not vote for the opposition ticket. Objection was offered to this substitute on the ground that it was not definite enough, that an elector might vote for a congressman and coroner and then vote for senator.

R. N. Hackett's substitute for the Smith substitute that the committee leave the matter where the state convention placed it, was overwhelmingly voted down.

"Twenty-Four Hour a Day" Bankers Get Prison Term

MEMPHIS, Tenn., Oct. 23.—Five bankers who have been on trial here, charged with conspiracy to defraud, were found guilty today by a federal grand jury.

W. C. White, a former director of the All Night and Day bank of Memphis and the Union Trust Company, of Hot Springs, also named in the indictment was acquitted.

Those convicted, but whose sentences were deferred were:

E. L. Hendrey, former president of the Memphis All Night and Day bank.

H. C. Wynne, former president of the Little Rock, Ark., All Night and Day bank.

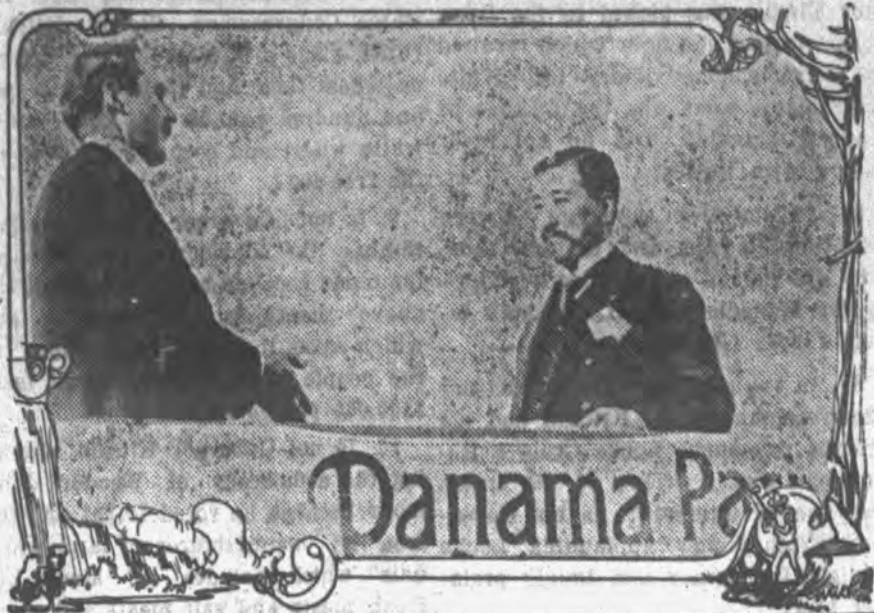
Abner Davis, former president of the All Night and Day bank of Oklahoma City.

C. A. Bonds, former president of the Kansas City All Night and Day bank.

J. H. Brooks, former director of the Memphis bank and head of a local lumber company.

The government charged that the defendants by an unlawful exchange of securities were able to pass clearing house examinations and that the funds of the institutions were used in an illegal manner.

A run on the Memphis bank about a year ago led to disclosures which ultimately involved like institutions in Oklahoma City and other cities. The indictment of a number of officers connected with each followed.

Counsel For Furniture Men Present Strong Case For Clients

RATE DISCRIMINATION TRIAL IS WELL PRESENTED IN WASHINGTON TO SHOW THAT TARIFF SHIPPERS ARE NOT BEING TREATED FAIRLY BY THE RAILROADS.

TOBACCO RESPECTED BY ROADS

WASHINGTON, D. C., Oct. 24.—Declaring that the rate of \$1.70 on furniture and \$1.75 on chairs from North Carolina territory to the Pacific coast was unreasonable, unjust, and a violation of the fourth section, E. J. Justice of Greensboro and R. H. McNeill, a former North Carolinian, but now residing in Washington, on behalf of the Southern Furniture Manufacturers' Association, today asked the interstate commerce commission to reduce the rate on furniture from North Carolina points to the Pacific coast to \$1.50 per hundred pounds the rate now applying on furniture from Virginia cities to the Pacific coast. Mr. Justice made an urgent appeal to the commission. He was frequently interrupted by members of the commission who asked questions in regard to the enormous furniture business of North Carolina.

Mr. Justice began his argument by stating that North Carolina by reason of its fine timber was manufacturing more furniture than any other state in the union. He said the discrimination against North Carolina in favor of Virginia cities, was killing the Pacific coast trade. He said the difference in the freight rate from North Carolina to the Pacific coast and that allowed on similar shipments from Virginia amounted to \$40 on furniture and \$50 per car on chairs.

"With a difference in freight rates of such a large amount the commission can readily see that the furniture men of North Carolina cannot long hold the trade on the Pacific coast with Virginia as a competitor when our sister state can put the furniture in the customer's hands at from \$40 to \$50 less per car," said Mr. Justice. "Much of this freight is hauled directly through High Point and other furniture towns of my state. Yet, notwithstanding this fact and the further reason that we are from a 100 to 200 miles nearer the Pacific coast than any of the Virginia cities, we must pay the railroad companies \$50 more per car in freight rates."

Man Tires of Daily Hash, Beats Wife, and Goes to Prison

CHICAGO, Oct. 24.—That he may for a time escape the hash which he says his wife serves him so frequently, William Williams, 35 years old, today accepted a sentence in the Bridwell for beating his spouse. Williams had been arrested on complaint of his wife.

Mrs. Williams told the court that her husband came home last evening and objected to the hash she had ready, saying he wanted stew.

"I told him to eat what was set before him," she continued, "and not make any remarks.

He got angry and beat me. Then he threw a chair about the room and broke forty jars of preserves I had just put up and smashed things up generally."

Williams said he was sorry and asked to be sent to the Bridwell. As he was leaving the courtroom he asked the judge:

"Do they serve hash at the Bridwell?"

"I don't know; I guess not," replied the judge.

"Then jail for me," said Williams.

Supreme Court in Raleigh Hands Down Some Decisions

RALEIGH, Oct. 23.—That a change in the interest and title of the insured forfeits the policy was the ruling of the supreme court in the case of J. A. Watson and L. D. Ivey against the North Carolina Home Insurance Company, the case coming up on appeal from Cumberland county. This makes the second time the case has been in the supreme court, the first time the court being divided, Justice Hoke not sitting and the judgment of the lower court was affirmed. On the rehearing the court reversed itself and held that the plaintiffs could not recover.

ANCIENT HEN FOOD PLACED BEFORE COURT

TWO YEAR OLD HEN PRODUCTS IN TIN WRAPPERS OCCUPY THE ATTENTION OF THE COURT

443 CANS OF FROZEN EGGS DISCUSSED

WASHINGTON, Oct. 24.—Four hundred and forty three cans of frozen eggs of the vintage of 1910 occupied the attention today of the supreme court of the United States. The members of that tribunal were engaged in determining whether the eggs were decomposed.

Ralph S. Rounds, attorney for the claimant of the eggs argued that the eggs were not "decomposed" within the meaning of the pure food law and told the court that the case was the most important of all five pure food cases which had come before it for consideration, because it would decide whether the pure food law was to be interpreted according to the view of the "young men in the department of agriculture or according to common sense."

He said that the common sense way of interpreting the law was to give the word "decomposed" the meaning of "unwholesomely decomposed," and not make the decomposition depend upon the number of bacillus coli that could be found in an egg.

Members of the court manifested an interest in the rudimentary facts about eggs in addition to the questions of law.

Mr. Rounds informed the court that there were four grades of eggs, "current use," "seconds," and "spots." "Do you mean to say that there are four grades of strictly fresh eggs?" inquired Justice Holmes. His confidence in eggs was restored by a negative answer. The attorney explained that the government had first charged that the product was "filthy, decomposed or putrid, but now only claimed that it was decomposed."

"You say that is all that is charged?" asked Justice Vandeventer, with a decided emphasis on the "all."

The court will continue its study of the egg tomorrow.

Drummers and Public Want Union Depot, Can't Get It

WILSON, Oct. 24.—Notwithstanding the fact that more than six hundred citizens of this city and a great number of drummers, who pass this way, have petitioned the Corporation Commission for a union passenger station here for the Norfolk Southern and the Atlantic Coast Line Railroads that august body, by a vote of two to one, have denied the petition of the citizens and the traveling public and the same state of affairs as heretofore will exist—running from one depot to another to get "left" by trains you wish to "catch." The commission claims that it would be unjust to compel the Norfolk Southern to join with the A. C. L. owing to the fact that they now have an up to date depot.

"Andy" Carnegie Makes a Gift for the School for Feeble Minded

KINSTON, Oct. 24.—Dr. Ira M. Hardy, superintendent of the state school for the feeble-minded, located near this city, has been notified of an appropriation by the Carnegie institute at Washington, of \$500 for the employment of a field agent of the school. The sum is to cover the pay expenses of a field worker for six months and is expected to be followed by similar appropriations semi-annually.

VERDICT OF FIRST DEGREE MURDER

Jury Returns at Midnight in The Becker Case

GOFF SPOKE FOR THREE HOURS

Judge Goff Tells The Jury That Conviction Hangs on Question of Schepp's Complicity

NEW YORK, Oct. 25.—At midnight the jury found Lieutenant Becker guilty of murder in the first degree.

NEW YORK, Oct. 24.—Justice Goff charged the jury in the Becker case today in a speech lasting more than three hours, ruling that the conviction or acquittal of the police lieutenant for the murder of Herman Rosenthal rested almost solely upon the question of whether Sam Schepps was or was not an accomplice. He was in doubt, himself on this point, he said and therefore declined to instruct the jury.

He ruled that Rose, Webber and Vallon were accomplices and that upon their testimony Becker could not be convicted of murder in the first degree even though the evidence showed that he had instigated the murder.

Justice Goff concluded his charge at 1:50 o'clock, but John F. McIntyre, chief counsel for Becker, spent a half hour in entering objections to the rulings of the court.

"It is for you to determine whether Sam Schepps was an accomplice," charged Justice Goff. "You cannot convict on the uncorroborated stories of Rose, Webber and Vallon.

As to whether Sam Schepps was an accomplice the justice refused to charge, saying that "while a suspicion exists that he was, I must say I have a doubt in my own mind."

If Schepps testimony were true, there was no reason, explained the justice why the testimony of the three informers should not be believed.

The court's interpretation of the testimony occupied three hours and ten minutes and during it all Becker sat with solid countenance.

Mr. McIntyre, in entering his exceptions to the charge asked the court to instruct against a compromise verdict.

The court granted his request and told the jury not to return a verdict of manslaughter.

Becker sat unmoved while the charge was delivered. Justice Goff finished his charge at 1:66 and the jury retired.

Becker is hopeful of acquittal but throughout the eight hour ordeal of stammering up yesterday he said nothing and gave no indication of his emotions.

Mrs. Becker, wife of the defendant, was one of the first to enter the courtroom when today's session opened.

A quarter of an hour before court convened today the jurors filed into the courtroom.

District Attorney Whitman entered the courtroom a few minutes later and took his seat within the railing. The witnesses were placed within the row in front of the spectator's seats. A little later Becker entered the room smiling. John F. McIntyre and John H. Hart, Becker's lawyers, laughed and talked with him at their table.

Justice Goff entered from a side door at 10:35 o'clock and five minutes later began his charge to the jury. He spoke almost in a whisper and the jurors leaned forward in their seats to hear him. Becker strained forward as if to catch every word.

After instructing the jury that the defendant must be presumed innocent until it was proven beyond a reasonable doubt that he was guilty, Justice Goff defined the different degrees of murder.

"The killing of a human being," he said, "can be considered as murder, manslaughter and excusable homicide. There can be no verdict of excusable homicide and I will not consider that phase.

"This man's case rests solely with you. But in making your decision you must be guided entirely by the evidence and not by remarks of counsel."

Justice Goff warned the jury not to consider questions of counsel to which witnesses were not permitted to reply.

Ninety-One Per Cent of Pharmacal Applicants Refused License

Out of the thirty-three young men who took the examination Tuesday for license as registered pharmacists, only three succeeded. This means that thirty men supposed to be especially trained for this work failed to meet the requirements of the State Board of Pharmacy. The three men who got their certificates were John Walter Wilson, of Norfolk; E. C. Williams, of Catawba, Va., and J. Key Brown, of Greenville, N. C.

Some of the applicants for the grade of registered pharmacist made a part of the examination and are permitted license as registered assistant pharmacists. Eleven tried for the assistants' grade and those of the eleven who succeeded to and those of thirty who made part of the full examination are licensed as assistants, as follows: J. J. Blanks, Richmond; W. K. Henderson, Norfolk; E. B. Davis, Ebensburg, Pa.; G. R. Thomas (colored), Annapolis, Md.; W. E. Perce, Tazewell, Pa.; Andrew Daniel Parson, Stony Creek, Va.; Andrew T. Oran, Gladys, Va.; Norvell Tallaferro, Uulaine, Va.; B. F. Foley, Jr., Richmond; Leonard P. King, Norfolk.

WHAT ARCHIBALD JOHNSON THOUGHT OF GOVERNOR KITCHIN'S SPEECH

Governor Kitchin made a speech in Thomasville a week ago yesterday on his way through the county, and Mr. Archibald Johnson, editor of Charity and Children, published at the Baptist orphanage at Thomasville commented on it through the columns of The Thomasville Davidsonian last week. Mr. Johnson was not pleased. He says:

"An audience of men that filled the hall, with perhaps a dozen ladies, gathered on Tuesday evening last to hear Governor Kitchin speak.

"It was a cold crowd for a campaign orator. The usual enthusiasm and spirit of such occasions were painfully absent. It was a melancholy meeting. The most pronounced applause was given when the governor held up the lumber journal and showed the picture of Senator Simmons on the cover; and a Simmons man started the cheering and the others joined in.

"The governor realized at the outset that he was facing an audience the majority of whom were favorable to Senator Simmons; if they were Kitchin men they were suffering with cold feet.

"The speech was a strong deliverance and the boldness and courage of the speaker as he hurled his anathemas at Simmons in the face of the friends of the senator, was altogether admirable. With the exception of the first ten minutes, in which the speaker eulogized Woodrow Wilson and Locke Craig, the whole speech was a bitter and relentless tirade against the man who for twenty-seven years has been a recognized leader in the public life of North Carolina and a fulsome and disgusting tribute to the fidelity, ability and honesty of William W. Kitchin.

"The warm eulogy of the governor as to the purity of motive of his blameless life, if it had come from another, would have been beautiful; but coming from the lips of the man himself, it was slightly out of taste. One could be reminded of the Pharisee who went up into the temple to pray and who thanked the Lord that he was virtuous, honorable, truthful, saintly and pure and not like the poor publican by his side who would not so much as lift his eyes to heaven.

"The whole trend of the speech was destructive. It was an attempt to ree upon the ruin he had wrought. While there was nothing in what he said that could be fairly construed as personal abuse, the culmination and conclusion of it all in the mind of the hearer who did not stop to think it over, was that no traitor more designing ever lived in the United States than F. M. Simmons.

"The speech was not a vote-getter—it was exactly the opposite. Mr. Kitchin, we dare say, is not so strong in Thomasville as he was before he delivered his speech. The policy he is pursuing cannot win out. If Governor Kitchin is nominated to the senate it will be in spite of the speeches he is making in this campaign.

"The governor boasted that his white banner had never trailed in the dust and all through the speech such bombast as this weakened all he said. It was a strange mixture of bitter, unrelenting hatred toward his opponent and of adulation of himself. To hear him tell it, for the past quarter of a century William W. Kitchin has been the axletree of the country bearing on his broad shoulders the burden of the government. We are not in this article making any prediction as to the outcome of the senatorial struggle; we are simply giving our readers our opinion of Governor Kitchin's speech and the spirit that promoted it, and we do not hesitate to say that we were surprised and disappointed at its matter as well as at its tone. It was not the appeal of a statesman, but the special pleading of a selfish and ambitious politician."

The Congressman Pays Tribute to North Carolina's Senior Senator and Takes a Whack at Free Trade

(Letter October 17, from Congressman H. L. Goodwin to George L. Fisher, a prominent farmer of Maxton and ex-member of the Legislature from Robeson county.)

Answering your questions in reference to Senator Simmons, I will say that I am convinced that Senator Simmons has made a loyal and faithful Senator during his service in the Senate. I feel that he has voted on all measures coming before the Senate, in the interest of the laborers, farmers, producers and consumers, of his state, and at the same time having at heart the best interest of the general industrial and commercial development of North Carolina. I have been closely in touch with the Senator in reference to many matters of legislation, in which our district has been much interested and I have anxious to do what he could to help always found him conscientious and build up our district and state. I have no patience, whatever, with the charge that he is not a Democrat. While he voted, when the tariff bills were being considered, for a revenue duty on many articles which in every instance was consistent with the true principles of the Democratic party, I have no idea that he ever gave a vote which could be construed to amount to a protective or Republican duty on any article. There is no free trade party in the United States. The Democratic party believes in a tariff for revenue only, and a Senator or Member of the House is sworn before he takes his seat to support the Constitution of the United States. This Constitution provides for raising revenue by a tariff on imported articles and the Democratic party has always stood for a tariff high enough to raise money to run the Government and it is the sacred duty of a Democrat to vote for a revenue producing tariff, and as long as he stays within the bounds of a Democratic tariff he should not be criticized by members of his own party.
