GOV. WILSON WILL RESUME CAMPAIGN

Says Roosevelt's Recovery Seems a Certainty

TO END CAMPAIGN IN N. Y.

Will Make Two Addresses in Philadelphia Monday, One to an Independent Republican Organization

PRINCETON, N. C., Oct. 25.—Governor Woodrow Wilson will resume his speaking campaign which was interrupted when Colonel Roosevelt was shot.

The governor said today that the Colonel's recovery seemed so certain that he was now arranging dates for the remainder of the campaign.

Governor Wilson will make two addresses in Philadelphia Monday, October 28, one arranged by an independent Republican organization of Wilson supporters at the Academy of Music, and the other at a Democratic rally at Convention Hall.

Tuesday and Wednesday of next week the governor said he expected to spend in campaigning through New Jersey in the hope that both houses of the legislature would be Democratic so as to assure the election of William Hughes, who was chosen in the Democratic primaries recently for United States senator.

The governor will speak Thursday, October 31st, at Madison Square Garden, New York, and probably will end his campaign with a trip into New York state. However plans are as yet indefinite in this connection.

The nominee had not expected to go back into the campaign so soon, but the engagements for him to speak in Philadelphia at the Academy of Music was made over two months ago, he said, and he had pledged himself at that time to speak.

An honorable escape, he said seemed impossible. Moreover, Colonel Roosevelt's strength returning so rapidly that he should be back in the campaign again next week. Of course if his health should go down again, I would have to cancel even the Philadelphia dates but the Colonel has such a superb physique that he will hardly have any ill effects now from his injury.

We Are a Little Disfigured But Still In The Ring

Mark Site of Washington's Camp NEWTON, N. J., Oct. 26.—A monument to mark the spot where Washington and his army encamped on the way from Newburg to Morristown in 1779 was unveiled today with interesting exercises. The monument was presented to the town of Newton by Marchioness Ellen Kays McLaughling of Brooklyn, whose grandfather, Lieut John Kays, was an officer in the Continental army.

HIX IS NOW HEAD OF THE NORFOLK SOUTHERN

VICE-PRESIDENT AND GENERAL MANAGER OF THE SEABOARD RESIGNS FROM THE LATTER ROAD

WILL ASSUME NEW DUTIES NOV. 1.

NORFOLK, Oct. 25.—C. H. Hix, first vice president and general manager of the Seaboard Air Line Railway, has accepted the presidency of the Norfolk Southern. He tendered his resignation as vice president of the Seaboard at a meeting held in New York yesterday when it was announced that he had been elected to the head of the Norfolk Southern. He will sever his connection with the Seaboard after service of twelve years on October 31st and will assume his duties of his new office on November 7. Mr. Hix says he will not displace any competent employees and that the men who attend properly to their duties will have nothing to fear.

Graves of the Titanic Victims Will Be Marked

HALIFAX, N. S., Oct. 25.—The graves of the victims of the Titanic disaster who were buried in Halifax cemetery are being individually marked.

Several memorial monuments have been contracted for by the White Star Line, owners of the Titanic and will be placed over the graves.

Halifax cemeteries contain the bodies of 150 Titanic victims. Most of them are men. Many remain unidentified, but there have been occasional identifications even within a few months and further identifications are considered likely.

There are 121 bodies in Fairview cemetery, 18 in Mount Olive cemetery and 10 in the Hebrew cemetery. The bodies were disposed of in this way as the religion of each was indicated by its effects.

The markers give the name of the identified victims and the date of the disaster. In the case of unidentified bodies the markers contain numbers.

Caruso's Cousin to Wed

PATTERSON, N. J., Oct. 26.—At one of the largest Italian weddings ever celebrated in this city Miss Mary Caruso, the tenor, will become the bride tomorrow of Francesco Sanclito, of Passaic. One thousand invitations have been issued for the wedding, which will take place at the home of the bride's father, Giuseppe Caruso, who is a brother of the father famous singer.

Athletics to Visit Cuba.

PHILADELPHIA, Oct. 26.—The Philadelphia team of the American baseball league, headed by Captain Murphy, leave today for a barnstorming tour of Cuba. The trip to the island to be made by the way of Key West, with exhibition games on the journey South at Greenville, S. C., Savannah and Jacksonville. The players expect to return home shortly after Thanksgiving Day.

TURKS 150,000 MEN STRONG

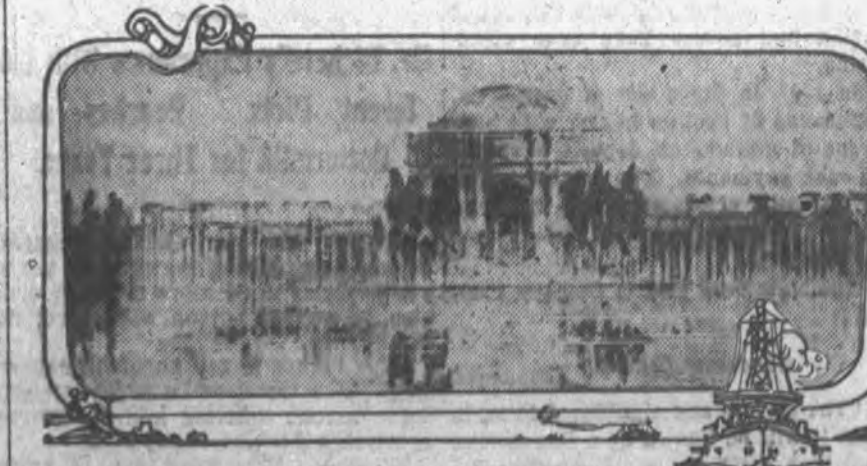
RIEKA, Oct. 25.—The Montenegrin army succeeded in surrounding the Turkish town of Scutario yesterday afternoon. The Montenegrin artillery opened fire on the town from the northwestern quarter, aiming at the citadel and the Mohammedan district without doing much damage.

The Montenegrin envoys proceeded toward the town to open negotiations for its surrender, but without effect. The Montenegrin infantry then made a desperate attack on the town, but encountering an annihilating fire from the Turkish artillery and finding themselves hard pressed and in danger they were compelled to return to their former positions.

They immediately began to make preparations for a renewal of the attack. This was made under cover of artillery fire.

A vigorous attack is to be made on the city from three sides. Crown Prince Danilo and his staff at one time were in great danger, a shell bursting a few yards from them.

The population of Scutari is in a state of panic and white flags are flying from a number of houses. At Tarakosch the Montenegrins occupied the highest point of the neighboring mountains and General Martinovich called upon the Turks to surrender and prevent useless bloodshed. The occupation of the town was effected by the bombardment of the fortress by all the Montenegrin guns. The Turks relied with 22 guns but

BULL MOOSE CHIEF IS NOW BACK ON HIS JOB

ROOSEVELT MAKES PREPARATIONS FOR HIS SPEECH NEXT WEEK IN NEW YORK

PHYSICALLY HE IS IN GOOD TRIM

NEW YORK, Oct. 25.—Colonel Roosevelt took up active work of his campaign today for the first time since he was shot eleven days ago.

John McGrath, his secretary, came from New York last night and as soon as Colonel Roosevelt had eaten his breakfast he began his work. He directed a number of letters to Progressive leaders then took up the preparation of the speech which he expects to deliver in New York in a few days.

Col. Roosevelt was in good trim physically, although he was still weak and was not able to do as much work as he wished. He has not overcome the effects of the nervous exhaustion from which he suffered after spending a week in bed in Chicago and finds himself greatly fatigued if he undertakes too much.

Dr. Scurry L. Terrell said that his patient was in surprisingly good condition and that he expected his strength to return rapidly.

Case of "Birds of a Feather Will Flock Together"

WASHINGTON, Oct. 25.—As one result of the local meeting of negroes which Jack Johnson was read out of his race, negro mothers have given prompt response to the resolutions urging them to provide their children with black dolls. Today negro children in many parts of the city were seen fondling dolls of their own color.

It has been announced that doll manufacturers have prepared to aid this movement, with the avowed purpose of instilling in the minds of the children race love, race loyalty and race contentment.

Not only will color dolls be made but it is said that calendars and prints for decorative purposes will be made with pictures of colored persons.

Strong Effort Will Be Made to Carry State of Illinois

CHICAGO, Oct. 25.—The real significance of the recent visit of William F. McCombs, chairman of the Democratic National Committee to Chicago, became apparent today when it was announced that many speakers of prominence in the Democratic party would be brought to Illinois in an effort to carry the state.

The first of these will be Senator James A. O'Gorman of New York, who will address two meetings here this evening. At the Democratic headquarters it was said he probably would make at least another speech in this state.

South Carolina State Fair

COLUMBIA, S. C., Oct. 26.—On the eve of the opening of the forty-fourth annual South Carolina State Fair all indications point to the most successful exhibition in the history of the society. Exhibitors from every county of the state were busily at work today installing their displays in the various buildings and pavilions. The display of live stock, agricultural products, machinery and manufacturers will be the largest and best ever seen here. The racing program will be inaugurated Monday and continued until Friday.

WILL ASK COURT FOR NEW TRIAL

Becker Will Make a Strong Fight For Life

APPEAL MAY TAKE A YEAR

Says He Has Not Received the Fair and Impartial Trial Which is Guaranteed to all Men

NEW YORK, Oct. 25.—"I am sorry the jury found as they did," was Lieutenant Becker's only comment to his jailer this morning as the convicted man sat on the edge of his prison cot with his chin resting in his cupped hands.

The nerve which stood by him throughout the ordeal of the fifteen day trial did not desert him today and his bearing was as firm and steady as at any time during the proceedings in the court room.

Becker's counsel may be partly accounted for by his confidence that an appeal will mean a reversal of the decision, followed by a new trial and probable acquittal.

Before he was taken to his cell from the courtroom, he said to friends seated near him.

"Have no fear this case is not ended yet. There will be a new trial, and I will be tried again at a time when public clamor does demand a victim. Then I am sure I will be acquitted. I do not believe that in those present proceedings I have had the fair and impartial trial which is guaranteed to all men under the laws."

Lloyd P. Stryker, of Becker's counsel, said today that the appeal would probably take a year's time. John F. McIntyre, Becker's chief counsel, was confident of the success of this action.

There is not the slightest doubt, he said, that there will be a reversal of this verdict in a higher court.

It was announced this morning that the jury arrived at its verdict of first degree murder after only three formal ballots.

At no time during the eight hours of deliberation was there a question of Becker's guilt—the only matter of debate being as to whether the verdict should be for first degree murder meaning death to the prisoner, or second degree, which is punishable by life imprisonment.

It was said that the first ballot showed eight of the jurymen for conviction in the first degree, while on the second ballot all but one of the 12 were agreed.

The final ballot, taken shortly before midnight, was unanimous for a verdict of first degree.

District Attorney Whitman will now turn his attention to the cases of the gunmen of the Rosenthal murder, who must be tried before the same special term of court as Becker. They have all asked for special trials, but it is believed that Becker's conviction will make their trials not much more than legal formalities.

Congressman Kitchin Here.

Congressman Claude Kitchin, of the second district, spoke here in the court house this afternoon in behalf of the candidacy of his brother, Gov. W. W. Kitchin, for United States Senator. The lateness of the hour makes it impossible to give a report of the speech today.

Aged Lady Dies

Mrs. Martha Belcher, aged 79, died this morning in Farmville. She is survived by two daughters, Mrs. S. J. Parker and Mrs. W. C. Askew, both of Farmville. Funeral will take place Sunday.

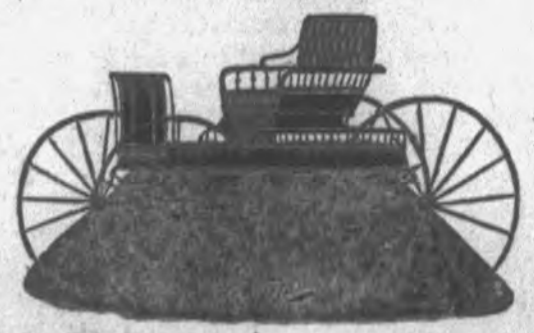
