TURKS REPORTING BULGARIAN DEFEAT

Conquered in Three Big Battles Yesterday

EUROPE IS AWAITING ANXIOUSLY

Two Branches of the Montenegrin Army Effect A Union Which Strengthens The Allied Armies

LONDON, Oct. 30.—The Bulgarian army was defeated by the Turks at Visa, Remil and Seria yesterday, according to an official dispatch received by the Ottoman embassy here. The Turkish loss totalled 800 killed and wounded.

Constantinople, Oct. 30.—1:30 p. m.—The Turkish commander in chief, Nazim Pasha, telegraphs that a big battle has been in progress since this morning. The troops engaged on both sides number 150,000. Nazim Pasha says the position of the Ottoman forces is favorable.

Bulgarians Reported Repulsed Constantinople, October 30.—Mahmoud Mukhtar's division of the Turkish army repulsed the Bulgarian troops yesterday, inflicting severe loss on them at Tcherekesskeul, on the Schorlu river and on the railroad midway between Constantinople and Adrianople.

Heavy Fighting Around Adrianople London, Oct. 30.—A big battle, perhaps the decisive one of the war, is now being fought to the east of the line from Constantinople to Adrianople, between the Turkish and Bulgarian armies and heavy fighting also is taking place around Adrianople itself.

Beyond the fact that a clash has come, however, the general staff of the Turkish and Bulgarian armies are keeping the outside world ignorant as to how things are going with them. Military critics here are inclined to believe that the Turkish army is ready to take the offensive.

The Bulgarian troops have obviously suffered a check in the vicinity of Adrianople, as dispatches from Sofia report the arrival there of many wounded from the front.

The Turkish commander's plan is not clear, but it is believed he will attempt to relieve Adrianople and its garrison of fifty thousand men, while at the same time holding the Bulgarians on his left flank.

The rumors that Bulgarian troops had reached the sea are unconfirmed. From Belgrade come reports that the Servian victory over the Turks at Veles was accomplished by the cavalry, which divided the Turkish force while the Servian artillery drove them from their position.

Montenegro Armies Effect Junction. Rieka, Montenegro, October 30.—The center column of Montenegrin troops commanded by Crown Prince Danilo today effected a junction with the southern Montenegrin army under General Martinovitch to the east of Scutari.

Austria and Russia Reach Understanding

Vienna, Austria, Oct. 30.—The Austrian and Russian governments have arrived at an understanding on the Balkan question, according to the Neue Freie Presse. An official announcement on the subject is expected shortly to explain the nature of the accord and the common policy that has been agreed upon with reference to the future treatment of the Balkan question.

GIVE UP LIVES SAVING CHARGES

Brave Nuns in San Antonio Trapped by Fire

HEROIC ATTEMPT TO RESCUE ORPHANS

St. John's Orphanage In a Texas Town Scene Of Abnegation. Institution Was Destroyed

SAN ANTONIO, Oct. 30.—Five Sisters of Charity sacrificed their lives in an attempt to save eighty-seven children in a fire that destroyed St. John's Orphanage today.

They succeeded in rescuing all but two children before they were trapped by flames.

Another sister was burned so seriously that she cannot survive. Two sisters escaped.

The dead sisters are:

Mother Mary of the Cross, Mother Superior of the parish. She was Mary Rossiter, a native of Wexford, Ireland. Mother Frances Pastier, native of France.

Sister Peter Claver Stevin, teacher in San Fernando school, native of Dublin, Ireland.

Sister Leocadia Nolan, teacher in San Fernando school, native of Ireland.

Sister Monica Montez, native of Mexico.

The injured nun is Sister Kostka Farrell, native of Kildare, Ireland. Physicians say she cannot survive.

The other injured are:

Miss A. Detemple, an employee, native of Germany.

Miss E. Standish, native of Saint Hedwig, an employee.

The fire's origin is not known.

Eighty-seven orphan children, ranging in age from 2 to 12 years and nine nuns were in the building when the flames broke out. Marshalling their charges to hurry them to safety the sisters of charity remained in the blazing orphanage until the building began to crumble and fall.

The death of the mother superior, Mary of the Cross, was the sequel to a demonstration of remarkable courage. She returned to the burning dormitory when she heard the cry of a child who had been overlooked in the hurry and excitement. A few moments later she appeared at a window with the babe in her arms.

A SECRET ARREST REVEALS A SERIES OF GRAFT IN ATLANTIC FLEET

WASHINGTON, Oct. 30.—A system of graft in the commissary department of the navy which may reach every ship in the Atlantic fleet has been revealed by a secret investigation, which, Rear Admiral Osterhaus today reported to the Navy Department, has resulted in the confession of G. T. Davis, chief commissary steward of the battleship Louisiana.

Admiral Osterhaus' report is very brief and contains no details further than that Davis, in his confession, has implicated the stewards of other ships of the fleet—at least six—and several contractors.

The investigation which has been under way for several days before a formal court of inquiry has been conducted with the utmost secrecy.

It is expected that after Davis had been suspected of illegal transactions in the handling of government supplies, Captain Welles of the battleship laid a trap in which, officials say, Davis was caught.

Captain Welles arrested Davis and preferred charges against him to Admiral Osterhaus. The investigation by the court developed not only the charges against Davis, but what is said to be a system of illegal dealings by commissary stewards on many other ships.

As in all cases of the kind, officials are reluctant to discuss the situation. The navy men are zealous of the honor of their service and make no effort to conceal their chagrin at a revelation of anything irregular.

Woodrow Wilson's Message to the American People

Sea Girt, N. J., Oct. 19, 1912.

To the Voters of America:

I am glad to have an opportunity to state very simply and directly why I am seeking to be elected President of the United States. I feel very deeply that this is not an ambition a man should entertain for his own sake. He must seek to serve a cause, and must know very clearly what cause it is he is seeking to serve.

The cause I am enlisted in lies very plain to my own view: The Government of the United States, as now bound by the policies which have become characteristic of Republican administration in recent years, is not free to serve the whole people impartially, and it ought to be set free. It has been tied up, whether deliberately or merely by unintentional development, with particular interests, which have used their power, both to control the government and to control the industrial development of the country. It must be freed from such entanglements and alliances. Until it is freed, it cannot serve the people as a whole. Until it is freed, it cannot undertake any programme of social and economic betterment, but must be checked and thwarted at every turn by its patrons and masters.

In practically every speech that I make, I put at the front of what I have to say the question of the tariff and the question of the trusts, but not because of any thought of party strategy, because I believe the solution of these questions to lie at the very heart of the bigger question, whether the government shall be free or not. The government is not free because it has granted special favors to particular classes by means of the tariff. The men to whom these special favors have been granted have formed great combinations by which to control enterprise and determine the prices of commodities. They could not have done this had it not been for the tariff. No party, therefore, which does not propose to take away these special favors, and prevent monopoly absolutely in the markets of the country sees even so much as the most elementary part of the method by which the government is to be set free.

The control to which tariff legislation has led, both in the field of politics and in the field of business, is what has produced the most odious feature of our present political situation, namely, the absolute domination of powerful bosses. Bosses cannot exist without business alliances. With them politics is hardly distinguishable from business. Bosses maintain their control because they are allied with men who wish their assistance in order to get contracts, in order to obtain special legislative advantages, in order to prevent reforms which will interfere with monopoly or with their enjoyment of special exemptions. Merely as political leaders, not backed by money, not supported by securely entrenched special interests, bosses would be entirely manageable and comparatively powerless. By freeing the government, therefore, we at the same time break the power of the boss. He trades, he does not govern. He arranges, he does not lead. He sets the stage for what the people are to do; he does not act as their agent or servant, but as their director. For him the real business of politics is done under cover.

The same means that will set the government free from the influences which now constantly

control it would set industry free. The enterprise and initiative of all Americans would be substituted for the enterprise and initiative of a small group of them. Economic democracy would take the place of monopoly and selfish management. American industry would have a new buoyancy of hope, a new energy, a new variety. With the restoration of freedom would come the restoration of opportunity.

Moreover, an administration would at last be set up in Washington, and a legislative regime, under which real programmes of social betterment could be undertaken as they cannot now. The government might be serviceable for many things. It might assist in a hundred ways to safeguard the lives and the health and promote the comfort and the happiness of the people; but it can do these things only if its actions be disinterested, only if they respond to public opinion, only if those who lead government see the country as a whole, feel a deep thrill of intimate sympathy with every class and every interest in it, know how to hold an even hand and listen to men of every sort and quality and origin, in taking counsel what is to be done. Interest must not fight against interest. There must be a common understanding and a free action all together.

The reason that I feel justified in appealing to the voters of this country to support the Democratic party at this critical juncture in its affairs is that the leaders of neither of the other parties propose to attack the problem of a free government at its heart. Neither proposes to make a fundamental change in the policy of the government with regard to tariff duties. It is with both of them in respect of the tariff merely a question of more or less, merely a question of lopping off a little here and amending a little there; while with the Democrats it is a question of principle. Their object is to out every special favor out, and cut it out just as fast as it can be cut out without upsetting the business processes of the country. Neither does either of the other parties propose seriously to disturb the supremacy of the trusts. Their only remedy is to accept the trusts and regulate them, notwithstanding the fact that most of the trusts are so constructed as to insure high prices, because they are not based upon efficiency but upon monopoly. Their success lies in control. The competition of more efficient competitors, not loaded down by the debts created when the combinations were made, would embarrass and conquer them. The trusts want the protection of the government, and are likely to get it if either the Republican or the so-called "Progressive" party prevails.

Surely this is a cause. Surely the questions of the pending election, looked at from this point of view, rise into a cause. They are not merely the debates of a casual party contest. They are the issues of life and death to a nation which must be free in order to be strong. What will patriotic men do?

Mr. Burns came to Oyster Bay today to take luncheon with Colonel Roosevelt and go over with him the plans for election day. The Colonel said: "We are not going to have any repetition of the spring primary. In this case we have the law behind us."

Colonel Roosevelt left today for New York to speak in Madison Square Garden tonight.

Begins 50th Year of Rulership

ATHENS, Oct. 31.—King George, of Greece, who again looms large in the public eye by reason of the flame of war that appears to be rapidly spreading over southeastern Europe, today entered upon the fiftieth year of his reign. Next to the venerable Emperor of Austria he is the oldest of the sovereigns of Europe. Born a prince of Denmark, he was proclaimed King of the Hellenes by the national assembly of Greece on March 30, 1863. He was then seventeen years old. On October 30 of the same year he arrived in Athens and on the following day he took the oath and mounted the throne.

Notable Wedding in Wilmington

WILMINGTON, N. C., Oct. 31.—The Bishop of North Carolina officiated today at the wedding of Miss Sadie Jones, daughter of Mr. and Mrs. Pembroke Jones and John Russell Pope, of New York city. The ceremony was performed in the old Wrightsville Chapel at Aairlie, the country home of the bride's parents, who are numbered among the social leaders of New York and Newport. The family has been prominent in Wilmington since before the war and still maintains a country home here.

GOVERNOR WILL BE ASKED TO STAY THE DEATH SENTENCE OF ALLENS

RICHMOND, Va., Oct. 30.—A number of ministers and others here are combining in an effort to procure the commutation of the death sentences of Floyd and Claude Allen, the Carroll county outlaws now under sentence to die November 22nd.

The governor will be asked, in event of the failure of prisoners to get a new trial, to commute their sentences to life imprisonment.

Report has it that at least two penitentiary directors favor clemency.

Mr. E. P. Fleming Dead

Another of Pitt county's Confederate soldiers and good citizens answered the final roll call this morning about 4 o'clock, when Mr. E. P. Fleming passed away at his home five miles from Greenville. He was 72 years of age and is survived by three sons, Messrs. J. E., C. E., and Bithel Fleming.

His wife died only two weeks ago and he soon follows to join her "Beyond the River".

Michigan Teachers in Session

GRAND RAPIDS, Mich., Oct. 31.—With every prospect of a busy and profitable session, the members of the Michigan state teachers association gathered in Grand Rapids today and began their annual convention. The program covers two days and provides for the discussion of every branch of educational work, together with addresses by such widely known educators as President Henry C. King of Oberlin College, Lotus D. Coffman, of the University of Illinois, E. T. Fairchild, state superintendent of public instruction of Kansas, and Charles A. Prosser of New York, secretary of the Society for the Promotion of Industrial Education.

VICE-PRESIDENT SHERMAN IS DEAD

Weakened Constitution; Gives Up Without Fight

END PEACEFUL IN HIS UTICA HOME

Plans of National Committee as to Successor Not Given Out as Yet. May Select John Wanamaker

UTICA, N. Y., Oct. 30.—Vice President James S. Sherman died at his home here at 9:42 o'clock tonight. Members of the immediate family were all present.

Not since early this morning when his attending physician made the final announcement of his inability to do more for relief than he had done, was there the least probability of saving the patient's life, or even of prolonging it for any considerable time. It had been the doctor's hope up to that time that he might so stimulate the kidneys as to cause them to resume their functions but when he was compelled to acknowledge failure in this respect, he surrendered, frankly acknowledging that the fight was lost. Since then he devoted his efforts to keeping his patient quiet and preventing suffering. His constant fear was that the uremic poison in his patient's system would cause convulsions which would result in instant death.

Suffragists at New Haven

NEW HAVEN, Conn., Oct. 31.—The annual convention of the Connecticut Woman Suffrage Association began in this city today with a large and representative attendance. Rabbi Stephen S. Wise of New York speaks before the delegates tonight. The convention will conclude tomorrow with the election of officers for the year.

Becker is Sentenced to Die During Week of Dec. 6th.

NEW YORK, Oct. 30.—Charles Becker, the former police lieutenant convicted of procuring the murder of the gambler, Herman Rosenthal, was today sentenced to die in the electric chair at Sing Sing during the week of December 9. The sentence was pronounced by Justice Goff.

Becker's execution will be stayed, however, by a notice of appeal from the verdict of the jury soon to be filed by his counsel who may take a year to determine.

He was at once delivered into the custody of Sheriff Harburger, who immediately left with him to take a train to Sing Sing prison, where the convicted man will be confined until fate is determined.

Mrs. Becker had a short talk with the prisoner in the sheriff's quarters at the criminal courts building before Becker was taken before the court. With Becker were his brothers, John B. Becker and Jackson Becker and Father Curry, of St. James' Church. All sought to cheer the condemned man.

Mrs. Becker with her brother-in-law pleaded with the sheriff to delay Becker's removal to Sing Sing. They said the prisoner should be permitted to stay in this city for several days at least in order to adjust his business affairs. The sheriff was obdurate and announced that he would take Becker away today.

J. F. McIntyre, Becker's chief counsel, who suffered a nervous collapse after the close of the trial, was unable to be in court today. His condition is serious, though not critical.

"Charles Becker, have you any legal cause to show why judgment of death should not be pronounced against you?" asked the clerk. Becker opened his mouth as if to speak but before he could reply John W. Hart, his attorney of record, rose to make the usual motions to set aside the verdict, and to arrest judgment. Justice Goff denied the motions and then pronounced the sentence.

To the People of Pitt County:

Believing that I have been misquoted in my position on questions of concern to the people of Pitt county I direct your attention to the following statement:

I ask you to nominate me in the Democratic primary on the Initiative, the Referendum and other measures. You nominated me and whether you nominated me on these measures alone or not, I am honor bound to stand by my pledges and fight for these principles.

As to a local stock law, I say now and have always said that the people effected by that law should be given a vote to determine whether or not they wanted the law. I believe this is the most amicable and the only way to settle this question and I do not hesitate to say that if I represent Pitt county in the legislature I will do all in my power to submit this troublesome question to a vote of those affected by it.

To do more than this is to take the matter out of the people's hands, where it justly belongs, and place it at the discretion of a few. I have been asked to say what I will do, if elected to the legislature, about the stock law fence south of Greenville, about which there has been so much trouble. I now repeat and say in the most positive tones, that I will vote for a law to give the people interested an opportunity to vote on the question as to whether the fence shall remain where it is or be removed.

The Democratic doctrine is, the majority rules, and I submit how are we to ever know whether a local fence law is wanted or not so long as one legislature makes it and another repeals it, without submitting it to a vote of the people. Such a state of affairs might go on indefinitely and we would arrive at no solution of the question, and those vitally interested be kept in constant turmoil and doubt as to how to protect their crops and stock.

The people themselves must have an opportunity to ratify or repeal this law at the ballot box. To allow this law to stand without a vote is an injustice to a part of our people, yet to repeal it without submitting it to a vote is just as grave an injustice to others. The majority must rule. That is good Democracy.

I have tried to state clearly my position regarding the stock law question. I say now positively it is the position I will maintain regardless of faction or influence. It is identically the position I took before the primary—you supported me then and I have a right to expect you to support me now.

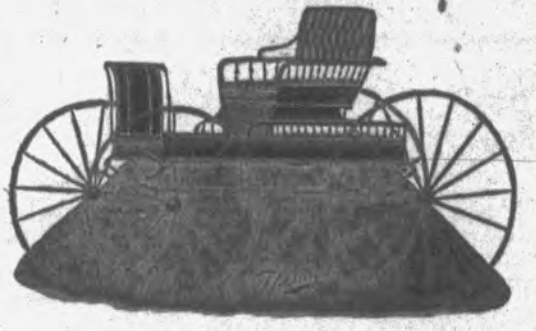
