SENATOR SIMMONS' MASTERFUL SPEECH INCREASES LOYALTY OF SUPPORTERS

The North Carolina Senior Senator is Met by the Largest Audience that Ever Occupied the Court House to Hear a Political Speech

FOR TWO AND THREE QUARTER HOURS THE
LITTLE GIANT OF DEMOCRACY HOLDS AUDIENCE

Makes a Democratic Appeal in Coming Election

By far the greatest political speech saw a good Democrat in his way and made in our handsome court house again formulated the question, but was that made yesterday afternoon quickly withdrew it when the man by the Senior Senator from North Carolina. Senator Simmons, modestly alluded to it as a "rambling speech". Still, happily enough all his ramblings in the political woods took him yesterday to some point which when once reached called forth for the lusty applause of the largest audience that ever gathered in the new court house to hear a political speech.

Col. F. G. James, in an introductory jewel of a speech was frequently and loudly applauded as he touched upon those questions that the national and state Democracy will be called upon to answer in but a few short days. His allusion to the speaker to be were of a nature that well define the sentiment felt by the majority of grateful Democrats of the county and state for a man who for twelve years has been the standard bearer of the Old North State in the most august body sitting in common in the framing up of the laws of this country.

The actual introduction of Senator Simmons himself, called for a demonstration such as has never been witnessed in our midst, and as the riot of appreciation subsided Senator Simmons began his magnificent, formidable and eloquent speech.

The fact that the previous night he had spoken to an enthusiastic audience of 6,000 listeners for two hours, had affected his voice and towards the beginning of his speech this handicap was very noticeable. When, however, two and three-quarters hours later the Senator, halted to receive the last demonstration, nobody in the packed court house, would have known it. The enthusiasm with which Simmons does everything that culminates in the good of the people that have entrusted him with one of the most responsible duties a constituency can entrust a candidate was with him during his long speech.

Clearly did he make it understood that he had not come to us with a message of self-reproach; with a few words of apology. F. M. Simmons had no apologies to make for the manner in which he had carried through the great duty. F. M. Simmons did not have to make any excuse for any of his actions while in Washington. What Senator Simmons came to us for was to present his record illuminated by the wonderful light of truth and standing upon it with the courage of the man thoroughly convinced that his acts emanated from the great love he bore the people that had so distinguished him.

Unlike several speeches heard in Greenville lately, was Mr. Simmons' A total want of personal abuse made his two and three-quarter hour speech wholesomely Democratic, Democratically wholesome. Names of brother partisans did he mention, but in mentioning them he covered them with the glory that its owners had earned. Facts did he refer to, but facts that under the light thrown upon them by him, appeared honorable, instead of shameful. For two and three-quarters hours did the Senior Senator speak from his heart to his audience, further endearing himself with them, and putting to shameful flight whatever doubt may have existed in some of the present ones.

Simmons, did indeed scorn the idea of a defense of his record. And pray, why defend that which because of its pure nature and purpose needs nothing but praise and commendation? The Senator's Democracy has been questioned to the four quarters of this great state. And again pray, who has been the questioner? Why, comes the ready answer, the questioner is

Pitt County Fair Association Officials Held Meeting Yesterday

WAREHOUSEMEN EXTENDED A VOTE OF THANKS

GOVERNING BOARD, TOWNSHIP COMMITTEES AND LADIES OF THE WOMAN'S DEPARTMENT GATHERED TO PERFECT PLANS OF SECOND ANNUAL FAIR OF THE ASSOCIATION

The governing board, township committees and ladies of the woman's department of the Pitt county fair held an enthusiastic meeting in the court house this morning and everything was found in readiness for the fair that will be held on the 14th and 15th.

A motion was adopted by a rising vote tendering the thanks of the association to the tobacco warehousemen of Greenville for tendering the use of their warehouses and to the tobacco board of trade for their cooperation in holding the fair.

The executive committee was authorized to use its discretion in awarding premiums for exhibits of merit of articles not included in the published premium list.

As to the feeding of stock exhibited at the fair, while the association will appreciate exhibitors who can do so bringing along feed for their stock, feed will be furnished by the association for all stock not otherwise provided for.

The township committees reported their proportion of donations for the fair as raised, several of them going even beyond the amount allotted to them, so it is seen this far ahead that the finances for the fair are provided for.

Mrs. J. D. Cox, director of the woman's department, reported that there is every prospect of this department of the fair surpassing last year.

Superintendent H. B. Smith of the Greenville graded school, stated that preparation for educational day at the fair were well under way. County Superintendent W. H. Ragsdale addressed the meeting with much enthusiasm, and said wherever he has been over the county he finds great interest in the fair, and that the schools are all coming for education a big day!

Mr. R. L. Little, secretary of the Farmers' Union, stated that the union will have a parade and demonstration on the first day of the fair, and that farmers' day is going to be a big dandy!

Mr. A. G. Cox gave his views on the fair held last year and the bright prospects for the one to be held this year.

Everything points to a great fair on the 14th and 15th.

Funeral of Vice President Sherman Closes All Federal Offices

WASHINGTON, Nov. 1.—Postmaster-General Hitchcock later issued an order that all flags on postoffice buildings throughout the United States be at half mast for thirty days, beginning November 2nd.

Washington, Nov. 1.—Postmaster-General Hitchcock today authorized postmasters throughout the country to close postoffices tomorrow on account of Vice-President Sherman's funeral.

Mr. Hitchcock construes the president's proclamation closing executive offices, as extending to postoffices throughout the nation. Postmasters have been authorized to use their discretion in closing offices so far as public business will permit.

At a conference today the Supreme Court of the United States accepted the invitation to attend the funeral of Vice-President Sherman and designated Associate Justices Hughes and Pitney to represent the court.

The Treasury Department also notified all customs houses to close tomorrow for the Vice-President's funeral.

To Celebrate Supremacy in Air

Paris, Nov. 2:—To celebrate the supremacy of France in aerial navigation a great banquet of over 2,000 covers is to be given tomorrow under the auspices of the French National Committee of Military Aviation. The scene of the banquet will be the largest of the great dirigible hangars on the aviation field at Issy les Moulineaux. The gathering will be exceptionally brilliant, the guests including members of the cabinet, heads of the army and navy, several score of French aviators, and many members of political social organizations who have helped to give to France the prominent position she holds as "Queen of the Air."

Tennessee to Vote for Senator

Nashville, Tenn., Nov. 2:—A direct election and a primary election will combine when they go to the polls next Tuesday. The direct election, as in other states will be for presidential electors, representatives in Congress, governor and State railroad commissioner. The primary election will be for the selection of the Democratic candidates for United States senator, and several State officials below the governorship.

TURKS WARSHIP SUNK BY ENEMY

Deadly Torpedoes Find Way to Side of Ship

WARSHIP SINKS AT ONCE

Ottomans Seem To Be Unable To Stop The March To Victory Of The Allied Armies

ATHENS, Greece, Nov. 1.—The Turkish battleship Feth-I-Bulend was sunk during last night in the Gulf of Saloniki by a Greek torpedo boat.

The Greek commander's daring enterprise was carried out under the guns of the Turkish forts without being observed and the torpedo boat escaped unscathed.

Turks Confirm Report.

Constantinople, Nov. 1.—The sinking of the Turkish battleship Feth-I-Bulend by a Greek torpedo boat in the Gulf of Saloniki is confirmed by a dispatch from Saloniki.

The warship sank in five minutes. The commander of the Feth-I-Bulend telegraphs that nearly all the crew of the warship were saved. He reports that the Greek torpedo boat entered the harbor unexpectedly at midnight and launched two torpedoes at the stern of the Turkish vessel, which began to sink immediately.

The commander, three engineers and four blue-jackets were thrown into the water, where they were rescued by fishing boats. The boilers of the Feth-I-Bulend exploded as she sank.

The Feth-I-Bulend saw active service in the Danube under Hobart Pasha during the Russo-Turkish war of 1878-9.

Bulgarians were Outnumbered.

Sofia, Nov. 1.—Details thus far of the rout of the immense Turkish army by the Bulgarians show that the Bulgarian forces were numerically far inferior.

The Turkish army is reported to have aggregated 200,000 men. It included the garrison which had retreated from the captured fortress of Kirk-Killsseh as well as the main body of Turkish troops which had advanced from Constantinople.

It comprised practically the whole of the Turkish troops remaining in Europe apart from the Garrisons of Adrianople, Saloniki, Monastir, Jannina, Scutari and a few other towns.

This great army was under the personal command of Nazim Pasha, Minister of War and commander in chief, who was assisted by some of the ablest Turkish generals serving in the army at the present moment.

The fight opened with the discovery by the Turks of a number of Bulgarian cavalry scouts. The Turks drew in their outposts and these were closely followed by the lines of the Bulgarian skirmishers, who were succeeded by the main Bulgarian army in fighting formation.

The battle which was destined to last several days and result in the defeat of the Turks, was soon in progress along the line.

The Bulgarian troops repeatedly delivered fierce attacks, sometimes at one point and sometimes at another, along the Turkish line extending from Lule Burgas to Sieral.

LITTLE BOY KILLED AT SHOW

Six Year Old Son of Mr. Henry Whichard

NEGRO HELD FOR BOY'S DEATH

Father And Son Go To See Sparks' Show In Robersonville Where Unfortunate Accident Happens

As the result of a tragedy occurring at Robersonville on Thursday, Garland Whichard, a little six-year-old son of Mr. Henry Whichard, near Parmele, is dead and Henry Wilkes, a colored man, is held in Martin county jail for killing the boy.

Sparks' show exhibited in Robersonville Thursday and Mr. Whichard took his little boy there to see it. While they were in a side show before the circus opened two negroes got in a row in the tent. One of them, Henry Wilkes, pulled a pint bottle of whiskey from his pocket and threw it violently at the other. The bottle missed the negro but struck the little Whichard boy, who happened to be standing in range, squarely on the head. The terrific blow felled the little boy to the ground with a fractured skull.

Three physicians, Drs. Ward, of Bethel and Ward and Nelson, of Robersonville, worked on the little boy all the afternoon trying to save his life, but he died about 8 o'clock. An operation showed that a hole as large as a half dollar had been broken through the boy's skull.

The negro, Henry Wilkes, was arrested immediately after the tragedy. So much feeling was shown against him with threats of violence, even the colored people taking part in this, that the mayor of Robersonville ordered Wilkes sent to the county jail at Williamston for safety.

Mr. H. B. Smith Run Over by Car, Suffering Painful Bruises

Late yesterday evening as Mr. H. B. Smith, superintendent of the Greenville graded schools, was passing the post office riding his wheel, the automobile driven by Master Blount, of Bethel, knocked him down, the fender of the car hitting the wheel and abruptly dismounting the rider. The darkness of the night and the slippery condition of the paved street, were probably responsible for the accident. The driver of the car did not see Mr. Smith until almost upon him and then the breaks did not act with the efficiency that would have been the case had the street been perfectly dry.

Mr. Smith is a great deal better today, although he is confined in his home. He expects to be out again by Monday.

Slayer of Railroad Official Will Offer Insanity Plea

GREENSBORO, Nov. 1.—William F. Blair, who yesterday killed George C. Thompson, division freight agent of the Southern Railway, at Blair's home here, will plead insanity as his defense. The note sent Blair by Thompson, his employer, shortly before the tragedy contained a polite notice of dismissal, stating that Blair had evidently lost interest in his work and that his services would not be required longer.

Blair has recently inherited about \$25,000. Members of his family here have already employed half a dozen of the ablest attorneys available to defend him. No bail will be allowed in his case.

The body of Mr. Thompson was carried to his old home in Culpepper, Va. He had been in the railway employ since he was thirteen years of age. His family is preparing to make a vigorous prosecution of the case against Blair.

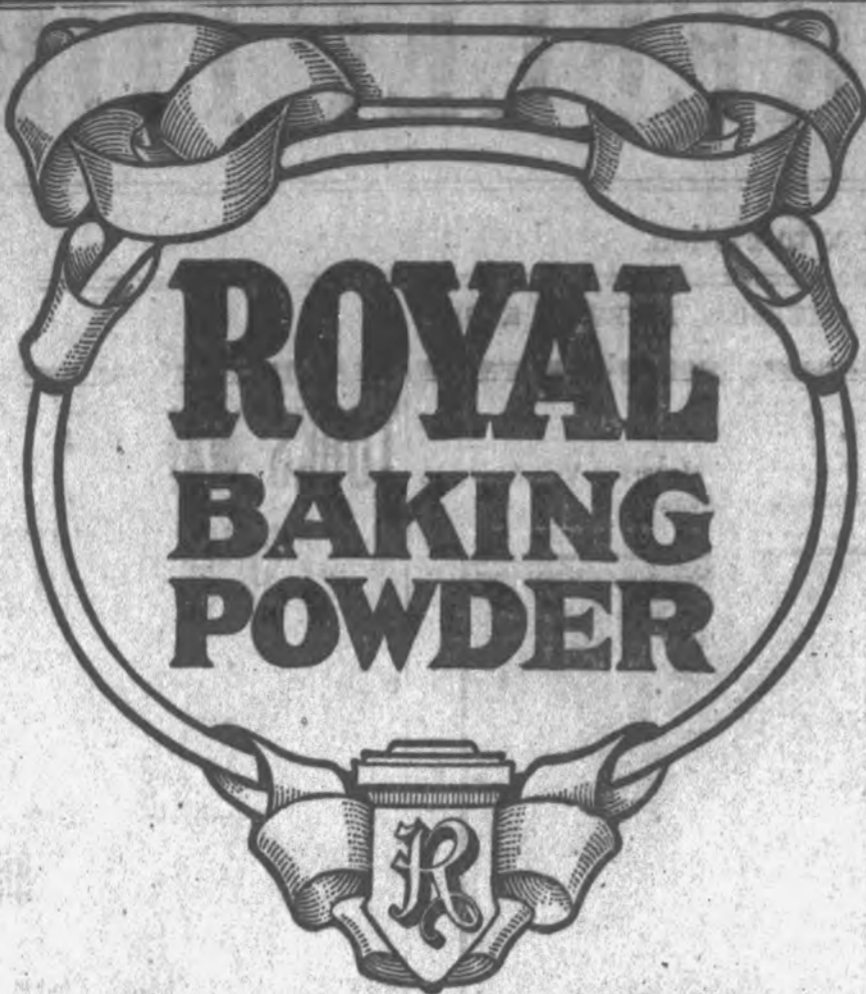

They will understand that an accumulation of causes and events that can not be reached by statute law or settled at the polls is to be counted on one side or the other in the scale of our prosperity.

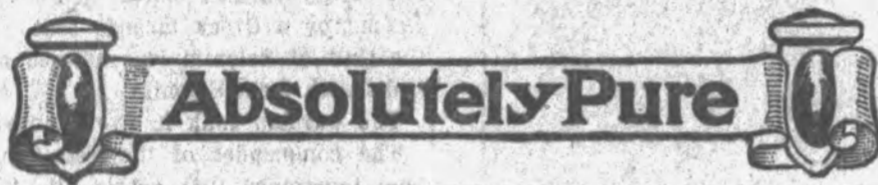
But the fact that we can not accomplish everything by putting good and prudent men in office is no reason why we should not put that kind of men in office. There is much that can be done by a wise administration at Washington.

The country is likely to prosper greatly with Woodrow Wilson in the white house.

With the election of Wilson—which seems now well assured—it is probable that the senate of the United States will be made Democratic. There is no doubt that the house of representatives will continue to be Dem-

ocratic. Thus the whole Federal government will be democratized.

It is a good thing to have the government all of one piece—just as it is a good thing to have harmony in a board of trustees or among the executors of a will. The fact is, indeed, that where there is a conflict of responsibility there is no real responsibility at all. With two rival parties pulling and hauling in congress, each in control of the single house, it is impossible for the people to tell which is most to blame for the resulting confusion. Certainly nothing important and helpful is likely to be done under such conditions.

Thus the fact that the success of the Democratic National ticket will give us a united government at Washington and therefore a really responsible government, is a pretty decisive reason why sensible men, whatever their past party alliances, should vote for Wilson and Marshall. For it is absolutely certain that a united and responsible government at Washington can not be got in any other way.

It is, of course, flat foolishness to say that the election of Wilson will precipitate a panic. The greatest panic in our history occurred in 1873. The panic we remember best took place in 1907. Both were under Republican administrations.

We have only such means of knowledge as can be gained from a wide observation and a fair understanding of events; we have no gift of inspired prophecy. But we venture to predict that the coming Democratic administration will do the country a great deal of good—that it will be memorable among the fair and fruitful times.

We believe the Democratic party will renew the spirit of self-government throughout the land; that it will strengthen our political system at its foundations by reviving popular power in local communities; that it will tend to create a political climate in which monopolies can not live.

We advise our readers to vote for Wilson and Marshall—and to free their mind from all doubt of the wisdom of that choice.
