20,000 SLAIN AND WOUNDED TERRIBLE PRICE PAID FOR POSSESSION OF TURKISH STRONGHOLD OPENING THE ALLIED ARMIES' WAY TO OTTOMAN CAPITAL.

HOSTILITIES CEASE PENDING INQUIRY INTO TERMS

SOFIA, Bulgaria, Nov. 20.—The Bulgarian troops operating before the line of fortifications defending Constantinople at Tchatalja have received orders to cease fighting and merely to hold the positions they have won as negotiations have been begun for the conclusion of an armistice at the request of Turkey.

Negotiating a Truce.
London, Nov. 20.—Fighting has practically ceased for the moment between the Turkish and Bulgarian armies struggling for the possession of the key to the gates of Constantinople and the opposing commander-in-chiefs are engaged in negotiating the terms of an armistice. If these negotiations prove successful they will be preparatory to a meeting of plenipotentiaries who will discuss terms of peace.

In accordance with the suggestion contained in the Bulgarian note that the allied Balkan nations are prepared to meet the Turkish commander-in-chief with a view of arranging an armistice, the Ottoman government has appointed Nazim Pasha to confer with General Savoff, the Bulgarian leader.

The Turkish general who has been putting up such an excellent defense in the ramparts of the capital, now has thrown on him the additional burden of deciding whether or not a further display of tenacity behind the fortifications of Tchatalja may bring easier terms and save the Ottoman empire more than Constantinople and a strip of Thrace along the shores of the Sea of Marmora, which seemingly is all that the conquerors are at present disposed to leave to be vanquished.

Turks Not Hopeful

In the meanwhile the two armies hold their respective positions. How long this armed truce will be maintained, however, will depend on the terms of peace offered by the League of the Balkan nations and on whether the hitherto futile attacks by the Bulgarians on the Tchatalja lines have inspired the Turks with hopes that the fortunes of war may yet turn in their favor.

Reports regarding the conditions proposed by the allies are conflicting. It is officially stated in Constantinople that the agreement of the allies to discuss the terms of an armistice and the preliminaries of peace does not stipulate any conditions.

Simultaneously with the lull on the battlefield comes news of a diminution of tension in the Austro-Serbian dispute by the compliance of Serbia with the demand of the Austrian government for an investigation on the spot.

Serbia Yields to Demands

Budapest, Hungary, Nov. 20.—Serbia has yielded to the Austrian demand that an official from the Austro-Hungarian ministry of foreign affairs should be allowed to proceed to Pristina to investigate the complaint made by the Austrian consul there that he had been hindered by the Servians in the performance of his duties.

This relieves the immediate tension between Austria and Serbia, as an opportunity is now furnished for an unbiased examination of the grounds of dispute.

Bulgars Deny Turkish Reports

Sofia, Nov. 20.—All the reports emanating from Turkish sources alleging that the Turkish troops had gained victories over the Bulgarians along the line of fortifications at Tchatalja are officially declared untrue by the Bulgarian war office today.

This is only information given out thus far in regard to the three days' operations of the Bulgarian army before Constantinople with the exception of yesterday's announcement that the armies had been engaged at the advanced points of the line.

Turks Repulsed at Adrianople

Regarding the situation at Adrianople, official accounts state that the Turkish troops attempted to break through the Bulgarian investing lines through the Bulgarian investing lines on Monday with heavy munition and horses.

Damning Evidence Arrived at Early in Trial of Gibson

GOSHEN, N. Y., Nov. 20.—"I saw Gibson seize Mrs. Szabo around the neck with his left arm; I saw his right hand thrust at her throat; then they both fell out of the boat."

John Minturn, eye witness of the death of Mrs. Rosa Menschik Szabo, for whose death on Greenwood Lake, Burton W. Gibson, of New York, her lawyer, is charged with murder, so testified at Gibson's trial today.

His testimony was introduced to bear out the state's contention that Mrs. Szabo was strangled by Gibson and did not die of drowning.

"Gibson and his companion were standing back to back in the center of the boat," Minturn said. "Gibson wheeled as they were passing and seized Mrs. Szabo—they struggled for a moment, the boat rocked. They fell out, the woman first, the man afterwards."

"When they were in the water presently the woman was lost to sight. The man then swam over to the boat, put his arm over it and turned it over. The boat remained right side up when they fell out and stayed in that position till Gibson tipped it over."

Minturn was standing on the water's edge, he said, when he saw the tragedy.

The boat was about seven hundred yards away. He was afraid he would forget, he added, so he went home and wrote down what he saw.

Rear-End Collision of Pay Train Results in One Victim

KELFORD, Nov. 20.—Extra Atlantic Coast Line pay train No. 38, southbound, ran into the rear of freight train No. 301, near this place, in Bertie county, early tonight, killing Harrison Bryant, porter on the pay train and seriously injuring Engineer Weathers of the same train.

John Samuels, the fireman, is missing and his body is believed to be buried beneath the wreckage, which blocked traffic.

The pay train was in charge of Conductor R. L. Cobb, who escaped injury.

The freight engine was coupled to a car and the injured engineer was rushed to the hospital at Rocky Mount.

The freight was in charge of Conductor Boney. The engineer on this train was J. S. Querry.

Wreck trains were hurried to the scene, with the result that the track was cleared soon after midnight.

The cause of the collision has not been ascertained.

On board the pay train was Paymaster A. B. Lynch, of Wilmington. He is said to be unhurt.

Engineer Weathers is a married man and resides at Wilmington.

No fire broke out.

Every precaution was taken to safeguard the money in the pay car.

BOND ISSUE FOR GOOD ROADS

Farmers' Union Advocates it as Solution

ASKS ORGANIZATION TO HELP

All Branches Of The Farmers' Wide Organization Appealed To To Help The Cause of Good Roads

The following resolutions for better roads were passed by the Ernul Local, Farmers Union, November 16, 1912.

Whereas, the Ernul Local Farmers Union realize that the progress of any community depends on its natural resources and on its capacity for handling them.

We believe that the natural resources of Craven county are unsurpassed if equalled by any county in the state and we further believe that the capacity for handling these resources in a great measure lies with the people of the county and.

Whereas, the people of Craven county are unreasonably handicapped by the bad roads of said county to such an extent that it cost the farmers and business men thousands and thousands of dollars every year to transport their produce to and from market over the present roads that would be unnecessary if we had improved public roads, and,

Whereas, the progress and development of the county demands, that, if we are to keep pace with the times and hold our own among the other counties of the state, and help the state hold its own among other states of the Union, we must improve our roads equal if not superior to other counties, and,

Whereas, we believe that the amount annually lost by the farmers of the county would in a short period of time put every road in the county in such excellent condition as to make Craven county the banner "Good Roads" county in the state, therefore, be it

Resolved, that, we heartily endorse every movement that has been made looking toward the bettering of the public roads of Craven county, but we fully realize that piecemeal work will never give satisfaction, and, that, we are entitled to better roads at the earliest possible time. Therefore, for this reason we favor the issuing of Craven county Good Roads bonds in a sum sufficient to place the leading roads in the county in a highly improved condition, so that travel could be made with the least possible exertion.

Resolved, 2nd, that, we urge every member of this organization to give his support to this cause, and also to support and aid in every way possible any individual, firm or organization that has for its object ways of Craven county.

Resolved, 3rd, that, we especially ask the support and cooperation of the New Bern Chamber of Commerce, Retail Merchants Association and any other organization that may be organized in Craven county, that believes better roads would benefit the county at large.

Resolved, 4th, that, the Ernul Local appoint a committee to be known as the Ernul Good Roads Committee, to agitate this movement and that other locals be asked to appoint a like committee and that these committees report the sentiment of the people as best they can to the County Union meeting to be held Saturday, December 7th, at 2:30 p. m. at the Court House in New Bern.

Resolved, 5th, that a copy of these resolutions be spread upon the minutes of this local, and that a copy be sent to the New Bern Sun and Journal with a request to publish.

BECKERS' SLAYERS DOOMED TO CHAIR

Justice Goff Will Condemn Them the 26

LITTLE CHANCE FOR THEM

The Four Informers And Driver Of The Murder Car Will Soon Be Released By The Authorities

NEW YORK, Nov. 20.—Joseph A. Shay, attorney for Charles Becker, filed with District Attorney Whitman today notice of appeal from the verdict of the jury which convicted his client of procuring the murder of Herman Rosenthal.

The notice acts as a stay of execution.

NEW YORK, Nov. 20.—Sentence of death on the four gunmen convicted yesterday of murdering Herman Rosenthal will be pronounced by Justice Goff on November 26. He so announced when the prisoners were arraigned before him today.

After sentence is passed the men will be taken to Sing Sing, where former Police Lieutenant Charles Becker is awaiting death.

The pedigrees of the gunmen were taken today at their arraignment. "Whitey" Lewis said his real name was Frank Seidenshue, born in Russia, 24 years old, and a bookbinder by trade. Both his parents are living and he has served two jail sentences.

"Dago Frank" gave his correct name as Frank Crofici, 27 years old, a native of Italy and a steamfitter by occupation. He has served one jail term and described himself as a moderate drinker.

"Lefty Louie" said he was christened Louis Rosenberg, was 21 years old, a native of Austria and married. His vocation was salesmanship, he said; he was temperate and had served one jail sentence.

"Gyp the Blood" was recorded as Harry Horowitz, a clerk, 24 years old, a native of New York city, married and temperate.

The state's informers, Rose, Vallon, Webber and Schepps, who have been held in prison during the trial, will be released.

The district attorney agreed today that there was no further need of keeping them behind the bars. It is thought they will leave the city. William Schapiro, driver of the murder car and jointly indicted with the gunmen and Becker, also will go free. In return for his testimony for the state, the district attorney's office will move that the indictment against him be quashed.

Of the seven indicted for the Rosenthal murder this leaves but one defendant to be tried. He is Jack Sullivan, "King of the Newsboys."

The room being festooned with this flower with additional decorations of white and blue santhemums to beautiful effect. A number of distinguished men and women from various parts of the state are here to attend the reception in addition to Asheville friends of the hosts and guests of honor.

Postal Authorities Get After 173 Persons Who Disregarded the Law

New York City Ex-Chamberlain to be Tried on Graft Charges

NEW YORK, Nov. 20.—Justice Goff's court, which has just completed the notable trials of Police Lieutenant Charles Becker and the four gunmen—slayers of Gambler Rosenthal—was the stage today for the opening of another legal drama of country wide interest.

The case is that of Charles H. Hyde, former city chamberlain who is charged with having corruptly compelled Jos. C. Robin, former head of the Northern Bank, to lend the Carnegie Trust Company, \$130,000, by threatening to withdraw city funds from the Northern Bank.

The indictment against Hyde was found by the grand jury on May 1st, 1911.

The principal witness against Hyde is Jos. C. Robin, who has pleaded guilty to grand larceny in that he stole funds from the Washington Saving Bank and has been in the Tombs for 22 months. Robin will get a suspended sentence for his work in building up the case against Hyde and Banker Cummins.

The penalty in Hyde's case in the event of conviction may be \$5,000 fine or ten years imprisonment, or both. Hyde, for 22 years a close personal friend of Mayor Gaynor and for many years his law partner, was appointed to the post of city chamberlain, the highest salaried office within the gift of the mayor, soon after Gaynor's election.

In the fall of 1910 Hyde's name came prominently before the public when it was charged in a criminal trial that he had taken part in the distribution of a \$500,000 corruption fund raised to beat the race track bills then pending.

Hyde was sought as a witness, but he suddenly disappeared from public view early in December and for more than fifty days was not to be found. Rumors placed him in Florida, where he was said to be living in his houseboat, the "Stop-a-While."

He was not found until January 16, when he returned to his office and went to work.

Senator Simmons' Secretary Spoken of for Western Collector

ASHEVILLE, Nov. 20.—A. D. Watts spent today in Asheville in conference with a number of prominent Democrats. Mr. Watts is a candidate for appointment as collector of the western district. Many thought that Samuel L. Rogers, manager for Senator Simmons, would receive this recognition as a matter of course, but others say that Mr. Rogers would be just as well content with the position of commissioner of internal revenue or something equally attractive in Washington.

Roller Mill Plant in Goldston Burns; Damage \$11,000

GOLDSTON, Nov. 20.—The roller mills at Goldston, owned by the Goldston Milling Company, of which A. L. Barber was the principal stockholder, was burned this morning between the hours of 1 and 2 o'clock. The fire originated about the furnace and is supposed to be accidental. The loss is estimated at \$10,000 to \$11,000 with \$5,500 insurance. It is the intention of the company to rebuild at the earliest possible date.

Engineers Meet at Akron

AKRON, O., Nov. 21.—A large attendance marked the opening here today of the eleventh annual meeting of the Ohio Society of Mechanical, Electrical and Steam Engineers. The sessions will last three days and will be devoted mostly to the reading of papers on engineering topics.

ALL CHARGED WITH ILLIGALLY USING THE MAILS IN THE PROMOTION OF SALES OF DRUGS AND INSTRUMENTS USED FOR THE PERFORMANCE OF ILLLEGAL OPERATIONS

MOST FAR-REACHING CAMPAIGN EVER STARTED

WASHINGTON, Nov. 20.—Acting under direction of Postmaster General Hitchcock, postoffice inspectors and marshals in the seventy-two leading cities of the country began today practically simultaneous raids for the arrest of 173 persons charged with using the mails to promote criminal medical practices or the sale of drugs and instruments used for illegal purposes.

The number of arrests to be made in the respective cities follows: New York 2; Buffalo 3; Pittsburgh 7; Indianapolis 5; Chicago 9; St. Paul 5; Fort Worth 4; St. Louis 3; Omaha 4; Oklahoma City 5; Portland, Ore. 9; Denver 5; Seattle 8; Spokane 5; San Francisco 7; Oakland, Cal. 8; Los Angeles 3; San Jose 3; Mobile 3; Marietta, O. 3; Dallas 3.

Two each in Albany, Washington, Memphis, Birmingham, Cleveland, Steubenville, O., Duluth, Winona, Minn.; San Antonio, Houston, New Orleans, Kansas City, Topeka, Alameda Cal.

One each in Atlanta, Cincinnati, Toledo, Minneapolis, Galveston, Salt Lake City, Ithaca and Elmira, N. Y.; East Orange, N. J.; Lancaster and Pine Bank, Pa.; Cumberland, Md.; Charleston and Columbia, S. C.; Jacksonville, Fla.; Columbus, Springfield, Mount Vernon, Dayton and Convo, O.; Fort Wayne and Terre Haute, Ind.; Peoria, Ill.; Kalamazoo and Iron River, Mich.; Holden, Mo.; Muskogee, Okla.; Wichita, Kas.; Council Bluffs, Ia.; Bellingham, Crescent and Tacoma, Wash.; Sacramento, Petaluma, Fresno and Glendale, Cal.

The arrests are made for the misuse of the mails, each case being based on the use of the mails to solicit business or dispose of wares.

This concerted official action covered the United States from the Atlantic to the Pacific and from the Lakes to the Gulf. Many of the persons to be arrested are prominent, commercially and socially, in their communities.

Some are leading physicians; others are rich and influential business men; yet others are men who live by their wits and are comparatively little known without their own small coterie of associates; and one is a Chinaman, who is alleged to have practiced his calling upon women of his own race and upon those of the lower strata of society.

All of the arrests are to be made for alleged violations of section 211 of the penal code of the United States, which bars from the mails any vile or obscene matter, whether sealed or unsealed, any advertisement, letter or circular proposing or suggesting criminal practices; or any packet containing any substance, drug or anything intended to be used for immoral or unlawful purposes.

Kinston Tobacco Market Will Be Declared Closed December

KINSTON, Nov. 20.—The Kinston tobacco market will close for the season on December 20. The early closing of the market this year is due to the fact that the product was marketed early this season. There, of course, is some tobacco in the hands of the planters yet, but with the prevailing high prices this will soon be disposed of. Most of the buyers on the local market will go to Kentucky where the season open about the first of the year.

TWO MORE GOOD SERMONS

Delivered by Mr. Madrey in the Baptist Church
Rev. C. E. Madrey preached two more excellent sermons in the Baptist church Wednesday afternoon and night. His subject in the afternoon was "Building Ruined Walls," based on the return of Nehemiah to Jerusalem to rebuild the walls of the city. Comparing the devastation there with the wreck caused by sin in the world, he said those who seek to change this condition by restoring the sin-ruined life to righteousness, must have a sympathetic contemplation of the ruin of sin. Then there must be personal contact with the ruin, a getting down beside those ruined with sin and helping to lift them up. To be effective, work must begin "over against your own house," first in the individual life and then in the home. No one is prepared to work for Christ whose life is uncertain.

The subject at night was "Counting the Cost". He showed the life of a Christian is not an easy one, but is a constant warfare against sin. It is not going to Heaven "on the flowery beds of ease," but the way is fought with trials and difficulties. Count the cost and see if it is worth while. The speaker placed special emphasis on the cost of not being a Christian, the loss that comes not only in this life but eternal destruction and separation from God and loved ones.

Mr. Madrey makes his sermons clear with many forceful illustrations. There was one profession at the night service.

The subject for tonight is "Profit and Loss", a companion topic to the one used last night. The service begins promptly at 7.30. The afternoon services are at 3.45.
