Turks Refuse Peace Negotiations Presented by Balkan States

FORTE ORDERS NAZIM PASHA, COMMANDER IN CHIEF OF OTTOMAN TROOPS, TO RESUME HOSTILITIES, CRUSHING BLOW TO TURKS WILL BE CONQUEST OF CONSTANTINOPLE

SCENES OF HORROR AS WOUNDED ARE BURIED WITH DEAD

CONSTANTINOPLE, Nov. 21.—The Ottoman government has rejected the terms offered by the allied Balkan nations. Nazim Pasha, the Turkish commander in chief, has been ordered to resume operations.

The official announcement of the rejection of Bulgaria's terms read:

"The Porte, finding the Bulgarian conditions for an armistice incapable has ordered Nazim Pasha to resume military operations."

Turkish Cruiser Reported Blown Up

SOFIA, Bulgaria, Nov. 21.—The Turkish cruiser Hamidieh is reported to have been blown up by Bulgarian torpedo boats near the port of Varna, on the Black Sea.

Turks Make Conflicting Claims

CONSTANTINOPLE, Nov. 21.—In an attack on the Turkish cruiser Hamidieh in the Black Sea this morning two Bulgarian torpedo boats are asserted to have been sunk and two other torpedo boats badly battered. The Hamidieh is said to have escaped practically without damage.

VIENNA, Nov. 21.—The terms offered to Turkey by the Balkan nations are neither in form nor in substance uncompromising, according to information derived from an authoritative source in Sofia.

They even leave the door open to eventual modifications by negotiation so that it may be assumed Turkey will accept them and a truce will be brought about.

Emperor Francis Joseph expressed his admiration at the way the Bulgarian troops had behaved during the war, in the course of a speech to the Hungarian delegates at a banquet last evening. On the other hand, however, his majesty declared he could not understand why the fortunes of war were so unfavorable to the Turks.

Referring to the dispatch of an Austro-Hungarian consular official to investigate the situation at Pristina, the Emperor expressed the hope that the reports published regarding the Serbian treatment of the Austro-Hungarian consul there would prove exaggerated and that the incident would be settled peacefully.

The Reichspost sent instructions to Lieutenant Wagner to proceed to Pristina, but the Serbian government prevented him from going. While staying at Nish, Lieutenant Wagner reports that he heard well-nigh incredible details of the barbarities committed by the Serbian troops on the Albanians.

A Red Cross doctor with the Serbian army told him:

"The Servians gave no quarter. All the Albanians, armed or unarmed, as well as the women and children, who fell into their hands were mercilessly killed. General Stephanovitch, the Serbian commander, had the Albanians captured at Kratva formed into two rows and shot dead with machine guns, the general saying: 'We must exterminate these Austro-Hungarian favorites.'"

"General Zivkovitch also had 950 Albanian and Turkish notables cut down near Sieniza. After the battle of Kumanovo numerous wounded Albanians and Turks were buried with the dead. In the Serbian fortress of Nish several Albanian women suspected of throwing bombs at the Serbian troops entering Verisovits were killed by the Serbian troops, who battered in their skulls with the butts of their guns.

Another Turkish prisoner was beaten to death in the hospital at Nish and one was maltreated and kicked by the Servians until he was dead."

Heartrending Scenes in a Turkish Cholera Camp

CONSTANTINOPLE, Nov. 21.—Heartrending scenes of suffering and

misery are enacted daily at the Turkish cholera camp at San Stefano.

Much skepticism had prevailed in Pera, the foreign quarter of Constantinople, both among members of the diplomatic corps and foreign residents. No one there believed the figures given by railroad employes and others in contact with the Turkish army, who declared that many thousands were stricken with cholera.

No reliable figures were obtainable from official sources and in the absence of these reports were regarded as grossly exaggerated. The camp is situated at the side of the railway embankment, 50 feet in height. A large open space like a village green stretches away, some times surrounded by better class houses of two or three stories built in European style for San Stefano is the summer resort of many of the more wealthy foreign residents of Constantinople.

Two Ottoman soldiers were standing on guard at the entrance to the camp but they never made a motion. Their duty was to prevent those within the cordon from escaping and not to hinder other people from entering.

A nauseating picture was witnessed at the side of the railroad. The bodies which had been thrown from trains lay as they had fallen. Some had struck on top of the embankment; others had rolled part of the way down and some had reached the bottom. Some of the corpses lay stiffly alone. Others were in groups of three or fours.

Around a one-story stable at the foot of the embankment was a group of 60 dead and dying lying close together, apparently for warmth on the slopes of a manure pile, which the sick men had found softer than the hard ground. One man on the top of the pile was digging with his fingers a sort of trough in which to lie. The trough soon became his grave.

As the visitors came near one victim attempted to crawl across the road to the crowded manure heap but failed and fell in the roadway.

Others lying around raised their heads and cried in the hearing of the attendants that they were given no bread or water.

Walking half way across the field the visitors passed dead and dying men, sometimes at intervals of a yard, sometimes from 20 to 30 yards apart.

Postal Authorities Catch 142 in Nation Wide Casting of Net

WASHINGTON, Nov. 21.—Results compiled today by the division of inspection of the Postoffice department indicate that the country-wide raid made yesterday on persons charged with misusing the mails was remarkably successful.

Telegrams are being received hourly of additional arrests; but all of the divisional offices have not completed their reports.

At noon today the names, addresses and records of one hundred and forty two individuals arrested had been compiled. Of these, ninety-nine were men and forty-three women.

Forty-two business concerns, of more or less commercial importance, were included in the official reports thus far received, approximately fifty representatives of the concerns having been arrested.

A large majority now have indictments pending against them.

Mrs. R. L. Frazier, of Washington, was arrested today charged with violating the postal law in connection with the subject of yesterday's raids.

Tar Heel Students Doing Some Splendid Y. M. C. A. Work

CHAPEL HILL, Nov. 20.—A vital factor in the life of the students of the State University is the Young Men's Christian Association. An idea of the magnitude of its work can be ascertained by noting some of the facts set forth in a recent report issued by the general secretary of the association. Its members at present number 325, three fourths of the number being active members. Two meetings are held each week, at which topics of individual and campus life are discussed. In addition to the work in the immediate college community, 20 members of the association engage in Sunday school work in seven of the Sunday schools surrounding Chapel Hill as teachers and helpers. For the past two years the Y. M. C. A. has raised \$500 each year for the support of a missionary in China.

The American Medical Association has given a \$200 award to Dr. W. B. MacNider, professor of pharmacology and college physician of the University, for scientific research for the year 1913. The award is a recognition of Dr. MacNider's extensive scientific research in the medical world in recent years.

Prof. J. S. Holmes, States Forester, read a paper before the 201st meeting of the Elisha Mitchell Scientific Society this week on the "Forestry for the Eastern North Carolina Lumberman". In regarding forestry as a financial investment for both lumberman and landowner, of East-ern North Carolina, Professor Holmes gave three precautions that should be heeded: The prevention of forest fires, protection of young growth, and provision for regrowth.

Prof. W. W. Peèle, headmaster of Trinity Park School, of Durham, addressed the Y. M. C. A. at the University this week on "Safe Principles". The speaker said there were three requisites for goodness: strong conscience, strong will, and strong intellect.

"The North Carolina Booklet", an historical publication issued from Raleigh quarterly by the North Carolina Society, Daughters of Revolution, carries in this issue two creditable articles by members of the faculty of the State University. Dr. Archibald Henderson writes of "Elizabeth Steele: Patriot". Prof. Collier Cobb contributes an article on "The Forests of North Carolina".

Former City Chamberlain Must Reckon With Whitmans' Energy

NEW YORK, Nov. 21.—District Attorney Whitman delivered his opening address to the jury today in the case of Charles H. Hyde, former city chamberlain, on trial before Justice Goff, charged with "agreeing to receive a bribe and of receiving an unlawful fee" in connection with the alleged manipulation of the city funds prior to the crash of the Carnegie Trust Company in August, 1910.

The institution held at the time \$650,000 in city funds.

Mr. Whitman said the state would show that Hyde virtually compelled Jos. G. Robin, convicted head of the new defunct Northern Bank, to loan the Carnegie Trust Company \$130,000 to meet a crucial situation.

Richmond Minister Pleads With Governor Mann

LONG PETITION PRESENTED

Governor Mann Will Listen To The Delegation Headed By The Richmond Preacher November 29

RICHMOND, Va., Nov. 21.—Dr. George W. McDaniel, pastor of First Baptist church, Richmond; Judge N. H. Hairston and R. H. Willis, of Roanoke; W. S. Forbes and Polk Miller, business men of this city, at noon waited on Governor Mann and presented a petition containing many thousands of names asking for a commutation of the sentence of Claude Allen, the Carroll county outlaw.

The governor designated November 29 as the time on which to hear all discussion of the matter and receive all petitions bearing on the case.

He announced that he would not discuss the matter further with anyone till that date, preferring to hear all at one time.

Northwestern Shippers Complain

MINNEAPOLIS, Minn., Nov. 22.—Special Examiner Settle of the Interstate Commerce Commission came to Minneapolis today to begin a series of important hearing on complaints affecting Northwestern shippers. Included among the matters to come up are the proposed advances in rates for transportation of fuel wood, sawdust and shavings from Wisconsin to Illinois points and the proposed advances in rates on linseed oil from Minneapolis and St. Paul to Chicago, Kansas City and other points.

Missouri Choice Over Kansas

LAWRENCE, Kas., Nov. 22.—With both teams reported in good condition interest throughout Kansas and Missouri centers on tomorrow's football game between the Kansas and Missouri Universities. The game is to be played here and the city is already filling with the followers of both teams. Nearly 15,000 tickets for the game have been sold. Betting slightly favors the Missourians, chiefly because of the splendid showing the Tigers have made this season.

Keen interest is displayed in the contest, as the result will virtually determine the Southern championship.

Martin O'Brien Surely is the Original Hard Luck Guy

STUEBENVILLE, Ohio, Nov. 21.—Martin O'Brien of this city, today put in a claim for the hard luck championship. Six weeks ago his brother John fell from a train sustaining injuries that still confine him to the hospital. A week later another brother, Matthew, suffered a similar accident, lying at death's door until a few days ago. Subsequently O'Brien's wife was sent to a hospital, seriously ill. Just as she had recovered his 5-year old child had diphtheria. Today his brother-in-law, Leo McGinnis, fell from a train, receiving injuries that may prove fatal.

O'Brien is a cripple. He lost one arm in a railroad accident several years ago.

\$50,000 Cotton Deal Pulled Through by Greenville Buyer

An important cotton deal was effected yesterday by one of the local buyers. Mr. W. L. Hall journeyed yesterday to the state's farm and before night he had purchased for Messrs. J. E. Latham and Co., of Norfolk, about 850 bales of cotton, involving a transaction of nearly \$50,000 worth.

TIDAL WAVE PLAYS HAVOC

Towns in Jamaica Coats Suffer Ravages

OVER A HUNDRED ARE KILLED

Combined Hurricane and Tidal Wave Demoralizes Shipping in all of the Island Ports

KINGSTON, Jamaica, Nov. 21.—The official estimate of the dead in the hurricane and tidal wave which visited the western part of Jamaica places the number at more than 100 in the coast towns alone. Details, which are gradually coming in, indicate great devastation in the western section.

Practically all lighters and casting sloops and other small vessels around Green Bay Island, Luca and Savanna La Mar foundered were demolished and a large proportion of the crews were drowned. Many persons living in these towns lost their lives in the collapse of buildings.

The houses of the American colony at Mentego Bay were badly damaged, but no casualties are reported. The Governor General of Jamaica, Sir Sidney Oliver, reached Mentego Bay today and found conditions so direful that he immediately ordered the despatch of several hundred additional tents and large quantities of food and supplies to Kingston. The railway lines are now working within twenty miles of Mentego Bay but the telegraph lines are still disorganized.

The tidal wave at Savanna La Mar was the highest in a century. One coasting vessel was washed half a mile up the main street. Fully 90 per cent of the houses were blown down in the hurricane. The two principal hotels were unroofed, as were the churches and the railway depot.

The sea swept over the streets in the lower section of the town and rows of dwellings were piled up in a gigantic heap at the mouth of the Gully where the greatest number of dead bodies were recovered. An American tourist who happened to be in that town during the hurricane, said 40 bodies had been recovered up to the time of his departure.

At Green Bay Island, eight miles southwest of Lucas, the American said there was much wreckage ashore and afloat but no sign of life could be discovered.

At Luca, 10 dead bodies were found directly after the storm had subsided.

Democratic Senate Assured Under Terms of Coalition

WASHINGTON, D. C., Nov. 21.—Through the division of the minority, a rare occurrence, the Democrats appear able to elect one of their number Senator Augustus O. Bacon, of Georgia, as president pro tempore of the Senate. The twelve Progressives among the fifty Republicans and forty-five Democrats will make up the upper house until March 4 next, hold the balance of power and the negotiations now going on appear to show that they will throw the control to the Democrats rather than to the conservative element among the Republicans.

There has been no president pro tempore since Senator Frye, of Maine, died, but Senator Bacon and Senator Gallinger have alternately served when the vicepresident's physical condition kept him away and when the Progressives declined to favor either of the two candidates for the office.

Senator Bacon is one of the ablest, most respected and oldest in point of service of the senators. It will take only four Progressive votes to put him in office. The move is taken to mean that the Progressives will be recognized as the leaders of what will be the minority after March 4.

Although many of the Progressive senators supported Theodore Roosevelt, many of the Progressives are anxious to be rid of the third party idea. They would like to make the Republican party Progressive. Senator La Follette is recognized as the leader of this element.

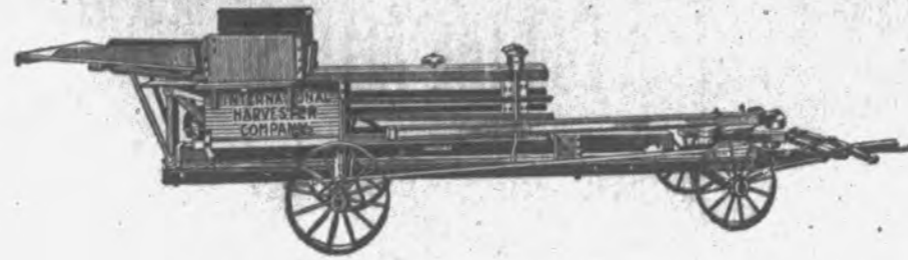

Sir Richard G. Glyn
Sir Richard G. Glyn, who distinguished himself half a century ago as a soldier and explorer, was born in London, Nov. 22, 1831. His education was received at Oxford. In 1852 he joined the Royal Dragoons and two years later fought with his regiment in the famous battles of Balaclava and Inkerman. In 1859 he retired from the army in order to indulge his passion for travel and exploration. In 1863 he led a memorable expedition from Natal to the interior of Africa and was one of the first Europeans after Dr. Livingstone to reach the Victoria Falls of the Zambesi River.
