M'ADOO IS LIKELY TO GET FAVOR OF STATE DEMOCRATS

Carolina Republicans Will Cast First Ballot for Judge Prichard.

TREND OF EVENTS ARE NOW WITH REPUBLICANS

If John Motley Morehead Holds Full Hand, Wood Will Then Get Vote.

Washington, Jan. 20. — Reports to Washington from all sections of North Carolina indicate that the Democrats at the San Francisco convention will support William Gibbs McAdoo for the presidency and the Republicans, on the first ballot, will vote for Judge Jeter C. Pritchard.

After this complimentary ballot is cast the vote of the Republican is to be determined by the hand that controls the State convention. E. Carl Duncan's lukewarm rally to the party during the Hoey-Morehead fight in the Ninth has been interpreted by some as an indication that he will make another effort to get control of the machinery.

Against this possibility is advanced the argument that Morehead, convinced before he entered the race in the Ninth that his election was impossible, only allowed the use of his name in order that he might stand in good grace with the National leaders and once again control the machinery in North Carolina. The Republican hope of success is, proportionately, as buoyant in North Carolina as anywhere, according to visitors coming to the National Capital, and Mr. Morehead in November went in for re-election as National committeeman rather than for election to congress.

If Mr. Morehead and his following control the party, rather than Mr. Duncan and the Republicans of Taft persuasion, the North Carolina vote may be cast for General Leonard Wood, heir apparent to the Roosevelt mantle. If Duncan should succeed in getting control of the party again, it is altogether possible that General Pershing, whose friends have definitely placed him in the race for the Republican nomination, may have the support of the North Carolina delegation.

There are two reasons why Mr. Duncan would favor General Pershing. The first is that Mr. Duncan would be inclined, his friends say, to support a man who went across and had a hand in the fighting where the fighting was in preference to General Wood, whom fate frowned upon and left at home to do some of the training of America's soldiers.

A second reason is that General Pershing seems to be drawing support from the conservative wing of the Republican party. While a poll of members of the house of Representatives shows that a majority of the Republicans prefer Wood, there are members of the party in the lower house who would support General Pershing. Many Republicans from the West, coming to Washington during the past week, have brought news of a growing sentiment for General Pershing out there.

MILD FORM OF INFLUENZA SPREADS THROUGH CHICAGO

Chicago, Jan. 20.—Influenza in mild form continued to spread today at the rate of eleven hundred new cases every 24 hours. All available trained nurses are being mobilized. The total number of cases will exceed four thousand and hospitals are filled. During the last forty-eight hours 2300 cases of influenza have been reported. Deaths now total twenty-six. Nearly four hundred cases of pneumonia with sixty-six deaths have been given out by authorities.

BELIEVES AMERICA AND SOUTH OUGHT TO BE QUITE NEAR

Chairman Payne Urges More Ships to Connect North and South America.

TWO NATIONS SHOULD SHAKE HANDS DAILY

Present Passenger Service Is Limited and Needs Additional Ships.

Washington, Jan. 20.—Affirming his belief that only by ships, and more ships could the United States and South America be brought close enough together to "shake hands daily," Chairman Payne today outlined the plans of the Shipping Board for linking the interests of the Pan-American republics on a chain of great steamers plying between the two continents.

Indicating the American government's keen desire to establish an adequate service to South American ports, Mr. Payne said the Shipping Board's policy "has sometimes manifested itself in an optimism which the cold logic of fact has not justified." Notwithstanding that, he declared the board would proceed with its plans.

In explanation of why fast passenger steamers had not already been put into the South American service, the speaker said the war delayed the building of passenger steamers by creating an abnormal demand for cargo ships and the repatriation of American soldiers had caused the war department to keep in military service many big liners.

"We are building 26 new passenger ships for delivery this spring," Chairman Payne continued. "The War and Navy Departments have turned over to us 27 ex-German passenger ships, but these having been made into troop ships."

Young Women of Training School Hear Dr. Ranson, India Missionary.

SAYS PEOPLE OF INDIA SEARCHING FOR TRUTH

Shows Splendid Opportunities Awaiting Missionaries in that Country.

The Vesper services of the Training School Y. W. C. A. on Sunday evening were unusually interesting. The young women of the school were fortunate in having the opportunity of hearing Dr. Ranson, who has spent six years as a missionary in India, tell the story of his experiences in that country. The Senior Class had charge of the services and furnished attractive special music.

Mr. Ranson began his story with his arrival in India in 1913, when he could not speak a word of the language. His first year was spent learning the language. He told several stories that showed the eagerness of the people of India for the Truth and the progress Christianity is making. The manners and customs of India were especially interesting to the young women. He showed trinkets, idols, prayer-rugs, coins and parts of the costume he wore while in India. He gave as the greatest view of the Hindu, they do not know how to tell the truth and think a white man does not know how to tell a lie.

"The people of India are searching after truth" was the burden of his message. He gave figures proving their increased interest. The number of Bibles and they buy, the way the people are ready to give up things and customs dear to them, and the way they give, all go to prove this interest.

SAYS PROHIBITION ILLEGALLY FORCED UPON NEW JERSEY

Governor Edward, in Inaugural Address, Pledges Effort in Campaign.

PEOPLE SHOULD SURVIVE BY CONDITIONS DUE THEM

Presents Several Instances Where Constitution Has Been Concerned.

Trenton, N. J., Jan. 20.—Governor Edward I. Edwards, democrat, in his inaugural address here today, reiterated his campaign pledges that "he would do every lawful thing to have it determined that the present condition of affairs with respect to prohibition had been illegally forced upon the people of this state." In this connection he made these recommendations:

Enactment by the state legislature, controlled by the republicans, of legislation designed to "assure to our people the right to live under conditions satisfactory to them."

Presentation by the state attorney-general to the United States supreme court of a petition of the State of New Jersey for a decision as to the legality of the ratification of the Eighteenth Amendment to the federal Constitution and as to whether prohibition is a proper subject for legislation by amendment to the Constitution, "because of the grave doubt existing."

Message by the state legislature of a resolution refusing to ratify or accept the federal prohibition amendment.

"My policy on this subject no doubt will provoke from some the criticism that I am flaunting the Constitution of the United States," he said. "I yield to no one in my respect and regard for that declaration of our rights and liberties. But I am strong in my conviction that the rights of New Jersey as a sovereign state are being trampled upon."

ALLEN FORTUNATE IN SECURING GOOD HOUSE IN WILSON

Former Man of this Place Succeeds in Buying one From Housing Corporation.

The following clipping taken from the Wilson Times, will be of interest to the many friends of Mr. H. L. Allen, who a few weeks ago resigned as superintendent of the water and light plant, in this city, to accept a similar position in Wilson. It also shows the real work that the Home Housing Corporation can do in a town or city. Residents in Greenville are, on account of the shortage of houses, living in stores and warehouses. People are writing each day and inquiring about houses, in this city, and on account of the shortage they are having to go elsewhere. The Home Building and Loan Association has done much to relieve the situation and is still doing all possible to help, but the conditions still exist. Anyone desiring to be of real service to their town could do nothing better than have a few houses built and help in this crisis. The clipping follows:

"Mr. H. L. Allen, superintendent of the light and water plants has purchased a home in our town, one of the new houses recently built by the Home Housing Corporation at a cost of \$7,500. But for the Home Housing Corporation, Mr. Allen could not have brought his family here and it is just possible that the capable manager of four public utilities recently from Greenville might not have been able to secure such living conditions as would have suited him on account of the congestion, and Wilson therefore might have found difficulty in retaining him in her employ. How far these things effect are never known. The truth of the matter is there is very little to life any way aside from the comfortable and happy home."

BOSTON TO ALTER FAVORED HISTORIC FEATURES OF CITY

Small Strips to be Sliced from Common to Meet Present Demands.

OPPOSITION DONE AWAY WITHIN MANY SECTIONS

Common Society and Street Committee Agree After Great Opposition.

Boston, Jan. 20.—Boston is preparing to alter some of its most cherished historic features to meet the demands of modern conditions. Small strips are to be sliced from Boston Common, training ground for troops in Revolutionary days, and arched of the tower of the Old South Meeting House, where the famous "tea party" was hatched, is contemplated. Traffic problems, acute in this city of narrow "cow-lane" streets, in each case are responsible.

The paring of the Common on two sides of its 43-acre area has been sanctioned only after the overcoming of long-standing opposition by those who held that no considerations of modern development should disturb this revolutionary landmark and present day breathing space in the city's center. Several years ago the voters turned down a proposal to shrink the Common in order to swell the streets. But in the recent city election the voters in all but two wards declared in favor of widening the streets from Common lands. The two wards which opposed the plan are in Charlestown, east of another historic shrine, Bunker Hill Monument.

Under the plan, which is a compromise arranged between the street commissioners and the Boston Common Society, Tremont and Boylston streets, which bound the Common on two of its sides, will be widened.

ALASKA FEATURES IN RAINE'S FIRST APPEARANCE HERE

Noted Traveler Gives Graphic Account of Conditions in that Territory.

A large crowd attended the "Travelogue on Alaska," which was given by Mr. Edgar C. Raine, at the Training School, last evening.

The pictures were beautiful in coloring and clear, and gave a fine idea of that interesting territory. After a brief introduction, giving some idea of the region, Mr. Raine showed the pictures, starting from Seattle on the "Victoria" and at the close of the lecture returned to the same place.

He gave his experiences in the various places as he showed the pictures. His audience followed over frozen trails, along streams, into mining towns among the Eskimos, and always were surprised at the signs of civilization and vegetation. He explained the cause of the wonderful vegetables and grain crops: during the growing season there is no retardation, as there is day light practically all the time.

Mr. Raine seemed thoroughly familiar with every section of Alaska, and said that he could spend a week telling his experiences in certain regions.

The audience was highly entertained for about an hour and a half.

BOLSHEVIKI TROOPS TAKE GREATER PART OF SIBERIA

Paris, Jan. 20.—Bolshevik troops occupy all territory in Siberia, west of Krasnyarsk, from which they have driven Kolchak's forces, according to latest dispatches received here. Kolchak units are reported retreating eastward.

ADMIRAL SIMS TO BE QUESTIONED ON RECENT CRITICISM

Daniels Enters Denial of Criticisms Brought Forward During Week.

SIMS WILL BE FORCED TO MAKE GOOD EARLY

Senate Sub-Committee Will Investigate Lack of Co-Operation of Navy.

Washington, Jan. 20.—Charges of Rear Admiral Sims that the Navy Department failed to co-operate fully with the allies during the great war will be investigated by the Senate sub-committee before which they were made.

This was decided today by the full naval committee which also authorized appointment of another sub-committee to determine whether there should be an inquiry into charges made by John R. Rathom, editor of the Providence (R. I.) Journal, that with the knowledge of Secretary Daniels "many seamen in the navy have been used for most vile and nameless practices in order to entrap innocent men."

While the Senate committee was in session, Secretary Daniels announced that Admiral Sims would be called on to make good his charges either before the senate or a naval board.

Simultaneously, Chairman Butler of the house naval committee, announced that Major General Leonard Wood would be called before that committee to explain statements attributed to him that American naval vessels were "floating death traps."

General Wood explained at Portland, Maine today that what he said was that naval ships manned by untrained crews would be death traps in battle.

Inquiry into Admiral Sims' charges will not be started by the Senate sub-committee until its present investigation of naval decorations is completed which probably will be within few days. That investigation was continued today with Admiral Sims concluding his testimony. Rear Admiral Mayo, commander in chief of the Atlanta fleet during the war, will be called tomorrow.

The full naval committee took up telegrams sent to Senator Lodge and other members by Mr. Rathom charging immoral conditions in the navy and it authorized Chairman Page to appoint a sub-committee to make a preliminary inquiry to develop whether an investigation was warranted.

Secretary Daniels declined to comment on Mr. Rathom's charges, declaring that he did not desire to make a statement until he was more familiar with the allegations. Assistant Secretary Roosevelt, who was said by Mr. Daniels to be more familiar with the matter, asserted that the special board of inquiry appointed by the Judge Advocate General of the navy two weeks ago had full authority to investigate the methods employed by naval intelligence officers in securing evidence against persons under suspicion of moral delinquency and to inquire into all judicial procedure of the navy at Newport.

Secretary Daniels also declined to discuss the assertions attributed to General Wood, saying that if anyone wished to "put him on oath and let him tell what he knew about the navy he might be called before the committee and he can explain his expert knowledge."

DEPORTED RUSSIANS GIVEN OFFICIAL RECEPTION TODAY

Terijoki, Jan. 20.—Russian deported from the United States were given what might be termed an official reception just outside this village today. In the crowd that greeted Alexander Berkman and Emma Goldman and their "comrades" was M. Zorin, a member of All-Soviets executive committee who, after a brief conference with Berkman, agreed to let whole party enter Bolshevik Russia.

QUESTION NO. 26.

What Pitt county newspaper has for thirty-eight years kept its shoulder to the wheel, always doing its best to push Greenville and Pitt county to the front, aligning itself with every movement that meant progress and prosperity? Ask R. C. Flanagan.

Prices have advanced to such a great extent that people no longer question whether dealers are profiteering.

If prohibition laws are not being enforced in this immediate territory we are at a loss where to find out the meaning of the word "dry."

If that delegation from Chowan College gives Greenville proper consideration, then, the city will certainly be a successful contestant for the school.

The senate will again make another effort for bringing about an agreement in the peace treaty controversy, and still there's a possibility that the unexpected may happen.

Approximately \$2,000,000 worth of whiskey has been transported to Havana, Cuba, which should cause the census taker to not become discouraged.

Senator Borah thinks that in quizzing General Wood he make get some new material for future battles against the league of nations. No doubt the senator is right, too.

That report stating that the British steamer Yarmouth, bound for Cuba with a cargo of whiskey, is sinking, probably makes many a thirty fellow wish he could go down with the ship.

Finnish White Guards escorting undesirable Reds from the United States across the Russian border evidently think they have undertaken an extraordinary job. And judging from sentiment, they have.

The sudden manner in which chief executives are being "swapped" around in France causes one to believe political circles of that country are experiencing some little uncertainty for the future.

The government has started another campaign against profiteers. This time excessive rent promoters are in the line of action, but if they get by as easily as other profiteers they have little need for worry.

Listing personal property under the revaluation measure certainly will produce a new sensation in this state. And more money will be donated to the commonwealth's "coffers" as a result.

Congress probably will have its hands filled in dealing with Russian propaganda in this county, if recent reports concerning Russian activities are true. However, we can never count on developments in such efforts until they are presented to the public in indisputable form.

THE STATE'S WHEAT CROP.

There have been many rough estimates presented in sections of the state regarding the production of wheat throughout the entire state for the present season, but owing to the lack of definiteness in several instances complete reports have not been available. However a statement has just been issued which gives a pretty accurate account of wheat production, showing that in all something near five million bushels have been raised up to the present date. The figures will no doubt prove of great interest to our many readers who have been waiting for something authentic concerning the production for the past year, and therefore, we quote the following extracts from an article which may be considered as near correct as possible:

Incomplete reports from wheat threshers to the State Department of Agriculture as required by the law of 1919 indicate that Henry A. Page's figures of the total wheat crop in North Carolina presented to the United States Grain Corporation during the war in order to prevent the Federal government's calling on to export three million bushels of wheat which it did not have, are nearer correct than those of the State and Federal crop reporters.

Mr. Page thought about four to four and a half million bushels would be all the wheat ever grown in the State in one year; Commissioner of Agriculture Graham made estimates of the 1917 crop at ten million and 1918 at thirteen million, later revising the 1918 crop and bringing it down in the neighborhood of the 1917 crop.

It is too early to say just what the 1919 crop will total; but sufficient reports have been received to show that it will be nothing like ten million bushels, and, in fact, will do well to go over five million.

Randolph county leads the list—not the first time, as either this county or Davidson is always first in the amount of wheat grown,—with 262,508 bushels; Davidson is second with 257,244; Forsyth third, 166,884; Guilford, 153,075; Stokes, 110,433; Stanly, 109,663; Lincoln, 92,043; Buncombe, 80,671; Chatham 71,167; Wake, with a few threshers yet to hear from has reported in the rise of 28,000 bushels.

This total will run very little over a million bushels and there are left few counties of considerable yields to hear from.

Assuming, and it is a safe assumption, that more will approach the yields of Randolph and Davidson closer than has Forsyth and Guilford, there are missing from a list of the real producers only about fifteen counties. But, conceding that these counties of Yadkin, Surry, Alamance, Rowan, Davie, Montgomery, Iredell, Watauga, Caswell, Catawba, Burke, McDowell, Wilkes, Rutherford, Haywood, Alleghany, Alexander and Ashe could all average a trifle better than Buncombe of Lincoln, and that the whole twenty of them produced a hundred thousand bushels each, there would be raised in the counties which lay some claim to wheat-growing only approximately three million bushels.

BRYAN ON PROFITEERING.

Profiteering and public ownership, according to William Jennings Bryan, are going to be two of the greatest issues of the approaching presidential campaign, and as he has taken an active interest in the development of both issues a recent statement from him will be read with a degree of interest by people who have been following his endeavors for the past several months. In discussing the two questions, Mr. Bryan says:

Profiteering and public ownership were declared tonight by William Jennings Bryan to be two of the great issues on which the coming presidential campaign should be fought. Mr. Bryan, who was a guest of honor at a dinner given by the Society of Arts and Sciences, asserted that the peace treaty cannot be carried into the campaign because of the large number of important domestic questions to be decided.

In reference to profiteering, which he termed "the darkest blot on this war," the speaker advocated the creation of trade commissions in the states and communities before which citizens could bring complaints against profiteering merchants.

"While the boys bled abroad," he

said, "the American people were bled at home by conscienceless profiteers. Even when the bleeding stopped abroad it continued at home. The tax records show how many more millionaires have been created in this country."

Mr. Bryan denounced the coal operators for the excessive profits, which he said they had made last year, and declared that the people must be given machinery by which to protect themselves.

"The people cannot take a club" he said. "The government that disarms its citizens must assume the duty to protect them. There are tribunals in this country where the merchant can summon his customer, but no tribunal where a customer can call a merchant to answer any complaint. What is needed is trade commissions for the Nation and the states and in every community where every citizen, no matter how humble, can have his complaint

heard." Mr. Bryan reiterated his ideas in regard to the peace treaty, which he expressed at the Jackson Day dinner in Washington. He maintained that the United States Senate "must cease its wrangling" and settle the matter immediately. Both sides should make concessions, he declared, the Republicans withdrawing their preamble "and let acceptance be by acquiescence." In regard to the Democratic attitude he declared that the importance of the much-debated article X was very much exaggerated.

Senator Lodge has been angered by Senator Hitchcock's address in the senate in behalf of the peace treaty, and has assumed an attitude of belligerency against it. The change, however, hasn't unnerved anyone, and conciliatory measures may be as possible now as heretofore.

According to Elihu Root, America's promises to help Russia have not been fulfilled. Which goes to show that the gentlemen has forgot how many promises have been carried out, particularly in the certain portions of Russia where little help was deserved.

Automobile speeders who are given severe fines in Mayor's court and take an appeal to higher sources of jurisdiction should get everything coming to them if supreme court action is necessary. This kind of business soon will bring people around to view the matter in a sane kind of way.

Asheville, so it is said, is preparing to stage a full fledged automobile show. It is to be hoped that "showing" will constitute activities of the event and racing around the mountain sides be eliminated.

Think of the proposed extradition of the former Kaiser of Germany producing deep emotion in Holland: One might as well picture an American ter-rapin "laffin" at the misfortune of a whale.

Expulsion of foreign-born agitators should be one of the greatest desires in this country, for there are enough home-born dissension promoters to keep everything from undergoing a complete state of lethargy.

General Wood appears to think the United States is in need of a larger navy, for in an address before American Legion members several days ago he declared the present one is nothing more than a "death trap." Surely General Wood ought to know what he's talking about his experience has been of such a varied nature.

**Federal Board
Makes New
Plans**

Atlanta, Ga., Jan. 19.—Bringing Central office authority to the District office is the latest plan devised by the Federal Board to speed up its work and to eliminate red-tape in providing vocational training for disabled veterans. A representative of the central office clothed with full authority is now at headquarters here, passing upon the eligibility for training of such men as have recently made application. Instructions from Central Office would still necessitate forwarding recommendations to Washington for approval if the Federal Board had not hit upon this plan of "Bringing the Mountain to Mahomet."

According to instructions Dr. C. G. Shulz, District Vocational officer of the Fifth District, is authorized to put into immediate training every man whose eligibility has been determined by the central office representative, and so enable veterans to get immediate attention to their claims for training.

Instructions eliminating "Red-tape Methods" also authorized the District Vocational Office to place men in training for such a period of time as is necessary to insure entry into lucrative and satisfactory employment, provided this training does not require more than two years. Special provision is made for cases that require a longer time.

There are some 12,136 veterans in the Fifth District for whom vocational training is almost immediately available under the new regulations. There are 11,507 men in this district who have not manifested a desire for vocational training, but who will be entitled to it, provided they bring their claims to the attention of the board. There are more than 1,300 men now in training in educational institutions, and in shops in the fifth district. It is the desire of board officials to get positions for every available man in training as quickly as possible.

Attention is called to the fact that no decision as to eligibility can be rendered unless the case shows:

That the man has a physical or mental disability permanent or temporary.

That his physical or mental disability was incurred, increased or aggravated by service or is traceable to service as substantiated by extracts from official army or navy records.

That his physical or mental disability constitutes a major vocational handicap in the case of section 2 training; or, in the case of section 3 training, that he was disabled under circumstances entitling him to compensation after discharge from the military or naval forces of the United States.

That the man has resigned or has been discharged or furloughed under honorable conditions since April 7, 1917.

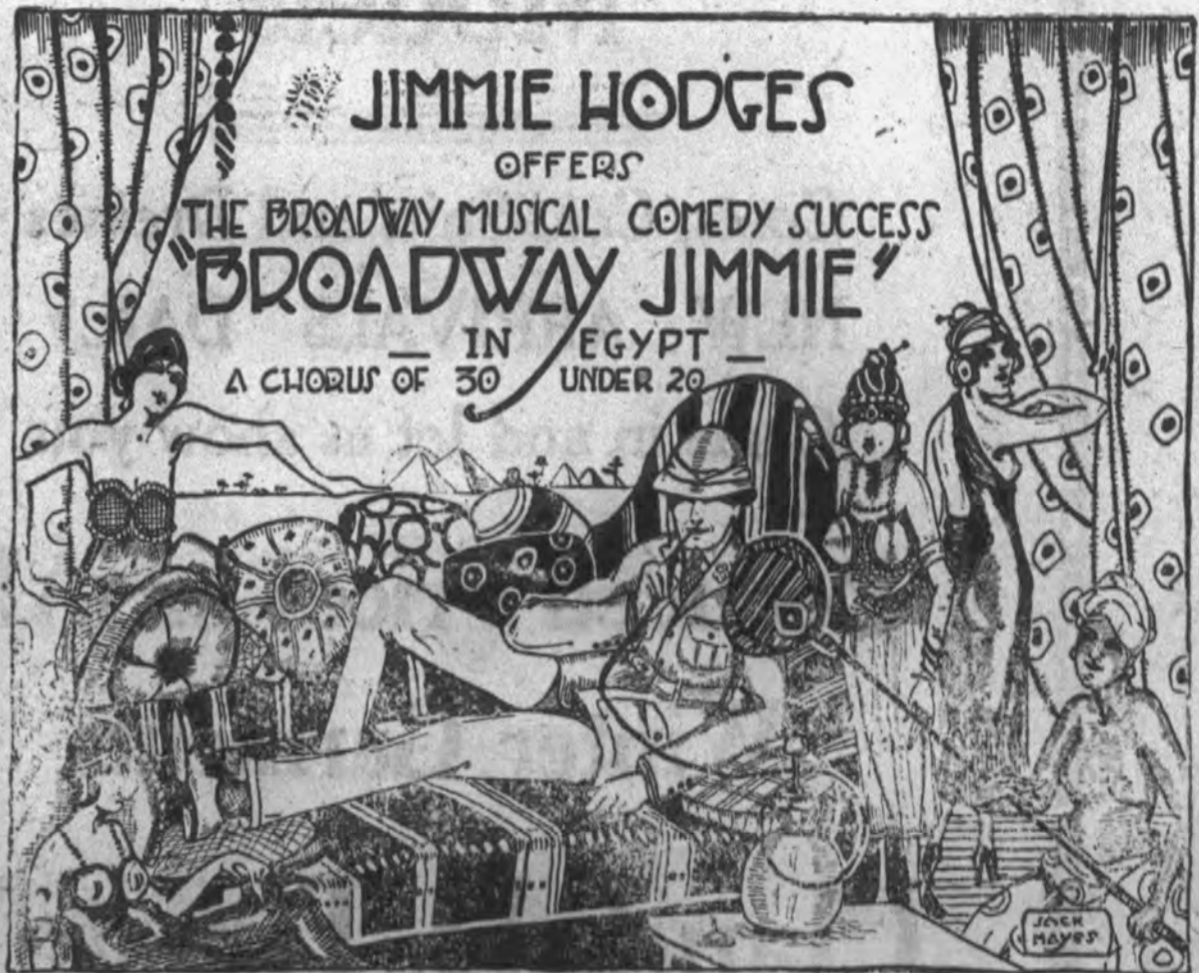

a sovereign state under the constitution have been invaded, and I insist it is my sworn duty to have it definitely established in a legal manner by the duly constituted authorities whether this is so or not. Whatever criticism come, I will not abandon my position that our rights have been infringed until otherwise determined by the courts."
He declared the power of the states to regulate their purely internal affairs by such laws as seem wise to the local authorities "is inherent and has never been surrendered to the national government."
"I might point out that the language of the so-called Eighteenth Amendment is unique in this respect," he said, "inasmuch as there is reserved to the several state concurrent power to legislate upon the enforcement thereof. For the first time in our history such language makes its appearance in the Federal constitution. Its presence there is not the result of accident or idle thought, but rather indicative, if the amendment is ratified at all, of the intention on the part of the several states to require their concurrence, at least as to intra-state commerce in any proposed Federal legislation concerning intoxicating beverages. In that view I am supported by counsel."
Other recommendations included ratification of the federal woman suffrage amendment; floatation of a bond issue for the construction of the proposed vehicular tunnel between New York and New Jersey and a bridge connecting Philadelphia and Camden.

sides, will be widened to a maximum of 43 feet instead of 50 to 60 feet as first proposed. This will be accomplished without sacrifice of greensward or trees, as the cuts will be made from the broad malls of the Common. The compromise plan carried with it an agreement that no further invasion of the Common would be made.
Boston Common was bought in 1634 by Governor Winthrop and others as a common cow pasture and training ground, and was one of several such tracts of communal lands and planting grounds. Today it is the sole remainder of these ancient commons, other holdings having passed into private hands.
It was on Boston Common that revolutionary soldiers drilled, from its limits at Park Square, then the Back Bay in fact as well as in name and now "made land," the British started for Lexington on April 19, 1775. On the Common the British mustered their forces to attack Bunker Hill and British artillerymen set their guns on Flagstaff Hill during the siege of Boston. Colonial expeditions set out against Louisburg and Quebec from the old Common, and Massachusetts regiments assembled there prior to going to the front in the Civil War.

ships, are not in condition to be used for a passenger service until reconditioned. The first of these is the Moccasin now on its way to South America, and will be followed by other and larger ships as fast as they can be made ready for service.

"Our present plans for the passenger service to the East Coast of South America are:

"Five steamers, maintaining a two-weekly service between New York, Rio de Janeiro, Santos, Montevideo and Buenos Aires.

"South-bound, these vessels will proceed directly to Rio de Janeiro. The five vessels selected for this service are all ex-German steamers of 15 knots speed. The Aeolus, Huron, Pocahontas, DeKalb and Princess Matoka." Mr. Payne said three of these would be ready for service in April or May. All will be converted to burn fuel oil. Their accommodations will be first-class and part of their cargo holds will be refrigerated to care for the movement of perishable products.
