

## FOSTER DECLARED PRINCIPAL LEADER IN RAILWAY STRIKE

Radical Leader of Steel Strike Said to be Promoting "Outlaw" Strike.

WILSON WILL INFORM WORKERS OF SITUATION

Government to Await Attitude of Workmen Before Taking in Decisive Action.

Washington, April 14.—Department of Justice investigators report that evidence in their possession proves that William Z. Foster, leader of the steel strike, is the prime mover behind the "outlaw" railroad strike.

The government let this be known tonight, feeling that when the strikers learn what influences are behind the movement they will align themselves with their recognized organizations. Action by the government in the direction of prosecution of strike leaders, therefore, will be held in abeyance, pending the expected reaction among the strikers on receipt of information showing the directing impulse of the strike agitation.

The evidence in the hands of Attorney General Palmer shows that Foster was present at union meetings which were adjourned to meet in other halls, not as organizations, but as individuals. Mr. Palmer also said that Carl Pierson and A. E. Reese, both of whom the department's investigators have placed in the category with Foster, were engaged in attempts to expand the strike and were definitely connected with planning it. Both began this work in Chicago, Mr. Palmer said.

As this phase of the situation became known, President Wilson met this cabinet for the first time since last August. The whole story of the strike crisis was related and it was understood a decision was then reached to seek a solution through the publication of the motives behind the walkout, the strikers being assured at the same time of early consideration of any wage demands they may have by the railway labor board.

This must not be construed to mean the government has adopted a policy of hands off, it was said, but rather that officials believed the time has not arrived for direct governmental action.

The senate did not confirm today the nomination to the labor board. They were considered in executive session and the President's selection brought sharp criticism in some cases, it was understood.

## ONLY THREE CASES SETTLED IN COURT DURING YESTERDAY

Compromise Action Taken in Case of Walter Barfield vs. Cannon Estate.

TWO OTHER CASES ARE FAVORABLY CONCLUDED

Several Other Cases on Docket for Disposition Remainder of Week.

Compromise proceedings were taken in the case of Walter Barfield vs. W. T. Cannon in yesterday evening's session of the civil term of Pitt county superior court shortly before the controversy would have been turned over to the jury for final consideration. The agreement came about after several hours had been consumed in examination of witnesses and argument by legal representatives appearing in behalf of defense, and provided that the plaintiff should receive one-third of the proceeds derived from the sale of land in controversy valued at \$2500, the remaining two thirds to be turned over to Mr. Titus Dall, of Ayden, guardian of the two children of Mr. and Mrs. W. T. Cannon, deceased.

There were only two other cases receiving final disposition in yesterday's session as greater part of the day was taken up in final completion of the above case. In the case of Joseph F. Staton and wife Ida Staton vs. T. M. Hooker, W. A. Teel and the town of Greenville, all matters in controversy were announced fully paid, satisfied and adjusted by the court, with terms of agreement appearing satisfactory to all parties involved. W. J. Stubbs was given judgment of \$75 in suit for \$400 against H. McClellan, the suit growing of charges by the plaintiff that the defendant held a number of his tools.

## FEDERAL BOARD TO REDUCE HIGH COST OF DISTRIBUTIONS

Federal Trade Commission Plans to Cut Living Cost in Direct Manner.

INCREASE IN MARKETING FACILITIES ARE ADVISED

Elimination of Unnecessary Costs in Distribution to Feature in Plans.

Washington, April 14.—Declaring that the costs of food distribution are too great, the federal trade commission today recommended improved marketing facilities and processes at the great consuming centers as a long step towards lowering the high cost of living.

"The movement of food should be most direct from field to factory," the commission declared in a report on wholesale marketing of food, one of the series in the food price investigations ordered by the President.

Elimination of unnecessary costs and losses in food distribution, the report added, would not only "act as a counter agent in checking disparity in food prices and money incomes, but would strengthen the nation's position in its competition for world trade."

The report asserts that the rapid rise in food prices in recent years is not so significant as "that the money incomes of large numbers have fallen far short of a proportional increase."

The weekly wage of union organized labor in 1918 bought but 77 per cent (according to the department of labor) as much food as in 1913. The larger number of service incomes do not fall within this organized group and are much slower to respond to the pressure of a higher cost of living. Moreover, these incomes are for the same reason usually less in amount.

## BAD SHIPMENT OF OLIVES CONDEMNED BY FEDERAL COURT

Shipment of Poisoned Olives Condemned and Destroyed in Milwaukee.

GOVERNMENT ALLEGED OLIVES WERE PUTRID

Investigations Show Defects in Pickling and Packing Before Shipping.

Washington, D. C., April 15.—A shipment of ripe olives rendered poisonous by bacteria which was seized in Milwaukee, Wis., on information furnished by the Bureau of Chemistry, United States Department of Agriculture, has been condemned and destroyed by order of the court, according to a statement issued today by officials of that bureau charged with the enforcement of the Federal Food and Drugs Act. The olives were in glass containers and labeled as "Supreme Curtis Quality California Ripe Olives packed by the Curtis Corporation, Long Beach, California."

The government alleged in the libel that the olives were adulterated for the reason that they consisted in whole or in part of a filthy, decomposed, and putrid vegetable substance. Examination by the bureau of chemistry of samples from the shipment showed that rotten pigs fed from three of the bottles died, indicating the presence of toxins due to decomposition of the olives by bacteria which were later identified as bacillus botulinus. Olives similarly infected were responsible for the death of several people within recent months in Canton, Detroit, Brooklyn, Memphis and elsewhere.

Investigations by the bureau of chemistry have shown that defects in the methods of pickling, packing and processing.

## RALEIGH CITIZENS PLAN TO ORGANIZE AN OVERALL CLUB

Movement on Foot for Cutting High Cost of Living in Capitol City.

Raleigh, N. C., April 15.—Originating with the Seaboard Air Line Shop employees, the Overall Club is being organized now in Raleigh and already a number of overalled citizens have made their appearance on the street. Mr. C. S. Massey, of the Seaboard, is promoting the organization among the workers while, apparently, it is spreading elsewhere without promotion.

A good pair of overalls, it is stated here, costs \$3.50 with the same amount for the jumper, and Raleigh merchants elsewhere without promotion.

"The trouble with the market today," said one leading clothier, "is under production. The danger of the overall movement, if it attains any general proportions, will be that the demands for overalls will so greatly exceed the supply that they will jump, and the fellow who will suffer will not be the business man or the workman who has joined the overall movement, but the fellow who wears overalls as a necessity."

Yesterday afternoon, the overall movement was the topic of conversation in the city building. Commissioner Gustafson, Sewing Machine Co. representative, Mooneyham, Tax Clerk Ed. Hugh Lee, City Clerk Willard Dowell, and several others who dropped on an informal conference voted for overalls, and Mayor Eldridge coming in on the heels of the discussion joined the majority.

## HENDERSON WOMEN LEADING STATE IN DOMESTIC WELFARE

First "Housekeepers Week" of State Brought to Splendid Conclusion.

Henderson, N. C., April 15.—Has set the pace for other places with a week devoted to the interests of the housewife, having just brought to a successful conclusion the first "Housekeepers Week" ever held in the state.

Through the efforts of the Home Demonstration Agent, Mrs. J. K. Plummer, the District Agent, Mrs. Morris, the Henderson Chamber of Commerce, and County Agent Anthony, the importance of the business of being a housewife was officially recognized in a program of events that aroused interest among town and county folks for miles around Henderson.

In the rooms of the Chamber of Commerce, demonstrations of muscadine grape products, butter making, cooking meats, sewing and making hats were given. Around the sides of the room were arranged all the latest devices for making the home more convenient, from a folding ironing board to refrigerators and cooking stoves, all of which were loaned for the week by local merchants.

Speakers from out of town included Mrs. Jane S. McKimmon, State Home Demonstration Agent, and Messrs. Arey and Kimrey of the Raleigh Dairy office of the Extension Service. The morning and afternoon sessions were well attended by both town and county, housewives, and several merchants sat through the demonstrations and learned how the things they sold were utilized in housekeeping. The last day of the week was given over to a demonstration of power plants for farms, three companies being represented with their home power and light equipments.

## NEW YORK STRIKE LEADERS READY TO ACCEPT PROPOSAL

Strikers' Chairman Says Men Are Ready to Let Labor Board Settle Disputes

VOLUNTEERS EAGER TO PRESENT SUBSTITUTES

Conditions Approaching Normal in New York and Districts of West.

New York, April 14.—The first overtures of peace on the part of striking railroad workers, who have disorganized the railroad transportation facilities of New York and northern New Jersey, came tonight when Edward McHugh, chairman of the strikers' committee, gave out a statement that "now that the railroad labor board has been appointed we desire to avail ourselves of the opportunity provided by it for a consideration of our grievances."

Restoration of passenger train service on the principal railroads into New York made headway tonight.

The rush of volunteer students and business men eager to substitute for the strikers apparently has had an impressive effect on the strikers. Their defiant attitude toward the railroads was reported to have undergone a change following optimistic reports of the movement of trains without their assistance.

Ferry boats plying the Hudson river from Manhattan to the Jersey terminals were able to handle the heavy traffic increased by the shutdown of the Hudson tubes. Extra boats have been pressed into service.

Lehigh Valley railroad officials announced tonight that through passenger service from the Pennsylvania station is being maintained without interference or delay. Word also was received today from Wilkes-Barre, Azleton and Sayre, Pa., that members of the four brotherhoods in these important division points, the center of the anthracite region, had voted not to strike and to remain loyal to the company. President E. B. Loomis was informed by Lehigh University today that the student body, including members of the graduating classes in all branches of engineering work, had offered their services for any emergency.

Conditions in the Grand Central terminal late today more nearly approached normal than during any period of the strike. The only train that had to be annualled was the Springfield Express over the New York, New Haven and Hartford railroad. Recent delays in other trains were cut from ten to fifteen minutes.

More than five thousand students at Columbia University, it was announced tonight, "are ready to act in any way the railroad managers and brotherhood chiefs might determine." A large mass meeting was held by the students to plan how best they could aid in bringing food supplies into New York. Dr. Richard Derby, son-in-law of the late Colonel Theodore Roosevelt, "fired" the Oyster Bay express into Jamaica this afternoon, having volunteered when another amateur fireman, gave out.

In one Georgia town the preachers have announced that they will wear overalls in the pulpit.

It looks like Pitt county is going to have some good men to vote for on the legislative ticket.

Looks like they are going back to another war in Europe. That might have been expected after the United States' action on the peace treaty.

When we all get to wearing them there may also be a cry as to the high price of overalls. But they cannot cost as much as a suit of clothes.

The country goes right on trying business he paralyzed with railroad strikes, when there ought to be legislation as will make strikes impossible.

Whether they look at it in that light or not, the striking railroad employees are pursuing just the course that will ultimately put them out of a job. They are arousing throughout the country a greater interest in good roads over which freight can be hauled by motor trucks. When these come into general use, as they will some day, there will be less dependence on railroad transportation.

Greenville will never come up to her opportunities until there is a return to using Tar river as a means of freight transportation. With a river right by her door that can be made navigable the year round, our business interests go right on paying enormous freight charges to the railroads when they might save thousands of dollars annually by using the river. A boat or large line is the thing to have.

### THE TRADE CONFERENCE.

Special group sessions devoted to various aspects of the development of foreign trade will occupy an important part of the program of the Seventh National Foreign Trade Convention at San Francisco, May 12-15, according to announcement made by O. K. Davis, Secretary of the National Foreign Trade Council, under whose auspices the convention will be held. In connection with the exhibit side of the forthcoming convention, Mr. Davis has arranged for an exhibition of industrial motion-picture films, suitable for use in foreign trade advertising to be given on Tuesday night, May 11th, preceding the formal opening of the convention on Wednesday morning, May 12th. The various types of films will be shown, portraying the up-to-date methods used by many leading American business firms in expanding their foreign business.

Among the speakers announced for the various group sessions, may be named Dr. Ernest L. Bogart of the University of Illinois, who will speak before the Educational Group Session on the topic "Teaching of Economics." "Financing Foreign Trade" will be the topic discussed by the second group session, under the auspices of American Bankers Association. John Gardin, of the International Banking Corporation, will speak at this session on the question, "Financing Through Credits and Investments." "The Webb Law" in Operation" will occupy a group session.

"Direct Selling" will be the topic for fourth group session, the speakers of which will include W. L. Saunders, President of the American Manufacturers Export Association, whose topic will be "Why Direct Selling?" Frank Noxon, Secretary of the Railroad Business Association, on "Foreign Trade and Railroad Equipment," and Burwell S. Cutler, former Chief of the Bureau of Foreign and Domestic Commerce, on "International Barter Under Adverse Exchange."

### INCREASED CORN ACREAGE.

It is stated that the weakest crop grown on Southern farms is the corn crop, which in total value comes next to cotton. The total value of the corn crop last year was \$845,000,000, yet only two states of the Southern group produced a yield of more than twenty bushels an acre. Mississippi, Alabama, Florida and Georgia averaged less than fifteen. Virginia averaged 28, North Carolina 19 and South Carolina 16 bushels an acre.

The situation is a little difficult to understand when we remember along with these low figures that the south has the record for corn yield per acre, and boasts of a large number of records of more than two hundred bushels an acre.

The low average per acre, it must be remembered, includes a large number of acres and probably farms, where the yield is less than half of fifteen.

Why plant such lands in corn? A twenty bushel-an-acre should be the irreducible minimum of every acre. If the land will not make this much, then turn it over entirely to the cowpea, soy bean and velvet bean. Let legumes

have a chance, rather than waste labor on a hopeless task.

Assuming that good judgment has been displayed in the selection and testing of seed, the next consideration should be good land and proper tillage. The tillage of the soil cannot be too good for corn. The land should be fine, mellow and moist, and should be free from weeds. Corn will not make a crop in either clods or grass. Fix the land right before you plant, and then so cultivate it as to keep it like you fix it until the crop is made. The cultivation should not be deep enough to injure the roots of the crop. It should be frequent and shallow.

In possession and failed to make delivery. Testimony on both sides was forceful, but lack of evidence failed to bring about judgment for the total amount involved in the dispute.

The Barfield vs. Cannon case recently was instituted through claims of the defendant that he deserved some compensation for services rendered Mr. and Mrs. W. T. Cannon, who before their death, were in a feeble state of health and required someone to look out after the piece of land in dispute. No provisions made for Mr. Barfield in the will of the deceased, the suit later being precipitated through a desire for adequate compensation improvements to the land and for services to the deceased. Witnesses for the plaintiff considerably strengthened evidence first produced, showing plainly that compensation was deserved.

Several more cases are still on docket for consideration before the present session of civil court is concluded, and much interest is centered upon them. Criminal court will open next week with a pretty full docket, so it is hoped by the court that the civil docket may be completely cleared before criminal work is taken up.

It follows that for a very large number of people receiving relatively small incomes, a week's wage in 1918 was purchasing much less than 77 per cent of the food it bought in 1913.

"Food absorbs 28.2 per cent of the average American household's income. It therefore constitutes no inconsiderable part of the wage and salary cost in all production. Of two communities who produce the same markets otherwise equally, that one which supplies its working people with food at a lower community cost will pay its workers a higher real wage or will have a marked advantage in underselling the other through lower production costs. Both results may in some measure follow.

"A wise governmental policy towards the food industries may lower production and distribution costs together with the final sales price without proportionately increasing governmental costs, thus reducing the national cost of food."

cessing ripe olives are responsible for widespread infection with bacteria. olives in weak brine for weeks and The practice of shipping and holding sometimes for months permits fermentation and generalized infection of the olives with many kinds of bacteria. Olives after this treatment are much more difficult to sterilize than those fresh from the tree and handled at once. As a result there is occasional failure on the part of the packer to heat the

containers to a sufficiently high temperature to destroy all dangerous bacteria that may be on the olives.


The failure to sterilize properly is more likely to occur when glass containers are used, probably because of the fear that a higher temperature.

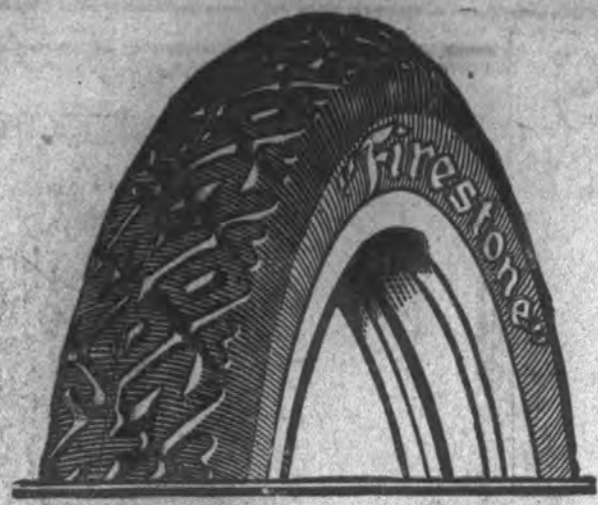

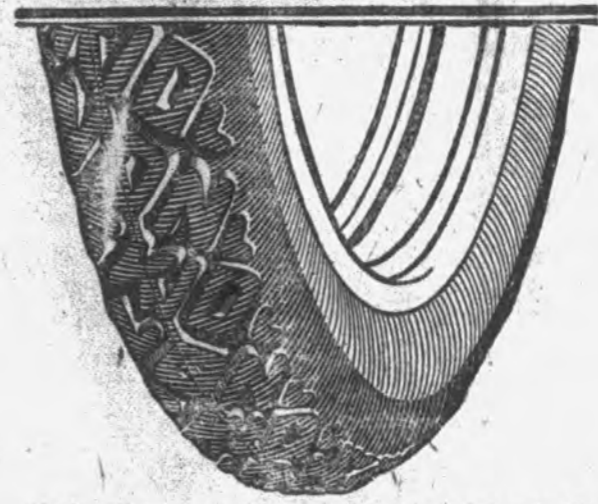
