

PREDICTS WOMAN SUFFRAGE WILL BE DELAYED ONE YEAR

Tennessee Constitutional League Members Send Message to Governors INJUNCTION MAY BE CARRIED TO SUPREME COURT FOR DECISION Suffragists Forces Still Consider Things Satisfactory in Every Way.

Nashville, Aug. 23.—Under an amended bill the Tennessee House this morning defeated the Walker motion to reconsider ratification of the suffrage amendment without a quorum.

Nashville, Tenn., Aug. 22.—Governor Roberts, in a formal statement tonight, declared he had been informed by Attorney General Frank M. Thompson that the action of the two houses of the legislature constitutes a ratification of the amendment.

"I will exercise and bring to bear all the legal and legitimate powers of the office of growing to consummate in an orderly and legal manner the certification of the action of the legislature to the proper Federal officials," he declared.

Nashville, Tenn., Aug. 22.—From the snarl of legal and legislative technicalities that have enmeshed Tennessee's ratification of the Federal suffrage amendment, tonight came the prediction of the Tennessee Constitutional League that the injunction against certification or ratification, obtained yesterday, would prevent enfranchisement of the women of the nation for at least a year and a half.

The Constitutional League, which has been fighting ratification in Tennessee on the ground that the State constitution prohibition the present legislature from acting on the suffrage amendment and which claims to include both suffrage opponents and advocates in its membership, made its prediction in a message addressed to the governors of Vermont, Connecticut, Florida, Alabama, Louisiana, Delaware and South Carolina.

TENNESSEE SOLONS ASK MASS MEETING TO FORM SENTIMENT

Decatur, Ala., Aug. 23.—The thirty-seven members of the Tennessee legislature here have issued a statement reiterating their determination to remain out of the state until people have had an opportunity of expressing themselves on suffrage and urged that a mass meeting be held Saturday next for the people to express their will.

NORTH CAROLINA TOBACCO MARKETS TO OPEN SEPT. 7TH INSTEAD OF SEPT. 1.

On account of the lateness of the tobacco crop in South Carolina, and on account of not being able to get freight cars, which necessitated the late opening of some of the markets, the tobacco men of South Carolina requested the markets of North Carolina to postpone the opening date of their markets from Sept. 1st to Sept. 7th, so the buyers could remain on their markets. In response to this request a meeting was held at 2:30 o'clock today in Wilson, and it was decided that North Carolina would comply with the request.

HUNGARY GREATLY CONCERNED ABOUT POLISH SITUATION

Should Poland Collapse Entire Europe Will Face Serious Crisis. PEACE TREATY FAILS TO RESTORE ORDER IN VIRTUALLY ALL PARTS Admiral Nicholas Horthy Tells Correspondents of Prevailing Situation.

Budapest, Aug. 23.—Hungary's statesmen are fearful of the consequences if the Bolsheviks crush Poland. Admiral Nicholas Horthy, Regent of Hungary, when seen at his palace office by The Associated Press correspondent, said on that subject.

"Should Poland collapse Europe would face a serious crisis, since all international order and standing power of Central Europe has been shaken by the breakdown after five years of war and by the crushing peace treaty in addition to other evils in the wake of war. treaties dictated by the Allies were unable to create order and tranquility, on the contrary all our evils grew more acute and all painful problems, on the way of solution more or less in the past, face us grimly like as many sphinxes. Central Europe is a eruption, still covered will smoke, and we cannot see any reassuring sign as yet to avert dangers lurking in the future above Europe.

75,000 PRISONERS TAKEN BY POLES IN GREAT OFFENSIVE

Matin Reports Says Russians Appear on the Eve of Complete Disaster.

Warsaw, Aug. 23.—The process of bottling up the Russians on the northern front between Prussia and Vistula has been completed, according to an official statement. The Poles have closed the gateway of escape, taking prisoners and materials in such quantities that it is impossible to count them. Soviet forces near Lemberg have begun to retreat owing to Polish advances on other fronts.

OVER 75,000 RUSSIANS TAKE IN POLE OFFENSIVE

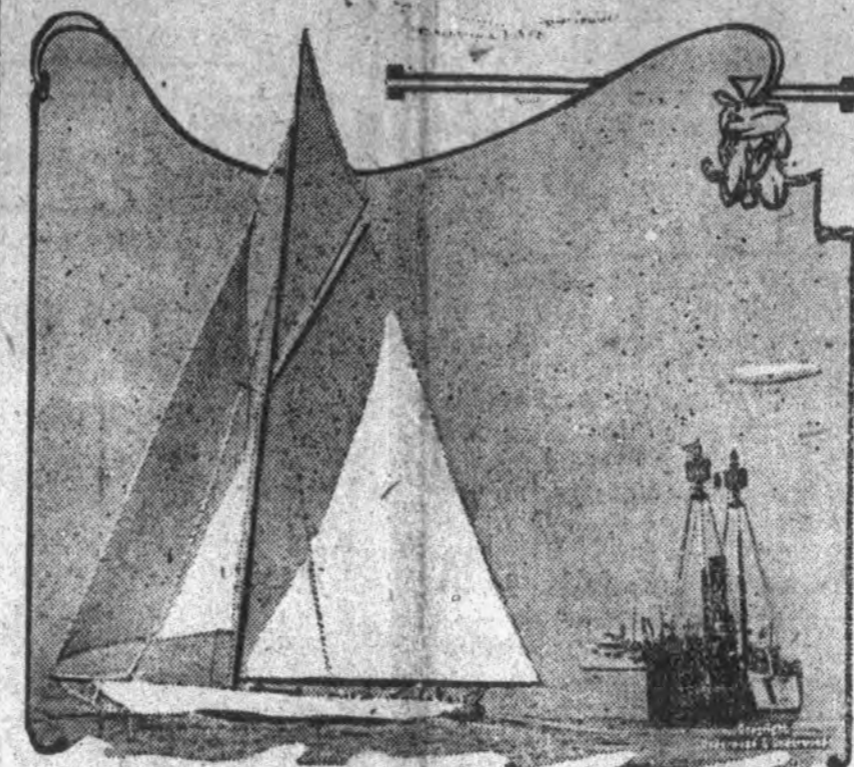
Paris, Aug. 23.—Soviet prisoners captured by the Polish counter offensive will total 75,000, according to Warsaw advices to the French foreign office. The Matin's Warsaw correspondent says that the Russians appear on the eve of complete disaster and quotes General Weigand as saying that Poland will be the grave of three-fourths of the Bolshevik army.

Warsaw, Aug. 23.—The Poles have taken Grudusk, twelve miles north of Ciechanow and have also cut off the retreat of Bolshevik forces northwest and north of this city and by the way of Mlawa and Przasnysz.

GERMAN WORKERS SEIZE PIERS IN CITY DANZIG

Paris, Aug. 23.—German workers at Danzig seized piers and established Soviet's rule to prevent the landing of supplies for Poland, according to a report from that city.

SAYS ALL EUROPE NOW ON VERGE OF ANOTHER CONFLICT

Regent of Hungary Declares Continent Must Face Many Small Wars.

BUDAPEST, August 23.—Admiral Nicholas Horthy, regent of Hungary, told the Associated Press correspondent today that in his opinion "Europe is on the verge of other wars which will not be severe but will repair the injustice and incongruities of the peace treaty. I am quite sure that old Hungary will come back again", he continued. "It was formed by natural necessities, so it cannot be held apart by paper treaties."

Allied military observers here feel that war is in the air and that Hungary is likely to begin it by invading Slovakia on a pretext of saving that country from Bolshevism but with the intention of crushing the Czechs, which the Hungarians feel would be an easy task, and the attacking Rumania with the aid of the Bulgarians, who want to recover Dobruja, and of the Serbs who want the Banat.

War prophets here are asking what Hungary intends to do with the arms and food she is collecting. It is known that Hungary has more than \$1,000,000 worth of American canned meats, that she has received 28 tanks and a large number of rifles and is manufacturing munitions. These latter are ostensibly intended for the Poles.

MORE SHIPS URGED IN EVERY SECTION BY SEAPORT CITIES

Every Effort Being Made to Speed Up American Shipbuilding, Is Said.

NEW YORK, August 23.—The slogan of "ships! ships! and still more ships!" so effectively used during the war to speed up America's ship building program as a definite of the submarine campaign still is heard in American seaports. It comes, however, not so much from those having freight for transit as it does from those who desire to make trips to foreign shores on business or pleasure.

Steamship accommodations for all lands, despite more than a doubling of pre-war time tariffs, and rigid restrictions as to passports are at a premium. Representatives in New York and other terminals of passenger carrying lines say that all available accommodations are booked as far as three months ahead. The unfortunate business man faces with the need of making an unexpected trip abroad, is forced to depend on possible cancellations of previously engaged passage on the part of some one who at the last moment is prevented from sailing. On many ships third-class accommodations hold men and women who are financially able to travel in the best that the ship affords. NEW YORK CITY IS FACED BY SERIOUS HOUSE SHORTAGES

House Situation This Fall Expected to be of an Unusually Acute Nature.

MORE APARTMENTS IS CRY IN SEVERAL SECTIONS OF CITY

Various Plans Suggested for Encouraging Greater Building of Homes.

NEW YORK, August 23.—New York City faces a housing situation this fall no less acute than that which last spring caused an army of tenants to march on Albany demanding new rent laws.

Last spring the immediate problem which faced legislators was passage of measures which would protect tenants, in a city where every apartment was a premium, from grasping landlords. Next fall the problem which is expected to engage attention of state law makers is the encouragement of apartment house building.

The housing shortage this summer has been the cause for sundry hearings by state and municipal bodies. At each was heard the cry "We must have more apartments." But so far there is little prospect that this demand will be met.

Experts have given it as their opinion that next fall instead of having more flats, New York's meager supply will be depleted by several hundred. The reason, they said, was that the demand for office space, especially on Manhattan, had caused many property owners to raze old apartments for construction of commercial establishments which they could rent at higher prices. TWO MEN KILLED AND ONE WOUNDED IN PISTOL BATTLE

Sheriff's Posse Clashes With Three Escaping Prisoners Near Walnut Cove.

Winston-Salem, Aug. 22.—Chief of Police Matthews, of Walnut Cove, N. C., and Walter Martin, of Madison, are dead and a negro whose name was unknown is seriously wounded as the result of a battle in the road one mile north of Walnut Cove between a sheriff's posse and three Madison escaping prisoners late this afternoon.

The shooting was the result of a row at a carnival dance hall when the negro insisted on dancing with white show girls. A disturbance was created and Madison men, including Martin, Jack Hawkins, and the negro, placed under arrest. En route to the mayor's office they escaped and fled in a waiting automobile.

Chief Matthews formed one of a posse summoned to pursue the fleeing prisoners and they were overtaken a mile north of Walnut Cove. A summons to surrender met with a fusillade and Matthews was shot through the stomach. Crumpled in his seat, he shot and killed Walter Martin, while Jack Hawkins and the negro escaped. The negro was trailed for a couple of miles by blood hounds, but was lost in a swamp and bloodhounds have been ordered to the scene.

HARDING CONFERS WITH HARVEY FOR FUTURE ADDRESSES

Marion, Aug. 23.—Senator Harding continued conferences today with Colonel George Harvey and indicated that his visit had something to do with the League of Nations on which the nominee is preparing a speech for next Saturday. Details of the conference, however, were withheld.

REQUESTS HAYS TO GIVE FIGURES FOR G. O. P. CAMPAIGN

Governor Cox Asserts Republican Chairman Cannot be Denial of Charge.

PLANS TO CONTINUE TO DEAL WITH FUNDS OF REPUBLICAN PARTY

Democratic Nominee Promises Evidence to Support Facts About Funds.

Dayton, O., Aug. 22.—A request that Will H. Hays Chapman of the Republican National Committee, supply information regarding Republican campaign funds was made tonight by Governor Cox, Democratic President candidate who came here today from Columbus.

Governor Cox declared that Mr. Hays' statement yesterday regarding Republican funds was not a reply to the governor's charge that the Republicans were raising a fund of \$15,000,000.

"I was very much gratified," said Governor Cox, "that Mr. Hays made his response, but as I read his statement, it's no denial. He says the irregular preliminary estimate is \$3,000,000. That does not mean anything. I want Mr. Hays to tell us into how many sub-divisions the country was divided by the Republican managers. I want him to tell us how many sub-divisions there are and what territories each covers, and incidentally I want him to tell what the quota was that was imposed on each district."

"He has spoken publicly often about these quotas and the public is entitled to this information. The Senate investigating committee will insist on it and why not have it now?"

In addition to his statement tonight, Governor Cox said that in his speeches late this week he would deal further with the question of Republican finances. He has promised evidence to support his charges that \$15,000,000 was the Republican "low limit" with the sky apparently the limit.

The Governor today received a telegram from Senator Reed, Democrat of Missouri, the Senate investigating committee regarding information to be given the committee. Senator Reed said the committee would resume its inquiry tomorrow at Chicago and that everything essential would be given "careful and thorough" investigation.

That "a great deal of money is to be expended outside of the Republican national committee" fund was stated by Governor Cox in commenting on New York newspaper reports of subscriptions to an alleged history by William Barnes, Jr., New York Republican leader.

GOVERNOR COX WILL CONTINUE TO FIGHT G. O. P. SLUSH FUNDS

Dayton, Aug. 23.—Governor Cox is planning to continue to feature Republican campaign funds and the League of Nations in his speeches he said today and his scheduled promised to add fuel to the controversy open by charges that a minimum campaign fund is being raised. No comment was made of denial of campaign funds by Senator Harding.

Legislative mills will grind out different kind of laws when women actually become recognized voters.

It is announced Senator Harding will soon deliver a speech clarifying his position on foreign questions. He would probably do better to make himself more plain on questions at home.

Harding, at least, has the consolation of knowing that he showed the American wizard financier a few things in his recent get rich scheme that startled the entire country.

Harding is delaying his really important speeches to such an extent that people are afraid he won't be able to get them all before the public in time for the campaign. And in that case, the gentleman will indirectly be reaping great benefits.

It may be mighty nice and pleasant for Senator Harding to sit on the front porch and talk politics to his admirers, but when the campaign is over he will be among those to wish that he had adopted the same kind of campaigning as Governor Cox.

Officials of the department of justice say the increased freight rates should not cause increased prices. The declaration brings some comfort to the public at least, for it was expected that after the raise had been borne higher prices would naturally come along to increase the public's burden.

It is absolutely certain that Speaker Seth Walker of the Tennessee legislature need not expect any quarter from the women after they are really enfranchised, for his opposition at the last moment has been exasperating and will be to his disadvantage when women become dominant factors in political sentiment.

Senator Lodge is no doubt too busy at this time trying to find out what Harding is going to do to renew his attack upon the League of Nations. It is surprising indeed that the senator should be forgetful of his mission against the League, but it must certainly be restful that his mind at least has been momentarily diverted.

The ratification campaign of the suffrage party is estimated to have involved an expenditure of \$150,000. This fact shows conclusively that few Republicans were connected with the issue, for if there had been the "slush" fund some would have been considerably larger than the general expense account.

Cameron Morrison, Democratic gubernatorial nominee for North Carolina, started of his campaign against the Republicans by declaring that the Republican candidate for the same office has been instrumental in the circulation of a number of charges tending to weaken his position with the public. Mr. Morrison is one of the state's most forceful speakers, and whatever he has his weight in practically every community. His nomination came about about a hard and determined struggle, and it is safe to say he will give the Republican party of the state something to think about before the election in November.

The suffrage situation in Tennessee apparently has become more accentuated than most people anticipated, and from all indications, may finally wind-up by consideration of the legislature's action by the courts. It can not be denied, however, that the issue has passed both houses of the legislature in a legal way, and it is believable that the courts will sustain first action regardless of the pressure which the irreconcilable "antis" will bring to bear before the matter is finally settled. Public opinion everywhere has condemned the legislators who at the last moment have been endeavoring to bring about reconsideration, for they have shown in a plain and convincing way that the fight has not been entirely on the square and that outside influences have dominated probably to a greater extent than the ordinary observer realizes. Ratification, however, is assured in Tennessee, for there was nothing illegal connected with the final decision of the House, and as a consequence the public looks to the body to sustain its really honest and upright action.

Real estate men in practically every section of the country are optimistic for the future. It is generally admitted that the slump in prices noticed in many sections cannot continue and that when crops are marketed the sale of land will be equally as active if not better than in the past several months. It is pleasing to note this sentiment, for it is feared in many communities that prices would fall below the average. The fact that there is an unlimited demand for real estate justifies the belief that high prices will continue, for as generally repeated by those in the land selling business "there is no more earth being made" and the public therefore cannot expect prices to go down with this fact in evidence. Money is tight right at this time, but after the crops are harvested and sold the situation will be changed materially, and many sections will be enjoying the usual amount of prosperity without questioning any probable decline in prices.

Governor Cox believes that labor situation in this country probably deserves greater attention at this time than in many years, and the fact that the Democrats have come nearer giving the laborer his desires for the future it is only natural that the presidential candidate should express himself plainly concerning the issue. Public sentiment would accomplish more in disputes than any action which the government might take, therefore, the suggestion may culminate in probably greater things than one at this time can conceive. The labor party is looking to the Democratic party for guidance, and future declarations will be greeted with interest in every section of the country where strikes and disputes have demoralized industry.

The opening of the tobacco market is looked forward to with anxiety by farmers throughout the country, for reports of low prices emanating from South Carolina causes many to believe that the situation here will be decidedly similar. Conditions here, however, are entirely different from those reports from South Carolina, for the grade of tobacco produced in this territory is in demand virtually all the year round and this fact in itself should justify the belief that prices will be everything expected. It is generally conceded that good grades of tobacco will bring prices of the reasonable nature, since there is no argument against the effect on prices of a constant demand it is perfectly natural to expect the season will be everything that can be desired.

The Poles appear to be giving the Bolsheviks a new conception of warfare, for they are giving the Red troops a merry race in battle, and showing the world that they mean to preserve their integrity as a republic. The little country has made an admirable stand against the one time victorious Russian hordes, and if they succeeded in driving them back upon their own soil a great victory will have been accomplished—a victory to be proud of in its every aspect.

Poles Gain Greater Successes On Warsaw Front

Cox May Be Compelled to Apear Before the Senate Committee

BOLSHEVIKI FORCES BADLY BEATEN BY ADVANCING POLES

Desperate Effort Being Made to Save Remnants of Defeated Red Army.

HEAVY FIGHTING IS REPORTED FROM THE NORTHERN SECTION

French Foreign Office Announce Attitude of French and Italian Premiers

London, Aug. 24.—The Bolsheviki have engaged in heavy fighting against the advancing Polish legion, seventy-five miles northwest of Brest-Litvsk, says a Moscow statement.

Warsaw, Aug. 23.—Russian Bolsheviki forces are reacting virtually along the whole line in an effort to save the remnants of the Red army, but they have so far been easily frustrated by the Poles.

On the north there is heavy fighting in the region of Mlava and Soldau. Forced to face two Polish armies, one advancing from Modlin and the other from Graudenz, the Bolsheviki are making desperate efforts to extricate their advance guard, some of which advanced as far as Eylau and Flonsk. The Red losses in prisoners in this region have amounted to 11,000 in the past two days.

The attempt of the Reds to break the Polish lines on the Przanzy-Makow-Rozany road and cross the Narew river has completely failed. Polish troops advancing up the right bank of the Narew, threw back the Bolsheviki to the north. Meanwhile, the main body of the Poles, advancing from Warsaw, occupied all the territory in the fork of the Bug and the Narew.

COX SAYS HE WILL PROVE CHARGES IN ADDRESS THURSDAY

Dayton, Aug. 24.—Cox has issued a statement declaring that he would prove his charges regarding the magnitude of the Republican campaign fund. He said he would present information in an address next Thursday night. "Harding denies my charges about campaign fund, senatorial oligarchy raising. I am prepared to believe that he knows nothing about a lot of things going on around him. The reveals a very dangerous symptom, which I have been discussing," said Cox.

EIGHT INJURED WHEN TRAPPED BY FIRE IN NEW YORK TENEMENT

New York, Aug. 24.—Eight were injured in a fire which trapped scores of families in an Eastside tenement. The firemen had to play the streams of water on the tenants huddled on the crowded fireescaps because of the intense heat.

DESIRES INCREASE IN APPROPRIATION FOR INSANE ALIENS

United States Immigration Authorities Ask Increase for Deportation.

NEW YORK LAST YEAR APPROPRIATED FORTY THOUSAND FOR ISSUE

Dr. Dawes, Medical Examiner of New York Hospital Asks for Assistance

New York, Aug. 24.—Increased appropriations to enable the United States Immigration authorities to deport aliens in whom insanity is discovered, was urged here today by Dr. Spicer L. Dawes, medical examiner of the New York State Hospital Commission.

Dr. Dawes declared that although 290 insane aliens were deported during the last fiscal year, there are still a great number in the state who might be deported if funds were available, thus cutting down an item of expense which is a burden on the education in New York. Dr. Dawes said that there are 30,000 insane persons in state institutions who cost the people annually \$11,500,000.

Of the 290 aliens deported for insanity last year 147 were sent to their home countries in the usual way by the Federal authorities, while 143 were "repatriated" by the state with the per (Continued on Page 4)

COX DECLARES HE WILL GIVE FACTS ABOUT SLUSH FUND

Democratic Nominee to Make Public Other Facts of Republican Campaign.

Dayton, Ohio, Aug. 23.—Developments in connection with his charge that "slush fund" of \$15,000,000 was being raised for the Republican campaign and personal affairs today engaged Governor Cox, Democratic presidential candidate.

Governor Cox received a telegram from Senator Kenyon, Republican, of Iowa, chairman of the Senate campaign fund investigating committee, which resumed its sessions today at Chicago, requesting information. No reply was made by the governor, as he had spent Senator Reed, of Missouri, a Democratic member of the Kenyon committee, a telegram last night, promising to transmit information in the near future.

In addition to the information to be given the committee, Governor Cox said tonight that he would make public other facts in his future addresses.

Declaring that he did not expect to testify before the Senate committee, Governor Cox said:

"I will send matter to the committee later. All of the information I have will be given to the public and, therefore, I do not see any use in going before the committee. I think also, that the committee will recognize that as a candidate, I should give it out in such manner as I see fit, but I have no disposition, of course, to conceal anything from them that I have myself.

TEACHER SHORTAGE BECOMES DECIDEDLY SERIOUS IN COUNTY

Forty-Five Teachers Needed to Complete Force in All Schools of County

ONE ROOM SCHOOLS CONFRONTED BY AN UNUSUAL SITUATION

According to County Superintendent S. B. Underwood, the teacher situation in Pitt county is becoming acute. At this time exactly forty-five teachers are needed to complete the teaching force in the county, with no very encouraging prospects as to supply. The majority of these vacancies are in one-room schools. In fact, only two or three teachers for one-room schools have been secured as yet in the entire county. The rest of the vacancies are in the two-room schools, with a few scattering vacancies in the others.

This is in spite of the fact that the activities of the entire educational machinery of the county have been directed toward the employment of teachers since the first of May.

The discouraging phase of the situation is that there are more than twice the vacancies now than there were at this time last year. There are simply not enough teachers in the state to supply all the schools, and Pitt county is sharing the fate of the other counties.

There were more teachers enrolled in summer schools this year than ever before, but the larger schools employed most of them even before the close of the various summer schools, and a grave shortage exists so far as the smaller schools are concerned.

After a heart-breaking struggle last year all the schools finally opened, though some of them were not able to begin until January, but it looks now as if it will be impossible to secure enough teachers to open all of the schools this year. There were 700 schools in North Carolina that did not open at all last year, and it looks as if the number will be greatly increased this year.

The increased salaries apply only to the trained teachers. The salary of teachers with second grade certificates is just what it was last year. Educators are of the opinion that most of those who have been teaching on (Continued on page 4)

KANSAS PLANTERS BECOME SUDDENLY WEALTHY ON CROPS

Stores of Sudden Wealth Numerous in Wheat Growing Territories.

MONETARY VALUE OF CROPS ESTIMATED AT ABOUT \$100,000,000

Topeka, Kans., Aug. 24.—Stories of sudden wealth in the Kansas wheat belt are numerous this year, due to the unusual acreage of "volunteer wheat," a crop grown from seeds which fall in the previous harvesting. Officially estimated there was 1,500,000 acres of volunteer wheat in Kansas this year, or about a sixth of the total harvested acreage. This wheat yielded probably 40,000,000 bushels or representing a monetary value of about \$100,000,000. The total Kansas crop of wheat is estimated officially at 150,000,000 bushels.

The large acreage of volunteer wheat is due to the fact that a great deal of this acreage was deserted as wheat land by the owners, after last year's none to bountiful crop had been harvested. The 1919 acreage was in excess of 11,000,000, by far the record for any state in the union. A wet fall caused the kernels of wheat which had fallen to the ground during the harvesting, to germinate.

Finding the "volunteer" crop making a stand, farmers did not disturb the growth and, with ideal wheat growing weather this spring, the volunteer wheat made yields fully as bountiful as the rest of the crop.

Innumerable stories of "deserted" producing \$5,000 to \$25,000 worth of wheat come from western Kansas where the bulk of the volunteer wheat was grown. Others tell of farmers who purchased farms this year and paid for them with the proceeds of this year's wheat harvest. Illustrating the "sudden wealth" general throughout the western Kansas counties, where land has been cheap and favorable seasons few and far between, a recent canvass of what yields in the vicinity of Oakley, a small town 60 miles east of the Colorado line, in Logan county.

OFFERS SOLUTION TO ELECTRIC TRAIN SERVICE PROBLEM

Federal Railway Commission Suggests Economic Business Commonsense

COMMISSION VAN GOES NO FURTHER THAN TO POINT OUT REASONS

Electric Industry as it Exists Now Is Without Financial Credits.

Washington, Aug. 24.—Satisfactory solution of the problem presented by the electric street railway industry can be reached through application of principles "of ordinary economic and business common sense" in the unanimous opinion of the seven men who composed the Federal Electric Railways Commission appointed by President Wilson in 1919. The report of the commission, prepared after exhaustive hearings and examination of nearly 100 witnesses, was made public today and says:

"The commission can go no further than to point out the principles upon which the readjustment should be based. The task really is that of the state and local authorities upon the one hand and of the companies upon the other.

"Failure to rehabilitate the industry and the service is possible only if those upon whom the responsibility rests fail to undertake the work or pursue it in a spirit that makes settlement impossible." (Continued on Page 4)

LEGION DESIRES TO ENTERTAIN FOCH IN AMERICA THIS YEAR

Government Extends Invitation to Both Admiral Beatty and Foch Too.

ANNUAL MEETING TO BE HELD IN CITY OF CLEVELAND, SEPT. 27

Indianapolis, Aug. 24.—National officers of the American Legion are hopeful that Marshal Foch and Admiral Beatty will accept the invitations of the United States government and the Legion to visit America next month and attend the second annual convention of the Legion to be held in Cleveland, Sept. 27, 28 and 29.

Lemuel Bolles, National Adjutant of the Organization, who has recently returned from Washington where he conferred with Secretary of War Baker and officials of the British and French embassies, said the Legion's formal invitations to the supreme allied military and naval commanders had gone forward through the embassies and that the State Department had also officially transmitted them at the request of Franklin O'Flaherty, national commander of the Legion.

Co-operation in the effort to have the two war chiefs come to this country for the convention has been promised by American officials and by the French and British embassies.

MAY COMPEL COX TO PRESENT FACTS AT SENATE INQUIRY

Senate Committee to Thoroughly Investigate Expenditure of Republicans.

SUMMONS CHAIRMAN TO PRESENT FACTS IN CAMPAIGN FUNDS

Prominent Leaders of Both Parties Ordered to Bring Information.

Chicago, Aug. 23.—Governor James M. Cox, the Democratic presidential nominee, will probably be subpoenaed and compelled to appear before the Senate committee, which today announced plans for investigating the Republican and Democratic national campaigns, unless he comes of his own free will, a member of the committee told The Associated Press tonight.

This member of the committee said that its members felt that Governor Cox must prove his charges that the Republicans were raising a \$15,000,000 campaign fund or withdrawn them and that the committee was prepared to go to any length to obtain evidence in the matter. No official subpoena will be issued, however, until the committee meets next Monday.

"If Governor Cox has not given us a satisfactory reply by that time, I feel certain a subpoena will be issued," he said.

Senator Reed said he had not received an answer to his telegram to Governor Cox up to 9 o'clock tonight when he left for a short trip to Wisconsin.

The statement was made when members of the committee were shown despatches quoting Governor Cox as saying he "saw no use in appearing before the committee," adding that he would furnish it with the evidence, but felt that he should be allowed to do so "when he saw fit."

Included in the matter to be taken up when the committee reconvenes next Monday will be an investigation of the Oklahoma Democratic senatorial primaries, and the pre-convention Kansas campaigns.

Chicago, Aug. 23.—The Senate campaign investigating committee today made plans for what it announced would be a "thorough and exhaustive investigation into the Republican and Democratic national campaigns." The investigation, it was announced, would not only deal with methods of obtaining and expending money in the campaigns, but would cover reports of alleged offers of federal positions as an inducement to political activity.

OFFERS MEANS FOR SOLVING JAPANESE PROBLEM IN AMERICA

Honolulu, Aug. 24.—A recall by Japan of all Japanese who have emigrated to the United States was proposed by a prominent Tokyo citizen as a means of solving the Japanese problem in America, says Tokio cablegram to a newspaper here. And the proposal was supported by the press.

DAMATIC STARS IN HUMOROUS ROLES IN REPUBLICAN'S HONOR

## BUSINESS CONDITIONS.

The desire of business to trim its sails so that it might weather any approaching squall was more definitely emphasized last month than at any time since the Spring of 1916. This was particularly noticeable toward the latter part of the month when large industries began cutting down their forces, as did the Pennsylvania Railroad in discharging 12,000 men and as did the American Woolen Mills which released a large number of its less efficient employees.

In other instances, large industries moved to safe guard their business by slackening their volume of production. The strain brought about by the scarcity of capital, has by now affected all industries. Whether that strain can be relieved by decreased production remains to be seen, but it would seem that the cost to do business in industries with a fixed overhead could be lessened more successfully by an increase of volume rather than by a decrease. That the strain would be relieved by increased production under normal conditions of transportation is undoubtedly true, but today facilities are not available to transfer any greater volume of goods from the point of production to the point of consumption than now is being handled. At least that is the way some industrial economists analyze the situation.

There has been some slight improvement in railroad situation within the month and commodities are moving more freely into trade channels. Continued improvement should ease the situation materially. Meanwhile, the problem before business is to produce as much as possible at the lowest possible margin of cost and at the same time to keep production in a healthy condition.

The security market, despite forecasts to the contrary, still has failed to develop a definite trend. During the month dullness and irregularity were the characteristics which ruled the stock exchange and although sentiment was optimistic, it was scarcely borne out by actual trading. Dealings on the stock exchange seem to indicate the desire of a great many holders of gilt edged securities to liquidate in order to obtain cash with which to continue operations.

Bonds of known industrial concerns have undoubtedly reached low ebb in the tide which swept over the securities market three months ago and that is the thing on which traders doubtlessly base their optimism. Cancellations of orders by retail merchants to wholesalers and jobbers seem to be increasing in number and volume. That is due in part, and perhaps mainly, to the fact that the retailer has a belief that prices are going to be lower. These cancellations have resulted in some instances in partial shutdowns and the adoption of a part time basis by some manufacturing industries, particularly in the textile industry. Another reason for cancellation is, probably, that the retailers last season anticipated a much larger volume of business than was realized this summer, and in their eagerness to have adequate merchandise with which to supply the hoped for demand, rushed their orders to manufacturers on the basis of a hope which was at best guess work.

The Republicans are going to buy the presidency if there is the slightest chance in the world of doing so. The great slush fund which Governor Cox has been talking about for the past several days is more of a reality than most people expect and is really becoming more of an actuality than the party desires. The Democratic nominee means to let the world know the issue in its true light, and when he completes exposing the campaign there is little reason to believe that the America people will not believe what he has said. The situation is a deplorable one in the extreme, and shows convincingly that if money has the purchasing power, the Republicans will buy the entire country.

The investigation to come about as a result of Governor Cox's charges of enormous Republican campaign "slush" funds may not be quite so pleasant to those denying the charges, for the very fact that the campaign is going to be one of the greatest in many years justifies the belief that huge sums of money will be involved in the issue. The truth is, the Democratic candidate has told the truth too plainly for comfort in the opposite ranks, and it is only natural that some kind of a denial should be expected.

### PREMIERS TAKE NEW VIEW OF POLISH PEACE TERMS

Paris, Aug. 24.—The French foreign office has announced that the new attitude taken by Premiers Lloyd George and Giolitti concerning Russia and Poland as due entirely to the American note to Italy. The communication to France from the British and Italian premiers is said to be in accord with the United States and France and that Poland would endanger her independence if accepting the Soviet terms.

Washington, Aug. 21.—The campaign of the National Woman's party for ratification of the suffrage amendment has cost \$150,000, according to an announcement tonight by party officers. They estimated that at least \$80,000 was spent to get the 36th ratification, some of which is still to be raised. Total expenditures from the time the senate acted favorably on the amendment in June last year, until the final action in Tennessee last Wednesday, amounted to \$140,500, of which \$68,519 was used in the drive for the 36th State. The Tennessee campaign cost, yet to be raised, amounted to at least \$10,000, the announcement said.

If Governor Cox should happen to be the next president there will be no further room for charges of senate oligarchy.

Tax revaluation in this state has its opponents, but like all other good measures, opposition means very little to it in the long run.

The Poles appear to have gained new heart under the guarantee of moral aid from the Allies. In fact, the way they have pushed the Russians back cause one to believe that the little country will be in position to resume normal life within a short time. They deserve such, anyway, and all that can be done by other nations will not be too much in the slightest sense of the word.

The postponement of the opening of the Eastern Carolina tobacco market will give the farmers more time to get their products in readiness for the market, and also give buyers plenty of time to finish work in South Carolina. Prices will not be affected at all by the delay, for tobacco grown in this section of the state is always in demand, and where there's demand prices will be everything expected.

Tobacco reports from several sections show that prices have been encouraging, and it is quite natural to expect that the opening of the market in Greenville will not be disappointing. The situation is one that demands the attention of practically every person in this section of the state for tobacco is the main crop and prices paid for it mean much. Reports from South Carolina should not be discouraging as they do not determine prices here owing to difference in grades and the great demand for better qualities as produced in this section.

Governor Cox says that Chairman Hays of the Republican party cannot deny his charges of excessive campaign funds, and as he speaks confidently as if well informed, it is safe to say there is something behind the charge. Cox is not the kind of man to start something which there is nothing too for his time is too valuable and people are looking to him as a kind of guide. His charge of Republican oligarchy in the senate is undeniable in every sense of the world for that fact is public property and doesn't require the action of any special investigating committee. As the two charges were made at the same time and with the same assurance of being correct the public may expect that Governor Cox has the situation sized up in its true light.

The prediction that enfranchisement of the American woman will be delayed at least a year cannot be considered seriously by those not familiar with the truth of conditions in Tennessee, for present delay is only the result of final suffrage opposition to bring about its defeat. The legislators who found it advisable to cross the line into Alabama to prevent a quorum in the House cannot continue to act so determinedly, for it is only a matter of time when they will be forced to give away under pressure of those who have waged such a splendid fight in the woman's interest. The situation at the time is nothing more than a climax to true greatness of the suffrage victory, for when the legislators realize that the vote for ratification is going to hold good in spite of efforts for reconsideration, then and then alone will they acknowledge their defeat. Tennessee will be reluctant to give up the honor and glory of ratification, and if it is left for the courts to decide justice will uphold the rights of the woman in a more decided manner than those who found that political affiliation wouldn't permit the last stand.

Greenville lost the fourth game of the championship to the Scotland Neck-Hobgood aggregation in Scotland Neck yesterday afternoon by the score of 8 to 1. and grade certificates will not teach at all on account of the low salary. Some of them are going to school to prepare themselves for better certificates and many of them are going into other lines of work.

Asked as to what would be done about it, the superintendent replied: "We shall keep pegging away at the job and find as many as we can. It is some time before time for the country schools to open, and we shall search the state for qualified teachers who really know enough to teach school. We shall do the very best we can to meet the critical situation that confronts us."

mission of relatives or guardians of the patients. Explaining his process of "repatriation," Dr. Dawes said: "After securing the consent of relatives to 'repatriate,' we arrange for passports to his or her home country and then give the insane person clothes, toilet articles and a new suitcase for the return trip. Under escort or guard, we send the patient all the way and see that he or she is safely delivered to relatives or friends on the other side."

"Last year the state of New York appropriated \$40,000 for this purpose alone."

Dr. Dawes said that in addition a great deal of time and money was devoted to returning insane persons to other states in which they are residents, whether citizens or aliens.

"With the exception of Connecticut," he said, "we have no difficulty in getting other states to take back their insane. We have written agreements with Massachusetts, Ohio, Illinois, Wisconsin, Iowa, Washington and several others. Not infrequently we send parties of insane persons across the continent to the Pacific Coast."

The law provides that insane aliens may be deported at any time provided that legal processes are instituted within five years of their landing here. As New York is the greatest port of entry, Dr. Dawes said, this state becomes the dumping ground for thousands of these people who must be taken care of at public expense until they can be deported.

### OFFERS SOLUTION TO ELECTRIC TRAIN SERVICE PROBLEM

(Continued from page one.)

In a summary of its conclusions and recommendations the commission said in part:

"The electric railway industry as it now exists is without financial credit and is not properly performing its public function.

"This condition is the result of early financial mismanagement and economic causes, accentuated by existing high price levels of labor and materials and the failure of the uniform unit fare of five cents prescribed either by statute or by local franchise ordinances or contracts to provide the necessary revenues to pay operating costs and to maintain the property on a reasonable basis.

"The industry can be restored to a normal basis only by the introduction of economies in operation, improving its tracks, equipment and service and securing a reasonable return upon the fair value of its property used in public service when honestly and efficiently managed.

"Restoration of credit involves a readjustment of relations which will remove public antagonism, provide public co-operation and insure the investor the integrity of his investment and a fair rate of return thereon."

Full co-operation of labor is essential to the prosperity and usefulness of the electric lines, the report says, adding that employes should receive a living wage and have humane hours and working conditions.

"They should have the right to deal collectively with their employers," it continues, "through committees or representatives of their own selection. All labor disputes should be settled voluntarily or by arbitration and the award of such a board should be final and binding upon both parties."

### VICTORY MEANS OPPORTUNITY FOR INCREASED ACTIVITY

"The suffrage victory means opportunity for more work and added responsibility"—according to Mrs. Carrie Chapman Catt, President of the National American Woman Suffrage Association.

"The suffrage triumph is too belated for it to come with any shock of surprise. We have long been ready for it. We are ready for the work that lies ahead of us.

"Since votes for women is now an accomplished fact, what are the women going to do with the vote?"

"Are they going to draw back their skirts in disdain from all interest in politics on the ground that it is corrupt?"

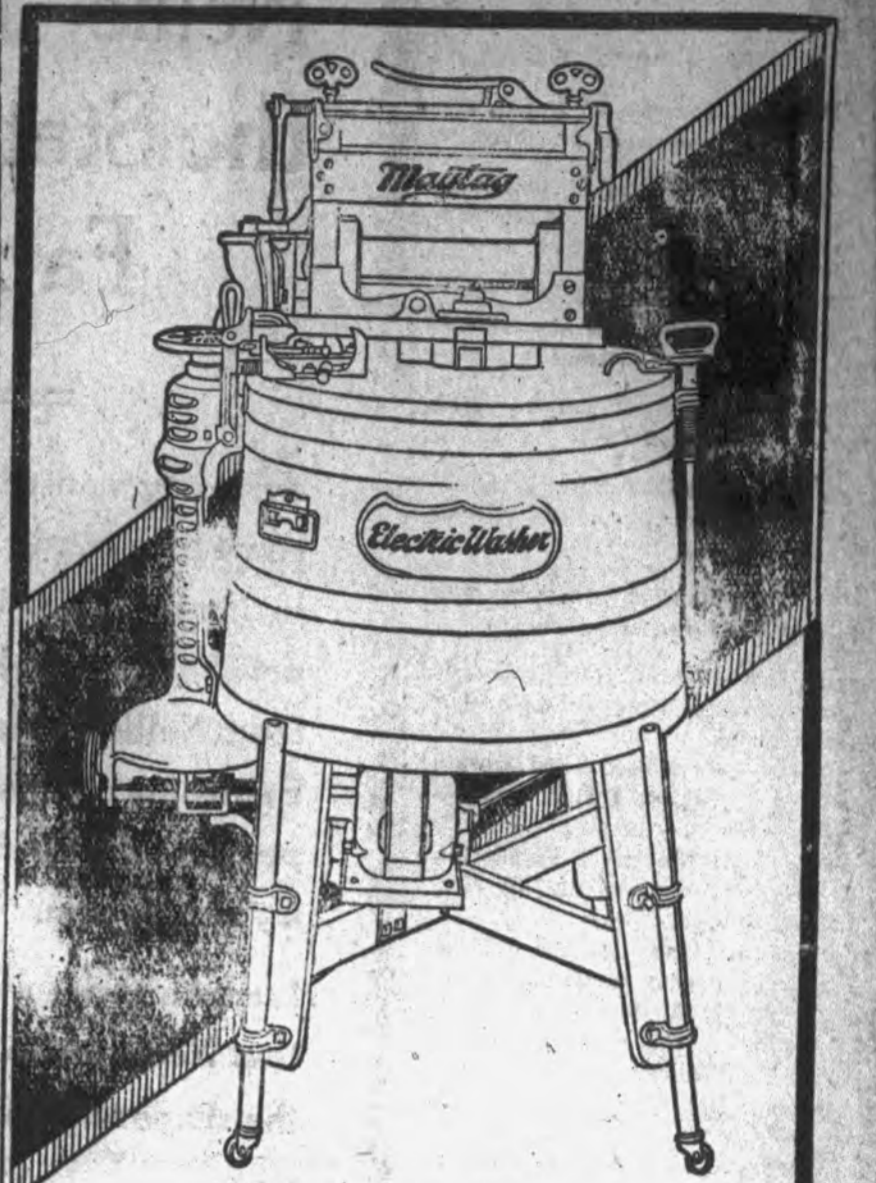
"Are they going to join the army of kid-glove men slackers whom I have heard proudly boast that they would not touch politics with a ten inch pole?"

"Or, are they going to be one of those who will help swell America's army of voters, who put conscience and thought into the scales with party politics and party candidates.

"In order to help the new woman voter find her way through the maze of these besetting questions there has been formed the National League of Women Voters. In each state, branches are forming out of the old suffrage associations. This League is not partisan, it is pan-partisan, all partisan. A woman can be a member of it and yet be a member of any political party she may choose, exactly as she may be a member of it and be a member of any church she may choose.
