

Cox Bitterly Assails Senator Cabot Lodge In Speech At Boston

Democratic Nominee Also Ridicules Harding in New England Address. ASKS MASSACHUSETTS PEOPLE TO REPUDIATE REPUBLICAN LEADERS Advocates Retiring Republican Senator to Private Life at Early Date.

Boston, Oct. 19. — Scathing attack upon Senator Lodge, of Massachusetts, and sarcastic criticism of Senator Harding, Republican Presidential nominee, were made today by Governor Cox during his New England tour through Massachusetts and New Hampshire cities and ending with a large meeting tonight on Boston Common.

Here in the home state of Senator Lodge, as well as to other audiences today, the Democratic Presidential candidate denounced Senator Lodge as "the arch conspirator of the ages" because of his fight against the League of Nations. Reiterating that Mr. Lodge headed "a conspiracy to strangle the treaty to death" through the "round robin," Governor Cox urged his Boston audience to "repudiate" Mr. Lodge's leadership and retire him to private life as soon as possible.

Senator Harding was heaped with sarcasm and ridicule by Governor Cox in virtually every address of the day, with the incident between President Wilson and the Senator regarding the latter's statement of French overtures for a new association of nations as the basis.

"The facts justify the conclusion that Senator Harding has stupidly, though deliberately, attempted to deceive the people of the United States," Governor Cox declared.

Reciting Mr. Harding's explanation of his Des Moines speech "rejecting" the league, Governor Cox added: "He must think the American people very stupid. He continues to say that they don't understand him."

Expressing belief that a French author and humorist was Senator Harding's source of information regarding French sentiment upon a new association of nations, and commenting upon Senator Harding's letter to President Wilson, Governor Cox said, sarcastically: "Poor Senator Harding has been misunderstood again. It is a pathetic thing that he suffers so much from the dulness of the American people, including newspaper editors and leaders among partisans and opponents."

The league was virtually the exclusive theme today for Governor Cox and his Boston address tonight made a total of ten speeches. The governor's denunciation of Senator Lodge was followed by hissing from his Concord and Manchester audiences.

The heights of his attack upon Senator Lodge were reached by the Democratic candidate here tonight. Expressing happiness over speaking on "the first form of America dedicated to free speech and free assemblage," Governor Cox said he desired "to remove clouds and confusion" regarding the league. These, the governor asserted, were "set up in a partisan plot, instigated and led by the arch conspirator of the ages, Henry Cabot Lodge, of Massachusetts."

SENATOR HARDING LAUDS REPUBLICAN PROTECTIVE TARIFF

Jackson, Oct. 20.—Senator Harding lauded the Republican protective tariff in an address here today, declaring that "with all progressive tongues and literary idealism of our opponents it is still Republican party not only as tariff protection, but every kind of protection which stands for safe-guarding of Americans."

HARDING TALKS TO CENTURY CLUB ON CITIZENSHIP ISSUE

Pitt County Senator Talks to Women on Importance of Casting Vote.

On Tuesday afternoon at the home of Mrs. J. L. Little, Senator Harding addressed the End of the Century Club on "Citizenship." Senator Harding said that, constitutionally, he was opposed to Woman Suffrage and disliked to see woman brought into politics, but now that she was, he hoped to see her wield her influence along the lines of equity and justice.

He began his address in a Round Table discussion asking the women to ask him questions which they did and he explained them. He then discussed the League of Nations—the national issue. He told of the beginning of our own United States how they debated and discussed whether the thirteen original states should become a federation of states or be separate countries. After seven years discussion a constitution was adopted and a union of states formed. This union has enlarged to forty-eight states and during the period of one hundred and thirty-two years the constitution has been amended nineteen times.

He was asked if he thought a League of Nations would prevent war—he replied, I do as much as I do the central government in Washington prevents our state from going to war with

REPUBLICANS FAIL TO APPROVE PLANS ON PRESENT PARTY

Coolidge Denounced Democratic Co-operation in Middleton Today.

REFUSES TO ABANDON SELF-GOVERNMENT FOR HIGHER PRINCIPLES

Condemns Invasion of One Branch of Government by Some Other Faction.

Middlesboro, Ky., Oct. 20.—Invasion by one branch of the government of the powers and duties of another branch was denounced by Governor Calvin Coolidge, republican vice-presidential nominee, in an address he delivered here tonight. The Governor asserted that "before the war, as after the war, the executive invaded directly and indirectly the properly independent functions of the legislative branch of the government."

"We refuse to abandon one jot or tittle of self-government," he said. "We will not permit those we put into power, whether a man or a group or a party, to continue a course which, we apprehended, will gradually sap our civic strength and ultimately destroy our free institutions. We will not allow ambition to assume control of our liberties. We propose to prevent class creation whether of wealth or of labor, mal-administration which wrecks injustice, enactment of laws which are not for the promotion of the general welfare, expediency in the determination of our policies, extravagance which dissipates our savings, and burdensome debt."

URGES CONTINUED DEVELOPMENTS IN AMERICAN MARINE

Calvin Coolidge, Republican Nominee, Urges Greater Attention in Future.

Asheville, N. C., Oct. 20.—The up-building of the American merchant marine and "an ample navy for our needs" were urged by Governor Calvin Coolidge of Massachusetts, Republican candidate for vice-president, in an address here tonight. He attacked the building and sales methods of the Shipping Board and the Democratic administration of the Navy Department, although adding that he was inclined to believe that Secretary Daniels was "the victim of an unworkable system which he did not originate."

"We have no desire for special privileges," said Governor Coolidge. "Freedom to sail the seas, freedom in trade, like treatment, these are the things for which we stand, these are the things we shall have. We established in 1812, when we were weak, equality of right in the use of the seas. We reasserted that right in 1917—only, however, after repeated and humiliating violation. "Commerce is the blood of modern existence. It is of prime importance to us that there shall be prosperous markets in which we may trade freely and on equal terms; that our production and transportation shall be developed with the regard to our own necessities and those of others, and economically handled and distributed; that there shall be adequate protection for our business activities abroad, and that every governmental function properly available in the promotion of our trade shall be so employed."

PLAN BOUNDARY IN NEWFOUNDLAND AND CANADA DISTRICTS

Timber Interest Plan to Establish Definite Boundary Account of Forest.

PAPER MANUFACTURERS INTENSELY INTERESTED IN PROPOSED PROJECT

Discover of Immense Timber in Labrador Brings Out Decided Activity.

St. John's, N. F., Oct. 20.—Recent surveys of Labrador which have disclosed immense resources of timber suitable for pulp and paper manufacture have led to a revival of efforts to bring about a determination of the boundary line between Newfoundland and the Canadian province of Quebec. This line has never been laid down by actual survey and its various definitions as given in documents issued at intervals in the last century and a half are so vague that government officials do not know just how much of Labrador belongs to Newfoundland and how much to Canada.

That Labrador is rich in many natural resources, including enormous waterpower, has long been known, but the practicability of utilizing its forests for paper making was not demonstrated until the world-wide paper shortage led to exhaustive investigations of the territory. This resulted in applications by promoters to the Newfoundland government for timber limits in Labrador. As these could not be acted upon until it was determined whether Newfoundland owned the land in question, representatives of this colony were sent to London late in the (Continued on page eight.)"

SAYS WORKING MAN OUGHT TO SUPPORT SAVING'S SYSTEM

Worcester Man Believes Average Man Would Save if He Understood Outcome

Washington, Oct. 20.—The working man will support a savings system which includes retention of a part of his weekly wages from his pay envelope if the system is understood thoroughly by him, John F. Tinsley, manager of a loom works, at Worcester, Mass., today told the American Bankers' Association. He urged adoption of such a plan throughout the country. Mr. Tinsley's recommendation was based on the successful operation of such a saving system among hundreds of employees in the Worcester mill, which has become known as the Worcester Industrial Savings plan. In brief, the plan consists of having the workers sign cards, authorizing the weekly deduction from their wages and designating the bank in which they wish the money deposited, and of organizing shop committees to encourage thrift. Weekly deductions may be increased or decreased by notifying the shop foreman, and each week a statement is placed in the pay envelope showing the weekly gross deposits.

"Of the upwards of 5,000 subscribers in Worcester," said Mr. Tinsley, "only 150, or three percent, have dropped out."

Four conditions were named by Mr. Tinsley as necessary for the successful operation of the plan: The system itself must be simple, flexible and easily understandable; the management must energetically support the savings idea; the foremen must be thorough believers in it and the organization for introducing it must be enthusiastically in favor of the savings idea.

The experience at Worcester, Mr. Tinsley declared, was that the foreign-born employees "as a general rule support the plan better than do the English speaking."

SENATOR OVERMAN TELLS OF CAMPAIGN IN SPEECH TODAY

North Carolina Representative and Miss Graham Live in Fight in Section.

The cause of the Democratic party and woman suffrage was presented in a forceful and interesting way to a medium sized audience at the court house in this city this afternoon by Senator Lee S. Overman and Miss Mary Graham, the former championing the higher principles of democracy, the latter almost solely confining her address on citizenship to a large number of women from many parts of the county. Both speakers received more than usual attention for their arguments upon various issues were highly illuminating and presented in no uncertain way the part which American men and women should play in the advancement of a nation which has attracted the attention and admiration of the entire world.

The wide scope embraced by democracy was set forth in a plain and convincing way by Mr. Overman, who has represented North Carolina in Washington for a number of years, and his arguments were based upon such sound judgment that they left little room for contradiction. He explained that it is going to be necessary for every true Democrat to exert the greatest possible influence in the present campaign and that while victory was almost assured, it would however be necessary for every adherent to stand firmly and unflinchingly behind the party and do his utmost to prevent a Republican victory—a victory which would mean destruction to the highest ideals preserved by democracy. Miss Graham presented the suffrage question in such a way that no American woman of sound judgment could possibly evade the direct appeal. She said that the time had come for every woman to exert her right, and that the greatest things of higher planes of citizenship demanded that the woman take advantage of this distinct opportunity presented though national amendment.

Senator Overman was introduced by Mr. H. A. White, of this city, who explained the important part which the speaker of the day had played in the interest of North Carolina, and the untiring way which he served both State and nation. He declared that no representative had ever been more faithful to his duties, and that the people of the State had not been slow in appreciating his splendid endeavors.

FINANCIAL RELIEF FOR AGRICULTURAL INTEREST SOUGHT

Meredith Appeals to Bankers for a Square Deal to Southern Farmers.

REVISION OF FEDERAL TAXES COMES UP FOR FINAL CONSIDERATION

Atlanta Banker Declares South Not So Near Broke as People Think.

Washington, Oct. 20.—Discussion of Federal taxation revision and financial relief for the agricultural interests was pressed to the fore today before the convention of the American Bankers Association. Suggested changes in tax laws, however, were indefinite, although some of them probably will be dealt with in resolution to be considered Thursday.

Secretary Meredith's speech, pleading for a square deal for farmers by the banking interests, opened the way for several informal meetings by rural bankers. While none of these crystallized into a settled plan, representatives of bankers in the cotton states decided upon a general mass meeting for tomorrow night, at which their particular difficulties and those of their producer-customers will be taken up.

Robert Maddox, Atlanta banker, declared that the South was not "nearly so broke as it has been made to appear." Banker and cotton producer alike should take an offensive rather than a defensive stand, he said, and he predicted that the creation of a sentiment of optimism among them would greatly enhance cotton values.

Mr. Maddox, however, said he appreciated the situation said to be facing the cotton growers and that there appeared to be no hope for help from the government. He suggested the formation of a great cotton export corporation as proposed for the southern states by Government Harding of the Federal Reserve Board a year ago, saying this seemed to be the only practical solution.

The tax question came up in the sectional meeting of the trust company bankers where Lynn V. Dinkins, of New Orleans, president of the group, said he believed present tax laws placed a handicap on commercial pioneering and acted as a brake on business.

"It is, of course, necessary," Mr. Dinkins said, "to raise by taxation sufficient income to pay the current expenses of the government, interest on the public debt and provide a reasonable sinking fund to be used in liquidating the public debt. There can be little discussion about that, but the sources from which this income is derived is a different subject."

INJURED MAN CLAIMS HE WAS ATTACKED BY KLU KLUX KLAN PARTY

Philadelphia, Oct. 20.—A man giving his name as Peter McMahon, of Youngers, N. Y., left a train and sought medical attention in this city today. His wrists were scarred by a rope and his back bore marks of a whip. He said he had been seized by a mob at Trenton, S. C., where he was assisting Miss Florence Powell, daughter of an Aiken banker to get more money for settlement of debts against her estate. He said the mob attempted to hang him but resorted to beating. The mob wore Klu Klux Klan hoods and put him on the train with orders to never return.

SENATOR FRANCE GETS LETTER SIMILAR TO ONE SENT TO HARDING

Chicago, Oct. 20.—Senator France of Maryland said he received a letter very much similar to the one received by Harding from France, suggesting a change in the league of nation and evidently written by a woman writer with no connection with the French government.

OMAS HAS BECOME HEADQUARTERS FOR BOLSHEVIKI ARMY

Siberian City Transformed Into Main Point for Russian Troops.

London, Oct. 19. — Omsk, Siberia, formerly the antibolshevik headquarters of the late Admiral Kolchak, has been transformed into a bolshevik headquarters, seat of the soviet government for all Siberia, chiefly by the use of red hunting, red paint and red propaganda posters and pamphlets printed in Moscow and sent to Siberia.

New street signs, featuring bolshevik nomenclature; new heroic street arches and monuments constructed of wood and painted red are other changes, noted by The Associated Press correspondent who recently crossed Russia. Behind the scenes, Omsk is the same city of suffering refugees, scant food and clothing and difficult living conditions in general, according to Russians who talked to The Associated Press correspondent and his companion, the first Americans to enter Omsk after Admiral Kolchak's hurried evacuation. There has been little relief in an economic way for the people, there being as much dissatisfaction under the reds there as under Kolchak.

Gone from Omsk are the vari-colored uniforms of Allied missions from Paris, London and Tokio and forgotten is the Omsk express, the weekly train to Vladivostok. The former are replaced by envoys and missions out from Moscow, unusually for food or any supplies that may be obtained for shipment to the bolshevik capital. American Red Cross nurses and Y. M. C. A. men have been replaced by bolshevik workers who wear the red insignia on their caps.

Military opposition to the soviets having been overcome, attention has been turned to constructive work. Attempts are being made to solve the ever-present food shortage by vegetable gardens in public parks and even in several streets. The entire grounds of the one cathedral were given over to potato growing during the summer.

WILLIAMS CAUSES DIRECT STIR OVER HIGH-RATE CHARGE

Comptroller Arouses Bankers in Charge of "Unjustifiable Interest."

ASSERTION PROMISES TO BEING STORM FOR REMAINDER SESSION

Rural Bankers Feel They Haven't Had Square Deal in the Past.

Washington, Oct. 18. — Technical questions scheduled at the American Bankers' Association convention here were displaced in interest among delegates today by the controversy centering around charges of "unjustifiable interest rates" made against New York banks by John Skelton Williams, Comptroller of the Currency.

Officials of the association tried all day to avert the threatened storm, but it was stated after the day's session of the various convention groups that there was a demand by delegates for a reply to Mr. Williams' assertions. The charges made by the comptroller will be considered by the committee on resolutions and later will be taken to the floor of the convention, it was said. The public relations committee, in a statement tonight, said:

"The general expression among the visiting bankers was in criticism of the act made by the Comptroller of the Currency, the majority of them pointing out that Mr. Williams did not give in his statement the amount of money loaned by the New York bankers on call at the high rate of interest mentioned. The various bankers estimated the amount loaned at from one to two per cent.

"They are inclined to class money as a commodity and point out that there has been less increase in the money rates than in any other commodity. It also was stated that the greater amount of money is being loaned at from 6 to 7 1/2 per cent while the prevailing low rate prior to the increase in other commodities was from 5 to 6 per cent."

Supporters of Mr. Williams among the bankers, however, said they expected to express themselves "freely" when the question reached the convention floor. Rural bankers were represented as feeling that they had not had a "square deal" at the hands of some of the New York banks serving them as correspondents.

Discussion of the Williams' charges crept into the executive meetings of the various group sessions, but mention of the attack was met with announcement that the subject was not one for any particular group to deal with, and that preparations were being made to have the association express its views formally.

The insurance committee decided to investigate reasons for advanced rates on burglary and hold up policies. Companies writing such insurance increased their rates several months ago without giving reasons for the advance, members of the committee stated.

**NO OFFICIAL COMMENT
CREATED BY ACTION OF
WHITE HOUSE MEMBER**

**Points Out Extraordinary In-
ferences to be Drawn from
Such Statement.**

Tuesday, October 19.—The French foreign office stated today that it not received any demand from Washington regarding the letter President Wilson wrote Senator Harding. It said no official communication had been made by the French government regarding a substitute for the league of nations.

Washington, Oct. 18.—President Wilson took steps today to ascertain whether the French government had given authority to "a representative of France" to approach Senator Harding "informally" with the request that the Republican Presidential nominee take the lead in the formation of an association of nations.

At the same time the White House made public the text of a letter addressed to Senator Harding by President Wilson inquiring as to the correct-

ness of a statement attributed to the Senator in a dispatch dated St. Louis, October 16, in which the candidate was quoted as having said he had been so approached.

"I need not point out to you," the President wrote, "the grave and extraordinary inferences to be drawn from such a statement, namely, that the government of France, which is a member of the League of Nations, approached a private citizen of a nation which is not a member of the league with a request that the United States head the way to a world fraternity."

Neither officials at the White House nor at the State department would comment on the nature of the inquiry directed to the French government. It was understood, however, that the note was transmitted by the State Department to the French government through Ambassador Wallace, in Paris. At the French embassy it was stated that no such communication had been received there for transmission.

Secretary Tumulty said that no reply had been received by the White House either from Senator Harding or that French government up to a late hour.

The letter of the President to Senator Harding follows:

"My dear sir:—

"In the New York Times of yesterday, Sunday, October 17, 1920, I find a statement dated St. Louis, October 16, which purports to represent certain public utterances of yours. In it occurs the following:

"Replying to criticisms of his proposals for an association of nations, he said in a rear platform speech at Greencastle, Ind., that he already had been approached 'informally' by a representative of France, who asked that the United States lead the way to a world fraternity."

"I write to ask if this is a correct quotation and if you really said what is there attributed to you. I need not point out to you the grave and extraordinary inference, to be drawn from such a statement, namely, that the government of France, which is a member of the League of Nations, approached a private citizen of a nation which is not a member of that league, with a request that the United States lead the way of a world fraternity."

"The Department of State has always found the government of France most honorably mindful of its international obligations and punctiliously careful to observe all the proprieties of international intercourse. I hesitate, therefore, to draw the inferences to which I referred unless I am assured by you that you actually made the statement.

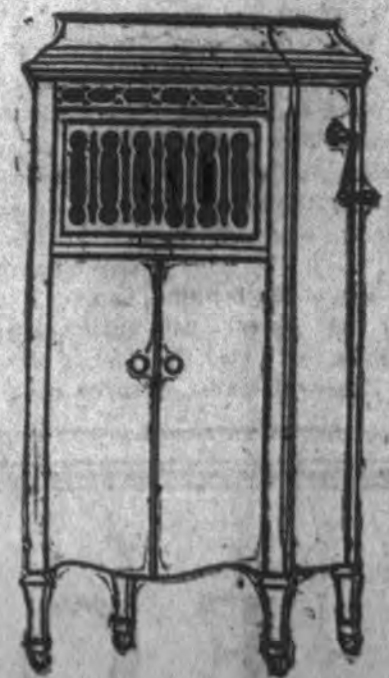

WAR ON RED PLAGUE DISEASES.

To meet the steadily increasing interest taken by the public generally and by the medical profession particularly in the war against the Great Red Plague the U. S. Public Health Service has organized an institute on venereal disease control and social hygiene to be held in Washington, November 22 to December 4. At this meeting health officers, private practitioners, clinicians, educators, psychologists, sociologists and others who feel the need of further information in regard to the twin diseases of the red plague and in regard to the different sciences that have helped in building up our knowledge concerning them, may obtain, free of all charge, the benefit of ten days intensive training by the best experts, man and woman, in the country. In this work the American Social Hygiene Association and the Inter-departmental Social Hygiene Board will assist.

The session of the Institute will be followed immediately by the convening of the All-America Conference on the Great Red Plague which will continue for six days will be attended by the best known physicians, administrators, and other experts of the three Americans and particularly of the United States. The meeting of the Institute and of the Conference in sequence is believed by the Public Health Service to afford an unparalleled opportunity for medical men and social workers to acquaint themselves with the means and methods of warfare against what is now generally recognized as perhaps the greatest single factor now impairing the public health.

The faculty of the Institute will consist of Doctors J. H. Stokes, Mayo Clinic, Rochester, Minn.; Hugh Young, Baltimore, Md.; John A. Fordyce, New York City; E. L. Yeyes, Jr., New York; Thomas M. Balliet, William A. White, Prof. M. A. Bigelow, Katherine B. Davis, Mrs. Martha P. Falconer, and some thirty or forty other leading specialists.

During the ten days of the Institute four full courses and eleven half courses will be given. Of the full courses, the first three will consist of

lectures on the diagnosis and treatment of the venereal disease, and the fourth will be on delinquent women and their relation to the law. The half courses will be on the diagnosis of the mental condition of delinquent women; on protective work for girls; the work of the venereal disease nurse; heredity and eugenics; sociology and social hygiene; public education in venereal diseases; law enforcement; sex psychology; clinic management; and clinic social work.

Officers of State and city boards of health, clinicians, nurses, social workers, judges, and probation officers of courts of domestic relations and juvenile courts, police matrons, police matrons, police women, superintendents of eleemosynary institutions, chiefs of police medical officers of commercial institutions, urologists, dermatologists, gynecologists, neurologists, psychologists, and officers of medical and sociological organizations are all eligible for admission to the Institute. Others who wish to attend but who are not included in these groups will be expected to present credentials from State or city health officers.

Application for admission should be made as soon as possible in order to enable those in charge of the Institute to make arrangements for the educational facilities, comfort, and pleasure of the guests. No applications will be accepted after November 15 except by special direction of the Surgeon General. Applications that have been sent in may, however, be withdrawn, if circumstances make attendance impossible.

All who desire will have ample opportunity for private conference with the members of the faculty. No tuition is charged, the generous co-operation of the faculty making this unnecessary. Hotel accommodations will be reserved if instructions therefore are sent to the U. S. Public Health Service, Washington, D. C.

PROVIDING FOR SOLDIERS.

Uncle Sam is looking about for 250 young men with a high school education who would like to learn the exciting profession of army balloonist, and eventually become balloon and airship reserve officers. They will be paid \$75 a month while learning, and receive a ration allowance of \$1 a day, together with quarters, all clothing and equipment, and free medical and dental treatment. The course is open to unmarried applicants possessing a high school education, or its equivalent, who can pass the Regular Army physical examination and the physical tests required of flying officers.

Successful candidates enter as cadets and will be sent at once to the Air Service School for training as balloon observers at Ross Field, Los Angeles, California. There each young man takes a 10-months' course in balloon observation under ideal conditions. He is taught how to handle his craft in all its phases and to make observations, and he eventually qualifies as a free balloon pilot.

When the cadet is rated as a balloon observer he goes to Fort Sill, Oklahoma, to receive his artillery training. Upon completion of this course, the student is commissioned a second lieutenant in the Air Service Reserve Corps. Then he has the alternative of discharge or continuation in service as an enlisted man. There is also opportunity for him to take the examination for a lieutenant in the Regular Army. If a cadet cannot finish his course successfully, he will be discharged and not retained in the army against his will.

Major General P. C. Harris, The Adjutant General of the army, says: "This training opens up an entirely new range of experience to the young man, and lays the foundation for qualification as a dirigible balloon pilot, a new field of almost limitless possibilities. Commercial transpor-

tation by airship is an accomplished fact in America, and according to present plans, next year will see it in actual operation in this country on a large scale. Today the only opportunity for such training is either in the army or in the navy; in fact, the lack of qualified personnel is one of the serious drawbacks to present commercial plans for airship transportation lines."

Army recruiting officers throughout the United States have been notified to furnish full particulars to all young men who are interested in becoming balloonists under these new conditions.

UNION LABOR.

There is no essential difference between the attitude of labor in demanding that it be permitted to bargain collectively with the employer, and the demand by organizations of producers for co-operative marketing.

Grain and cotton producers have felt for years that the existing method, whereby purchasers locally make individual bargains for the crop, often worked to the disadvantage of the producers and, as a result, in many sections of the middle west and in various commodities, co-operatively run elevators have been established to which the producer delivers his grain, though not much has yet been done in this direction by the cotton growers.

The discussion is rife amongst both the grain men in the middle west and the cotton growers of the southwest for the expansion of co-operative elevator and warehouse program with co-operative marketing organization on a big scale, while the Federation of Farm Bureaus has been making a study of co-operative marketing operation now in existence with the idea of expanding them.

Here and there producers of farm products are undertaking in various ways, under various titles and with divers high sounding plans, to set up new or to amplify existing co-operative marketing machinery. They are now apparently even seriously discussing plans which contemplate within their general outlines, the establishment of banks and the carrying on of such financial operations as have never yet been attempted by any like organization except, possibly, the Non-Partisan League.

Producers' organizations are clamoring that bankers are merely the trustees for the community's funds. Thirty years ago the bankers often felt that he was the community, and that his was the final decision as to whom, and to what extent, credit should be advanced. Only too often he pursued his calling on the basis of selfish interest, but it was even at that time recognized that the banker with a judicial temperament (who was a rara avis), was better for the community than one who allocated credits for his own advantage, or for that of his clique or his bank.

A suspicious remark, even if made in confidence, may do injury to the character or business of the man about whom the remark is made. For this reason those ready to utter such remarks should think before speaking. If a man gets in a hard place it is better to help him than to make his condition harder.

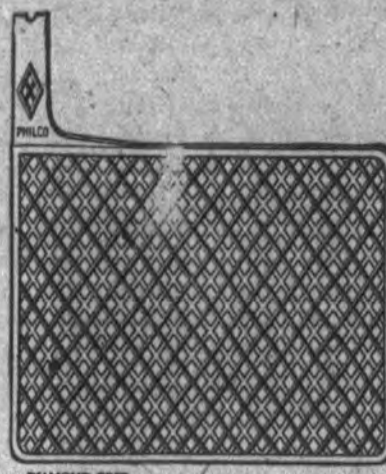

PERMANENT PASTURE POINTERS

The following pointers on permanent pastures may interest those who expect to put in pastures this fall:

1. Buy seed now while they may be had.
2. Plant pastures on darker well drained soils with clay subsoil, and if possible get them close to barnyard.
3. Use plenty of unleached barnyard manure. Mix it with upper two inches of seed bed. Thorough preparation practically insures success.
4. Inoculate the clover seed to make sure of success the first year. Ask your county agent to assist you in getting inoculation material.
5. Mix seed with cotton seed meal or fertilizer in sufficient quantity to sow over the plot twice to insure even seeding. Make two sowings, the second sowing at right angles to the first.
6. Do not begin grazing until grass is from four to six inches tall.
7. Do not graze too heavily the first year. Too much grazing will injure it when it is young.
8. Keep stock off the pasture when the soil is wet.
9. Plant acreage in proportion to stock to be grazed.
10. Use the mowing machine if weeds

11. A permanent pasture is a splendid antidote for hay buying.
 12. Good pastures mean better stock, more profit and richer farms.
 13. Fall sown pastures are best, sow from September 15 to November first.
 14. A good permanent pasture should last from two to ten years without being reseeded. Depending on the preparation and care.
 15. Do not allow geese on these pastures.
 16. Use at least two tons of ground limestone per acre. Harrow into the seed-bed thoroughly.
 17. Have the best in milk, butter, eggs, and meats. Plant a permanent pasture at once.
 18. For assistance in selection of proper soil, securing lime stone, seed, etc. See your county agent.

**PREDICTS GREATER
BUSINESS THROUGH
BETTER RAILROADS**

**John J. Pulley Tells Banker's
Association of Improved
Conditions.
ADVERSITY OF RAIL
CONNECTION DISASTER
IN BUSINESS CENTER
President of Saving's Associa-
tions Looks Hopefully to
Future.**

Washington, Oct. 19. — Improved business conditions generally during future years because of the bettered railroad situation resulting from the new Transportation act were forecast by John J. Pulley, President of the Savings Banks' Association of New York, speaking today before the American Bankers' Association.

"Adversity in transportation spells disaster in business," declared Mr. Pulley, who addressed the bankers' convention on the effect of the Transportation act on the credit of the railroads. He asserted that general bankruptcy and disorganization of nation's railway system would have resulted last spring had not the new law "wisely" provided for the roads during the period of transition from government control to private operation.

The increase of railroad rates, recently made by the interstate commerce commission under the authority of the new law, Mr. Pulley said, added "hundreds of million of dollars to the value of railroad holdings of investing institutions."

The new rates, he said further, will prove advantageous to the medium grade railroad bonds, and should tend to give added assurance to investors that early maturities will be accounted for properly. The \$300,000,000 revolving fund, provided by the law for rail equipment loans, also was praised as benefitting the rehabilitation of railway credit.

As a third factor improving railroad credit, Mr. Pulley cited the National Railway Service Corporation, recently

organized by the National Association of Owners of Railroad Securities as an agency of the Interstate Commerce commission to aid in making loans and obtaining new equipment.

The present acute car shortage, Mr. Pulley continued, would have been averted had this corporation been in existence in the past 12 months.

**HARDING REPLIES
TO RECENT LETTER
FROM WHITE HOUSE**

**Answers Wilson's Question Re-
garding Invitation from
French People.**

Marion, O., 18.—Replying to an inquiry from President Wilson, Senator Harding wrote the White House tonight that although France had sent her "spokesmen" to him informally, asking America to lead the way for an association of nations, the incident had not involved the French government in any violation of international proprieties.

The Senator declared that in his reference to the subject in a speech at Greencastle, Ind., recently he only had sought to convey the thought that there had come to him "those who spoke a sentiment which they represented to be very manifest among the French people." He added that his words "could not be construed to say that the French government has sent anybody to him."

Referring to Mr. Wilson's suggestion of impropriety in a foreign nation approaching a "private citizen" on such a subject, Senator Harding pointed out that he is a member of the foreign relations committee as well as a nominee for the presidency and suggested that "an informal expression to me is rather more than that to a private citizen."

The text of Senator Harding's letter, sent in reply to one from the President asking whether the Senator had been correctly quoted in his Greencastle speech, is as follows:

"Dear Mr. President:
"I have before me a press copy of your letter to me of this date, though I am not in receipt of the original copy. I am glad to make a prompt reply.

BELIEVES GERMAN PLANNED TO WHIP ENGLAND'S FORCES

Mathias Erzberger States that Kaiser Planned to Take England Last.

Berlin, Oct. 10.—The former-German Emperor William confidently expected to emerge victoriously from the world war and then marshal his continental armies against England in what he termed "the second June war," says Mathias Erzberger, in his volume of war recollections just published at Stuttgart. The Emperor evidently used the term "June war" in the sense of a conflict for world supremacy between two great nations.

Erzberger, who was formerly minister of finances, but now has temporarily retired from public political activities set forth in detail the meeting between the then Emperor William and the Reichstag leaders, after the fall of Chancellor Bethmann Hollweg, and following the adoption of the peace resolution in July 1917.

He says the Emperor became enthusiastic over the phrase "peace or compromise," which he assumed was what the Reichstag majority demanded. "Excellent word 'compromise,'" William stated. "It means," he said, "that we take the money, raw products, cotton, oil, and ores out of the pockets of our enemies and transfer them to our own."

The Parliamentary leaders, Herr Erzberger says, were astonished by this unexpected display of imperial mentality and felt that they were being made the victims of his mockery. The Emperor's further remarks were in the same channel, he declares.

William asserted that the United States and England had entered into an alliance for the purpose of reckoning with Japan after the war. He was also reliably informed that Russia would join Japan in varding off the Anglo-Saxon blow. He admitted that England would not emerge from the war defeated but said the final accounting would come when he led his continental armies against her in "the second June war."

The amazement of the Parliamentarisms grew as the Kaiser, contined Erzberger reports. The monarch asserted that "a complete understanding would be reached with France when the war was over."

COAL INDUSTRY HAS BEEN PARALYZED IN MANY PARTS BRITIAN

London, Oct. 10.—Great Britain's coal industry has been nearly paralyzed by the miner's strike. With cool weather prevailing slight disorders have been reported in South Wales.

GOVERNOR ALLEN TO PRESS INVESTIGATION AGAINST LOW PRICES

Topeka, Kansas, Oct. 10.—Governor Aklen said today that he would press the investigation of Chicago Board of Trade and if the recent slump of cotton and wheat was shown to have been done by speculation and gambling he would abolish the board.

REPORT OF LEAGUE TO EFFECT PEACE BRINGS ABOUT STIR

Score of Letters Show Confidential Activity of Prominent Parties.

St. Louis, Mo., Oct. 18.—Scores of confidential letters from the files of the League to Enforce Peace, of which William Howard Taft is president, were introduced into the record of the Senate committee investigating campaign expenditures here late today. Names of a number of prominent New York bankers were mentioned in the correspondence.

Don H. Hunt, attorney for the committee, who investigated the activities of the league, reported that "in my estimation" officials of the league have violated the Logan act, passed January 30, 1790, which prohibits American citizens carrying on negotiations with foreign governments or their agents regarding disputes or controversies without the permission of the United States. The act carries a penalty upon conviction, of fines of not more than \$5,000 and imprisonment of from six months to three years.

Plan Would Make Impossible Gold Redemption by Rapidly Rising Prices.

Washington, Oct. 10.—Professor Irving Fisher's plan to stabilize the dollar by diminishing or increasing the gold behind the dollar as prices fall or rise was adversely reported upon today by the currency commission of the American Bankers' Association. After a year's study, the commission found that the plan contained "grave dangers" and it recommended against memorializing congress in favor of changes in the monetary system suggested by the Yale economist.

"It is our conclusion," the commission reported, "that Dr. Fisher's plan, thought interestingly and ably worked out, is wholly impractical and would involve grave dangers to the stability of our financial and monetary system. It would lead to foreign drafts on your gold in any period of crisis since the plan calls for lightening the gold behind the dollar when prices fall and foreigners, foreseeing this, would draw down their balance and sell 'dollars' short before the government could do the change."

PLAN BOUNDARY IN NEWFOUNDLAND AND CANADA DISTRICTS

summar to discuss with minut English counsel the preparation of a formal draft of Newfoundland's Labrador claims as opposed to those of Canada.

The coast of Labrador was annexed to Newfoundland in 1763. Ten years later, owing to difficulties arising out of grants made to a number of persons under the French rule, it was changed to Canadian jurisdiction. In 1809 it was again transferred to Newfoundland and has since been attached to this colony.

The difficulty arises over different interpretations of the words "coast of Labrador." One view is that Newfoundland can claim only the coast between Blanc Sablon and Cape Chidley, with perhaps a half a mile inland, and that the rest of Labrador belongs to Canada. As defined in the letters patent constituting the office of Governor of Newfoundland, the boundary was described as a line drawn between Blanc Sablon and Cape Chidley, which would pass through the ocean in certain sections and leave large areas of the coast to the westward of the line and therefore not under Newfoundland jurisdiction.

Many Newfoundland officials hold to the view that the correct delimitation was made in a sessional paper issued in this colony in 1864. Under the phraseology of this document Newfoundland would be entitled to thousands of square miles of the interior of the Labrador peninsula in addition to the coast.

by one branch of the government of the powers and duties of another branch. We will repudiate those who make solemn promises in our name, which they neglect or refuse to observe, and who seek to commit us to adventure upon uncharted seas without counsel with others equally responsible to us, and which our common sense warns us to be perilous to our existence.

"Arbitrary measures confined only to the war period may be excused on the ground of war necessity and war confusion. In such a grievous time, freedom to be preserved must submit to autocracy. We can then afford to overlook assumption of power if in the general interest and designed to secure the end desired.

But as we look back over the past

eight years we find the war merely emphasized, not provoked the violence done our institutions and our policies. Before the war, as after the war, the executive invaded directly and indirectly the properly independent functions of the legislative branch of the government. Before the war, as after the war, domestic and foreign policies were inaugurated which violated sound tradition.

"We demand that our government shall function as it was designed to function, its three co-ordinate branches moving their respective orbits as defined by the constitution, free from invasion by one into the power and the authority of the other, and each and all responsible only to the people."
