SENATE LAUNCHES GARDNER BOOM IN UNEXPECTED WAY

Adopts Resolutions Confidently Anticipated His Return to Public Life Shortly.

CHANGE OF PRESIDING OFFICERS OCCASION OF MORE GENERAL NOTICE

After Installation of Cooper Senate Devotes Short Time to Eulogy of Predecessor.

Raleigh, Jan. 13.—Giving the retiring Lieutenant-Governor a demonstration without precedent in the legislative annals of the State, the senate yesterday launched a boom for O. Max Gardner as Governor in 1925, by unanimously adopting a resolution which "looks forward with enthusiastic anticipation to his early return to public life in the State he loves so well."

The hour of eulogistic speech making which preceded the adoption of the resolution was participated in the Senators of every shade of political party in the majority party and by members of the minority.

When the Senate reconvened yesterday afternoon at four o'clock for the purpose of installing Lieutenant-Governor W. B. Cooper, of Wilmington, as its presiding officer, the proceedings began in traditional fashion.

The senate was called to order by President Pro Tempore Long, who called ex-Lieutenant-Governor Gardner to the chair. The first intimation of what was to follow came with the extended and spontaneous ovation accorded the retiring presiding officer. Mr. Gardner made a brief speech to the senate, in which he gave spirited praise to the integrity and honesty which characterize the official acts of North Carolina legislators.

Mr. Gardner said: "It has been my good fortune to serve in the capacity of senator, president pro tempore and presiding officer in six assemblies of North Carolina State Senate. In a moment my office relations with the General Assembly will be terminated. Before my successor takes his seat I crave your final indulgence, not to pronounce a formal valedictory or pessimistic lamentation, but to bid you an official and affectionate goodbye.

My short association as your presiding officer during this term has been delightfully congenial and happy, and has served to instillate each of you into the warmest affection of my heart. "In the range and vicissitudes of my life I think I have mixed and mingled with all the types and elements that compose our composite citizenship. I fancy that I know North Carolina pretty well, having touched her life in almost every county, city, town, hamlet and village throughout the length and breadth of our State, but it would be a most difficult task if I would undertake to approximate an accurate picture of a typical North Carolinian. How would you describe such a person. What manner of man is he?

"If through the alchemy of condensation we could blend, fuse and consolidate the combined character, ability, vision, weakness and strength of this General Assembly and divide the mass into 170 component parts, each separate human unit would possess most nearly the splendid attributes of body, heart and mind of a typical North Carolinian, and at the same time reveal the truest possible type of a real American! For, after all, North Carolina in her racial integrity and Anglo Saxon purity is true America and Genuine Americanism."

CHEER UP MABEL WELL RECEIVED IN TOWN LAST NIGHT

Musical Comedy Company Was Full of Wit and Comedy and Many Good Song Numbers.

"Cheer Up Mabel" musical comedy company, under the personal direction of George E. Wintz, played to a large and appreciative audience in this city last night at White's theatre. The production was just a little different from anything appearing here this season, featuring largely in comedy with a little plot hanging upon very slim threads of romance. There were quite a number of interesting features presented throughout the two acts, chief among them being special song features, quartette renditions and Hawaiian dances.

In the first act members of the company, composed largely of chorus girls headed by Nyra Brown, leading lady, marched out on a improvised runway extending midway the audience, indulging in a number of interesting features which continued occasionally until the final act. Miss Brown, almost completely covered by brilliant balloons scored a decided hit in a popular song number from the stage and out on the runway, and in numbers of instances enhanced the company's success. John Getz played the leading role of an abandoned son of a rich man in particularly fine style, and won constant applause in song numbers conforming with the part in which he appeared from time to time.

The scenery conformed well with gradual development of the plot, as did costumes. In each part the chorus girls were well and brilliantly attired, apparel ranging anywhere from the Hawaiian style now more frequently seen on the American stage. There was nothing at all gaudy in dress of leading characters, particularly the women, but the style was effective and provocative of more than ordinary attention. The "monkey man" proved a source of unending pleasure to young people in the audience, and his witty sayings, combined with those of the versatile black face comedian met with generous applause during the entire performance.

All in all, the show was not the best that has ever appeared here, but it was good and deserving of commendation. Difference of opinion prevails concerning it, of course, but everybody can't be pleased, as there are those who at times fail to appreciate themselves. And that's saying something.

ASKS LEGISLATION TO IMPROVE LABOR ISSUES IN LONDON

Member of Parliament Says Government Must Provide Way for Unemployment Problems

SITUATION MAY DEVELOP THAT WILL THREATEN LIFE OF NATION ITSELF

Ugly Temper Prevails Among Many of the 100,000 Unemployed Over the Government Inactivity

London, Jan. 13.—Labor leaders are demanding urgent legislation to solve in some way the problem of unemployment in Great Britain. Warnings have been given of a serious social or industrial upheaval, or some kind of straitening "direct action" unless the British government acts promptly.

"If nothing is done within the next six weeks," said J. R. Clynes, member of Parliament the other day to Dr. Macnamara, the Minister of Labor, in the course of a discussion with labor leaders, "a situation may develop that will threaten the life of the state itself."

There is said to be an ugly temper among many of the 1,000,000 or more unemployed over what they regard as dilatoriness on the part of local and governmental authorities in taking steps to meet the situation adequately. About 100,000 of these idle men are in London.

Homeless and destitute, they have seized about 50 suburban public libraries, baths and assembly halls. From some of these they have been forcibly ejected by the police and this has caused more ill-feeling.

Delegates from employed committees in a score of more of London boroughs have recently formed a central council, which is holding secret meetings at which "direct action" is planned.

What form this "direct action" will take is not divulged by the men, who proclaim their intention is to act independently of the Labor Party or trades unions; Dennis Jennett, chairman of the committee, told The Associated Press representative they will be of a startling nature.

LAW SUIT AGAINST ALLEGE MONOPOLY IN CIRCUIT COURT

Suit to Terminate Agreement Between Transportation Companies in the Rocky Mountains Begins.

St. Louis, Jan. 13.—Suit to terminate an alleged transportation monopoly in the Rocky Mountain National Park on the ground that it is illegal came up here Monday before the U. S. circuit court of appeals. The alleged monopoly was authorized by the national parks service in 1919.

The prime mover in the suit is Enos A. Mills, of Estes Park, Colo., who is known as the "father of the Rocky Mountain National Park" because of his successful efforts for its creation.

According to Mr. Mills, transportation monopolies in other national parks have operated against Americans "seeing America first" by placing tourists under un-American restrictions in the chief picturesque areas of the public domain.

The suit against the government is brought in the name of Charles Robbins, a resident of Estes Park, who has carried it up to the court of appeals from an adverse decision in a lower court in Colorado.

The brief filed in behalf of Mr. Robbins set forth the contention that the roads in the Rocky Mountain National Park are public roads and that the right to use these roads for either business or pleasure is a common right.

SIMPLER PASSPORT MEASURES DESIRED BY TWO COUNTRIES

Secretary of Berlin Chamber of Commerce Declares Europe and America Desire Change.

ISSUE PRESENTED TO SEVERAL GOVERNMENTS FOR FINAL APPROVAL

Movement Toward Greater Simplicity Originated by Buenos Aires Chamber of Commerce

Berlin, Jan. 13.—There is a spontaneous demand from commercial organizations of Europe and the American continent for simpler passport regulations, says Fred W. King, acting president of the American Chamber of Commerce of this city. The matter already has been brought to the attention of a number of governments and protests have been made to Washington against the American system of issuing short-time passports, it is stated. The protest is based on the ground that there is much delay and difficulty in having these passports renewed when they have expired.

Representatives of Chambers of Commerce of many nations are to hold a conference, the time and place of which has not yet been determined, for the purpose of developing a passport plan that will be at once satisfactory to the government and meet the needs of commercial and other travelers.

Those advocating changes want passports to be issued for, perhaps, a number of years, instead of for a few months and to eliminate the custom of viasing, inspection and long examinations at every frontier. It is claimed that the delays resulting from present regulations have been carried to a most aggravating extent by some of the smaller nations of Central Europe.

"Business men have told me of losing hundreds of thousands of dollars by being unable to keep appointments and close contracts because of delays in receiving credentials to cross the frontiers," said Mr. King.

THINK CHANGES OF THE MOON AFFECT RADIO AIR SERVICE

Members of Air Fleet in Adriatic Territory Declare Moon Affects the Atmosphere.

Paris, Jan. 13.—The changes of the moon have been found by the radio officers of the small American fleet in the Adriatic sea to have a striking effect upon the electric waves of the atmosphere for transmitting radio communications. The officers have succeeded in drawing curves and other diagrams, based upon months of observation, which, they assert, reliably serve to indicate what atmospheric and celestial conditions affecting radio service will be met at any particular date in the future.

The discovery apparently has special application to the vicinity of the Adriatic, for there the changes in the atmospheric conditions caused by the change in the world's relation to the moon are much more marked than anywhere else in the world, so far as yet discovered.

The Adriatic fleet under Admiral Andrews depends almost entirely for its communications upon radio service, and having only receiving and sending apparatus of moderate efficiency it has specially benefited from the discoveries. The powerful wireless stations, such as the new Lafayette station near Bordeaux, manage to overcome unfavorable conditions by using great power and so are not concerned about which way the moon turns.

LETTER OF CHEER AND OPTIMISM IS RECEIVED LOCALLY

Southern Manufacturer Writes Local Firm to Forget Hard Times and Face Future.

About the best word of good cheer and optimism we have come across in these times when there is so much expression of complaint rather than looking on the bright side of life, contained in a letter from one of the largest manufacturing concerns in the South to a prominent business man in Greenville. We have the privilege of printing this letter, omitting the names, and hope that everyone who reads it will catch the fine spirit expressed and quit looking at the gloomy side of conditions. Here it is:

"This is just a letter of good cheer. Somebody has said that the darkest hour is just before dawn; and if that be so, day-break is surely near, and a mighty bright, sunny day at that.

"Observers on the hill-tops tell us that they can now see the rosy tipped fingers of the dawn, drawing aside night's sable curtains, and that ere long a great flood of brightness will awaken the drowsy world. They point to the starting up of the wheels of industry and of the quickened pulse of commerce as the first signs of the passing of the night. Soon will follow the busy stir and activity of the new day.

"After such a nightmare as most of us have had, few of us will feel like joining with the roosters in crowing for the day; but there are always a lot of nice, juicy worms crawling around after such nights of depression as we have just had and it is usually the early bird that gets them. The bird that sits around all morning and mopes over the cutting off of his feed and the plucking out of his tail feathers is not getting anywhere by a waiting policy. He's got to get out and scratch and keep his eye skinned.

"This year is predicted by financial and business experts to be a year of wonderful progress and profit to the South. Next fall is slated to be a period of such business activity and agricultural prosperity that our present troubles will be entirely forgotten in the wealth we shall find in consequence of the world-wide demand for our products.

"Are you ready for the new day? We trust you are forward-looking and that your foresight and labors will be richly rewarded by a year of unparalleled prosperity."

TAR HEELS READY TO JOIN VIRGINIA CALL TO ORGANIZE

Three Hundred Representatives From Twenty Counties Endorse Marketing Plans at Raleigh.

CALIFORNIA ATTORNEY OUTLINES MOVEMENTS TO CURTAIL ACREAGE

Dr. Joyner Calls on Planters to Free Themselves from State of Economic Servitude.

Raleigh, Jan. 13.—Three hundred tobacco growers representing twenty counties in North Carolina unanimously joined Virginia growers yesterday in endorsing the movement to organize a co-operative marketing association following an outline of the California plan of commodity marketing in Raleigh by Aaron Sapiro, of San Francisco, counsel for fourteen co-operative marketing associations on the Pacific coast. The North Carolina Tobacco Growers' association went on record as favoring a reduction this year of 33 1/3 per cent.

The headquarters of the proposed marketing association will be in Raleigh, and it is proposed to include North and South Carolina and Virginia growers in the association. The agreement, as outlined by Mr. Sapiro, who has been employed as counsel for the proposed tri-State association, is to become effective for a period of five years when signed by sixty per cent of the planters of the three states.

"If the growers want to do it, there isn't a power on earth that can keep the tobacco industry from becoming stabilized and prosperous in a twelve month," declared Attorney Sapiro, who explained California plan of commodity marketing as being simply "merchandizing instead of dumping."

In urging co-operative marketing by growers, Mr. Sapiro declared there should be no disposition to antagonize any other interest and he invited the assistance of bankers, business men and all others who may be interested but insisted that the proposed association must be composed exclusively of growers.

Following Mr. Sapiro's address, on motion of Mr. W. C. Manning, of Williamston, the gathering unanimously endorsed the plan as outlined.

Dr. James Yarkin Joyner, of LaGrange, who was elected president of the North Carolina Tobacco Growers' Association, was given a great ovation when he declared that he was a "dirt farmer," but that about all he had gotten out of farming since he began being one was "dirt." Dr. Joyner, who was recently made chairman of the organization committee for the Interstate Tobacco Growers Association, with the eloquent fervor that made him famous as an educational crusader in North Carolina, expressed the conviction that the time has come when the tobacco growers of the South should break the shackles that bind them to economic servitude.

The meeting yesterday represented the annual convention of the North Carolina Tobacco Growers' association, but discussion of plans for the formation of a separate marketing association took up the greater part of the day.

Senator Harding is going to Florida where they skin alligators in the summertime—and Yankees in the winter. It's to be hoped he will protect his skin to weather the storm in the White House, as reflection points to many of a violent nature.

The business man wants to impress the public with the fact that he is fast getting away from war-time prices by reducing wages and a general cutting down of expenses. However, he forgets that war-time dividends will have to go too before readjustment is accomplished. And that is the saddest part of all.

Foreign buying has helped in boosting wheat prices lately. The fact goes to show what the same kind of buying would mean to the tobacco industry and cotton, also. Farmers should keep this in mind, reduce acreage this year, relieve congestion and be in position for the harvest to come within the next several months.

President-elect Harding isn't much on pomp and splendor when the government has to pay dearly for it as was shown in abandonment of plans for social activities during the inauguration. He has set a mighty good example for the country, for when leaders in government discourage it is easy to believe the public will fall in line. This has been the case for numbers of years, and should be so at this time.

Reports of Raleigh banks as presented in yesterday's edition of the News and Observer showed that they have been able to weather the general depression in a satisfactory way. Such reports show up in a gratifying way certain forces endeavoring to enlarge the panic scare. Hereafter the banks need have no fear regarding deposits as the public is just beginning to realize the truth of the situation.

The governor of the Federal Reserve system has requested the public to forget the "buyers strike" which has been in progress for some time, declaring that such a state of affairs brings about unemployment which in turn has impaired the public's purchasing power. The statement no doubt is true, but if he recalls it, the public is "dead broke" according to version of prominent persons promoting the strike. However, if he'll manage to induce people to patronize national banks more than they have for the past few weeks, an improvement in the strike will take place, otherwise we can see no early relief. The truth of the situation lies in the "panic scare" that has pervaded many sections of the country, bringing disturbed economic conditions, and cannot be improved until people wake to the truth. When this occurs business should become better, banks stronger, and the whole country happier. The strike is to be deplored, but there is no one to reproach but the hard time compeller.

Opening of tobacco market in Eastern North Carolina shows that reductions of acreage is the only way to bring about an improvement in prices. The situation now is similar to the opening period and promises no change for the better. Leading tobaccoists believe the farmer will be threatened by bankruptcy if acreage is not reduced, and as there is no alternative it is the only course to pursue. Low prices are general both in the bright and burley producing territories and if the farmer does not curtail his crop as advised the market will be gutted completely and industry placed in a position from which it will be long in recovering. There is nothing to do but cut the crop down to half and plant food crops on surplus acreage. Congestion will be relieved to such an extent that foreign demand will be better next year, and in the course of a few months depression will be forgotten and growers placed in shape to meet just obligations which have been a source of constant worry since opening of markets.

Henry W. Grady, who twenty years or more ago was the South's leading orator and statesman, must have looked with prophetic eye to a day like the present when he uttered these words: "When every farmer in the South shall eat bread from his own fields and meat from his own pastures and disturbed by no creditor, an enslaved by no debt, shall sit amid his teeming gardens and orchards and vineyards, pitching his crops in his own wisdom and growing them in independence, making cotton his clean surplus and selling it in his own time, and in his chosen market, and not at a master's bidding—getting his pay in cash and not a receipted mortgage that discharges his debt, but does not restore his freedom—then shall be breaking the fullness of our day."

If every planter in the South would farm on this plan the mention of hard times and depression from low prices would be always of the past.

Captain J. J. Laughinghouse tells the News and Observer that he is opposed to any attempt to discourage capital punishment in this State, and means to tell the legislature so. His expression will meet general favor in many sections, for it is realized that law cannot be upheld when the fear of having one's life snuffed out for committing a crime is removed. There is enough crime as it is, but with the law removed no one can possibly conceive the scope which it would assume. Captain Laughinghouse has taken up a mighty timely subject, and knows enough about conditions existing in this State and other parts of the country to put up determined opposition.

Uncle Sam and John Bull understand each other so thoroughly that it is not probable any trouble will result from alleged surveillance by the British government of cable messages passing through the British Isles. The two nations have transacted too much business to let such a small matter trouble them in this great period of social unrest and economic disorder, and the public need have little fear concerning the outcome. Neither would refuse reparation in case of damage to property, therefore, the present misunderstanding will be easy to settle to satisfaction of both.

The Austrian government is in a condition of bankruptcy and no longer in position to continue, according to reports received in this country. The situation is not surprising in the light of the active part the nation took in the recent war. She should appeal to Germany for help and receive in return some autocracy. That's what they tried out on the rest of the world so unsuccessfully.



Though he recently inherited \$60,000 through the death of his uncle, Abraham Schneider, seaman on the U. S. destroyer Wadsworth, stationed at the Philadelphia navy yard, announced he intended to "tick by the navy." He is the son of Mrs. Annie Schneider of Boston, Mass. He will receive the income of the \$60,000 until October 4, 1921, when he will be twenty-one, and receive the principal.

KNITTING CRAZE HITS VIENNA
Vienna, Jan. 12.—In Vienna just now there is as great a craze for knitting as there was in England during the war. This revival is due to Major Bateman, the American Red Cross Commissioner, because it was cheaper for America to furnish wool than furnish garments for the people of Austria. He organized a band of "Volunteer Knitters" whose number has now grown to 20,000 women and 100,000 children. The yarn with which they work is furnished free and the finished garments, most of which are for the smallest children, are distributed through American organizations.

Austrian women invented the so-called "continental" method of knitting, which is said to be faster than any other and involves fewer motions, the familiar clink of the needle for instance being entirely absent. They claim to be the best knitters in the world and have already turned out thousands of garments, using up the wool faster than it can be supplied.

DUELLING HARMLESS SPORT IN MEXICAN TERRITORY
Mexico City, Jan. 13.—Duelling as practiced in Mexico is the most harmless of outdoor sports. Although scarcely a week passes but some person whose pride has been hurt challenges the offender to "pistois at twenty paces in the Bosque of Chapultepec," few reach beyond the stage of talk and none even venture close to reality.

A deputy from one Mexican state rises in the chamber and bitterly assails a member from another state for his attitude on certain public measures. The other replies with equal vituperation. Before the day is done the chances are a challenge will be carried to one or the other by two seconds who later describe their efforts in a verbose report to all the newspapers.

Once in a while a challenge will be accepted and then there is a scramble on all sides to see that the "government intervenes" at the proper moment. Whether there is official "intervention" is conjecture but the announcement is always the same—that "high authorities frowned upon the contemplated struggle to death and forbade." Pride is always satisfied by such announcement and the incident is forgotten.
