## Army Sentences to Be Reduced By New Legislation

Bill To Go Into Effect Today for Grading Down Severity of Court-Martial Sentences.

ORDER FROM PRESIDENT DIRECTS REDUCTION OF MAXIMUM PUNISHMENTS

Executive Order Will Not Result In Radical Reduction of Penalties, It Is Stated.

Washington, Feb. 4.—Reduction in the number of dishonorable discharges from the army and a grading down in the severity of the courts-martial sentences are expected by the Judge Advocate General's Department to result from an executive order limiting military peace time punishment which goes into effect tomorrow. The order follows wide agitation over court-martial penalties during the war period.

A memorandum from the President attached to the order directs that maximum punishment and dishonorable discharges be imposed only in aggravated cases. This was expected to have more effect in reducing penalties, it was stated than the actual order, which reduces punishments for 21 different offenses under the military code.

The old maximum for 18 months confinement for desertion by men less than one year in service has been reduced to one year, and in cases of more than 6 month's service, from 2 1/2 years to two years. The period of absence for which desertion penalties can be imposed is increased from 30 to 60 days.

The maximum penalty for fraudulent enlistment has been reduced from one year's imprisonment to six months. The greatest reduction of maximum confinement is for assault without deadly weapons, which was 5 years, reduced to one year. The maximum where weapons are used still is 5 years.

The maximum for obtaining under false pretences money or property valued at \$50 or more is reduced from 5 years to years.

The executive order will not result in a radical reduction of penalties, Colonel C. A. Kreger, Acting Judge Advocate declared. "Punishments for offenses in the army have been based since 1914 on a consensus of those fixed by different state laws for similar civil offenses. The executive order reduces maximum penalties for such offenses as fraudulent enlistment, desertion and other peculiarly military in nature, but maximum penalties seldom have been awarded for these offenses.

## German Shipping Interests Begin Great Campaigns

Despite Lack of Tonnage and Shortage of Coal a Determined Campaign Will Be Waged.

Hamburg, Germany, Feb. 4.—Despite lack of tonnage, shortage of coal, labor troubles and a depreciated currency, German shipping interests have begun an intensive campaign to revive pre-war sea trade. Millions of marks have already gone into important ship-building contracts.

Hugo Stinnes, reputed to be the wealthiest man in the new republic and a heavy shareholder in a number of shipping companies, is reported to be attempting to extend his influence which is now the controlling factor in the German East Africa line and the Woermann line, and an important factor in the affairs of the Hamburg-American line.

Regular steamship services with America, South America, East Africa, Mexico, Cuba, Portugal, Australia and Mediterranean and Scandinavian ports have been reestablished and the North Sea, Baltic and Rhine traffic has assumed a new and lively aspect. Handicapped by shortage of ships the Germans have turned their attention to conversion of warships to commercial usages, to construction of motor ships out of sailing vessels, and to the study of oil-fuel as a substitute for the more expensive coal fuel.

Revival of German commerce is indicated by the increased number of ships calling at the more important ports. During the first 11 months of 1920, 4,369 vessels of a tonnage of 3,892,240 arrived at Hamburg, as compared with 1,854 vessels and 1,303,629 tons in 1919, and 13,875 vessels of 13,006,426 tons in the first 11 months of 1913.

The majority of these vessels, however, are sailing under foreign flags.

## Health Officer Urges Citizens To Keep City Clean

States In Order to Have Health City Must Be Kept in Sanitary Condition.

UNLESS PEOPLE HEED THE REQUEST THE LAW WILL BE STRICTLY ENFORCED

Clean streets and alleys are a city's best advertisement. The way to get them is to go after them. All-together in a regular campaign.

Our streets and alleys need cleaning. Perhaps we have become so accustomed to seeing them littered with refuse and accumulations of trash that we do not realize how dirty they are. If they were once thoroughly cleaned, we would see the difference. Strangers from other cities, where clean streets and alleys are normal, notice the difference and comment upon them when they get home. That is not a good advertisement for any town. If cleanliness of the person is next to godliness, surely cleanliness of a city is next to prosperity. It is easy for a visitor to believe that if the city is clean, it is also prosperous. He will go home and say so and that is the best kind of advertisement.

No town ever suffered in the eyes of strangers or got a bad reputation from having clean streets, bordered with shade trees, well trimmed and cared for, with yards and houses bearing evidence of being well kept. Such a city is like the refreshing ocean breeze to the traveler who has gone from one dirty city to another until he is almost lost his anticipation of finding cleanliness and beauty in a municipality. The impression that a clean city makes upon such a visitor will make him talk about it wherever he travels.

To make a clean city, its streets, alleys, back yards and vacant lots must be thoroughly cleaned. The visitor does not get much opportunity to see the alleys, but that is no reason why they should be permitted to be dirty and unsanitary. The public health is even higher consideration than a reputation for cleanliness and beauty. No matter what the city government may do toward keeping the city clean, experience shows that it does not succeed and it will never succeed alone. Gradually refuse accumulates everywhere. There is only one way to make a complete clean-up and that is for the citizens to unite and do the job themselves, with official aid, of course. Then there is only one way to keep the city clean, and that is through the citizens themselves.

After such a campaign is through, a city is actually clean, far different from its former condition, no matter how clean the people have imagined it to be before the campaign. Clean streets, alleys, back yards and vacant lots can be secured when all the people get on the job together and at the same time. Every public improvement organization, every club, every neighborhood, association, every municipal department should be united in one great and practical effort to create a state of cleanliness and then they should determine to preserve that condition, keeping it up. The city that keeps everlastingly clean also keeps everlastingly growing. What Greenville needs is some of the strong growing pains produced by shovels, rakes, mowing machines, brooms, water, dump carts, scrub and paint brushes in the hands of some of the citizens of Greenville who are apparently blind to filth and the many unsanitary conditions that actually exist in our home town today.

I do not like to be compelled to force anyone to clean their premises and vacant lots, but I am going to show the few who ignore this little hint or warning that the town of Greenville has an ordinance that will make them clean up and help us have a clean town. Enlist in the clean-up campaign and see Greenville. It will help you as well as your neighbor.

## Declares Aid Of Federal Reserve Needed On Farms

Notes With Twelve Month Period of Maturity Would Help Farmers Over Bad Situation.

ARMENIA IN IMMINENT NEED OF WHEAT CROPS FROM THIS TERRITORY

Member of Federal Reserve Board Tells Marketing Conference of Prevailing Situation.

Madison, Wis., Feb. 4.—Federal Reserve paper with a nine months or twelve months period of maturity would greatly assist the farmer and overcome to a great extent the predicament the tillers of the soil find themselves in at the present time, according to A. F. Lever, member of the Federal Farm Loan Board, who addressed the Marketing Conference here today. "The question uppermost in the minds of farmers is what happened to bring about the present situation," said Mr. Lever. "What has occurred to justify a slump in prices of farm products ranging from 50 per cent. to 100 per cent. within a period of 12 months?"

Certainly there are no less mouths to be fed now. The yield for 1920 was not unusually large.

The starving children of Armenia need your wheat and corn and livestock, but they have nothing with which to pay for it. The domestic consumer of farm products is on the buyers' strike. He is refusing to buy at the exorbitant prices demanded by some retailers, except as he must buy to meet immediate needs.

The domestic manufacturer, the wholesaler and the jobber, because of the uncertainty of the price of the raw material and the demand for finished product, are, as it were, dancing the hesitation, and they too are in the market only to fill immediate needs.

The underlying cause has been that a farmer has been taught to walk the furrow and produce, and per capita he is the best producer in the world. We have taught him to become an expert with his hands and have left him as a child in the use of his head in the management of his affairs, other than production.

## Gov. Morrison to Make War On Klan In Carolina

Has Under Consideration Measure Which Will Prohibit Klan's Work In State.

Raleigh, Feb. 4.—Governor Cameron Morrison is not only opposed to the organization of the Ku Klux Klan in North Carolina but has under consideration a measure which will prohibit the operation of the Klan in the State.

The Governor is standing flat-footed against any organization which attempts by secret means and processes to enforce the law in the State. This, the Governor believes, is the function of the State and the Federal government and there is no authority under the spirit of law at least for the underwriting of its processes by secret order. This, the Governor understands, is the purpose of the Ku Klux Klan.

Governor Morrison is ready to concede high services rendered by the Ku Klux Klan in the dark days of reconstruction. There was justification then, according to his views, because the law had fallen down and because such a step was necessary to maintain Anglo Saxon civilization in the South.

At this time the law is abundantly able to cope with any situation which develops, and if not, the General Assembly of North Carolina is biennially in session, subject to call into special sessions at any time, and it may provide new law if that is needed.

Just what steps the Governor anticipates taking is problematical. It is known that he has conferred with a number of interested men in the State concerning this order and feels very deeply concerning it.

## Sinn Feiners Hold Sway In Official Circles of Dublin

Institution Considered the Only Legitimate Authority In Country at Present Time.

Dublin, Feb. 4.—The Dail Eireann, the Sinn Fein Parliament in the minds of an overwhelming majority of the Irish people, continues as the dominant—the only legitimate authority in Ireland. It is created as an authoritative body. None of the municipal or county bodies which pledged allegiance to it have withdrawn from that position.

The Dail Eireann's instructions are obeyed by these subsidiary bodies and all dealings with the Irish local government board, which represents the British government, are barred. For this reason the board is unable to make its customary audit of county and city accounts. The result is increasing difficulty in every district.

"Rate," or tax collectors are faced with two sets of instructions—one from British government representatives, or the Local Government Board, the other from local Sinn Fein authority. A King's bench decree, designed to compel these collectors to obey the law has been unavailing. Obedience of Crown instructions, in many cases, would doubtless bring severe punishment, if not death, to the collector.

Tax collecting, needless to say, is not brisk. The balances in local treasuries are proving insufficient to enable authorities to maintain public institutions. In Sligo, banks have refused to permit overdrafts, and there is no money to pay the contractors who are therefore withdrawing their services. Patients in hospitals are without sufficient food and the inmates of the poorhouse are in a similar plight.

The Chairman of the Board of Aldermen approved the suggestion of Dail Eireann that leading men of the city be asked to advance fifty pounds each to relieve the situation, but there was no response.

In Queen's county, the greater part of the taxes of the county, amounting to about 60,000 pounds, remains uncollected, and the resources of the county are exhausted, involving serious consequences to the lunatic asylum and several hospitals. The county council at its meeting resolved to ask the advice of Dail Eireann. They have no doubt of its ability to meet, and are willing to act upon its instructions.

## SHORTAGE OF COAL DRIVES POOR CLASS TO STEAL SUPPLIES

**Situation in Budapest Assumes Serious Proportions, Causing Wholesale Thievery.**

Budapest, Feb. 3.—Many of the poor people of this city are being driven to wholesale thievery by the fuel shortage. The recent theft of 25 carloads of wood from one train of 100 carloads as it entered the city shows the extent to which the stealing is going on.

Wood is so scarce that when a kagon load is driven through the streets people stop and gaze after it until it is out of sight.

Baring small boys are ever on the alert for a stray piece of wood or anything that will give heat at home. They scamper after every passing wood wagon but are soon frightened away by long whips in the hands of two women who sit on guard astride the load.

The operation of unloading a ton of Hungary's inferior brown coal before a house attracts many neighbors who make a pathetic picture as they watch basketful after basketful disappear into the coal bin of the more fortunate one.

Because of the urgency to obtain fuel, by dishonest means, if honest ones are of no avail, the juvenile courts were never so crowded with youthful offenders.

The scarcity of fuel arose more acute daily as winter advances. The street railway service has been sharply curtailed and people wait for hours exposed to the bitter cold. The worst operated American street car never tolerated such crowding.

Gas factories are provided with coal for only 24 hours at a time and the gas is turned on now only at noon and after 6 o'clock. Only one light is permitted in a room and not more than three rooms in a house or single apartment may be lighted at the same time. Even at the most expensive hotels there is no running hot water. Saturday is a thing day. On other days baths can only be had at the public baths for which Budapest is famous.

## PROVIDE PLANS TO RECLAIM FORESHORE OF LAKE MICHIGAN

**Reports of District War Department Says 100 Square Miles of Land Would be for Warves**

**CHICAGO DISTRICT WOULD BE GREATLY BENEFITED BY PROPOSED IMPROVEMENTS**

Chicago, Feb. 3.—Reclamation of the foreshore on Lake Michigan in the Chicago district would provide nearly 100 square miles of land for wharves, warehouses and ports facilities, according to a report submitted to city official by Col. W. V. Judson, District War Department Engineer.

The report calls attention to the fact that ocean liners may dock at fifteen years if the Great Lakes-St. Lawrence River channel project is carried out. Such an outlet to the at-the-sea routes of the world. The coal mines of Illinois and the cotton belt of the south will feel the touch of Chicago commercial endeavor through an eight foot barge channel to the Mississippi. Never before did it seem as fair to point out in prophecy a region where must in evitably and soon be established the world's greatest port facilities, the report says.

The foreshore of Lake Michigan from Chicago slopes very gently Lake-ward, the report continues so that the seven fathom contour is four miles off shore. This means that in our submerged lands, all publicly, the Chicago district possesses nearly a hundred square miles any part of which it is within the power of man to raise into land. This is an asset of almost incalculable value.

Reviewing the sections of Chicago's lake front, Col. Judson points out that Lake Wolf and George lie close to Lake Michigan.

Mrs. Vanderbilt, according to reports from Raleigh, made quite an impression in her first appearance before the legislature. She informed her hearers at the outset that she did not know much about speaking but she had an idea that a woman's speech ought to be like a skirt—long enough to cover the subject, but short enough to attract attention. The remark produced a delighted outburst of applause from both men and women, and vigorously so, as such tact coming from such a splendid woman was worthy of admiration.

A severe shortage of coal has driven poor people to thievery in Budapest, according to information received in this country through Associated Press dispatches. It is natural to expect such conditions to prevail in that part of the world where economic conditions have been disturbed for such a long time, and there will hardly be any relief until people forget the parit belligerency that has been the cause of it all. The United States might have had to deal with coal thieves if prices had not been reduced, but fortunately there has been such a decline lately that the average workingman can afford to provide his home with fuel without resorting to more desperate measures.

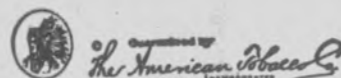
An official count of government funds now on hand shows that in cash and securities the amount totals some over thirteen billion five hundred million dollars. The statement may sound strange coming as it does from a man in position to know, and is deserving of greater consideration than anything which heretofore has been uncovered by official investigations.

The Standard Oil Company found it advisable to reduce the price of gas one cent on the gallon. And to make up for the shortage of funds this would bring about at the end of the month, advises employee of a ten percent reduction. That may be on account of hard times, but it is mighty sound business policy under any conditions.

# OFFICIAL COUNT OF GOVERNMENT CASH COMPLETED TODAY

Total Amount in Treasury Department Amounts to \$13,500,000,000 In Cash and Securities

## COUNT MADE BY SPECIAL COMMITTEE OF THREE IN PRESENCE OF ARMED MEN

Washington, Feb. 3.—A complete count of the Government's cash has just been made for the first time in twelve years. The total approximated 13 billion, five hundred million dollars and included all cash and securities held as reserves against currency outstanding.

The count was made by a special committee of three assisted by eight accountants and by fifteen laborers who were used to move around the heavy sacks of gold and silver. The men delved into great vaults in the Treasury building and took stock of gold, silver and paper money and securities many of which had not seen the light of day since shortly after William Roward Taft was Inaugurated President and a new treasurer of the United States appointed in 1909.

The accountants in entering the vaults passed grimvisaged guards who day and night sit on the lid to prevent any possible attempts at an unauthorized raid on the treasury. The

vaults themselves are supposed to be burglar proof and are of massive concrete and steel construction. The storage sections are kept under seal and this was the first time that some of them had been opened in twelve years for when John Burke became treasurer after President Wilson was first inaugurated he accepted the count of cash in the storage sections which had not been opened since the previous count in 1900.

## Cloture Motion Finally Voted Down and Republican Unable to Decide Date to Vote

Washington, Feb. 3.—Shoving aside all pending legislation, including a dozen big appropriation bills, the Senate today voted to continue consideration of the Fordney emergency tariff bill. The gates were opened wide for a flood of oratory when a petition for the use of cloture in the tariff debate was voted down 36 to 35, mustering far jority.

In a session marked by political jockeying, debate consisted of short but heated speeches. Attempts were made by each side to lead the other into pitfalls. Republican leaders sought to avoid cloture, but the Democrats challenged that it be brought in and then marshalled their forces, defeating it pty. Minority members then sought a unanimous consent agreement fixing a date for a vote on the tariff only to have one of their own ranks enter objection.

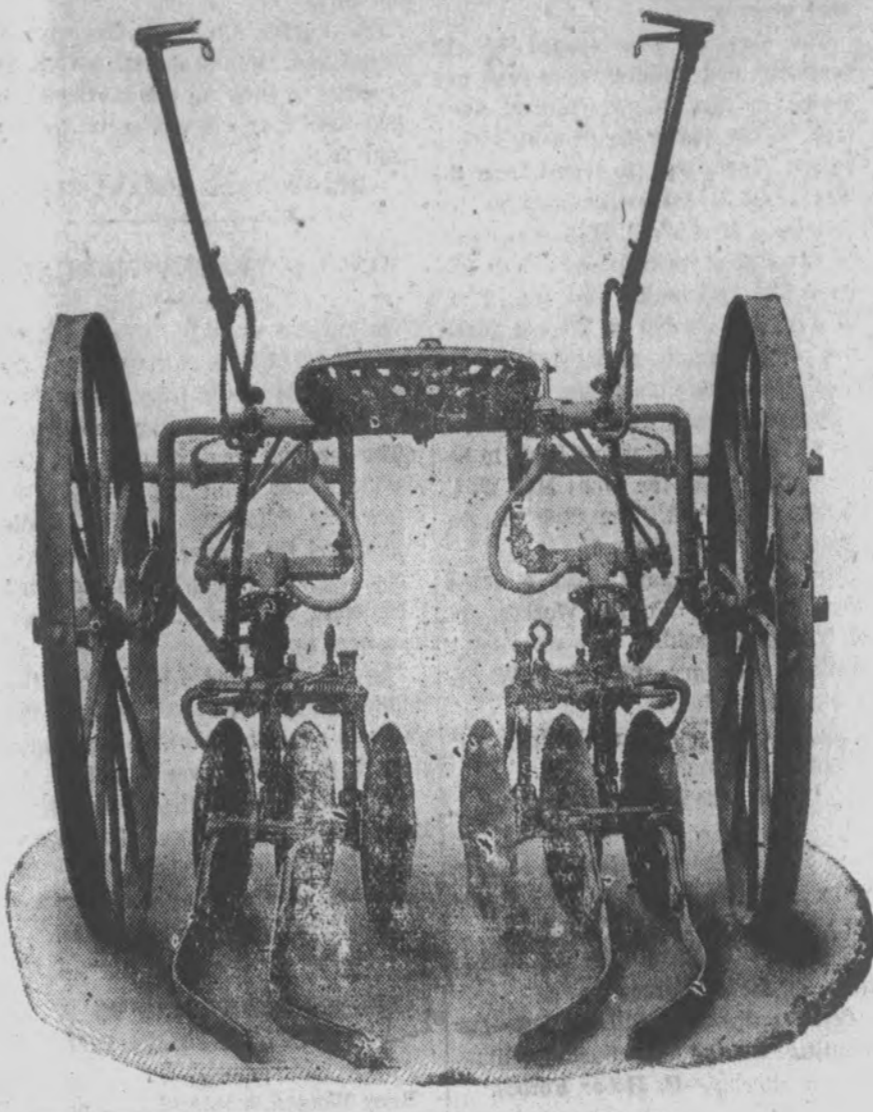

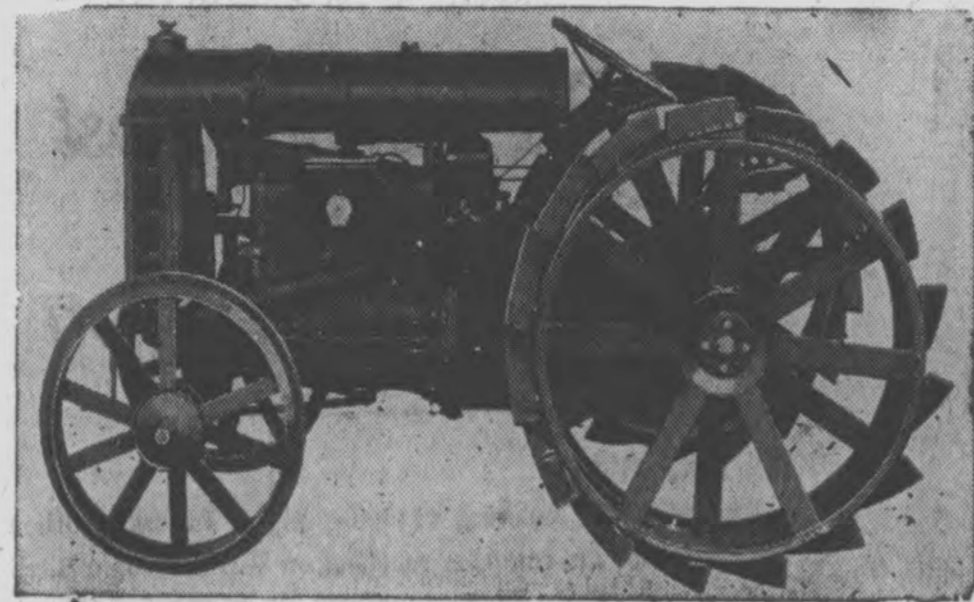

# CHICAGO BANKER BITTERLY ASSAILS REPUBLICAN PARTY

Charles Dawes, Among Those Mentioned for Harding Cabinet, Attacks Recent Critics

**FIRMLY CONDEMS MANY MEMBERS RESPONSIBLE FOR BAD STATE AFFAIRS**

Former Chief of Procurement for American Army in France Hands Old Guard Hard Blows

Washington, Feb. 2.—Declaring he was not in politics and was not going in, Charles G. Dawes, of Chicago, former chief of supply procurement for the American army in France, bitterly attacked today what he charged were political attempts to discredit the achievements of the people who won the war.

In the course of a five-hour examination by a House war investigating committee, Mr. Dawes struck with sledge hammer blows at critics who had tried, he said, to detract from the glory of the great achievement by picking flaws and parading trivial faults three thousand miles away. At times the air was thick with a streak of oaths for which the witness frankly confessed he had neither apology nor excuse.

Late in the day he reiterated an earlier off-hand statement as to his own part in politics which was accepted to mean that he would not become a member of Mr. Harding's cabinet, a position with which his name has been linked. Even before his views on this subject were expressed, Mr. Dawes sharply denounced the present system of conducting the Federal government an evil of a hundred years' standing, he declared with which investigators might better afford to deal instead of trying to scoop up water already over the dam.

Mr. Dawes was called by Democratic members of the committee to rebut testimony relating to waste and extravagances and particularly with reference to liquidation of American accounts in France and sale of surplus stocks to the French government. Answering charges that food and clothing supplies might have brought more than the \$400,000,000 paid by France, Mr. Dawes turned sharply upon one of the questioners, Representative Bland, Republican, of Indiana, and shouted: "It is just that sort of fool argument that forced Great Britain to hold on to its stock and attempt to drive a hard bargain. The stuff is there today, rotting. You cannot discuss an expert question 3,000 miles away. There is no use to try and throw mud when you were not there to know conditions. England lost billions of dollars by listening to that sort of talk—listening to a lot of people who were afraid of muckrakers at home. They are raising the devil in England now because England did not sell its supplies when we sold."

# DETAILS OF INDIAN NATIONAL CONGRESS RECEIVED IN U. S.

Text of Resolutions and Addresses Reach Commissioner of Indian Bureau in New York.

New York, Feb. 3.—Details of the debates in the session of the Indian National Congress held at Nagpur, Central India, in December, have just been received in the mails by the India Reformation Bureau in New York, with the texts of resolutions and addresses, etc., at the congress, which have been briefly referred to in cable advices. Twenty-two thousand delegates from all parts of India, including several thousand women, assembled at the congress, and decided upon an extension of the movement now in progress, including non-payment of taxes as an extreme measure.

One of the resolutions adopted amended the constitution of the congress, so as to secure the attainment of the 'swaraj' (national sovereignty) by all peaceful and legitimate means. A significant omission from the resolution was the clause referring to the use of constitutional methods for the attainment of self-government within the British empire.

Other conferences held at Nagpur took the general attitude expressed by the congress. The All-India Students' Conference passed a resolution in favor of immediate and unconditional boycott of the government and the government-aided schools and colleges. Lajpat Rai presiding at a conference held for the purpose of protecting cattle against slaughter and export, declared that the cattle question could not be settled until national sovereignty was obtained.

The opening speech of the presiding officer of the congress outlined a plan for the immediate boycott of British

trade. In order that the ruling power may be gradually exhausted, he advocated a plan by which English planters, merchants, traders and manufacturers in India may be faced with a scarcity of labor. This, he maintained, would produce national strikes of unskilled workmen in the railway, postal and telegraph departments.

## NEW ORLEANS NEGRO

### POPULATION SHOWS INCREASE

Washington, Feb. 3.—The negro population of New Orleans is now 100,918, an increase of thirteen per cent. Newark, N. J., shows an increase of 79 per cent., with a population of 17,010.
