FORTY KILLED IN SERIOUS WRECK AT PORTER, INDIANA

New York Central Express Crashes In-
to Derailed Michigan Central
Train at Junction

MANY PERSONS INJURED
AND TWO COACHES TORN
TO PIECES IN COLLISION

Towerman Arrested Immediately
Charged With Negligence In Leav-
ing Switch Open

Porter, Ind., Feb. 28.—Between 30
and 40 persons were reported killed
and an unknown number injured to-
day when a westbound New York Cen-
tral train crashed into a derailed train
here, in which officials said may be
one of the most disastrous wrecks in
history.

Michigan Central officials placed the
number of dead at 30, while unofficial
reports made the death list as high as
fifty.

The towerman of the Michigan Cen-
tral was arrested immediately after the
wreck, officials saying they believed
he had left a switch closed causing the
derailment of the eastbound train.

The Michigan Central train left Chi-
cago at 5:05 p. m. bound for Toronto,
Canada. It was cut in half by the west
bound flyer and both engines plunged
down an embankment.

Both enginemen of the New York
Central train were killed. The engin-
eer was Claude Johnson, of Elkhart,
Ind. Five bodies were recovered near
the debris of the two engines.

Fifteen bodies had been recovered
within a few hours after the wreck.

It is believed that virtually all of the
dead were in two of the Michigan Cen-
tral coaches, which were demolished
when the New York Central hit it.

The only dead known on the New
York Central train were the two en-
ginemen. The engineer of the Michigan
Central is missing. It was reported
that he leaped from his cab when he
saw the oncoming New York Central
train.

The tracks of the two railroads in-
tersect here at a sharp angle, being
almost parallel. The Michigan Central
train was believed to have started across
the intersection and then to have been
derailed. The towerman was blamed
by railroad officials for allowing the
Michigan Central train to attempt to
cross ahead of the westbound train.

She left on the afternoon train for
Kinston, where she will be for a ten-
day period.

MERCHANT KILLED BY STORE LOOTERS AT WASHINGTON

Former Greenville Man Dies From
Wounds Inflicted By Unknown
Persons

Washington, D. C., Feb. 28.—As the
result of his injuries and great loss of
blood, his brain crushed in several
places of his body, E. G. Worthington,
local merchant died at the Fowle Me-
morial hospital Sat. evening at 6 o'clock
as the result of a brutal attempt at mur-
der early in the morning. The identity of
the men who assaulted him is unknown.
Robbery is believed to have been the
motive of the attack. Bloodhounds
were on the scene this morning but
were unable to take up the trail due
to the large number of persons who
had visited the store.

The first one to learn of the assault
was a young man who arrived at the
store about 8 o'clock this morning to
bring Mr. Worthington his breakfast.
The boy tried to get in the front door
but found it barred. He could hear
someone moaning inside the building.
Going around to the side door he gained
entrance and found the man lying on
the floor, unconscious, and his head in
a pool of blood. Closer to the front
window was more blood. The body
when found was behind one of the
counters. It is believed that Mr.
Worthington had been knocked down
near the window and that the robbers
had then dragged his body across the
floor in order to prevent passers-by
from seeing it.

There was plenty of evidence that
the men were after money. The cash
drawer had been broken into and was
bare when opened this morning. Mr.
Worthington slept in a small room over
the store. The robbers went over it
thoroughly. Clothing was found
strewn about and a suitcase had been
broken open. How much money the
thieves obtained is unknown.

After finding Worthington, the boy
ran outside and told the news. The
police were notified immediately. They
inspected the premises but nothing
could be found to give any idea as to
who the men were. In the meantime
Worthington was taken to the Fowle
Memorial Hospital.

Mr. Worthington came here from
Greenville. He has been in business
here for some time but recently moved
to his present location. His wife and
several children are living in Green-
ville.

DELIVERS SPLENDID TALK TO MEMBERS OF ROTARY CLUB

Rev. S. K. Phillips, Pastor Presbyterian
Church In Stirring Appeal to Or-
ganization Last Night

Following is a synopsis of the ser-
mon delivered by Rev. S. K. Phillips
to Rotarians in the Christian church in
this city last night. The services were
largely attended by members of the lo-
cal Rotary Club as well as many citi-
zens:

Mr. Phillips took as his text Luke
2:22, "And Jesus Increased in wisdom
and in stature and in favor with God
and man." He showed that these
words were statements of the growing
program of Jesus of Nazareth. It was
God's program for his development
and because He was God's ideal son,
men today dare not chose a plan of
development other than His. Jesus
did not stand still mentally. He did
not stand still physically. He did not
stand still spiritually. He did not stand
still socially. He developed his mind,
his body, and his soul and his social
life.

He declared that God's man in the
world today is not the intellectual
giant, with a neglected body, a shriveled
soul, and a great chasm between
himself and his fellowmen. He is not
one-sided, a two-sided, or even a three
with a keen mind, a sound body, a soul
in touch with the eternal, and a hand
clashed with a mighty grip to the need
of his brothers everywhere.

He then showed that Rotary has or-
ganized in the world to promote this
program. Rotary business is to stimu-
late mental development, increase
physical fitness, bring men into touch
with God, and to practice the service of
Jesus Christ.

He declared that Rotary motto, "He
profits most who serves best," did not
come from the lips of Paul E. Harris
and the men who wrote her code of
ethics, but fell from the lips of Jesus
more than nineteen centuries ago, and
that Jesus was the words first and
supreme Rotarian. He said that Jesu
was the very heart of Rotary, and
as he laid bare that great heart going
out to meet the mental, physical, spiri-
tual and social needs of the world, ev-
ery Rotarian present felt that Rotary
should lead him in the footsteps of the
Great Master.

The sky-pilot of Rotary in Greenville
certainly showed to his comrades and
those who heard him, that in preaching
Jesus of Nazareth and practicing His
religion everywhere, a man was repre-
senting Rotary aright, and could not
call himself a true Rotarian until he
recognized Christ as the foundation
source of all that Rotary has for the
world today.

TEMPORARY BODY OF YORK MASONS ORGANIZED HERE

Knight Templars Desirous of Obtain-
ing
Commandary Meet and Form
Tentative Plans

Knight Templars of Greenville and
Pitt county desirous of obtaining a
Commandary, which is the highest
body of York Rite Masonry, met last
Friday afternoon in the office of H. A.
White and perfected a temporary or-
ganization known as the Bethlehem
commandary. The officers elected are
W. H. Horne, eminent commandary; J.
N. Hart, Rev. Frank Scattergood, cap-
tain general.

This organization is to petition the
Grand Commandary of the State at its
meeting in Asheville in May for dis-
pensation. There are at present 27
commandaries in the state and if this
is granted it will make the 28th.

The organization of this body speaks
well for the local men engaged in the
work, and should be a great incentive
for increasing the score of fraternal
activity.

AMERICANS SHOW MUCH INTEREST IN POSTAL SERVICE

Convention Between Spain and Seven
American Republics Drawing
Great Attention

Washington, Feb. 28.—Widespread
interest in the application of the new
postal convention between Spain and
the United States, is being shown
by American business men.

Its full significance in the way of
stimulating trade, correspondence and
the interchange of periodical litera-
ture between the countries involved is
not properly appreciated by the public,
Otto Praeger, Second Assistant Post-
master General, said today.

Mr. Praeger headed the American
delegation to the convention Univer-
sal Postal Union in Madrid last Novem-
ber, there the Latin American re-
publics with Spain and the United
States refused to follow the lead of
other European countries in doubling
existing foreign and domestic rates.

It means that a mail order house
in Chicago can now circularize Lima,
in search of customers for the same
amount of money that it can circularize
any American city. Mr. Praeger said.
Great newspapers can extend their mail
circulation to all the signatory coun-
tries at domestic rates, while books
and commercial samples may flow
back and forth between the United
States and South America or Spain
with the same facility, and at the
same cost as between New York and
Philadelphia. The advantage which
will accrue to American business can
only now be estimated but it will be
enormous.

SUPREME COURT TO DISPOSE OF SEVERAL ISSUES

Number of Cases National Importance
to be Virtually Disposed of At
Hearing Tomorrow

Washington, Feb. 28.—Decisions in
some of several cases of national im-
portance may be handed down to mor-
row by the Supreme Court, which will
end a months recess taken to study
and reach conclusions in issues pre-
viously argued.

Among the cases in which argu-
ment have been heard are several ex-
pedited at the request of the govern-
ment on the ground of their impor-
tance to the public welfare, but it
does not necessarily follow that de-
cisions in any of these will come to-
morrow.

The appeal of Senator Truman H.
Newbury, Republican, Michigan, from
conviction for conspiracy to violate
the Election Law, is expected to be
court far ahead of the others because the
government said it was necessary that
Mr. Newbury's claim to his seat be
decided if possible before the session of
the new Congress expected to be cal-
led shortly.

Two internal revenue cases the so-
called invested capital and capital as-
sets cases which have been argued,
have been declared of first importance
in connection with the federal finance
hundreds of millions of dollars in ex-
cess profits taxes must be returned if
the government loses both or either
of these suits.

Ten cases involving the validity of
the Lever Act, the weapon of the gov-
ernment in fighting profiteering, have
been waiting judgement as has the
single case brought to test the Farm
Loan Act. In Atherton Mills vs John-
son the court has before it the question
of the constitutionality of the law im-
posing a special tax on products of
child labor moving in interstate com-
merce.

POLISH CONTINUE BATTLES AGAINST UPPER SILESIA

Campaign Against Section Being Direct-
ed Determinedly From Ricketty
Buildings in Bethun District

Bethun, Upper Silesia, Feb. 28.—The
campaign into which Poland has en-
tered to gain control of the rich Up-
per Silesian industrial centers through
a plebiscite victory, probably in the
middle of March, is being directed from
a ricketty three story hotel here which
has been purchased by Wojciec Kor-
fanty, director of Polish propaganda,
plastered with anti-German placards,
filled with propagandists and organi-
zers and guarded from outside and in-
side, day and night by armed men.

Korfanty, himself, who formerly was
a member of the Reichstag, and now
is the bugbear of the German mine
owners here, has offices in the building
but they are available only to those
who have unquestionable credentials.
German residents and officials leave
him severely alone.

Some of the huge posters in the
building are relics of war propaganda,
one of them picturing three old wom-
en before a firing squad of German
soldiers. Under the placard, is the
legend "Gtoszy za polska"—vote for
Poland—and under this the same ad-
monition is written in German. All
the posters in addition to the Polish
legends are interpreted in German, for
many of the people of Polish extrac-
tions cannot speak the Polish lan-
guage.

Korfanty received The Associated
Press correspondent with a brisk and
cheerful greeting. He was addressed
in neatly tailored clothes, affected a
monocle and was surrounded by many
assistants, one of whom stood im-
mediately back of him during the whole
of the conversation.

In view of the Polish exchange situ-
ation, Polish money selling then at
ten to one in favor of the German mark
and reports of unemployment and fi-
nancial distress in Poland, Korfanty
was asked what benefits the working
population of Upper Silesia could ex-
pect from a union with Poland.

LIFE OF CRIMES IS SET FORTH BY LOCAL SOCIETY

Singletary Chapter, Daughters of Con-
federacy, Present History of Gen.
J. Bryan Grimes to the Public

The Singletary Chapter of the Daugh-
ters of Confederacy now engaged in a
study and preservation of history of
Pitt county. At the meeting of the
Chapter last week Gen. J. Bryan Grimes
one of the noblest men of Pitt county
has produced, was the subject of a
sketch which for the interest that the
people generally will feel in it has been
given for publication.

General Grimes traveled two or three
county, North Carolina, in the year
1828 and lived at his father's old home-
stead called Grimesland. When a
young man he married Miss Davis, of
Wayne county. She lived only a few
years and left two children, Bryan
and Elizabeth. Bryan died when only
a small boy; Elizabeth married Samuel
Mordcau. They lived in Durham and
Mr. Mordcau is the law instructor for
Trinity College.

General Grimes traveled two or three
years in Europe prior to the Civil war,
in fact was in Europe when South Car-
olina seceded. He hurried home and
offered his services to Governor Clarke
who appointed him colonel of a regi-
ment. He declined this with the state-
ment that he had no military experience,
and asked for an appointment under
some one with military training. He
was then appointed major under col-
onel Julius Daniel. Daniel was later
appointed brigadier general and Major
Grimes was made a lieutenant col-
onel. Later at the Bloody Angle, when
his regiment went in to the fight with
465 men and came out with 85, every
commissioned officer in the regiment
was either killed or wounded, except
the lieutenant colonel. They fought
for several minutes with bayonets and
muskets at the breastworks until the
enemy surrendered. For his gallantry
victory he was appointed brigadier gen-
eral.

Later at Reams Station he was lead-
ing his brigade to capture two batter-
ies. A bomb shell struck his horse in
the forehead, blowing the entire head
away and covering his face with blood
and brains. His face was so covered
with these that his men wavered, but
wiping his face with the tail of his
coat he gave command "Charge" and
went forward, capturing the two bat-
teries. Ordering the lieutenant col-
onel of the enemy to dismount General
Grimes mounted his steed feeling very
proud of his capture. As he was dis-
posing and spiking their guns, feeling
that they would fall back into the en-
emies' hands, he noticed a courier run-
ning his horse toward him from Gen-
eral Gordon's command, his division
commandant. This message said he
was ready as quick as possible to charge
and capture a battery to his left. He
looked in that direction and saw two
guns come over crest of the hill, saw the
first gunner fall to his knees, lower
and raise his gun until he got satisfactory
aim, and when he fired a forty pound
cannon ball went through General
Grimes' horse between the riders knees
cutting a moon in the saddle skirt. In
front of the right knee and came out in
the saddle skirt in front of the right
knee and came out in the saddle skirt
rear of the left knee. He dismounted
in time not to be caught by the falling
horse, formed his men and charged
on foot. By this time the entire bat-
tery was in position and opened fire
on them with grape shot. In this
charge his saber was shot in two and
while his arm was up waving his sab-
er the seam in his coat was cut and
his arm felt the slight burn, but not
enough to blister, one grape shot cut-
ting away part of the flesh on his
collar. But this did not deter them,
for he went forward and captured the
battery. Two horses killed, sword shot
in two, seam of coat under right arm
cut off and wreath cut off collar, all
in an hours' time.

When upon a short lough after
this he married his second wife, Miss

THE CLOTHING INDUSTRY

One of the industries most seriously affected by the trade reaction is that of manufacturing of clothing, and the story of its rise and fall since the Armistice is interesting for the lesson in price movements that it teaches.

Ready made clothing is usually made upon order from the trade and preparations for a season are made well in advance. Light weight cloth for spring wear is ordered of the mills as early as the previous June, samples are made up and in October salesmen go out on the road to take orders for spring garments. The manufacture of the garments commences some time early in December and delivers to the retailers are completed by the following March and are placed upon sale to the consumer in April. The heavy weight cloth for winter garments is bought from the mills in November, the line is opened in April, manufacture is commenced early in June and completed in the fall when the retailers place the goods on sale. The manufacturer is thus compelled to purchase his material from nine to twelve months before it reaches the consumer and from four to six months before he receives his orders from the retailer. The retailer, of course, likewise takes a chance for he must anticipate the coming demand of the consumer as best he can.

Following the signing of the Armistice the outlook for business seemed extremely poor. It was feared that general business was going to be slack would not be great. The time for buying cloth was in November, the month of the signing of the Armistice. The manufacturer, therefore, felt that it would be prudent to buy very sparingly and that if business should prove better than anticipated, they would have no difficulty in securing cloth in the open market later in the season. The retailers took the same view of the situation and were conservative in placing their orders.

DECLARES AMERICA OUGHT TO BE FAIR IN SOUTH AMERICA

Foreign Minister of Uruguay Says United States' Attitude Should Be in Keeping With Times

Montevideo, Feb. 28.—The United States should not only be right in its conduct toward South and Central American republic, but should seem to be right. Dr. Juan A. Buero, Foreign Minister of Uruguay, told North American correspondent in an interview the other day.

Dr. Buero made this statement when asked by the correspondent concerning the prejudice reported to exist in States because of actions taken at various times in regulating the affairs of some of the less stable republics in tropic zone.

Uruguay, he said, throughly understands the United States and the reason for its action. However, some of the nations that have had difficulties with the United States may have not understood the North American position. Further more, there are a number of agitators throughout South America willing to play upon the minds of the

people to influence the against North America and make them believe that the great northern republic is actuated by a spirit of aggression.

Therefore, permit me to suggest in the interest of American solidarity and universal good will among American republics that the United States not only be, but seem to be right in its dealings with South and Central American republics. The facts and the appearances should decide.

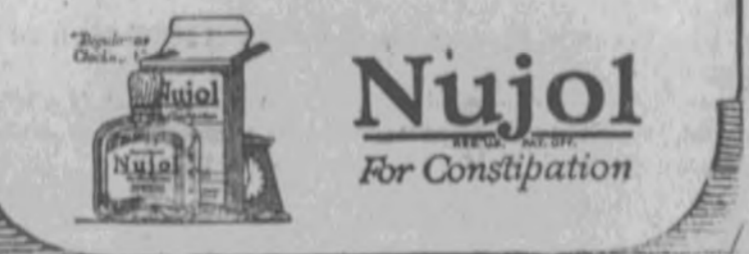

Charlotte Bryan, of Raleigh and she remained in camp with him for some time. From then until the end of the war he was with General Lee. During 1864 he was made major general and was in all the hard fighting. His division made the last charge at Appomattox—Cox's brigade fired the last volley. General Gordon told the writer in St. Augustine, Fla., that he bore the message to Gen. Grimes just after his division had driven the enemy back in the last charge, that when he told General Grimes that General Lee said cease fire as he had surrendered General Grimes replied, I can cut thru and save my division. You must not disobey General Lee's orders, said Gordon.

General Grimes during the war was engaged in the following battles; Williamsburg, Yorktown, Seven Pines, Mechanicsville, Cold Harbor, Malvern Hill, Second Manassas, seven days fight around Richmond, Boonsboro, Port Royal, Fredericksburg, Chancellorsville, Gettysburg, Brandy Station, Upperville, Berryville, Martinsboro, Front Royal, Snicker's Gap Norton's Ford, Mine Run, Monocacy, Frederick City, Rockville, Centerville, Warren Junction, Catlett's Station, Germania Ford, Wilderness, Spottsylvania Court House Winchester, Charleston, Sheparston, Stevenson's Depot, Bunker Hill, Strasburg, New Market, Port Republic, Fisher's Hill, Cedar Creek, Tranches at Petersburg, Hare's Hill Run's Salient, Sailors Creek and Appomattox.

When his army life ended he returned to Raleigh and lived there thru 1863-66-67, leasing his farm to some northern men. In 1868 he returned to

his farm in Pitt county with his family and there reared a family of eight, his oldest son, Alston, dying a few years ago. His second son, J. Bryan Grimes, is now Secretary of State, which office he has filled several terms; Mrs. Charlotte Williams, wife of Alfred Williams Hackett; Dempsey Grimes, married Miss Skinner of Oxford; Junius Grimes married Miss Wharton of Forsyth county; Miss Susan Grimes never married, died recently; Miss Byrdie Grimes married Col. Croom Rodman; George Grimes, who died of diphtheria a short time after his father's death. His widow died recently at the advanced age of 81 years.

General Grimes was assassinated on the public road in eBaufort county, at Bear Creek, on the first Saturday in August 1880. His murderer was released through disreputable methods of his attorneys. So outraged was Judge Gilmer at the verdict that he advised the murderer to no to return to that county to live, which was equivalent to telling him that if he did he might be dealt with. He took the judge's advice and left the state for eight years. At the end of the time he returned to Washington and was put in the lock up for

being drunk. He was allowed to sleep off his drunk and at 3 o'clock a. m. was taken out by the friends of General Grimes and lynched at the draw on the bridge across the river. A placard was pinned to his back reading "Justice at Law".

In the devotion to duty, in faithfulness to every trust, in sincerity of purpose, in dauntless courage, in unselfish patriotism, in everything that constitutes a noble generous true man, North Carolina has never honored a superior to Bryan Grimes. Of him a distinguished North Carolinian wrote "for honesty of purpose, for devotion to principle, for firmness of friendship, for honor in all things, for faithfulness to all promises and obligations, and for true courage, he stood on the day of his death the peer of any living human being."
