COMMERCE BODY TO RENDER SMOKER IN CITY TONIGHT

Every Section of The County to Be Represented in the Court House Tonight

This is the night when the men of Pitt County will meet in conference at the Court House to hear from H. A. White, Chairman of the Campaign Committee and others interested in the reorganization and expansion of the Chamber of Commerce how they will benefit by this movement.

The meeting will be a Smoker, beginning promptly at eight o'clock. There will be no charge for admission, no solicitation for funds or memberships in the Chamber of Commerce. Cigars and tobacco will be furnished free of charge. There will be singing by home talent and a get-together spirit that will be remembered for a long time in Greenville and other communities of Pitt County.

William C. Ewing, Campaign Director, in charge of the intensive effort to unite the citizens of Pitt County in one big progressive organization, will speak. Mr. Ewing is a veteran Campaigner of the staff of the American City Bureau, of New York and has cooperated with the citizens of counties in Virginia, South Carolina, Mississippi and Maryland in their work of building up Chambers of Commerce and making them county-wide in scope. He has been a student for many years of civic problems and for a long period was a member of the Board of Directors of the Boston, Mass., Chamber of Commerce.

Word was received late this afternoon by Dr. C. J. Ellen, President of the Chamber of Commerce, and Chairman of the Executive Committee, that delegations of citizens from Farmville, Ayden, Grimesland, Pactolus, Grifton, Fountain, Winterville, Bethel, Stokes, Chocod and Falkland will be on hand.

Announcement was made this morning that the new membership of the Chamber of Commerce would have complete say as to the election of the Board of Directors. Members of the present Board have tendered their resignations to take effect upon the election by the entire membership next month of the new Board. Following is the letter of resignation signed by the eleven directors:

The undersigned officers and directors of the Greenville Chamber of Commerce hereby tender our resignations, to take effect as soon as the expanded Chamber of Commerce shall elect our successors. In making public this action we desire to explain the reason for it.

For several years a comparatively small group of men have been endeavoring to advance the interests of our city through the activities of the Chamber of Commerce. We are proud to have had a part in this work.

The time has come when the conduct of this organization should no longer be in the hands of a small group of city business men. What is needed is a general community organization whose purpose shall be the development of the whole of Pitt County.

Since the membership will be so greatly increased, it is desirable that the new members shall have the same opportunity as the old to determine the policies and select the officers for the coming year. For this reason we are resigning.

We appeal to all who have the interest of Pitt County at heart to unite with us in this endeavor to advance the common welfare through a Chamber which shall be controlled by the united conscience of all public spirited men and women.

The Directors will all be present tonight, intent upon doing their best to build up the new Chamber. One and all say: 'Come to the Smoker tonight.'

LOCAL REVIVAL STILL ATTRACTING WIDE ATTENTION

In developing this strong sermon, Dr. Edwards brought out the following facts, namely: The fisherman was discouraged he laughed out, he obeyed, and he dropped his net on the right side. With these points the speaker showed where people are too easily discouraged. They should have faith in God. Every person should launch out and make their life count for the glory of God. Obedience is absolutely essential if the child of today ever amounts to the great man of tomorrow. Just so with the Christian. In the last place Simon Peter was on the right side. He dropped his net on the right side and his success was great.

Prior to the sermon Mr. Pollock sang 'My Wonderful Dream. Two new members were added to the Church.

The afternoon services are proving very beneficial to the children and as this is the last week in which new members will be taken, Mrs. Pollock is very anxious for all to join immediately.

PRES. HARDING AND OFFICIALS REVIEW ATLANTIC FLEET

WOMEN DISPLAY GREATER INTEREST IN CITY PRIMARY

Registration Yesterday Showed That Women Outnumbered Men More Than Two to One

Registration for the municipal primary to be conducted in this city on May 2nd, showed no decided change yesterday so far as number of registrations were concerned, but one feature that stands out very prominently is the fact that women outnumbered the men more than two to one. This is the first time that the women have outnumbered the men to this extent, although, they have outnumbered them several times.

The total registration of the day approximated 33, of which number twenty-three were women and ten were men. The second ward led all others with a total of thirteen registrations against seven in the fifth ward. The first ward came in for third position with six registrations against three in the Third Ward and four in the Fourth Ward. The total registrations up to today are: men 633; women women 375, making a grand total of 1,008.

The women are taking greater interest than at any time since the opening of the books, and as a result there is greater interest being manifested on the part of the candidates, as no one can tell just what effect the women's vote will have.

AMERICAN FORCES ON THE RHINE IN FOR HARD LABORS

Soldiers Comprising Army Kept Busy From Morning to Night With Problems of District

Coblentz, April 28.—If Americans at home imagine that the life of soldiers composing the American Army of Occupation on the Rhine is one of idleness they will be a long way from the truth.

The little fighting force of 10,000 men has to be kept hard, trained and ready for quick action, and that means work - eight hours of it a day at drill, study, target practice or maneuvers, for it is the purpose of the General Staff here to maintain union hours. Most of the American doughboy's eight-hour day is spent in drill which occupies from three to five hours daily, varying according to the circumstances and needs of the different units.

A visit to this American community transplanted into the center of Europe would find the American boys just now preparing for a Summer of grim war maneuvers, for the open training season has just commenced and will continue until October 31.

The regular target season, which is now in full swing, will last until July 31. It is being held on the target ground ranges built by the Germans a few miles east of the fortress of Ehrenbreitstein. It includes known distance practice, combat firing and company proficiency tests.

Problems, terrain exercises and maneuvers including night operations and combats in woods for units up to and including a company are also part of the day's work. Field work for the battalion will commence as soon as the battalions have completed all firing.

The second period, from August 1 to September 15 will include, battalion, regimental and brigade maneuvers, and terrain exercises. During this period, one week for each brigade will be reserved for battalion combat problems with live ammunition and in conjunction with auxiliary arms. As General Allen puts it: 'We do everything that is done in war except kill men.'

TO FIND CAUSE OF DISAPPEARANCE OF THE SPOKEN DRAMA

Question to Be Taken Up at the Eleventh Annual Convention of the Drama League

Chicago, April 27.—Remedy for the disappearance of the spoken drama from a great many small cities, due to a combination of motion pictures, high railroad fares and general uncertainty of the theatrical business outside of a few large cities, will be sought at the Eleventh annual convention of the Drama League of America opening here tomorrow.

A report on the actual condition of the one night stand made a survey of the country, will be given to the convention, Walter Prichard Eaton, a director of the League said. Travelling companies as we used to know them, have practically been done away with.

A manager has been called in to tell his side of the case, while how the small town looks at it will be related by Harold L. Beign, of Grinnell, Ia.

By its program this year the Drama League frankly acknowledges the need of amateur effort everywhere if the spoken drama is to survive beyond the confines of large cities. At its convention it is going to bring all the help and encouragement it can to all those who are working to this end.

Many phases of amateur effort, including high school drama, religious drama and little theatre circuits planned to help small local theatres exchange plays and productions, will be discussed. Perhaps the most important of all will be the reports on what has been done and can be done to bring the spoken drama to the rural regions.

How much the theatre has changed in the past decade and how the interests of the Drama League are changing with it to meet new conditions, are illustrated vividly in the program of this year's convention. When the League was organized, its object was to educate audiences to support the best plays in the theatre and thus to encourage the tours of these plays thru the country.

WOMEN PROMISE GOOD LEGISLATION WHILE IN OFFICE

Feminine Government in Thayer, Kansas, Makes No Promises But Means To Have a Clean Town

Thayer, Kan., April 28.—The feminine government of this town, swept into power at the recent municipal election, promises Thayer a business-like, forward-looking administration, but it is not announcing any flamboyant promises of reform. The entire women's ticket - mayor, police judge, and five councilwomen - was elected by a four to one vote over the men's ticket. This is the only town in the state which has a woman mayor.

'We have no campaign pledges to fulfill; we make no pledges, for we were drafted for the nominations, asserted Mrs. A. H. Forrest, the new Mayor. However, we intend to serve with all our hearts and trust that we will produce results, rather than promises.'

This town, like many small towns - you know our population was only 528 in the last census - was suffering from ennui. The women of the town, thru the women's clubs have been trying to do things for the town, and have succeeded to some extent. However, I believe we will be in position to do much more now that we have an entire corps of city officials in entire sympathy with these efforts.

'Neither myself nor any of my associates was consulted in regards to the nomination. It was conferred on us by those who stand for a progressive policy, and the manufactured the slogans of the campaign, 'Get Thayer out of the Jack-oaks stage,' and 'Vote for the women; it means a cleaner town.' We shall try to give the city a business-like, forward-looking administration.'

LONDON CONGRESS IN READINESS FOR COMMERCIAL DRIVE

Chamber of Commerce of That County Outlines Preliminary Plans for Great Event

Paris, April 28.—Arrangements for the London Congress of the International Chamber of Commerce to begin Monday, June 27, have just been made by the Board of Directors at a meeting here.

Delegates to the Congress will be organized in five groups. Walker D. Hines, formerly United States Director General of Railroads, will be chairman of the group for transportation and communications, while the chairman of the other four groups will be Dr. Walter Leaf, Great Britain, for finance; Eugene Schneider, for France, for production; Marco Cassin, Italy, for distribution; and Lucien Beckers, Belgium, for devastated regions.

The American representatives on group committees will probably be Finance, Thomas W. Lamont, of J. P. Morgan & Co., New York; production, E. G. Miner, President of the Pfauddler Company, Rochester, N. Y., and distribution, Gerard Swope, president of the International General Electric Company, N. Y.

In addition a committee has been appointed to sit during the congress to deal with questions relating to the organization and operations of the International Chamber on which the American representative will be John H. Fahcy, of Boston. The representative of the United States on the committee which will consider resolutions to be placed before the general meeting will be Joseph G. Defrees, President of the United States Chamber of Commerce.

The Board approved nearly 300 applications for membership. These included recognized organizations in various countries and 128 firms or individuals who were admitted as associate members.

Select committees appointed by International Chamber will report to the London Congress. Among questions being considered by these committees, with names of American representatives who have attended committee meetings, are: Double taxation, Robert Grant, Jr., Lee, Higginson & Co.; commercial arbitration, S. B. Archibald; international credits, H. E. Bedford, Jr.; Paris.

SUPERIOR COURT ADJOURNS AFTER TWO WEEKS TERM

With road sentences playing an important part, the criminal term of Pitt County Superior court adjourned at the noon hour yesterday after a period of nearly two weeks. Judge Devin, of Oxford, presided during the term, dealing justice impartially to all parties.

Jerry Langley, trespassing, judgment continued to next term of court upon payment of costs. Lillie Webb, disorderly conduct, case continued. Sarah Spruill, assault, case continued. Jerry Langley, disorderly conduct, case resulted in nol pros proceedings. The case against Floyd Stokes for abandonment, resulted in mistrial.

Nearly every case with the exception of a few minor ones which drew fines, resulted in road sentences.

AMUZU PARK OPENS FOR SECOND SEASON ON FRIDAY EVENING

Opening Night Will Be Featured With Many Attractions; Music By Edmond's Orchestra

With many improvements which makes it one of the most up-to-date parks in the State, the Amuzu Park, which is located a couple of miles from this city, will on Friday evening, April 29th, open for its second season. The opening will be featured with a round of good things, such as dancing, boat-riding, etc., with the music furnished by Edmond's Orchestra. On Saturday evening there will be a square dance, the music being furnished by 'Ye Olde Fiddlers Band.'

The improvements at the Park consist of new swings, both single and double, cables in trees for rope climbing, other athletic features. A play ground slide has also been erected for the little children and many other features too numerous to mention. The installation of the swings and athletic features create a desire for more physical exercise which is essential for the development of boys and girls. The Pond has recently been drained and fresh water added. Additional sand has been placed on the bank, and a modern boat landing has been provided.

The hours for the opening and closing of the park are: Sunday hours, one to seven. This has been arranged so as not to conflict with the church hours. On week days the park will close at eleven p. m.

Friday and Saturday nights of each week will be special nights, and the owners of the Park have arranged an interesting program for these nights. Lincolnton has voted \$200,000 for improvement of its public schools. This shows practically every town in North Carolina is going forward by leaps and bounds and that hard times are not what they used to be.

Chief Flynn of the New York police department says he is wearing a solution of the recent bomb plot, considering the time consumed in the investigation it wouldn't be surprising to learn that he has apprehended every person connected with the occurrence.

Charlotte is to have a million dollar home construction corporation. This ought to be an inspiration to other towns that have been seriously affected by shortage of homes for many months. Charlotte is to be commended upon its progressive spirit, for it has done something to really be proud of.

General reduction in cotton and tobacco acreage seems to be attracting attention throughout the entire country at this particular time, especially in Eastern North Carolina where growers are convinced this is the only way of relieving the congested condition of the world market. If every planter does his part in curtailing acreage the situation will be much brighter in the days to come, and in the course of time prices will be at a normal level and cost of production. There is need of such action and indicates close co-operation among members of the industry.

It is estimated that approximately 60,000 seaman will be affected by reduction in wages within the next several days, and it is to be hoped they will be wise enough to continue work without walking out on a strike as has been noticeable in other branches of industry. It is perfectly natural to expect that wages will be subject to radical reductions now that deflation is in progress. This is one of the most direct indications of readjustment, and the working man that accepts reductions without thought of creating inharmonious relations is the one who has the best the future has in store for him.

Reports that the administration is considering proposals for financing the cotton crop should not cause the farmer to forget that reduction of acreage is just as important as ever. It will do little good to provide money with farmers contemplating planting normal acreage, for the market is congested to such an extent now that demand will be months in picking up again. The situation is not altogether pleasing, and the farmer should remember that all the money in the world cannot change prevailing conditions on the world market.

The fact that over a million coal miners are idle in the English coal mining area indicates that serious conditions will prevail in that country next winter in event work is not resumed in the next several weeks. The situation is anything but pleasing, and ought to bring about more than usual activity on part of the government toward restoring normal production. It is absolutely essential that production be kept up to the average through every year if demand is met, but with present period of unemployment prevailing it is hardly probable England will be able to pass through another siege of winter weather without realizing the seriousness of non-production. America fortunately is not troubled with its miners at the present time, and indications point to one of its most successful years in history. The present coal supply is increasing, and as a result it is to be expected that prices will undergo a decided decrease in the course of several months.

THE REPUBLICAN TARIFF
 Congressman Kitchin's report on the emergency tariff bill is one of the most thorough discussions of the measure that has been presented to the public since the issue was brought up for consideration. It dwells mainly on the fact that rates of the bill are higher than those enacted by any congress in records of the country, and, in fact, considerably higher than any tariff which so far has been passed in any country where civilization has received the thought which it so surely deserves under all conditions.

The fact that the Republicans have a long period of administration before them has produced determination to make the most of the great opportunity, and in the emergency tariff they have found something fully capable of meeting the demand. That such a tariff is nothing more than robbery cannot be doubted in the slightest sense of the word. The people have fought it determinedly for years and years realizing it as such, but times have come when fighting is in vain. The awakening period always comes, however, and congressman Kitchin's statement is sufficiently forceful to impress the public with the necessity of strenuous opposition against a measure which will benefit no one but its supporters.

In discussing the bill Mr. Kitchin cites sugar as an example of what the bill will mean to all commodities which it covers:

The consumption of sugar in the United States in 1920 was in round numbers ten billion pounds. As every intelligent man knows, the sugar trust absolutely controls the sugar situation and that over one half of the sugar we consume is imported and that the tariff duty is added to all sugar consumed in the United States, both domestic production and imported. This bill will increase the duty 100 percent over the existing law; that is, it gives to the sugar trust the right to exact one cent a pound additional from the people (by the time it reaches the consumer at least a cent and a half is added.) This bill gives to the sugar trust at least \$125,000,000. It gives the sugar trust the right to and privilege to exact from the American consumers an additional \$125,000,000. No one, it seems, except the Republican leaders in Congress knew that the sugar trust was confronted by an emergency and was in such financial distress that the Republican leaders should hasten to its rescue with the bill.

Republican leaders are now preparing to rush this bill through the Senate at the earliest possible date, and if they do so the country will be the ultimate sufferer, and that cannot be doubted, in the least. The only opposition they have is the minority members of the Democratic party, therefore, it is very evident the bill will go through without any degree of opposition. It will be a direct injustice against the public and shows exactly

what the Republicans mean to do now they are in office.

In other words, this is merely a sample of what they intend to do, and the public may rest assured other bills will bring only slight improvement, but if they do by all of them as they mean to do by this the future will witness direct digression from the splendid principles enunciated by leading figures of the Democratic party. However, the future will tell the tale much to the people's sorrow.

TO THE WOMEN VOTERS

To The Women Voters:

Until now I have asked your support and vote on my own merit and reputation, without the endorsement of some person in Asheville or Kansas City, or without searching through the 7,000 pages of an unabridged dictionary to find words to adequately express my virtues. I have felt that the good people of the town have the good judgment to form their own opinion of the fitness of the candidates without the aid of those things. For a person's reputation with those a man whom he has lived is over and above the power of words or endorsements to change or alter. My reputation among you will show that I have stood always for a clean town, a law-abiding town, a healthful town and a good town to live in, and if elected Mayor it will be my purpose to make Greenville the model town of the State along these lines.

Right here I would like to say a word about the pool room question. Political capital is being made out of the fact that the Syrian Pool Room was compelled to close its doors. Public sentiment caused this to be done, but certain ones are claiming the credit. But they forget to tell you that this so-called Den of Iniquity was first allowed to open and operate under the present administration, with the same Mayor and the same Board of Aldermen. And when they tell you that they have closed the pool rooms of the town, and claim credit for so doing, they forget that there are as many pool rooms now operating in the town as there were two years ago.

I am a home boy. I have lived here all my life, and pay taxes here. I have never asked for office before. When the war came on I volunteered and spent two years in the service. While I was away sacrificing this time, the other gentlemen who are candidates were for the most part at home making money and furthering their own individual interests. I submit that I deserve the honor more than either of them.

"We would not have an America living within and for herself alone,
