

GREENVILLE HIGH SCHOOL CLOSES A SPLENDID SESSION

Commencement Address Delivered by Dr. Howard Odum of University of North Carolina

The high school commencement was brought to a close last evening with an address by Dr. Howard W. Odum, the presentation of diplomas and the awarding of prizes.

Prior to the address the glee club sang "Stars Brightly Shining". This was followed by a speech "The Clouds" by little Miss Mary Corcas Harding, the four year old daughter of Mr. and Mrs. J. B. Harding, who is sponsor for the 1921 class.

Superintendent J. H. Rose introduced Dr. Odum, who delivered the annual address. Dr. Odum holds the chair of Sociology at the university of North Carolina and is a most gifted speaker. The subject of his address was "Vocational Citizenship". He took the six great institutional modes home, school, church, State, work and community, which go to make up this great democracy and from these he developed a great address. He appealed for a united citizenship. Organized so that great things can be accomplished and organized so that no harm nor evil influences can enter to corrupt the home, educational, religious, principles of government, work or social life of the community.

Dr. Odum brought out most forcefully that commencements are reminiscent there is always the old yet ever the new principles which go to make up the great citizenship of the country. What is to be the contribution of each high school boy and girl in the great period through which we are now passing? Dr. Odum after asking the question answered it with illustrations which were plain and simple, showing that every boy and girl can select several vocations and yet be a great success.

His address contained splendid advice to the graduating class and will long be remembered by the large audience who heard him.

After the address Supt. Rose introduced Mr. J. L. Little, president of the board of trustees, who after a few remarks to the graduating class presented diplomas and certificates to the following young ladies and gentlemen:

COLONY OF CAVE DWELLERS BERLIN BEEN DISPERSED

Simple Solution of Housing and High Cost of Living Problem Said the Leader

Berlin, May 31—The colony of cave dwellers of Berlin which took the back-to-the-land doctrine so literally that scores of men, women, boys and girls dug caves for themselves in the banks of the Spree just out of Berlin and discarded all modern wearing apparel, has been dispersed by the police. The colony's leader, Dr. Heinrich Goldberg, argued before a magistrate that the experiment was a simple solution of the housing and cost of living problem.

The cave dwellers began by discarding hats and shoes but soon decided to do away with clothing altogether and in this fashion dispersed themselves in the waters of the Spree, or sat about their cave doors munching black bread and sausages, apparently oblivious to the crowds of sight seers which began to frequent the vicinity.

Dr. Goldberg from his abode in the "Cave of Zerstustra", issued circulars discussing the Nietzschean philosophy, anarchy, Communism, the faults of the present civilization and asking the rent-wary and the work-worn to "watch this colony grow".

Somebody spoiled the experiment by complaining that the brotherhood was having a deleterious effect upon public morals and calling attention to the doctor's career, which was said to have included efforts to reform England, Russia and Poland.

The colony has disappeared but its leader has become a familiar figure upon the streets of Berlin, wearing long hair and going barefoot.

SIX WHITES AND FIFTY NEGROES KILLED IN A RIOT

Two Thousand Negroes Placed Under Guard.—Negro Section Burning Other Telegraphic News

Tulsa, Okla., June 1.—Fifteen dead already reported as a result of race riots which began when armed negroes surrounded the jail where a negro who is alleged to have attacked a white girl was placed. Armed whites gathered, rioting continuing, whites and negroes facing each other across the railroad tracks, firing continuously. Troops are rushing to the scene.

Tulsa, Okla., June 1.—Six whites and fifty negroes are reported dead and a heavy list are wounded. Ten square blocks of the negro section is burning. Two thousand negroes have been rounded up and placed under guard. State troops have arrived.

BUSINESS MEN OF AYDEN FAVOR NEW MARKETING PLAN

Mr. L. S. Tomlinson Explains Business Men's Part of Work and How It Will Effect Them

At a recent meeting of the chamber of commerce of Ayden the business men went on record an unanimously favoring the plan of co-operative marketing of cotton and tobacco. They had Mr. L. S. Tomlinson of Wilson to talk to them at this meeting and explain the business man's part of this work and how it will effect the business man. Mr. Tomlinson said that the business man who stood by and did not put his shoulder to the wheel and help put this proposition across, was standing in his own light and was losing an opportunity to heal a wound that had long existed between the country and town.

At the close of this meeting the chamber of commerce voted unanimously in favor of co-operative marketing and appointed a committee to formulate plans to put it across in Ayden and adjoining townships. On this committee was appointed J. H. Coward, Stancel Hedges, J. R. Pierce, J. R. Turnage and W. H. McKinney. They also appointed a committee to formally offer to the association the services of the three tobacco warehouses and retyring plant located in Ayden.

The canvassing committee held its first meeting yesterday afternoon in one of the directors rooms at the Bank of Ayden. They had present at this conference several business men from Snow Hill, W. B. Pace, Pitt county agent, and others. These men from Green county outlined the plan of procedure in their county, where more than 80 percent of the farmers have signed contracts.

It was decided that the committee would call in farmers from the different communities of Ayden township for a conference Friday, June 3rd, at 2:30 p. m. At this meeting the contract will be studied and thoroughly discussed. At the same time these farmers and business men will set a day for canvassing the township. On this day the merchants, doctors, lawyers, bankers and everybody will close up their shop and help the farmers of Ayden township sign up at least 80 percent for co-operative marketing. This is indeed a fine spirit shown by the business men of Ayden and other towns of the county are at this time working out plans to put it across in their respective communities.

REVALUATION AND SCHOOLS

Thirty-six North Carolina counties which in 1919-1920 did not levy enough taxes to maintain six months public school will ask the State for an increased amount of help in 1921.

The horizontal reduction done to property valuations by the county boards figures in the scheme of things. The State equalizing fund was computed by the financiers at the 1921 session of the general assembly. The revaluation figures were used in arriving at these totals and with the assessment figures frightfully remembered "where are we at" is pertinent.

The equalizing fund is explained by the State superintendent as being necessary because "certain counties had insufficient funds to provide for a school term of six months as required of every county by the law." Each of these counties was apportioned, in addition to the regular apportionment, an amount sufficient to cover the difference between the funds available and the amount required for its three months term. The 1919-1920 equalizing fund totaled \$150,000,545.06.

We are glad to know that Rockingham is not included in this list of pauper counties.—Tar Heel.
