JAPANESE TAKE FIRST STEPS IN REDUCING ARMY

Discharge of More than Fifty Thousands Men will Begin at Early Date

(By International News.)

Tokio, May 5.—In response to the cry for army reductions to keep pace with those to be made in the navy under the terms of the Washington conference and to bring about a reduction of taxation, the war office soon will discharge 51,180 men from service and beginning with next year the day of the induction of conscripted men will be postponed a month, lessening the conscription period from two years to twenty three months.

This will effect a saving of \$7,500,000 a year, but the war department plans to spend most of this for new and modern fighting equipment, at least for the first year or two.

The army reduction from the present force of 298,000 men will leave the standing army of the country at 246,800 men. The reduction will really total 55,600 men, but 4,420 are to be re-enlisted in other services.

The branches are to be cut as follows: Infantry, 34,000; cavalry, 2,300; field artillery, 17,000; engineer corps, 1,700, and heavy artillery, 600. The following additions will be made: Howitzer corps, 300; railway units, 300; aviation, 260; automobile corps, 280; and cavalry gunners corps, 280.

In the future a battalion will include three instead of four companies, according to the re-organization plans. Each company will have six ordinary machine guns with about ten heavy machine guns.

TEN KILLED AND SCORES INJURED IN TEXAS STORM

Damage was estimated at more than a half million dollars today, according to latest reports and casualties are expected to grow as belated reports reach here.

The sewer extension on Broad street was one of the most ambitious programs discussed during the evening, but definite action was delayed until a later date. The greater part of the evening was consumed in regular routine business and hearing of reports of the various city departments.

LOCAL POSTOFFICE OBSERVES POSTAL IMPROVEMENT WEEK

Public urged to Co-operate in Effort to Improve Department's Service.

HUNDRED MILLION PEOPLE ARE SERVED DAILY BY SYSTEM

First Assistant Postmaster General Bartlett Tells of Imminence of Work

The postoffice department has designated this week as "Postal Improvement Week" and an intensive campaign is in progress to increase the efficiency of the department. In keeping with proclamation issued the first part of the week, Postmaster Heber R. Munford stated this morning that the local office was doing everything possible to improve its service. Every department is receiving special attention and each employe has been instructed to do everything possible to make his services as efficient as possible.

By properly addressing letters and parcels the public will be assisting the department in rendering a higher class service. Very few people have any idea of the vast proportions which the postal business has assumed in the United States, and for that reason John H. Bartlett, first assistant postmaster general presented a number of pertinent facts in an address delivered before the chamber of commerce at Marion, Ohio, prior to the beginning of "Postal Improvement Week." "It is only when the countless streams of business from every inhabited section of the country come flowing into Washington that the total makes an impression of greatness," Mr. Bartlett says. "About two thousand men and women at the national capital represent the heart of the system which reaches 325,000 employes and serves a hundred million people. We are simply called upon to please one employe eight hours a day, but rather, it is our duty to please 100,000,000 employes 24 hours per day 365 days per year."

"In order to visualize the immensity of the postal business, I remind you that there are something like 12,000,000,000 letters and 3,000,000,000 parcels handled each year. We sell 14,000,000,000 postage stamps, 2,700,000 stamped envelopes, and 1,125,000,000 postal cards each year, and for accommodation we lick many the stamps. We issue \$1,500,000,000 in money orders yearly. We have the largest savings bank in the world, namely, 500,000 depositors, with a total deposit of \$152,000,000. You see a mail sack and then, but you do not realize probably that we have 65,000,000 of them, and we have one little factory in Washington employing 300 hands engaged in mending them all the time. We use 800,000 miles of twine each year to tie up the letters. This is enough to wrap around the earth 32 times. Some ingenious boy some day will invent a method of handling these letters without this tying with a string which cuts into the letters and sometimes injures them. We have a fleet of 4,000 motor vehicles. We spend about \$600,000,000, and we have an annual turnover of about \$3,000,000,000. We run about \$100,000,000 short of making the business pay, and we have done better during the past year than for many years previous."

"There are 33,000,000 copies of daily newspapers printed each day in the country and many of these are handled by the department. We are making it one of the high points of the administration to see that the people get their newspapers promptly and regularly. We invite criticism and information on this point."

Local Secretary Leaves for Kins to Take Part in Membership Drive.

Mr. H. L. Smith, secretary of the Pitt county chamber of commerce, left this morning for Kinston where he will remain the rest of this week assisting in the membership drive of the Eastern Carolina chamber of commerce. Secretary Bartlett and Mr. Smith have visited one or two other towns this week and found interest in the organization growing by leaps and bounds.

An intensive campaign for increasing membership of the new institution will be waged vigorously the next several weeks, and directors of the local chamber agreed to allow Secretary Smith to assist in this work. In fact, the county chamber was quite active in the formation of the new one, and its members are interested in plans for its success.

The Eastern Carolina Chamber of Commerce comprises a number of the wealthiest counties in this section of the state, and when completely organized will be one of the most influential institutions of its kind in the country. The program for the future is ambitious in every sense of the word, and affects every person interested in the growth and development of the section.

Mr. Smith stated last night that prospects for success in the membership drive were bright, and it is hoped to canvass every county and complete organization at the earliest possible moment. CHANG'S FORCES MEET DEFEAT AT SEVERAL POINTS

Manchurian Leader Suffered Defeat at Machang and Changsintien.

WU ARMY CONTINUES STEADY ADVANCES IN DIRECT ON CAPITAL

Chang's Forces Almost Completely Demoralized, Dispatches Says

(By International News.) Peking, May 5.—General Cao Tso-Lin, commander of the Feng forces, has suffered reverse on the points of the battlefield, according to consular advices received here. At Machang, south of Tientsin, Chang's losses are said to have been heavy. Along the Hun River he asserted that his troops have driven eastward. The routing of Manchurian leader's troops at Changsintien, which forms the west terminus of the battle line, appears to be complete.

The forces of Chang, after capturing the vicinity of Changsintien, boarded trains and sped to Fenshi, next station, where they made a stand for a while. Troops of men of the defeated army approached the walls of Peking and pleaded for Juge insied the city. Many of them threw away their guns. The forces of the city were immediately ordered by the local authorities had ordered the defeated troops of either side.

The closing of the gates resulted in the shutting out of a number of foreigners, including Mrs. Barton, wife of the Second Consul of the American legation. Mrs. Barton, who had been visiting her country home, demanded that the gates be opened for her, but this was done only after a ransom had been sent to her aid from the city.

The Chang soldiers, who found they would be unable to hold the city, dispersed, discouraged, and many of them marched toward the while others sought refuge in various temples and pagodas located in the outlying districts.

cotton advancing and business return-  
ing to normal there is no reason why  
bright leaf prices shouldn't measure  
up to expectation. This is certain  
if a good crop is produced, and is the  
duty of every grower to confine his  
attention to production of what the  
market demands.

The entire city will be glad to learn  
that the county commissioners have  
decided to make proposed improve-  
ments to sidewalks and the lawn at  
the court house. This has been need-  
ed for years, and will increase ap-  
pearance of the building to no little  
extent. The eight white way lights  
will give the imposing structure of  
justice a fine appearance at night,  
and make it show up to proper ad-  
vantage. The court house is proba-  
bly one of the finest in the state, and  
the commissioners are to be congrat-  
ulated in their effort to preserve its  
good looks.

Opening of the hard surfaced road  
to Winterville will be received with  
genuine interest in all parts of the  
county, as everyone is interested in  
the campaign to improve county high-  
ways. Within a short time the road  
will be extended to Ayden and the  
county then will have something like  
thirty or forty miles of improved  
road. When the entire system is  
completed the industrial greatness of  
Pitt county will be more completely  
recognized. Big sums of money are  
being spent for road development in  
this state, but the cause is a good  
one and no one is ready to register  
a kick.

#### FOREIGN LOANS.

We regret to observe that one of  
the most influential of this country's  
organizations for the promotion of  
foreign trade has revived the idea  
that foreign loans in the United  
States should be accompanied by an  
agreement that the proceeds will be  
expended in this country.  
In support of this proposal the  
statement is made that a similar po-  
sition has been commonly followed by  
other countries. It is true that a  
similar condition has been frequently  
imposed by banking houses in other

countries, but it has not been custo-  
mary for foreign governments to in-  
terfere with loan floatations in this  
manner, and as a general proposition  
the idea is open to all the objections  
that lie against governmental inter-  
ference in business affairs.

In the situation of the United  
States at the present time the first  
appropriate comment is that such a  
regulation would be wholly unneces-  
sary to secure the purpose in view, as  
present exchange rates virtually  
give assurance that any credits creat-  
ed in this country will be expended  
here. So long as exchange on the  
United States is at a premium  
everywhere, nobody is going to with-  
draw funds from the United States.  
To do so would be an act of business  
folly. If the borrower does not want  
to use the funds for purchases here  
on his own account he can sell them  
at a premium to somebody who does  
want to use them here. The premi-  
um is proof of that.

The regulation has been suggested  
by the fact that in certain instances  
European borrowers are said to have  
used credits obtained in this country  
for the purpose of making purchases  
in other countries, as for example  
purchases of wheat in Argentina. Ob-  
viously, such a transaction would be  
impossible if there was not a demand  
in Argentina for means of making  
payments in the United States. In  
the supposed case, the loan would  
finance purchases here by Argentina  
instead of by the European country  
to which the credit was granted. The  
purchases would not be of wheat, but  
of something else representing an  
equivalent value. In the case where  
the European country wanted wheat

there would be competition with our  
wheat growers, but if the funds were  
used for a non-competitive purpose  
it is clear that the loan would be  
beneficial to all three of the countries  
involved.

# CROP SHORTAGE IN EUROPE MAY BOOST AMERICAN PRICES

### Reports of Commerce Department Indicate Increased Trade Today

By W. H. ATKINS, International News Service Staff Correspondent.

Washington, May 2.—Europe will rely heavily this year upon the United States, both for raw materials and foodstuffs. America's exports, therefore, will continue in as large a volume, if not larger than in 1921. The best estimates of American trade observers today revealed that Europe's crops are not up to predictions.

America's wheat surplus will be drawn upon to make up shortages in different European countries. While crops in the chief grain-growing regions of Europe are in fair condition there will be a deficiency in output because of poor results from the sowings last fall.

Competent experts abroad, reporting to the commerce department and other government agencies, agree that to make up the shortage in the larger producing areas, as well as the much larger deficiency in the Central European countries will mean a steadier flow of American products to European buyers.

A more hopeful view prevails of Europe's ability to finance heavier purchases. Reports to the Federal Reserve Board and other fiscal agencies indicate that European securities are being sold in large volume in the United States at the present time, and the result will be the establishment of new credit channels, through which larger foreign trade may be arranged.

Trade experts, reviewing Europe's food needs for the remainder of this year, cite the following facts:

#### Foreign Conditions.

Rumania one of Europe's great grain storehouses, offers had prospects for next season's harvests.

Intensive efforts are being made by England, France, Italy and Rumania to increase the spring plantings to make up part of expected shortages.

In Germany, the Netherlands and Poland the potato shortage, with accompanying high prices, has tended to stimulate larger acreage of potatoes at the expense of beet sugar acreage.

Conditions closer to normal appear to exist in Belgium, Scandinavia and Italy.

In war areas of Europe it is estimated that 90 per cent of the farmland will be under cultivation this year.

Heavy buying this spring already has restored partially the depleted grain stocks of Great Britain.

France, Belgium and the Netherlands must continue to purchase heavily of grains through the entire summer, experts declared.

Most persistent demand comes from Central Europe. This is due to the exhaustion of native grain stocks, potato shortage, scant supplies of fodder as a result of the drought last autumn.

Austria's import demands of flour alone probably will amount to 324,000 tons between March 1 and August 1.

Germany is far from self-supporting in her foodstuff production and must continue to buy extensively of American exporters.

SPANISH-AMERICAN NAVY OFFICERS PROTEST AGAINST THEIR REMOVAL

House Made to Harding to Repeal House Bill Eliminating Auxiliaries

By GEORGE R. HOLMES, International News Service Staff Correspondent. Washington. — Nearly 400 naval reserve and auxiliary officers of various grades now in active duty will be separated arbitrarily from the service July 1 without provision for the future under terms of the navy appropriation bill which has passed the house.

Included in this number of officers are fifty-nine old-time officers who composed the Naval Auxiliary Service which was organized in 1898 for the Spanish-American war. They were placed in charge of the naval supply ships, all of the officers of the regular naval establishment being needed for the battleships.

When organized, officers in the auxiliary service were accorded the same privileges as the regulars, with longevity pay and other benefits. In the emergency of 1917 congress legislated these auxiliary officers into the newly organized naval reserves. This deprived them of their longevity pay and other benefits and placed them on a par with volunteer officers of little or no service record.

The navy appropriation bill which passed the house made no provision for these fifty-nine auxiliary reservists, who had served both in the Spanish-American and in the world war. It is claimed for them that their service should give them a status identical with or superior to that of many of the younger regular officers.

No Retirement Pay. Legislation already enacted and bills pending before the house naval affairs committee provide for pensioning regular combat officers and for retirement at 60 years of age or for length of service. No retirement pay or other benefits are provided for the fifty-nine officers who composed the old naval auxiliary service, many of whom are nearing the sixty-year age limit.

These auxiliary officers have appealed to President Harding in an effort to correct this alleged gross discrimination. Letters of protest, in effect a round robin, have been mailed by each officer to the White House. It is expected the fight will be carried to the Senate Naval Affairs committee, where the work of the House Appropriations committee is to undergo careful revision. Friends of the naval officers expect the senate to grant relief from the apparent injustice.

The house appropriations committee considered the case of the reserve and auxiliary officers serving on active duty when it framed the appropriation bill. It was determined to reduce the cost of the naval establishment and decided the only way to effect reductions was to cut off officers and men. It was not authorized to make provisions for retirement or retirement pay, that being the duty and the province of the naval affairs committee.

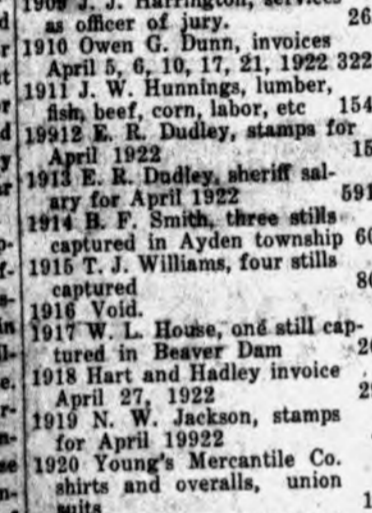

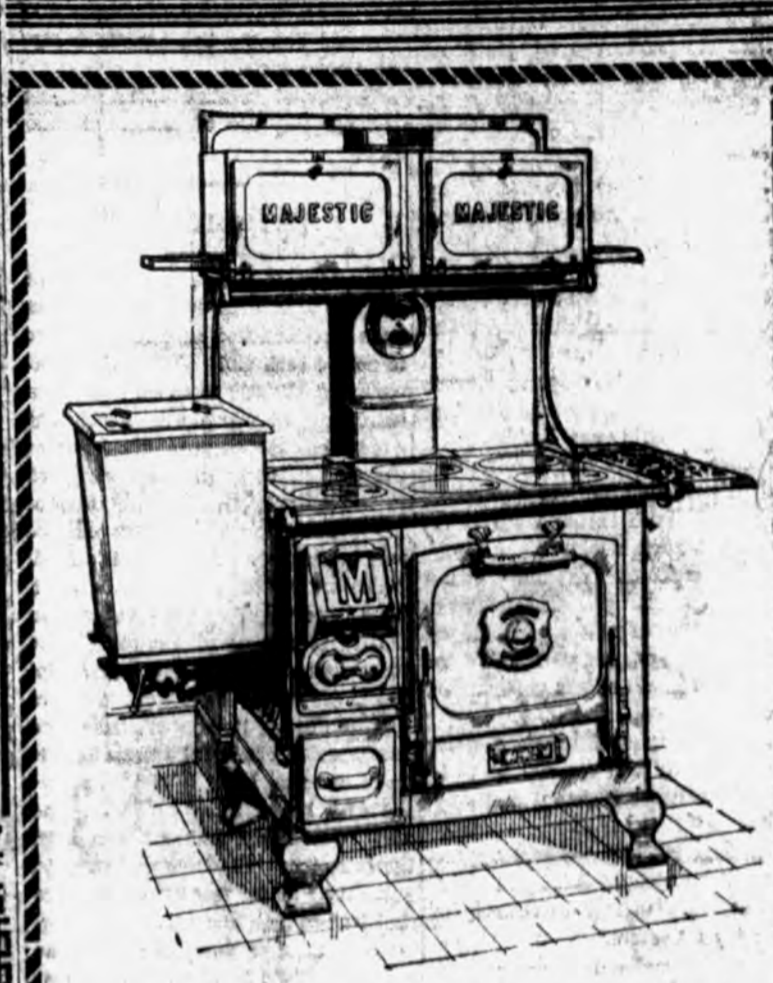

**Co-operative Concern With 4,000 Stockholders Unable to Meet Its Obligations.**  
(Wilson Times.)

Detroit, Mich., April 21.  
Last week's Guide had a short eleven-hour dispatch from Detroit telling of the failure of the Gleaner Clearing House Association, a co-operative concern organized in 1906 by the farmers of Michigan and financed by them. Further details of the failure can now be given.

Charles R. Talbot, vice-president of the National Bank of Commerce, and chairman of the bankers' committee which has been working with the board of directors and officers of the Gleaner Clearing House Association for about six weeks in an effort to straighten out the financial difficulties of that association, was appointed temporary receiver of the big co-operative scheme of the farmers of Michigan by Presiding Judge Arthur J. Webster, in Circuit Court, last week.

The receivership was granted on petition of the officers and directors of the Gleaner Clearing House association who also asked that the association be dissolved.

The total assets are figured at \$719,020.61, as of December 31, 1921 in an audit completed April 1, by Marwick, Mitchell & Co., accountants, while the liabilities are set at about \$446,745.33.

However, out of the assets, as figured, must be taken about \$200,000 in terminal properties, deeded back to Armour & Co., from which the Gleaner's Clearing House Association took over on land contracts many elevators, when the Federal Court ordered Armour & Co., to "unscramble" its elevator activities, according to William E. Brown, attorney for the Gleaner Clearing House Association in the present court action.

Fred E. Llewellyn, a former representative of Armour & Co., according to Attorney Brown, became manager of the Clearing House Association, April 1, 1920, and had charge of the elevators and equipment, at a salary \$1,000 a month, but he retired about six weeks ago when it became necessary to cut expenses, it was stated by Attorney Brown.

The Gleaner Clearing House Association was organized in 1906 as a voluntary association of farmers organized for the purpose of conducting a co-operative business. It was incorporated under the laws of the State of Michigan in 1907 and conducted as a general co-operative business on Russell street, Detroit, until April 1, 1920, when its properties, located at that point, were sold and the association moved its managing offices of the city of Grand Rapids.

**Had Many Warehouses.**  
The association operated elevators warehouses or potato seatings at the following points: Belding, Blanchard, Greenville, Ionia, Lakeview, McBrides, Marion, Newaygo, Reed City, Sandusky, Saranac, Scott, Sidney, Six Lakes, Stanton, Swartz, Creek, Trufant, Berrien Springs and Grand Rapids.

Owing to a continuous decline in prices of farm products during the last year and a half the association has suffered heavy losses at many of its points of operation. Michigan farmers have been in no position to reimburse the enterprise and no assistance could be secured from the War Finance Board because of technical limitations as to its field of operation.

An audit of the affairs of the association as of December 31, 1921, showed a stockholders' equity, over and above all indebtedness, in the amount of \$72,734.78.

It being impossible, however, to further finance the business, loans could not be met. From Fruitman's Guide of New York, Issue April 22, 1922.

**SEE U. S. LAST IS SLOGAN OF THE JAP TOURIST**

**Europe Takes Top Place as Choice of Tourists from Nippon.**

Washington, May 4.—"See America last," is the revised slogan of the Japanese tourist.

Reports of steamship bookings just received here from Tokio indicate that the Japanese going abroad for the first time is today reversing the old order of things by taking passage to Europe and returning by way of the United States. First-class cabins on all Europe-bound steamship lines are booked in advance until July, the reports state, while traffic on the trans-Pacific lines is said to have slumped materially.

According to Japanese officials, this marked increase in the number of tourists going directly from Japan to Europe does not indicate any falling off in the number of Japanese visitors to America. It merely means that there is a growing conviction among Japanese travelers that it is better to visit Europe first in order that their impressions of America may be had in the light of a previous knowledge of the Old World.

Heretofore the usual custom for a Japanese planning a word tour has been to go first to San Francisco or Seattle, cross the United States by rail and embark at New York for Liverpool or Brest, and, after "doing Europe," to return by way of the Suez Canal.

The crowded condition of the European lines, as compared with that of the trans-Pacific routes, also is accounted for in part by the fact that, while there have been considerable increases in passenger facilities in the trans-Pacific service, especially in view of the establishment of United States Shipping Board lines, there have been virtually no additions to the Japan-European service.

The increase in the local amount of

round-the-world passenger traffic is explained by the fact that many Japanese business men apparently are availing themselves of the full in business at home to take long delayed business inspection trips abroad.

**Lay-Greene.**

Chapel Hill, May 3.—The engagement of Miss Elizabeth Atkinson Lay, daughter of Dr. and Mrs. George W. Lay formerly of Raleigh, and now of Beaufort, N. C., to Paul Elliott Greene, of Lillington, was announced this afternoon at a party at Chapel Hill. The marriage will take place in the summer.

Miss Lay is at present field agent of the Bureau of Community Drama of the University Extension Division and a leading play writer in the Carolina Playmakers. She obtains her M. A. this year at the University and is a St. Mary's Raleigh graduate. "When Witches Ride," by Miss Lay, is to be published in the first volume of the Playmakers' by Henry Holt & Company.

Mr. Greene is the son of Mr. and Mrs. William Archibald Greene, of Lillington, a graduate of Buie's Creek Academy, an overseas veteran in the World War and recently a winner of the Keenan fellowship for 1922-23 in philosophy. He likewise is a playwright of ability and has produced a number of exceptional ones. One of these, "The Last of The Louries," is to be published in the same volume of the Playmakers with Lay's. On several plays, the two have collaborated.

Ed. Note.—Miss Lay is known most favorably in Greenville, having visited her sister, Miss Nancy R. Lay, who was in the city schools last year. Dr. and Mrs. Lay are well-known in Greenville and the announcement of Miss Lay's engagement will be a great surprise to the many friends of the family.

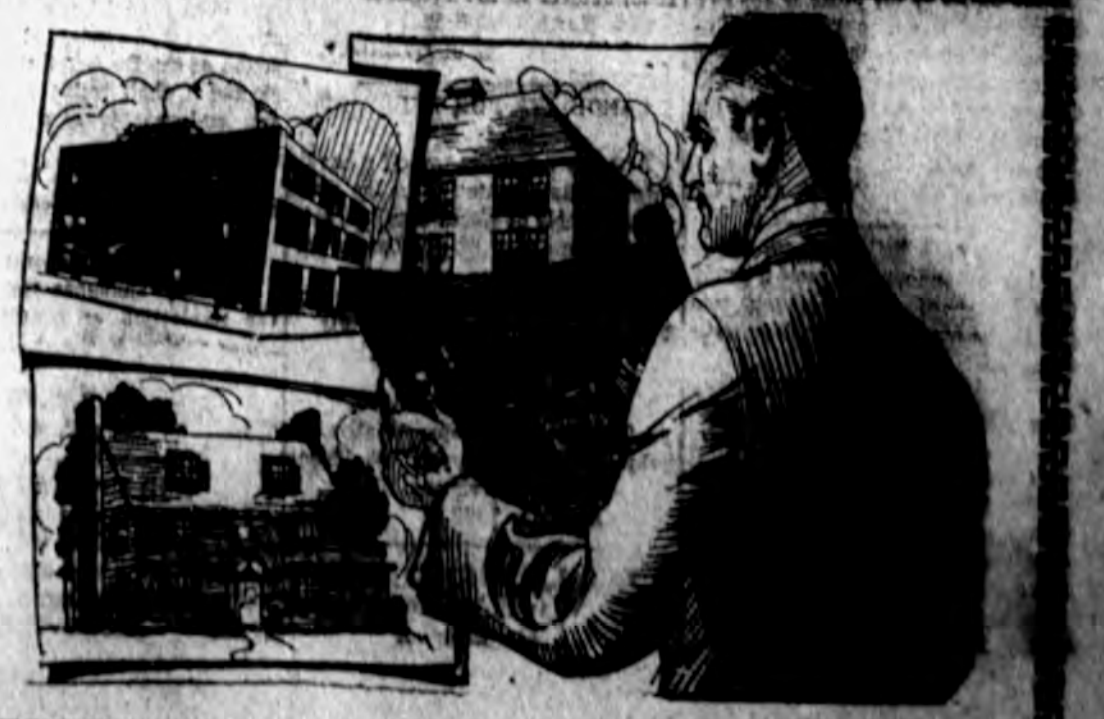
