CROPS DESTROYED BY HAIL STORM IN LOWER PART PITT

Crops and Buildings around Grimesland Badly Damaged by Storm Yesterday

HUNDREDS OF ACRES LAID BARE BY HAIL AND TERRIFIC WIND

Storm one of the Worst has Visited Community in Years.

A terrific rain and electrical storm passed over Greenville yesterday shortly before the noon hour, and while no actual damage was reported in the city it is said crops in the Grimesland section suffered to no little extent as result of hail. Small buildings were blown down on many farms, and carried for a great distance. Hail was so thick that ice could be raked up by the barrels in several places this morning.

The extent of the damage could not be determined this morning, but it is believed it will go into thousands of dollars. In fact, many of the largest farmers in the county will be forced to replant and several days, even weeks, will be necessary to repair the damage. The storm extended a great distance below Grimesland, and it is believed damage was great in all sections.

Never before in the history of Greenville, according to old observers, has such a heavy cloud been noted. The city was almost in complete darkness shortly before the torrential downpour of rain, and considerable fright was produced among those fearful of a more serious storm.

The precipitation was the heaviest in months considering the length of time in which the rain lasted, and streets and roads were flooded for several minutes. The clouds practically disappeared an hour after the rain began to fall, but slight showers occurred intermittently during the rest of the day.

It seems Greenville caught most of the rain, as travelers reported no rain at all from Ballard's Cross Roads to Farmville. On the other side of Farmville, however, the rainfall was as heavy if not heavier than that here. Slight damage has also been reported from other sections of the county by wind, but it seems the Grimesland community suffered the worst.

Electric light service in several homes was demoralized by the terrific electrical storm occurring during the latter part of the rain, but no serious damage was reported.

AMERICA TO OPEN FOREIGN MARKETS

(By International News). Washington, May 15.—American exports for the month of April exceeded imports by a hundred and four million dollars, the commerce department announced today.

Exports amounted to three hundred and twenty-one million dollars, a decrease of nine million dollars below March. Imports amounted to two hundred and seventeen million dollars, a decrease of thirty nine million.

BEAUFORT CROPS BADLY DAMAGED BY HAIL STORM

Lower Part of Pitt County Also Suffers from Severe Storm Yesterday.

According to information received here this morning considerable damage was done in the lower end of this county and Beaufort by the hail storm yesterday afternoon and hundreds of acres of crops will have to be replanted.

Its seems the Goose Neck community suffered probably worse than other sections of Pitt and it reports are true the destruction of crops will prove a severe handicap to farmer; this year. Many trees and sheds in path of the terrific windstorm were blown down and scattered over a wide area.

Beaufort county, below Washington, it is believed suffered to a greater extent that Pitt and damage in that section will run into several thousand dollars. Entire crops of two or three farms were reported to have been completely destroyed. No loss of life, however, has been reported from the Eastern section of the state.

Wind and hail passed over Pitt county but rain was not lacking. The section around Greenville witnessed one of the heaviest precipitations in years, and streams are swollen considerably as a result.

MOTHER'S DAY IS FULLY OBSERVED BY CITY CHURCHES

Splendid Tribute Paid to Mothers of Land by Ministers and Choirs.

COMMUNITY SING BROUGHT PROGRAM TO TERMINATION

Large Crowds Turned out Despite Torrential Downpour of Rain Before Noon

Observance of Mother's Day in Greenville was marked by appropriate and interesting services at practically all churches of the city yesterday, and large crowds turned out to pay tribute to the beloved personality despite threatening clouds and a torrential downpour of rain shortly before the noon hour. The occasion probably proved the most interesting in years, and was brought to a conclusion yesterday afternoon by a community sing held in the auditorium of the Teachers College instead of on the campus as first planned.

Programs at the churches were carried out in an interesting way, and large crowds joined in to pay tribute to the hundreds of mothers who had been provided places of honor at each of the churches. Musical numbers especially were of an inspiring nature, each choir doing its best to live up to the importance of the occasion and to pay homage to the character that has done more than any other to brighten the America home.

At the Memorial Baptist church Rev. Leland W. Smith delivered a powerful and timely sermon on the subject of "Mother's Wages." This came in the midst of a particularly interesting number of musical selections by members of the choir. The address of welcome was delivered by Dr. C. J. Ellen, followed by scripture reading by R. T. Burnette.

An offering was made by the congregation for motherless children, quite a neat sum being realized. Each musical number pertained in some way to Mother's Day, and proved very inspiring.

At the Methodist church mothers were provided a special place of honor, and were presented a program made every heart glad. Members of Sunday school classes read the proclamation of the governor of North Carolina regarding the observance of the day.

Rev. V. P. Scoville delivered an appropriate sermon at the regular morning service, and the choir rendered several special numbers of more than usual interest. Each member of the congregation was presented with a rose as they entered the door. Children's day exercises were held last night at eight o'clock and another splendid program was rendered by young members of the church.

At the Christian church Rev. W. P. Shanhart delivered a sermon in observance of the day, and paid a splendid tribute to the spirit of the American mother. A particularly interesting feature of the Sunday school hour was a program rendered by members of the Young Men's class. Mrs. Knott Proctor sang an appropriate selection and Mrs. Travis Hooker presided at the piano.

At the Immanuel Baptist church Rev. Thomas W. P. Plemons spoke on the subject of "The Mother's Day Support" and brought out many interesting facts in connection with the life of sacrifice of the mother of today. Mothers were provided a place of honor, and listened to a particularly inspiring program by the choir. The day was also observed by classes of the church.

The Presbyterian church also observed the day in an appropriate way. St. Paul's Episcopal church also had arranged a program observing the day, and Rev. C. H. Bacon preached a timely sermon.

At the Free Will Baptist church Rev. N. D. Wiggs spoke during the regular morning services. A fitting program had also been arranged for the Sunday school hour. The choir rendered several special selections.

The day was one of the fullest in the history of observance of the occasion, and hundreds of people turned out despite the unfavorable weather conditions.

Knights Templar of Greenville are to be congratulated upon the splendid showing at the Winston-Salem conclave, and deserve the support of Greenville people in preparing for the conclave here in 1924.

The battle over the tariff bill is being prolonged regardless of efforts of its supporters to bring about immediate passage. Opposition to the measure is more serious than one time expected and the bill will have a narrow escape from defeat.

It is gratifying to note that North Carolina people lead the state in payment of debts. This goes to show that prosperity is more general in this state and people seemed to think that that isn't the cause we must have more honest people than other states.

After his vacation in Jersey President Harding should return to Washington today in fine physical condition. The chief executive believes in a certain amount of recreation as his administration has proven, and if this is necessary to governmental success, then he will have a great career.

The community sing in Greenville yesterday was greatly enjoyed, and proved the value of the sing in bringing the masses together in one great cause. It was very appropriate this event should have been held on Mother's Day as it was a splendid tribute to the mothers of the city.

Improvements at the court house will add greatly to the appearance of a large temple of justice, especially when the white way lights have been installed. With the lawn brilliantly illuminated at night the improvements to streets and laws will stand out in bold relief and show how necessary this work really was.

The reported agreement with Russia was merely reported as no agreement has occurred and is highly improbable at this time. This is to be regretted as it was hoped the issue had been decisively disposed of with all factions satisfied. Russia is in a pitiful plight, and if settlement is possible the allies should make it an actuality as early as possible.

Six rival contracts for the lease of Muscle Shoals are now being considered at Washington, but it seems continued government ownership is destined to meet with general favor. Henry Ford's offer has met with more popular approval from the public, but his chances seem to be very slim at present time.

Greenville and Pitt county business men should support the movement now under way for erection of a Masonic Temple building. Such a structure would add greatly to the appearance of the city and give the Masons even greater distinction among state organizations. An enormous amount of money will be necessary in providing the kind of building necessary, but with proper spirit this can be raised in short order.

The British delegation at the Genoa economic conference has accepted the last Russian reply as a satisfactory basis for European peace. If Russia would only accept the British demands in the proper spirit the world would be gratified at the success of the conference. They will first have to prove their sincerity before anyone feels the slightest elation.

Violence reported among miners near Pittsburgh, Pennsylvania is to be regretted as it was hoped this could be averted until the strike was brought to an end. Dynamiting private property cannot improve the situation even though some may think so, and the government should take steps to avert further violence. The miners sowed their own oats, and the reaping cannot be made any under getting mad and attempting to damage that belonging to others.

That giant meteor, supposed to have imbedded itself into about five hundred square feet of ground in an isolated section of Virginia certainly did the populated communities a great favor by landing there. Its damage would have been inestimable in other sections, and for that reason Virginia people are extremely thankful things happened as they did. It seems now however that the colide bursted in the air and didn't hit the earth.

That conditions are becoming more favorable in business circles of the nation is evidenced by reports received from large financial institutions. These convey a spirit of optimism gratifying indeed and should have much to do with establishing a keener interest in country communities. The road back to normalcy is filled with many treacherous places, but business has turned the bend and is bound for easier things.

Increased stability of American business features the trade review of the federal reserve board just made public. This is another indication that America is on a permanent road to recover, and one in which the general public will be intensely interested. Stability of business may not be in evidence in every community, but if it is not the business man himself is responsible.

Governmental investigation of the proposed merger of six independent steel corporations into one gigantic institution has been ordered, according to latest reports from the capital. This information will be received with keen interest as the consolidation of these great concerns would give too much of an opportunity for monopolizing the industry. The senate should give the proposal the consideration of which it is deserving. It's an issue in which the entire country is involved, and if the senate should pass it up then others can't expect to take much interest in it.

Formal request for suspension of increased freight rates in the state of Tennessee has been lodged by the Public Utilities commission. That this matter should be given the consideration it deserves goes without question. Freight and passenger rates in all southern states are higher than they should be and railroads should take immediate steps looking to reductions. Every enterprise of any size should register a kick until they see some results. Conditions will remain the same unless something of the kind is done as the railroads will certainly get everything out of the public they can. Excessive rates are not to be tolerated anymore than prices, and decisive action should be taken for public protection.

Automobiles are more responsible for the general increase in crime than all other causes combined, according to a statement issued by the president of the prisoners relief society of America. The truth of this statement cannot be doubted. The facilities for criminally offered through the speed and comforts of an automobile are indubitable, and if everybody can be impressed of the fact it is probable the situation may become more favorable. Crime however, would still prevail in alarming proportions whether the automobile existed or not, but it is proving a big factor to the criminal and we can't deny that. The return to normalcy may improve the situation and for that reason the public is turning its eyes hopefully to the future.

A MASONIC TEMPLE NEEDED.

Greenville Masons are considering the erection of a Masonic Temple building to cost in the neighborhood of \$50,000. Such a structure would add greatly to the appearance of the city, and it is up to the public to encourage erection as early as possible. The Knights Templar were inspired by their record in Winston-Salem recently and it is certainly probable this will have much to do with their activities. They are planning to entertain about a thousand state masons in 1924, and to do this properly a large and commodious Masonic home will be necessary.

Greenville is certainly fortunate in having progressive organizations, and the record they have made should be the pride of the entire city. Loving cups have been coming to Greenville regularly in past years, and we can't afford to permit interest in these records to fall off.

No criticism is made of those tobacco farmers, who after giving the matter due consideration, signed the 5 year pool, believing it best to do so, but criticism is made, and justly so, of those who induced farmers to sign, telling them if they did not sign they would have no place to sell their 1922 crop of tobacco. In such cases, our opinion is the farmers are not bound to deliver their tobacco to the pool.

We again question the righteousness to the taxpayers of Pitt County of having our Farm Demonstration agent to spend his time and the County's money building up Corporations of this or any other kind. We ask the Tax Payers is it right for any Pitt County officer to use his office for private gain. Has not our County Farm Demonstrator received a fee for every man he has induced to sign the 5 year pooling contract, in addition to his salary paid out of Pitt County's taxes.

Why is it that the officers of the Co-operative Association have given orders that another drive must be put on to get more tobacco farmers to sign the 5 year pooling contract, when claim after claim has been made that they have already signed up from 60 to 95 per cent of the tobacco? Are they afraid to have their system tried out side by side with the Auction Sale of Tobacco which has prevailed for 30 years? We suggest to the Tobacco Farmers and business men generally that no thing is fairer than have the Co-operative method or any other method tried out by the side of the Auction system at the same time. If this new system gives the farmers more dollars for their tobacco, then our farmers and business people are intelligent men and will soon find it out. If their new system gives the farmers less dollars for his tobacco then it should and will quickly blow up. Farmers in Pitt and adjoining counties have been reading claims that the Kentucky Pool has been making fine sales for their tobacco some as high as 29c but up to this they have only paid the farmers about 7 or 8c. If they should get 7 or 8c more which would still be much less than auction prices, what has become of the million of dollars held back?

Does any thinking man believe that any tobacco warehouse has been turned over to the Association because the owners wanted to help the farmers? If you will look over the list of warehouses offered you will find many which have not run for years, others have been running at a great loss, involving banks and bankers, others whose business greatly declined in 1921 and prospect of a greater decline in 1922. So with promises of big price, big rental and big fat salaries they were finally persuaded to help (?) the poor tobacco farmer by lett ing him furnish the tobacco out of which to pay these bills

Gentlemen look over the list of warehouses offered and you will be convinced that the poor farmer was not so much considered as self, and self alone, in disposing of them to the association.

METHODISTS RAISE OVER \$21,000 FOR SPLENDID BUILDING

Baraca Class More Record Gift to Building Fund at Yesterday's Service.

Yesterday was the greatest day that the Jarvis Memorial Methodist Sunday school has ever yet experienced. In spite of the showers and the threatened downpour the Sunday school had the largest attendance that it has ever had. When the count was made there were six hundred and eighteen present. The previous high mark was that of the Sunday before which was 584. All in all it was the most enthusiastic crowd that any Sunday school has ever seen, and it was a most inspiring sight to see such a crowd gathered together to worship God and honor Mother. The school began at nine-thirty, and classes were over at 10:15 and from then until 10:45 a special program in honor of The Mother's was carried out.

Naturally the enthusiasm of the school knew no bounds.

PRESIDENT STONE ANSWERS INQUIRIES ABOUT COMPARISON OF AVERAGE

Mr. J. N. Gorman, Greenville, N. C.,

Dear Sir: On my return home I find yours of April 21st, which explains my delay in answering it, and I am very glad to give you the information you desire.

In Kentucky we have a law requiring all auction markets to report at the end of each month the number of pounds sold of tobacco and the dollars it brought.

The Secretary of Agriculture keeps these reports, and they show that up to April 1st, 1922, 36,495,960 pounds had been sold by the growers who had not joined the association, at a gross average of \$21.40.

Where Judge Bingham was misunderstood in his speech at Goldsboro, and the opposition is quoting him as having said the tobacco sold over the loose floors had only averaged between 17 and 18 cents per pound, when in fact he meant to say that the tobacco sold over the loose leaf markets in Kentucky during the month of March averaged between 17 and 18 cents per pound.

The records of the State Department show that the actual average during the month of March was \$17.81, and if we continue to sell our re-dried tobaccos at the prices we are now getting for them, the association will average from \$2.00 to \$4.00 per 100 pounds more than the outsider has gotten on the public market.

You will notice that I have said above the average of all tobaccos sold of the 1921 crop on the outside was \$21.40 gross, and as the warehouse charges this year have been considerably over \$1.00 per 100 pounds, it will only net approximately 20 cents per pound.

Trusting this gives you the information you desire, and if I can be of any assistance at any time, I will be glad for you to write me.

GREAT BRITAIN IN FAVOR OPEN DOOR OIL POLICY TODAY

England is Willing to Co-operate with America, Sir John Cadman Says

London, May 1.—Britain's oil policy is an "open door" policy, according to Sir John Cadman, formerly director of His Majesty's Petroleum executive and now technical adviser to the Anglo-Persian Oil Company.

"We are anxious to see oil developed in every part of the world, no matter by what nation," Sir John declares. "There is no do-in-the-manger spirit whatever. We have no desire to secure oil fields at the expense of other nations or to attempt to take an unfair advantage."

This statement from Sir John Cadman bears out previous predictions made by the International News Service to the effect that the men behind the British oil industry have reached a decision that they can best achieve their ends by co-operating with the oil interests of the United States instead of fighting them.

Already there has been an agreement reached between the Standard Oil Company and the Anglo-Persian Company of Great Britain for joint development of the oil fields in Northern Persia. This agreement is now awaiting ratification by the Persian government. Another important step taken toward co-operation between the oil interests of the two nations in the recent agreement between the British controlled oil fields and the Standard Oil Company for the joint development of the fields in Venezuela.

To Announce Agreement.

Within a short time it is expected that a definite agreement will be announced whereby the oil interests in Mesopotamia will be definitely opened to American exploitation. It may also be expected that working agreement will be achieved between British and American interests for the development of fields in Colombia, fields which have been almost completely under British domination.

There is no definite statement forthcoming from the British oil interests as to the cause of the apparent change of heart which has led to this generous policy towards American oil interests. However, it is whispered in high political circles that the British government dropped a hint.

EUROPEAN BRINGING OF COTTON WILL AID PLANTERS

Industrial Recovery of War-Torn Regions Booms Business.

By W. H. ATKINS, International News Service Staff Correspondent.

Washington.—Kings of the cotton industry see in Europe's industrial recovery larger demands which will provide a healthy stimulus to production of the South's great staple.

Government experts sent abroad to study the cotton situation are optimistic in their reports. Greater demand for cotton to supply mills in France, Czecho-Slovakia, Great Britain and Poland is predicted by these experts.

Advance in the cotton industry in France and Czecho-Slovakia is emphasized particularly in reports to Washington.

Most of the cotton spindles in France are busy. In the last six months French cotton mills have consumed nearly 400,000 bales of cotton or about 75 per cent increase in capacity over the preceding six months' period.

France now has about 9,000,000 less than before the war. Mills destroyed during the war have been rebuilt but plans are being made to reconstruct such enterprises. It is now estimated that only 5 per cent of the looms in France are idle.

Practically all of the cotton used by France is of American origin. Her imports from Egypt and India are comparatively small. American exporters, it is said, are contemplating a heavier movement of cotton in the coming months.

At the end of the Czecho-Slovakian fiscal year, April 1, that country had consumed 350,000 bales of cotton, or more than double the amount consumed in the preceding year.

Further estimates are that between April and August, this year, Czecho-Slovakia will consume 117,000 bales.

Improvement in exchange conditions in some of the large cotton-consuming countries forecast larger cotton demand to supply mills capable of increasing their output of cotton manufactures.

The government is continuing its policy of aiding American cotton producers and exporters in the export plans. The War Finance Corporation is now making liberal loans to aid in this financing, where other means are lacking.

RUSSIAN COMMERCE IN 1913 AND 1921.

Recent developments in Europe lend interest to studies of the Trade Record of the National City Bank of New York regarding the commerce of Russia prior to the war and at the present time. Russian foreign commerce, says the Trade Record, had grown rapidly in the quarter century preceding the war, and aggregated nearly \$1,500,000,000 in 1913, of which about \$700,000,000 was imports and approximately \$800,000,000 exports. The rapid growth of that trade is evidenced by the fact

that the total imports had advanced from \$328,000,000 in 1900 to \$687,000,000 in 1913, while the exports had advanced from \$369,000,000 in 1900 to \$760,000,000 in 1913. While the opening years of the war gradually reduced the exports, the total imports showed little reduction down to 1915, due to the large quantities of war material bought from the United States, Great Britain and France.

Following the changes in form of government in 1917, the statistics of imports and exports were not available, and the first complete year's picture we now get of Russian Foreign Trade is a statement by the Soviet government of the imports and exports in the year ending November 1, 1921, forwarded to the United States department of commerce by its commissioner at Riga. It shows the total exports, valued in gold roubles at 1913 prices, at 16,735,000 roubles as against 1,520,000,000 roubles in 1913, while the valuable of "Soviet purchases abroad and actual importers" during 1921 is 157,000,000 roubles of purchases and 134,000,000 of actual imports, as against 1,375,000,000 roubles of imports in 1913.

The principal countries from which Russia drew her imports in 1913, stated in the order of their relative value, were Germany, Great Britain, China, United States, France, Persia and Austria Hungary. Approximately one-half of the imports of 1913 were officially reported by the Russian government as imported from Germany, and fully one-half of the total imports of that year were sent to Germany, Great Britain occupying second rank in the countries to which the exports were sent, Netherlands third, France fourth, and Austria Hungary fifth. The total imports from Germany in 1913 were 652,000,000 roubles out of a total of 1,375,000,000; from Great Britain 173,000,000; from China 84,000,000, and from the United States 79,000,000. The exports in 1913 were, to Germany 454,000,000 roubles out of a total of 1,520,000,000; Great Britain 268,000,000; Netherlands 177,000,000; France 101,000,000 and to the United States 14,000,000.

ANOTHER BIG SALE OF TOBACCO MADE BY CO-OPERATIVE
R. J. Reynolds, Through Vice-President T. H. Kirk, Makes Third Largest Purchase of Leaf from Burley Growers' Association.
Lexington, Ky., April 28. — An announcement that the Burley Tobacco Growers' Co-operative Association had sold another "good big order" to the R. J. Reynolds Tobacco Company was made at Lexington Friday night by President James C. Stone. The announcement followed a busy day for President Stone, James N. Kehoe of Maysville, Bush W. Allin, of Harrodsburg, and John P. Winn of Versailles, members of the executive committee, and a member of conference between President Stone and representatives of a number of manufacturers, including the R. J. Reynolds Company.

While a number of sales have been made since it was announced that the redried tobacco was ready for market, the sale Friday was the first in which the identity of the purchaser has been made known.
The purchase by the Reynolds Company is the third large purchase of leaf tobacco made by this company through the Burley association. No information was available as to the actual amount sold or the prices to be paid. The sale was negotiated by Vice-President T. H. Kirk, one of the leading men in the Reynolds organization.
That there will be no lack of demand for the redried tobacco was indicated by the receipt of additional inquiries for this tobacco and for price schedules by President Stone, in charge of sales, and by personal calls of representatives of the manufacturers on the head of the Burley association.
