NEEDLEMAN'S FIGHT IN DEFENCE OF LIFE BEGINS IN WILLIAMSTON TODAY

Grand Jury is Composed Mostly of Farmers; Alleged Mutilators Will Also Be Tried; Needleman to Enter Plea of Not Guilty

Williamston, May 4. - "If you know of any instances where the law has been violated, either by public officials or private citizens, it is your sworn duties to return bills of indictment," charged Judge Natt A. Sinclair, in Superior Court here today to a Martin County grand jury called to pass upon bills presented to it in connection with an alleged attack by Joseph Needleman upon a young white girl, and his subsequent removal from jail and mutilation by a band of men.

"It is not necessary to lynch a man to be guilty of lynching," continued the jurist, "for in the efforts of a mob to lynch a man, they lynch, in reality, the law." Judge Sinclair told the jurors that conversation and acts tending to incite lynchings were against the law, and that they instituted conspiracy against the law. Without once calling Needleman by name, Judge Sinclair in directing the grand jury in connection with the jail breaking, stated that the circumstances leading up to the break should be investigated to determine whether the instance could have been forestalled. He deplored the belief that the law could be taken into the hands of individuals to execute as they saw fit. He added that it was the duty of officers of the law to protect their prisoners from mob violence, even though the prisoner might be guilty of the most heinous crimes. The grand jury retired to consider the bills of indictment about mid-day. It is composed with but one or two exceptions, of farmers.

There was some talk today of a move by the defense for a change of venue to another county, but nothing of an official nature along this line developed.

Williamston, May 4. - Joseph Needleman, tobacco salesman, was ready to enter a plea of not guilty at the opening here today of the special term of court to try him for an alleged attack upon a young white girl. His attorneys, shortly before the court opened at 10 o'clock, gave as their opinion that the only charge upon which the state could expect to build any kind of case would be one of immoral conduct rather than a capital offense, for which Solicitor Don Gilliam was prepared to ask an indictment of the grand jury.

In addition to Needleman, 30 alleged members of the mob, which broke into the Martin county jail and removed him, were prepared for indictment which Solicitor Gilliam asked against them on behalf of jail breaking, while against seven of them the Solicitor said an additional charge of performing a mutilating operation upon Needleman would be asked.

Needleman, still weak from the operation alleged to have been performed on him five weeks ago, and pale and wan from the loss of blood and consequent confinement arrived shortly before the court opened in company with his attorneys and under heavy guard. Judge Natt A. Sinclair, and Solicitor Gilliam also arrived a few minutes before the court opened.

The 30 men against whom indictments were to be asked, it was indicated, might ask for separate trials, in which case the court proceedings would be long and drawn out. The degree of the alleged guilt varies and it was stated that some of them had admitted participation to a certain extent in the removal of Needleman. None of them, however, had admitted having performed the operation upon Needleman, and in advance of each presentation to the grand jury of bills of indictment, Solicitor Gilliam would not make public the names of those against whom he would ask indictment on the major offense.

Should there be empaneled convictions of the 30 men, it will be the first time in North Carolina that an alleged mob has been apprehended.

(Associated Press.) Williamston, May 4.—The Superior Court of Martin County, Judge N. A. Sinclair presiding, met in special session here this morning to consider indictments against Joseph Needleman, charged with the capital offense of attacking a 17-year-old white girl, and a group of men charged with having taken him from jail following the alleged offense. Solicitor Gilliam indicated he would ask indictments against at least seven on the charge of having mutilated Needleman, which crime is punishable by from 5 to 60 years in the State's prison. The crime of conspiracy and jailbreaking, with which the others are charged and against whom indictments will be asked by the Solicitor, is punishable by a fine of \$500 or from 2 to 15 years in the State's prison, in the discretion of the court.

The condition bringing about the request for the special term was brought about when Needleman was arrested, March 27, charged with having attacked a 17-year-old girl. He was taken from jail March 29 by a masked mob and mutilated. An investigation resulted in the arrest of a number of suspects. Solicitor Gilliam has indicated that he will ask the grand jury to indict the following on the charge of conspiracy and breaking jail: Henry D. Mother Crazed at Slayers' Graves



TRAGIC BURIAL OF ELECTROCUTED DIAMOND BOYS

One of the most pathetic pictures ever made is this, depicting the greatest agony a mother could bear—witnessing the burial of two sons who were electrocuted for murder. In the little Hebrew cemetery in New York City, in a drizzling rain, two rabbis intoned the burial ceremony for Joseph and Morris Diamond, executed for the murder of two bank messengers. Their families were greatly respected. The mother (right), after the ordeal of saying goodbye to her sons in the Sing Sing death cell the previous night, suffered a complete mental collapse at the funeral and, screaming incoherently to her dead boys, had to be forcibly restrained from leaping into the graves. Her daughter, Sally (left), who raised funds and sought out witnesses to the moment of execution in attempt to save her brothers' lives, also struggled to cast herself into the graves.

VAN ORMAN WINS IN BALLOON RACE

Was Victor Last Year and Will Probably Represent U. S. in Gordon Bennett International Race

St. Joseph, Missouri, May 4.—William T. Van Orman, with the Good Year—3 won, the National Elimination Race started from Rosecrans Field here late last Friday by five balloons.

He was the victor last year and again will represent the United States in the Gordon Bennett International Race, providing the Contest Committee of the National Aeronautic Association approve his performance.

After a day and two nights Van Orman landed early Sunday morning near Reform, Alabama, a total distance of about 530 miles.

The balloon drifted at a rate of approximately 25 miles an hour, and kept an altitude of about 12,000 feet on a South Eastward journey, Van Orman reported. A radio equipment, which he carried along, kept him informed of weather conditions and the progress of the other balloons.

Captain Henry E. Honeywell finished second was less than 59 miles behind Van Orman. Captain Honeywell was disqualified on the ground that he had delayed his start and the local contest committee is to meet today to act definitely on the matter.

SEA WORKS DESTRUCTION AT ISLAND OF HELIGOLAND

Hamburg.—The shores of the island of Heligoland are caving in with startling rapidity. For years the sea has been steadily encroaching on this little island, and all that was left of the bathing beach has been almost completely claimed by the sea as its own. Recently a huge slice of approximately 3,000 cubic yards plunged into the sea with a terrific roar. The villa of a prominent Berlin banker, just completed, is now seriously imperilled, while an adjoining building is being torn down. A solitary garden pavilion hangs on the verge of the precipice as though at any moment it might drop into the depths below. As the erosions of the waves have of late produced a number of deep crevices in the rocks, it has been found necessary to close the public road over the cliffs.

FLEET TO WAGE WAR AGAINST RUM FLEETS

New York, May 4.—Units from the Coast Guard of the entire Atlantic Sea board with the Revenue Cutters, Grechem, Seneca and Mohawk were mobilizing at the Clifton Coast Guard base on Staten Island today for a new war against rum fleets lying off the coast from New Jersey to Connecticut. The fleet comprises more than 60 vessels, armed, manned and equipped as for battle. Most of them are motor craft between 40 and 60 feet long and capable of great seas. The vessels will put to sea tomorrow and will operate under orders to shoot and then investigate afterwards in case of suspected rum runners.

FRIEND IDENTIFIES BODY OF WOMAN AS MRS. J. DESIDERIO

Declares Bit of Cloth Found Near Mutilated Body Was Part of Garment Loaned to Mrs. Desiderio

Gary, Indiana, May 4.—The mystery surrounding the death of a young woman, whose partly burned body was found a week ago near Chesterton, appeared to be solved today with the identification of the torso by a girl friend. Florence Boto said the body was that of Mrs. Josephine Desiderio, 21, of Gary.

This corroborated the identification by Mrs. Desiderio's mother, Miss Boto said she had been with Mrs. Desiderio the day before the murder. She was arrested yesterday in South Bend, Indiana. One of the strongest points in Miss Boto's identification, according to the police, was the fact that she said a bit of cloth found near the mutilated body was part of a petticoat she had loaned to Mrs. Desiderio. Mrs. Arthur L. Housen, of Michigan City, however, was equally positive as identifying the body last night as that of her daughter, Mrs. Mary Berg, 22, wife of Harold Berg, a railroad brakeman.

CITY ELECTION IN PROGRESS TODAY

Mayor and Three Aldermen to Be Elected as Result of Today's Voting

Greenville voters went to the polls today to elect a mayor and several aldermen. The two contestants for mayor were the present incumbent, D. M. Clark and Captain J. J. Laughhouse. The aldermen were First Ward, J. I. Smith present incumbent and V. C. Fleming; Third Ward, R. E. Sellers, present incumbent and P. L. Goodson; Fifth Ward, J. E. Dees, and Dr. R. L. Carr.

Although the voting was a quiet affair much interest was manifested with friends of the various contestants working untiringly through the day.

In the Fifth Ward, Mr. C. H. Edwards, who has served as alderman during the past year withdrew leaving the field open for the two new candidates.

At the time of going to press no figures could be obtained as to the result of the election.

Hearings on Revision of Postal Rate Will Be Opened July 20

Washington, May 4.—Hearings looking to a permanent revision of the postal rate to take care of the \$68,000,000 increase in the salaries of postal employees will be opened by joint committees of the Senate and House here on July 20, and will be carried forward in half dozen cities throughout the country. Hearings are authorized in the Postal pay and rate increase measure passed in the last session of congress.

The "Los Angeles" Nearing Destination

Washington, May 4.—The dirigible, Los Angeles, reported her position at six o'clock this morning as 400 miles from Mayaguez, her Portorican destination. The message said the ship's four engines were running at a cruise speed with a wind from the north east. It was slightly cloudy, and head winds expected further along. It was estimated here that at the time she reported, she was off the east coast of Florida, and was maintaining her schedule. It is estimated that the dirigible would arrive in Mayaguez at four o'clock this afternoon.

NEGRO SHOT AND KILLED BY ELMER McLAWHORN NEAR AYDEN LAST NIGHT

CONSIDER MEISSNER APPOINTMENT AS MERELY TEMPORARY

Regarded by Some as a Shrewd Political Move; Was Secretary to President Ebert

Berlin, May 4.—Political circles interpret the appointment of Dr. Meissner, who was secretary to President Ebert, and Simon, to continue as Secretary to President Von Hindenburg as merely temporary, pending settlement of a three cornered fight behind the scene, between German Nationalists, The People's Party, and the Military Federation. The latter would like to see Lieutenant Colonel Von Seidman, who was associated with Field Marshal, Von Hindenburg, throughout the campaign, installed as the president's secretary.

Leaders of the People's Party fully expected to name the president's secretary from their ranks as a reward for what they called their sacrifice of Dr. Jarrez, their presidential candidate in the first campaign, in favor of Von Hindenburg in the second.

The Nationalists do not want the People's Party to name the secretary and at the same time they object to the appointment of a militarist, because they fear the opposition of large industrial interests, and the damage that might be done to German business interests. The appointment of Meissner not only avoids an immediate clash of these differences, but it is regarded by some as a shrewd political move to insure the continuity of the Executive Administration.

Since February the Home Economics Department of Woman's Club has had for its objective a Home Demonstration agent for Pitt county. A committee of interested county women appeared before the board in March at which time the motion for the work was tabled. This morning a committee composed of women from Pitt and Beaufort counties appeared before a joint session of the county Commissioners and Board of Education. The women from Pitt county told of the need of an agent in Pitt county, a few of whom told of the wonderful results of the work in counties in which they had lived, while the women of Beaufort county told what the work had meant to the women of their county. A strong appeal for the work was made by Miss Pauline Smith, district agent. After Miss Smith's talk the Board was asked to make their decision and they voted unanimously for an agent.

The women from Beaufort county who made talks for the work were Mesdames Riggs, Taylor, Whitley and Miss Taylor.

This work will be started in the county the first of July. A great deal of credit is due the Woman's Club for sponsoring this movement.

Means to Begin His Two Year Term Federal Penitentiary

New York, May 4.—The conviction of Gaston B. Means, former Department of Justice Agent, by a jury last July on a charge of having conspired to illegally remove liquor from a bonded warehouse, today was confirmed for once before the Circuit Court of Appeals. Means, who has been on bail, was ordered taken into custody, that he might begin his two-year term in the Federal Penitentiary at Atlanta, to which he was sentenced at the time of his conviction. A \$10,000 fine was also imposed.

Holds That Congress Had Right to Enact Publicity Provision Income Tax Law

Washington, May 4.—Congress had the constitutional authority to enact the publicity provision of the income tax law, the District of Columbia Court of Appeals held today in the case from the District Supreme Court.

Grand Jury Recommends That McLawhorn Be Held Under Bond of \$1000, While Jack Blount and Dewitt Smith Be Held Under \$500 Bond for Aiding and Abetting

Mack Brown, negro, of the Ayden section was on Sunday night shot and killed by Elmer McLawhorn, white. The coronor's jury returned the verdict that said deceased came to his death by pistol shots in the hands of Elmer McLawhorn and recommended that McLawhorn be held for the next term of Superior Court, for the trial of criminal cases, under a bond of \$1000 and that Jack Blount and Dewitt Smith, white men of the Ayden section, be held under \$500 bonds for aiding and abetting.

According to information McLawhorn, Blount and Smith, left Ayden last night about 11 o'clock and walked to the home of Laurie Cox, white man, who resides a short distance from Ayden. After calling Cox out and having a talk with him, the three men started on their return trip to Ayden. On the way back they stopped at the home of Frank Brown, negro, who lives near a little store, and requested that he sell them Coco-Coias and cigars. Brown advised them that he did not run the store and told them where they could find the owner of the store.

The three men, according to their story, went on down the road and when only a short distance away from Brown's home they were shot at, all the bullets missing them. Blount and Smith ran, while McLawhorn went to Ayden to get an officer.

In the mean while, Brown and his wife, who were badly frightened had, immediately upon the departure of the men, gone to the house of Brown's brother, Mack Brown, for protection. Upon their arrival there they told Mack that some one was attempting to break in their house and he not having auto with which to go for an officer sent them on to another brother's a short distance away. According to Frank Brown's statement, he had passed on when he heard the shooting.

Upon arrival in Ayden, McLawhorn secured the services of Officer Hattell, who after advising McLawhorn to secure a pistol, they started for Frank Brown's house. A short distance from the house they met Daughy Smith, who said that they had heard that Dewitt had been shot, and he was going for an officer and doctor. The three men then went to Frank Brown's but before reaching the house they were joined by Blount and Smith. While knocking and asking for admittance to the home of Frank Brown, Mack Brown was seen approaching the house, with according to information, a shot gun. McLawhorn seeing that the negro was approaching them, turned and shot him, death being instantaneous.

After securing all evidence it is believed that Mack Brown was the negro who fired at the men.

According to a statement made by the coronor, the negroes claim that Brown was not armed, but investigation has revealed a gun, with which it is believed he was armed.

Revision of Rate Construction Necessary Remove Discrimination

Richmond, May 4.—Complete revision of the Rate Construction covering interstate traffic between North Carolina and Virginia, together with a revision of the North Carolina exception sheet to make classifications conform to the Southern Classification ratings, will be necessary in order to remove unjust variance discriminations now existing between the classifications and mileage contracts controlling freight shipments within the state of North Carolina as compared with shipments between Virginia and North Carolina. Thomas D. Geoghegan, first witness to testify before examiner Carter, of the Interstate Commerce Commission in a complaint of the Virginia Corporation Commission, started today.

THE CO-OPS AND INDEPENDENTS

The Tobacco Growers Co-operative Association and the independent tobacco buyers seem to be engaged in a fight to a finish. Unless the former changes its business methods very materially, the latter will ultimately win out. Real co-operation in business organization is diametrically at variance with extravagance in the management of their affairs. Fancy salaries and unnecessarily high overhead expenses do not comport with the principle of co-operation. So far as we have been able to judge from the conduct of the affairs of the Tobacco Growers Co-operative Association, the only real beneficiaries of it are the tobacco growers who do not belong to it. The benefit comes to them through competition which finds expression on the part of the independent buyers in a supreme effort to put the co-ops out of business. This fact of itself makes the competition more acute and the independent market generally more attractive. On this account it is to the interest of the outside growers that the co-operative association, which just now seems to be rapidly coming into disfavor, continue to function. The principle involved in the truism that competition is the life of trade,

is tremendously in evidence in that existing between the co-ops and the independent buyers. Thus the outside grower is the direct beneficiary. He gets a large per cent more for his tobacco than the members of the association, and gets it all in cash at the time when he needs it most.

The time has passed, if it ever existed, for the farmers to join an agricultural association for philanthropic purposes or to promote an alleged principle which is long on promises and short on fulfillment. God knows they are entitled to all they can get for their products and they need the money and need it badly when they are sold.—Fayetteville Advocate.

THE GREAT INSANITY

General Manager William E. Mallalieu of the National Board of Fire Underwriters, was recently invited to talk to the National Fire Waste Council. Commenting on his remarks, the Insurance Field said he handed them an idea that illuminated the heavens of financial economy like an aurora borealis. "Imagine," he said, "the situation if the eminent Secretary of the Treasury, as the representative of the American people started each day's work by causing to be thrown into the bottomless reaches of the Atlantic Ocean forty-one living persons and a load of gold pieces worth \$1,500,000, an amount equivalent to the per diem average of our national destruction by burning! The country would first stand aghast and then would call for an immediate investigation by an authority on mental diseases. And yet the American public is staging practically the same performance every day in the year.

"What, in effect, is the difference? In one case the lives and gold treasure would be lost to society—in the other, equivalent lives and values are actually cast to the four winds; it is no figment of the imagination but a concrete occurrence. The sum total of destruction is made up of fires scattered over our land from coast to coast so that the people at large fail to absorb the full picture that represents our national ash-heap and apparently are unable to grasp its true significance."

North Carolina continues to lead the United States in the percentage of its birth rate. Also, the State holds its own in having the smallest per centage of foreign-born population of any state.

Governor A. W. McLean received 294,441 votes in the election of 1924 against 185,627 received by his opponent, I. M. Meekins, who was later appointed on the federal court bench.

North Carolina, one of the thirteen original States, has a stripe, as well as a star in the United States flag.

The State normal school for negroes at Fayetteville was founded in 1877. It now has 12 building and 42 acres of land. The buildings are valued at \$300,000, the land at \$30,000 and the furniture and equipment at \$65,000.

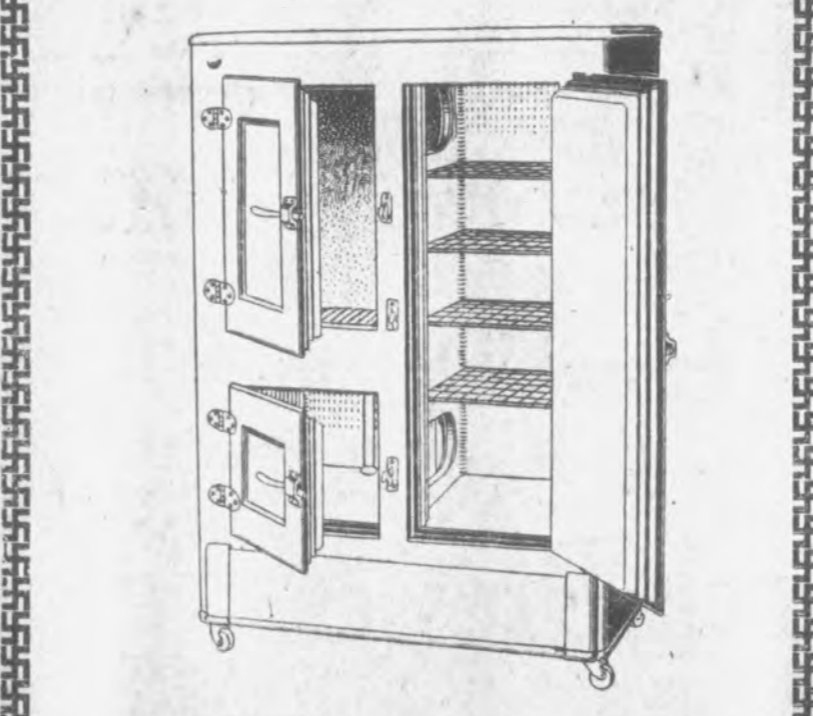
