LOCAL DELEGATES ROTARY CONFAB MIRACULOUSLY ESCAPED DEATH MONDAY

Automobile With Mr. and Mrs. J. E. Winslow and Dr. and Mrs. C. L. Outland Struck By Reckless Motorist and Tossed Headlong Into Waters of Long Lake

Gary, Ind., June 22. - Mr. and Mrs. J. E. Winslow and Dr. and Mrs. C. L. Outland of Greenville, North Carolina, miraculously escaped death early this morning on the crowded Dunes Highway leading into Chicago when their automobile was struck by a reckless motorist and tossed headlong into the waters of Long Lake, lying along the narrow 20 foot road-way.

The car sunk nearly out of sight in the marshy waters of the lake with members of the party forced to break out a rear window in the Winslow's Hudson Coach to get to safety on the roadway.

They were unable to open the car doors because of pressure of the water. When a wrecking crew arrived from a Gary garage only the extreme top of the car at the rear was above the water and several hours were required before the machine could be pulled out of the lake.

They were on their way west to Gary from Michigan City with Dr. Outland driving Mr. Winslow's new Hudson Coach when the accident happened. The southside of Dunes Highway was a steady stream of motorists that have given the highway its name as "The Cross Roads of America."

Dr. Outland turned out as far as he could but the other car struck the left front wheel of the Hudson and the crash locked the steering apparatus.

The Hudson was whirled about and then shot headlong through the closed grouped string of cars and into the lake on the outside of the road. Highway men cannot understand how a general piling up of automobiles on the roadway was avoided. Not one of the four was seriously hurt despite the impromptu bath they received.

ARRANGEMENTS FOR WAR DEBT ARE BEING HAMMERED HOME

Congress of International Chamber of Congress in Session at Brussels Considered it a Vital Issue

Brussels, June 23.—Early arrangements of the war debt is being hammered home as a vital issue at the Congress of the International Chamber of Congress now in session here. Unless these debts are out of the way, the delegates were told by Sir Allen Anderson, Deputy Governor of the Bank of England, the recovery of maritime trade will be impossible.

Sir Allen speaking on shipping problems, ownership of merchant ships, submitted figures to show it without profits and declared it partly responsible for the present world trade stagnation.

He also referred to "Flag Discrimination," which some of the delegates understood to be an allusion to the policy of the United States. The American delegates are ready to reply should there be any specific reference to the matter.

Paris, June 23.—Today's session of the Chamber of Deputies considering the Moroccan question broke up in a free for all fight when the white haired Colonel Picot, Deputy of the Right Block, rushed to the Rostrum and slugged the Communist Deputy, Dorait, squarely in the face as the latter was attacking the French Government.

JUDGES' TALKING

(Clark's Comment)

"The man who buys liquor, then drinks it, and then drives an automobile on the public highway, is a terrible menace to life and property," declared Judge Albion Dunn, talking to the grand jury of Pasquotank county. "Such drivers should be placed where they will be unable to operate a car for some time," his honor significantly added. So say we all, but before asking for three cheers for Judge Dunn it may be well to wait and see if his actions square with his words. Hastly

disclaimer is entered of any purpose to question his honor's sincerity, but judges so often talk like they would do things to the drinking motorists and then back off, that some of us wait to be shown. About the same time, in Forsyth Superior court, Judge Shaw was remarking, in sentencing one convicted of driving while under the influence of drink, that he considered it a most serious offense, the drinker endangering his own life as well as the lives of others. The defendant had appealed from a fine of \$100 in the county court and Judge Shaw multiplied that by three. But why, seeing that the seriousness, the potential danger of the offense, is so aggravated, do the judges so uniformly sidestep a jail sentence? Three hundred dollars is a stiff fine, but that doesn't hurt like 30 days on the road. Imprisonment is a stigma, of course, but it is certainly no more disgraceful to serve a term in jail or on the roads than to get drunk and parade the highway where all may see, a menace to all who pass.

In that same talk to the Pasquotank jurors Judge Dunn made other and further remarks that are cause for cheer, such as: No more judges are needed. If the 8-hour law was applied to bench and bar congested dockets would be speedily cleared; announced opposition to the abolition of capital punishment; criticised the recklessness of law enforcement officers, who needlessly endanger the citizens. Some of that all of us can cheer, and all of it some of us can cheer.—Greensboro Daily News.

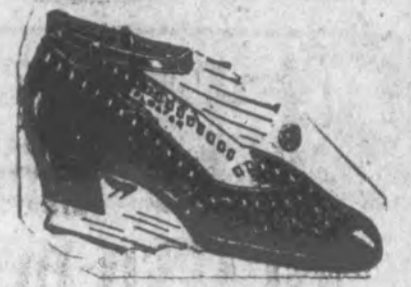

In discussing this subject Mr. Ballard said, "God has always been a king. We can think back as far into the eternity of the past as it is possible to think, and we find the Kingdom of God in existence in His Heaven, and Jehovah on the throne."

Based his claim on passages found in the 28th chapter of Jeremiah, the 14th chapter of Isaiah, and the 4th chapter of Ezekiel, the pastor declared that God had a kingdom here on earth long before the day of Adam, with cities and "fruitful fields" and ruled over by one of his angels, Lucifer, who afterwards fell, and became the devil. He pictured the destruction of this kingdom, and the cursing of the earth, so that it became "void and without form" as described in Genesis. God then reformed the earth and made man "after his own image" and tried to build up another holy kingdom among men. This experiment failed because of the disobedience of man. Mr. Ballard then told about the kingdom of Heaven and the Kingdom of Christ which is to be eternal on this earth.

NOTES ON TARHEELIA

The North Carolina State Board of Embalmers, created by the General Assembly of 1901, is composed of three members of the State Board of Health and two practical embalmers elected by the Board of Health. The Board regulates the practice of embalming bodies in the State.

The pure food law passed by the General Assembly of 1899, amended in 1905 and re-drafted and passed as a new act in 1907, forbids the manufacture or sale of adulterated food or beverages and charges the Department of Agriculture with its enforcement.

Seth Sothel, appointed Governor of Carolina by the Lords Proprietors in 1678, was captured by pirates on the way to his new post and detained until 1682.

Foreign corporations, before being permitted to do business in North Carolina, are required to file copies of their charters in the office of the Secretary of State.

The following North Carolina counties are under the jurisdiction of the Audubon Society: Alamance, Alleghany, Ashe, Avery, Brunswick, Buncombe, Burke, Caldwell, Columbus, Dupham, Edgecombe, Greene, Haywood, Iredell, Lee, Lenoir, McDowell, Mecklenburg, New Hanover, Northampton, Rockingham, Rowan, Rutherford, Surry, Watauga, Wake and Yancey.

Judicial Conference to Convene in Raleigh On Next Thursday

Raleigh, June 22.—The judiciary of North Carolina, together with 20 attorneys, one from each judicial district of the state, will assemble in Raleigh Thursday of this week, for the first sitting of the Judicial Conference created by the 1925 General Assembly. Members of the judiciary are automatically members of the conference. The attorneys were appointed by Governor McLean, acting under the authority vested in him by the act creating the conference.

The presiding officer will be the chief justice of the Supreme Court, Judge W. P. Stacy. He will outline the purposes of the conference in an address to the other judges and the attorneys present.

The creation of a Judicial Conference to study the needs of the courts of North Carolina and, if practicable, to bring about reforms, was urged by Governor McLean, in a message before the General Assembly last winter.
