SHEPHERD FREED MURDER CHARGE IN TYPHOID CASE

Assured That Charge of Murder of Mrs. McClintock Will Not Be Pressed by Attorney Crowe

Chicago, June 27. - William D. Shepherd was found not guilty last night of using typhoid germs to kill William N. McClintock, his millionaire foster son, after the jury had deliberated five hours and forty minutes.

Within a half hour he was freed from jail where he had been since March 13, on his personal bond of \$5,000. A charge of slaying Mrs. Emma Nelson McClintock, William's mother, is held against him.

Despite the jury findings, Judge Harry Olson, municipal court chief justice, and instigator of the investigation of McClintock's death, will continue to probe and prosecute, if that is possible, he said.

A burst of cheers came from the crowded court room when the verdict was announced and a broad smile wreathed the face of the accused. Shepherd and his attorneys shook hands with, and thanked each other as they filed from the box after the past six weeks trial.

"The state made a good fight and lost," said Robert E. Crowe, State's attorney, and leader of the prosecution. "The verdict speaks for itself."

Chicago, June 27. - William D. Shepherd acquitted last night by a jury of the charge that he murdered his millionaire foster son, William N. McClintock, today was assured that the second murder charge, that he killed Mrs. McClintock, William's mother, would not be pressed by State's Attorney Robert E. Crowe.

Strike Situation in Shanghai Shows Improvement Today

Shanghai, June 27. - With the exception of shipping, the strike situation was improved here today. 80 percent of the stores closed during the recent disturbances have re-opened. Those remaining closed are apparently bankrupt. The shipping strike is causing heavy losses to the Chinese customs revenue and is severely affecting British and Japanese trade.

50 representatives of Chinese students' unions from various parts of the country meeting here yesterday, have resolutions urging the Canton Government to take military possession of Shanghai, the foreign settlement at Canton. The Chung King, and Japanese food supplies are running short, with local markets continuing their refusal to sell to these foreigners. Russian and Japanese employees all in the customs service at Ningpo, have gone to Shanghai or other places where there is less agitation against foreigners.

Reports from Tiensin, say that during the dragon boat festival, Chinese pamphlets were distributed saying, "do not riot. The present ill treatment of the Chinese by the British is the result of the Boxer uprising in 1900, therefore we should be more careful this time."

ECONOMY PROGRAM IMPOSED BY COURT ON CLARA K. YOUNG

Order Issued Directing That \$1,400 Weekly Must Be Set Aside for Benefit of Her Creditors

Los Angeles, California, June 27. - New York creditors of Clara Kimball Young, screen and stage star, were given the opportunity today to take advantage of a court imposed economy program placed on Miss Young when an order was issued directing that \$1,400 of her \$1,500 weekly salary must be set aside for the benefit of creditors while she is in California. The order was made as the result of proceedings instituted by Robert W. Brownson, Detroit lawyer who is attempting to collect on a judgment obtained against Miss Young for legal services.

Miss Young was haled off the stage in a local theatre yesterday and brought into superior court where the judge in attempting to determine the living cost for the Young woman learned that the ring she wore, apparently a two carat diamond, was an imitation diamond costing less than \$5.00, that the necklace, which appeared to be a string of pearls, was valued at \$15 by Miss Young, and the Ermine coat she wore on the stand was her most expensive article of apparel, costing about \$300.

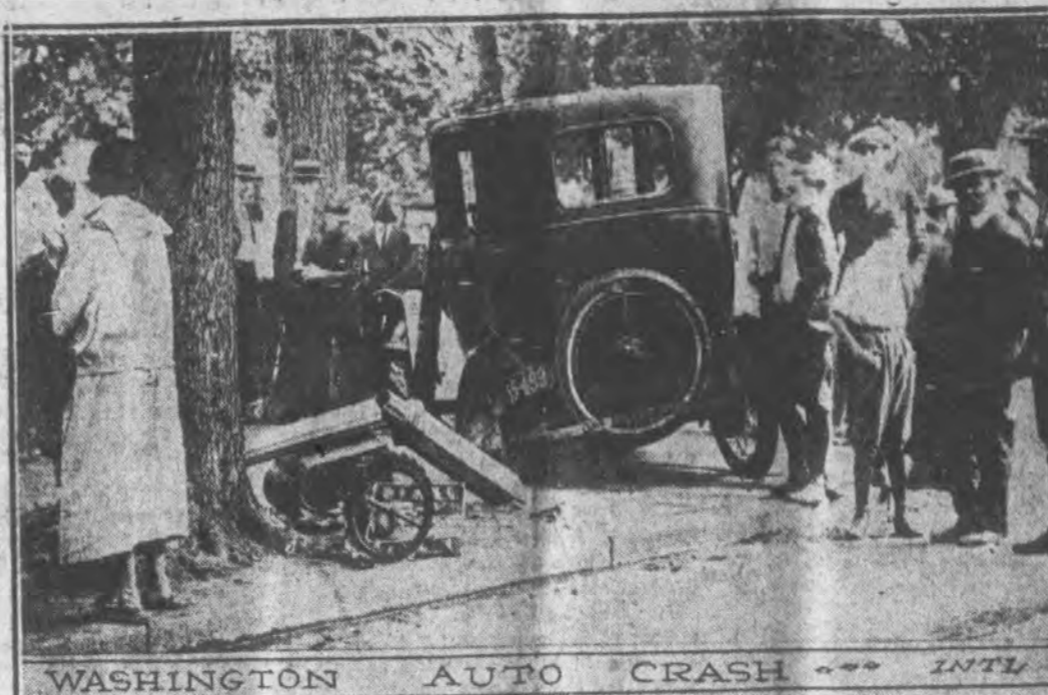
From 5 to 7 Thursday afternoon there will be a garden party given by Mr. and Mrs. Mark W. Brown at their residence, "Many Oaks."

BALLARD SENTENCED TO BE ELECTROCUTED THURSDAY, JULY 30

Negro Will Pay Extreme Penalty for the Slaying of Deputy Sheriff W. D. Eason

Gatesville, N. C., June 27. - Jim Ballard, negro of Gates county, will pay the extreme penalty on July 30 for slaying of Deputy Sheriff William V. Eason, unless further process of law on the exercises of executive clemency at the hand of the executioner is stayed.

The negro was sentenced to electrocution here last night by Judge Henry Grady, presiding over the special term of court after the jury had returned a verdict of guilty, without recommendation of mercy.

Heve Ballard, brother of the defendant was sentenced to 20 years imprisonment, and Cora and Sallie were given two year sentences.

Stock Holders of Southern Railway Lose Suit Today

Richmond, Va., June 27. - Certain stock holders of the Southern Railway today lost their suit in law and equity court here by which they sought to collect \$29,000,000 in back dividends, which they claimed was due them from the railway. Judge Ben T. Crump announced his decision against the stock holders this morning after having the case under consideration since last March.

CHINESE SHOW ECCENTRIC IDEAS OF SPORTSMANSHIP

Anking. - Sports meets which are being held throughout the Yangtze Valley in central China are demonstrating the lack of appreciation among Chinese youth of the spirit of sportsmanship and the need of training along this line. At another meet recent yagover nment technical school was playing basketball with the local Mission Cathedral school. The technical school was ahead most of the first half, but a few minutes before the whistle sounded the Cathedral boys picked up and tied the score.

In the second half it became quite obvious that the Cathedral team was the stronger and would doubtless win. The technical boys, seeing themselves losing stopped playing on the pretext that the baskets were not round. They proceeded to tear down the baskets, then went to the government dressing building and wrecked the place.

Two days later St. Paul's high school in Anking was playing football against a local government school. The head master of the mission school saw to it before the game that the back gate to the grounds was unlocked as a precaution against trouble. St. Paul's won, and the minute the game was over the winning team made a hasty exit through the gate and hurriedly found refuge in the mission compound closely pursued by the loser and their supporters.

THREE NEGROES SENTENCED TO DIE IN ELECTRIC CHAIR

Calm in Receiving Court's Decree: Two Declare, "They Had Made Their Peace With God"

Winston-Salem, June 27. - In Superior Court here this morning, Judge Shaw sentenced three negroes convicted of murder early in the week to die in the electric chair at State's prison.

John W. Dawkins, and Ernest Keys, convicted of the murder of John H. Vaughn, August 2, last, were sentenced to be electrocuted August 28, and Fred Jones, found guilty of killing John M. King in a hold-up on the night of June 13, was sentenced to die September 4.

Notice of appeal was given by Attorneys for Dawkins and Keys. Counsel for Jones asked for a new trial on the ground of newly discovered evidence, and by agreement, July 25 was set for the date to hear the petition.

The negroes were calm in receiving the court's decree two of them declaring "they had made their peace with God."

ONE BODY RECOVERED FROM GILLISTHEATRE

Death Toll Will Probably Be Only Two or Three Instead of 35 as at First Stated

Kansas City, Kan., June 27. - With one body recovered from the ruins of the Gillis Theatre building destroyed by an explosive and fire Thursday night, search was continued today to determine if any more lives had been lost. Fire officers said the death toll probably would not reach more than two or three instead of 35 or more as first stated.

GOVERNMENT SEEKS PURCHASERS FOR THE SHOALS PROPERTY

Everyone Interested in Proposition Advised of Conditions Under Which Power Will Be Sold

Washington, June 27. - The War Department announced today that Major General Taylor, Chief of Engineers, had written "to everyone who has shown an interest in Muscle Shoals power, asking if they would be interested in the purchase of the power."

The question applied to power developed at the plant during the testing period of the main generator unit beginning August to continue for several months. Replace were requested by June 30, and the conditions under which power would be sold were outlined in the communication.

Votes Passage of the Fiscal Bill Minister Caillaux

Paris, June 27. - The Chamber of Deputies has taken its first step toward putting France back on a gold basis, in the opinion of Finance Minister Caillaux, by voting passage of his fiscal bill 330 to 34. The vote was taken this morning after an all night session and the measure subsequently was passed by the Senate.

Article two of the bill increasing the paper circulation by 6,000,000,000 francs, was passed by a vote of 328 to 119, and article three authorizing a gold basis loan in exchange for National Defense Bonds, by 373 to 36. The remaining articles were adopted by a show of hands.

60 MILES AN HOUR CLAIMED FOR SPEEDY SOUTHERN BOAT

Plaquemine, La. - Capable of making a mile in 55 seconds, "Miss Plaquemine," a hydrospeed boat constructed by Henry N. Sherburne, of Plaquemine, is believed to be one of the fastest boats ever built in this section.

"Miss Plaquemine," with the eight other members of the fleet, is the result of the need of Mr. Sherburne, its inventor, for a rapid means of transportation over the bayous of Louisiana in visiting his various business enterprises scattered along these channels. It has no under-water propeller, being driven by a 90 horse power Curtis airplane motor mounted on the stern, using a propeller of the type mounted on planes for driving power. The boat is 20 feet long and seven feet wide and when traveling in shallow water, while at slow speed she draws six inches.

AMERICAN CONSUL CALLS ON CHINESE CIVIL GOVERNOR

Makes Visit in Attempt to Settle Differences Between Chinese and Foreigners; Obtains No Results

Canton, China, June 27. - The American Consul, accompanied by the Commander of the U. S. Asheville, called on the Chinese Civil Governor here yesterday on invitation of the latter, to attempt mediation of the differences between Chinese and Foreigners.

The American consul did not see the Chinese Civil Governor, but was received by his Secretary. No results were obtained from the conference, and the consul was invited to call again.

The French and British are making further defenses at Shamen, the Foreign Colony. The positions occupied by troops and machine guns are well protected and practically all foreign women and children have left Canton. No further firing has been reported.

The Chinese troops, which yesterday were observed occupying positions opposite Shamen, have remained quiet. It is reported that France has demanded an indemnity of about \$45,000 for the shooting of Edward Pasquier, a French citizen, who was killed when Chinese demonstrators fired across the canal from Canton to Shamen. The demands of the French, the report said, also includes cessation of hostilities of the strike, and the deportation of civil governor. Telegraphic communication is interrupted.

Informed of the plans, the president, the dispatch says, remarked he might not like it. In case the president does not accept it, the dispatch continues, it is probable that he will not oppose Congress making an appropriation for a summer White House.

EAST CAROLINA COMMERCE BODY IN MEET HERE

Luncheon at Rotary Club Enjoyed by Number of Citizens From Pitt and Lenoir Counties

The Eastern Carolina Chamber of Commerce held a get-together luncheon here yesterday at the Rotary Club which was enjoyed by about thirty representative citizens from this and adjoining counties.

The meeting was presided over by Mr. J. W. Holmes, of Farmville, president of the organization, and following the delightful luncheon, Mr. N. G. Bartlett, secretary of the Eastern Carolina Chamber of Commerce, explained the purposes of the organization and the great work that it is trying to accomplish.

He pointed out that one of the greatest needs in this section now was a combined effort against the boll weevil if we are to save this year's cotton crop. He stated that government experiments had proven that the weevil could be exterminated by means of poisoning and that unless farmers tried to rid themselves of this menace the banks would soon refuse to extend credit. Mr. Bartlett also outlined briefly the publicity campaign being carried on by the Chamber of Commerce in its efforts to attract new industries and home seekers to this section.

The address of Mr. Bartlett was followed by a number of short talks brimming with praise for the work that has been accomplished by the Eastern Carolina Chamber of Commerce and pledging support to its future efforts.

Reports Say Provisional President of Greek Republic May Resign

Athens, June 27. - Admiral Comdouriotis, Provisional President of the Greek Republic, may resign, it was reported today in political and diplomatic circles, as a result of Thursday's coup by which General Pangalos, former War Minister, overthrew the cabinet and established a new government under Pangalos Premier-ship. M. Lambrakin, Editor of the Elatherous Tipos, was arrested today by order of the new Premier for publishing an article this morning recommending that the leaders of the Right Party oppose the new government.

POISON THE WEEVIL

Reports from weevil experts who have been employed in this section to help exterminate the pest indicate that already the crops are infested with great numbers and unless a combined effort is put forth immediately

there is little hope of saving this year's cotton crop. As pointed out by N. G. Bartlett, secretary of the Eastern Carolina Chamber of Commerce, in an address here yesterday, there is only one sure way to get rid of the boll weevil and that is by poison. Government experiments have brought to light this means of freedom from the weevil and now it is up to the community to unite their efforts to carry on this war on the pest. The chief trouble in this section lies in the fact that neither farmers nor business men have taken the weevil seriously but the government warns that the situation is steadily growing worse and unless steps are taken to curb the rampage future cotton crops in this section will amount to but little. With this warning bankers are beginning to realize the seriousness of the situation and word has been sent out that no credit will be extended to individuals or communities where no effort to get rid of the weevil is being made. With the true picture of conditions so clearly in view it behooves business men as well as farmers of Eastern North Carolina to join together in a campaign to get rid of the boll weevil.

CHAPTER IX—Continued

We had proceeded some five more miles when again we saw a white arrow upon the rocks. It was at a point where the face of the cliff was for the first time split into a narrow cleft. Inside the cleft was a second guidance mark, which pointed right up it with the tip somewhat elevated, as if the spot indicated were above the level of the ground.

It was a solemn place, for the walls were so gigantic and the slit of blue sky so narrow and so obscured by a double fringe of verdure, that only a dim and shadowy light penetrated to the bottom. We had had no food for many hours, and were very weary with the stony and irregular journey, but our nerves were too strung to allow us to halt. We ordered the camp to be pitched, however, and, leaving the Indians to arrange it, we four, with the two half-breeds, proceeded up the narrow gorge.

It was not more than forty feet across at the mouth, but it rapidly closed until it ended in an acute angle, too straight and smooth for an ascent. Certainly it was not this which our pioneer had attempted to indicate. We made our way back—the whole gorge was not more than a quarter of a mile deep—and then suddenly the quick eyes of Lord John fell upon what we were seeking. High up above our heads, amid the dark shadows, there was one circle of deeper gloom. Surely it could only be the opening of the cave.

The base of the cliff was heaped with loose stones at the spot, and it was not difficult to clamber up. When we reached it, all doubt was removed. Not only was it an opening into the rock, but on the side of it there was marked once again

shot past us with tremendous force. It was the narrowest escape for one or all of us. We could not ourselves see whence the rock had come, but our half-breed servants, who were still at the opening of the cave, said that it had flown past them, and must therefore have fallen from the summit. Looking upwards, we could see no sign of movement above us amidst the green jungle which topped the cliff. There could be little doubt, however, that the stone was aimed at us, so the incident surely pointed to humanity—and malevolent humanity—upon the plateau.

We withdrew hurriedly from the chasm, our minds full of this new development and its bearing upon our plans. The situation was difficult enough before, but if the obstructions of Nature were increased by the deliberate opposition of man, then our case was indeed a hopeless one. And yet, as we looked up at that beautiful fringe of verdure only a few hundreds of feet above our heads, there was not one of us who could conceive the idea of returning to London until we had explored it to its depths.

On discussing the situation, we determined that our best course was to continue to coast round the plateau in the hope of finding some other means of reaching the top. The line of cliffs, which had decreased considerably in height, had already begun to trend from west to north, and if we could take this as representing the arc of a circle, the whole circumference could not be very great. At the worst, then, we should be back in a few days at our starting-point.

We made a march that day which totaled some two-and-twenty miles, without any change in our prospects. I may mention that

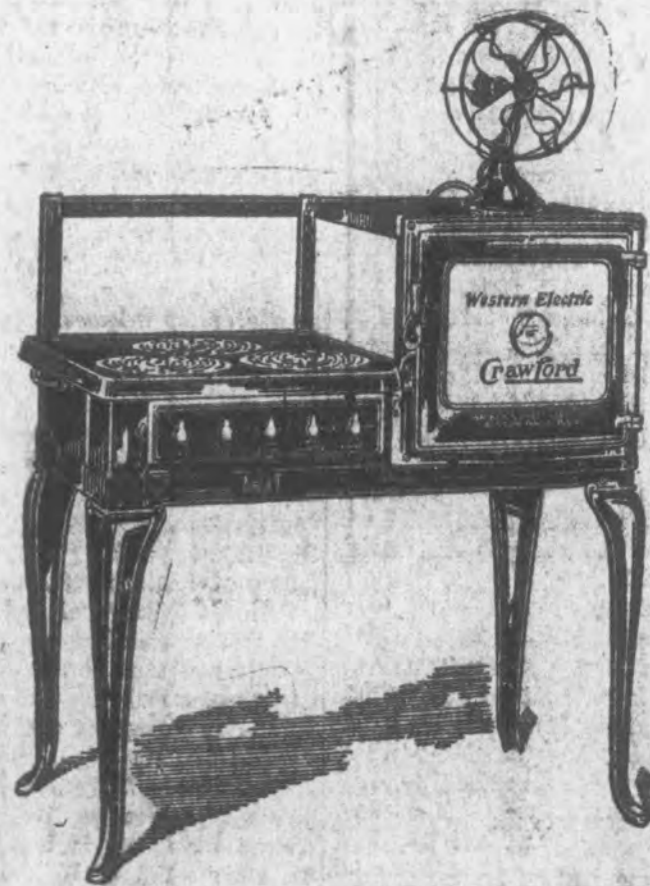

the sign of the arrow. Here was the point, and this the means by which Maple White and his ill-fated comrade had made their ascent.

We were too excited to return to the camp, but must make our first exploration at once. Lord John had an electric torch in his knapsack, and this had to serve us as light. He advanced, throwing his little clear circle of yellow radiance before him, while in single file we followed at his heels.

The cave had evidently been water-worn, the sides being smooth and the floor covered with rounded stones. It was of such a size that a single man could just fit through by stooping. For fifty yards it ran almost straight into the rock, and then it ascended at an angle of forty-five. Presently this incline became even steeper, and we found ourselves climbing upon hands and knees among loose rubble which slid from beneath us. Suddenly an exclamation broke from Lord Rexton. Clustering behind him we saw in the yellow field of light a wall of broken basalt which extended to the ceiling. "The roof has fallen in!" In vain we dragged out some of the pieces. Too much cast down to speak, we stumbled down the dark tunnel and made our way back to the camp.

our aneroid shows us that in the continual incline which we have ascended since we abandoned our canoes we have risen to no less than three thousand feet above the sea-level. Hence there is a considerable change both in the temperature and in the vegetation. We have shaken off some of that horrible insect life which is the bane of tropical travel. A few palms still survive, and many tree-ferns, but the Amazonian trees have been all left behind. It was pleasant to see the convolvulus, the passion-flower, and the begonia, all reminding me of home, here among these inhospitable rocks. There was a red begonia just the same color as one that is kept in a pot in the window of a certain villa in Streatham—but I am drifting into private reminiscence.

That night—I am still speaking of the first day of our circumnavigation of the plateau—a great experience awaited us, and one which for ever set at rest any doubt which we could have had as to the wonders so near us.

You will realize as you read it, my dear Mr. McArdle, and possibly for the first time that the paper has not sent me on a wild-goose chase, and that there is inconceivably fine copy waiting for the world whenever we have the Professor's leave to make use of it. I shall not dare to publish these articles unless I can bring back my proofs to England, or I shall be hailed as the journalistic Munchausen of all time. I have no doubt that you feel the same way yourself, and that you would not care to stake the whole credit of the Gazette upon this adventure until we can meet the chorus of criticism and scepticism which such articles must of necessity elicit. So this wonderful incident, which would make such a headline for the old paper, must still wait its turn in the editorial drawer.

And yet it was all over in a flash, and there was no sequel to it, save in our own convictions. (To Be Continued)

OXFORD UNIVERSITY GETS RARE SET OF ASTROLABES

Oxford, Eng.—The 63 astrolabes given to the university by Dr. Lewis Evans, brother of Sir Arthur Evans, the archaeologist, when taken with those now in the possession of the colleges, from the most complete and representative series of this rare and ingenious instrument.

The astrolabe appears to have been invented in the second century before Christ by Hipparchus, who measured the exact length of the year, the distance to the fixed stars, the time of revolution and eclipse of the moon, and invented trigonometry and the system of locating points on the map by latitude and longitude. It is a flat dial with a sight across it and a number of hands which can be set against the numerical tables around the circumference. Its use is to measure the altitude of the sun and the stars.

The astrolabe is one of the few scientific instruments saved from the wreckage of Greek civilization.

The Arabs, who in their great day were among the most enthusiastic scientists known until the present scientific developments in America and Germany, brought the instrument to a high standard of perfection and used it generally for navigation.

MUSIC LOVERS WORSHIP AMID BEAUTIES OF NATURE

San Bernardino, Cal.—A capacious and probably unique, natural amphitheatre, distinctive in its setting 7,000 feet above sea level in the wooded heart of the San Bernardino mountains, on what is known as the "Rim of the World," was opened recently with a musical program novel in itself.

This huge out-door theatre can accommodate an audience of 50,000 persons or more. The seating arrangements include everything from the natural pine needles, collected to form a seat, to cushioned chairs. Instead of one stage there are many. They are composed of platforms of table-shaped rocks artistically placed by the hand of nature about the large amphitheatre. On one, hundreds of feet above the audience, a violinist standing in the shafts of colored lights blended with

the moon-beams through the branches of great trees on the mountain side above him, rendered music from the masters of long ago. From another, across a ravine on a precipitous mountain side, a string quartet played softly while choruses sang from half hidden caverns.

Vari-colored lights playing about the amphitheatre created a fantastic effect.

NEGROES TO HOLD ANNUAL CONFERENCE AT DENVER

Denver, Colo.—Denver will be the center of attraction for Negro people of the United States during the last week of June, when the 16th annual conference of the National Association for the Advancement of Colored People will be held. The conference, which will open with a mass meeting on the night of June 24, will continue through until the night of June 30.

Racial questions from every angle will be discussed by the conference, whose sessions will be held in Denver's municipal auditorium.

Among the speakers will be William E. Sweet, former governor of Colorado; Clarence Darrow, Chicago lawyer; Ben B. Lindsey, judge of

Denver's juvenile court, and Representative L. C. Dyer of Missouri, who led a fight in congress for the passage of a federal anti-lynching bill.

The issue of residential segregation of Negroes, which the association now is carrying to the United States Supreme Court, will be discussed by Dr. George W. Lucas, president of the New Orleans branch of the organization.

A feature of the conference will be the presentation of the Spingarn Medal, awarded annually to the American Negro for the most distinguished achievement in some honorable line of endeavor. Roland Hayes, famous negro tenor, was awarded the medal last year.
