SELF RESPECT A PRE REQUISITE FOR NEWSPAPER MEN

Essary Declares That Newspaper Men Who Expect to Be Respected Must First Be Self Respecting

Asheville, July 8.—The National Capital is the great germinator of gossip and of scandalous whisperings regarding great and the near great, declared Johnson Fred Essary, president of the Gridiron Club, and Washington's correspondent of the Baltimore Sun, in an address before the final session of the 28th annual convention of the Southern Newspaper Publishers Association, here this morning.

Mr. Essary's address and another by Russell E. Edwards, of Washington, D. C., director of the Education Section, American Tree Association, were the chief ones of the closing program. The final business of the session included the adoption of special committee reports on auditing, resolutions and memorials.

Mr. Edwards address was on the subject "Forestry and its relation to news paper and other industries." Both talks were heard with much interest by the publishers.

Asheville, July 8.—"Newspaper men who expect to be respected must first be self-respecting," declared J. Fred Essary, of The Baltimore Sun Bureau at Washington, in speaking before the Southern Newspaper Publishers Association, in session here.

"It is not enough that we should know a great deal of the mechanics of life, we must acquire a sense of dignity as journalists, a dignity which you and I know is often lacking in the columns of our papers," he added. "No story is so uninteresting as the story of how a reporter failed to get the story."

Mr. Essary then told of the hardships and trials of a Washington correspondent, telling of the many foolish queries that are received by them. He cited as an example one received by a correspondent which read: "We have information that there is something in the air. Get it and send us 1,000 words."

Straight news is not the only product that proceeds from Washington, he declared, for despite the fact that the capital of the greatest news center in the world, many false and unfounded stories regarding the presidents and other high officials are originated there. He told several stories that he had heard of various presidents, which were utterly ridiculous and untrue. One of them was of the Woodrow Wilson lavishing gifts and entertainments on a chorus girl, when the actual facts were that the president attended the show, which was a stock company, and at the end of the season sent some flowers to the actress telling her how he enjoyed her acting.

Washington aside from being the government center, is now the nerve center of American business and the endless stream of "copy" that comes from there furnishes proof of its news distributing and originating value. The Southern newspapers have come to appreciate this fact, he stated as evidenced in the number of correspondents now being kept in Washington by them. Fifteen years ago there were not half a dozen Southern newspapers who had their own correspondents in Washington. Now every large newspaper in the South maintains a bureau there.

PRINTERS VOTE ON INCREASED TAX FOR MAINTENANCE OF HOME

Indianapolis.—The yearly income of the Union Printers Home in Coldwater Springs, will be increased about \$85,000 as the result of a favorable vote by members of the International Typographical Union on the question of a ten cent increase in the monthly per capita tax for maintenance of the home. The union members gave the proposal a majority of almost 15,000.

The additional money will be used to complete and equip in addition to the home and for maintenance. Helpless patients, who have not previously been eligible for admission, will be cared for under the enlargement plan.

BARONESS MEETS INSTANT DEATH BY FALL FROM WINDOW

Baroness Helen Zur Muehlen Formerly Miss Helen Curruthers Falls From Seventh Story Ritz-Carlton Hotel

New York, July 8.—Baroness Helen Zur Muehlen, of Daba Dutch East Indies, was killed today by a fall from a seven story window of the Ritz-Carlton Hotel.

She struck on the roof of the hotel's Japanese Garden, which is on a level with the second floor. James M. Thompson, at one time a close friend of Miss Millicent Rogers now Countess Von Salm Hoodstrates, was visiting the Baroness, with other friends. He said she stepped to an open window for fresh air and fell.

The Baroness, who was about 28, was Helen Curruthers, of New York, before her marriage to the Baron. The Baron is at present in Java, where he expected to be joined by his wife. According to the hotel management, Baroness Zur Muehlen had gone to her apartment after dancing until late, being accompanied to the suite on the seventh floor by a number of friends. Complaining of the heat she went to the open window and to the horror of her friends tumbled over the sill. Police, after an investigation, said it was believed she had fainted. The young woman was elaborately gowned and jeweled. Her diamond earrings were dashed from their settings in the fall, and were recovered from the roof by detectives.

SECOND DAY OF HEAT WAVE TAKES TOLL NINE DEATHS

Violent Thunderstorms B'ing Only Temporary Relief; Dozens of Prostrations

New York, July 8.—The second day of the heat waves which swept down the east from the middle west has caused at least nine deaths directly and indirectly, and dozens of prostrations.

Violent thunder storms in most sections yesterday brought only temporary relief. Score of buildings were struck by lightning.

In New York City a temperature of ninety degrees with high humidity killed one man and prostrated nine other persons. Three boys were drowned, a white boy giving his life in a futile effort to rescue negroes in the Harlem River. One died in Hoboken, N. J., and two were overcome.

Jack Dempsey and Bride to Sails for Home on Homeric

Paris, July 8.—Jack Dempsey and his bride left this morning for Cherbourg where they will sail for home on the liner Homeric.

GERMAN BILL WOULD BAR BABY ACTORS APPEARING ON SCREEN

Berlin.—Children under three years of age will not be permitted to appear in moving picture films if a bill introduced in the Reichstag becomes a law.

The bill points out that the nervous and physical strain of facing the bright lights of movie studios is injurious to infants. The bill further provides that children between three and 12 years may not appear in films except by permit of police and school authorities.

Yale Lecturer at Berlin. Berlin.—Professor E. M. Borchard, of Yale, recently opened a lecture course at the Berlin University. He said in his opinion his chief task consisted of re-establishing international scientific relations and preparing the way for the resumption of German-American exchange of professorships such as existed before the war.

TWO MEN KILLED BY LIGHTNING WHILE WALKING MONDAY

One Identified as Thomas C. Burnes; Were Walking Along Highway at Locust When Killed

Albermarle, July 8.—Two bodies were held here today in an undertaking establishment for more complete identification.

One was the body of Thomas Carl Burnes, of Battery C, Fifth Field Artillery of Camp Bragg. The other was still unidentified, although it was thought to have been also a soldier. The men, strangers in this section, were walking along the highway at Locust, Monday evening, when they were struck and instantly killed by lightning.

Standing on the porch of her home, a woman, the only eye witness to the tragedy, stated she saw the bolt strike the men and knock them to the ground. For an instant, she said, fire seemed to play about the bodies of the men, burning their clothing.

One of the men was identified by papers in his pocket as Burnes. The authorities of the Company were immediately notified and replied to a telegram by ordering that the body be prepared for burial.

Among the papers carried by Burnes were two honorable discharges from the United States Army, and a reinstatement certificate dated April 15, 1925.

A letter from his sister, Mrs. Robt. L. Walker, of Charleston, West Virginia, was on his person.

Richmond Light Infantry Blues To Visit Richmond

New Haven, July 8.—The first and second companies of the Government Put Guards will accompany the Richmond Light Infantry Blues, of Richmond, Va., on the latter's trip to Europe in May 1926, at the invitation of Marshal Foch to visit the battle fields of France and Belgium.

BUSINESS MEN CAN STOP RUM FLOW, SAYS SPEAKER

Portland, Ore.—If business men would boycott bootleggers the eighth amendment would soon be enforceable, said Stanley E. Vandersall of Boston, in an address today at the thirtieth International Christian Endeavor convention.

"Many business men who expect their employes to respect the laws of this country are purchasers of bootleg liquors, and all intoxicating liquor by reason of the prohibition laws are in that class," said Mr. Vandersall. "Without the buying power of the men with money who scoff at the prohibition laws back of them, the bootleggers could not exist. 'Boycott bootleggers' would be a good slogan for the business men to adopt and put into practice."

A. DAVIS, ACTOR SHOT BY HIS WIFE

In Hospital in Critical Condition; Declares "It Was All Over Another Woman"

New York, July 8.—Allan Davis, an actor, in "The White Cargo" was in a critical condition in a hospital today, having been shot by his wife, Edith Parker, who was considered one of the most beautiful chorus girls in Earl Carroll's "Vanities," but who recently in stages parlance has been at "Liberty."

There had been no inkling along the rivalry of domestic troubles. In fact they were regarded as ideal lovers. "It was all over another woman" said Mr. Davis, after being questioned by detectives. She said that she had intended to end it all, and a dent in an unfired cartridge apparently bore out her statement and she tried to kill herself. She was held at a police station on charges of felonious assault. "I never want to see her again," said Davis to detectives in asking that she be denied admission to the hospital. One bullet entered a shoulder and another his head.

The shooting occurred last night at an apartment on 49th street where Davis was dining with two men friends.

Infant Daughter of Mr. and Mrs. Corley Died Last Night

Zeddie Mae Corley, infant daughter of Mr. and Mrs. Robert Coley, died last night from pneumonia. Funeral services will be conducted from the home this afternoon at 2:30 o'clock by Rev. W. S. Harden, interment taking place in Cherry Hill Cemetery.

The little girl was only three months old and had endeared herself to every one who knew her.

Mr. and Mrs. Coley have the sympathy of the people of this city in their sorrow.

Noted British Auctioneer Dead

Addlestone, Eng.—Henry Stevens one of Britain's oldest practising auctioneers and a curio king died recently at the age of 82.

Among the many curios which came under his hammer were President Kruger's hat and the waistcoat of King Charles II.

Stevens during his life time had sold every conceivable thing, including the late Lord Derby's great menagerie of more than 1,600 animals and birds; the death mask of Napoleon; a piece of Queen Victoria's wedding cake; the spear that killed General Gordon, and one of Dick Turpin's pistols, and 24 out of the known 75 auk's eggs in the world.

Hindenburg's Son His Adjutant

Berlin.—Major Oscar Hindenburg, who, until his father's election as president of the German Republic, was stationed with the Hannover Cavalry School, has been transferred to the Defense Ministry. He has been posted as the president's personal adjutant.

FORD DENIES ANY PART IN ATTACK ON JEWS IN PAPER

In Affidavit Denies Personal Responsibility for Newspaper Article

New York, July 8.—A denial of personal responsibility of an attack on Jews in his paper is made by Henry Ford in an affidavit which he has unsuccessfully sought to file in connection with libel suits against him and the Dearborn Independent, by Herman Bernstein, editor of the Jewish Tribune, who seeks \$200,000.

Federal Judge Knox yesterday refused to accept the affidavit or to vacate an attachment which ties up \$65,000,000 of Ford's money in deposit in New York banks.

"The merits of this case rather than its technicalities must hereafter engage the attention of the case," added the Judge.

In the affidavit Ford averred: "I did not write the article in question or inspire it; had no participation in the writing of it; did not direct its writing; it was not shown to me before it was printed; I did not wish to cast aspersions upon the article or know it was to be printed; and I had nothing whatever to do with its printing, publication, and circulation."

Judge Knox seeing that he did not wish to cast aspersions upon the affidavit noted that it was the statement of an ex-parte-litigant.

Third of Genna Brothers Falls in Feud Beer Runners

Chicago, July 8.—Gangsters guns blazed in Chicago streets again this morning seriously wounding Tommy Genna, third of the Genna brothers to fall in six weeks in the feuds of beer runners.

GERMAN REPUBLICANS CONTINUE TO HONOR MEMORY OF EBERT

Heidelberg, Germany.—The esteem in which large sections of the German people hold the late first president, Friedrich Ebert, finds eloquent expression in the numerous pilgrimages to his tomb by republican organizations of various kinds. There are always fresh flowers on the grave furnished by individuals or societies honoring his memory, and especially on Sundays there is a constant stream of visitors. Many workers singing societies pay tribute to their late leader by singing a dirge at his tomb.

Jap Printer's Task Lightened

Tokyo.—The Osaka Asahi and the Osaka Manichi have agreed to limit the Chinese characters in use to 2,490 instead of the 6,000 odd formerly drawn upon by the compositors. Exceptions are to be made in the cases of imperial edicts, laws and proper names.

COOLIDGE KEEPING IN MIND MEN WITH SMALL INCOMES

To the President the Prosperity of Both Rich and Poor Are Intertwined

Swampscott, Mass., July 8.—As he watches from long range preparations of government officials for another slash in taxes, President Coolidge is keeping in mind the men with a family and a small income as well as business generally. To him the prosperity of both are intertwined. The President believes that a drastic cut in sur taxes not only would result in increased government revenue to a consequent stimulation of business, but would benefit the small tax payers by insuring him steady employment.

Mr. Coolidge holds to the views that holders of large incomes are concerned more with avoiding high taxes by protection to investment in tax exempt securities, than in attempting to increase their fortunes through regular business enterprises. On the other hand he believes that the far seeing man with a family having an income of \$5,000 or under would not favor a sharp cut in his own taxes if it might injure the business on which he is dependent for employment. He would prefer, the President states, to have less relief as far as his own taxes go and have a plan worked out that would insure him a steady job with opportunity of increasing his income. While Mr. Coolidge appeared to be giving the tax problems more thought than any confronting the administration, he is leaving preparations of a reduction plan to Treasury Officials and the responsibility of the Congressional committee.

BARUCH GIVES AT LEAST \$25,000 TO THE PAGE SCHOOL

First Task of School Will Be to Diagnose the Disease That Would Destroy World Peace

New York, July 8.—For study of the possibility of maintaining world peace by taking the profit out of war, Bernard M. Baruch has given at least \$250,000 to the Walter Hines Page School of international relations at Johns Hopkins University. The exact amount of the gift will depend upon the cost of studies over a period of at least three years. It may reach \$300,000.

Mr. Baruch's idea for the fund was based on his experience on the War Industries Board.

In a similar emergency he wrote in his report as Chairman of the Board. There ought to be not alone a mobilization of non power, but of things and dollars. The first task of the Page School is to diagnose the diseases that destroy World Peace.

Regards Indictment As An Attempt to Intimidate Campbell

Great Falls, Montana, July 8.—The recent indictment of Gordon Campbell, discoverer of the Kevin-Sunburst Oil Fields, at Spokane, on a charge that he fraudulently used the mails in promoting an oil syndicate, was characterized here last night by United States Senator Burton K. Wheeler, as an attempted on the part of the Department of Justice to intimidate Campbell so that he would be willing to testify against the Senator as the Department desires.

Water Scarce in Gold Town

Tonopah, Nev.—Water is selling for five cents a gallon in the little boom mining town of Gilbert on the desert near here. The principal barber shop of Gilbert has a fully equipped bath tub but there is a sign that "Customers must furnish their own water."

WORK RESUMED ON NEW CAMPUS BLD'G. TEACHERS COLLEGE

Will Contain Two Bible Study Halls and Two Literary Society Halls

Work has recently been resumed on the Campus building at East Carolina Teachers College. This new building will be the home of student activities. It will contain two Bible study halls, and two literary society halls. Each society hall will be equipped with a kitchenette so that the halls may be used for society purposes.

On the main floor of this building will be located an auditorium seating 1700 people. It will be equipped with folding chairs that can be removed to make room for any function or purpose for which it may be needed. The plans for this building provide also a gymnasium, but the section which is to contain the gymnasium will not be built at the present time.

This building was begun last year, but was not completed on account of insufficient funds. Something like one hundred thousand dollars was spent at that time for materials and labor. All pilings and concrete for the foundation were put down and much material to be used in construction was placed on the ground.

The contract for completing the building was recently let to the J. E. Beaman Construction Company at \$184,338.35. The contract for heating was let to Bermott Heating Company at \$4082.06. The plumbing was let to W. O. Mitcham at \$4000.00. The plans for this building were prepared by the H. A. Underwood Company, Architects and engineers.

This contract covers only a part of the building as it will appear when completed. Another section of this building will be built later containing a complete gymnasium with swimming pool and other modern equipment. At present the college has only an improvised gymnasium. The building of this section of the Campus building has been postponed for lack of funds.

EVENTS PLANNED BY CUPID POSTPONED BY MOSQUITOES

New Orleans.—Mosquitoes, which have descended in larger swarms than usual this summer on New Orleans and other places along the Gulf coast, have been blamed for bad dispositions and almost everything else. But the latest charge against them comes from Tangipahoa parish where the pests are accused of causing the postponement of five weddings in one week. The weddings were to have been outdoor affairs in keeping with the season.

A dry winter which caused the deaths of thousands of small fishes and other forms of animal life that prey upon mosquito larvae, followed by unusual rains this spring are the causes given locally for the unusual plague of mosquitoes. Local health officials say that in the main they are harmless, at least insofar as germ carrying goes.

Druggists that sell various ill smelling oils have reaped a harvest this summer and smudges of burning rags, rubber and Spanish moss are common sights in front and back yards and even on sidewalks here. Good screens keep most of the pests out, provided screen doors are closed quickly when one enters or leaves a building.

CUBAN GOVERNMENT TTO ESTABLISH DOZEN NEW CONSULATES IN U. S.

Havana.—The growing importance of commercial relations between Cuba and the United States is reflected in the proposed establishment of 12 new consulates in the United States. The foreign relations committee of the senate and house of the Cuban congress are preparing a consular and diplomatic bill to provide expansion of both services.

Cities in the United States already named as points for new consular offices are: Birmingham, Ala.; Indianapolis, Ind.; Wichita, Kan.; Buffalo, N. Y.; Portland, Ore.; Providence, R. I.; Beaumont, Fort Worth, Houston and San Antonio, Tex.; Seattle, Wash., and Milwaukee, Wis.

PROGRESS OF HUMAN KINDNESS

Excerpts from the report of a North Carolina Grand Jury on the subject of corporal punishment for prisoners:

It is our unanimous opinion that a deplorable condition existed in the Rocky Mount camp, with no extenuating circumstances, no redeeming features, no jurisdiction, right or reason for such brutal, inhuman physical treatment as had been accorded prisoners in this camp or stockade.

We recommend the total abolishment of any form of corporal punishment in the camps of Nash County, or to such prisoners as are in the jurisdiction of the Rocky Mount Road Commission, or used for any purpose whatsoever.

Excerpts from the Sunday sermon of the Rev. Charles Hillman Fountain, a Christian minister, on the same subject:

Modernism looks upon sin as a disease rather than a guilt. This influence is seen in pampering the criminal classes, sending offenders to nice prisons to be well fed and entertained. If the whipping-post could be established it would have a beneficial effect in securing the safety of society.

Now, one cannot help wondering which of these men, the North Carolina Grand Jurors or the Christian minister, the Carpenter of Nazareth would consider as most fit to enter the Kingdom of Heaven.—N. Y. World.

Government Weekly Weather and Crop Review

Washington, D. C., July 8.—Week generally warm but rainfall continued low local character. Many localities were still too dry and general rains badly needed in Texas and Oklahoma. In Texas showers were mostly ineffective and cotton continued to deteriorate over most of central and southern parts of state with plants small and prematurely developed. Drouth has become severe in Oklahoma but cotton is not yet seriously damaged. Progress during week was fair on bottom lands but poor on uplands with general condition still fair to good. Except locally growth was very good in Ark and La. Showers beneficial in Mississippi and Alabama and where moisture was sufficient in these states cotton made fair to very good advance but some sections were too dry and in these growth was slow. In southern half of Georgia crop continued to make very good progress but elsewhere it was less favorable with plants small and some blooming prematurely.
