

## RALEIGH GIRL IS AHEAD JEFFERSON MEMORIAL DRIVE

### Drive for Funds to Purchase Monticello Creating Considerable Interest in State

Next announcement of standing of candidates, Sunday June 6th.

Candidates are credited with ten votes for every dollar collected by them or their campaign committees. All money obtained in the election will go toward freeing Monticello of debt and endowing it as a National Memorial. For each unit of 50,000 votes in the grand total, one delegate will be sent on the American Birthday Tour of Europe with all expenses paid. Winners will be announced June 20th.

Miss Sarah Brooks, candidate of the Raleigh Rotary Club, again takes the lead in the number of votes to the credit of the sixteen candidates, who in the North Carolina election are combining their efforts to raise a state fund to be used in the payment of the debt on Monticello, and to select a number of North Carolina young women to be included in the national delegation touring seven European countries this summer, as guests of the Jefferson Memorial Foundation.

Miss Brooks, resuming her old place in the standing of the candidates in the election, with the highest deposit of votes for the day, 1525, displaced Miss Lena R. Redmond, of Rocky Mount, who as the last candidate entered in the election had made a spectacular rise to the top of the list as announced last Sunday.

The largest deposit of votes from the Charlotte group of candidates yesterday was credited to Mrs. Susie Love Norman, who turned in 410. Gastonia, Mrs. Norman's former home town, has promised in the remaining two weeks of the election, to line up in her support.

Raleigh leads by more than 2,000 votes in the total number of votes given to her four candidates in the election. Second in line comes Charlotte, with a total of 12,355 votes credited to her five candidates. Rocky Mount with 7,764 votes for their candidate, Miss Lena R. Redmond, is given third place in participating cities raising the fund. Salisbury is placed fourth, having polled 6,887 votes for her two candidates.

It is expected that with the next announcement of the standing of the candidates, Sunday, June 6th, that North Carolina will have elected her first candidate, for the state fund will have been added to considerably by the proceeds from the Jefferson Memorial Benefit Bridge tournament and dance to be given Friday evening, June 4th, by the Sir Walter Hotel in compliance to the four Raleigh candidates.

With the election of one candidate assured the sixteen candidates will combine their efforts toward the raising of another \$5,000 (50,000 votes) for the purchase of Monticello, for it is with each unit of 50,000 votes raised for the state fund that a candidate is declared elected to take the six weeks educational

## URGES EX-SERVICE MEN TO TAKE UP GOV'T INSURANCE

### Head of Metropolitan Company Says Failure Shows Extreme Lack of Judgment

New York, June 3.—That every individual entitled to revive or convert his Government war risk insurance, who has not done so to date, should revive or convert this insurance before July 1 is the conviction of Harry J. Miller, second vice-president of the Metropolitan Life Insurance Company.

Pursuant to this conviction he has issued a circular letter to the more than twenty thousand agents and managers of the Metropolitan Life, asking them to use their utmost endeavors with former service men, with whom they come in contact, to see that they revive or convert the insurance they are entitled to carry or are carrying.

"Any person who can possibly afford to pay his premium for revival or conversion of his Government war risk insurance and fails to do so, shows an extreme lack of judgment," said Mr. Miller.

"Every insurance man worthy of the name, is desirous of keeping these Government policies in force. The premium rates are reasonable and the United States Government is the security back of the insurance.

"I have not seen recent figures on the number who have converted or revived their policies but I understand that less than thirty thousand had taken advantage of their opportunity on May first. With the millions of men in service, practically all of whom were entitled to this insurance, it seems that the majority should be interested in taking advantage of their right.

"The Government has set July first as the dead line when this insurance can be revived or converted so it behooves those former service men, who have not done so, to act promptly.

## None But Democrats Can Vote Saturday

The following letter has been mailed to the Registrars and Judges of Election in the several precincts in Pitt County:

Greenville, N. C. June 3, 1926.

My dear sir:

"You are addressed as an official to hold a primary election.

"The following is quoted from Section 9027, Consolidated Statutes, and must govern you in holding the primary election:

"No person shall be entitled to participate or vote in the primary election of any political party unless he is a legal voter, or shall become legally entitled to vote at the next general election, and has first declared and had recorded on the registration book that he affiliates with the political party in whose primary he proposes to vote and is in good faith a member thereof, meaning that he intends to affiliate with the political party in whose primary he proposes to vote and is in good faith a member thereof."

"The foregoing law must govern you in holding this primary. And the Democratic Party, only, has candidates in the primary. No other party has registered a candidate. Therefore no person can participate or vote in the approaching primary election who has not first declared and had recorded on the registration book that he is affiliating with the Democratic Party, meaning that he intends to affiliate in good faith with that party as a member thereof. You are the judges of party affiliation, when there is any doubt as to it. If you must pass on the question a majority of your number must agree on the answer. It is as much your duty to enforce this part of the law as any other part of it.

## CARROLL DRAWS YEAR AND DAY ON PERJURY CHARGE

### Broadway Theatrical Producer Must Serve Sentence and Pay Fine for Bath Tub Party

New York, June 3.—(AP)—Earl Carroll, Broadway theatrical producer, convicted of perjury in connection with a grand jury investigation of a party in his theatre at which an unclad chorus girl served drinks while seated in a bath tub, was sentenced today to serve a year and a day on each of two counts and to pay a fine of \$1,000 on each.

Carroll was originally indicted on six counts, two referred to his testimony that there had been no liquor served at the party, two to his statement that no one occupied the bath tub and two to his assertion that he had no list of guests at the party.

The guest lists were dropped on recommendation of prosecution. The producer is charged with guilt of the liquor indictment but not of the unclad chorus girl bath tub. The court ordered the jail sentences on the two counts to run concurrently so that Carroll will have to serve a year and a day and pay a fine of \$2,000.

## SWEDEN'S STATE LABOR INSURANCE HAS FAILED

Stockholm, June 3.—(AP)—Sweden's state organization for labor insurance has failed. Parliament has decided that the venture is too expensive and the business will be liquidated.

When compulsory insurance of employees was introduced here twenty-two years ago, a special department, acting as a government insurance company was formed. Much pressure was exercised upon employers in favor of the national insurance body. Private companies persisted in competition and were able to undersell premiums to such an extent that the bulk of the business went to the private companies.

## URGES STANDARD FOOTING FOR ALL WEIGHT EVENTS

Madison, Wis., June 3.—Standardization of footing for competition in the eight events in collegiate track circles is deemed necessary by Tom E. Jones, veteran track coach of the University of Wisconsin, to eliminate "unfair competition."

Mr. Jones, who is the president of the newly formed Western Coaches association, will ask the assistance of the National Collegiate Athletic Association for corrective measures.

## SUIT AGAINST TOBACCO CO-OPS NEARING CLOSE

### The Association Must Have Receiver or Make Monthly Reports to the Court

Raleigh, June 3.—(AP)—When Colonel E. P. Buford, of Lawrenceville, closes the argument for the plaintiffs in the Tri-State Tobacco Growers Co-Operative Marketing Association receivership suit in Federal Court here this afternoon, Judge I. M. Meekins will probably appoint a receiver for the organization or sign an order requiring the organization to make monthly reports to him. He indicated last night at the close of court that he had these alternatives in his mind and it was quite evident that he leaned toward the latter course. In that case he would go a step further, he said, and appoint Colonel Buford as an attorney for the court to be associated with the association counsel in the suit to recover re-dry profits made by former association officials.

The defendants agreed to the proposed decree, although making it clear that they believed no evidence justifying a receivership had been introduced. Plaintiffs, while not specifically objecting to Judge Meekins' suggestion, indicated they still believed a receiver should be appointed and Colonel Buford was to attempt to convince the court of this in his argument this afternoon.

## Western Tennis and Golf Entrants To Indianapolis

Indianapolis, June 3.—(AP)—Two athletic classics, the Western tennis championships and the Western open golf tournament, will be held at Indianapolis this summer.

The tennis tournament will open June 21 at Woodstock Country club, and the golf tournament will be played over the Highland Golf and Country club on August 25-27 and 28.

The tennis singles' entry list will be made two days later. William T. Tilden, who holds the Western title, will defend it here.

## Inventor's Show Brings Out Many New Devices

Seattle, June 3.—(AP)—A windshield for dirigibles, three-wheeled roller skates and an "unsinkable" boat are some of the things which inventors wish to display at the National Inventor's Exposition here June 17 to 19.

Any new human contrivance is eligible for this exhibit, which is sponsored by the National Association of Inventors.

The dirigible, windshield is a funnel shaped metal arrangement to be attached to the dirigible mooring mast to protect against the wind. The new roller skate has a center wheel which is larger than the one in front or back and on which the skater may make quick turns. The unsinkable boat is described as one which "couldn't be filled with water fast enough to sink it."

Electrical saws to relieve carpenters of much of their work and formulas for building stone and stone pipe are among the exhibits to be entered.

## AMERICAN SCOUTS BID FOR ENGLISH GRID PID STARS

London, June 3.—Scouts of American football clubs have become active here, and there are several reports of migrations of English and Scottish professionals to America after the season closes in England.

It is stated that wages ranging from fourteen to twenty pounds a week are being offered coveted players by American clubs, but it is mainly among the Scottish players where the Americans most readily find recruits. Wages for English players last season was about six pounds a week.

Both English and Scottish strongly oppose migration of the players, who have year-round engagements. They consider summer play detrimental to the winter form of the men.

### BENJAMIN'S HISTORIC HOME IN SOUTH TO BE PRESERVED

Bradenton, Fla., June 3.—(AP)—The historic mansion where Judah Philip Benjamin, secretary of the Confederacy, took refuge during the Civil War, is to be preserved as a memorial by the Daughters of the Confederacy.

Benjamin, when General Robert E. Lee surrendered, hid in a secret chamber in the rear of a large fireplace. It was directly from his home that Benjamin finally fled to England, to escape the hardships of reconstruction days.

### STONE LANTERN JAPANESE GOOD WILL TOKEN OF U. OF M.

Columbia, Mo., June 3.—(AP)—A large stone lantern has been presented to the University of Missouri school of journalism by the Japanese government as a token of friendship and good will.

The lantern, nearly seven feet in height and of historic design and interest, was obtained through the efforts of Prince Tokugawa, president of the American-Japan Society of Tokyo from an old estate near Zempku-ji, where Townsend Harris, the first American envoy to Japan, established his legation sixty-seven years ago.

The gift, in a large measure, is complimentary to the high service rendered in the Orient by graduates of the school of journalism here.

### LEPER CURING FLORA IN BRAZIL MORE EFFECTIVE

Rio De Janeiro, June 3.—(AP)—Numerous genera of leper curing flora exist in Brazil, including one species which is thought to be more efficacious than the famous chaulmoogra tree of Hawaii, announced the National Agricultural Society.

The Brazilian tree which is thought to contain a superior grade of the magic ethyl ester is popularly known in Portuguese as "sapucainha." In various parts of Brazil the seed is called "leper fruit" and "leper bread," indicating that the natives believe it cures the disease. The tree grows wild in several states.

### RIVIERA VILLAGE IS SWAMPED WITH DEAD JELLY FISHES

Nice, June 3.—(AP)—All is not roses and sweet-scented scenery in the neighborhood of the French Riviera.

The little fishing village of Cros-de-Cagnes, just outside of Nice, will soon be uninhabitable unless some means is found of destroying the millions of jelly fish which have appeared in the bay. Huge piles of dead fish are nightly thrown up on the beach and the authorities recently were unable to clean them away before they commenced to rot. Attempts to burn the fish had been unsuccessful.

### JUNKED MOTOR CARS STOP "WASHING" OF RIVER BANK

Pierre, S. D., June 3.—(AP)—Junked motor cars are being put to a new use here—that of helping to "tame" the Missouri river.

The "Big Muddy" has a coy habit of tearing away large bits of South Dakota farmland abutting the stream, during the spring rises, and carrying them downstream sometimes in twenty-acre chunks. The piling of logs, brush and debris along the bank has not availed to stop the channel's depredations.

But it has been discovered that the frames of junked cars piled one upon another wherever the channel is cutting away the bank, settle so firmly and are so impervious to the channel stream that they stop the cutting away of the bank. Several scores of abandoned automobiles are serving more effectively than expensive piling.

### GULF OF CALIFORNIA FISH BE TAKEN FOR INDUSTRY

Gnaymas, Sonora, Mexico, June 3.—(AP)—A virgin fishing ground so far as commercialized fishing is concerned—the Gulf of California—is to yield its wealth to American and Mexican financiers who have organized the Southern Commercial Company.

The waters of the gulf long have been known as a paradise for sportsmen with rod and reel. They contain oysters, lobsters, crabs, turtles, sea lions, three kinds of sardines, Spanish and American mackerel, albacore, bonito, yellow tail, sea bass, halibut, silver sea trout, flounder, and many other varieties.

The cannery will be located on the Sonora coast north of here.

### WARNS AGAINST EXTENDED SUN TREATMENT TO CHILD

London, June 2.—(AP)—Sir Henry Guvain has issued a warning against the abuse of sunlight treatment, and has advised parents to have the advice of physicians before they submit their children to extended sunlight treatments.

In the opinion of this distinguished doctor there is a tendency to overdo the use of sunlight in the treatment of weak children, and he says it may even be fatal if an ailing child is exposed to the sun for a long period.

### HON. S. J. EVERETT MADE FINE RECORD IN SENATE

Senator S. J. Everett who has served two terms in the upper house of the North Carolina State Legislature, made a fine record while attending the two sessions, which honor he accepted at a personal sacrifice to himself financially, and now that he has consented to be a candidate for the third term at the request of many of his friends, it is the opinion of this paper that the county would lose valuable legislation should Mr. Everett not be elected for the third term.

### Washington's Boat Crew This Year Is One of Giants

Seattle, June 3.—(AP)—The University of Washington, Pacific Coast intercollegiate champion for the fifth consecutive season, approaches the national academic regatta on the Hudson this year with a crew of giants.

The varsity crew that defeated the University of California as the climax to a clean sweep on Lake Washington this spring consists of the tallest men, says their coach, Russell S. Callow, who ever propelled a college boat.

This eight averages six feet and three inches in height, 170 pounds in weight. Three of the men are six feet and five inches tall, and the shortest oarsman in the boat, Captain Al Ulbricksen, stroke, is six feet one. Even the coxswain, Art Wuthenow, is five feet eleven inches tall, though he weighs only 120 pounds.

The Huskies, who last year at the Poughkeepsie won the intercollegiate junior varsity title while the varsity lost the championship to the Naval Academy after capturing it two seasons in succession, have a junior varsity shell averaging six feet one inch in height. These "Jayvee" oarsmen outweigh the varsity by an average of one pound, averaging 177. The junior varsity coxswain, Francis Blothen, tips the scales at 116. He is five feet ten inches tall.

Washington's triple California quest was completed by a freshman crew averaging six feet one inch in height and 180 pounds in weight, running four pounds heavier than the varsity boat.

All the Husky strokes who appeared against the Golden Bears are married.

### Mail Pilots in Rockies Set Best Time in Winter

Cheyenne, Wyo., June 3.—(AP)—Air mail pilots who daily skirt over the Rocky Mountains have ideas of good flying weather. They prefer to ride ahead of a strong wind, such as sweep through Wyoming during the winter, to the fair, warm weather of summer time.

The mail birdman is not unlike his fellow worker on the ground. He wants to finish his job as quickly as possible and a strong wind at his back, although it may produce bumps and rough flying, speeds him to his destination.

The best flying times of the Rocky Mountain division of the transcontinental air mail route have been made in the winter, air mail officials report. In crossing the Continental Divide from Cheyenne to Rock Springs, a distance of 258 miles, a record time of one hour and thirty minutes was hung up in December 1925. During fair weather this spring the average flying time has been two hours and a half, with the best time only ten to fifteen minutes less.

### Forced Wearing of Hat Affects Moslem Prayers

Constantinople, June 3.—(AP)—The law on compulsory wearing of the hat in Turkey is conflicting with the traditional Moslem prayers.

Religious usage has required that the heads of those who enter a mosque should remain covered. The visorless fezz did not interfere with the genuflections which demand the repeated touching of forehead to the floor, but with the hat, this ritual is well nigh impossible.

Consequently, worshippers are using the expedient of taking off their hats when they enter a mosque, and of immediately tying on their heads large handkerchiefs or night caps. The Director of Religion and the Moslem religion does not demand that the head be covered during prayer, however, and that this is merely a tradition which should be stamped out.

### Pate-de-Foie Gras Popular in France

Strasbourg, France, June 3.—(AP)—Pate-de-foie-gras, the gourmet's delight, is almost as commonplace in its home-town as ham and eggs in America. This delicate dish is one of the things that has made Strasbourg cooking famous, and the good Strasbourgeois eat it at meals, after meals and between meals.

Pate-de-foie-gras, washed down with a draught of the famous Alsatian beer, is a favorite tea-time dish. Innumerable old women go from cafe to cafe peddling the delicacy, slices of which are cut from a big "pate" carried in a basket. It is sold like peanuts and chocolate in America.

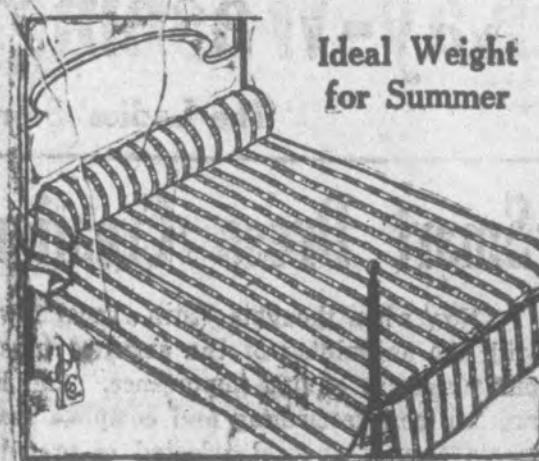

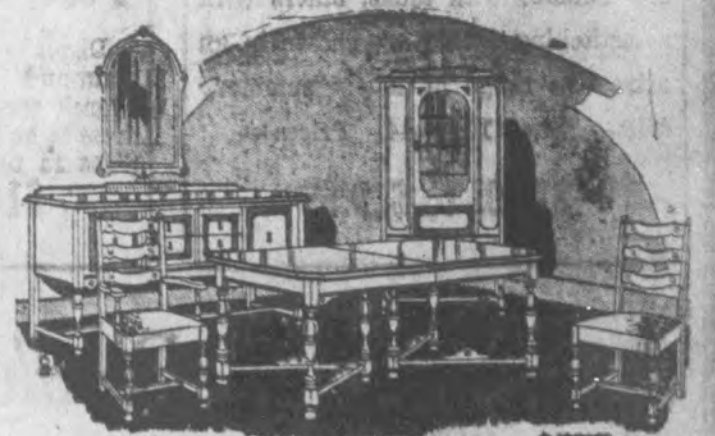

# Daily News Letter

London, June 3.—(INS)—A novel contest has taken place here, when seven university bowmen, using arrows and straw balls, met and defeated a team of picked golfers from Roxton.

It is about 500 years since the Scottish king commanded that "golf be utterly cried down" in order that their people might practice archery, so golfers need not be too despondent at the result.

But although it is true that the authenticated record of golf drive is 445 yards, while the record flight of an arrow is 310 yards, yet in this case it was shown that, in the ordinary way, archers can shoot further than golfers can hit, and the bowmen won by 41-2 points to 21-2.

It was a strange sight. The players were accompanied by caddies, but the latter looked more like Cupids than anything else, solemnly carrying bows, arrows and clubs.

At each green the archer aimed at a straw ball, and a correct hit

corresponded with the hoing of the ball by a golfer. From the tee the archers drove their arrows as did the golfers their balls, and similar penalties as obtain in the ordinary round of golf rewarded a badly directed arrow.

Sinner or Dupper That is London's latest problem.

It arises from the want of a name for a new meal. Social London now dines later and later, 9:30 and 10 being the present accepted hours. So what is a hostess to say when she invites a guest? "And is the guest to get his dinner before he arrives, or should he await the point of famishment?"

Several influences have helped to introduce this new unnamed meal. Visitors to the Riviera where they dance late rise late play games late, still insist on an evening meal at a late hour. And so, London hotels are now serving a meal at 10 p. m.—by which time the dancing has started—half dinner and half supper.

The 11 p. m. supper is also becoming a little longer than it used to be. The reason for this is that few Londoners now dine before going to the theatre. Sandwiches and cocktails are now the accepted pre-play menu.

But what is the name to be given to this 10 p. m. meal in the ordinary house or hotel? Hostesses and hoteliers are both eager to know.

There may be hidden treasure

in the back garden of one of the workmen's houses now being built on the site of Henry VIII's palace at Oatlands, Meyrick, in Surrey. History maintains that the jewels belonging to Henry's Anne of Cleves are buried there.

Oatlands Palace was Henry's favorite Leicestershire home, and the jewels were hidden there, it is said, by the cook Anne, though hers was a short stay—just long enough to have her jewels stolen, so the story goes, by a servant who, when pursued, buried the treasure on the estate. The ghost of Catherine Howard, Henry's fifth wife, is supposed to haunt the place.

It was the home of successive queens until it was dismantled by Cromwell as "a den of royal infamy." Its stones were employed in the building of locks and bridges in Surrey.

Every day discoveries are made on the estate. The builders have excavated a quaint old Tudor cellar and a great brick drain running to the Thames, which local gossip has given a grizzly history.

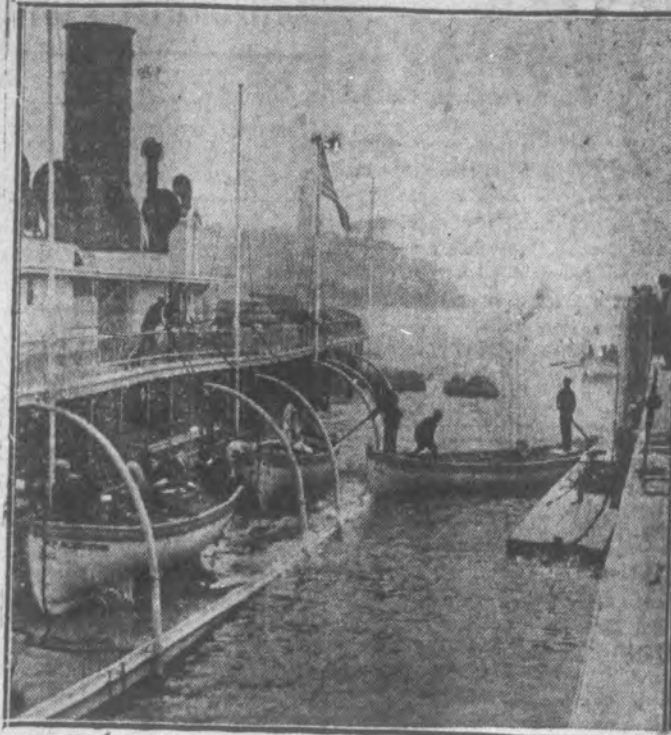
event.

### Alaskan Railroad Boon to Increase Tourist Travel

Anchorage, Alaska, June 3.—(AP)—The Alaskan railroad was constructed to develop the assets of Uncle Sam's northern possession but it also has brought satisfaction to the road's officials from another source—tourists.

The route of the railway from Seward, on the Pacific Ocean, to Fairbanks in the interior, passes through one of the most beautiful sections of the Northland. Each year has brought an increasing number of visitors, who start the trip with a six-day ocean voyage from Seattle on vessels which maintain weekly sailings throughout the year.

The entire trip with the exception of forty hours on the Gulf of Alaska is made through what is known as the Inside Passage, a land-locked route which is described as being as smooth as a mill pond.

At Seward the trains connect with the boats, and thence they go northward along Turnagain Arm, a branch of Cook Inlet, and through mountains which were once declared impassable. North of Anchorage the Matanuska Susitna and Tanana valley farming districts are traversed. Halfway between Anchorage and Fairbanks is Mt. McKinley National Park, where several thousand acres of virgin wilderness have been preserved.

Most Striking Facial Feature Cartoon's Aim

Des Moines, Iowa, June 3.—(AP)—Spying in a cartoon two rows of shining teeth and a square jaw, the American newspaper reader learned to recognize Theodore Roosevelt.

Harding was identified by his heavy, almost shaggy eyebrows. Coolidge's symbol is the long New England nose and the austere mouth, turned down at the corners.

All of these characteristics have been imprinted so firmly in the American mind by cartoonists that the public now recognizes its public figures as quickly from cartoons as from actual photographs, says J. N. Darling, veteran cartoonist.

"All public men who are caricatured a great deal," believes Darling, "are better known by their conventional caricature than by their own birthright of facial characteristics. In the evolution of a caricature the cartoonist begins with a fairly accurate portrait, but finally he eliminates all except the predominating characteristics and the result is a sort of conventional formula with little of the portrait remaining. By the same process the letters of T. R. stood for years as a complete nomenclature of Theodore Roosevelt.

A comparative newcomer to the gallery of cartooned characters is the reformer or the prohibition advocate, Darling, always a strong friend of prohibition, recalls that when the subject first injected itself into the

To Make Another Drive for Horses Roaming Forests

Bozeman, Mont., June 3.—(AP)—Last year the forest service initiated the plan of rounding up and disposing of all wild horses within the confines of the national forests and plans to continue the drive this year.

In 1925 there were 300 head captured in the Gallatin national forest alone and it is estimated that there are 500 of these useless animals still within this forest range. Throughout the national forests of the state there are thousands more.

Some of these animals were at one time domesticated. They were turned out to forage for themselves and those of the least value were not rounded up. In time many of them became wild and the ones that survived the winters and predatory animals bred with other bands and thus herds were formed.

The advent of machinery has caused such a depreciation in values that many horse owners do not make claim. In this case, the forest service advertises for sale and the animals are sold to the highest bidder.

Embrace Christianity Urges Jap Editor

Osaka, June 3.—(AP)—If Japan expects to absorb the benefits of Western civilization, "it will be necessary for her to welcome Christianity with open arms and harmonize the religion of the West with the national characteristics of the Eastern empire," in the opinion of the Osaka Mainichi.

This newspaper's editorial on the subject, which attracted considerable attention, said it is "indeed a great mistake to think that Western culture grew up quite independent of its religion, just as it is absurd to think that Eastern culture is independent of its religious thought or feeling."

"Strange to say, the majority of Japanese seem to think that we can very well absorb Western culture without paying any heed to its religion—Christianity. It is our humble opinion that in order to fulfill the heaven-sent mission, if such it be, of world peace, the Oriental and Occidental civilizations in general, it is almost incumbent upon us Japanese to welcome Christianity with open arms, so as to be able to make that religion our own, just as we did Buddhism and Confucianism in the past."

"To welcome Christianity means not necessarily to make this country a so-called Christendom, but it means that the nation as a whole should become conversant in Christian doctrine and sentiment in a similar degree as Western peoples who confess that religion."

"Japan should have her own Christianity perfectly harmonized with her national characteristics, and so well assimilated as to make it her own religion, side by side with her inherited spiritual cults, such as Buddhism, Confucianism and Shintoism."
