



# GEHRIG AND RUTH EVEN FOR HOMERS

(By the Associated Press) Concluding an 18 game road trip that earned them 13 victories, the New York Yankees were on the road home today for a two weeks stand in their own stadium against western invaders. Babe Ruth wanted to square matters with Lou Gehrig in their home run marathon before reaching New York, so he knocked one out of Connissey yesterday. The wallop enabled the Yankees to beat the Chicago White Sox 3-2.

The Philadelphia Athletics furnished the surprise jolt of the use in Cleveland losing a double play to the Indians 9-6 and 5-2. Connie Mack's outfit fished in turning in five errors for the afternoon.

The winning streak of the Detroit Tigers that had reached five games was ended by tall end Boston Red Sox who batted Gibson for an 8-7 decision. The Tigers overcame a four run lead acquired by Boston in the second inning and had the tying run on third in the ninth.

Washington pounded Alvin Crowder, a former teammate, forced him to leave the box and defeated St. Louis 14-6. Ernie Wingard, succeeding Crowder, fared little better and gave way to Van Olden who was belted for five hits in three innings. The Senators lambled out 15 hits while Zachary, formerly of the Browns, was scattering the hits he doled out to Dan Howie of the club.

The give and take battle between Chicago and Pittsburgh for first place in the National League showed no change today. The Cubs split a doubleheader with Brooklyn, losing the first in ten innings 3-2, and winning the second 7-1. The Pirates followed suit and merely reversed the order against the Giants. Pittsburgh won the first game 11-6 and the Giants the second 9-3. Carmen Hill was credited with his 15th pitching victory of the season in the opener. A seven run bombardment by the Giants in the sixth won the windup contest.

The Cincinnati Reds continuing their way toward the top rung of the second division, flattened out the world champion Cardinals 9-4. Grover Cleveland Alexander was batted out in the seventh and two St. Louis pitchers who followed him were treated similarly.

## THREE YOUNG PITCHERS BAFFLE BATSMEN



New York.—(AP) Two pitchers found in the bush leagues and one plucked from an obscure mid-western college have appeared this year to quell the batsmen of the big leagues and confound the critics by keeping well up in the races three teams that were given but an outside chance.

Seeking the slight of hand which sent Chicago's two representatives and the Washington club to places surprisingly high in their leagues, the fan will find it in the pitching arm of Charley Root, "rob" hurler of the Cubs, Ted Lyons of the White Sox, products of Baylor University, Texas and Horace Lisenbee, one of our leading Senators at 23.

While Lyons and Root gave signs of "arriving" in world beating form after four better-than-average years in the majors, Lisenbee struck his stride at once in his first year in the big time, fanning American leaguers as energetically as he did the boys of the Southern Association a season before.

## Dempsey Tunney Fight Will Be Held In Chicago

Chicago, July 25.—(AP)—Arrangements for the heavyweight championship match between Gene Tunney and Jack Dempsey in Soldier Field stadium here probably will be concluded this week. Tex Rickard arrived Thursday for a conference with Chicago officials.

Mayor Thompson, the State Athletic Commission and George F. Getz, minister head of the Mayor's activity committee will meet with the New York promoter and lay plans for handling a crowd of approximately 150,000 and gate receipts of more than \$2,000,000.

Since boxing was legalized in Illinois, fourteen months ago the lowest gate has been about \$800,000 although championship matches have been held in each of the major league baseball parks but none in the stadium.

Edward J. Kelly, president of the South Park Box which built and controls the huge horseshoe in Grant Park, returned from the Dempsey-Sharkey fight, with renewed hope that the Dempsey-Tunney match would be landed by Chicago. He said he would welcome it. Rodeos, track meets, many exhibitions and all sorts of spectacles have been staged in the stadium, which seated comfortably 100,000 persons at the Army-Navy football game last fall.

The big floor, approximately 80 yards wide and 15 yards long will be filled with seats for around \$50 park officials estimated.

# CHAS. BERGER FACES TRIPTO THE GALLOWS

## Gangster of Illinois Hopes to Avoid Noose by Appeal to Supreme Court.

Benton, Ill., July 25.—(AP)—His colorful but checkered career as a deadly machine gunner and leader of the most formidable band of Southern Illinois gangsters at an end, Charles Berger, bragging law-defier and conspirator, today looked to the State Supreme Court to save him from the hangman's noose.

The once jaunty gangster who has declared that "no law is strong enough to hold me" now has an opportunity to reconsider his defiant declarations, following his conviction yesterday by a jury in circuit court here for the murder of Mayor Jos Adams of West City last December. He no longer is the daring swagart two-eye man that he was during the reign of gang warfare in the coal belt.

The strain of 15 days of trial which has confronted him and long days of confinement in jail here shows plainly on his countenance and he appears pale and haggard.

Berger places his only hope to "save the gallows on an appeal to the supreme court, in case Judge H. Miller overrules a proposed motion for a new trial. His attorneys announced they would seek a new trial and it is likely that the motion will be filed in a day or two.

Meanwhile Berger's two former henchmen, Art Newman and Ray Hyland, also convicted with the gang chieftain and sentenced to life in the penitentiary are being held in the county jail with Berger, awaiting Judge Miller's decision on a date for their incarceration at the State prison at Chester.

Their counsel has indicated they may file a motion for a new trial although it generally is reported they are satisfied with the verdict.

While awaiting the next turn of events in the case, counsel for Berger and Hyland made the announcement that the two gangsters had confessed to them their guilt to the crime and admitted that the State's case was identical with the story of the happenings from the time Berger is alleged to have planned the killing of the mayor, though the actual slaying itself the attorneys said they told the two gangsters before the trial that unless they "came through" with the true story of the killing they would not represent them.

State's Attorney Roy Martin, declared the conviction of Berger, Newman and Hyland would bring an end to machine gun and gang warfare which has terrorized the coal belt region of Illinois for the past three years.

"We have a radio, running water, electric lights, every convenience we had at my father's home in Wichita."

## Nothing In Religion To Prevent Crime

Charlotte, July 25.—(AP)—There is nothing in the average "religion" to prevent crime," said Rev. W. B. McIlwaine in his sermon Sunday morning at Westminster Presbyterian Church. "for the average religion" is negative rather than positive. It is founded on "thou shalt not's." The average man who feels the need of something better in his life sets out to reform, cuts out some of his bad habits, decides that other habits can be retained and adds the habit of occasional church attendance and contributions—and then considers himself "religious." What he needs is not so-called "religion," but Christianity; not reformation but regeneration. Reformation is from one's self; regeneration is from God.

Taking as his text, "Be ye therefore perfect, even as your father which is in heaven is perfect," Mr. McIlwaine gave an interpretation of the Christian life as "plus, not minus."

"Too frequently a church member tries to live a Christian life under the impending rocks of Sinai instead of on the "delectable mountains" of God's love. He makes Christianity seem like something forbidding and gloomy, hedged-in by little negative rules and the world is offended by this false emphasis. He makes his "religion" something that takes much and gives little but the promise that somewhere in the dim, uncertain future, he may be saved from the gangs of a possible hell. There is no power in such a religion.

The religion of "morality" and "reformation," compared to Christianity is like a beautiful statue of cold, unresponsive marble compared to a living friend.

## Two Hurlled To Death In Plane Near Chicago

Chicago, July 25.—(AP)—Seizure of a dual control on an airplane by a youth taking his first ride in the skies may have caused the accident that hurled two men to their death near here last evening and seriously injured a third.

The victims, Ray Westphall, 21 of Chicago and Irwin Hybel, 22 of Dundee, Ill., were killed instantly while the pilot of the crashing plane, Carl Hawkins, 24, was burned and injured internally.

Roy A. Hearn, a pilot who witnessed the crash on a field conducted by North Shore Aviation Club at Morton Grove, a suburb, laid the accident to the fact that there was an auxiliary control stick in the forward seat occupied by the passengers.

"Everything points to the fact that one of the men seized the stick and pulled it," he said. "The effect was to shoot the nose of the plane straight up. Naturally it wouldn't go up at the low starting speed. Instead, the wings elevated it fell down."

Looking at it from this standpoint, the project sounds like a good business proposition, but when the fact that a new bridge means indefinite delay in extending needed highways in this county, we can't say fact that a new bridge project. If the present bridge is safe for travel, it is our opinion that the interests of the people of the county and section would be best served by completing the highways out of the

funds now available and let the bridge wait until such a time as it is found to be a necessity.

Increase Shown In Bankruptcy

Raleigh, July 25.—(AP)—More petitions in bankruptcy were filed in courts comprising the Eastern North Carolina federal court district last fiscal year than in any single fiscal year since 1923. S. A. Ashe, Jr., deputy clerk of local United States Court, reported today.

Clerk Ashe's report, which contained the number of cases filed in Wilmington, Fayetteville, Washington, New Bern, Wilson, Elizabeth City and Raleigh District Courts shows that 228 petitions in bankruptcy were filed during the fiscal year ending June 30, last.

Three hundred cases, including petitions dismissed and compositions confirmed, were concluded during the year. Of this number 57 were of the involuntary type, or cases in which creditors forced the debtor into bankruptcy.

The total liabilities of the 307 bankrupts were \$9,274,999.37, of which amount \$7,799,181.56 represented liabilities of the 244 voluntary bankrupts. Amount realized through the settlement of the cases totaled \$1,443,143.35.

At the beginning of the last fiscal year there were 227 cases pending. The nature of the business of the 300 bankrupts whose cases were concluded during the year follow: Farmer, 46; wage earner, 10; merchant 177; manufacturer, 12; professional 9, and other classes 46.

In 1923 there were 211 cases filed 127 concluded; liabilities of \$5,601,983; amount realized \$704,971. In 1924, 199 cases concluded 213 liabilities, \$6,747,089; amount realized \$839,603.

In 1925 cases filed 196; cases concluded 224; liabilities \$10,531,711 amount realized \$1,477,879. In 1926 cases filed 201; concluded 207; liabilities \$6,112,573; amount realized \$1,233,059.

Approximately one hundred and fifty cases were docketed for the term.

Washington, July 25.—(AP)—After battling flames on his airplane to protect the records of an unofficial world's record altitude flight today estimated at 48,000 feet, Lieut. C. C. Champion, naval flier today received the stunning news from the bureau of standards that on preliminary reading his battered barographs would only show 39,000 feet.

Other flogging cases under scrutiny are those of Eston Murchison of Bessemer, Ala., who was taken from an automobile and whipped because he was riding with two "strange girls," and Hugh McSwain and Pearl Boggs, who were flogged on a road near Birmingham several weeks ago.

Experience In Spotting Liquor Stills May Aid Redfern



By W. H. BEATTY (Associated Press Staff Writer)

Brunswick, Ga.—When Paul R. Redfern, 25-year-old aviator, soars over the swamps and jungles of the Amazon on his proposed non-stop flight, he will probably feel as much at ease as though he were going through his regular flying routine for the government.

For Redfern's flights during the last six months have been over such stretches of land and water as he expects to cross on his long air voyage from Brunswick, Ga., to Rio de Janeiro, a distance of 300 miles.

The "pioneer" air scout of the national prohibition unit, southeastern division, Redfern's assignments during the last six months have been to rout out the moonshine stills in the swamp lands of South Carolina, Georgia and Florida. Moonshiners, seeking something new in the way of concealment, conceived the idea of building heavy rafts in the marsh grass and heavily wooded swamp area along the coast, where they successfully operated stills for several months.

It was impossible for government boats to reach the swamps and the parties could not find the still because of the head-high marsh grass. Then the prohibition officials imported Redfern and his plane from Geneva, N. Y., where he was operating an airport.

Flying at a dangerously low altitude over the swamps, Redfern spotted the stills, one by one, signaled to a convenient patrol boat and small rowboats were sent into the swamps to capture the moonshiners, while Redfern circled overhead, directing the hunters to their objective.

In the first 10 days of flying Redfern located and led in the capture of 49 stills, each of them valued at several thousand dollars.

"We usually got our man," Redfern says. "The moonshiners couldn't get out of sight of the plane no matter how hard they tried, and after a few hours of hide-and-seek in the chilly swamp waters they were caught by patrol boat operators."

The flight, which will start August 1, will take him two days and two nights, he estimates, and will be over some of the uninhabited jungle regions of the Amazon River. He will fly a Stinson monoplane to be called the "Port of Brunswick."

1927 CORN CROP SMALLEST SINCE 1902

Washington.—(AP)—The 1927 corn crop, estimated at 2,274,000,000 bushels, will be the lowest produced in the United States in 26 years.

"This year's crop" government officials say, "is unusually late. Much of it still is under cultivation, whereas under normal conditions it should have been laid by. Corn responds to warm weather, and this season has been cool and wet. Records of the past 36 years indicate that the amount of rainfall is the dominant factor governing corn yield."

The nation produced 2,845,000,000 bushels last year.

TWO DEAD AND TWO INJURED IN AUTO ACCIDENTS SUNDAY

Danville, Va., July 25.—(AP)—Two persons are dead and two others are in a critical condition as the result of automobile accidents near here yesterday afternoon. Hugh Fitzgerald was instantly killed and his small son, Hugh, Jr., probably fatally injured when a car driven by Mrs. Nonie Fitzgerald struck a sand bar near Chatham, and turned over three times. Mrs. Fitzgerald was uninjured.

Robert Gregory was crushed to death and R. H. Estes perhaps fatally injured when their automobile turned over on the Mount Cross road a few miles from the city.

\$50,000 FIRE VISITS MEMPHIS, TENNESSEE

Memphis, July 25.—(AP)—A fire captain was seriously injured and several other firemen narrowly escaped injury when the wall of a warehouse of the Maury-Cole Company, manufacturers of Canova food products was destroyed by fire last night. Damage was estimated at \$50,000.

Fire Captain C. A. Smith, directing his men near one of the walls of the building was caught when the wall toppled, but was promptly extricated by the men who had dodged just in time. The extent of Captain Smith's injuries were undetermined early today.

Several weeks ago the commission handed down an order allowing the Southern Railway Company to move its present freight depot in Asheville to a point known as Baltimore Bottoms, two miles from the present location.

Asheville city officials, together with various other respondents, protested and filed exceptions to the order. Last week the commission overruled the exceptions.

Notice of appeal by the respondents was filed by A. Hall Johnson and George Pennell, Asheville attorneys.

Sacco-Vanzetti Near End Of 7-Year Fight For Life



Bartolomeo Vanzetti (left) and Nicola Sacco. Inset—Judge Webster Thayer. Lower—Gov. Alvan T. Fuller. Boston—(AP)—The end of seven years of waiting in the shadow of the electric chair is in sight for Nicola Sacco and Bartolomeo Vanzetti.

The result of the latest and possibly the last fight to save the lives of the internationally known pair, who claim they were convicted of murder because they were radicals, is expected soon.

The long struggle in the Massachusetts courts ended last April when Judge Webster Thayer sentenced the men to die during the week of July 10. They had been convicted of murdering a paymaster and his guard during a robbery in 1920.

Then the eyes of the world turned to Governor Alvan T. Fuller of Massachusetts when Vanzetti, in a long written plea asked him not for a "pardon," but for "justice."

Accompanying the plea were five affidavits by persons who affirmed that Judge Thayer, during the trial, had spoken outside the court room in language that showed he was prejudiced against the defendants.

The governor assumed the task of reviewing the evidence, and also questioned the jurors who brought in the verdict of guilty. He worked with an advisory board consisting of president A. Lawrence Lowell of Harvard University, President Samuel W. Station of the Massachusetts Institution of Technology and Judge Robert Grant.

When it became evident that the work of reviewing the evidence would not be accomplished before the week in which Sacco and Vanzetti were sentenced to die, Governor Fuller granted a respite until the week of August 10. In the and made measurements at the scene where Frederick A. Parmenter, the paymaster and his guard Alessandro Berardelli, were shot to death.

No other criminal case in the history of Massachusetts ever attracted such world-wide attention as that of Sacco and Vanzetti. For steadfastly protested their innocence, basing their battle for liberty on the contention that they did not have a fair trial. They declared that they were tried while "Red" hysteria was at its height and were condemned because of their admitted radicalism, and because they had been draft evaders during the war.

The life of a third man doomed to death has been prolonged by the lengthy court proceedings and the appeal to the governor during the past 18 months. He is Celestino Madeiros, convicted of murdering a bank cashier at Wrentham, Mass., during an attempted holdup. Madeiros, while in jail, made a statement tending to exonerate Sacco and Vanzetti of the crime and accusing the "Morelli gang of Providence, R. I." of the murders. Madeiros asserted that he was associated with the gang.

His statement made one of the grounds of the defense in its appeal for a new trial. The possibility that he might act as a witness resulted in several respites being granted him. He is now under sentence to die during the same week as Sacco and Vanzetti.

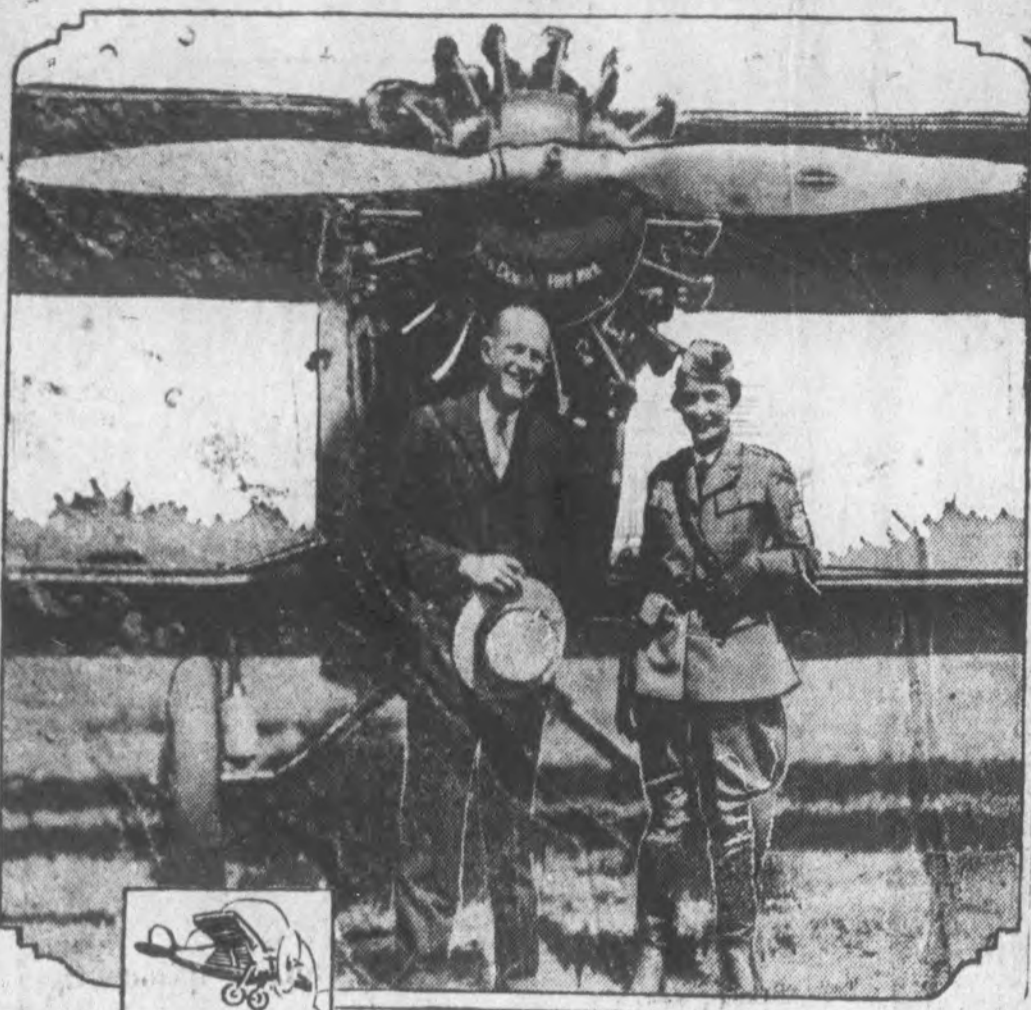
