## MAKES REPORT OF ACTIVITIES OF VETERANS

### Chief of Staff Tells 460 Confederates of Year's Happenings.

Raleigh, Aug. 3.—(AP)—Colonel J. J. Gormley, Charlotte, Adjutant General and Chief of Staff of the North Carolina Division, United Confederate Veterans, today reported to his 460 white haired, grayed, ribboned comrades in reunion here a divisional membership of 1,150.

The annual reports showed 759 veterans active and 391 inactive with the loss by the inexorable hand of time of 128, stricken by death, during the year. The preceding year 210 had died.

The report covered the period from August 1, 1926, to yesterday.

"It is with pleasure that I report the revival of W. J. Hoke camp at Lincolnton, with Capt. J. M. Shilohhart commander, also organizations of Alliance camp at Burlington, with Capt. R. J. Thompson, commander, and A. A. Hill camp at Lexington, with Capt. T. W. Tige, commander; the last named are new members of the division, and have been assigned to the first brigade, he reported.

"While we realize that our ranks are growing thinner each year, it is gratifying to report that the number of deaths reported for the year is so less than the former year."

Adjutant General Gormley asked the prompt payment of the 36 cents annual dues and "in conclusion, I desire to express the appreciation of the members of the division, and thanks for the action taken at its last session of the legislature in providing a reasonable pension to the boys and to the wives of our comrades who have answered the last roll call."

Adj. Gen. Gormley's report was the only one made today. The resolution committee met to receive individual resolutions and to make its report at tomorrow's closing session.

Written on the Aquitana on the way to Paris by way of Cherbourg, leaving New York just after midnight yesterday morning.

No matter how often you cross on big ships like this or on little ones, you are reminded that the long trip called death and an ocean voyage are not alike.

You take your "last dinner" in New York, friends are more or less sorry to see you go. That's the death.

On board ship you sail through space for some thousands of miles, with only water all around you. That's the trip from here to the next world.

In due time you land in that next world, to find it different from this and very interesting.

If you go to Paris, this writer is going there, you reach what many Americans consider a fairly good imitation of heaven.

The safety in crossing our little ocean, the certainty of landing on the other side, should make us worry less about the big crossing over the ocean of ether.

Once we knew as little about an Atlantic crossing as we know now about the "final trip" that each must take when his turn comes.

When Columbus started they told him he would fall over the edge of the ocean.

When the Phoenicians, ancestors of many energetic Jewish citizens, first sailed from the Mediterranean, through the straits of Gibraltar, past the gigantic rock and into the Atlantic ocean, they thought that was the end of them.

Now crossing the ocean is like going from New York to Chicago. You hear from your friends on both sides of the ocean. Business messages come from the United States side, other messages from the European side, where 250 miles from shore.

Science has conquered this little ocean. Intelligence has made it tame. (Continued on Page Six)

## ARRANGE DATE FOR OPENING PITT SCHOOLS

### Nineteen Long Term Schools to Open 1927-1928 Session September 19th.

Nineteen long term schools coming under supervision of the Pitt County Department of Education will open for the 1927-28 session September 19th, according to information made public this morning by the Department of Education.

This decision was reached at the regular monthly session of the County Board of Education held in this city Monday morning. Several other matters were taken up by the educators, but arrangement of dates for the opening of the schools was the most outstanding thing considered.

Twenty-four short term schools will open on the 17th of October. Colored schools will open on November 7th. There are twenty-four negro schools in the county.

## Bank Conditions Indicate Prosperous Months Ahead

Raleigh, Aug. 3.—(AP)—Total resources of North Carolina's 466 state banks and branches at the close of business July 30, 1927, amounted to \$308,040,861.84, compared with \$309,567,398.95 on June 30, 1926, a decrease of \$1,526,537.11, J. H. Mitchell, chief state bank examiner, reported today.

During the same period, resources of national banks decreased \$4,775,000.

The principal items of increase and decrease in resources was an increase in Liberty and North Carolina bonds of \$2,536,000 and a decrease in loans and discounts of \$8,058,000.

During the same period the capital stock, surplus and undivided profits and reserve accounts increased \$5,400,000 while borrowed money decreased \$8,928,000.

"While the resources of North Carolina banks are usually at their lowest point on the June 30th call, the combined statement this year reflects the strongest condition which has been presented in many years," Mr. Mitchell said. "It indicated crop yield and prices materialize, the coming fall and winter months will usher in one of the most prosperous periods in the State's history."

## GA. TOBACCO AVERAGES 20¢

### Reports Today Indicate That Prices Are Considered Satisfactory.

Waycross, Ga., Aug. 3.—(AP)—Reports received here today from markets throughout the south Georgia bright leaf tobacco belt indicated that the second day's sale will hold up well. Farmers in the immediate Waycross section are still busy in curing operations. Sales for the first few days are expected to be comparatively light. Satisfactory prices are offered.

Tifton, Ga., Aug. 3.—(AP)—Opening sales in the Tifton tobacco market totalled 339,682 pounds which brought the growers \$64,819.83 or an average of \$19.08 per hundred pounds.

This compares with last season's opening sale of 278,910 pounds sold for \$69,145.29 or an average of \$24.79 per hundred weight.

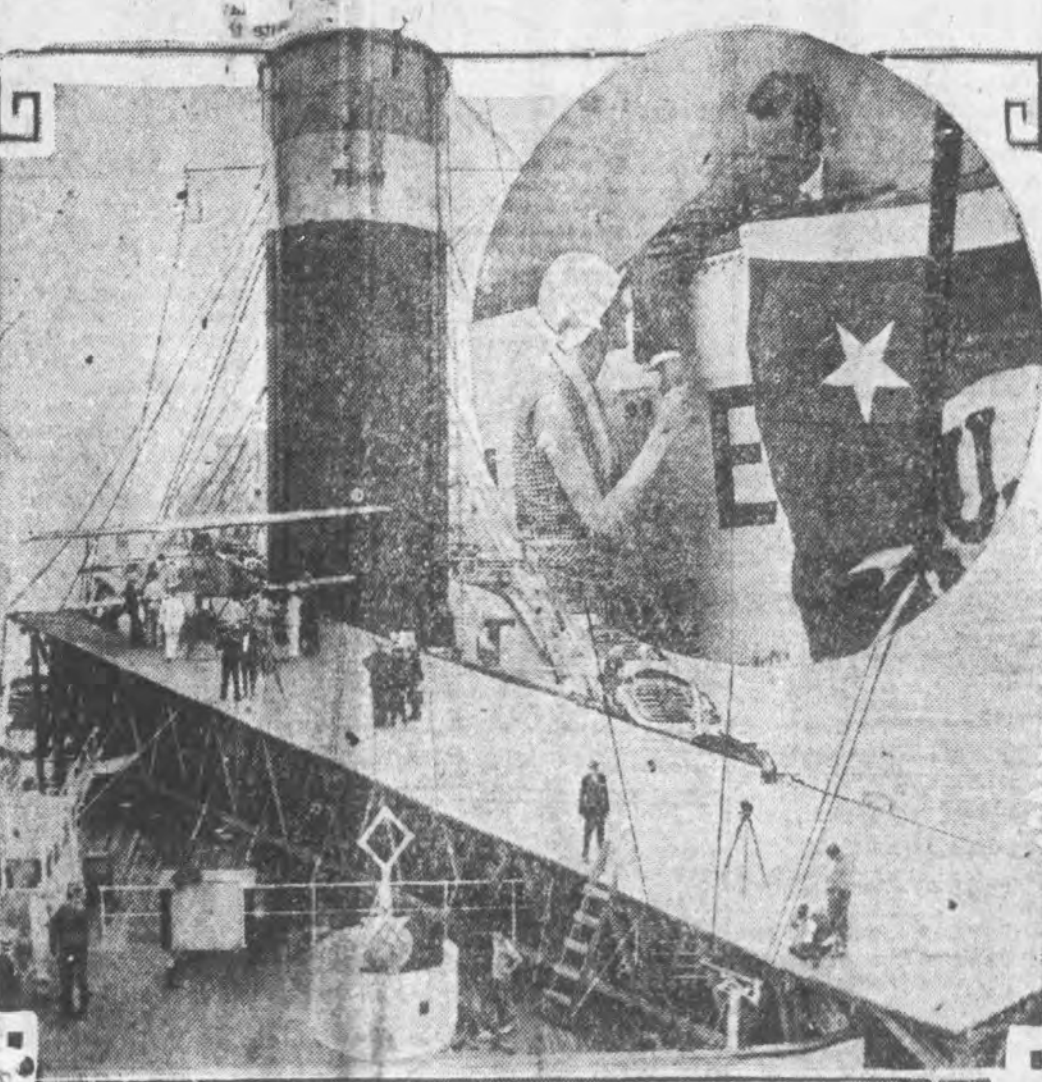
Today's offerings were about one third of yesterday's and prices continued satisfactory.

Black-Sher, Ga., Aug. 3.—(AP)—Tobacco sales at the opening of the market here yesterday totalled 458,780 pounds with the price averaging 20.25 cents.

Valdosta, Ga., Aug. 3.—(AP)—The sales on the local tobacco market today were light at noon approximating only 35,000 pound at the average of 18 cents.

Camilla, Ga., Aug. 3.—(AP)—Fifteen thousand pounds of tobacco were sold on this market today at an average of 15 cents per pound, indicating a total of \$2,225. Indications are for heavier sales after the close of this week, giving the farmers time to prepare and grade their product.

## HANDWRITING EXPERTS GET WILKES CASE

### To Views Paper in Connection With Alleged Financial Shortages of County.

Winston-Salem, Aug. 3.—(AP)—Handwriting experts of the investment brokerage firms of Curtis and Sanger and of the National City Bank of New York, will compare notes with the signatures of Claude C. Faw, chairman of the Board of Education of Wilkes county, and C. C. Wright, secretary, and A. Brewer, chairman of the board of commissioners of Wilkes, and J. C. Wallace, secretary, they are to view the Wilkes papers, says a press dispatch from North Wilkesboro to a local paper.

Attorney Mark Squires, of Lenoir, has obtained the signatures of the county and school board officials, had them duly certified and with certified stamps of the seals of both boards will take them to New York for the purpose of helping the bankers who invested in what they thought to be gilt-edged securities to trace down alleged forgeries. Each official wrote his name twice on the blank sheet of paper used for that purpose. In the presence of the solicitor impressions in wax were taken of the seals of the two boards. Photostatic copies of some of the \$150,000 notes outstanding have been received in Wilkesboro, but the bankers were not satisfied with the opinion of untrained laymen as to the authenticity and regularity of names signed to them.

Robert H. McNeill, Washington lawyer, and son of deputy federal court clerk Milton McNeill, went to New York last week at the behest of solicitor Jones and arrived in Wilkesboro with what is termed valuable data and correspondence from the big financial concerns who hold what are alleged to be the spurious notes of the Wilkes county school board and of a board of county commissioners. It is learned that New York bankers will lend every assistance in their power to the North Carolina prosecutor who is seeking to get at the facts in regard to the notes.

## NEGRO DESPERADO SHOT TO DEATH AT CHARLOTTE TODAY

Charlotte, N. C., Aug. 3.—In what was described as a fight for liberty, Paul Gaddy, alleged negro desperado, was shot to death by Ed Correll, police detective here early today.

Detective Don Blake who was with Correll just before the shooting declared that Gaddy was shot after he had cut the detective's clothing and grazed his skin with a long bladed knife during a struggle to escape.

## FRENCH AIRMAN BEGINS ACTION AGAINST LEVINE

Paris, Aug. 3.—(AP)—Maurice Drouhin, French aviator, today began action against Charles A. Levine, seeking to compel him to fulfill the terms of their tentative contract signed early in July, when Drouhin was chosen to pilot Levine's monoplane Columbia, in a return Atlantic flight from Paris to New York.

## DIE IS CAST FOR PACIFIC AIRSHIP RACE

### Fourteen Official and Four Unofficial Entries for Dole \$35,000 Prize

San Francisco, Aug. 3.—(AP)—The die was cast today for the first trans-Pacific airplane race in history with fourteen official and four unofficial entries for the James D. Dole \$35,000 prize for the first and second aviators to fly from the North American continent to Honolulu starting after noon, August 12.

The official list of entries was left incomplete when the hour for its closing—midnight last night—arrived. The committee in charge of the arrangements announced that all entries postmarked before that hour would be accepted when received.

A wide assortment of aviators, navigators and aviation enthusiasts "make up the list which will enter in the 2,400 mile dash across half of the Pacific ocean. Two women were among the official entries—Mrs. William P. Erwin, wife of the Dallas, Texas, entrant, and Miss Mildred Doran, Flint, Mich., school teacher, who will make the trip with John Pedlar, the Flint entrant. Several army and navy aviators will participate.

The San Francisco Bay region will be the starting point of nearly all the fliers. The sole exception, to date, is Major C. O. Osborne, Osborne's only entry, who has stated that he will take off from Vancouver, B. C. It is figured that those who start from either Mills Field, the San Francisco airport, or New Farm Island, Oakland's airport, will have more than an hour's "steep" miles advantage over any who start off from any other part of the mainland.

Mrs. Erwin is an experienced pilot and will alternate with her husband at the control stick of her plane. The Erwin family plans to make the Honolulu hop first in their flight to Hong Kong, in quest of the \$25,000 prize offered by William B. Easterwood of Dallas for a flight from Dallas to Hong Kong.

All entrants in the race have been instructed to be here by Monday, August 8. On that date they must appear before the rules committee to present their credentials and these will be granted after the planes are inspected by federal aircraft inspectors here. Each pilot must hold a federation aeronautics international certificate.

On August 8, the entrants will draw lots for starting positions, and entrants must be on the starting line in the order indicated by the drawing and must start within one minute after the signal is given by the official starter, or retire to the end of the line.

## FATE OF ITALIANS STILL IN BALANCE

Boston Aug. 3.—(AP)—Governor Alvan T. Fuller's meeting with his executive council, to determine the fate of Nicola Sacco and Bartolomeo Vanzetti, scheduled for today, has been postponed until noon tomorrow, it was announced this morning by William L. Reed, the Governors assistant secretary.

The two radicals, whose seven year battle for life presumably is drawing near an end, awoke today to their first morning in the death house cells to which they were transferred late last night.

## NEW MYSTERY CROPS OUT IN NEGRO KILLING

### Tom Bradshaw Believed Mortally Injured Before Being Shot at Bailey

Rocky Mount, Aug. 3.—(AP)—A new element of mystery confronted Nash county officials today as they continued investigation of the death of Tom Bradshaw, negro assailant of a young white girl, after an autopsy last night led to expression by Dr. G. Fletcher Reeves, county health officer, that the wounds which caused death must have been received five or six hours before he toppled into a clump of bushes in Tolson Swamp yesterday when members of a posse peeped him with gunshot.

The autopsy revealed that two loads of shot, which Dr. Reeves said must have been fired into the negro some time early Tuesday, perforated his liver, right lung and intestines and these, he said, together with shock and exhaustion, caused the death of the fugitive.

After receiving Dr. Reeves' report last night and considering the new time element injected into the shooting, Coroner C. C. Collins' jury adjourned until Friday night when it will meet in Nashville to resume the taking of testimony and to fix cause of the black's death. County officials in the meantime, continue a detailed investigation.

Had the negro been shot Monday morning, Dr. Reeves said, it would not have been possible for him to have run until yesterday, with his lungs in the condition he found them. His right lung was nearly useless, the intestines were perforated and it would have been impossible for him to have lasted through 40 hours of grilling pursuit, the doctor said. The conclusion reached by some authorities that the shot which caused his death was fired Tuesday.

Dr. Reeves was certain the two loads of birdshot which entered the negro's body at the time of his capture, except for the shock they caused, could not have caused death. The negro was in a state of absolute collapse, he said, and any serious shock would have been sufficient to cause his death.

Witnesses examined by the coroner, who were near the scene of the capture, declared the negro fell directly after two or three gunshots were fired. None of the witnesses knew from what direction the shots came, or by whom they were fired, they testified.

Nashville, Aug. 3.—(AP)—An autopsy over the body of Tom Bradshaw, negro, alleged attacker of a 12 year old white girl of Nash county Sunday, will be held here Friday.

The hearing of evidence last night was declared incomplete by Dr. G. Fletcher Reeves, county health officer, but the testimony given at the inquest was that the negro died of exhaustion and fatigue rather than from bird shot wounds inflicted by posse members yesterday.

As to who fired the shots the inquest was in the dark and no developments along that line was evidenced today. A more complete autopsy was promised for Friday night.

Bradshaw's body was brought to Bailey late yesterday without any handcuffs although the negro previously had broken away from his captors while handcuffed.

## Ku Klux Klan Identified in Flogging Case

Oconota, Ala., Aug. 3.—(AP)—The Ku Klux Klan was definitely identified with the flogging of Jeff Calloway today by John Hughes, who admitted on the witness stand that he was one of a number of Klansmen who took Calloway from a church service several weeks ago, bound him to a tree and whipped him into unconsciousness.

## STATEMENT BY MR. COOLIDGE DRAWS GOSSIP

### Effects of President's Announcement Yesterday Carefully Analyzed Today.

Washington, August 3.—(AP)—The effect and significance of President Coolidge's brief announcement of the nation's political future were being analyzed carefully who were gradually recovering from the unexpected news from Black Hills of South Dakota.

The unadorned ten word statement, "I do not choose to run for president in 1928," apparently was due to produce thousands of worlds of comment by political leaders and newspaper editors and had fanned to sudden heat the presidential campaign which seemingly had been lulled into tranquility during the summer months.

In general the political leaders shocked apparently by the bomb-shell-like character of the announcement of a clear sky, either remained silent or only expressed their guarded opinions.

In some cases political prognosticators, who interpreted the pronouncement as Mr. Coolidge's withdrawal turned to discussion of the other possibility for the Republican Presidential Nomination. But there was also a swing of opinion, including many of the President's closest friends which warned that the president must not yet be eliminated from consideration should the position be offered him. Among the possible candidates other than president Coolidge the names mentioned most frequently were those of Frank O. Lowden, Secretary Hoover, Vice President Daves, Senator Borah and Speaker Longworth.

Republican leaders viewed the president's announcement in many cases with regret, although the majority of them expressed no comment awaiting further elucidation of its portent.

Rapid City, S. D. August 3.—(AP)—A tremendous stack of telegrams was laid before president Coolidge today, attesting the widespread reaction and surprise with which the country has met his statement that he does not choose to run for another term.

The came from every where and were said to convey the expressions from political leaders and friends in virtually all of the states.

Mr. Coolidge had scarcely left his office yesterday after making his remarkable and unexpected statement before the wires into Rapid City started humming and soon the commercial lines were augmented by the President's personal wire from Washington.

Some of the messages which reached Rapid City were relayed immediately to the summer White House 32 miles up in the hills last night, but the bulk of them was left on his desk for his perusal today.

While the President withheld further comment, the summer capital was swept into a frenzy of speculation. Far from the centers of population where news is not readily accessible, members of the president's party contented themselves with discussing their own views of the unprecedented development and with looking forward to what bearing the statement might have on the remainder of the summer here.

There was in Rapid City a general consensus that yesterday's statement actually means that Mr. Coolidge intends to retire from the White House March 4, 1929 no matter what pressure may be brought to bear upon him, it was held that even so, little information could be expected as to his plans when he would relinquish office.

While there were some who professed to see in the announcement a determination to avoid the 1928 campaign, others took the expression of Senator Capper, of Kansas, a White House guest, as their impression of the situation.

## BENDS TREE LIMBS, GROWS AN ARM CHAIR

Embarrass, Wis.—(AP)—John Krubsack bent the twigs—and a comfortable chair sprang out of the ground.

By grafting and bending the limbs of 32 box elder saplings Krubsack trained the trees to grow in the form of a chair. It took 11 years of patient effort, but Krubsack sold the tree chair for \$4,900.

## W. C. THOMAS IS READY FOR TOBACCO CROP

### Plant Covering Over City Block Overhauled and Ready For Action Today.

Announcement was made today by K. W. Cobb, secretary of the Greenville Tobacco Board of Trade, that the W. C. Thomas Tobacco Company had completed the overhauling of their entire plant which covers one city block in the heart of the Greenville tobacco section.

This plant is located on the Norfolk and Southern railroad on Pitt 10th, 11th and Clark streets. The plant comprises approximately 100,000 square feet of floor space.

This company stems and redries tobacco on order for foreign and domestic trade. They handled last year approximately between 8 and 10 million pounds of tobacco. Their season's capacity is 10 million pounds.

When in full operation the plant employs 450 laborers, the majority being stemmers.

Buyers this year will be H. A. Bost, W. W. Sellars, W. F. Thomas, A. D. Dickerson, W. J. Clark will be factory manager. He will be assisted by Meade Irvin.

## COOLIDGE STATEMENT HAS ITS EFFECT ON THE STOCK MARKET

New York, Aug. 3.—(AP)—The stock market broke 3 to nearly 16 points on the first onslaught of selling which followed President Coolidge's statement that he did not choose to be a candidate for President in 1928 and immediately staged a remarkable recovery which substantially reduced, or wiped out, most of the early losses and carried a few issues to record high levels.

# LEADERSHIP IN NATIONAL UNCERTAIN

Long a stumblingblock for potential champions, the Boston Braves have just completed the job of cleaning up a three game series with the Pittsburgh Pirates. The National league situation was as jumbled today as it was in mid-July and there is yet to be developed the real favorite for championship honors.

Kent Greenfield, one of John McGraw's cast-off, pitched Boston to a 3-2 victory over the Pirates yesterday and this incident, coupled with the Chicago Cubs 6-2 win over Philadelphia put Donie Bush's club one and one half games out of first place.

Carmen Hill, the National league's leading pitcher was thumped for the Braves' victory but poor support aided in his downfall.

Guy Bush, one of the Cub's pitching mainstays, got away to a shaky start against the Phillies but steadied down after his mates had batted Furguson for four runs in the second.

The Giants finished up their series in St. Louis by dropping one to the Cardinals 6-2. Dutch Henry went to pieces in the eighth after he had held the Word's champions scores for seven innings. The New York team had visions of a clean sweep in the Mound City but a six run rally, featured by Frank Snyder's home run with two on bases, exploded them with a bang. The Giants, still hoping to get into the championship race in earnest, will now meet the Cincinnati Reds and Pirates in order, and possibly after these series they will know quite a bit about their status.

Cincinnati was preparing for New York invasion by taking both ends of a double header from Brooklyn dodgers. Jackie May had the better of Doug McWeeny in the opener and won 3-1, while the Reds pounded Pitt for a 5-4 decision in the second. Jack Hendrick's burghomaster's climbed back into fifth place through their winnings.

Walter Johnson's 20th anniversary in major league baseball was celebrated at Washington where the Detroit Tigers won out in a 9th inning rally 7-6. Goose Goslin and Harry Hellmann led the hitting with three safeties apiece.

The Chicago White Sox and Philadelphia broke even in a twin bill. The Sox won the opener 7-4, with Ted Lyons on the mound. Metzler's homer in the ninth inning of the second game put Chicago in the lead but the Mackmen came right back to tie the score. Cochran's homer broke up this contest in the 12th innig, Philadelphia getting 6-5 decision.

Stewart pitched St. Louis to a 3-2 win over Boston in the opening game of a double bill.

Whites blanked the Missourians in the windup 3-0, allowing only two scratch hits. O'Rourke and Sleser were the only Browns to touch the Red Sox hurler. The Yankees and Indians were idle.

Seabright, N. J., Aug. 3.—(AP)—Five eastern and three western stars today remained in the running for the men's singles bowl in the Seabright lawn tennis and cricket club's 34th annual invitation tournament.

## AWAIT WORD FROM LONDON AND AMERICA

### Naval Experts Skeptical Regarding Acceptability of Japans Proposal.

Geneva, Switzerland, Aug. 3.—(AP)—Word was awaited today from Washington and London to indicate the reaction of the respective governments to the new formula proposed by the Japanese in the hope of saving the tri-partite naval reduction conference.

The Japanese in presenting it said it was "just an idea"; that they realized it was entirely imperfect and that Hugh S. Gibson, the chief American delegate should feel at liberty to modify it or comment on it in any way he desired.

The naval experts were particularly skeptical regarding its acceptability, not so much by the United States—it being no secret that it was framed to please that country—as by Great Britain.

Indeed, W. C. Bridgeman, first aid of the British Admiralty declared to the Japanese leader, Admiral Saito, that he could not accept the proposed compromise as a basis of discussion, principally because the plan called for a second class of 8,000 ton cruisers capable of mounting 8-inch gun cruisers afloat.

But in view of the earnestness with which the Japanese "idea" was presented, he agreed to telegraph the text to Downing Street, where a regular cabinet meeting was due to be held in the course of Wednesday.

Evidence that the war on bovine tuberculosis has not turned the public against milk, dairy experts say, is seen in the fact that annual consumption of milk in the United States has increased more than 49 quarts per capita since 1918. During 1926 the public consumed 56 billion pounds of milk and cream, an increase of two billion pounds over the quantity consumed in 1925.

## FARM HINTS

Cows should be watered twice a day. The more milk a cow gives the more important it is that she be watered twice or more often. It makes little difference with low producers whether they are watered once or twice, as they often refuse to drink more than once a day.

Spaced six by six feet apart, the number of trees required for planting an acre of farm woodland is 1,210.

Laying and breeding qualities of the poultry flock can be improved considerably by frequent culling. Removal of birds from the flock at the first indication of debility or sickness is a necessary precaution against loss.

Official records, when grouped according to the age of the animals show that production of cows increases up to the age of five to seven years, remains nearly constant from three to four years, and after seven years declines with advancing age.

Loose smut of wheat, which causes an estimated loss of ten million bushels annually in the United States, is controlled best by use of resistant strains. While it is possible to control the disease by treating the seed with hot water, the treatment is difficult to apply and frequently reduces the stand and yield.

**WHAT DOES IT MEAN?**

After four years in the White House without making, that we recall, any direct statement, Mr. Coolidge yesterday broke his silence with a ten word statement: "I do not choose to run for President in 1928." Although coming direct from the President, the statement is still very indefinite and has caused much speculation among members of both the major political parties, and we are skeptical as to its true meaning.

The question that now arises in the minds of the people is what does Mr. Coolidge's statement mean? Does it indicate that he does not want the nomination again and is out of the running for another term in the White House?

Does it mean that while he does not wish to wage a campaign for the nomination he would accept it if his party tendered it without contest?

Or has someone told him that his return to the White House is impossible? Hence the sour grapes: "I do not want it."

Until there is some further explanation from Mr. Coolidge it cannot be definitely said that he does not aspire to a third term and is out of the running.

**Attitude Of Press To Statement of Mr. Coolidge**

Greensboro, N. S., Aug 3—(AP)—The Greensboro Record under the caption, "President Coolidge to retire," today says editorially: "Not a single one of the astute political reporters had even suspected the announcement they were to receive—President Coolidge had been known as the silent man since he succeeded to the Presidency. He had kept his own counsel with rare self control—While the whole country was discussing the third term tradition and the Press was editorializing on it, the President had formulated in his own mind the decision which neutralized all the speculation based on the assumption that he was a receptive candidate for another term."

"Tuesday's simple announcement has caused something approximating consternation among the rank and file of republicans."

Wilson, N. C., Aug. 3—(AP)—"He has not declined to be a candidate," is the heading of an editorial appearing in the Wilson Daily Times yesterday afternoon. The editorial continues: "Mr. Coolidge does not do the choosing. The party leaders in the republican party do most of the choosing and then it is up to the people to have their say at the polls—Mr. Coolidge has been receiving good reports from the leaders of the west to the effect that the farmers are delighted with his administration."

"Mr. Coolidge, however, may have some misgivings and therefore has put out this 'feeler' to see how the folks will take it—Mr. Coolidge, however, has not

yet said he would not be a candidate."

Gastonia, N. C., Aug 3—(AP)—"President Coolidge's announcement does not necessarily mean that he will not run again," thinks the Gastonia Gazette. "His cryptic utterance is capable of several interpretations and at first blush could be interpreted as meaning that he would not accept the nomination under any circumstances."

"However," the Gazette continues "it is our opinion that he would run if enough persuasion could be brought to bear. The brief statement from the President is feeble enough to give him an accurate idea of the sentiment of the country it is our bet that another fuller and more comprehensive statement will be forthcoming in a few weeks. By that time the political opinion of the several sections of the United States is gathered and assimilated, Mr. Coolidge will have a definite statement to make."

Rocky Mount, N. C. Aug. 3—(AP)—The Evening Telegram this afternoon says editorially concerning President Coolidge's announcement: "Because it is made so early in the campaign, before there is any definite indication as to who might be the next President we are forced to be a bit skeptical over Mr. Coolidge's decision reached, seemingly, without serious thought on the President's part."

"The Democratic party must have been greatly relieved to hear it," the Telegram continues: "certainly there is no other man at present in the G. O. P. ranks anything like so well known as Mr. Coolidge. But on the other hand, the third term argument which would have been such good campaign material, will be lost with Mr. Coolidge out of the running."

"With the experience Mr. Coolidge has had, wearing chaps and riding mechanical horses," continues the paper, as it comments upon the President's future, "there is an even possibility that some movie producer will give him a job in a western. Imagine the President 'Silent Cal' of the Great Open Spaces."

Wilmington, N. C., Aug. 3—(AP)—Despite what his personal friends and advisers had to say, President Coolidge has removed himself as a candidate for President in the next contest, the News-Dispatch says in an editorial on the President's statement yesterday that he does not choose to run again.

"And with the elimination of President Coolidge, enter Herbert Hoover as the most likely nominee of the republican convention," the editorial says, in expressing the belief Mr. Hoover will "undoubtedly be the administration candidate."

Charlotte, N. C. Aug 3—(AP)—Under the caption, "The Cryptic Coolidge Utterance," the Charlotte News today, comments editorially that "President Coolidge is still the leading candidate of his party for the Presidential nomination in 1928."

"Had he been resolute in his convictions about the issue and had decided unequivocally that under no circumstances would he be again a candidate for the Presidency, he could just as easily and just as cryptically have said so."

"Republican leaders will know precisely how to construe the Presidential utterance."

Raleigh, N. C., Aug. 3—(AP)—The Raleigh Times, commenting on President Coolidge's statement that he does not choose to run again, today says in part: "A week ago the political situation nationally contemplated Coolidge as the certain candidate of the republicans, with the democratic candidate a problematical figure."

"Today, the certainty is rather Al Smith as the democratic candidate and the puzzle the man whom the republicans finally decide as the best chance of doing what it has been decided Coolidge could not hope to achieve."

The editorial headed, "Shadow of Al Smith Hangs Heavy Over Black Hills," says:

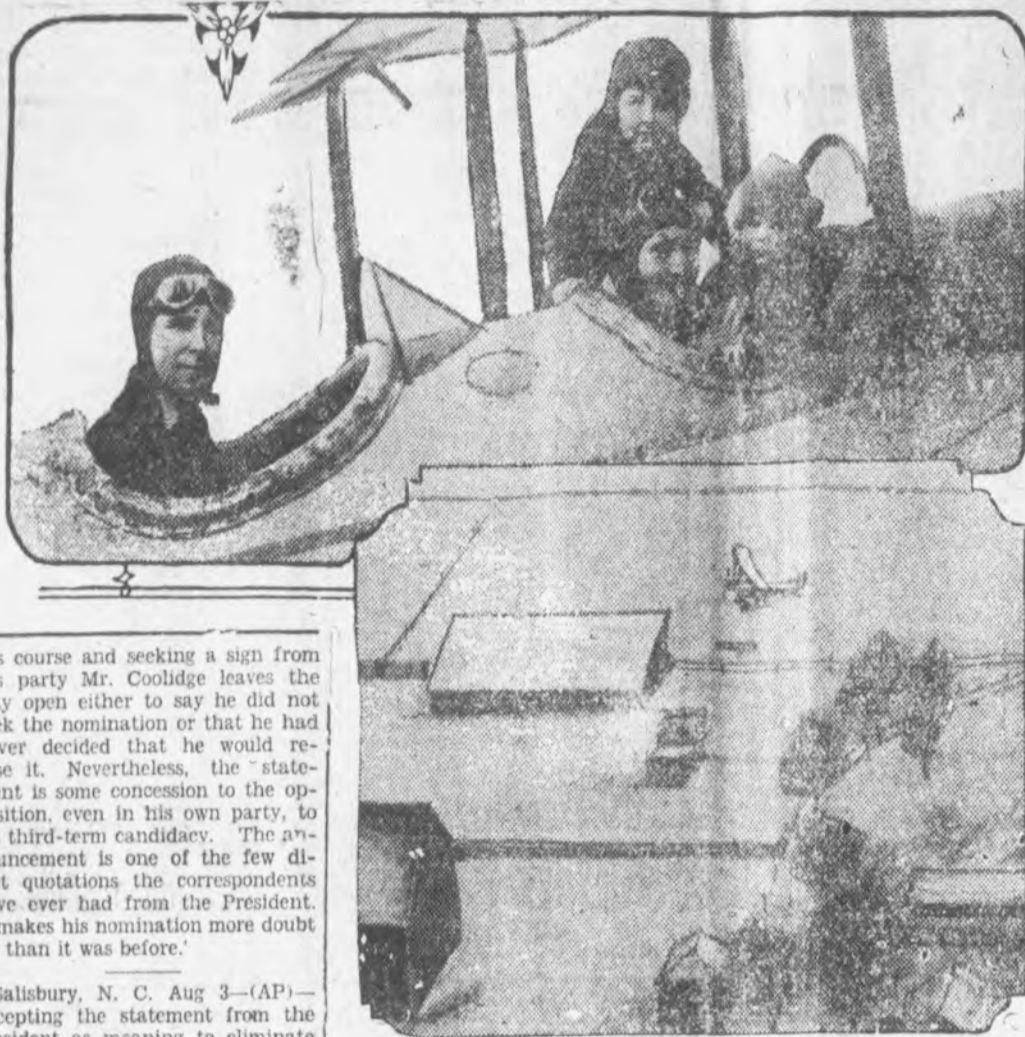
"When he is told now that he must not take the nomination he could command because he would be defeated, it means that the republicans are convinced that the democrats are going to name the one man against whom he could not win."

The President, the Times says, could have had the nomination but "he has been told by somebody blunt and honest enough to tell even a President the truth that, if he were nominated, he would be defeated. He admits it sourly, reluctantly, and he so phrases the admission as to keep within the bounds of the precise truth."

Hickory, N. C. Aug. 3—(AP)—The Hickory Daily Record said editorially today:

"Somehow he (Mr. Coolidge), became more admirable in his retiring statement than heretofore. One finds oneself almost able to wish up a surprising something original. He has done something original, something that no one else would have done—and he did it himself. That is all so unlike Mr. Coolidge that those of us who have not yet become entrenched in a dislike for the monotony of his pickled smile might seek the darkness and solitude of an attic closet and giggle out loud—think of that, will you—Mr. Coolidge original—"

his course and seeking a sign from his party Mr. Coolidge leaves the way open either to say he did not seek the nomination or that he had never decided that he would refuse it. Nevertheless, the statement is some concession to the opposition, even in his own party, to his third-term candidacy. The announcement is one of the few direct quotations the correspondents have ever had from the President. It makes his nomination more doubtful than it was before.

Salisbury, N. C. Aug 3—(AP)—Accepting the statement from the President as meaning to eliminate himself from consideration in 1928 the Salisbury Post assumes the sincerity of the act. "When Cal said he did not wish to run, he means just that," and closing says:—"The country knows today that Mr. Coolidge does not wish to run for the Presidency next year, nor any other year." Why should the President play politics of a questionable kind and send out a "feeler," which conditions do not call for.

Fayetteville, N. C., Aug 3—(AP)—The fact that Coolidge's statement was type-written and given out to newspapermen who were asked to call the Fayetteville Observer says today, indicates the action taken was premeditated "superinduced by pressure brought to bear by Senator Capper and other leading republicans, who were at the summer White House when the statement was given out."

"The announcement by the President was shrewd political move and the declaration that no pressure was brought to bear was very adroit."

"The indications are that the Coolidge supporters are convinced that Lowden is developing so much strength on account of dissatisfaction in the middle west that Coolidge is losing ground rapidly."

Winston-Salem, N. C., Aug 3—(AP)—The Twin City Sentinel, in support of President Coolidge's announcement that he does not choose to be a candidate in 1928, attributes his decision largely to the influence of the no-third term tradition. It points to the fact that he will have served nearly six years when his term expires March 4, 1929. The Sentinel believes that the President kept his own counsel in this matter and that no political leader had any definite knowledge that he was going to issue such a statement and when he did. The Sentinel believes that the outlook for democratic victory in 1928 is brighter now that Mr. Coolidge is out of the race, and urges the party to exercise care and harmony in selecting its candidate.

Kokomo, Ind.—(AP)—When Clyde Shockley needs a bit for his binder or a new set of blades for the hay mower, he rolls his plane out of its hanger behind the barn, and takes off from the south pasture for Indianapolis.

When Mrs. Shockley and the two little Shockleys want to go for a spin at twilight or on Sunday afternoon, their farmer father loads them into the front seat of his ship, jumps into the pilot seat and a way they go.

The whole family is enthusiastic about flying, and Shockley thinks that "some day every farmer will find an airplane as much of a farm necessity as a tractor or a binder."

Shockley has been made Kokomo's only air policeman. His main duty is to watch for stolen cars abandoned along county roads, but he has figured often in making arrests.

Once bandits held up a grocery store in daylight and escaped. Police telephoned to Shockley a description of the car in which they fled. He took the air and soon had spotted them speeding along the highway. He flew daringly low and opened fire on their machine. They abandoned it, sought safety on foot and were soon rounded up and arrested by police, who saw Shockley's plane circling low and followed it.

When Lindbergh came home from Paris, Shockley packed a passenger into the front seat and sailed away to Washington to see the ceremonies, buffeting a high windstorm over the Alleghenies to arrive on time. When St. Louis welcomed the trans-Atlantic flyer, Shockley was there in his plane too.

On his farm Shockley has established an airport where he keeps open house for passing planes—and they are numerous, for his farm lies at the junction of several routes prescribed by the department of war and commerce.

Mrs. Ruth Shockley neither fears the air herself nor worries while

her husband flies without her. Their son and daughter—John 5, and Mary Allen, 3, have travelled thousands of miles by plane.

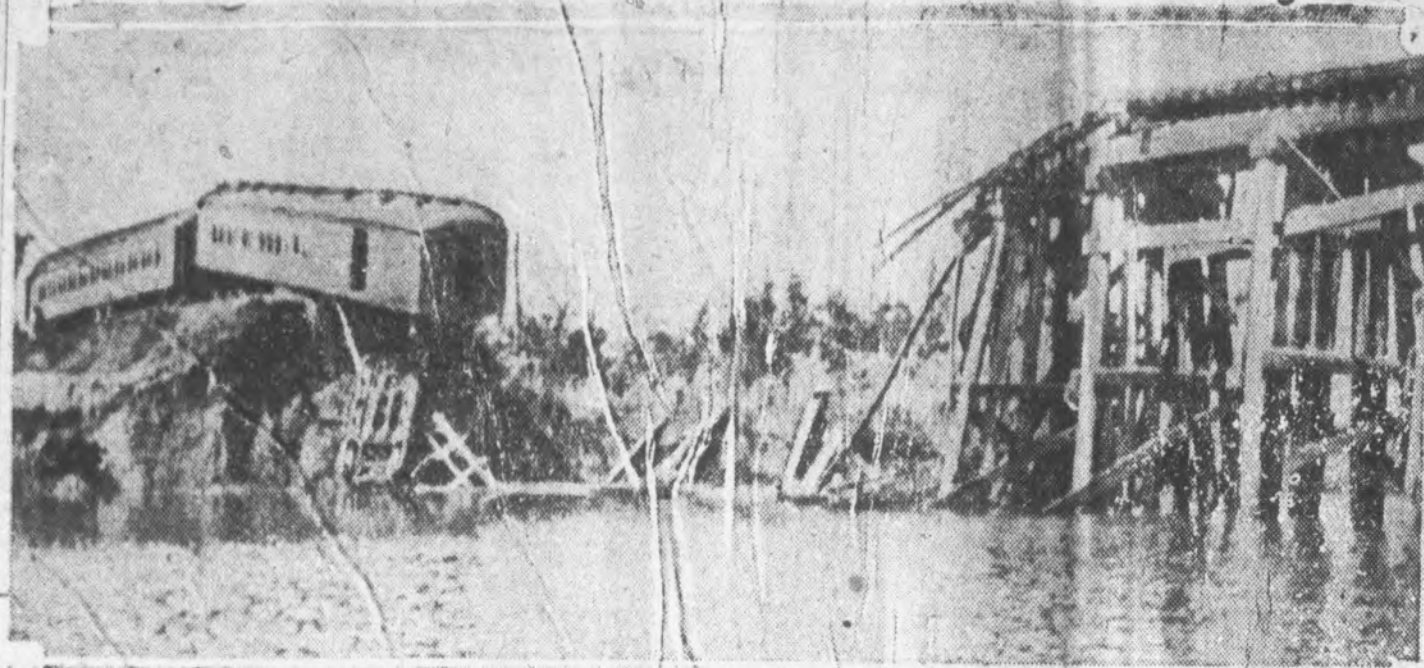

Sacramento, Cal. — (INS)—Heroes may be born, but villains are self-made.

An elevator boy by day and a movie villain by night is the way Napoleon Pollice, young Filipino, double for himself.

This versatile villain, when he is laid off the "lot" decorates the professional ring as "Tiger" Napoleon, coming light weight champion.

And not content with romance, fighting and tips, young Napoleon's real ambition is to be lawyer. The embryo Lincoln from the Orient reads Blackstone by the gleam of the Kleig lights while waiting to stab the hero in the back.

Napoleon, who has been "lifting" legislators for two sessions at the Senator Hotel, was first lifted into the permanent hall of romance as a pseudo hero in a book written by a Senator's wife.

If interested in introspection, study yourself through your relation with your children, declares Dr. Herbert R. Stolz, director of California's experiment in parent edu-

cation. Children he contends, are like the convex and concave mirrors found in "crazy alleys" and the various "zones" of the world's amusement parks. They bring into sharp relief your peculiarities, making enonimities of parental shortcomings that otherwise might pass unnoticed.

Any father or mother who indulges in self-analysis, for instance will find that many times his children are the victims of parental moods, declares Dr. Stolz who has conducted parent education classes in Oakland, Berkeley, Sacramento, Stockton and Woodland for the past year.

Dr. Stolz, whose experiment was financed by the Laura Spelman Rockefeller memorial in conjunction with the State Department of education, declares that no general rules can be laid down for rearing children. Each situation is a specific problem and the only general rule is that parents must indulge in real constructive thinking on the subject. Self-control, which is imperative if the parent is to command the respect of his child, will come as a result of this deliberation, he says.

Corporal punishment, Dr. Stolz believes, can well be excluded from home life, but not necessarily "corporal pain." Interpreting this seeming paradox, the teacher of parents explains that a child should not

be spanked as punishment, but as a "treatment" for a temporary ailment.

We are only twelve thousand years from the late stone age, not two hundred years from the stage coach and sailboat.

A simple idea, like putting the eye of a needle in the point instead of the thick end made the sewing machine possible and freed millions of women from slavery. We should believe that other ideas will free us from the slavery of superstition, which has driven us hard through the centuries and caused more brutality, fear, cruelty, and murder than all other causes together.

Tennyson hoped there would be no moaning at the bar when he put out to sea, and wrote prettily about "twilight and evening star." Typical mid-Victorian, that last trip worried him. Earth's citizens of the year 8,000,000 may think as little about that "last" journey, feel as sure about it as a modern thinks and feels about his trip to Paris

now.

As people go to Paris and come back, none the worse for the trip, and take up their activities again, many believe those that take the voyage of death come back from that trip to earth and take up their work about where they dropped it.

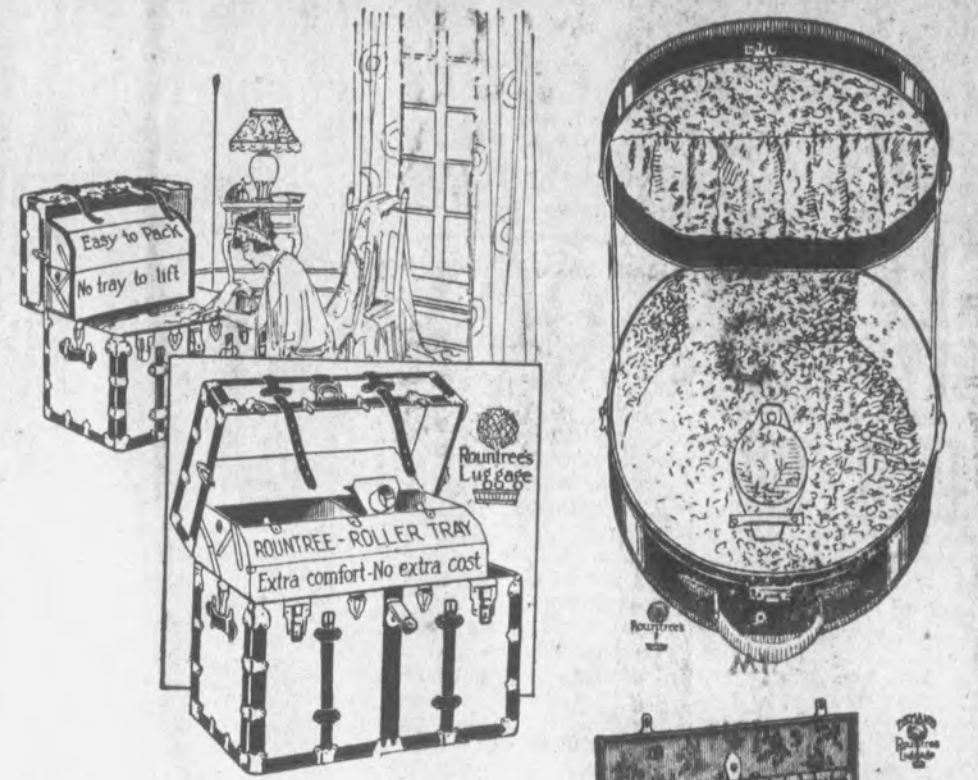
