## REED TO FIGHT FOR STATUS OF SPECIAL FUND

### Democrat of Missouri Desirous of Determining Legal Position Of His Committee.

Washington, Sept. 22.—(AP)—With the organization of the senate in December, Senator Reed, Democrat, Missouri, will renew the fight for adoption of a resolution which will clear away any doubt as to the legal status of the special campaign funds committee of which he is chairman.

A proposal to continue the committee during the recess of Congress was lost in the bitter filibuster marking the closing days of the last session, but since filibusters are difficult except at the windup of a session members of the committee anticipate no difficulty in having the resolution adopted.

Bound up in the measure probably will be a provision authorizing the committee to assemble the ballots in Pennsylvania which have been impounded by the Federal Courts in that State and remove them to Washington along with the registration books and other documents used in the senatorial election in the Keystone State last November.

These ballots and documents will be used in the contest which William B. Wilson, Democrat, has brought against William S. Vare, Republican, who has been declared legally elected to the Senate.

The ballots cast in Philadelphia and Allegheny counties already are in possession of the Reed committee and it is assured that the Senate will entrust this body with the task of assembling and bringing the remaining 5,000 boxes of ballots to Washington.

Whether the Reed committee or the privileges and elections committee will head the Wilson contest will remain for future determination by the Senate after the ballots have been assembled here. There was some disposition at this session to have the Reed committee function.

The Reed committee has yet to make its final report and also to press contempt proceedings against Samuel Insull, Chicago Public Utilities official, and Thomas W. Cunningham, of Philadelphia, treasurer of the Pennsylvania State Republican committee.

## DECISION IN LIQUOR CASE

### Supreme Court Says Man May Serve Liquor in Home, but May not Transport it

Raleigh, Sept. 22.—(AP)—The Supreme Court holds that while a man, under the Turlington act of the last legislature, may serve liquor to his family and bona fide guests in his home, and keep it in the home, he may not buy it or transport it for home consumption.

In its latest batch of 11 opinions, handed down yesterday evening the court reversed the late Judge Raymond Parker who had held that John Winston of Halifax county was within his rights when he bought and transported between a pint and a quart of liquor some three miles from his home to be used for his own consumption.

If it appears from the home and at the same time to prohibit it means by which it may be brought there. Chief Justice Stacy declared that should be remembered that the life of the law has been experience not logic.

The court held that Ernest Boswell, convicted twice of second degree murder in Wilson county for the slaying Feb. 7, 1925 of Clayton Beamon, must serve his prison sentence to 15 years, that failure of Judge Dunn to refer in his charge to the "presumption of innocence" was no reversible error.

The higher court reversed Judge Grady, Hertford superior court, in a case against the Atlantic Coast Line, in which a non-suit was ordered for a case brought by the administrator of a nine year old boy who stepped off a bridge at Tunis. It was held that the Hertford court jury should say whether the railroad was negligent in permitting a four-foot banister with intervening open space there.

## TODAY

John L. and Mitchell. A Suicide's Lament. Ask Him for an Option. \$1.00 Becomes \$1,000. (By Arthur Brisbane) Copyright 1927, by Star Co.)

Fighting has changed. On March 10, 1888, this writer saw John L. Sullivan and Charles Mitchell fight in a muddy, slippery 24 foot ring on Baron Rothschild's training ground, near Chantilly in France. It was not like arrangements for tomorrow's fight.

Thirty or forty men stood around the ring. One was Billy Porter, the bank burglar, who afterwards died in the German salt mines. He had a revolver in each overcoat pocket, and notified those in Mitchell's corner that Sullivan was to have fair play. Sullivan got it.

The men fought with bare fists soaked in walnut juice, and had long spikes on their shoes. Sullivan requested Mitchell to "be a gentleman, you if you can," when Mitchell drove a spike in Sullivan's shin.

The fight was under London prize ring rules, each ending when either man went down with one knee on the ground. No gate receipts, no purse, only a side bet.

When the fight ended in a draw both men were locked up by French gendarmes at Senlis, bombarded by Germans. This writer saw them there. The French jailer had taken away their silk handkerchiefs to prevent their hanging themselves. "Both wept. Both are dead. What would they think of a modern fight with \$3,500,000 gate receipts?"

Frederick Gattler, a teacher of languages, killed himself, leaving written in correct Latin this, "I am nobody. I never was anybody."

"That could be said truly in many languages by 999,999 people in a million. With few exceptions, nobody is anybody. We are human microbes doing work for which we were put on earth, then disappearing."

A microbe has no right to expect that he will ever be anybody, but that fact that he is nobody is no excuse for suicide.

## Police Seek Men In Assault Case

Grover, N. C., Sept. 22.—(AP)—Search continued today for three of the four men wanted by police here in connection with the fatal beating administered Tuesday night by a band of men to Claude Long, 32 year old negro.

The men sought in connection with the death of Long, who succumbed to his injuries yesterday, were Ernest Hicks, Jack Westmoreland, Marcel Fortune and Hoyte Allen. Fortune surrendered to the police here today.

The men were prosecuted in mayor's court here Tuesday on charges of beating a small negro boy. It is alleged that after the trial they followed Long, his sister, the negro boy and another negro woman and when near the Grover Mill attacked Long.

Charlotte, N. C., Sept. 22.—(AP)—Joe Bingham, 23, of Huntersville, was killed and Edgbert F. Kumm and Robert A. Blair of Charlotte were badly injured when an automobile in which they were riding ran down an embankment on the Shopton Road late last night, it was learned here today.

The accident occurred near Shop-ton in the southwestern part of the county as the men were returning home from a barbecue. Kumm is suffering from a fractured skull, broken ribs and probably internal injuries. He is at a local hospital.

The accident occurred on a curve, according to rural police who investigated. They said it was a "clear case of just missing the second curve."

## LEGION BEGINS PILGRIMAGE TO BATTLE FIELDS

### North Carolina Man Elected Vice-Commander in Closing of Paris Convention.

Palais Du Trocadero, Paris Sept. 22.—(AP)—Edward E. Spafford of New York City, was unanimously elected National Commander of the American Legion.

Mr. Spafford was placed in nomination by the North Carolina delegation and his name was seconded by Washington, Tennessee and Virginia.

James Raffis of Washington, Paul R. Younis, of North Carolina Ralph T. O'Neill, of Kansas, Dan Spullock of Louisiana, and J. M. Henry, of Minnesota, were elected vice-commanders.

Gill Robb Wilson of New Jersey who fought with the Lafayette flying corps before the United States entered the war and then with the A. E. F. was elected Chaplain.

The 1927 Legion adjourned at 3:47 as the bands played and colors and badges were presented to the new Commander, the vice Commanders and former Commander.

Jay Ward, a 5-year old Pennsylvanian, chosen as mascot for his state from among a thousand candidates was presented to the convention by Commander Savage as a "Typical American Boy."

He was dressed in pure white with a blue cap and had the distinguished service cross in his breast.

He was chosen national mascot of the Legion, on motion of the New York delegation, seconded by Alabama.

A resolution recommending that the president be authorized to suspend immigration from any country when circumstances warrant and that foreigners who illegally enter the United States be liable to immediate deportation caused a flurry in the convention finally it was referred back to committee.

A Chicago man from the Polish quarters of the west objected to increasing the president's power.

A Pennsylvania delegate shouted, "don't forget that the Legion numbers, among its members sons of Italy, Poland and many other countries providing immigration to America who fought side by side with us."

Delegate Daugherty or Arizona shouted: "this resolution was drawn up to prevent just such manifestations as that at the last convention, and such manifestations in the United States as occurred recently at the unknown soldiers' tomb in Paris."

Othe resolutions tending to resist effort to obtain more liberal immigration legislation were adopted.

The convention approved the boy scout movement on a resolution by committee on Americanism. It also adopted a resolution recommending that progress in aviation be favored in every way possible by the Legion, that cities and towns be urged to establish airports wherever practical and that signs aiding air-men in finding their way be placed.

## MARTIAL LAW AT HANKOW

Hankow, China, Sept. 22.—(AP)—Hankow was under martial law today, with streets heavily patrolled, following a disturbance outside the British concession in which a gang of armed men rescued a uniformed prisoner, believed to be a Communist leader.

The man had been arrested aboard a Japanese steamer and was being taken through the crowded streets by a Chinese escort. The gang, appearing suddenly, opened fire at pointblank range. The escort returned the fire and the bullets flew thick and fast. An undetermined number of passersby were killed or wounded. The prisoner rescued by several members of the gang were arrested and martial law was proclaimed.

In connection with the case, the Japanese authorities this morning removed fifty Chinese soldiers from the Japanese steamer, disarmed them and held them under arrest pending the arrival of a squad of Chinese troops.

Upon the arrival of the latter trouble arose and a Japanese steamer was bayoneted in the neck. He fired in self defense and this was followed by machine gun firing in which one Chinese was killed and a few wounded. The situation later was restored to normal.

Chicago, Sept. 22.—(AP)—James J. Jeffries, one of the heavyweight champions, who tried to come back and failed, thinks that Jack Dempsey will shatter ring tradition and regain his crown tonight. Opinions of others well known ringmen, fight managers and promoters were:

Tom Sharkey—"I picked Tunney last year. I have changed my mind this time."

Johnny Dundee—"Dempsey will knock out Tunney."

Willie Ritchie—"One has to pick Tunney to retain his crown."

Tom Jones, veteran promoter—"It looks like Dempsey night to me."

Jimmy Coffroth, promoter—"I am not picking anyone. I'm friendly with both and not betting at all."

"Bull" Montana—"I feel that Dempsey will win."

Packey McFarland—"I believe Dempsey will win with the wallop."

Jimmy Dougherty, manager of George Godfrey—"Tunney will win but Godfrey will be the next champion if the titleholder will meet him."

Among the Tunney adherents were Benny Leonard, Johnny Kilbane, Battling Nelson, Jess McMahon, George White, Irving Berlin, Arnold Rothstein and Ike Dorgan.

## COOL WEATHER MAKES ADVENT

Autumnal Equinox Accompanied By Lowering Temperature in all Parts State

(By Associated Press.)

The Autumnal Equinox, Herald of cool tidings from the ice-tinged northland, has arrived.

Usually the equinoctial phenomenon, designed by nature and worked out in all its mysteries by men, marks its advent to the bizarre accompaniment of that fraternizing celestial triumvirate—rain, wind and squally storms—but so far this trio of gifts from bedlam has been lacking.

North Carolina, sweltering for the past week or more under torrid sun beams of unprecedented intensity, hailed the change with open arms and sighs of relief, for there is considerable difference in a mercury soaring to peaks perilously near the 100 mark to one hovering around a mark ranging from 30 to 50 degrees lower.

Last night was below the "cool" stage. It began to get cold, and by midnight, in some sections, blankets had been dug out, furnace fires started and the weary feeling of oppression from summer's heat was dispelled by the comforting assurance that winter's vanguard was at hand.

Asheville and mountainous districts were "shivering" at 8 o'clock with a temperature of 49 and the mercury falling. Street thermometers at Durham registered 75 at 1 o'clock yesterday; by 6 o'clock the mercury had shot downward approximately 15 degrees.

Very little change in temperature was reported from Raleigh and Wilmington, but residents went about under temperature ranging from the low sixties to several degrees lower, welcoming the contrast from the past week's devastating heat pangs.

A low of 56 at Greensboro was noted yesterday, with even cooler weather prevailing last night. At Winston-Salem the low mark was 59. Other communities recorded temperatures varying from 20 to 37 and 38 degrees lower than the record high marks established during the past week's heat wave.

While last night's official low mark was not available Charlotte's average temperature was lower than the subnormal mark of Tuesday.

Murkiness, with clouds filled with gloom rather than rain, prevailed over most of the state, and as night drew a citizenry prepared to slumber beneath blankets.

Regardless of whether the cool time is to be permanent or only a phantom which will be dispelled by following days of more encompassing heat, the citizenry of the old North State were grateful for the relief and Libra, Scorpio and Sagittarius emblematic signs which govern the autumnal solstis until the winter solstice, were welcome.

## TWO GERMAN FLIERS REACH TURKISH CITY

### Konnecke and Hermann Plan to Take Off For Barsa and Other Points Tomorrow.

Berlin, Sept. 22.—(AP)—Lieut. Otto Konnecke's success in reaching Angora, the Turkish capital, on the first leg of his eastward flight to the United States has given a fresh fillip to German long distance aviation, which was in disrepute of a funk over the failure of the Junkers planes on their attempted trans-Atlantic hop.

Konnecke, accompanied by Johannes Hermann, radio operator, and Count George Solms-Laubach, financial banker, made the 1,875 miles from Cologne to Angora in less than 18 hours. At times the speed was 115 miles an hour.

Konnecke plans to get away tomorrow for Barsa, Mesopotamia, flying thence to Bombay, Calcutta, Shanghai, Tokyo, Sakhalin Island, over the North Pacific to Alaska, to San Francisco thence to New York, with a detour South to Mexico City.

Two trans-Atlantic flight expeditions are under preparation by Germans.

A three-motored plane has been assembled at the Junkers branch plant at Malmo, Sweden, and is expected to arrive soon at Nordeney, the island off the German coast which served as an airplane base during the war. Friedrich Loose, who was one of the pilots of the Junkers plane Bremen on the recent unsuccessful trans-Atlantic venture, will pilot the plane, assisted by Herr Starke, a Luftwaffe test pilot. They plan to make several stops. Proceeding by way of Portugal, the Azores and then probably Bermuda. Junkers officials say the enterprise is a private one with which the firm is not connected.

A flight with two hydroplanes to America, also by way of the Azores, is planned by the Rohrbach airplane concern. One of the planes started last night for Denmark and the other is making a trial flight at Copenhagen. Ernst Udet and Herman Steindorf will be the pilots.

## OHIO CITY HAS PUZZLE BABY

### Cleveland to Decide Whether Child is to be Outcast or Inmate of City Home.

Cleveland, Ohio, Sept. 22.—(AP)—Cleveland's puzzle baby, whose identity a court of law has been asked to decide, may find herself by nightfall either an outcast in Fairview Park Hospital or the well-known sister of the four small children of Mr. and Mrs. Sam Smith.

A month ago today she was born. And while she celebrated at the hospital with a few playful kicks and lusty yells, Common Pleas Judge Carl V. Weyandt busied himself over a mass of evidence from which he must decide whether the infant girl belongs to Mr. and Mrs. Sam Smith or was given to them by mistake in place of a boy which they believe is theirs.

Hearing on the habeas corpus action which the Smiths filed against the hospital was postponed last week until today. In this action the Smiths seek to compel hospital officials to take back the baby girl and give them their son "George."

The hearing was postponed last week because of the absence of Miss Ruth Meyer, a nurse who attended Mrs. Smith. Miss Meyer returned two days ago from a vacation. Mr. and Mrs. Smith have expressed their determination to leave the "puzzle baby" at the hospital for good unless they are given satisfactory proof the child is the one born to them.

Judge Weyandt announced that if he found the evidence to be convincing, after it was all presented, he would render his decision late today.

## OFF FOR FIRST STOP ON TRIP TO NEW ZEALAND

Detroit, Sept. 22.—(AP)—Captain Frederick A. Giles, Australian aviator, took off from Hess Field at Wyandotte, Mich. near here, at 8:45 a. m., today bound for Ford Field, at Lansing, Ills., near Chicago, the first stop on his proposed flight from Detroit to Wellington, New Zealand.

Flying a Hess Bluebird single passenger plane, Captain Giles made a perfect take-off under full load. He expected to land at Ford Field at 9 a. m. He will remain in Chicago for a day to have his plane thoroughly inspected before starting his westward flight.

## NAME VICTORS OF OVERLAND PLANE RACES

### Fliers Who Finished Today Watch Skies For Eleven Planes Not Reported

Spokane, Wash., Sept. 17.—(AP)—Fliers who finished in three overland air races here watched the skies today for their less fortunate rivals who were scattered out to the East and South.

Eight entries remained in the class A and B races from New York and three from the Pacific Coast derby which started from San Francisco.

C. W. Holman, St. Paul, E. C. Balough, Chicago and N. B. Hamer, Spokane, were unofficially declared winners, respectively, of first, second and third places in the class A derby yesterday.

Of the 25 pilots who started in New York Monday in the class B derby, the unofficial winners were declared to be C. W. Meyers, Detroit, Leslie Miller, Des Moines, and J. S. Charles, Richmond, Va., respectively. Eugene Detmer, Tarrytown, N. Y., came in third, but on the basis of elapsed time got fourth unofficial place.

Garden City, N. Y., Sept. 22.—(AP)—Telegrams received here today by the Rogers airline, forwarded from points where they were dropped by "Duke" Schiller and "Eddie" Stinson, in their non-stop cross country flight indicated that all is well with the fliers. Roosevelt Field, N. Y., Sept. 22.—(AP)—Steve Lacey, of Lamo, belated starter in the non-stop flight division of the National Air Derby took off at 11:32 a. m. Eastern Standard time today for Spokane.

Lacey was temporarily eliminated from the race yesterday when he damaged his plane in an attempt to take off. Officials were uncertain about the manner in which his elapsed time would be computed. He was due to take off at 3:11 yesterday afternoon.

## ELDER READY FOR SKY RIDE OVER THE SEA

### Young Aviatrix Hopes Weather will Permit Take off at Dawn Tomorrow Morning.

New York, Sept. 22.—(AP)—Ruth Elder, the real "American Girl," pilot of the monoplane American Girl spread out her nattiest flying costume before her and packed a tooth brush and vanity case today, and hoped the weather would permit her to start a sky ride to Paris at dawn tomorrow. The same runway mound at Roosevelt Field where Lindbergh, Chamberlin and Byrd took off on their flights across the Atlantic was reserved for Miss Elder's plane. Gas and oil sufficient for the 3,810 mile journey was provided.

There was a pronounced low pressure over the trans-Atlantic air line but Miss Elder and her co-pilot, Captain George Halderman, said they expected this to lift before tomorrow morning.

"We will go as soon as it has lightened enough to take off down this runway," Halderman said, "and that way we should be at New Foundland just as dark falls over the water."

"We should make the 1,150 miles to Newfoundland, in 11 hours. I probably will take the plane off here and after it has gained altitude Miss Elder will take the stick. She is the pilot, you know, in an effort to be the first girl to pilot a plane, not merely fly in a plane, to Paris."

Felts Field, Spokane, Sept. 22.—(AP)—Steve Lacey, who hopped off from Roosevelt Field today, is not a contestant in the New York Spokane non-stop flight, E. A. Goff Jr., referee of the national air races here, declared today.

Lacey failed to start before four p. m. yesterday, against standard time, Mr. Goff said, and even though he others finished in the post-noon flight, he would not be considered a contestant.

## Negro To Pay Death Penalty

Raleigh, Sept. 22.—(AP)—George Frank Bazemore, negro, convicted Greene county killer, will pay fine death penalty at state prison tomorrow morning unless some last minute action to stay execution is taken. Bazemore was convicted of shooting Gordon Yelverton, prominent white man, to death last November.

The negro, a resident of "death row" for six months, has been convicted twice of killing Yelverton, and made an appeal to the Supreme Court the second time, but his case was not perfected. Evidence showed Bazemore shot Yelverton in the back, took the white man's truck and load of tobacco and placed it on sale at Farmville.

New trial was granted following the first conviction on the ground that the trial judge erred in allowing the court clerk to take the verdict in the absence of the judge. No move was in prospect today for a respite.

## YOUNG TO HEAD F. E. D. RESERVE

Minneapolis Man Appointed Governor of U. S. Federal Reserve System.

Washington, Sept. 22.—(AP)—Roy A. Young, who began his career as a bank messenger and rose to the governorship of the Minneapolis Federal Reserve Bank, is to become the head of the Federal Reserve system of the United States.

Appointed by President Coolidge as a member of the Federal Reserve Board, Mr. Young upon qualifying for the office will be designated Governor of the Board. He takes the place of D. R. Crissinger, of Ohio, who recently resigned from the Board's Governorship.

Mr. Young will serve under a recess appointment until the Senate acts on the confirmation of his nomination.

Dr. Way Dies at Asheville

Asheville, Sept. 22.—(AP)—Dr. Howell Way, 62, of Waynesville, chairman of the North Carolina State Board of Public Health, died at an Asheville hospital this morning where he had been a patient for several weeks undergoing treatment for heart disease.

## TELL PARENTS OF NEEDS OF CITY SCHOOLS

### West Greenville Parents-Teachers Association Hears Talks On \$100,000 Bond Issue.

The Parent Teachers Association of the West Greenville School met yesterday afternoon in extra session. The meeting was presided over by its new President Mrs. J. L. Turnage. A large number of parents were present.

After the transaction of the routine business the Association was addressed by Mr. J. L. Little, Chairman of the Board of Trustees of the Greenville City Schools and Mr. J. N. Rose, Superintendent of the Greenville City Schools. In the speeches of these two men school matters were discussed freely with special emphasis on the School improvement election which is to be held Tuesday October 11th.

It was pointed out that the West Greenville School which began operating two years ago with five teachers now contained eight teachers; that the building is now full; that the total school enrollment was 210 more than what it was last year; that every building is filled to capacity and if the enrollment increases much more this year the school will have to use a double shift program.

Attention was called to the fact that in scoring the school system of North Carolina recently the state Department of Education at Raleigh placed Greenville next to the top in cities of like size and seventh in the entire state. It was also brought out that the town had not increased its tax rate in six years; that the \$200,000 bond issue of 1924 had been absorbed without increasing the tax rate and the chances are that this proposed issue of \$100,000 could be taken care of without touching the tax rate. Mr. Little closed with an appeal to those present to be sure to register by October 1st, and to be sure to vote on October 11th.

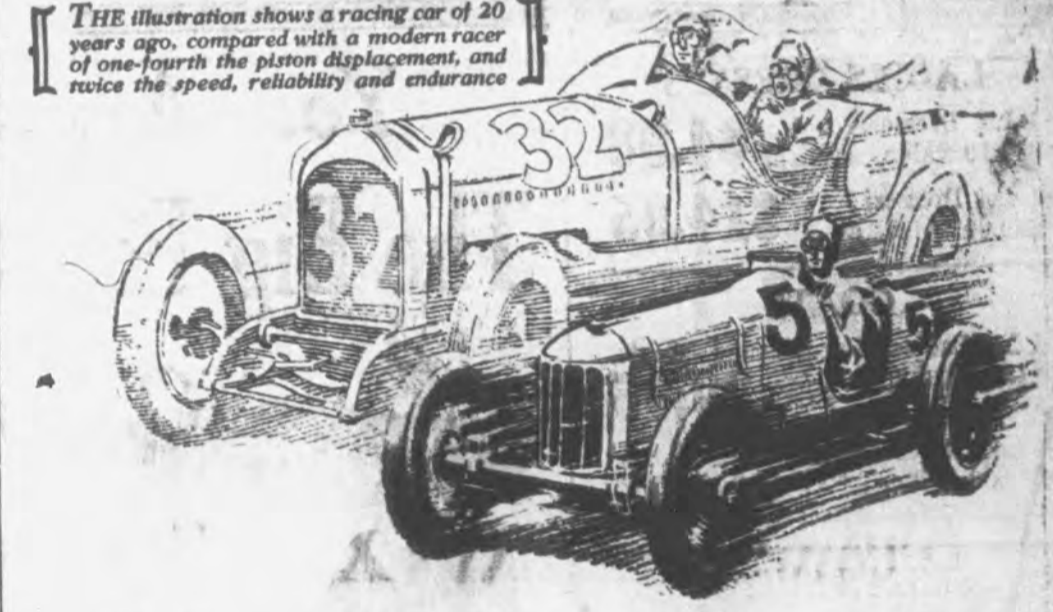

We don't know who will get the championship as a result of tonight's fistic battle at Solders' Field, but we know that financially, both participants will be winners. Most anybody would cheerfully take a licking for half a million or a million bucks.

It has been suggested that plans are already being laid for the 1928 Tunney-Dempsey fight in case the former champion is successful in his attempted come-back tonight.

#### BRIDGE OR ROADS?

The State Highway Commission is calling for bids for the construction of a new bridge across Tar River here which means that the original plans for the bridge are going to be carried out and

the county as a whole will be the loser.

There is at present only a certain amount of road money available for us in this county and regardless of the county's needs no more money will be available until another session of the legislature, and maybe not then.

We, as well as anybody else, would like to see a handsome bridge across the river here, but we do not believe that this bridge should be built before completing the hardsurfacing of roads in the county that at present are more necessary than the bridge.

So far as we can learn the present bridge over Tar River, while not built according to State Highway specifications, and is not a thing of beauty, is safe and ample for some time to come to take care of the traffic. Unless the highway commission is in possession of facts to show that this is not the case and the bridge is unsafe, we do not see the wisdom of keeping the citizens out of the needed roads and giving them a bridge instead.

Sometime ago the State Highway Commission took over the Cox Mill road, and it was hoped the action meant that soon the extension of the road to the Craven county line would be hardsurfaced. Most every one in the territory will agree that the hardsurfacing of this piece of road would mean much to the residents of the section thru which it passes and would also mean much to the traveling public in general by affording a shorter route to New Bern and the coast re-

sorts below there. Even since the state took over this road it's early completion has been a pleasant dream of citizens of this city and county, but alas, the bridge project has cropped up to take a good portion of the money that would have been available for use on this road and the dream of comfortable travel via the Cox Mill route has faded far into the future, and how far no one now knows.

While both the bridge and the road are now state projects and the State Highway Commission has the last say, the fact that the territory affected is also a part of the state and should have a voice in the action of the commission should be taken into consideration. Unless competent engineers can show that the present bridge is unsafe for travel and should be replaced immediately, the citizens of this county should make every effort to block the use of the money, that should go into needed road improvement, for a new and handsome bridge as a memorial to the Highway Commission. We do not object to a new bridge if the state is able to build it without cutting its road building program, but we do object to seeing, for several years to come, a muddy and dangerous road between here and New Bern just because somebody in authority wanted to build a bridge.

#### Italy Cuts Hotel Rates

Those who have failed to visit Italy in the past are assured of a saving in expenses. Hotel men have agreed to cut accommodation rates 10 per cent and to make a like reduction in the price of Italian wines and liquors served.

## About Town

C. W. Porter, director of high school athletics, didn't attend the monthly meeting of the American Legion Tuesday night, but he is favorably impressed with the suggestion made by W. H. Rogers, president of the Rotary club, that the Legionnaires use their influence in promoting interest in activities of the various athletic organizations of the city.

"The need right at this time is for more organizations of this kind," said Mr. Porter, "but more interest in what the boys are doing to give the city a wholesome brand of athletics."

"The military unit furnished a good brand of baseball this summer but they ended the season in worse financial condition than they started. They didn't get proper support at any time during the season."

"It's the same way with high school athletics. Our boys may put out the best baseball or football teams in the state, but their efforts are not properly appreciated. At least, the public has never given their achievements more than passing interest."

"Bill Rogers is long-headed. He has a way of seeing things in their proper relations. It is to be hoped the Legionnaires adhere to his suggestion and rally behind our boys."

There are numbers in favor of the erection of an athletic stadium in Greenville, and there are some who are not.

The question has been discussed both pro and con by members of the Pitt county post of the American Legion, but sentiment is so well divided they don't know exactly how they do stand.

The building of a stadium thru public subscription is a mighty suggestion, D. C. Moore, well known Legionnaire believes, but it is necessary to create public sentiment before such would become possible.

"The undertaking seems to be too great at the present time," Dr. K. B. Pace said today, "but it might be put across at a later date."

It was his suggestion that caused the Legionnaires to table the proposal at their monthly meeting last Tuesday night.

"It is necessary for Greenville people to register for the \$100,000 school bond election to be held next

month," W. E. Hooker, prominent business man, said today.

"It is not only imperative that everybody registers, but it is also necessary that they vote after they register. To register and not vote will count against the issue."

Mr. Hooker is a member of the board of trustees of city schools, and it enthusiastically in favor of improving the school system. He realizes that members of the faculty are badly handicapped by increased enrollment and no way to handle it.

# JORDAN OR BIGAMY

## Minister at Grand Rapids Hospital Said to Have Wives in Several Sections.

Columbus, Ga., Sept. 22.—(AP)—The clerical garb of the Rev. Willis Jordan, who is ill in a Grand Rapids, Mich., hospital, has been revealed as the cloak of a Lothario according to investigations made by F. T. Gloer, head of a private detective agency here which has been seeking the minister since his disappearance a week ago.

Mr. Gloer has asked authorities at Charlotte, N. C., to swear to a warrant charging the Rev. Mr. Jordan with bigamy. This action was taken at the request of the former Mrs. Emma Landridge, of Washington, who now resides in Columbus. She claims to have married Mr. Jordan in Charlotte in 1925 and also said that she had married the evangelist by long distance telephone two years and seven months before the ceremony was performed in Charlotte.

Receipt of a telegram from Winding Gulf, W. Va., confirmed that a woman there had been married to Jordan and that so far as she knew no divorce had been obtained.

Other evidence indicated that the minister had wives in Winona, Minn. and Akron, Ohio.

The Rev. Mr. Jordan disappeared from Columbus recently when he was relieved of his pastorate in a church here. He was found in a Grand Rapids hospital where he is alleged to have admitted that he went to Grand Rapids for the purpose of marrying a woman. He said that he became ill while waiting for the five days required by law before he applied for marriage license. He admitted having a wife in Roanoke.

No charges have been made by Grand Rapids police and the minister is expected to leave the hospital today. He said that he had been ordered to leave Columbus by two men whose names he did not disclose and he indicated he would not return there.

Charlotte, Sept. 22.—Although news dispatches today and yesterday stated that Chief of Police of Charlotte had been requested to issue a warrant for the Rev. Willis T. Jordan who married Mrs. Emma Landridge of Washington D. C. here August 19 chief Alex West said today he had received no such report.

The letter which W. T. Gloer, a

private detective announced at Columbus Ga., that he had written the chief, had not been received it was said.

Police officials were recent as to what possible action they might take in the event the letter arrives. They said they had nothing official in the matter and until some such information was received nothing would be done.

The Rev. Jordan and Mrs. Landridge were married here by squire J. M. Alexander, a justice of peace on August 19 last.

Grand Rapids, Mich., Sept. 22.—(AP)—Leaving behind an unpaid hospital bill, the Rev. Willis J. Jordan, Columbus, Ga., minister who was identified here Monday after disappearing from his home a week ago, left the hospital shortly before noon today in a taxicab without revealing his destination. Previously it was learned that he is practically penniless.

He has taken on Tiger Flowers, former middleweight champion; Young Stribbling and Johnny Riski. Wiggins met Flowers three times, losing on points once, earning a draw another time and having a no-decision affair the other time.

Wiggins boxed for a total of 268 rounds from Jan. 1 to Aug. 1 when he stopped for a short time to help Gene Tunney get into shape for his title bout with Jack Dempsey.

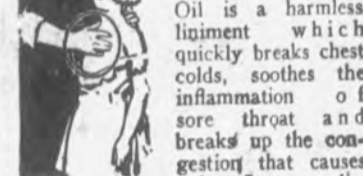
