

MRS. GRAYSON PREPARES FOR FLIGHT AGAIN

Aviatix to Take off For Copenhagen as Soon as Weather Becomes Favorable.

Old Orchard, Maine, Oct. 24.—(AP)—A broken exhaust valve which but for good fortune might have caused an explosion of the motor and sent the plane Dawn, precipitately into the sea, was found today by T. Harold Kinkaid, motor expert, in his investigation of the trouble which forced the Grayson plane to return yesterday after a five hour flight toward Europe.

Old Orchard, Me., Oct. 24.—(AP)—Notwithstanding three failures after starting a trans-Atlantic flight, Mrs. Frances Wilson Grayson was determined today to make another attempt to get to Copenhagen in the monoplane, Dawn.

The time for the next attempt depends on favorable weather and the condition of the motor which practically failed during Sunday's flight after the machine had covered more than 450 miles of its outward trip.

Mrs. Grayson, who is in command of the expedition and has as aids, Bryn Mawr, navigator and pilot, and W. J. Siskosky, mechanic, was undaunted by the successive reverses and delays which have been their fate for nearly two months.

That no abandonment was contemplated until weather conditions make such action absolutely imperative was seen in the hastily telegraphed requests which recalled T. Harold Kinkaid, Wright motor expert, and Ivor Sikosky, designer of the Dawn.

Kinkaid and Sikosky left for New York after the Copenhagen bound machine apparently had at last found its way to their destination when news of the enforced return was received here.

The failure of the left side motor found a mystery today to Stultz, pending the time when mechanics will have an opportunity to take it down.

The machine had scarcely reached Sable Island off the tip of Nova Scotia when "suddenly the motor made a terrific noise" and great quantities of smoke poured out, as Eddy described the difficulty.

The fliers feared it might blow the gasline through the lever and for the third time the plane was saved by the speedy release of a part of its load of fuel.

Twice before when the big ship seemed headed for the waves in take-offs here, it was righted by the quick action of mechanism.

Freed of 260 gallons of gasoline, the plane rose rapidly and fears that had led to the sending of a hasty SOS message the making of tentative plans to land in the water along a nearby steamship were found to be premature.

The Dawn was headed back on "one and a half engines," and the return trip made without further incident.

The take-off had been made in perfect weather, and so confident were the wives of Goldsborough and Stultz that they were busy packing their effects for a return on a night train to New York when they received word that the big amphibian was returning.

The Dawn hopped off at 6:13 o'clock and came back ten hours later after reaching the vicinity of Sable Island off the coast of Nova Scotia. The aviators calculated they had covered 984 miles.

After becoming a mere speck to watchers on shore the Dawn last Saturday morning was forced back 24 minutes after the take-off. The return was ascribed to tail winds which beat down the heavily loaded plane. Improper balance of the load was the reason for the return of the craft last Tuesday when it landed a few minutes after heading cut to sea.

Mrs. Grayson has said that the purpose of her "great adventure" is to prove that the amphibian plane is the proper type for trans-Atlantic commerce and that woman has an equal share in advancing science. Her exhibition was conceived, planned and financed by women.

MEXICO WELL PLEASED WITH D. W. MORROW

Believes New Ambassador Will Assist in Removing Difficulties Between Nations

Mexico City, Oct. 24.—(AP)—The arrival of Dwight W. Morrow, newly-appointed American ambassador to Mexico, is hailed editorially today by both of the city's leading newspapers which see in his designation an auspicious chance for healing pending difficulties between the two countries.

Excelsior finds a source of congratulation in the fact that Mr. Morrow is not a "diplomat" because, it says, American diplomats in Mexico of late years have not gained prominence for their spirit of justice or their proper understanding of Mexican affairs.

The paper declares that this condition had become so pronounced that President Coolidge finally decided to appoint a trusted friend, thus implying that matters which might better be understood in both countries, are subject to revision.

El Universal expresses belief that in appointing Mr. Morrow President Coolidge played his trump card. It says that Mr. Morrow belongs to a group of North American "heroes" who control the world's finances and are the only one admired in the United States. The paper contends, the Mexico-American dispute at bottom is nothing else but a fundamental economic question and Mr. Morrow is the most capable man to deal with economic affairs.

Excelsior, however, touching this same point, expresses the opinion that Mr. Morrow, beside being a banker, is a statesman which is important because at present "something higher and more transcendental than money matters is at stake."

Latin-American countries at present offer the deepest and most complicated problems for the United States because of the activities of American financiers the paper says. Suspicion is especially intense in Mexico where it is believed that Washington's policies have been contradictory, incoherent, wavering and intended to foster constant conflict. Mr. Morrow's main task consequently, Excelsior declares, will be to bring about the conviction among Mexicans that to dictate Mexican policies and to the United States does not intend dissipate the unavailing of the Mexican people who fear that the "United States" is implacably destroying our rights and our tranquility.

He told of the foreign missionary work now being done by the church and the need for expanding these activities. "Two-thirds of the population of the earth have never heard of Christ," he declared, "and the need of missionary work was never more important."

He said the time is not far away when the 2,300 church scattered throughout the state would be consolidated along the same plan adopted by the county school systems. It is a far cry from the tiny churches to the great township edifices of the future, but educational leaders met and settled a similar issue and the churches must do the same before they will be able to carry on as they should.

Following is the historical sketch as presented by Mr. Jones:

There is no written record of the Greenville Baptist church, now known as the Memorial Baptist Church, save the statement in an old deed in book H. H., page 98 of the records of Pitt County. According to this deed the church was constituted in 1827. The deed, bearing date of Sept. 10th, 1832, was for the lot on which the present Memorial Baptist church now stands, and was from Joe B. Jenkins to Redding S. Blount, a trustee of the church.

The only other recorded history of the first forty years of the existence of the Greenville Baptist church is found in the minutes of the Old Neuse Association, which reveal the names of delegates and the number of members of the church each year from 1827 to 1847. In October of 1827 the church was received into the Neuse Association as a newly organized body of twenty-three members. Elder Thomas D. Mason, Thomas Gaskins and E. L. Daniel represented the church at this association meeting.

It is authentically known that Brother Thomas D. Mason assisted in the organization of the Greenville Baptist church and that he was its first pastor, still serving in this capacity when the Baptist State Convention was organized in 1830.

The said Baptist State Convention was organized on March 26th, 1830 in the home of Dr. and Mrs. A. I. Gorham, members of the Greenville Baptist church. The church was represented at this meeting by Elder Thomas D. Mason, George Stokes and Redding S. Blount. "The meeting began as the Baptist Benevolent Society, and the following resolution was adopted without a dissenting voice: 'Resolved that this society be transformed into a State Convention.' In the morning they met in the 'Baptist Meeting House' (which, according to other records, was the home of Dr. and Mrs. A. I. Gorham) where the sermon was preached by Elder S. Wait. At three o'clock the society convened in the Academy where the business of the convention was completed.

In 1827 Thomas D. Mason organized another church a few miles below Pateolis on the road to Washington. It was known as Grindall Creek. It is now represented by the members of the time it soon fell to pieces. Memorial Baptist Church Celebrates 100th Birthday With Appropriate Exercises

Members of the Memorial Baptist church celebrated their hundredth birthday with inspiring exercises yesterday. The stately old church building, situated at the corner of Fourth and Green streets was packed to capacity at both morning and evening services. A picked choir, composed of singers from various churches of the city, furnished music for the occasion, which proved to be one of the most inspiring of the hundred years of the institution's history.

Exercises were brought to a conclusion last night by a masterful discourse dealing with achievements of North Carolina Baptists during the last hundred years, by Dr. C. A. Maddy, of Raleigh, corresponding secretary of the Southern Baptist convention and a leader in state missions work. Yesterday morning Rev. H. F. Jones read an historical sketch of the church, after which Judge Albion Dunn delivered an address on the "Present Status and Future Outlook."

Judge Dunn referred briefly to the history of the church and paid tribute to the splendid record of achievement. "The only way we have of judging the future is by the past," he declared in visualizing the future of the denomination. "The past has been filled with most noteworthy accomplishments, and the future apparently holds forth the most inviting prospects."

Numbers of congratulatory messages were read by the pastor at the morning services. Some of these were from former ministers who have seen long service in the local field. Colonel Lindbergh Back in New York After Flight Covering 22,350 Miles.

LONE EAGLE ENDS FLIGHT OVER NATION

Colonel Lindbergh Back in New York After Flight Covering 22,350 Miles.

New York, Oct. 24.—(AP)—Back at the starting point of his flight to world fame and his 22,350 mile tour of the country, Colonel Charles A. Lindbergh rested today without revealing definite plans for the future.

"I have no plans," he said. "I'm going to rest a few days and then make a short visit to Michigan. After that I frankly don't know."

Tanned, bright-eyed and smiling, the Lone Eagle swooped down out of the sky over Mitchell field and landed in his "Spirit of St. Louis" at 1:59 o'clock yesterday afternoon, one minute in advance of the time an appointment made on July 20 when he started a tour that brought him before 30,000,000 people in 82 cities of the 48 states of the union.

The flier said he had no definite plans, but only a desire "to drop out of the public view for a while."

In the few moments he failed to talk of his plane, Colonel Lindbergh spiked reports that he would enter the political field or join the Department of Commerce.

"Absolutely not," he said as he was told of reports he might enter politics, possibly running for Congress. "When I know myself what I'm going to do, I'll announce it."

Clad in a blue worsted suit over which he wore a leather pilot coat, the flier seemed to be in perfect health as his bright eyes flashed in his tanned face. "I never felt better in my life," he said.

Usually the Colonel shifted the conversation from himself to the merits of the plane that had carried him through 355 hours of flying since he left San Diego, Cal., previous to his hop to Paris.

"The Spirit of St. Louis is in fine shape," he said. "But this looks like a good time to do it, so I'm going to have it completely overhauled. It isn't destined for a museum yet. Eventually, but not now."

Statements by Mr. Guggenheim, William P. McCracken, Jr., Assistant Secretary of Commerce for Aviation, and Harry S. New, Postmaster General, told how the tour had stimulated interest in flying in the air mail, and in construction of airports.

Colonel Lindbergh left for the home of Mr. Guggenheim at Sand Point, Long Island, where he will be a guest for a few days.

The flier has a stack of mail three feet high awaiting him. Most of the letters make business offers, one of them bidding for the appearance of the aviator in a picture showing the hero in a flight from San Diego to Paris and in subsequent receptions in Paris and Washington, all culminating in his signing of a movie contract.

Lindbergh reflected chances to earn several million dollars through work in the movies and on the stage and through thousands of business endorsement proposals.

He said he would not further the progress of aviation.

BANKERS OPEN CONVENTION HOUSTON, TEX.

Tax Revision, Legislation, and Expose Gold Brick Scheme Feature Session.

Houston, Tex., Oct. 24.—(AP)—Tax revision, legislation educational campaigns and expose of "gold brick financing" featured discussions at the opening of the American Bankers' Association convention here today.

Responsibility for the bank failures of the deflation period was charged directly to systems used by the various state banking departments and the comptroller of the currency by Dan V. Stephens, president of the Fremont State Bank, Fremont, Neb.

The business of the country now is being conducted by about 4,000 less banks than existed seven years ago when the deflation started, he asserted, and no doubt could be conducted with 4,000 less banks than are now operating.

"In other words," said Stephens, "the first and primary cause of bank failures is the excessive number of banks created by the various state banking departments and the comptroller of the treasury."

"The second cause is attributable to the inefficiency of bank supervision by banking departments. This is not a criticism of officials now conducting the various Banking departments of the country nor the comptroller of the currency, but is a criticism of the system which they employ and which has been employed for many years in the conduct of their business."

"Remove the two causes, first by limiting the number of banks and second by adequately supervising those that are created and bank failures will disappear."

"The remedy for the first cause lies in the mere voluntary act of the various banking departments in restricting charters to the actual needs."

He declared that the federal and State system of banks examination was ineffective due in part to lack of permanent assignments of examiners which he found resulted in "long range findings." He suggested adapting the banking departments of the various states and the comptroller of the currency to the credit clearing house idea.

Summing up, the report said there were no mineral claims in Teapot Dome, "worth serious consideration" and added that from both a geological and operative point of view drilling should not be started on the reserve.

Y. M. C. A. Has Million Members

Chicago, Oct. 24.—(AP)—For the first time the total membership of the Young Men's Christian Association in the United States and Canada has exceeded the million mark, the annual report of the General Board of the National Council of the Y. M. C. A. of the United States revealed today. The present membership is 1,005,714.

The report presented at the fourth annual meeting of the council also showed that the operating expenditures of the more than 1,500 associations in the United States and Canada together with their State and National agencies and services abroad for the past year \$67,125,000, compared with \$64,181,000 last year and \$21,919,000 ten years ago.

Several Persons Burned to Death In Finland Fire

Helsingfors, Finland, Oct. 24.—(AP)—Twenty-one men and women were either burned to death or suffocated and a number of persons seriously injured in a fire in a motion picture theatre in Tammerfors last night.

When the film caught fire, a panic ensued and fleeing spectators found the exits blocked by lines of people waiting to get in to the next performance. Firemen, by turning their hose on the waiting throng, forced a path for them.

In the meantime those in the galleries jumped to the floor thirty of them were taken to hospitals.

DEFER ACTION ON TESTIMONY IN OIL HEARING

Justice Siddons Not Yet Ready to Admit Evidence Presented In Teapot Dome Case.

MANY STARS SHONE FORTH ON SATURDAY

Atlanta, Ga., Oct. 24—(AP)—A week-end more or less placid as to developments, since no devastating upsets were recorded, yet abounding in instances of team and individual brilliance, serves to remind devoted followers of Southern conference football that they are nearing the middle of a highly colored season.

A glance over past statistics indicates that almost any eleven in the group is capable of outscoring loose with scoring power enough to topple the leaders.

Seven teams now stand undefeated. But no team in the conference has an uncrossed goal line. No team that has played more than one conference game has held all its conference opponents scoreless.

Only Vanderbilt and Washington and Lee remain unscathed on by conference opponents and each of these has just entered the conference scramble.

Georgia Tech, with four wins; North Carolina State, Tennessee, Georgia, with two wins each; L. S. U. with two victories and a tie, and the Generals and the Commodores with one triumph apiece, are the seven that have come so far without tasting defeat.

A cursory review of Saturday's games reveals a tendency traceable to the wide open attack that has featured the season thus far—the prevalence of long and sudden conference gallops to touchdowns.

Bill Spears, of Vandy, made his conference debut against Tulane by getting away twice for eighty yards runs—once with a captive enemy pass and once from scrimmage.

Tuck, Alabama fullback, grabbed the opening kick-off to go eighty five yards for a touchdown against Sewanee.

McDowell, of North Carolina state, sprinted 75 yards to score a touchdown against Florida, and Owens, of the Gators, in the same game, went 88 yards for a marker of his own.

Stumpy Thomason, in Atlanta, entered the marathon with a 75 yard dash across the Tar Heels line.

McCrary took a pass and went 60 yards to count for Georgia against Auburn.

PLAYING THE GAME

Development of the Shift
By Fielding H. Yost

Ann Arbor, Mich., Oct. 22—(AP)—Development of the present much misunderstood shift plays in American football

started in 1894 or 1895 with the abolition of the right of players to be in motion towards the line of scrimmage when the ball was passed.

Since that time the fundamental of the rurs has been against the "running start," while Fielding H. Yost previous to the rule changes of these two years as many as ten men were in motion forward when the ball was snapped.

The original American Rugby rules required only one man to be on the line of scrimmage when the ball was snapped. This resulted in the formation of the flying wedge, a V shaped formation. It started far back and the ball was snapped to one of the runners just before the wedge crossed the scrimmage line.

Changes in the rule in 1894 prevented the use of the flying wedge, while additional changes in the rules in 1895 required the presence of five men on the line of scrimmage with the provision that one man might be in motion backward toward his own goal line. This change in the rule was followed by the famous guards back formation of Pennsylvania with its companion tackle back, turtle back and all mass formations.

After twenty years of such plays, in 1905, the rules again were changed, this time to provide for seven men on the line of scrimmage and soon after this what are generally known as shift plays came into use. It is necessary to make a distinction between a shift play and the general understanding of a shift play.

All teams use a shift of personnel. Some accomplish this shift upon a signal number, the players taking different positions as they line up. Some shift in the huddle, a practice that Michigan has used since the introduction of that system of signal calling. In these shifts there is no attempt at a forward movement, just a different distribution of the personnel to get the best use of the abilities of different players.

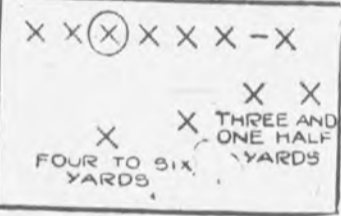
The generally discussed shift as originated by Dr. H. L. Williams of Minnesota, where a group shifts and is supposed to stop, is the one that has been the center of public discussion for the past several years, and changes of the rules during the past year.

Following out the fundamentals

of the game as evolved in 1894, the rules committee has attempted to stop all possibility of a "running start," by directing the officials to count "one, two, three, four," after a shift or huddle before the ball is put in play.

In spite of all this discussion of shifts and other styles of play, football has become as fundamental in its general scheme of attack as baseball. Line play especially including the end positions, has become similar both on offense and defense. There remains, however, quite a difference in the disposition of the backs.

Ninety per cent of the teams in the United States use what is known as the "Z" formation with a man shifted in the line and the backs and it is this shift which occasionally on one side.



This is the formation from which the Minnesota shift makes its play after the backs have made their respective number of hops.

The Warner system, now in use at Stanford and also used by the Navy, makes a slight variation as follows:



The man at the left is the man in motion when the ball is snapped.

All teams use the punt formation, with the different backs disposed of in the angle back of the line to make the most value of their ability. This is the formation most largely used by Michigan, as it gives



the greatest latitude to the attack and especially to the individual who can pass, run and kick. It is an ideal formation for running, kicking, bucking and passing.

FORTY-SEVENTH STATE

The forty-seventh State! So much has been said about North Carolina as the "fifth State," and more recently about its being the "fourth State," that to refer to it as the forty-seventh State in the American Union seems out of place. And it is out of place. It is no wonder that the club women of North Carolina have set about to redeem the State from its lack of public library facilities.

What better work could a women's club do than to aid in providing library facilities for every child in the State? Until books are accessible to every child, the State will lack a vital essential to real progress. Thanks to the club women and to other public spirited citizens, the need is being remedied.

The last Legislature appropriated \$10,000 for this work. This money is not to be distributed indiscriminately. It is only being allocated upon the condition that a consolidated school district shall raise \$50 and the board of education shall appropriate another \$50. The additional \$50 is given by the State, so that a fund of \$150 is provided with which to start a library. means that \$30,000 is going to be spent on school libraries, as practically all of the \$10,000 has been allocated by the State Board of Education.

It is an instructive report that Mrs. Lillian B. Griggs, director of the State Library Commission, has gotten up on public library service in the State. It shows 46 out of 100 counties without public library service. The es-

establishment of school libraries will aid greatly. Then there are Sunday school libraries in many places, and the State library extension service is aiding in putting books within reach of men and women and children who want to read. North Carolina will not long remain the 47th State. It is moving toward the top, but it has a long way to go.—News and Observer.

About Town

"The celebration of the hundredth birthday of the Memorial Baptist church yesterday was an occasion that will not soon be forgotten," said Rev. H. F. Jones, pastor, reminiscing over achievements of the institution to the writer of this column today. "A hundred years does not seem long. It isn't. But when we begin to go back and enumerate the achievements of an institution which has survived that many years, it seems like eternity. The Memorial Baptist church has kept abreast of the denomination during the last century, and it is the ambition of the congregation to continue to do so. 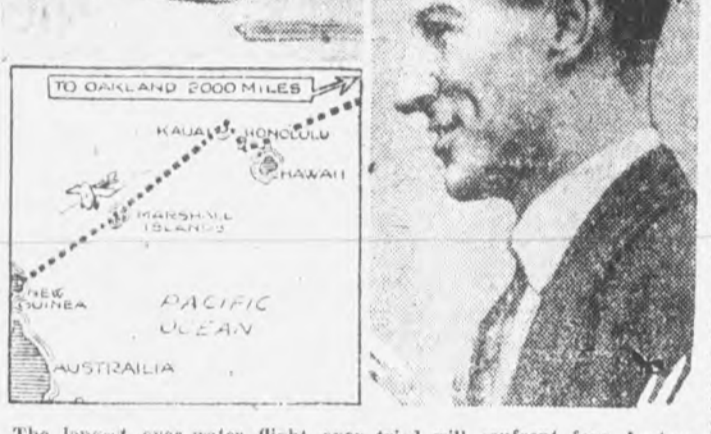

Australians Plan 3,800-Mile Sae Hop In Pacific Venture



The longest ever-water flight ever tried will confront four Australian birdmen, bound by air from California to Australia, if they complete the first leg of their flight from Oakland, Cal., to Honolulu. air conditions have convinced Captain Kingsford Smith and his three associates of the feasibility of trying to make a sure jump from Hawaii to New Britain island, off the coast of New Guinea. Captain Smith and Lieut. Keith V. Anderson will act as pilots.

lots of the ship. Charles T. P. Ulm in the Royal Australian naval reserve, will go as navigators. Taking off from Oakland, Cal., on October 18 or as soon after as weather permits, the four flyers will make Honolulu their first objective. There they will take a light load of gasoline and jump to Kauai, a small island in the Hawaiian group just northwest of Honolulu.

From Kauai's barking sands they will take off on their 3,800 mile hop to New Britain Island. Their Oakland-to-Melbourne route will take them over the Marshall islands and other Pacific groups, but they will not land on any of them unless forced to by mechanical or other troubles.

When the plane leaves Day Farm Island, the municipal flying field near Oakland, it will have the largest crew aboard that has headed for Hawaii since the memorable attempt of the late Commander John Rodgers. The seaplane of his unsuccessful expedition were manned on which Miss Mildred Doran and her two male companions went to their death.

With slightly more than 1,400 gallons of gasoline, the Australian plane will have a capacity of a by five men. Only one plane in the recent hole flight carried as many as three. This was the ill-fated calculated sustained flight of 46 hours, giving a cruising margin of 500 miles in excess of the distance between Kauai Island, Hawaii and New Guinea.

The jump to Hawaii, while considerably shorter than the next span of the itinerary, is regarded as the more dangerous, first because of the need for greater accuracy in navigation to locate the island, and second because weather conditions are likely to be more disturbed.

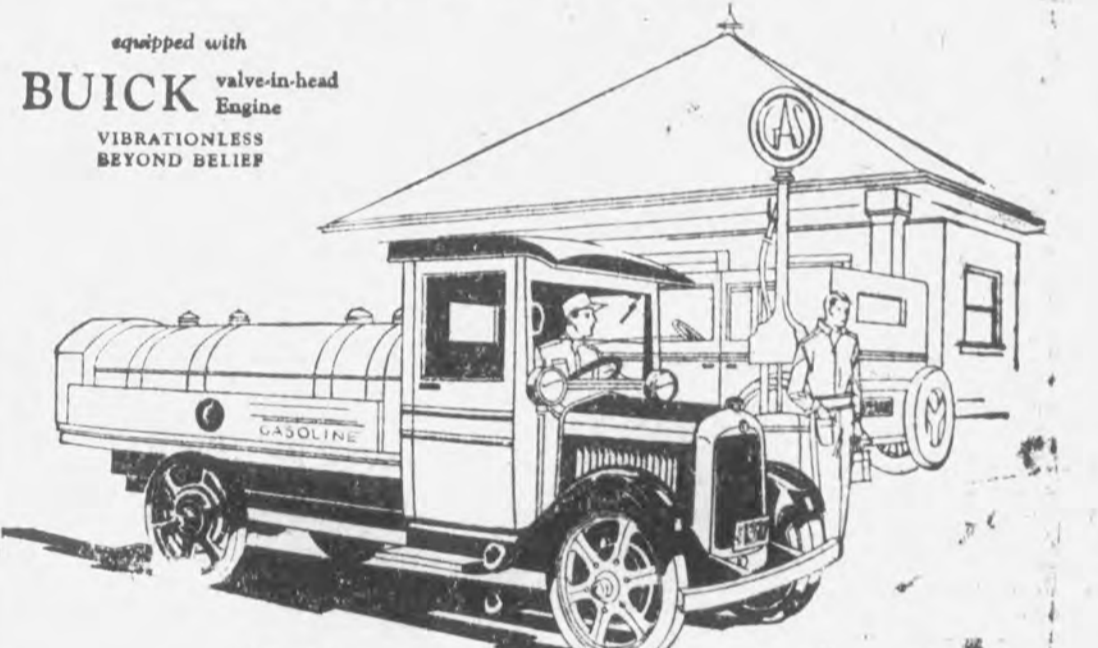

The cost of living was 62 per cent higher than in 1914." In other words, workers this July were 52 per cent better off than they were thirteen years ago. The workers of all kinds in this country earn each year 10,000 million dollars more than it costs them to live.

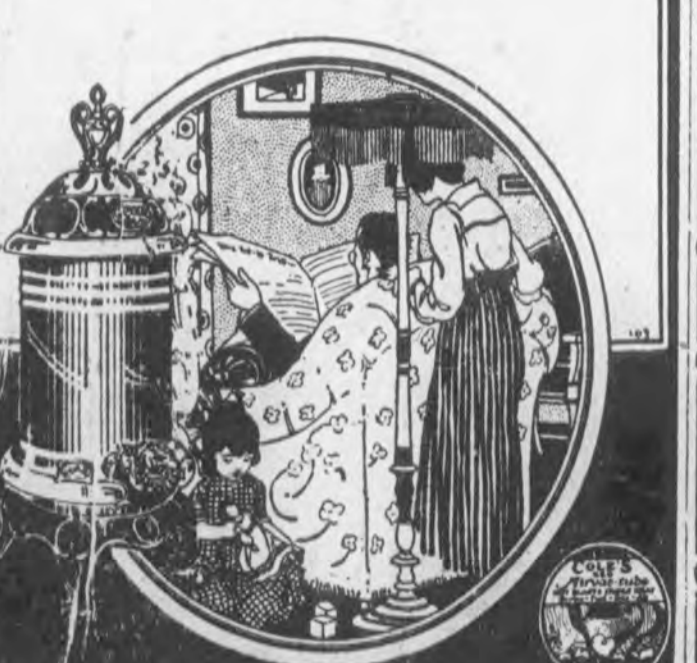
