## CUBAN CONFAB AGAIN FACED BY DEADLOCK

### Questions of Tariff And Intervention Continue to Predominate Pan Sessions.

Havana, Feb. 13.—(AP)—The Pan-American conference was faced with prospects of a deadlock today on two questions—tariff and intervention.

Apparent conflict developed between advices from Buenos Aires that the Argentine government was understood to have instructed Dr. Puyretron, head of the Argentine delegation not to insist on the inclusion of an economic clause in the proposed Pan American union convention and the repeated announcement of Dr. Puyretron that he would sign no convention that did not embody this clause. This lent special interest to a meeting of the committee on the Pan-American union summoned for today.

The convention to regulate future activities on the union was on its agenda. Dr. Puyretron wished to have the clause under dispute inserted in the preamble. At the last meeting of the committee it was agreed to consider first the actual articles of the treaty so as to allow time for second thought and consultation with home governments.

Before the committee went into session today, however, chairman Enrique Olaya of Columbia predicted that consideration of the articles would be completed during the session and actual debate on the preamble begun.

The preamble, Dr. Puyretron insisted should declare that Pan-Americanism rests largely upon economic union along the countries of this hemisphere and therefore that all artificial or exclusive barriers to the free flow of commerce should be abolished.

All other members of the sub-committee which discussed the union convention unanimously opposed these views. They maintained they affected the sovereign rights of states. This afternoon the sub-committee on public international law also was scheduled to meet to combine all views regarding the question of intervention by one state in the internal affairs of another.

Both Dr. Puyretron and Mr. Gustavo Guerrero of Salvador announced that in this meeting, which will be held behind closed doors, they would continue to uphold the complete and unconditional prohibition of intervention which was recommended in the Dio Janetro Jurists conference.

The Jurists recommended the flat declaration: "no state may intervene in the international affairs of another." The United States delegation has opposed any formula as sweeping as this and holds that the duty of a conference is to codify existing international law and not to introduce new precepts.

## HARTNESS IS SUCCESSOR TO W. N. EVERETT

### Statesville Man Named Secretary of State at the Noon Hour Today.

Raleigh, Feb. 13.—(AP)—Governor McLean at 12:10 o'clock this morning, appointed James A. Hartness, of Statesville, prominent in Democratic and Anti-Saloon League circles, Secretary of State, to succeed the late William Nash Everett of Rockingham, who died last Tuesday night.

Mr. Hartness, accepting the office, probably will be sworn into his new duties tomorrow.

At the same time the Governor announced the appointment of Elizabeth City, as assistant director of the budget, effective Wednesday, and made public a letter praising Mr. Williams' abilities. Mr. Williams accepted the appointment.

Mr. Hartness will run in the June 2 primary if he should happen to have opposition at that time. His appointment is for Mr. Everett's unexpired term which ends in January next year.

The Governor explained that endorsements of Mr. Hartness came from all over the state.

Senator Williams will give full time to his duties, that of working on the executive budget system, which, the Governor said, "is the most effective measure enacted during my term. Under it several million dollars have been saved to the taxpayers."

Miss Beatrice Cobb, of Morganton, newspaperwoman, became a member of the State Historical Commission to fill the vacancy caused by Mr. Everett's death. (Continued On Page Six)

## OLDER BOYS CONFERENCE ENDS HERE

### Jerome Clark, of Fayetteville, Elected President at Banquet Saturday Night.

The three day session of the Older Boys Conference of the State Y. M. C. A. was brought to a conclusion at Jarvis Memorial Methodist Church yesterday afternoon shortly after three o'clock. The final session was marked by a report of finance committee, which was based upon the conclusions of the various discussion groups and a short fellowship service led by Henry Ruark, of Duke University. Numbers of boys responded to his appeal for personal decision and determination to go back to their respective communities for a definite program of service.

One of the outstanding features of the conference was a banquet held in the dining room of the Eastern Carolina Teachers College Saturday evening. Over two hundred young men, representing nearly eighty high schools of the state, attended this affair, and listened to illuminating addresses dealing with boys' activities. J. B. Kirtland acted as toastmaster.

Officers for the ensuing year were elected at this session. They were: Jerome Clark, of Fayetteville, president; Martin Bazemore of Wilson, vice president; Edward Albright, of Durham, secretary; Joel Schneider, of Statesville, treasurer.

The principal address of the occasion was delivered by Henry Ruark and J. A. McMillian. Mr. Ruark spoke on the subject of "World Brotherhood" and Mr. McMillian, who is alumni secretary of Wake Forest college, spoke on "The Game of Life," using the story of baseball for the foundation of his remarks.

Mr. Ruark, who recently attended a world's conference of boys' workers held in the city of Helsingfors, Finland, told the chief message of the conference. The receiving of the flaming torch of Christianity and throwing it to their fellows of all races of the world, he declared, was one of the outstanding features of the gathering. He portrayed the opportunities which the boys of the United States have for fellowship and service to the boys in America representing the different races.

Mr. McMillian said it was not the spectacular or sensational individual playing of any single man on the team, but that the combined strength of the entire club counted largely in the final outcome of the game. He applied the same thing to life, and made a forceful plea for united effort of all the boys in behalf of the great issue of the day.

The conference here was one of the most successful during the nine years of history of the Older Boys gatherings. C. A. Witherspoon, of Charlotte, secretary of the State Y. M. C. A., stated this morning. Over a hundred homes of the city were thrown open to the entertainment of the three hundred or more boys attending the conference, he said, and virtually everyone returned home with a splendid impression of the hospitality of Pitt county people.

Virtually all of the sessions were marked by most intense interest. Mr. Witherspoon declared, and expressed opinion that constructive sentiment had been implanted in the minds of the entire membership. He said he desired to express his appreciation to the people of Greenville for the splendid manner in which they helped entertain the boys and felt sure much good would result from the associations formed here.

Chicago, Ill., Feb. 11.—In Chicago where this is written, the sun is shining brightly, on Wabash avenue, on the Lake, and all the surrounding country. Gigantic buildings reach skywards, north of the Chicago River of Michigan avenue, where this writer advised friends to buy real estate a few years ago. The great opera house will soon be built, thanks largely to Samuel Insull.

This is a great city, destined perhaps to be the world's greatest air port and the world's greatest city. Los Angeles, Seattle, and a hundred other places will disagree with that suggestion.

This is Lincoln's birthday. Yesterday was Edison's birthday. 119 years ago, a tall, thin woman, probably not able to read or write, the sort that would be kept out of the United States by our immigration laws now, was taking care of a long boy baby, just born.

That was a "lucky" baby for the United States, named Abraham Lincoln, he kept this country united which glazes the south today as well as the north.

Thirty-eight years after Longfellow was born, along came Thomas A. Edison, another fortunate arrival for this country. He supplied electric light and many other things. He was 81 yesterday. May he see 101.

Fathers and mothers, sad because they can't give their sons "all the advantages" will please notice that the two sons, Edison and Lincoln, had no advantages. They didn't go to college, no fortune was left them. They acquired information, had little education. But they did have the chance that every American boy has, and all that anybody needs, if intelligent and willing to work.

## COOPER WILL BE SET FREE FEBRUARY 20

### Governor McLean Today Commuted Sentence of Prominent Wilmington Banker.

Raleigh, Feb. 13.—(AP)—Governor McLean at 12:30 o'clock this morning, commuted the eight year sentence of Thomas E. Cooper, former Wilmington banker, to the 14 months he will have served on good behavior next Monday, Feb. 20, when he will be free.

The executive clemency had been anticipated generally since December when it became known that many petitions in Cooper's behalf had been filed with the Governor from all over the state.

A parole would have placed Mr. Cooper on probation, but the commutation gives him absolute freedom. One of the suggestions to Mr. McLean had been to leave the state but the Governor said he always had held banishment to be a very obnoxious policy.

Judge Henry A. Grady who presided at Cooper's trial, solicitor Woodus Kelum, and ten of the twelve jurors besides countless citizens, recommended clemency.

Cooper was convicted in November, 1924, for violation of the banking laws in connection with the failure of the Liberty Savings Bank and was sentenced to serve eight years on the New Hanover county roads. Pending an appeal to the state supreme court he was convicted in federal courts of violation of federal banking laws in connection with the failure of the Commercial National Bank and sentenced to serve three years in federal prison at Atlanta, and on Feb. 25, last year, he was paroled by President Coolidge after serving two years of his three year sentence.

## THIRTEEN MEN DIE IN BLAST AT MINE PIT

### Exploring Party at Whitehaven, Eng., Killed in Series of Explosions.

Whitehaven, England, Feb. 13.—(AP)—The Haig mine pit where 13 men lost their lives yesterday in the third explosion in five years, was sealed again today. Fifty-six lives have been lost in the series of disastrous blasts.

The 13 victims were members of an exploring party of 21 who had entered the mine in search of the body of a miner lost in an explosion last December when four were killed. It was the first time the workings had been penetrated since the December explosion.

The searchers had reached the scene of the December explosions when four blasts occurred within 19 minutes.

The eight who reached the surface alive had left the main party to recharge their batteries and eat a lunch. They were about 500 yards away when the explosion occurred.

"Just as we finished eating," said one of the survivors, "we heard a dull rumbling, then came a second explosion and we all started to get our apparatus and go to the rescue of the others. A third explosion blinded us and before we could find our equipment we were knocked semi-conscious by a fourth."

"Only one lamp remained lighted. Half crawling, half walking guided only by wagon lines. We struggled the two miles to the pit shaft. It seems an eternity—and at times I never thought I could win through. The explosions had filled the air with a thick dust and we reached the surface completely exhausted."

Desperate efforts to reach the entombed men, several of whom were officials, were blocked by the foul air. Relief work was finally abandoned at noon and the mine sealed. The survivors said they found both original fires had burned themselves out, but that a third must have broken out.

## GOVERNMENT WINS FIRST TILT TODAY

### Justice Siddons Upholds Objection of Prosecution in Case Against Sinclair.

Washington, Feb. 13.—(AP)—The government won a victory today when Justice Frederick L. Siddons upheld its objection to testimony intended to show that United States authorities had shadowed trial party for which offense Harry F. Sinclair, William J. Burns and three associates are being tried for criminal contempt of court.

Sinclair hired Burns detectives to shadow the Fall-Sinclair oil conspiracy jury which had his fate in its hands.

Defense counsel pleaded the testimony would show Sinclair in employing the detectives had acted in good faith in following a government custom. They also argued they had the "right to show by evidence what usage and custom was."

The government contended that what it did regarding jury shadowing had nothing to do with the contempt case.

In ruling, the Justice emphasized his decision of last week that jury shadowing was unlawful.

The ruling barred from the witness stand 18 witnesses the defense had called to prove jury shadowing was a custom followed by the government.

## Abandon Hope of Saving Missing Ontario Miners

Timmins, Ont., Feb. 13.—(AP)—The work of bringing bodies of victims from the burning Hollinger gold mine continued today with hope abandoned that any of the missing miners would be found alive.

Early today 25 bodies had been brought to the surface and reports at the shaft head were that the bodies of the 14 other missing men had been located. Twelve of the 31 miners imprisoned Friday had been rescued.

It was officially announced that the fire, which had been burning on the 550 foot level since Friday morning, was under control.

## Hoover Openly Announces Candidacy For Presidency

Washington, Feb. 13.—(AP)—Secretary Hoover today sought a temporary refuge from the storm of political discussion brought by his announcement of his presidential candidacy, and prepared to leave Washington on a fishing trip in Florida.

He asked the bureau of fisheries to recommend the spot on the Florida coast where an amateur fisherman could best hope for a catch, and declared that he would go there and remain at least a week.

It was indicated today that in spite of his announcement, Mr. Hoover intends to refrain as much as possible from political discussions. For several years past he has indulged himself for a week or so during February with a week's vacation in Florida. He will be accompanied by one or two personal friends.

## Prison Inmates Kill Two Guards In Massachusetts

Bridgewater, Mass., Feb. 13.—(AP)—Led by an insane murderer, liberated inmates of the Bridgewater State farm overpowered and killed two guards this morning and were subdued after a force of more than sixty guards, state police and city police from Brockton had invaded the institution.

The slain men were Eugene Am-law, night supervisor of guards, and Wilford Gerrior, a guard.

Gerrior's death at the hands of the murderer—ring leader, as he came upon the maniac in the act of scaling a transom from his cell. The slayer clubbed the guard to death with his bare fists, ripped the guard's keys from his uniform and then freed four other dangerous prisoners.

The five set upon Am-law, who was making his rounds, and slew him. Other guards who were in the night relief room barricaded themselves and sent out calls for help.

## Japanese Ship Taken by Pirates

Shanghai, Feb. 13.—(AP)—The first piracy on the north coast of China in two years brought forth two Japanese warcraft to recapture Japanese merchantmen from the pirates.

The Japanese steamer Hiraio Maru, outbound from Shanghai, encountered a steamer flying a Japanese flag accompanied by a Chinese junk near Hainan. The junk approached the Hiraio Maru and as it neared the ship it was seen to be filled with pirates.

The pirates fired on the steamer, wounding the captain and killing one sailor. The Hiraio Maru escaped and arrived at Tsingtao Sunday. The Japanese destroyed Tsuibaki from Port Arthur and the gunboat Tachibana from Tsingtao started on the trail of the pirates.

It was reported by wireless today that the Tsuibaki recaptured the ship from the pirates near Hainan after severe fighting. The Japanese steamer was identified as the Haisu Maru. It was presumed here that the vessel had been seized by the pirates. The fate of the ship's crew was not reported.

## FIFTY DEATHS RESULT FROM HEAVY STORM

### Western Europe Hard Hit by Terrific storm on North Atlantic Coast Today.

London, Feb. 13.—(AP)—Crippled shipping limped into port today, as the toll of a gale which swept western Europe on the north Atlantic over the week end was counted. It was feared that the death might mount to fifty. The loss of property was heavy.

Twenty five lives are known to have been lost in Scandinavia and nine in Great Britain. Accidents to shipping were just becoming known although the gale spent itself early Sunday.

After the dredge vessel Grinkle sank in the Jersey river six of the crew were missing and they were listed among the casualties today.

Houses were blown down, roofs carried away and a torrential rain fell at Liverpool with occasional gusts reaching 104 miles while on the opposite side of England at Plymouth it was only a gentle two mile breeze.

The British steamship Snadown Castle, from Tyn to New York, reported by wireless that it was returning to Cobh with the forehold full of water. The steamship American Farmer arrived at Plymouth 30 hours late. Its propellers were damaged four days out of New York and it made its way through heavy gales. The steamship Montclair reached Liverpool 2 hours late.

Radio reports told of a thrilling struggle between the tanker Varand and the sea on the ship's maiden trip from New Orleans to London. For 12 days the Varand has been in tow of the Dutch 'Tug Zwartee because of serious damage to its rudder, prop and propeller. The ship also sprung a leak. Towing the tanker through the heavy sea became so difficult that another Dutch tug, the Seine, went to the assistance. The hurricane completely disabled the Seine, carrying away the compass, rails, rudders and wrecking the wireless apparatus.

The liner Muenchen left her course to assist the crippled tug and two other Dutch tugs, which had previously run to the assistance of the liner Burgardic, also came to the aid of the Seine, which returned to Cobh under convoy. The Varand according to the latest advices was south of Ireland and still in tow.

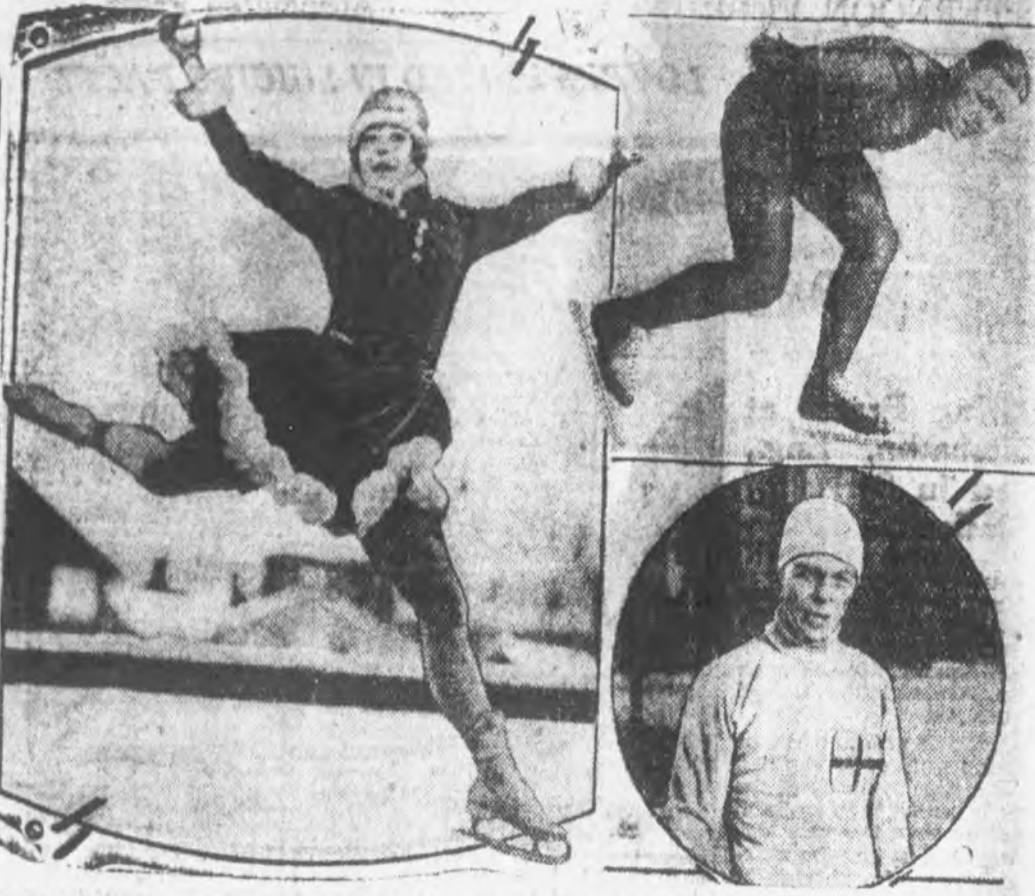

St. Moritz, Switzerland (AP)—Ringing up the curtain on the year's great program of international sport, more than 600 picked athletes representing 24 nations began competition in the winter Olympics here February 11 with all odds favoring the north countries of Europe to repeat their triumphs of four years ago.

While Norway and Finland, which finished one-two in 1924, are odds-on favorites to top the field in the week of varied and strenuous contests on Alpine ice and snow, contestants from the United States and Canada as well as Sweden, Switzerland, Austria and Great Britain are conceded a chance for victory in individual events.

Charlie Jewtraw, the great young American sprinter who won the 500 meter speed skating race in 1924, is not defending his title, but the United States skating contingent, captained by Valentine Blahis of Lake Placid, N. Y., has hopes of keeping it in the United States.

As in track, the Americans appear best in the short distance event. In the longer races, Clas Thunberg, the Finnish "Nurmi of the ice," seems almost unbeatable. Norway, which made a clean sweep of the skiing events four years ago, looms at least as strong here as does Finland in the skating races. Jaug and Thams, the Norwegian aces, are sure of some determined opposition, however, from the American team which boasts such performers as Charlie Proctor of Dartmouth College, Rolf Mowson, Springfield, Mass., and Anders Hauken, Chicago veteran, who scored the longest leap in the 1924 games, although given up the fourth place because of form.

In the women's figure-skating event, American has perhaps its best chance. Miss Beatrix Loughran of New York, runner-up to the Austrian, Mrs. Szabo-Plank, four years ago, has improved considerably since. Both probably will get some spirited competition from Norway's 15 year old sensation, Sonja Henie.

Another event which may go to New World Athletics is hockey, the past star force of Canada which now holds the championship. The "Varsity Grid" team representing the Dominion is a strong favorite in view of the overwhelming Canadian victory four years ago and absence of competition from the United States this year.

Great Britain, holder of the curling title, is favored to repeat in that sport while the Swiss, in their native Alps, perhaps have the best chance to win the bob sleighing event.

New York, Feb. 13.—(AP)—Lloyd Hahn, America's hope in the coming Olympic, seeks another world's record tonight, running in a special two thirds of a mile even at the New York Elks here in the 102nd engineers armory here.

Hahn, already the holder of four world's marks for indoor track events, will race against Jimmy Connolly of the New York A. C., who established the present standard for the two thirds of a mile in old Madison Square Garden in 1923. Connolly's time is 2:43.3-5.

Hahn, a Nebraska, now running under the colors of the Boston A. C., will race against Dr. Otto Peltzer, in the Knights of Columbus track games here on February 29. Ray Conger, who defeated Peltzer in a Chicago meet last Friday, is entered in the same event.

In more than thirty races during the past two years, Hahn has come through without a defeat. He has been victor in eight consecutive races this far this season.

Tommy Armour, national open titleholder, tied for the next place with Henry Clui, Bridgeport, Conn., and Leonard Schutte, of Little Rock. The trio had 289 each.

Bobby Chickschank, who was successfully defending his title, contented himself with 291. Prize money totaling \$5,000 was distributed.

SPORTS SLANTS

New York, Feb. 13.—(AP)—To judge from the reaction to the latest trade of the New York Giants the club has clinched first prize in the keep-the-boys guessing contest.

Without yet having solved to their entire satisfaction just why Hornsby was traded to the Braves, the experts now are puzzling over the latest deal that sends Burleigh Grimes to the champion Pirates in exchange for Vic Aldridge, the Hoosier schoolmaster. The Giants have taken their share of "riding" over the Hornsby deal and one of the assembled critics Saturday was bold enough to inquire whether "Charley Stoneham has taken John McGraw into his confidence" in trading Grimes.

Perhaps the explanations that the Giants prefer a curve ball pitcher who writes his own newspaper stuff to a spitball heaver with temperament. Both Aldridge and Grimes have had erratic and checkered careers under various banners. The Hoosier schoolmaster was both a hero and soot in the 1925 world series with Pittsburgh. Vic won his first two starts against the Senators. So did Walter Johnson and the setting was laid for a dramatic tussle when they hooked up in the seventh and deciding battle in the fog at Forbes field. But Aldridge "blew up" in the first inning, let in four runs with his wildness and passed unceremoniously from the picture. Old Hornsby stuck it out in spite of the terrific hitting off his delivery but was beaten and also lost the chance to join the immortal few who have three triumphs in one series to their credit.

The trading of Aldridge marks the passing from the Pirate fold of the last of their 1925 world series heroes. Max Carey was the all-around star, setting the pace at bat, but Mac became mixed up in the 1925 Pirate revolt, receiving his walking papers and now roaming the outfield for Brooklyn.

Kiki Cuyler's double off Walter Johnson was the deciding hit of the series, but Kiki likewise earned the enmity of the management and now is with the Cubs. Stuffy McInnis, whose steady influence on the Pirates defense and infield strategy turned the tide in their favor, hit the trail that all fading veterans do.

Grimes, one of the most effective twirlers in the league, when right, has had a career of ups and downs in 12 years of major league experience. His holdout tactics in the spring while with Brooklyn were as famous as his spitball offerings in mid-summer.

Last year Burleigh was a prime factor in the late season rush of the Giants toward the top, especially during their sensational western trip. But he offset some of this distinction by being belted all over the lot by the Phillies in a crucial game that ruined the last slim pennant hopes of the McGraw clan.

At seven months of age, my pig weighs 183 pounds. One can easily see by observing the other mates that my pig will weigh more than any four of the others together. A few days ago Prof. S. B. Simons, supervisor of vocational agriculture suggested that I try and produce a ton litter of pigs. After thinking over his suggestion and talking the matter over with Prof. Setzer and my father, I have determined to be the first boy in our school to raise a "ton litter."

One of the outstanding features of vocational agriculture is that all the boys conduct a home project based on the type of work studied in school. By conducting my own project, I have come to have great confidence in my ability to raise hogs. I know the instruction received is practicable. In my opinion the study of vocational agriculture is not only instructive but also very interesting.

# ABOUT TOWN

In the opening session of the Hi-Y conference which closed a three day session in this city yesterday afternoon, Rev. L. R. O'Brien, pastor of Emmanuel Baptist church, told the young men that the physical, mental, social and spiritual development of man is one of the greatest problems of the present era.

"Being young, strong and ambitious and zealous for higher things of life, you are naturally concerned with the requisites which go to make life worth living—the fourfold, the symmetrical man—the whole man.

"We may increase or decrease our potential capacity for development and usefulness. A clean, strong enduring body therefore is a wonderful asset. We are working day by day to perfect the ideal man.

"To think clearly we must act wisely. Too few of us realize the power of thought over action. If we think in terms of good, improvement in standards of morality will naturally result. But, if on the other hand, our thoughts deal with things of a lower plane, then we may expect nothing more than to pass through a period of deterioration.

"Sow an act and you reap a habit; sow a habit and you reap a character; sow a character and you reap a destiny. This quotation is as true today as it was yesterday, so if we would perfect ourselves, mentally, physically, socially and spiritually, we should be careful of the way we use opportunities offered by each succeeding day."

"The Greenville tobacco market has doubled in size in the last four years," a member of the Tobacco Board of Trade remarked today, after going over statistics made public by the market.

"Selling slightly over twenty-four million pounds of bright leaf in 1924 the market has expanded to such extent that it was able to nearly reach the sixty-two million pound mark, which does not include scrap and handled by the factories and over 150,000 sold since the closing date.

"With this splendid record before them, members of the Board of Trade will this year strive to reach the seventy million pound mark. Many improvements will be made among the warehouses and factories so that the greatest offerings of the season may be handled rapidly and with the greatest dispatch.

"Greenville is located in the largest bright leaf growing country in the world and there is no reason on earth why it should not become the greatest market in the world. With possibilities of the most inviting kind urging us along, the future bids fair to see our greatest ambitions assume more concrete form.

"Faith in ourselves and the unspeakable riches contained in our prolific soil will be one of the greatest assets in the program of expansion we have before us. Let us forever keep this fact before us and strive to convert dreams into actualities.

"The eye of man, aided by science, has at last been able to peer across the Atlantic," a reader of this column remarked to the writer today, after reading the account of the recent test in television made by John Baird in London.

"In the television, Baird, who is one of the greatest of British inventors, showed the images of man and women sitting fully 3,000 miles away. The images, naturally, were crude, but they were there and what is more they demonstrated that this weakening of the scientific world holds forth great possibilities today than ever was anticipated or dreamed of before.

"Television, like radio, will have a long, rough road to travel before it is perfected, but that it will eventually become the marvel of the world, I have not the slightest idea."

"Instead of shipping four car loads of hogs to western markets this year, it begins to look like we are to be able to ship at least eight carloads," members of the Pitt county Board of Agriculture told the writer this morning.

"This will be one of the largest shipments in the history of the country. It will bring a considerable sum of money to our farmers, and will assist them materially in providing for the financing of next summer's crop of tobacco.

"The hog hominy program adopted by the department sometime ago is meeting with unexpected success. Should we be able to continue as we have started, then the future holds forth great possibilities for development of hog raising, poultry raising, etc.

"Our growers should receive all encouragement possible in this direction because such activity increases the financial greatness of the locality and assists our people in meeting obligations which they would not otherwise be able to meet."

"Water transportation with its accompanying lower freight rates affects every business individual in our city and community, and again we urge that you give this matter serious study, and when the time for the meeting arrives, be on hand and let your views be known."

**THE FARMER'S EFFICIENCY**

Not infrequently we hear it said that the real cause of the farmer's troubles is his inefficiency, and that if he would only adopt the well-tested methods of the business man he would soon be out of the woods. That is something we have always doubted, for the reason that we have seen a number of eminently successful business men try their hands at farming. They undertook to apply their well-tested methods to agriculture, only to find that their farms were useful devices for reducing their income taxes. We concluded then, that the real dirt farmer knows a thing or two which even the business man does not know.

And now we are comforted at seeing this opinion confirmed by the researches of the National Industrial Conference Board. Its studies acquit the American farmer of the charge of inefficiency. It finds that the average output per farm worker increased 47 per cent during the period 1899-1925. In this same period the increase per factory worker increased to 49 per cent.

So, in spite of all the industrial miracles of our Henry Fords, the farmer has managed to keep quite well abreast of the manufacturer, so far as improved production goes. Indeed, his productive efficiency has been one cause of his troubles. He has been overpro-

ducing. For that matter, many manufacturers have been doing the same. But they have the advantage over the farmer in that they can shut down the plants or work on part time until surplus is reduced. The farmer cannot do that, but that is not his fault. If anybody is to blame, it is not the farmer, but nature. — New York World.

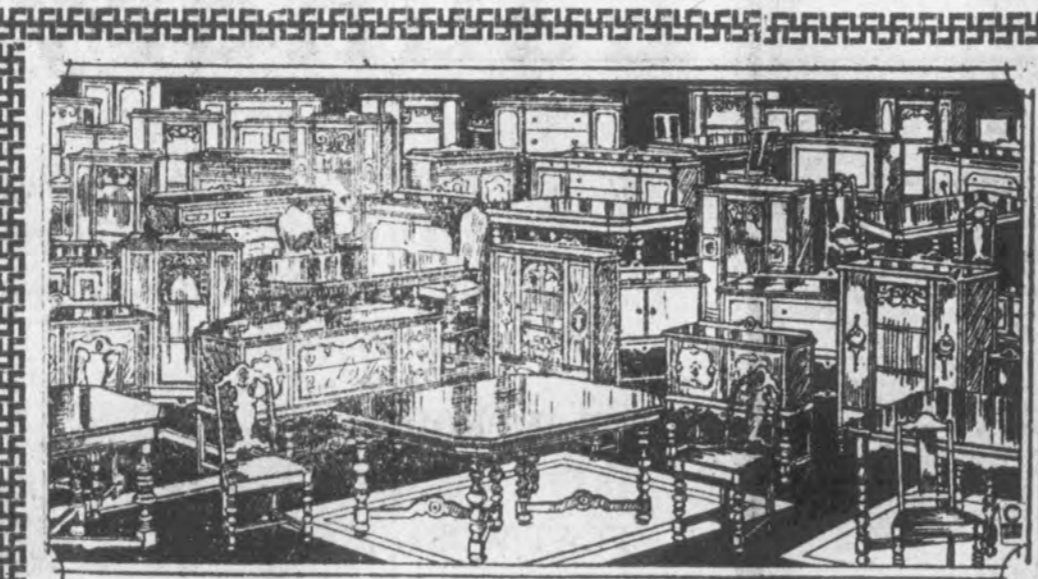

### New York Markets Closed in Observance of Lincoln's Birthday

### Stephenson May Be First Witness In Jackson Trial

Indianapolis, Ind., Feb. 13.—(AP)—Belief that D. C. Stephenson, life prisoner and former Ku Klux Klan grand dragon, would be the first witness for the state in the bribery trial of Gov. Ed Jackson, became general today when it was learned that Prosecutor Will H. Remy and Emsley L. Johnson, his special assistant held a sudden conference at Remy's home last night.

Selection of only one juror was necessary before testimony could be offered. Eleven jurors had been chosen Friday when adjournment was taken over the week-end.

Although neither Remy nor Johnson would comment on their conference, it was understood it had to do with the advisability of having Stephenson testify. Stephenson while grand dragon was said to have been friendly to Jackson when the latter was making his campaign for governor. Since his conviction, however, Stephenson has snuggled statements from his prison cell denouncing Jackson and making charges of political corruption in Indiana. Jackson's indictment grew out of investigation of the charges.

Stephenson was named in the indictment as having been a party to the alleged conspiracy to bribe former Governor Warren T. McCray to appoint James E. McDonald as Marion (Indianapolis) county prosecutor in 1923.

### Aged Woman Dead

Charlotte, Feb. 13.—(AP)—Mrs. Kathleen Wentz, 79, died here today at the home of her niece, Mrs. C. H. Bradshaw. She suffered a stroke of paralysis about fourteen weeks ago.

Funeral services will be held tomorrow afternoon at 2 o'clock at Moore's chapel.

Surviving Mrs. Wentz is her niece, Mrs. Bradshaw and one brother, J. A. Lybrand, of Shelby.

### George Not Yet Notified

Washington, Feb. 13.—(AP)—Senator George, of Georgia, still was without official notification today of the action of the Georgia state central executive committee in authorizing the appointment of delegates from his state to the democratic national convention at Houston in June.

Four hundred rebels took part in the fighting which lasted four hours.

### Columbia, S. C. Passes Through "Blue" Sunday

Columbia, S. C., Feb. 13.—(AP)—Resumption of Governor Richards Sunday law enforcement program after a year's intermission was marked by a modified "blue Sunday" in Columbia yesterday, contrasting sharply with the six air-kiss Sundays experienced by the capital city early in 1927 when the chief executive's campaign against Sunday golf and selling of gasoline and other commodities was at its height.

Most of the filling stations were closed. Some that remained open required of every purchaser a signed statement that the fuel or other supplies desired were "necessary," drug stores, fruit stands, and hot dog establishments appeared to stay open as usual. So far as had been reported, early today there were no signs made for alleged violation of the state's ancient Sabbath-observance statutes.

### Present Stewart Charge to Jury

Washington, Feb. 13.—(AP)—The government has about completed the task of laying before the federal grand jury facts concerning the refusal of Robert W. Stewart, chairman of the board of the Standard Oil Company to answer questions before the Senate oil committee.

All that remained to be done is to place before the jury documents concerning the naval oil leases, executive orders concerning them, a witness from the Interior Department to establish facts of the leases, and to hear J. J. McGrain, deputy sergeant-at-arms of the Senate.

District Attorney Gordon said today it would take several days to prepare an indictment if the grand jury acted.

### ABANDON HOPE FOR NAVAL TUG CREW

Boston, Feb. 13.—(AP)—Hope for three members of the crew of the wrecked naval tug Mohave who fled the craft in a punt after she piled up on Harding ledge last night was diminished when the punt was found today washed ashore off Black Rock, Cohasset, nearly three miles from the scene of the wreck.

The punt was right side up but filled with water. The remainder of the crew was rescued. The men were W. J. Ends, C. H. T. Reid and L. L. D. Liles.

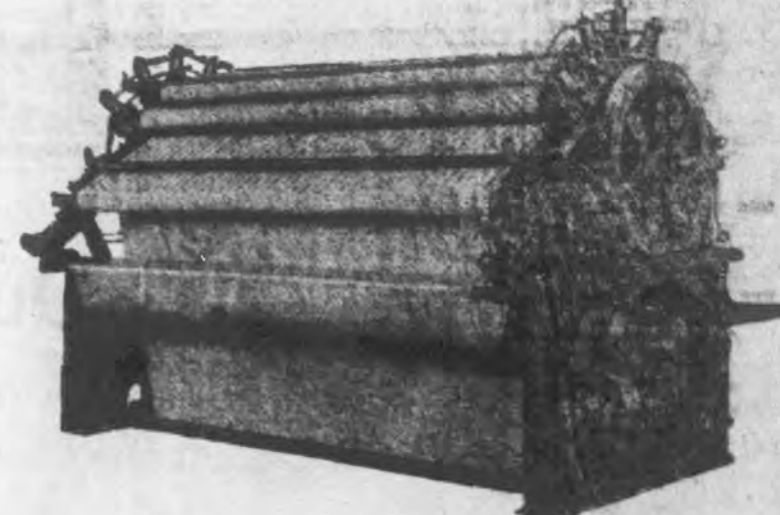

# LINDY HITS LONG TRAIL HOME TODAY

## American Flying Ace Expected to Reach St. Louis at Two O'clock Today.

Atlanta, Feb. 13.—(AP)—Fog and rain prevented the south from checking the flight of Colonel Charles A. Lindbergh today from Havana to St. Louis.

Radio stations, wireless outposts and newspapers combed the country for word of the Spirit of St. Louis, but up to this afternoon, no definite information had been received of the aviator since he took off from Havana this morning at 2:25 o'clock.

Only one report of an airplane that might have been that of the "Lone Eagle" was received during the morning. This came from Sarasota, Fla., near the west coast. It was a radio message picked up by Lieut. Justin Lee, of Orlando, Fla., of the United States Naval Reserve over an amateur set from a fellow officer in Sarasota which told of an unidentified plane passing above the clouds there at 6:50 a. m. It was flying in a northerly direction, the message said, and the motor was distinctly heard.

The Associated Press, through radio stations of member papers, asked the radio audiences to report Colonel Lindbergh's passage but none had done so this afternoon.

Weather forecasters along the expected route said Colonel Lindbergh would encounter fog and rain all the way to St. Louis.

Havana, Feb. 13.—(AP)—Lindbergh was following the long trail home today.

His good will flight completed, Colonel Charles A. Lindbergh hopped off from Columbia flying field at 2:26 a. m. this morning for his home port of St. Louis, a flight of the straits of Florida as Lindbergh headed over them on the only water jump of his flight to Key West, Fla.

As the Spirit of St. Louis left the dimly lighted field only the steady throb of its motor traced its course to the open sea. From Key West Lindbergh's route led along the Gulf of Mexico to a point south of St. Louis from there it turned north to that city.

The plane was loaded with 225 gallons of gasoline, half its capacity. It was estimated that this would carry Lindbergh for twenty hours. The flight, the fourth long run in his career, was expected to last at Lambert field, St. Louis, east after two o'clock this afternoon. The three flights which have exceeded the present distance were: New York to Paris, 3,800 miles; Washington to Mexico City, 2,200 miles and San Diego to St. Louis, 1,530 miles.

Cheers rose from the spectators on the field as the flyer swept over them, leaving behind a message of good will and enshrined in their hearts. Miniature flags of thirteen countries visited on this tour painted on the fuselage of the Spirit of St. Louis, attested the affection of Latin-American for "We." These represented Mexico, Guatemala, British Honduras, Nicaragua, Honduras, Salvador, Costa Rica, Panama, Colombia, Venezuela, the Dominican republic, Haiti and Cuba.

Lindbergh also made stops at two United States possessions, Porto Rico and the Virgin Islands. Lindbergh, fit and smiling, arrived accompanied by Ambassador Nobel Brandow Judah and Mrs. Judah at 1:50 a. m. the Cuban band struck up a lively march and the spirit of St. Louis was sheeled from the hangar, while the flyer walked about the field hunting a suitable place for a take off.

He returned to the plane, stowed his luggage and a few sandwiches aboard and taxied to the far end of the field at the opposite end from the hangars. Ambassador Judah and Mrs. Judah followed him in an automobile lighting the way.

He started from the Polo field and as the plane sped over the bumpy ground, it passed close to one of the goal posts. Half way down the field he was in the air and rushing along just raised the plane to clear the hangars. The spectators and a large number of the Cuban flying corps cheered and threw their hats into the air.

For fifteen minutes the sound of his motor was heard as he circled around apparently seeking his bearings. Lindbergh made a final circle over the field and gave three flashes of his signal lights in farewell to Ambassador and Mrs. Judah.

Immediately after the take off Captain Laborde, Lindbergh's Cuban aide, announced that he was worried as a strange rustling sound came from the plane and his thought the motor might not be functioning properly. The lights of the escorting automobile were maneuvered to provide the best illumination possible in event of a landing.

Fears were soon dispelled, however, when a steady whir indicated that the motor was functioning properly. After assurance of Lindbergh's safety was signalled to spectators the crowd started to melt away. The field was darkened. Another chapter had been added to the history of aviation and a new one begun.

St. Louis, Feb. 13.—(AP)—Colonel Charles A. Lindbergh, who one year ago today took off from Lambert-St. Louis on his last air-mail trip to Chicago, was eagerly awaited here at the same field after taking off from Havana, Cuba, on a non-stop flight of approximately 1,200 miles.

Although it was his third homecoming since his epochal flight to Paris the enthusiasm of the city which sent him forth had not abated but the joyous outbursts of feeling had turned to a steady glow of pride and concern for the flyer and his achievements.

# MRS. GATLIN'S TRIAL BEGINS

## Reidsville Girl Goes On Trial in Connection With Death of Her Father.

Wentworth, Feb. 13.—(AP)—Pale from her confinement of five months in jail but speaking in a firm clear voice, Mrs. Alma Petty Gatlin, 29 year old, Reidsville girl, shortly before noon today was arraigned in Rockingham superior court and pleaded not guilty to the charge of murder growing out of the death of her father, Smith T. Petty.

Mrs. Gatlin was brought from the county jail a few minutes before her arraignment at a special term of court called to dispose of her case. Her friends said she had lost some weight during her confinement but appeared otherwise to be unchanged.

The young woman, accused having slain her father as he sat at breakfast nearly a year ago and then buying his body in the cellar of their home, remained in the courtroom after the arraignment, although the court busied itself with the docket and other matters preliminary to the term.

A special venire of 200 men was called this morning from Rockingham county and if the jury cannot be obtained from this number it was said that a panel would be called from Stokes county.

## Rockefeller Warns Against "Sharp" Business Practice

New York, Feb. 13.—(AP)—John D. Rockefeller, Jr., back from Washington where he testified in the senate's Teapot Dome investigation, warned of "sharp" business. He did not mention the oil inquiry.

Mr. Rockefeller, whose talk was broadcast by station WJZ listed integrity, obedience to law, clean living, loyalty and the four fundamental qualities underlying character.

"Is there anyone of them that can be omitted or ignored without hazarding control business success?" he asked, "it is true that money is often made by trickery and sharp practice, but successful business is not established on a foundation so 'Regretfully must we admit,' he said, 'that instances are not lacking of corporations and individuals who act themselves up as superior to law. But when condemned as they are sure to be in the court of public opinion, even the most worldly-minded is bound to ask himself 'does it pay?' and to admit that no business can be permanently successful which is not law abiding."

So long as it remains the law of the land it should be obeyed. The alternative is anarchy."
