## CONGRESS IN QUANDRY OVER FARM MEASURE

### With Day off, Members of Both Houses Thinking About McNary Issue.

Washington, April 7.—(AP)—Congress took a day off today, but its members had some pre-Easter home thinking to do about the pending Farm Relief legislation.

Just about the time both houses quit work on yesterday, it developed that President Coolidge felt the new edition of the McNary-Haugen bill, which he voted last year on the ground that its much debated equalization fee was unconstitutional, did not meet all the objections he had in the former measure.

Whether the fee provision was what the President had in mind was not made known, although this item is known to be included in several phases of the question now being considered by the executive and his counselors.

There have been some claims that Mr. Coolidge would veto the revised bill and others that it would meet executive approval because of its alternate section relating to the equalization fee. Such predictions are not warranted at this time, the President feels, because the proposal is not yet in its final form. And before it reaches that stage, its sponsors are going to have some amendments to contend with from the Democratic side, minority members blocked efforts yesterday to set Tuesday for a final revision which they believe is essential. Supporters of the bill, however, do not anticipate these will be radical enough to delay a vote which some hope to reach by Wednesday.

According to a vote Tuesday included Senator Simmons, North Carolina, Bill Washington, and McKellar, Tennessee, all Democrats. The latter expects to propose a change to limit the power of the proposed Federal Farm Board to utilize the equalization fee.

## Broadway Star Defiant After Her Suspension

New York, April 7.—(AP)—Jeanne Eagels, star of "rain" and "her carboard lover," felt certain today that "no handful of actors" could keep her off Broadway. This was her reply to the actors' equity association which suspended her for a year and a half and fined her two weeks' salary, approximately \$3,600.

The penalty resulted from her failure to appear in the cast of "her carboard lover" at St. Louis, forcing the show to close. She said she was ill and unable to appear.

"No handful of actors for whom, with a few exceptions, I have no respect, can keep me off Broadway," the actress said when informed of the suspension. "I'll be back in a new play by Christmas."

Sam H. Harris, who has a contract with Miss Eagels to appear in a new production next October, eleven months before the suspension expires, indicated she would work under that contract when it became operative.

"She will act in my new play," he said.

## Bank of France Not To Seize Russian Gold

Paris, April 7.—(AP)—There is little likelihood of seizure by the Bank of France of the \$5,000,000 Soviet gold now aboard the *Daguer* off New York when the vessel touches at Cherbourg en route to Germany, semi-official quarters declared.

It is pointed out that while the Bank of France has laid claim to the gold in American courts, no action has been started in France and there exists no writ whereby such a shipment in transit and not consigned on the French coast could be legally halted.

## SNOW STORM PLAYS HAVOC IN NEBRASKA

### Hundreds of Men at Work today Attempting to Normalize Telegraph Service.

Omaha, Neb., April 7.—(AP)—An April snow storm that cost communication companies thousands of dollars, brought the boon of moisture to thirsting wheat fields and wrote new records on the weather bureau books, had the wrecking crews busy today in eastern Nebraska.

Hundreds of workers spent the night in an effort to normalize telephone and telegraph service and clear the arteries of travel.

Business in Omaha and across the river in Council Bluffs, Iowa, stood still yesterday when the seven-inch snowfall halted street cars and paralyzed communication. Radio gave the only touch with the outside world for several hours, radio amateurs and the United States Army stations joining regular broadcasting stations in placing their facilities at the disposal of press associations.

Lincoln, Nebraska, had 10 inches of snow, a record for this time of the year. At Omaha temperatures ranging between 35 and 40 prevailed during the day, dropping early today to below freezing.

It was estimated by officials of the Northwestern Bell Telephone Company that their loss would be more than \$200,000 with a total of 2,700 poles down in the entire storm area, thousands of miles of wires out of service and more than 2,700 phones out of order in Omaha alone.

Value of the snow to growing wheat and its benefits to the soil is inestimable, according to agricultural experts. The snow melted rapidly and better moisture distribution was affected than would have been the case if rain had fallen. It was explained.

Of Napoleon, it was said that in his youth "no one ever saw him laugh." He didn't live ninety-three years, but he did live more in one day than amiable Mr. Depew in all his ninety-four years.

Chauncey Depew attended 8,000 banquets and never felt boredom drive him into eating too much. That's wisdom.

He campaigned for Lincoln, got \$1.75 for his first legal services, lived under twenty-four presidents, from Andrew Jackson to Calvin Coolidge, and knew thirteen of them personally. ## Family of Eight Either Slain or Burned to Death

Cisco, Tex., April 7.—(AP)—Eight persons, two adults and six children, all members of the family of Boss Jackson, farmer, either burned to death or were slain before their country home was destroyed by fire last night. Sheriff Hart of Eastland county said tonight Chief W. C. Wilson of Cisco, who was called to the scene, said the condition of the bodies of the children caused them to think they had been slain before the fire started.

A. C. Green, mortician, to whose establishment the bodies were taken, said the bodies were burned so badly it was difficult to determine what might have caused the death.

## ATTEMPT TO GET BEARING ON POLITICS

### Chicago Voters Give Ears Rest and try to See What Political Storm Is About.

Chicago, April 7.—(AP)—Chicago voters today gave their ears a rest and attempted to get their bearings in the political storm which has raged here for several weeks while candidates of two opposing Republican factions sought nomination in the state-wide primary elections next Tuesday.

Leading candidates on both the Lowden-Densen and Thompson-Small sides delivered virtually the last word as the active campaign closed in Chicago. Secretary of State Pearson, who opposes Gov. Small, seeking re-nomination for a third term, has left Chicago and was scheduled to make addresses in Champaign and Urbana today.

Mayor Thompson reiterated his statement that he "would seriously consider resigning if Swanson is elected." He referred to Judge John A. Swanson, candidate for state's attorney on the opposition ticket.

Judge Edmund K. Jarecki, in charge of county election machinery, stated that the possibility of frauds at the primary was small.

"While I do not anticipate an ideal election," he said, "it will not be as disorderly as many persons suppose." He made known that plans were being perfected for the mobilization of 5,000 police and several thousand volunteer watchers at the polls.

The board of election commissioners, said they were considering plans to protect ballot boxes against theft with tear gas devices similar to those in use in bank vaults.

Orders were issued also to members of the prohibition forces in Chicago warning them to quit politics or face removal. Seymour Longman, assistant secretary of the treasury in charge of prohibition enforcement, said: "An office shall not use his official authority to influence or coerce the political activity of any persons or body. An officer who spends a portion of his time in talking politics is neglecting his work and engaging in a political activity which will not be tolerated."

Following the church ceremonies, the funeral cortege, escorted by police, proceeded uptown and through the Hudson river towns to Peekskill, for interment in the family mausoleum just outside the village. Peekskill suspended all activities during the interment.

## SAY HOOVER AND LOWDEN ARE LEADING

### Two Corn Belt Republicans, However, Unable to Determine Which is Stronger.

Washington, April 7.—(AP)—Two House Republicans from the corn and wheat belt—Dickinson of Iowa and Newton of Minnesota—engaged today in a debate on paper as to whether Lowden or Hoover would be the stronger nominee for President.

It revolved around Governor Al Smith of New York, who is out ahead in the race for the Democratic nomination, and the possible trend next November in the farming regions.

In a formal statement, Dickinson assumed that Smith would be the Democratic standard bearer and declared that the Republicans, to win in November, must turn to Lowden.

Coming back in another statement, Newton insisted the wise and only course for his party is to nominate Hoover. He contended the commerce secretary not only has strength in the industrial east but in the farming west.

The Iowa used figures to support his prediction that Smith would win at the polls against Hoover, but would lose if pitted against the former Illinois Governor.

With 268 electoral votes needed for the election, Dickinson figured that against the commerce secretary Smith would pile up 327 votes, Hoover 204. Against Lowden, he gave the New York Governor only 209 electoral votes, Lowden 322.

As the Iowa put it on paper, Lowden would carry eleven states, where the farm vote is a factor, that would be lost to the Republicans if Hoover were nominated. He declined to concede a state to Hoover that he did not place in Lowden's column.

"From the trend of the present day," said Dickinson, "it must be assumed that Governor Al Smith will be the Democratic opponent. Anyone skeptical about Smith's nomination need but examine the caucus returns from a few of the states in the middle west to realize that his nomination cannot be stopped."

"The Republicans line of defense must be drawn accordingly. In the east Republican uncertainty is conceded, and with the general trend toward unemployment, Smith will fare even stronger than present day predictions. With Republican weakness in the east, we can only hope to win with Republican strength in the middle west."

"If the Republican nomination is made without a candidate favorable to farm legislation, it immediately places in the doubtful column several states upon which the Republicans must rely in order to be assured of success."

Pointing out that Dickinson was conceding that Lowden could not carry New York, New Jersey, Connecticut, New Mexico, Rhode Island and Massachusetts, Newton, who is one of the Hoover stalwarts in the House, declared the Iowa representative, "does his candidate an ill turn by such a disclosure to the public."

"He should communicate such information confidentially to the party leaders," declared Newton, adding:

"Mr. Dickinson states that Mr. Hoover, if nominated, will carry Kansas, Iowa, Minnesota, Michigan and other pivotal agricultural western states. He is right about this, but it does not accord with the current propaganda of his colleagues in the Lowden campaign. He, however, simply confirms a manifest fact, and if he will add that Mr. Hoover will carry the eastern states by the largest vote in history, he will then be right as to his conclusions."

## N. Y. HONORS DEAD CITIZEN

### Final Tribute Paid Chauncey M. Depew by Bustling Metropolitan of Nation.

New York, April 7.—(AP)—Bustling New York paused in its activities today to pay its final tribute to the memory of one of its oldest and most beloved citizens, Chauncey M. Depew, "the man without an enemy."

Fifth avenue was hushed in the vicinity of 53rd street as the funeral services were held at St. Thomas' Protestant Episcopal Church. Just around the corner from the Brownstone mansion where the 93-year-old statesman, railroad executive, wit and orator, died on Thursday.

Inside the church were gathered some of the most distinguished citizens of the country. They represented great business and social organizations with which Mr. Depew had been associated for many years. Every pew was occupied and many stood in the rear of the church.

The solemn, impressive ritual of the denomination was in charge of old time friends—Bishop William T. Manning of New York and the rector, the Rev. R. T. Brooks. The vested boys choir of the church sang.

Following the church ceremonies, the funeral cortege, escorted by police, proceeded uptown and through the Hudson river towns to Peekskill, for interment in the family mausoleum just outside the village. Peekskill suspended all activities during the interment.

## Chinese Reds Massacre Many

Canton, China, April 7.—(AP)—Advices from the Yenchun and Yeungkong districts, 140 miles south of Canton, today said that inhabitants had been massacred by Reds who were in control there.

Three thousand extremists captured the cities and set them afire. All males more than 40 years old were slain, women defamed and infants burned.

The Canton government troops, which have been suspected of communist sympathies, ignored orders to go to the district and reinforce troops already there.

Canton itself was quiet today.

This conference caused Boston fans to wonder if Hornsby was to be made manager captain and leading batsman, but the president disclaimed any intention of letting Slatery go before he starts.

## Ray Keech, In Four-Ton Car Seeks Record Held By Briton

Daytona Beach, Fla., April 7.—(AP)—Action of favorable winds, tending to smooth out the marcel-like waves in the beach sand here, today awaited by Ray Keech, racing driver, who planned to attack the world's automobile speed record as soon as the hard packed sands were level enough for safety.

Keech said last night that if the beach continued to improve as it had in the 24 hours previous he would make a run today, at low tide, between 3:30 and 4 p. m. against the 206.9 miles per hour record now standing.

Daytona Beach, Fla., (AP)—Ray Keech, young racing pilot who drives a giant 36-cylinder car as Ben Hur drove a chariot, has arrived here to renew the battle of speed against time on the burning sands of Daytona Beach.

For the second time in about six weeks he intends to send his great machine roaring down this natural machine roaring down this natural speedway in an attempt to break the world's record of 206.95 miles an hour set February 19 by Captain Malcolm Campbell of England.

At that race meet, misfortune followed the two American drivers—Frank Lockhart and Keech. Lockhart lost his chance when his Stutz Blackhawk swerved and hurtled into the ocean, injuring him, and Keech in the monster Triplex Philadelphia nearly lost his life when scalded by steam while making an estimated speed of 250 miles an hour.

Keech's attempt was unrecognized by the American Automobile Association because the machine had no reverse gear, but one now has been installed and the four-ton machine is all set for its new record assault. Keech has captured the imagination of speed bugs hereabouts. They like him to Ben Hur and to Caesar, perhaps because of the careless power of his pose at the wheel and the firm set of the jaw as he guides the monster annihilator of space.

This cool young man is 27 years old, lives in Philadelphia, was married in 1920 and has two children. He has been Eastern States champion for two years and is one of the best of the country's dirt track drivers. His machine is built on the heavy-duty principle with three mighty Liberty motors totalling 1,500 horsepower holding it down as well as giving motive power.

In his February test Keech proved the machine was remarkably easy to hold in a straight line at high speed and also that its engines are capable of driving it considerably faster than the record.

Despite his narrow escape, Keech is eager to trust himself again to the mercies of the huge mass of steel and rubber on which he bases his record hopes.

## N. Y. FANS CAUSE MUCH SPECULATION

By ALAN J. GOULD (AP Sports Editor)

New York, April 7.—(AP)—The poor showing of the New York Yankees in their spring training games has failed to shake the confidence of the big majority of experts that the world's champions again will lead the American League parade.

These newspaper critics may be riding for a fall, as most of them did last year when they picked the Athletics to win, but 85 per cent of these polled by the Associated Press this spring are convinced that Babe Ruth and his mates will repeat.

Forty-two out of 49 writers and sports editors who contributed their opinions to this second annual consensus of the Associated Press pick the Yankees to make it three straight pennants. Tossing out the results of southern exhibitions, these critics believe that even though the race this year may be closer than in 1927 when the Yanks finished 19 up on their nearest rivals, there is no reason to doubt that the powerful attack of the New Yorkers will again be dominant.

Of the handful of experts who predict the Yankees will be bumped off their high perch five select the Athletics led by Cobb and Speaker, as pennant winners, while two name the Washington Senators as first choices.

This minority places the Yanks second in six selections and third in one list. In sharp contrast to the National League selections, where the Pirates are choices in a wide range of opinion, there is remarkably little difference of opinion about the rating of American League clubs. In fact they are picked right down the line to finish exactly as they did last fall. The Detroit Tigers round out the first division in the consensus, and a pennant contending "Big Four" that is conceded a big edge over the other half of the circuit. In fact only four critics think well enough of the chances of any of the other teams to pick them for first division berths. Three of these ballots go to the Chicago White Sox and one to the Cleveland Indians.

Washington, April 7. — (AP) — Washington society is fully prepared for a particularly brilliant post-Lenten season which starts off with the annual breakfast at Friendship, suburban home of Mr. and Mrs. Edward Beale McLean, and proceeds unabated for several weeks.

The McLean breakfast on Easter Sunday is a tradition, having been instituted by Mrs. John R. McLean more than thirty years ago, and embracing as guests the President and First Lady of the Land — the President and Mrs. Coolidge have been guests there several times — members of the Cabinet, the higher ranking officials of the government and all of the ambassadors and ministers from foreign countries and their families.

It is an old fashioned repast of hot waffles, honey, dainty salads and such things, but especially waffles.

When Theodore Roosevelt was President, he and Mrs. Roosevelt accepted the McLean invitation.

In passing out of official life in Washington — as all officials must sooner or later do, either by death or defeat, Mrs. William Howard Taft, whose position can only be taken from her by the death or resignation of her husband, Chief Justice of the United States, will leave behind her the most beautiful memorial the capital has ever known, the flowering Japanese cherry trees which now invigorate thousands of tourists to the city.

Every morning and afternoon Mrs. Taft herself circles the basin in Potomac park in which are reflected the blossoms, and with her friends, she enjoys the longer drive about Haines Point along whose roadway the later blooming trees are planted. The trees are not expected to be in full bloom until next week.

The Ambassador of Japan and Mme. Matsudaira and their family resort to the driveway every day to drink in a little home atmosphere and always the members of the ambassador's staff visit the scene and frequently pose for tourists under the blooming boughs.

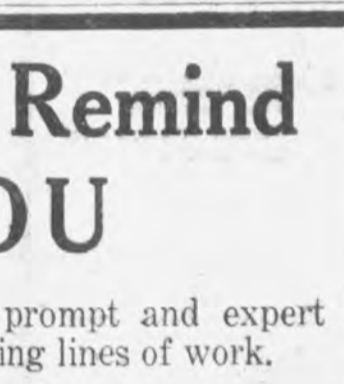

WELL KNOWN NEGRO PASSES AWAY HERE. Robert L. Kearney, colored, 60, who died at his home on Clark street, Monday night, will be buried Sunday afternoon at Cooper's field.

Curtailed production was increased about seven per cent among mills making narrow sheetings. Fine goods mills are averaging 25 per cent; colored goods mills 25 per cent.

It is believed that the sales last month closely approximated the curtailed output, and it is expected that fall prices on gingham will be made in the next couple of weeks.

Weekly Stock Report. New York, April 7.—(AP)—Speculative interest in this week's markets was divided between the continuation of the sharp upward movement of stock prices and the collapse in crude rubber quotations to the lowest levels since 1924.

The advance in stock prices took place in the face of a series of ordinarily adverse market developments. These included a huge increase in brokers' loans, which are now at record high levels; a falling off in freight car traffic, an increase in crude oil production, further exports of gold, stiffening money rates, commission of the U. S. rubber preferred dividend and indications that the reduction in federal taxes would be less than previously expected.

There were a few off-setting developments, most important of which was the reported agreement of eastern railroad executives on a four trunk-line consolidation plan. The increase in the regular Atchafalpa dividend from \$7 to \$10 annually and the optimistic statements on business conditions by Walter Chrysler, automobile manufacturer, and President Parsons of the F. W. Woolworth Company helped to maintain bullish enthusiasm.

The break in rubber followed the announcement of Premier Baldwin that British export restrictions would be abandoned on November 1 next. Crude Rubber dropped five cents a pound the first day and two cents more the second day after the announcement, touching a new low level around 19 cents, but it made partial recovery later. Rubber shares were weak in sympathy.

Airplane stocks featured the trading on the New York stock exchange, both Wright aeronautical and Curtiss soaring to new high levels on buying influenced by expectations of large government and private contracts. General Motors

was sluggish early in the week but started forward at a brisk pace on Thursday on reports that a new pool had been organized in that issue. Other motors advanced in sympathy, Packard mounting to a new peak price. Radio was reactionary most of the week. Officials of the exchange announced after the close Thursday that no further reports would be required of detailed transactions in the stock, indicating that the recent investigation had failed to disclose evidence of the "technical corner" believed to have been created when the stock started on a wild rampage about a month ago. Steels were lagged this week. Public utilities presented several points of strength, particularly among the New York traction and gas shares. Oils were under steady accumulation with sharp advances in Atlantic Refining and Richfield Oil of California among the features in that group. Railroad shares gave one of the most impressive demonstrations of group strength, the general average mounting to a new high level for the year. New peak prices for the year, or longer, were registered by a number of issues including Washab, Texas and Pacific, Pittsburgh and West Virginia, Baltimore and Ohio, Western Maryland common and second preferred and Lackawanna.

Higher Wheat Prices Predicted. Chicago, April 7.—(AP)—Freezing temperatures predicted for tonight over much of the domestic wheat belt led to higher prices for wheat today after hesitancy start. Selling of wheat on account of additional rains had only a transient effect. Opening unchanged to 1-2 65-6c off, wheat soon rose all around to above Thursday's finish. Corn, oats and provisions were also stronger, corn starting 1-4c to 5-8c up, and subsequently holding near to the initial range.

Weekly Stock Report. New York, April 7.—(AP)—Speculative interest in this week's markets was divided between the continuation of the sharp upward movement of stock prices and the collapse in crude rubber quotations to the lowest levels since 1924.

The advance in stock prices took place in the face of a series of ordinarily adverse market developments. These included a huge increase in brokers' loans, which are now at record high levels; a falling off in freight car traffic, an increase in crude oil production, further exports of gold, stiffening money rates, commission of the U. S. rubber preferred dividend and indications that the reduction in federal taxes would be less than previously expected.

There were a few off-setting developments, most important of which was the reported agreement of eastern railroad executives on a four trunk-line consolidation plan. The increase in the regular Atchafalpa dividend from \$7 to \$10 annually and the optimistic statements on business conditions by Walter Chrysler, automobile manufacturer, and President Parsons of the F. W. Woolworth Company helped to maintain bullish enthusiasm.

The break in rubber followed the announcement of Premier Baldwin that British export restrictions would be abandoned on November 1 next. Crude Rubber dropped five cents a pound the first day and two cents more the second day after the announcement, touching a new low level around 19 cents, but it made partial recovery later. Rubber shares were weak in sympathy.

Airplane stocks featured the trading on the New York stock exchange, both Wright aeronautical and Curtiss soaring to new high levels on buying influenced by expectations of large government and private contracts. General Motors

# MANY ATTEND SALEM EVENT

### Thousands Flock to Winston Today to Witness Closing of Moravian Services.

Winston-Salem, April 7.—(AP)—Gathering from far and near, thousands of persons today were pouring into Winston-Salem by train, automobile and bus in preparation for the closing ceremonies of the Moravian celebration of Passion Week and the world famous Easter ceremony at Old Salem Church the Moravian cemetery.

Not only was the Twin City rapidly becoming crowded by the thousands of worshippers and sight-seers, but adjoining cities were being made the stopping place for other thousands who will not come here until late tonight. Hotels here were virtually filled and every room was reserved for tonight. Private homes were filled and police and city and county officials were completing preparations to care for hundreds in the city hall and county courthouse.

Greensboro and High Point hotels were filled with visitors en route. One hotel at High Point reported last night that scores unable to get accommodations here had registered there. Special buses are being operated between Greensboro and High Point and Winston-Salem to bring travelers unable to make train connections.

The services which have been in progress all of this week will be climaxed tonight by the presentation of the cantata "The Seven Last Words of Christ" at the Moravian home church ending with the sunrise adoration starting in front of the church and ending in "God's Acre" where Moravians have been buried for more than a century.

The Moravian band of some 300 pieces will start playing at 2 o'clock tomorrow morning and the sunrise service will start promptly at 5:15 a. m.

## Huge Beacons Visible 150 Miles Reared To Guide Night Flyers



On Mount Diablo (above) and one of the Merced hills in California are being built two giant air beacons for night flyers which will be visible for 100 to 150 miles. The map shows their relation to smaller beacon lines projected or in course of construction. One of the huge lights is shown at the right.

San Francisco, Cal. — (AP) — height is to surmount fog which sometimes curtails the aviator's view of the ground up to an altitude of about 2,000 feet.

The reflector and lens of the beacons are 36 inches in diameter. In front of the reflector is a 1,500-watt incandescent lamp. If it burns out a second lamp is thrown over automatically to take its place.

An astronomical clock turns the beacon on at sunset and off at dawn, compensating automatically for the constantly changing time of sunset and sunrise.

The Standard Oil company is installing the two beacons at the suggestion of the department of commerce, complementing the existing system of daylight airway signs and of beacons which are being built or which are projected by the department of commerce.

Mr. Editor: Having found one other person who said he enjoyed my reminiscences, who makes three who have the trouble to inform me that they read my articles, I have concluded to send another for publication.

I think I neglected to tell that Governor Morehead drove his hogs from Pitt to Clufford county. A man went on before and called and one blind to drive and one on each side to keep them in the road. A tall house upon the plank road was near our home. People who rode upon the plank road stopped here to pay, according to the number of miles they had traveled upon the road. The road also had stables at this toll house in which four horses were kept, as this was one place of two at which three relay horses were kept. As soon as the war began the plank road was abandoned, and that is, the people along the road, took the plank up. Some made bridges of them but most of the plank were used for fire wood. If this had been a free road it would have been a real boon to the country, but as

to his three boys, who were all the children he had. He gave each one a large plantation about ten miles apart. They were separated so that there might be no occasion of a quarrel or a misunderstanding. He is the only prosperous man that I ever knew who never worked any. He was not what is called a lazy man but he just did not do any work. After the war he bought a storehouse and bought a bankrupt stock of goods of a man who owed him money. He hired a clerk and sat around the store a great deal, but he never sold any goods. I came near forgetting that he had a large scuppernon grape vine in his garden and someone took me on a visit to him one Sunday afternoon and his wife gave us a fine mess of grapes.

## RESCUE CHICAGO MAN HELD FOR \$100,000 RANSOM

Chicago, April 7.—(AP)—Thomas Gaylor, wealthy automobile dealer held for \$100,000 ransom by a band of kidnapers, was rescued apparently unharmed and four of his captors were arrested and jailed here today, Michael Hughes, Commissioner of Police, announced.

Hughes said he had the information from William E. O'Connor, deputy commissioner, who led five city detective squads to the kidnapers' rendezvous. Hughes would not say where the capture was made, nor name the kidnapers.

Gaylor is the fourth Chicago kidnaping victim within a year. The most recent was Milton Held, racing handbook operator. He returned last week after friends had paid \$15,000 ransom.

The police said the kidnapers were part of a gang which operates as far east as New York. Their ransom money has approached \$500,000 in three years, the police said.

That the lair lay in Wisconsin,

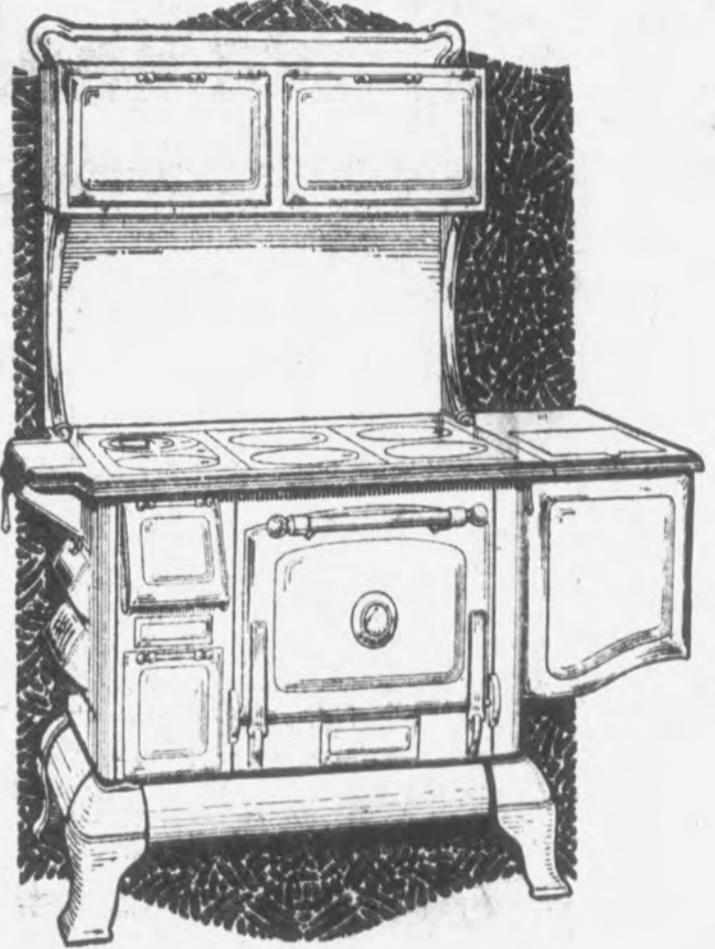

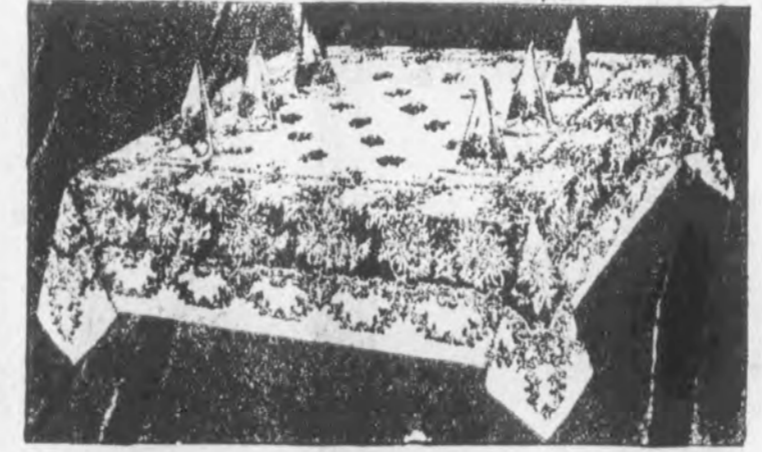

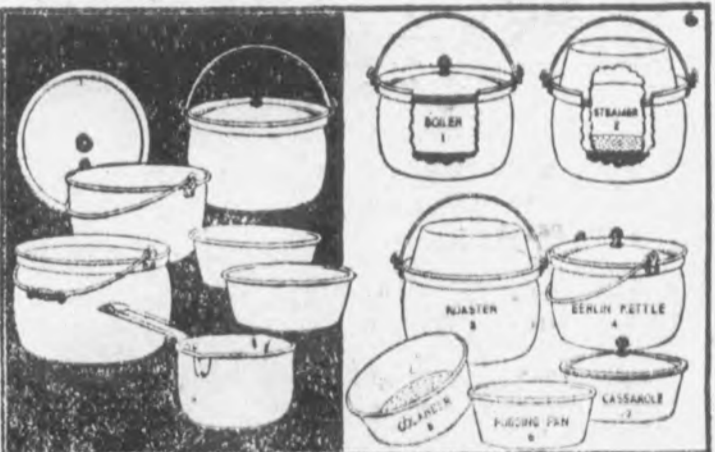
