SENSATIONAL EVIDENCE IN KLAN PENDING

Accounts of Deeds of Violence of Ku Klux Klan Expected in Pittsburgh Court.

Pittsburgh, April 11.—(AP)—The trial of Ku Klux Klan injunction suits was temporarily halted in federal court today when a spectator was ejected after he had called a witness a liar.

Dr. Charles F. Hunter, one of five "banned" klansmen, was on the stand describing a tilt between Van A. Barrickman, a co-defendant, and Dr. H. C. Shaw, grand dragon of Pennsylvania, at Barrickman's trial before the order, at the time of the disruption.

Hunter said a man put his hand on his pocket and said, "I'll get him," (meaning Barrickman).

"Who was that man?" asked Lewis C. Wilkinson, counsel for the former klansmen.

"William J. Hohman,"

"You're a liar," shouted Hohman.

Pittsburgh, Pa., April 11.—(AP)—Accounts of "deeds of violence," a "battalion of death," "night riders," and a "kangaroo court" today caused expectation of further sensational testimony in a suit of the Ku Klux Klan and a counter action by banned members.

The "night riders," J. R. Ramsey of Dayton, Ohio, said, were a branch of the Klan organized "to put over programs that would be detrimental to the Klan if its members were caught at such work." He testified all members of that body, which was also known as the "battalion of death," were klansmen.

The "kangaroo court," according to Clarence W. Ludlow, formerly of Dallas, Tex., now resident here, passed sentence upon alleged martial offenders. At these sessions, Ludlow said, imperial wizard, Hiram W. Evans sometimes sat as presiding officer. Ludlow related how Evans once ordered a white man flogged for failing to support his family.

Judge W. H. S. Thomson is hearing the suits in the United States court. Yesterday the judge refused to allow one question put to a witness by Barrickman agent Dr. Van A. Barrickman, and ordered a "re-arrest of Night Riders into Mexico."

E. A. MacNeil, former exalted cyclops of ... in ... Pa. Klavern, testified he had received letters from S. D. Rich, then grand dragon of the Pennsylvania Klan, "to commit deeds of violence" but stated he could not produce the letters.

He also claimed he had recruited about 5,000 members in Armstrong county for which he should have received \$20,000 under his agreement but had only gotten \$2,400.

Testimony was given by Dr. L. B. Peebles, Parnassus, former grand klan of New Kensington, that he had seen many members armed with automatic revolvers and sawed off shotguns and that Grand Dragon Herbert C. Shaw had "delivered tirades against Catholics and Jews."

The whipping of two Jewish men by Tulsa, Okla., klansmen was testified to by Frank S. Lanham of Sand Springs, Okla. Lanham said he was a former Klan exalted cyclops and that the Klan night riders took the two men to a woods 10 miles north of Tulsa, and forced them to whip each other, alleging that they had made advances to young girls of Tulsa. When the night riders took the whips and applied the lashes he said.

On cross examination he said he could not name the 15 or 20 night riders present, but that Klenge Sanford and a Tulsa trucking contractor were among them.

When Van A. Barrickman, a defendant and defense counsel, asked Lanham if the Klan dominated the Oklahoma state government, Judge W. H. S. Thomson intervened and said he did not want to hear anything that could be handled by a state court.

LEADERS HOLD POSITIONS IN BALLOT FIGHT

Presidential Delegates retain Advantage on Face of Returns From Four States.

Washington, April 11.—(AP)—Leaders in the free-for-all battle of ballots for presidential delegates retained their advantages today on the face of returns from four state primaries and caucuses at which 155 Kansas City and Houston votes were at stake.

Louden picked up at least 30 of the 50 district delegates chosen in the Illinois Republican primary, beating his total to 130 pledged and claimed convention votes to date. However, who did not figure in yesterday's balloting, still has a lead of 181 unattached and claimed delegates.

The former Illinois governor stood today to gain further support as a result of yesterday's Nebraska primary, where 19 delegates were voted upon, and today's convention in North Carolina, where four delegates at large were to be selected. The conference secretary, however, a leading Louden for the southern states' votes.

The primary in Nebraska, where Senator Norris led field, was in doubt early today although Governor McMullen's slate of delegates pledged to support a candidate favorable to the equalization fee of the farm relief bill led a slight lead over the McKelvie slate pledged to a candidate in sympathy with the administration's agricultural policies. Louden is an advocate of the equalization fee and is second choice man on the McMullen-Norris slate.

Four congressional district Republican conventions in Oklahoma yesterday selected unattached delegates, while resolutions expressing confidence in Louden, Senator Curtis and Vice President Dawes were adopted at one of these meetings.

Idaho, the only other state where delegates were chosen yesterday, announced its 11 for Senator Borah, with Hoover as second choice.

On the Democratic side, Governor Smith garnered at least 47 of the 50 district delegates chosen in Illinois and ran his total on pledged and claimed delegates to 241. Nebraska's 16 votes already had been conceded former Senator Hitchcock and a tumultuous convention in Oklahoma selected an unattached delegation composed of Smith and free supporters.

COTTON GETS ATTENTION OF BOTH HOUSES

Marketing Machinery Discussed by Both Branches of Congress Today.

Washington, April 11.—(AP)—The cotton marketing machinery overhaul suggested from various quarters as a result of the 1927 price collapse occupied both Senate and House committees today but served to bring only a declaration by Senator Smith of South Carolina, chairman of the Senate committee, that he hoped and expected to see additional regulatory legislation enacted at this session of Congress.

The Senate sub-committee investigating the slump and incidentally charges of "violence" market rigging operations by Anderson Clayton and Co., of Houston, Texas, spent most of its time discussing the nature and purpose of market "straddles" with William L. Clayton, head of that firm.

In the House, however, the agriculture committee had up the Vinson bill for "going with the grain," Representative Vinson of Georgia, explaining his plan for regulating cotton futures trading and H. C. Safford, of Houston, representing the American Cotton Shippers' Association, endorsing the "general principles" of the bill.

The Vinson bill conforms closely to the Rankin bill in the Senate which Safford specifically endorsed yesterday.

Clayton's appearance before the Senate committee led to several questions between his lawyer, R. H. Fullbright and J. H. Gilbert, representing Arthur R. Marsh and who was supposed to be completing his cross-examination of the Houston cotton merchant.

H. M. BLACKMER FAILS TO SHOW UP AT HEARING

Missing Teapot Dome Witness Does not Respond When Called in Sinclair Case.

Washington, April 11.—(AP)—Callie H. M. Blackmer, witness Teapot Dome witness in the trial of Harry P. Sinclair, the government today laid the ground work for another contempt proceedings against him when he failed to respond.

Blackmer, who is in Paris failed to respond at the first trial of Sinclair and Albert B. Fall last October and \$100,000 of his property was seized by the government. He then was subpoenaed for the present trial. His attorney told the court when their motion to dismiss the first contempt proceedings was denied, that the Denver oil man would not heed the second subpoena.

The Denver oil man was wanted to tell of the organization of the Continental Trading Company, some of whose profits in liberty bonds reached Fall.

In moving against Blackmer, the government proceeded under a law passed at the instance of Senator Walsh, of Montana, the Senate Teapot Dome trial, making it possible to deal with recalcitrant witnesses. When M. T. Everhart, son-in-law of Fall, resumed the witness stand today Daniel T. Wright, counsel for Sinclair, said he had no more questions to ask. The government followed suit and he was excused. Everhart yesterday told of having received \$233,000 in liberty bonds and \$35,000 in cash from Sinclair to be delivered to Fall or his Ranch Company. The bonds he said were for one third of the Ranch and the cash for making improvements in the property.

The next witness, J. E. Benton, vice president of the First National Bank at El Paso, Texas, produced various slips for deposits that Fall

SMALL MEETS WITH DEFEAT IN ELECTION

Governor of Illinois Apparently Crushed Yesterday; Thompson Defeated Also.

Chicago, April 11.—(AP)—Illinois voters in statewide primary election yesterday voted Gov. Len Small off the books of their political favor, dashed the hopes of Frank L. Smith for another mandate to the Senate of the United States and in Chicago tore at the Republican leadership of Mayor Thompson by defeating his choice for state's attorney, Robert Crow.

It was unusually large turnout of voters that swept aside, aimed in its entirety the Republican ticket of Small-Thompson-Crowe which campaigned under the slogan "America first," blazoned on billboards, and street signs the length of the state.

Len Small, two-term governor seeking Republican renomination at the head of Mayor Thompson's "America first" ticket, was crushed under the ballot-loaded roller which flattened his political ambitions as thoroughly in Cook county (Chicago) as it did down-state.

Robert Emmet Crowe, who prosecuted Loeb and Leopold and who personified the "America first" aspirations of Mayor Thompson in Cook county, apparently had fallen in his attempt to mount the third term step of state's attorney.

Even the mayor himself, not a candidate for any post more important than committeeman of his home ward, seemed to have lost the solace even of that slight victory.

Louis Lincoln Emerson, 64-year old secretary of state, was the candidate who swept to an unexpected large majority over Small for the gubernatorial nomination. His lead, with 4043 of the state's 624 precincts tabulated, was 25,526 indicates that the percentage of advantage were maintained in remaining returns, a final majority in the neighborhood of 400,000.

The Emerson vote in the 4043 precincts was 614,840, the totals representing 2,290 downstate and 1,753 Cook county precincts. The vote for Small in the same precincts was 338,214.

Judge John A. Swanson, who headed the Republican ticket against Crowe in Cook county as Emerson did against Small in the state, was the crusading candidate who apparently had won nomination as state's attorney. He ran far behind the Emerson lead, but he was maintaining a margin which he was confident carried victory.

Emerson, Swanson and Attorney General Oscar Carstrom, also successful in his efforts to win renomination, were top cards in the Republican group, which recognized the leadership of United States Senator Charles S. Deneen. The all-but-certain success of virtually the entire Deneen slate held powerful political portent, for it opened the road to party control by Senator Deneen who has been "out" while Mayor Thompson and state's Attorney Crowe were "in."

ELECTION IN NEBRASKA IS QUIET AFFAIR

U. S. Senator and Entire State Ticket Chosen at Primary Yesterday.

Omaha, Neb., April 11.—(AP)—A United States Senator, an entire slate of state officers and both Democratic and Republican delegates to the national conventions were chosen yesterday in a quiet Nebraska primary election.

On the face of a representative group of precincts in widely separated sections it was indicated that United States Senator R. B. Howell won renomination over Attorney General O. S. Spillman, his opponent.

The vote in 544 precincts out of 1983 in Nebraska, gave: Howell 25,599; Spillman 19,629.

The campaign was a bitterly fought one.

Arthur Mullen, veteran Democratic leader in the state, apparently won re-election as Democratic National Committeeman, over William Ritchie, Jr., cousin of Maryland's Governor. The vote in 403 precincts gave: Mullen 10,449; Ritchie 7,863.

There were six candidates in the Republican race for Attorney General all seeking to succeed Mr. Spillman, leading the field was C. A. Sorenson of Lincoln, campaign manager for Senator George W. Norris and his chief aide in Nebraska. The vote from 307 precincts out of 1983 in Nebraska, followed:

The vote for Democratic nomination as Attorney General in 267 precincts gave: Howler Saxton, Omaha 4483; J. Lawler, of Hastings, 5157.

NEGRO MUST DIE IN CHAIR

Supreme Court Fails To Find Error in Case of Winston-Salem Murderer.

Raleigh, April 11.—(AP)—Appeal of Clearence Thomas negro, convicted of slaying a Winston-Salem night watchman last Christmas night, was dismissed today by the state Supreme court.

Thomas, one of three negroes on state prison death row, had his death date extended last February when he appealed, automatically staying execution. Unless Governor McCrory extends clemency, Thomas, under the law must go to his death in the electric chair Friday, April 27.

"No error appears in the instance case," Chief Justice Stacy wrote in the Thomas case.

Associated Justice Brogden affirmed the referee's report in clerk of superior court George against Lola Walker, executrix of the estate of a former clerk, Cumberland county, and others. The referee, the high court held, did right in entering judgment against Mrs. Walker for \$67,255.50. Another defendant in the action, the U. S. Fidelity and Guaranty Company, who gave four \$10,000 bonds for Walker from February 1915 to December 1926, also appealed.

Justice Brogden wrote that "upon the entire record we are of the opinion that the judgment rendered should be upheld."

Raleigh, April 11.—(AP)—W. H. S. Burgwyn, attorney of Woodland, candidate for lieutenant-governor in the coming Democratic primary today filed notice of candidacy with the state board of elections.

Col. John D. Lanston, Goldsboro, last week filed notice for the same office, while R. T. Fountain, Rocky Mount, is also in the race for lieutenant-governor.

A. T. Allen, state superintendent of public instruction also filed notice of candidacy. He is opposed to date.

FARM MEASURE CAUSES STRIFE

Senator Brookhart Declares Bill Should be Designated "Dawes Bill"

Washington, April 11.—(AP)—Embarrassed by charges of delay to gain political support for Vice President Dawes in the coming Republican convention, the senate turned today to consideration of what will happen when the bill finally gets to the White House is not known, but it is plainly indicated yesterday that if the equalization fee provision is retained at passage, even with the alternative of withholding its application until other surplus crop marketing machinery fails, it stands little chance of receiving President Coolidge's approval.

"As it stands now, the President feels the measure still contains several provisions that met his disapproval in vetoing the bill last year, chief among which is the equalization fee."

Senator Brookhart, Republican, Independent, of Iowa, one of the opponents of the bill, took the senators by surprise when he charged, during a let-up in the amendment discussion proceedings, that the measure had been held up by three friendly to Vice President Dawes to bring the latter to the front as a presidential candidate. This was denied by McNary.

The Iowan, who was in the late Senator LaFollette's camp in 1924 presidential race, said the delay was to force the farm relief issue into the last stages of the pre-convention campaign and that Dawes was running for the presidency as a supporter of the measure which should be called the "Dawes bill."

Republican Wins in Nebraska.

Omaha, April 11.—(AP)—United States Senator R. B. Howell, Republican, seeking re-nomination in the Nebraska primary yesterday, apparently has won from Attorney General O. S. Spillman.

The vote in 896 precincts out of 1983 in the state gave Howell 40,299; Spillman 30,224.

Body of Missing Airman is Washed Ashore at Norfolk

Norfolk, Va., April 11.—(AP)—The body of Commander T. G. Ellyson, a native of Richmond, one of three naval aviators who disappeared with a seaplane after leaving Hampton Roads for Annapolis at 2 a. m. May 28 was recovered this morning at Willoughby, a Norfolk suburb, where it washed ashore.

Identified by a radiogram from his wife, found in one of his pockets, telling of the illness of their child. It was in response to this message that the flight from Norfolk to Annapolis was undertaken.

Charles D. Sarber, of Ocean View, who was walking along the beach shortly before daylight this morning, stumbled over the body and notified police. Commander Ellyson's face had been badly crushed, presumably when the plane crashed. He wore an aviator's suit over civilian clothes.

Raleigh, April 11.—(AP)—Harmony was established in state Republican convention actively today in the first half hour of the session which began at 10:30 a. m. when a viva-voce vote the convention decided to dispose with the report of the committee of credentials.

All county chairmen, including Mecklenburg, which reported "no contest that we know of," reported no contests and on motion of Thomas J. Perkins, district attorney, of Asheville, opposed by Willis Briggs, district attorney, Raleigh, the credentials committee was dissolved without report.

Henry Lane, Good Shepherd Episcopal Church, Raleigh, prayed for "moderation of speech in the heat of debate" in opening invocation. Mayor E. E. Culbert in welcome invoked for harmony in party lines. Gilham Grissom, Raleigh, federal director of internal revenue, commended too that this state should vote with New York and Illinois and other leaders at Kansas City.

David H. Blair, Winston-Salem, federal commissioner of revenue at Washington, thought the convention important enough to attend and he

BIG LEAGUES SWING INTO ACTION TODAY

Baseball weighed with pennant hopes and fears today bring the game home to more than 400 major league players and a quarter of a million fans. Opening of the season in eight cities will produce material for the compilation of box scores and a standing of the clubs on which the championships will ultimately be awarded.

A shivering Washington crowd saw the Senators and Boston Red Sox offer a prologue yesterday American League fans today will see the curtain run up at Philadelphia, Boston, Detroit and Chicago, while the National League is starting another baseball year at New York, Brooklyn, St. Louis and Cincinnati.

Heavy artillery has been massed on every front for the opening battle. Each manager wants to get off in at least temporary triumph and players have been told in vigorous terms that a game won in April may decide a championship in late September.

The opening finds the usual variety of chances. Ambitious youngsters will be found on every club knocking at the door of opportunity while a quota of veterans has fallen under the handicap of bad legs and arms and passed out of the picture. More than the normal number of former major league players who have served sentences in the minors have disproved the truth of the saying that they do not come back for here they are again.

There was no Walter Johnson to answer the rallying call of the Washington fans "Hey Barney," when the Senators and Red Sox lined up yesterday. Buck Wheat's sunburned face will be missing today and the swarthy Jacques Poirier will not hear a major league fan cry "Hit it out of the lot, Mack." The sun will not be dimmed by the brilliant red under-shirt of Bob Shawkey when the Yankees emerge from their dug-out.

To pick up the bat and glove dropped by the players passed onto the minors, these same minors have sent up young arms and legs to carry on. Eddie Morgan, standing out in a crop of promising young outfielders, will bid to for the favor of Cleveland fans while St. Louis has Brannon at second and Kress at short to carry a formidable infield burden. The expensive Chalmers Cissell will be found at short for the White Sox and a willing, hustling Andy Cohen is in charge of second base for the Giants. Bill Kelley has had chance at first base for the Phillies and Arthur Whitney has won the third base bid on the same club. Doug Taitt played his first major league game for the Red Sox yesterday.

The living examples of the fact that all is not lost when a major league player drops back to the minors will see action today when Frank O'Doul plays for the Giants, Harry Riccoda and Howard Freigau go to bat for Brooklyn and Gene Robertson makes himself generally useful for the Yankees.

A number of players may turn toward the wrong bench at the end of an inning. Half a dozen stars were for clubs last year, they are against now. Rogers Hornsby will be trying to beat the Giants as Frank Hogan and Jimmy Welsh work for New York interests. Dave Bancroft's hits and throws from shortstop will help Brooklyn and not Boston. In the American League Lu Blue will do all his first basing for St. Louis, while Harry Manush, another former Detroit Tiger, is in the Brown outfield. Earl McNeely has taken off a Washington uniform and put on that of St. Louis.

Harry Rice will be hitting for the Tigers against the Browns and there is no white elephant on the shirt of Chick Galloway as he sits on the Detroit bench. George Sizer is in Washington colors instead of St. Louis, and Tris Speaker is wearing the blue of Philadelphia instead of the red, white and blue of the Senators. Big Miller's stockings have changed from brown to blue.

Every prospect pleases except fickle weather as the big parade starts. It will require nearly six months to pass a given point, represented by two championship marches and a world series at the end.

Harry Wilson Dons New Garb, Hopes To Defeat Midshipmen Once Again



"Lighthorse Harry" Wilson is going to take yet another fling at the Navy. He is out for the West Point lacrosse team which has two objective-trimming the Middies June 2 in what may be the last Army-Navy game in any sport for some time, and earning the right to go to the Olympics. The sport is included on the Olympic list this year. The Middies, too, are in the running for selection.

WEST POINT—(AP)—Harry Wilson has gained about every athletic honor possible as a Penn State and West Point athlete for the last 7 years, but he has one more ambition. He hopes to help beat the Navy once again.

When West Point came off victorious last fall in what may be the last Army-Navy football game for some years, it was largely Harry Wilson who did it. In the past winter the Navy partly evaded things by nosing out the Cadet basketball team of which Harry Wilson was a member. Now Harry is playing lacrosse and the Navy game June 2 will be his last appearance against the Middies.

"Lighthorse Harry" is heavily counted on for the attack. He plays lacrosse as well or better than football. O'Donnell, Ayre and Saunders, last year's football men, with Donald, Sladen, Holley and Allen, make up Wilson's teammates in attack. Born and Harbold, who worked well together as ends in football last year, will be with the team as goal defenders. Also Kenny and Anderson, football players, besides Seaman, Lovell and Bisson. Goal present four prospects, Deering, Goldberg, Mason and Sisson.

Because the Army authorities understand the Navy's three year eligibility rule policy as precluding all intercollegiate athletics after it goes into effect all games between Army and Navy automatically stop after July 1, 1929. Thus the lacrosse duel June 2 may be the last Army-Navy game for some time to come.

Besides the Navy game, the Army stick wielders have another important objective in common with such institutions famous for their lacrosse teams as Syracuse and Johns Hopkins. This objective is the right to represent the United States in the Olympics. The game this year has been included in the list of Olympic sports and the representative team is very likely to be a college aggregation.

In 1927 Army won nine games and lost two—once to Johns Hopkins and the other to the Navy. In 1927 Army won eight and lost to the same teams again. In 1925 Navy went unbeaten, but was defeated once in 1927. This would indicate that these two teams were about as closely matched as any in the country. Both teams are mainly intact so far as last year's players are concerned.

If these two teams come to their final game unbeaten the contest may involve the right to go to the Olympics. The service schools always have rated near the top in this strenuous sport and are well up to standard this year.

Fourteen years ago Ty Cobb, Eddie Collins, and Tris Speaker, rivals for all around honors and the stars of three pennant contending clubs, finished one-two-three in the American league batting race.

Today these three musketeers, with the end of the long trail in sight, are in the same uniform for the first time to mark another dramatic turn in the fortunes of baseball associated with Connie Mack.

The fourteen years it has taken to get this great trio together have taken their toll. Collins already is out of daily harness, devoting his experience rather than his playing ability to Mack's machine. Cobb and Speaker have slowed up but they still have a lot of base hits in their bags.

All three have retained their batting eyes even though they can't cover the ground they used to. The figures offer striking proof of this. Their marks for 1927 show an average falling off of less than ten points apiece as compared with 1914 when they set the pace for the rest of the flock. Here's how they compared:

Player:	1914	1927
Cobb	369	357
Collins	344	338
Speaker	328	327

There were only a dozen 300 hitters at the close of the 1914 American league campaign. Fifty did that well or better last season.

The titanic race for home run honors 14 years ago ended in a tie between Home Run Baker and Walter Cam Crawford, each with eight. Babe Ruth last season had that many by May 11 and a dozen others finished the campaign with eight or more.

Fourteen years ago, as now, Ira Thomas occupied the role of official after dinner spokesman for the Athletics. It was just a few days ago that Ira put the Athletics in the 1927 race with a few cheering words, for old times sake, here is the report of one of Ira's talks about the old Athletics, as printed in the Washington Post of December 6, 1914:

"That Connie Mack, the baseball wizard, can put a team of nine men in the field, not one of whom ever touched a drop of liquor, and but one of whom knows the taste of tobacco, was the statement of Ira Thomas, catcher for the Philadelphia Athletics, made at a dinner. The Philadelphia \$100,000 infield, (McInnis, Collins, Barry, and Baker) consists of men who don't know the taste of liquor and only one has ever used tobacco, according to Thomas, who dwelt upon the subject of sobriety among players of the National League.

Bender, Plank and Coombs—any one of them worth at least \$100,000 if not twice that sum as present day baseball prices go.

Today Mack's big three are Grove, Rommel and Blanke, again a south-paw and two great right handers but not to be compared as a trio with the famous group that pitched the Athletics to four pennants in five years.

"Plank was the greatest left hander of all time, Bender the greatest one-time pitcher I ever knew and Coombs a wonderfully consistent as well as rugged worker," said Mack one day in sipping his old timers. "Grove has more stuff than plunk had. He may turn out to be as great when he settles

New York, (AP)—Not less than 20 bright, young players who have dreamed of baseball fortune to be found in the major leagues will have their ambitions realized this year.

The secret of arrivals is exclusive of pitchers for not even the managers know how many of the 1928 quota of pitching recruits will be among those present when the summer weather boils the kinks from more experienced pitching arms.

Among several good young catchers coming up to the big leagues for the first time, Gus Mancuso, formerly of Syracuse, stands out with the St. Louis Cardinals. Mancuso is with the Red Birds as a result of the second thought of the management. He did good work for Syracuse but the parent club did not realize just how promising he really was until this spring when he was ordered to join the major leaguers instead of the minors. Mancuso's name was not on the roster of the 1928 Cardinals (furnished before the team went South).

Two new first basemen will start from the jump. Del Bissomette with the Brooklyn Robins and Bill Kelley of the Phillies. Andy Cohen at second base for the Giants will be very much in the spotlight as he succeeds Rogers Hornsby and may hear from time to time that "Hornsby would have got it" or "Rogers would have done something if he had been up there."

The St. Louis Browns have drawn on Tulsa for three infielders, although one may have to double in brass or taking a turn in the outfield now and then. Otis Brannon and Ralph Kress will play second and short for Dan Howley while Guy Sturdy will make himself generally useful around first base or in the outfield.

Chalmers Cissell will be called on to play shortstop for the Chicago White Sox under the handicap of a big price tag attached to his rights. Arthur Whitney, who will cover third base for the Phillies, is

one of the few drafted players to come through beyond dispute. Harry Riccoda, who has been in and out of the big time, is back again with assurances of remaining somewhere in the Brooklyn infield.

A flock of young outfielders will break in. Eddie Morgan of Cleveland, Doug Taitt of the Red Sox, Paul Easterling of the Tigers, Sid Purdy and Marty Callaghan of Cincinnati, John Leonard Martin of the Cardinals, Emile Barnes of the Phillies and Art Jahn and Lefty O'Doul of the Giants will be in evidence opening day.

O'Doul, a former major league pitcher, is older than the others but has made a good impression on Manager McGraw in the spring training. Detrick, a fast firing Virginia, reported to the Phillies as an infielder but was shunted to the outfield where his speed and great arm can show to greater ad-

vantage. Barnes, once a start football player at the University of Alabama, has so much speed that his hitting may be left to take care of itself.

A. C. C. Pitcher Has Hard Luck.

Butterworth, however, nailed the next offering—a high one—into center field for a single when the outfielder let it drop to the ground untouched.

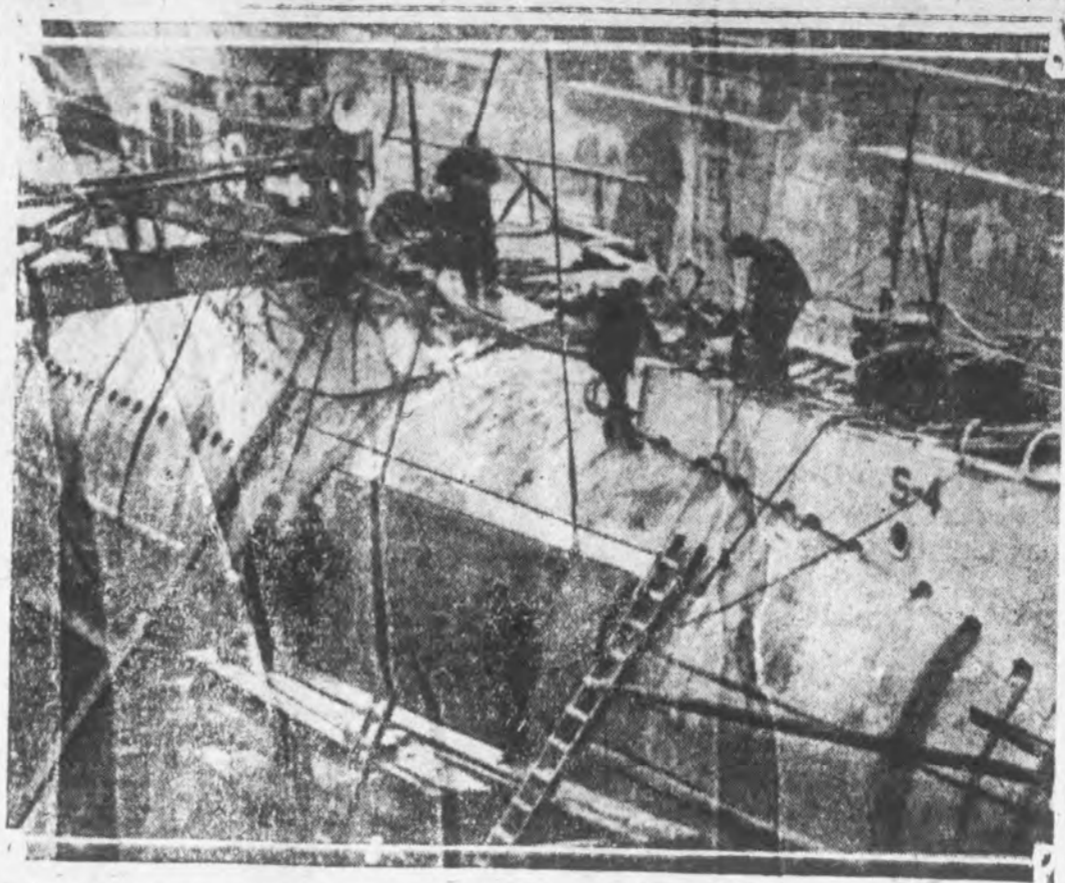

Miami Beach, Fla., April 11—(AP)—Gene Tunney, heavyweight boxing champion, announced today that he had signed a contract with George (Tex) Rickard his exclusive boxing services in 1929. The contract will become effective at the expiration of the present agreement, October 1. Tunney said he signed the contract last night.

Martin Home Is Wrecked By Fire

The nine-room dwelling house of C. W. Martin, six miles north of Greenville, was totally destroyed by fire last night, which was estimated at \$4,500, which was partially covered by insurance.

The fire originated upstairs and had gained such headway when discovered that frantic efforts of Mr. Martin and his son to cope with the flames proved futile. The building was practically new.

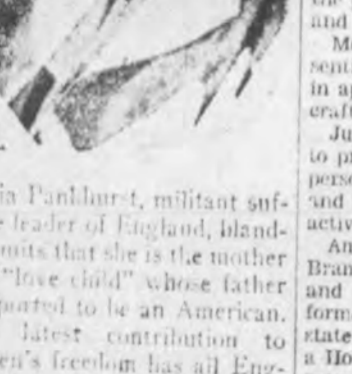
A resolution calling for strict enforcement of the eighteenth amendment was rejected by the resolutions committee.

Smyrna Rocked By Earthquake

Constantinople, April 11—(AP)—Greece rocked by a series of quakes late last night.

The Smyrna region, where 60 persons lost their lives on March 31 in a series of quakes, again was filled with terror as four houses crashed in the city proper and 40 in the neighboring village of Treh.

Seven quakes rocked the village of Tourball which already had been completely demolished. No further casualties were reported.

REPORT INCREASE IN SUNDAY SCHOOL WORK

Concord, N. C., April 11—(AP)—Marked increase in all phases of Sunday school work in the state was shown in reports submitted today to delegates attending the annual state Sunday school association now in session here.

President J. B. Ivey, Jr., General Superintendent D. W. Sims, offered reports indicating that the past year had been the most successful in the history of the association.

Sunday school conventions were held in each of the 100 counties in the state and at these conventions and the 99 institutions held in addition by the state association, there were represented 2,389 Sunday schools, 772 pastors, 1,284 superintendents, 6,547 teachers and 95,259 students.

Work of adults, young people and children was discussed at three simultaneous conferences this afternoon.

FIFTEEN KILLED IN PARIS TRAIN COLLISION

Paris, April 11—(AP)—Fifteen persons were killed and thirty injured in a collision of trains bound for the English racetrack just outside of Paris at 1:35 o'clock this afternoon.

Firemen and a wrecking crew, after two hours work, succeeded in extricating nine bodies from the wrecked trains which had caught fire. Only two of the bodies had been identified late today and both of these were Frenchmen.

Twenty of those injured were taken to hospitals while the wrecking crew continued to search for bodies pinned under the blazing cars.

No Americans were reported among the killed and injured, although race track trains generally carry a fair percentage of overseas track followers.

A. D. Brownfield, receiver for the Citizens Bank of Corning, N. Y., then identified slips showing liberty bonds deposits in that bank. One of the slips was for \$50,000.

The rule, secretary cashier of the First National Bank of Pueblo Colorado was recalled and said \$20,000 in liberty bonds was received from Fall on October 31, 1922, and the proceeds credited to the account of the Tres Rios Cattle and Land Company, the Fall ranch.

John J. Roberts, special government prosecutor, then offered in evidence ledger sheets from the First National Bank at Pueblo showing accounts of Everhart, Fall, the Tres Rios Company, and deposits slips showing the receipt of liberty bonds from Fall and Everhart.

Here then were introduced the telegrams exchanged in December 1923 between C. E. Stafford, of the Interior department, and Fall relative to the trip planned by Sinclair and his attorney, J. W. Zevely, to Three Rivers New Mexico, for the first conference with Fall.

Another travel voucher was presented showing that Fall left Washington on February 1, 1922, for New York, and returned to Washington soon after. A letter from Sinclair to Fall on February 3, 1922, was put in relative to the possibility of leasing the Teapot Dome, Sinclair submitting a tentative basis of which he would be willing to develop the project. He said he was ready to pay a "reasonable" royalty for this privilege.

Sinclair then said he was willing to buy up the outstanding claims to Teapot Dome ground, and urged restricted leasing of the land to prevent increase of the congestion in that vicinity which he said would follow the policy of granting numerous leases.

G. T. Stanford of Sinclair's counsel testified that the Mammoth Oil Company, a Sinclair organization

which the lease was issued, was incorporated in February 1922 with one million shares without any given value, which was increased to 2,500,000 shares on April 10, 1922, all of the stock was issued to Sinclair except necessary organization shares for the lease of the naval reserve.

Roberts then introduced Sinclair's formal application for the Teapot Dome lease. Sinclair personally guaranteed fulfillment of all terms of the lease in an accompanying application made March 11, 1922. Then followed a number of quit claims and other documents concerning the lease which Fall had held should be furnished by the lease of the Wyoming reserve.

Roberts was placed in the record in rapid fire order the chain of events on which he hoped to send Sinclair and Fall to jail.
