SUNDAY AGAIN HEARD BY BIG CROWDS HERE

Evangelist Spoke on "Second Coming of Christ" at Services Last Night.

Billy Sunday delivered the most powerful sermon of his campaign in this city last night.

He spoke on the "Second Coming of Christ." It was a brilliantly worded discourse, dealing with the millennium. Varying considerably from the usual interpretation of this particular era spoken of in the Bible, the evangelist presented his four thousand hearers with more food for thought than any other single service of the series.

"There can be no millennium until Jesus comes," Mr. Sunday declared. "It is his presence that makes the millennium. You might as well talk of daylight not coming until the sun goes down."

"The millennium cannot begin until Satan has been bound in the pit. Nothing is more certain than that the glory of God shall cover the earth, but it will be after Jesus comes."

"Many have the idea that the world will grow better and better until the coming of the millennium, and everybody will be converted, and you hear that stuff preached, but the Bible does not teach any such thing."

"A great many people think the millennium will come first and Christ after it. What people think has nothing to do with it, but what God says has everything to do with it. You will see God's time card if you carefully read the Bible. Not a word can be found that gives the slightest hope of the millennium before the coming of Christ."

Combining his powers of oratory and drama, the evangelist painted glowing word pictures of the return of the Christ. At times he became so incensed against the operations of Satan that he would lift a chair from the platform and make a pretense of hurling it at some distant point.

At some points he stated that in the congregation. It is such outbursts of emotion, accompanied by the dramatic that has placed Mr. Sunday in such an eminent position among Christian workers of the world. His sincerity, his complete concentration upon the subject in hand, was more plainly in evidence last night than ever before, although this has been marked throughout the entire campaign.

Members of the Pitt County post of the American Legion and various Bible classes of the city were guests at the tabernacle last night. Mr. Sunday paid tribute to the achievements of members of the Legion during the World War. He said the spirit of bravery dominating the American forces was accountable for winning of the great conflict.

He recognized the Bible classes, and declared he hoped to see several times as many members by the time his campaign is over.

The choir loft was again packed to capacity last night, and Homer Hammond and his three hundred songsters sang as they probably never sang before. This is one of the most inspirational parts of the services, and each week witnesses more consecration among the members of the choir.

A quartet from the Memorial Baptist church rendered a selection, "He Is Risen," during the latter part of the musical program.

Opening prayer was led by Dr. T. H. Plemons, former pastor of the Immanuel Baptist church, who is a Greenville visitor at this time.

Mr. Sunday announced that he would preach to women only Saturday night. The announcement was greeted by deafening applause that brought a smile of satisfaction to the face of the evangelist.

He also said that next Sunday afternoon would be devoted to services for men only. This will be the third time of the campaign that services have been held for men.

Mrs. Sunday will speak to women at Jarvis Memorial Methodist church Sunday afternoon at the same time services for men are under way at the tabernacle.

Smith Leading In Race For Vote Of Delegates To National Convention

Washington, May 16.—(AP)—Governor Smith's total of instructed, pledged and claimed delegates to the Houston convention today was over the 600 mark—603 1-2 to be exact—as a result of primaries and conventions in three states yesterday. A total of 733 1-2 delegates votes, or two-thirds or the 1,100 in the convention, is necessary to nominate. At least 79 1-2 of the Smith block are disputed by his opponents.

Secretary Hoover's delegate total had grown to 541, of which 184 are contested. A total of 545, or a majority of the 1,089 sent to the Republican convention, is necessary to put the candidate over.

The two leading candidates for the President nomination of their respective parties picked up their largest gains yesterday in the New Jersey primaries. Smith bagging the entire Democratic vote of 28, while Hoover, on the face of a complete return, won 25 of the 31 Republican delegates.

The remaining six were pledged to President Coolidge with Hoover as second choice.

Hoover won six more delegates yesterday in Alabama district convention. Another district was to hold a meeting today immediately preceding the state convention which will name four delegates—large O. D. Street, Republican national committeeman for Alabama, is claiming 14 of the state's 15 delegates for Hoover.

The cabinet officer's total of 467 does not include Maryland's 19 which are yet to be decided but which will be of the recent preference by virtue of the recent election vote in that state.

Two other Republican conventions held yesterday—in Wyoming and Montana—selected unsuccessful delegates to Kansas City. Wyoming appointed nine and Montana eleven. It appeared to observers that the latter block would be split between Lowden and Hoover at the national convention.

Besides the 28 in New Jersey, Smith reaped 16 more delegates with the holding of conventions in Vermont and Montana, each state giving him eight. Should it appear that Smith might not win the nomination, the Montana delegation, under the instructions given it yesterday, will seek to have Senator Walsh, of that state, reconsider his withdrawal as a candidate so they can support him.

Walsh stopped all efforts in his behalf after the recent California primaries which, he said, showed the futility of further contesting with Governor Smith. The Montana Senator will be a delegate to the Houston convention.

Violations of Traffic and the Prohibition Laws Features of the Docket.

Clash of Northern and Southern Troops Expected Around Tientsin and Peking.

Tokyo, May 16.—(AP)—A clash between northern and southern (Nationalist) forces, who are threatening Tientsin and Peking, was believed to be imminent today.

A dispatch from Peking to Renko, a Japanese news agency, said 2,700 members of the families of northern officers and officials had been sent to Mukden, Manchuria. Most of them were women and children. This was taken to indicate that the northerners believed the battle might decide the fate of Peking.

The Japanese cabinet at a special meeting today decided to send more troops to China. The third division from Magoya, which at present is moving toward Shantung, may be partly diverted toward the Manchurian border. More troops, therefore, were believed to be necessary to protect Shantung, where Japanese and Chinese clashed recently.

It was generally indicated that the Japanese would not permit fighting in Manchuria. It is understood that Marshal Chang Tso-Lin, northern dictator, had been so warned.

There were rumors that Japan unofficially advised Chang to return to Mukden before hostilities broke out at Peking or Tientsin for there after any attempt on his part to seek refuge in Manchuria might not be permitted. There have been various advices that Chang had left or was about to leave Peking.

New Jersey Voters In Favor Hoover

Newark, N. J., May 16.—(AP)—Herbert Hoover and Governor Smith of New York on New Jersey delegates to national political conventions in yesterday's balloting, Smith by the mere formality of an election and Hoover by defeating Lowden delegates in three districts.

Six of the 81 Republican delegates are pledged "Coolidge first choice. Hoover second," the others are out-and-out for Hoover. Hoover alone was entered in the presidential preference vote.

Governor Smith gained 32 delegates and 28 votes, as New Jersey Democrats are entitled in their convention to a half vote for each of eight delegates-at-large and a full vote for each of 24 district delegates. The Democrats had only two contests on their hands and they were personal fights.

DURHAM MAN GIVEN TRIAL FOR MURDER

Hearing begins in case of Durham Contractor Charged With Killing Dressmaker.

Pittsboro, N. C., May 16.—(AP)—Absence of an important state witness today delayed the opening of the trial of W. Herbert Lawrence, Durham contractor, charged with the murder of Mrs. Annie B. Terry. Solicitor Clawson Williams declined to name the witness but said he expected to locate him by this afternoon. Judge R. A. Nunn ordered a recess until 1:30 o'clock in order to give the solicitor time to seek the witness.

Pittsboro, May 16.—(AP)—With 160 special veniremen drawn by order of Judge Romulus A. Nunn, selection of a jury to try W. Herbert Lawrence, Durham contractor, on a charge of murdering Mrs. Annie Terry, dressmaker of Durham, was in order today as court convened at 9:30 o'clock.

Crowds began to gather about the Chatham county courthouse long before the hour for opening court. Many persons from Durham were in the number who sought to witness the legal fight which speculation and report have indicated will be dramatic and sensational. Booths were scattered about the scene, offering food and drink for a consideration which, in some cases, was intended for the coffers of public or semi-public organizations. Hawkers of books and other articles had places of vantage, prepared to make the most of the opportunity presented by the throng of potential purchasers.

Solicitor Clawson Williams had stated that the prosecution had evidence upon which it was prepared to ask the jury for a verdict of first degree murder, carrying the death penalty, while from the camp of defense counsel, embracing some of the best known attorneys of this section, came the intimation in reply that their client's own clerk should shoot the state's case full of holes.

In selection of the 12 jurors, the defense was entitled to 12 peremptory challenges while the state had but four. Any number of talesmen could be excused for cause, however, and in view of the fact that Lawrence has been closely identified with Chatham county and has many friends of long standing among its citizenship, it was believed that a large number of names drawn from the hat would be disqualified to serve.

Interest in the trial has been raised to a high pitch by reason of the element of mystery involved in the prosecution's case against Lawrence as well as by his prominence and by the circumstances of the crime itself. Mrs. Terry's body was found in the Cape Fear river nine days after two fishermen had reported hearing a woman's screams on the Avents' ferry bridge in lower Chatham county the night of March 24. After following clues that led to South Carolina and to various points in this state, officers took Lawrence into custody on April 11. Since that time he has been confined in the Durham jail, where he continued to direct the operations of his contracting firm. He has never been given a preliminary and as a consequence the state has not shown its hand.

A green automobile said by witnesses to have been sighted at the scene of the murder is understood to have been one of the clues which prompted officers to arrest the contractor who was reported to have been friendly with the slain woman.

MORE ART AND BEAUTY ASKED BY PRESIDENT

Tells Art Clubs Moral Standards Would Be Increased By Things Artistic.

Washington, May 16.—(AP)—A plea for more art and beauty in the daily life of the American people in order that their "moral standards" might be raised was made here today by President Coolidge.

"It is especially the practical side of art that requires more emphasis," Mr. Coolidge said in an address opening a joint meeting of the American Federation of Arts and the American Association of Museums.

"We need to put more effort into translating art into the daily life of the people," he added. "If we could surround ourselves with forms of beauty, the evil things of life would tend to disappear and our moral standards would be raised. Through our contact with the beautiful we see more of the truth and art brought into closer contact with the intimate."

"Our country has reached a point where this is no longer a visionary desire but is becoming an actual reality. With general prosperity, with high wages, with reasonable hours of labor, has come both the means and the time to cultivate the artistic spirit."

"Philanthropy has given the people access to all that is most beautiful in form and color. It is theirs without money and without price, if they will but go and possess it. Out of our agriculture, our commerce and our industry, we can see already emerging a new spirit. The potential is becoming actual."

"Through science and invention, gradually but surely, we are banishing the drudgery of existence and fitting into every avenue of living a touch of the artistic. We are working out the ideal under which every one will realize that they are artists, in their employment, in their recreation and in their relations with one another."

President Coolidge cited the Chicago World fair of 1893 and the Washington pavilion commission created in 1901 as two mighty influences in the artistic awakening of the United States. The great development of museums was praised by him as affording inspiration for a rival of beauty in this country.

Aid in the extension of your work has been given by various philanthropic endowments," Mr. Coolidge told his audience. "One is interested in the elevation of industry arts in America on the sound theory that beauty in a commercial product is worth while, not only materially, but also ethically, and that it gives an opportunity to bring art into the home."

DRY PLANK IS ASKED BY S. C.

Delegates Enter Democratic Convention to Fight for Bone Dry Advocates.

Columbia, S. C., May 16.—(AP)—With Governor Richards as their candidate for the post of national executive committee delegates of the bone dry block entered the state Democratic convention today to fight for a delegation to the national meeting instructed to work for prohibition candidates and a dry plank.

Complete abrogation of the state party rule 33, requiring primary voters to pledge support to the party nominees, was endorsed by a caucus of some 150 delegates held last night. Those attending the caucus adopted resolutions favoring the substitution for rule 32 of the statutory oath after hearing John Gary Evans of Spartanburg declare that the party oath was not legal because it was in conflict with the statutory oath. The statutory oath, he explained, requires the voter to state that he is qualified by residence and otherwise to cast his ballot in the primary. The federal supreme court, said Mr. Evans, would not uphold election managers who required the party loyalty pledge as a qualification for voting. A test made before the supreme court, he continued, might result in having a primary election set aside were the rule enforced, and the election managers liable for damage suits.

Rejection of the rule was accomplished after considerable debate and the nomination of Governor Richards for the committee post was not endorsed until after W. H. Keith of Greenville said that he could not support the governor because "he has appointed men to enforce the dry law in my county who have made of it a farce."

TWO KILLERS GRANTED NEW TRIAL TODAY

Ray and Deyton Case Among Ten Opinions Handed Down By Supreme Court.

Raleigh, May 16.—(AP)—Lum Ray and Marshall Deyton, convicted of murder in Yancey county superior court last August and sentenced to serve 15 to 20 years each, today were granted a new trial in one of 10 opinions handed down by the Supreme Court.

Chief Justice Stacy held that superior court judge Moore had erred in his instructions to the jury trying the two men. "It has been held in a number of cases that where the defendant testifies in his own behalf, it is error for the trial court to instruct the jury to scrutinize his testimony and to receive it with grains of allowance, because of his interest in the verdict, without adding that if they find the witness worthy of belief, they should give as full credit to his testimony as any other witness," said Chief Justice Stacy.

The two men were convicted of slaying William Laws. They pleaded self defense.

Dewey Ray, convicted of abandonment of wife and child in Yancey county, gets a new trial in error of instruction to the jury by Judge Moore. It was held by Justice Adams who, pointing out that there was some evidence that the child of Ray's wife might have been illegitimate, wrote that status does not impose upon a husband the burden of supporting another man's offspring.

Geurukus, convicted in Mecklenburg of abortion, must serve his term, the court upholding Judge Webb.

Conviction of Dave Garland in Yancey superior court of the murder of Lonnie McMahan last July, was upheld. Judge Moore had sentenced Garland to 10 to 15 years.

LIGHT WEIGHT PLANE MOTOR CUTS HAZARDS

Aeronautics Committee Told of Scientific Research in Field of Aviation.

Langley Field, Va., May 16.—(AP)—The development of a light weight oil-burning motor and other advances in scientific research expected to reduce the hazards and costs and increase the usefulness of airplanes have been explained before American aircraft engineers here by the national advisory committee for aeronautics.

The heavy oil fuel engine for aircraft, weighing less than three pounds per horsepower, has been devised in the committee's laboratories here after five years of experiment. A one cylinder model was demonstrated to the commercial engineers yesterday during the third annual aircraft engineering research conference, and it was made known that the experiments have advanced far enough now to warrant the construction of multi-cylindered motors for actual use in aircraft.

This motor, it was explained, eliminates the fire hazard which attends the use of gasoline in the common types of airplane engines. The fuel supply being capable of extinguishing a flame unless raised to a very high temperature. It also does away with electric ignition and carburetion, since the fuel is sprayed into the cylinders under high pressure and ignited by the heat in the highly compressed air charge. In addition to these advantages with respect to safety and simplicity, it produces more horsepower to the gallon of fuel, promising greater cruising radius and carrying capacity for aircraft equipped with such a power plant. The 26 horsepower one cylinder model develops 500 revolutions per minute.

The research workers are particularly hopeful that the oil burning motor will prove of great value in aircraft constructed for heavy loads and long flights, including bombing, transport and passenger machines. Looking toward increased economy and efficiency in gasoline motors, for use in plants built for high speeds and ready maneuverability, such as the pursuit and sport types, they reported considerable progress toward the development of an engine in which every down stroke of the pistons, instead of every other one, would be a power stroke. This, they pointed out, would approximately double the horsepower of a motor in relation to weight, permitting the construction of even lighter speed motors than have yet been devised. Beyond that lies development of a similar two-stroke cycle fuel injection engine, work on which has already begun.

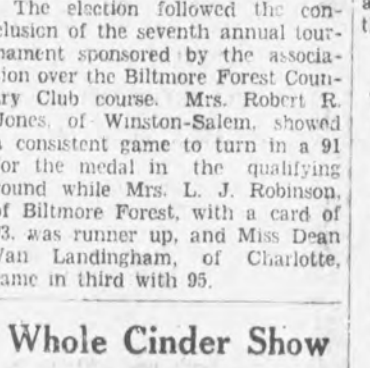

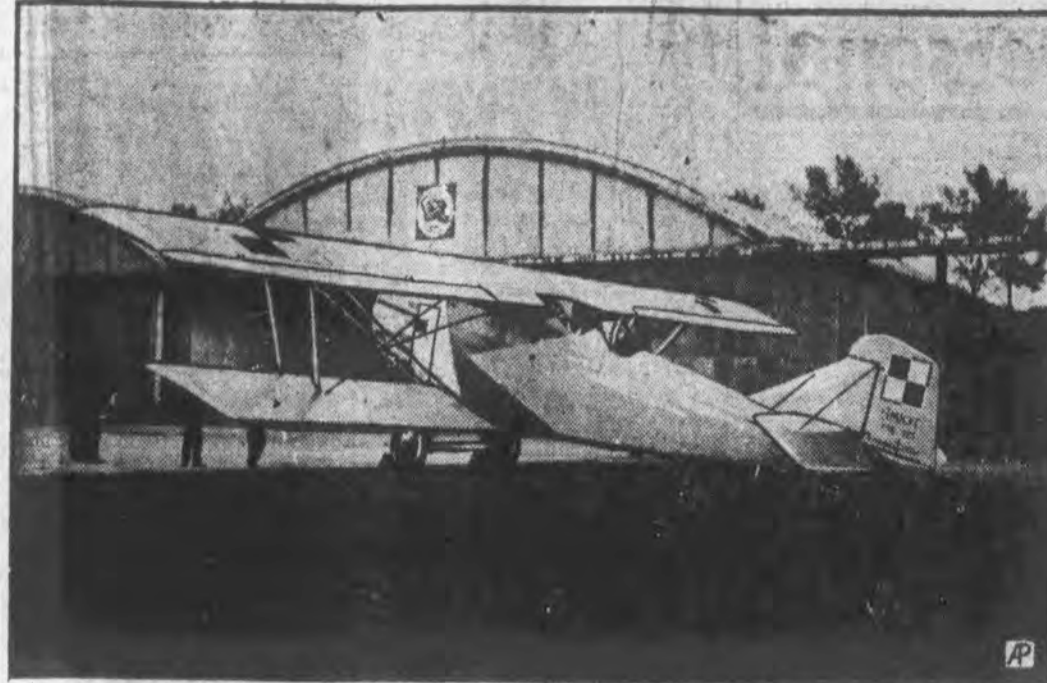

TELLS OF HIS ACTIVITY FOR HERB HOOVER

The Former Assistant Postmaster General, Says He Handled Campaign Money.

Washington, May 16.—(AP)—Rush Holland, former assistant attorney general, told the Senate campaign funds committee today about his activities in the south on behalf of Herbert Hoover, testifying that he had been active particularly in Arkansas, Louisiana, Mississippi, Georgia, Alabama, and Florida. He also had written letters to Republicans in North Carolina and Colorado.

The witness said he was a field worker and had "stopped" in Arkansas, Louisiana and Florida but had only passed through the other Southern states.

"Have you handled any money?" chairman Steiwer asked.

"I have," Holland replied.

"From whom did you receive it?"

"Ultimately from Mr. Huston."

He referred to Claudius H. Huston, former assistant secretary of commerce, who, he said, had made good to him his expenses and money advanced by Perry Heath, treasurer of the Washington Hoover headquarters.

"How much money have you received from Mr. Huston?"

"An even \$10,000."

Holland said he had also received \$400 from Heath to defray expenses.

"Have you any arrangement with Huston for further money?"

"No, my activities are practically at an end," Holland said.

"What was the money used for?"

"I can't say, but I can say what it was paid out for."

"In Arkansas I paid nothing. I offered to help out the Republican organization but it didn't need it. I paid out nothing in Louisiana. In Mississippi I paid \$2,000 to Perry Howard, the Republican national committeeman."

"In Georgia I paid \$2,000 to Ben W. Davis, the national committeeman and in addition gave him \$300 for expenses incurred by him on two trips to Washington."

"In Alabama, I gave the national committeeman \$1,000."

"What's his name?" Steiwer asked.

"Oliver D. Street."

"What else?"

"In Florida I spent \$3,000. I gave \$2,500 to what is known as the Protective Tariff League of Florida. I gave \$500 to Glenn B. Skipper, vice-chairman of the state central committee."

"Where else did you place money?"

"No other place."

"You have accounted for only \$8,000 according to my figures," Steiwer said.

Two Planes Start To Assist Bremen

Pictou, N. S., May 16.—(AP)—The two amphibian planes commanded by Major General Fechet, chief of the United States army air service took off at 10:15 o'clock eastern daylight time, this morning, for St. Georges, N. Five Minute Cabbage.

A late summary said the greater part of the four principal spring wheat states had received rain during the last few days and that there was general optimism as a consequence regarding field quotations. Moreover, export demand today for wheat from North America was of disappointingly small volume.

Wheat closed weak 2 to 2 3/8 net lower, corn unchanged to 3/8 off; oats unchanged to 1/4 down and provisions varying from 2 decline to a rise of 10.

STOCK MARKET

New York, May 16.—(AP)—Growing fears that speculation on the New York stock exchange was running out of bounds led to a heavy selling movement today which cut down or wiped out many of the earlier gains. The reaction followed another sensational buying movement in the airplane stocks, which carried Wright up 30 points to a new high record at 244 and Curtiss up 22 points to a new peak at 191. Early gains in other speculative issues ranged from 1 to 10 points.

So great was the volume of trading that the ticker fell 50 minutes behind the market by early afternoon, total sales in the first three hours running above 2,500,000 shares.

Call money renewed at 5 1/2 per cent and appeared to be in plentiful supply at that figure, but a distinctly firmer undertone was apparent in the time money market. American International Corp., which soared 8 1/2 points to new high record of 118 1/2 in the morning, broke to 109 by early afternoon. American Linseed fell from 106 3/4 to 100 and Radio from 205 to 196 1/4. Similar recessions took place in other pool activities. Adams Express, American Zinc preferred, Montgomery Ward, Kroger Stores, Cudahy Packing, Hudson and American Smelting sold 3 to 8 points below yesterday's final quotations.

Steels, public utilities and sugars showed the best resistance to selling pressure. Oils failed to make any appreciable response to the sharp decline in crude oil production last week, and coppers, which had been in brisk demand on the recent stiffening in commodity prices, ran into heavy profit taking.

The speculative mania has assumed such gigantic proportions that several of the conservative commission houses urged a scaling down of long commitments until the market has had an opportunity to strengthen its technical position which is believed to have been weakened by the rapidity of the recent advance.

The closing was weak. Total sales approximated 4,750,000 shares.

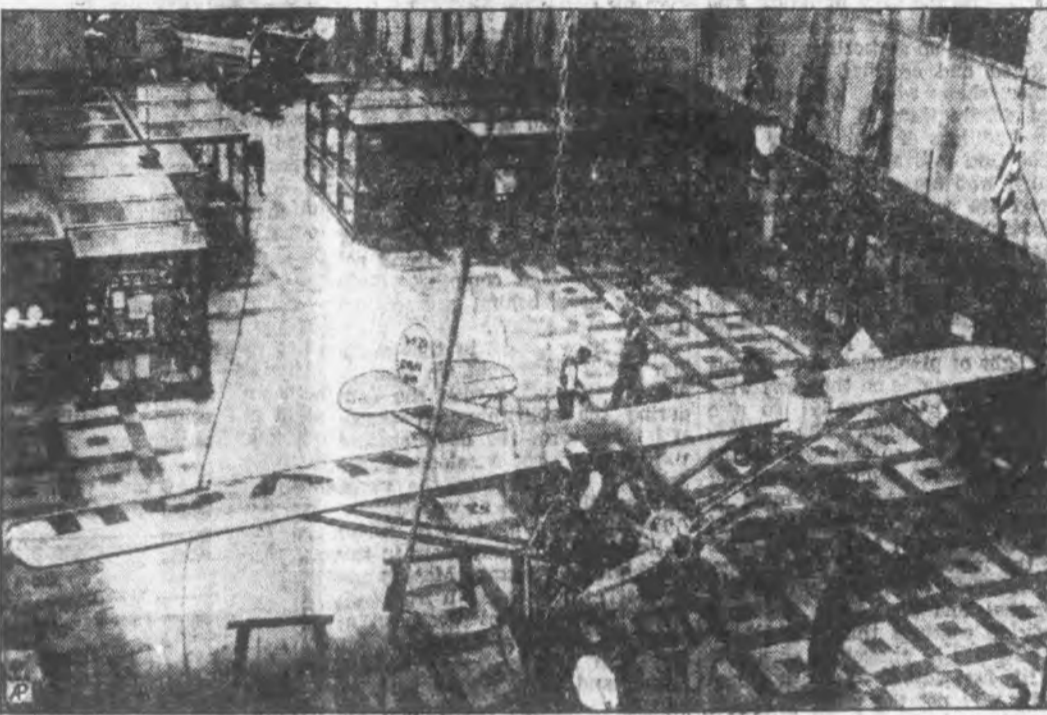

SUNDAY AGAIN HEARD BY BIG CROWDS HERE

was another great meeting they had at the foot of Mount Sinai, when the law of God was given to them amid thunders and lightnings, and fire and smoke. That was a great meeting, too, on Mt. Carmel, when Elijah, the sturdy Tishbite, defied the prophets of Baal, and that was a great meeting, too, when David danced before the ark of God, as it was borne into Jerusalem. It was a great meeting, when Solomon dedicated the temple, and the glory of the Lord came upon the people, and those were great meetings that were held on the banks of the Jordan, when Jerusalem and all Judea went out to hear the man who dressed in camel's hair and wore a linen girdle, and lived on locusts and wild honey. It was a wonderful meeting when Jesus preached the sermon on the Mount, and another when He fed the multitude with five loaves and two fishes. And that was a great meeting on the day of Pentecost, when the Spirit came down like a rushing mighty wind, and under Peter's preaching about three thousand were converted.

All these were great meetings, and any number of others have been held both in former times and in our own day. Those were great meetings in the early days of Methodism, when Wesley and Whitefield preached to great multitudes in the fields. Those were great meetings when multitudes were flocking to hear Finney and Moody; and great meetings have since been held by other great evangelists all around the world. But no meeting has ever been held anywhere or in any time that could begin to compare in importance with the greatest of all meetings that is to be held in the air, when our Lord comes to make up His jewels. That meeting is the one for which all others have been preparing the way. It will be the crowning meeting of all history. The purpose of all that has been done in this world up to the present time has been to prepare for that great meeting in the air.

From Adam mankind has been marching, step by step, up a grand stairway leading direct to that meeting in the air. The call of Abraham and his twelve sons were another; Joseph ruling in Egypt; Moses another; the deliverance under Canaan under Joshua another, and so on with every event in sacred history. It was for this Jesus suffered on the cross to make atonement for sin. It was for this He arose from the dead and ascended into heaven, where He took His place at the right hand of the Father. It was for this the Holy Spirit came at Pentecost, and it was for this that churches have been organized and missionaries sent to the ends of the earth. These things have all been done to prepare the way, and lead up to the meeting which is so graphically described in the text.

It was for this meeting God made His plans before He laid the foundations of the earth, and it was of this meeting He was thinking before the morning stars sang together. We are not told when Jesus will come, but we are told that His coming is sure, and we are charged to watch for it. Yet the church today shows as little concern about His coming again as His disciples did about His going away. All of this is fully in accord with Peter: "There shall come in the last days scoffers walking after their own lusts, saying, Where is the promise of His coming, for since the fathers fell asleep all things continue as they were from the beginning until now?"—II Peter 3:3-4. Jesus not only foretold His going away, but charged His followers to expect His return, and be ready for it: "Watch therefore, for ye know not what hour your Lord doth come. Therefore, be ye also ready, for in such an hour as ye think not the Son of Man cometh."—Matt. 24:42-44.

Every time we lift the communion cup to our lips we "do show forth the Lord's death, till He come." There is no prophecy needing to be fulfilled before Christ comes. Jesus said: "This gospel of the Kingdom shall be preached in all the world for a witness unto all nations; then shall the end come"—Matt. 24:14. There is not a nation on the face of this earth that has not had the Gospel preached within its bounds. The second coming of Christ is the emphatic doctrine of the New Testament. It is mentioned and referred to more than three hundred and fifty times, and yet the

majority of church members never heard a sermon on the subject; that is the reason they think so little of looking into the matter themselves. The church makes much of baptism, but in all of Paul's epistles baptism is only mentioned or referred to thirteen times, while the return of the Lord is mentioned fifty times. This certainly shows which he considered the most important.

McChyne, the great Scotch preacher, once said to some of his friends: "Do you think Christ will come back tonight?" One after another they said, "I think not"; then he solemnly repeated: "Watch therefore, for ye know not what hour your Lord doth come. Therefore, be ye also ready, for in such an hour as ye think not the Son of Man cometh."—Matt. 24:42-44.

With such admonitions as this, what right have we to be unconcerned about it and say, as many preachers do, "It is nothing to me; I take no interest in the subject whatever." Who would care to travel on a train where the engineer would never read his orders? Who would ride on a ship where the captain never looked at the compass? You may call it rubbish, but the disciples called it the "blessed hope." "Why call ye me Lord, Lord, and do not the things I say?" If Jesus had said, "I will not return for two thousand years" nobody would have begun to look for Him before the time was near, but He expects His followers to be always looking for His return. Just as Simeon and Anna watched and waited for His first coming, so we should be watching and waiting for His return. It is not enough to say, "Oh, I'm a Christian; I'm all right." We are not all right unless we obey the command to watch, for it is certainly as much of a command to look for the coming of the Lord as it is to keep the Sabbath holy. Nothing else will do so much to keep us right where we should be in our religious experience. Knowing that the bank examiner may drop in at any moment keeps many a cashier from becoming dishonest.

A great many say, "I believe the millennium will come first, then Christ will come at the end of it." What people think has nothing to do with it, but what God says has everything to do with it. Many have missed railroad trains because they believed they would come at a time that did not correspond with the official time card. You will see God's time card if you carefully read the Bible. Not a word can be found in the Bible that gives the slightest hope for the millennium before the return of Christ; but you can find plenty of verses that tell you to look for the coming of the Lord first.

As we look back over the two thousand years since Christ, how far we seem to be away from the time when the will of God shall be done on earth as it is in heaven. Every edition of the press seems to make it clear that the devil is still having his way. Look at the reign of wickedness in our great cities in both high life and low. No college has ever yet made a saint or ever will. Education may improve conditions, but it can never change or cleanse the heart. Look at the lukewarmness and indifference in the churches everywhere, and see what many of them are compelled to resort to in order to keep from going under. See to what schemes and dodges and foolishness some preachers have to resort to to get anybody to go and hear them.

There can be no millennium until Jesus comes; it is His presence that makes the millennium. You might as well talk of daylight not coming until the sun goes down. The millennium cannot begin until Satan has been bound in the pit. Nothing is more certain than that the glory of God shall cover the earth, but it will be after Jesus comes.

Many have an idea that the world will grow better and better until the coming of the millennium and everybody will be converted, and you hear that stuff preached, but the Bible does not teach any such trash.

On the day before the flood there were no doubt many people who were sincere in thinking that the world was growing better, and yet it was so hopelessly wicked that God had to destroy it. Some of the men who married into the family of Lot may have made the same claim for Sodom, only a day or two before its destruction; no doubt Lot's wife was of the same opinion. On the day before the crucifixion there were men in Jerusalem who undoubtedly agreed with each other that the world was growing better. The world will grow worse and worse. They did eat, they drank, they married wives, they

were given in marriage into the day that Noah entered the ark and the flood came and destroyed them all. Likewise also as it was in the days of Lot, they did eat, they drank, they bought, they sold, they planted, they builded. But the same day that Lot went out of Sodom it rained fire and brimstone from Heaven and destroyed them all. Even thus shall it be on the day when the Son of Man is revealed. (Luke 17:27-30.) Lawlessness, vice and crime will increase; communism, nihilism, anarchy, adultery, divorce, graft, all will continue to grow until they will finally ripen into the anti-Christ.

Many think and preach that the millennium will be brought about by the increase of knowledge, culture, great discoveries, such as the gasoline engine, automobile, electricity, radium, liquefied air, wireless, telegraphy, airplanes, etc. These have nothing to do with bringing the millennium. It is the personal reign of Christ that brings the millennium. Those who have been the greatest blessing to the world were filled with this hope—and preached it.

The word of God was vitiated and neutralized by the traditions of men when Jesus first came, and that is very largely the trouble in present times. Instead of going to the Bible to find out what God says, the preacher is too apt to go to his books, to see what the great men of his church have to say about it, and all their preaching and teaching takes its color from the glasses the rabbi wear, just as was the case in the time of Jesus. The fact that Jesus was not recognized by the high-up authorities, but was rejected and crucified as an impostor, shows what a dangerous and deadly thing it is to accept the traditions of men rather than what God says about things. Too many who are now masters in Israel are as much in the dark as Nicodemus was. The truth is no harder to get at than corn on the cob, if we will first strip off the husk and shell it.

It is high time for Christians to interpret unfulfilled prophecies by the light of prophecies already fulfilled. The curses on the Jews were brought to pass literally; so also will be the blessings. The scattering was literal; so also will be the gathering. The pulling down of Zion was literal; so also must be the building up. The rejection of Israel was literal, and so also must be the restoration. The first coming of Christ was literal, visible and personal, and what right has anybody to conclude that His second coming will be altogether spiritual? If His first advent was with a real body, why not the same with His second coming?

Jesus is going to come and reveal Himself to the members of His body at the very moment when the last soul is saved necessary to complete that body—for the body of Christ must consist of a certain number of souls, or it never could be completed. If it were an infinite number it would be an endless task, and Jesus would never return, for He can no more come without His heavenly body than He could come the first time without a human body. It is the completion of the body of Christ, therefore, that will bring Him, and this shows how we may help and hasten His coming. "Looking for and hastening into the coming of the day of God wherein the heavens being on fire shall be dissolved and the elements shall melt with fervent heat." (II Peter 3:12.)

When the Rapture comes it will come in the twinkling of an eye, and will be altogether unexpected except by those who have been searching the prophecies and are looking for it, just as Simeon and Anna and the wise men were looking for Jesus at His first coming. After it has occurred there will be an army of church members and preachers who will not know that it has come, because they are not members of the Lord's body; for the Lord will not at that time be seen by any except those who have been caught up to meet Him in the air. The remainder of the world will not know that He has been here, and they will not know what has become of the missing ones. They will seem to have disappeared in all kinds of unaccountable ways, unless their earthly bodies shall be left behind them, as the linen clothes of Jesus were left in the tomb. But things will soon settle back into their old condition and the world go on its way, as did Sodom after Lot was taken out.

We shall then have bodies that will remain young forever. Pains and aches, gray hair, wrinkles and feebleness will never again be known. Listen to this: "Behold, I show you a mystery; we shall not all sleep (die), we shall all be changed. In a moment, in the twinkling of an eye, at the last trump, for the trumpet shall sound, and the dead shall be raised incorruptible (no longer subject to age or decay), and we shall be changed" (into His likeness).—I Cor. 15:51-52.

"Therefore, be ye also ready, for in such an hour as ye think not the Son of Man cometh." God's clock is never behind the smallest fraction of a second. If we have a part in that meeting, it will mean that we shall be here in this world with the Lord during the millennium—a thousand years—with the devil chained and cast out—not a saloon, gambling hell or brothel in the world, and everything just as we want it. Think of how glorious it will be to live for a thousand years in this world with our blessed Master, and be closely associated with Him, with bodies that will not wear out or grow old, always in perfect health, and with facilities for enjoyment a thousand times higher than we possess now. The millennium will be the greatest time ever known, for it will be the golden age of man. Poverty, sickness, war and pestilence will be unknown. There will be no devil to cause human suffering and woe.

We are not told when Jesus will come, but we are told that His coming is sure, and we are charged to watch for it. How it would affect our lives, and make hard things easy to bear, if we would only do this, and always be doing this. Don't you know how eagerly you

get ready for company that you love, when you receive a telegram saying that they are surely coming? How you clean house and want to have everything in the very best of order! If we were continually looking for the coming of Jesus we would be as careful to keep our lives as clean as you would be to have your homes clean if you were expecting company. The certainty of His coming would also be a constant source of comfort and inspiration to us, if we believed it to be near.

The Lord does not come to the world at the time of the Rapture, but only reveals Himself to the members of His body. At the time of His resurrection He was only seen by those who believed on Him, Pilate and the high priest, and those who crucified Him, did not know that He was risen. So it will be at the time of the Rapture, the world will not know that He has been here, and will have no knowledge of Him, until He comes with the members of His body, at the close of the tribulation. What an awful thing, then, to have the glorious privilege of living in this dispensation, with all that it means, and miss getting into the body of Christ by refusing to become a Christian. The preacher owes it to his people to look into these things, that he may show them their great privilege, and warn them of the awful things that may come upon them, if they miss their chance and have to go thru the great tribulation. The preacher
