

## FEDERAL TRADE COMMISSION TOLD "HO" POWER UTILITIES GET PUBLICITY IN CAROLINAS

S. M. Boney, of Of Raleigh, Tells Of Appeal To Prominent Men And Women Of The States.

Washington, May 17.—(AP)—How publicity favorable to power utilities was obtained in North and South Carolina was disclosed today before the federal trade commission as attention was directed to the activities of the public utility information bureau working in those states.

Although somewhat evasive in replying to question, Samuel E. Boney, of Raleigh, N. C., director of the bureau, testified that by appealing to the civic pride of prominent men and women in the Carolinas he wrote articles that appeared under their names with their consent.

The articles, he said, were circulated among 6,500 newspapers, colleges and trade organizations through the bureau's monthly bulletin called "public service," and were reprinted in many newspapers.

He testified that the articles in the bulletin were directed against municipal ownership of utilities, government operation of Muscle Shoals, the Boulder Canyon Dam project and on other subjects related to public utilities.

Boney said the bureau was organized in 1924 and that he had been director for four years. Like nearly all of the other utility bureau directors, he testified he was a former newspaper man.

The bureau's membership consist of 21 street railway, electric and gas companies, among them several subsidiaries of national groups of power companies, he testified. Among the national groups, he said, were the Virginia Electric and Power Co., a subsidiary of Stone and Webster, Tidewater Power Company of Wilmington, N. C., recently acquired by the Insull interests of Chicago and the Duke Power Company.

The witness said the bureau was being operated for interstate operating companies and that approximately \$4,000 is spent annually in furthering public relations. He testified that the bureau cooperated with the National Electric Light Association, the joint committee of National Utilities Associations, and the State Utility Bureaus in the exchange of literature and methods of obtaining publicity.

Boney failed to produce all the minutes of the meetings of the bureau's steering committee explaining that George H. Conklin, of Augusta, Ga., secretary and treasurer of the bureau, had them. He was ordered to submit the minutes later.

The witness was questioned about an authorized payment of 150 to Professor Thronckle Saville, who was described as a hydraulic engineer in the Carolinas. The payment had not been made but was authorized Boney said, because Saville had drawn a map of the Carolina Power lines which was produced in the Winston-Salem Journal. He said the director of conservation and development of North Carolina had requested the bureau to pay for the work on the map.

By maintaining personal contact with Carolina newspaper editors, about 300 columns of utility publicity distributed by him was published during the past year, the witness said, most of it being printed without any indication of the source.

Boney testified that he had written the editor of the Charlotte, N. C. News whom he believed to be Julian Miller, and had succeeded in having printed an editorial he had written in opposition to Boulder Dam based on the argument that if the dam was built it would create a competitive cotton growing district.

The witness said he had advocated in his speeches and literature the doctrine that municipal ownership of utilities retarded the industrial growth of the Carolinas.

### Colombia Flier To Fly From N. Y. To Bogota Soon

New York, May 17.—(AP)—Lieut. Colonel Camilo Daza, head of the army air force of Colombia, arrived today to fly from Mitchell field to Bogota, Colombia, over the route taken by Col. Charles A. Lindbergh in his good-will flight.

Col. Daza expects to hop off before June in a Swick plane with a home motor, the plane arrived two weeks ago and will be assembled at Mitchell field.

## LONG'S PLANE WRECKS AGAIN

### Ship Practically Destroyed In Impact With Auto Crossing Landing Field.

The Waco airplane of Matt D. Long, local cotton mill man, was demolished yesterday afternoon when it collided with an automobile in landing at Mr. Long's private landing field near this city. Mr. Long escaped unhurt. The automobile was badly damaged by the impact.

Mr. Long had made several practice landings and was coming in for the final landing when the crash occurred. The ship had been brought down to a perfect landing and was rolling across the field when it collided with a small automobile driven by a man named Profit, that had driven across his "blind spot." The flier had no warning that the car was on his landing field until the impact came.

This second time within four weeks that the Waco plane has been wrecked. The first time Mr. Long, accompanied by Ben Dixon McNeill, Raleigh newspaperman, smashed his landing gear when taking off from a heavy field and was forced to land on one wheel, the plane burying its nose in the earth.

Repairs from this accident were completed the first of the week. Alton Stewart, pilot of the North Carolina Airways, Inc., of Raleigh, took the ship through every conceivable test yesterday morning. Mr. Long took Mr. Stewart back to Raleigh by air and made a safe return to Greenville. He made several practice landings after arriving here, and that last time he came down and made a perfect landing on the crash cause.

The radiator, windshield and top of the automobile were smashed. The airplane lost three wings and a section of its landing gear.

## United States And Other Nations Take Action To Save Nationals In China

Shanghai, May 17.—(AP)—Northern forces were moving into position today to battle against the southern forces threatening Peking as American and other foreign troops prepared to protect their nationals in Tientsin, fearing it would fall into the hands of the nationalists.

Companies of American and British soldiers, who were beginning their summer training at Shanhaiwan and Chinwangtao, were ordered to return to Tientsin. American marines, Italian and Japanese soldiers barricaded the exposed points in the foreign concession area and threw walls of sand bags about them. Other preparations for the defense of the concessions went forward steadily.

Peking, May 17.—(AP)—Threatened by advancing nationalist troops, Peking was tense today. Larger patrols than usual moved through the streets of the native city and about the foreign concessions. Preparing for the defense of the legation quarters made by the guards, whose senior officer is Lieutenant-Colonel Thomas Holcomb, United States Marine Corps.

Japanese soldiers worked actively providing quarters for several hundred of their troops near the former Australian legation and strengthening their defense.

British nationals were warned by their legation to be prepared to move into the legation quarters at short notice. Valuables were being sent for safekeeping by Chinese and foreigners to the various legations.

American troops were assigned to defend the southern boundary, marked by the Tartar wall and they shared the western "Front" with the British. The French took the east boundary and the Japanese, Italians and British the North.

In Tientsin, also threatened, 3,950 American soldiers formed a portion of the defending force. The troops there included the third marine brigade under Brigadier General Smedley D. Butler, a strong marine aviation detachment under Brigadier General Joseph C. Caster. Other forces at Tientsin include 2,200 French Colonial, 1,600 British infantry, 400 Japanese and 375 Italians. Lieutenant General Arai of the Japanese Army is senior officer.

Tokyo, May 17.—(AP)—In view of the increasing uneasiness in Peking and Tientsin because of the nationalist advances, instructions were issued to the Nagoya division today to divert regiments of infantry and a battery of artillery from Tsingtau to Tientsin.

## MANY STATES REPRESENTED AT ATLANTA

### Presbyterian Commissioners From Seventeen States Present At Assembly Today.

Atlanta, Ga., May 17.—(AP)—With the election of a new moderator to succeed Dr. Robert F. Campbell, Asheville, N. C., and organization of the assembly as the chief work for the initial day's sessions, commissioners from 17 southern states gathered today for the seven day 68th annual general assembly of the Presbyterian church in the United States.

Before relinquishing his chair to the new moderator Dr. Campbell brought to the commissioners, the annual sermon of the presiding official to be followed by the rites of the Lord's supper. No business was to be transacted until the afternoon session when the election and organization follow the annual custom.

Union of the church with other branches of the Presbyterian church, adoption of the annual budget, reports from the committee on assembly's work and the various subcommittees, together with general legislation for the coming year, from the topics to come before the assembly during the sessions which end on May 24.

Among the overtures to be considered is one from the Presbytery of Florida seeking to have the church sever its relation with the federal council of churches in America. This matter was brought to vote upon another overture at the last assembly in Eldorado, Ark., and the church decided by one vote to stay in the council.

Another overture from the presbyteries of western Texas, central Texas, Mangum and New Orleans seeks to have the church appoint a committee to study the scriptural grounds for divorce because of desertion and report to the next assembly whether any action should be taken. The overtures, declaring that increasing divorce bring threat of more extensive breaking down of "all that is holy in marriage and family relationships," asserts that approach has been brought upon the church for solemnization of marriage rites in cases of persons divorced on the grounds of desertion.

Christianity began its course in the world with preaching, must be continued by preaching, and must reach its consummation by preaching. Or, R. F. Campbell, pastor of the first Presbyterian church of Asheville, N. C., and retiring moderator of the Southern Presbyterian church, told the annual general assembly today.

"It is sometimes said that the pulpit is declining in power; that preaching has not the hold it once had," Dr. Campbell said. "If this is true, it is true only where the pulpit has blinked the fact of man's fall, has yielded to an easy-going exception of sin, and can, therefore, no longer proclaim with pugnacity and power the necessity of repentance and man's part as a condition of remission on God's part through the sacrifice of his son."

Taking his text from Luke 24:46-48, Dr. Campbell declared the text presented Christianity as a unique religion.

"Christianity is unique in that it has a vital relation to a prior revelation. And he said unto them, 'This it is written.' Christianity then was not a new and unheralded religion. 'Christianity is unique in its relation to certain outstanding facts in the history of its founder.

"Our Lord in the text puts to the front, as the cardinal facts, his sufferings and his resurrection, for he said: 'It is written that the Christ should suffer and rise again from the dead the third day.'

### American Eliminated

Hunstanton, May 17.—(AP)—America's sole surviving representative in the British women's open golf tournament, Mrs. Dorothy Campbell Hard, was eliminated three and two by Miss Judith Fowler today.

### Cape Town Flier Reaches Croydon Air Field Today

Croydon, Eng., May 17.—(AP)—Lady Heath, formerly Mrs. Elliott Lynn, the first woman to fly from Cape Town to Europe, arrived at Croydon in a light airplane from Le Bourget today. She has completed a 10,000 mile solo flight from Cape Town from which point she started on February 12.

Lady Heath experienced a number of mishaps during her long flight including a sun stroke and forced landing at Bulkyway on Feb. 26, where she was found unconscious on the veils. She had an attack of fever at Tripoli on May 1 and damaged her airplane at Tunis.

## Senate Campaign Funds Committee May Go To Raleigh

Washington, May 17.—(AP)—The senate campaign funds committee probably will go to Raleigh next Monday to question a number of persons in North Carolina about reports of heavy expenditures for campaign purposes.

Senator Steiwer, Republican, Oregon, chairman of the committee, said today he had been supplied with a long list of witnesses who are assumed to have information about the expenditures. The chairman said it would expedite matters for the committee to go to Raleigh rather than summon such a large number of witnesses to Washington.

## BEGIN TAKING EVIDENCE AT TERRY TRIAL

### Daughter Of Murdered Dressmaker Takes Stand Today In Pittsboro Court.

Pittsboro, May 17.—(AP)—The married daughter and two sons of the victim were the first of a string of witnesses called by solicitor Claxton Williams today as he began his effort to convict W. Herbert Lawrence, wealthy contractor, of the murder March 24 of Mrs. Anne B. Terry, dressmaker, of Durham, whose body was found in the Cape Fear river early in April.

Lawrence's name was not mentioned during the testimony of Mrs. Mary Yandle, the daughter, and of her brothers, Robert and Edgar, but the defendant followed every word of evidence with marked attention. Judge Romulus A. Nunn acceded to requests of counsel for both sides that witnesses, except members of the families involved, be excluded from the court room during the testimony of other witnesses.

Mrs. Yandle told of her mother receiving a telephone call about 7 o'clock in the evening of March 24, a few hours before a woman's screams were heard by two fishermen at Avents Ferry bridge in lower Chatham county, followed by the sound of a heavy object striking the water, but no further information about the call was developed. The young woman, dressed in black, also gave evidence as to the clothing worn by her mother on that night.

Robert Terry testified that he drove his mother down and left her in front of a department store between 7:30 o'clock and 8 o'clock. She was wearing a felt hat. At this point a hat was offered in evidence, and identified by the witness as the one worn by his mother. It was said to have been picked up on the highway near Avents ferry on the day following the disappearance of Mrs. Terry. Edgar's testimony had to do mainly with the fact that his mother left home that Saturday night and was not seen again until her body was found in the river.

Orin Holmes testified that Mrs. Terry stopped in his clothing store between 7:30 and 8 o'clock. On cross examination he said his store was between Main street and the bus station where, he replied to an inquiry, buses could be taken for various points in the state.

Drowning was given as the cause of the woman's death by Dr. Chas. Scott, coroner of Lee county. He described a small depression found on her head saying it was of a size that would have been made by a small hammer. No other injuries were mentioned by the witness.

Mrs. Yandle was asked by telephone counsel if she had not telephoned a relative in Charlotte to ascertain the name of a man to whom her mother had been introduced, during the time intervening between the finding of the body and the arrest of Lawrence. She answered in the affirmative. It developed, however, that this man was one of those who came from South Carolina after the crime and was released.

She swore she had "an uneasy feeling" when she read in newspapers of the report by two fishermen that a woman's screams, "Don't kill me, please don't kill me!" had been heard at the ferry bridge because her mother was absent from home.

Lawrence's name was brought in to the testimony for the first time by Robert Dixon Durham contractor. The last witness examined before Judge Nunn ordered a recess at noon until 2 o'clock. Dixon swore he saw a man he thought was the defendant in an automobile with another person between 7:30 and 8 o'clock at the intersection of Holloway and Dilard streets in Durham.

## GIVE REVISED ESTIMATE OF COTTON CROP

### Department Of Agriculture Provides Figures Covering All States For 1927.

Washington, May 17.—(AP)—Revised estimates of last year's cotton crop announced today by the department of agriculture places the area in cultivation on July 1 at 49,985,000 acres, the yield at 154.5 pounds and the total of cotton actually picked at 12,955,000 equivalent 500 pound bales. Ginnings of the 1927 crop totalled 12,950,473 equivalent 500 pound bales as announced by the census bureau.

These figures compare with a June 25 area of 48,730,000 acres for the crop of 1926, a harvested area of 47,057,000 acres, a yield of 18.6 pounds of lint per acre and a total production of 17,977,000 equivalent 500 pound bales.

### Juror's Home Is Bombed At Chicago, Ill.

Chicago, May 17.—(AP)—The home of Fred W. Elche, one of the jurors who convicted Eugene (Red) McLaughlin of highway robbery two days ago, was bombed last night.

Elche himself was not at home. His wife, their three children, a sister and six guests at an informal party being held in the two story frame structure were severely shaken.

Shortly after the bombing Elche was at the detective bureau identifying Gus Steinwick, secretary and treasurer of the Chauffeurs and Teamsters Local No. 742, as one of the two men who last Monday attempted to bribe him.

### South Carolina Democrats Vote For Dry Candidates; Session Marked By Brawl

Columbia, S. C., May 17.—(AP)—Governor Smith may have opposition in the Houston convention from South Carolina Democrats, but not the kind his arch enemies in this state had mapped out for him.

After a hectic day meeting in which the lie was passed and a brawl indulged in by former Governor John Gary Evans, of Spartanburg, leader of the bone-dry bloc, and Edgar A. Brown, of Barnwell, a former speaker of the South Carolina house, the state Democratic convention last night elected 13 delegates to the national conclave, and a national committeeman and committeewoman.

The delegates will go uninstrued as to the presidential candidate, but with directions to work for a dry nominee and dry platform.

Anti-Smithites lost in their attempt to instruct the delegates against Smith or other candidates of similar views; their resolution being voted down at the day session by a vote of 190 to 147.

Another resolution, rejected 194 to 147, and over which the first fight occurred, would have abrogated the state party rule binding those voting in the South Carolina primary to support the national and state nominees in November.

Proposals favoring retention of the unit voting rule and the two-thirds majority nominating rule were approved.

The fight between Evans and Brown climaxed a period of tense debate. Evans had argued for abrogation of the state rule on the ground that it was illegal and was keeping potential Democratic voters out of the party. Brown denounced the attempt as a "menace to solidarity of the Democratic party and to white supremacy."

## THREE MARINE BIRDMEN OFF TO NICARAGUA

### Big Monoplane Hopped Off From Miami this Morning Shortly After 5 O'Clock.

Miami, Fla., May 17.—(AP)—Three United States marine corps fliers hopped off at 5:15 o'clock this morning in a transport monoplane for Managua, Nicaragua, 1,100 miles distant.

Dawn had just broken on the flying field here when the giant plane roared down the 3,500 foot long runway and rose gracefully like a great sea bird before it had covered two thirds of the runway. The plane circled the field and then sped away in the early morning mist toward Havana, Cuba.

Lieut. H. B. Palmer, commanding officer, and his companions, Lieut. R. H. Hughes, radioman, and Sergeant Steel, mechanic, were on board the fourth marine plane to leave here recently for service with the corps in Nicaragua against the rebel leader, Augustino Sandino.

Two of the flights were completed without a stop. The other was halted at Tela, Honduras, 250 miles short of the goal, by darkness.

Good flying weather prevailed here and reports to the Tropical Radio Telegraph Company from land stations and ships over much of the route indicated favorable conditions.

## SUNDAY MAKES GREAT APPEAL FOR THE HOME

### Evangelist Declares Society Does Not Make Man Sin, Unless He Wants To.

"Is It Well With Thee?" This was the text upon which Billy Sunday preached to a fairly large congregation assembled at the warehouse-tabernacle last night. Distinctive in presentation as all Sunday sermons are, this message was driven home with striking originality, and carried conviction to those who had been in doubt about the exact position they should take in the moulding of their own destinies.

Tonight Mr. Sunday will speak to members of Battery E, 13th North Carolina national guardsmen. The artillerymen will attend in a body, dressed in full uniform. They will assemble at the armory promptly at 7 o'clock and then leave for the tabernacle.

The Patient Circle of the King's Daughters will also attend services in a body tonight, it was announced this morning. Members of the organization will assemble at the Christian church at 7 o'clock and go from there to the tabernacle.

These are among the prominent organizations the evangelist has preached to during his three and a half weeks' stay here. He will speak on the subject of "What Must I Do To Be Saved." It will be one of the great sermons of the series and the large warehouse building where services are being held is expected to be packed to capacity.

"There are not enough devils in all the world to make a man sin if he doesn't want to," Mr. Sunday told his hearers last night, "and there aren't enough angels in heaven to make him decent if he chooses otherwise."

"If society is rotten it is because of the individuals in it that make it rotten; therefore, don't blame the preacher, nor the devil."

Numbers of gripping illustrations were brought into play at different stages of the discourse, and again the evangelist found his powers of an actor to great advantage. Apparently infuriated at the activities of the devil, Mr. Sunday brought his chair into play again and swung it around as if to hurl it at an imaginary foe sitting out in the audience. Violence of action always produces a ripple of laughter, and the evangelist smiles like he enjoys it himself.

"If society isn't what it ought to be, perhaps you are not what you ought to be, so stop blaming society and trying to square yourself that way."

"Don't blame us. Great heavens! we are only humans. I am trying to do my best for God, don't blame us. Don't blame the devil. All the devil can do is tempt you. He can't make you sin."

"I'll tell you what to do. Go home, look into the mirror and say—'God, there is the old lobster' in there that is to blame. There's the wop—that fellow right there. 'Is it well with thee? No, not if you are without Christ,' and with this admonition ringing in the ears of his listeners, the evangelist presented illustrations that greatly increased the effectiveness of the text.

The sermon follows:

This evening in the Second Book of Kings, the fourth chapter and the twenty-sixth verse: "Is it well with thee? Is it well with thy husband? Is it well with thy child?"

Years ago in Cincinnati, one night at a rich, fashionable church the minister had made his appeal, and as he came to the close of the sermon the Spirit of God seemed to say to him, "Make your appeal personal. Ask if there isn't somebody here tonight who wants to have it settled."

### Personal Appeal.

He never had done it, but the spirit seemed to say again: "Make your appeal personal. Ask if there isn't somebody now that is sick of sin."

And when they concluded the song the minister said: "Is there a man or woman here that is sick and tired of sin and you want to be a Christian? I feel constrained and drawn to ask you. Will you lift your hands?"

He waited, and there was no response. He made the appeal again and the door opened and a young man entered and dropped into the rear seat.

He made the appeal again, and this young fellow jumped to his feet, lifted his hand and then he cried out so that the audience was startled: "Pray for me. I am sick and tired of sin, and I have made a wreck of my life," and then he dropped, weeping, to the pew.

The minister prayed. The weeping was dismissed. Nobody spoke to the young man as he went out. The minister came down the aisle and talked with him, learned a sad story of prodigality and wandering, learned that his father and

# W' LARNING TO FIGHT CHAMP SAM MANDELL

New York, May 17—(AP)—Baby Face Jimmy McLarnin—the Harp that twanged the cords in Sid Terris chin just once to become the lightweight sensation of the day—will have his chance tonight to strum knock out music on the jaw of Sammy Mandell, champion of the division.

Odds of 2 to 1 were laid, however, that Mandell would evade the knockout wallop in McLarnin's right hand. Mandell was a bare 6 to 5 favorite in the fight if it went the limit.

Mandell, a natural lightweight, expects no difficulty with the scales while McLarnin, who started his career as a flyweight, was close to the class limit of 135 pounds.

The boys who put their cash on Mandell, despite the all round skill and ring craft of the champion, shuddered a bit at the thought of what happened when that other ring flash Sid Terris, collided with an eight inch thrust of Jimmy's right fist in the recent indoor season. Although the pinch traveled too fast for the eyes of most of the 15,000 gathered in Madison Square Garden all saw over Terris twitching from the shadow of a champion—for that night at least.

With the hysteria of that sensational one round knockout deadened by time, ring critics now believe that Mandell despite his unwillingness to risk his title more than once in the two years he has held it, is too fast and clever for the challenger. Although McLarnin boasts knockouts in the past year over tough Kid Kaplan, in addition to Terris, and a decisive victory over Billy Wallace Cleveland contender, critics forecast that Mandell will outsmart the California Cit.

Mandell, although he has engaged in titular battle only with Phil McGraw since winning the 135 pound crown from the aging Rocky Kansas has warded off ring rust with 30 fights in the last two years.

Every man on the Knoxville team connected safely, street leading the attack with four for five, and scored at least once. Hamilton handled 12 chances at second base without a bobble.

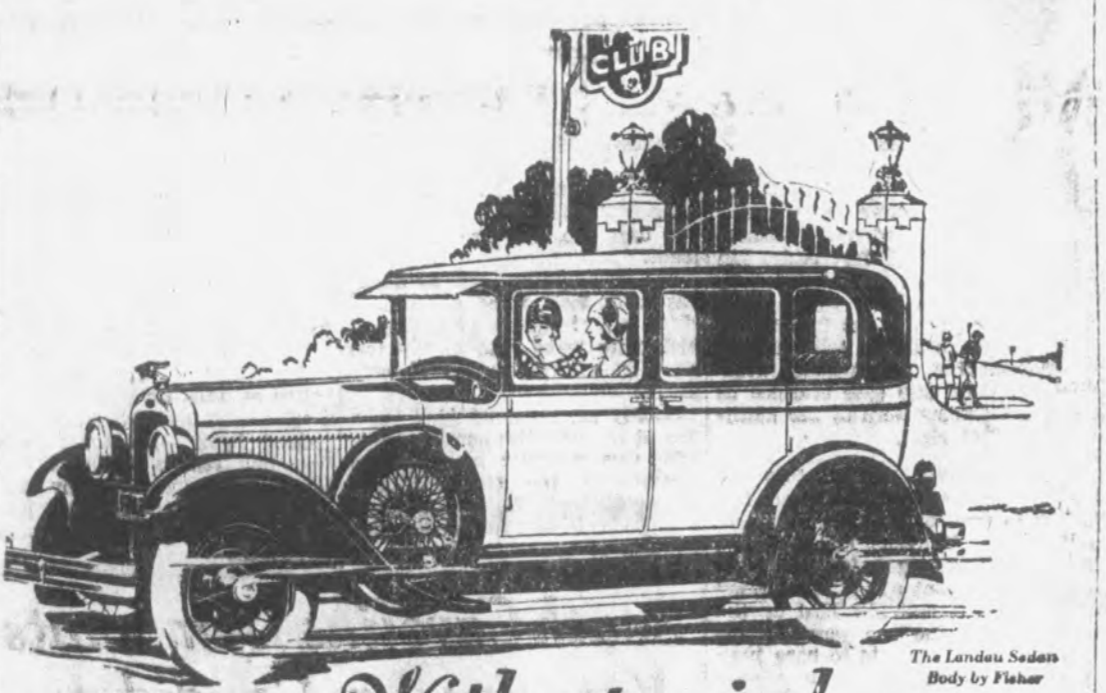

mother lived in Brooklyn and he hadn't heard from home for seven years, and he didn't know whether they were living or dead.

**Father Dies.**  
The minister advised him to write home and tell them where he was and what he had done. He didn't expect an answer back for four days, but when the fourth came there was no answer. The fifth day, there was no answer, and he was worried; the sixth day there was no answer, and he was troubled; the seventh day there was no answer and he was in distress; the eighth day no answer, and he was in agony.

The ninth day and the answer came, but the envelope was bordered in black. With tear-dimmed eyes and trembling hands he broke the seal, and he read something like this: "My Precious Boy—The joy which your letter brought to our home and hearts was only exceeded by the sadness which reigned there at the same time, for as nearly as we can conclude, the same day and the same hour that you say you found Jesus Christ as your Saviour in the church in Cincinnati, your old father was going out into the skies.

"All day long he tossed and rolled upon his bed, and his mind would roam and wander and he would cry out, 'Oh, God, save my poor, wayward, wandering boy!'"

**Prayed For Boy.**  
"We would attempt to turn his mind from your prodigality and drunkenness and wandering, but he would come back to it and cry out, 'Oh, God, save my poor, wandering, wayward boy!'"

"Just before he passed on, he cried, 'Oh, God, save'—and he finished the prayer in the presence of Jesus."

Down at the bottom of the letter the mother added this postscript: "Edward, you are a Christian tonight because your old father would not let God go nor take 'no' for an answer."

"Oh, for men and women who know how to pray like that! Great God, for wives that could lay hold upon the Lord for husbands; parents for children, friends for friends, so that they would be swept into the Kingdom of God and yield for Jesus Christ."

I would like to make my message tonight brief and make it personal, so that not a man or woman could leave this tabernacle and honestly say: "He didn't mean me. That didn't apply to me."

"First, 'Is it well with thee?' and I will answer that much of it for every unsaved man or woman in this tabernacle. How could it be well with you? If you were to die, you would be in hell before midnight. How can it be well with you when the wrath of God is upon you, when God's hand is against you? How can it be well when you are a rebel to God and God's kingdom, and living in rebellion, and nothing but the mercy of God prevents His wrath from falling upon you?"

God said to Jesus Christ: "I commission you to go down and tell them to never mind what they have done, forget the past and remember that I have a full pardon for them, free and eternal."

It never enters into consideration what you have been and what you have done, if you are only ready and willing to forsake your stains. God stands ready and willing to forgive them, no matter what you have done—that is not the question with the Lord. And then, because of the life and death and resurrection of Jesus Christ it is made possible to do His will and keep His commandments.

Then said Baird: "You may put two chains on me; I will wear mine and his. Put two around me instead of one."

And they locked two chains around him and they carried him out and dumped him into that infamous well at Calcutta. This other man was exchanged and he went back to England and until the day he died he never tired in private or public of sounding forth the praises of the man who, by wearing his chain had made it possible for him to creep back again into the arms of his wife and of his children.

**Christ-like.**

Oh, if that man had worn all the chains that would not have been analogous to what Jesus Christ did when He made it possible for every one of us to keep out of hell. I don't see why you want me to kill myself trying to get you to do what is right. I think that with one message anybody

New York, May 17.—(AP)—Nervousness over the weather outlook in the south was reflected in considerable covering or rebuying in the cotton market today, together with moderate trade and commission house demand. Prices advanced 40 points or more on the more active positions and while demand tapered off around 21.25 for July and October, the mid-afternoon market held within 8 or 10 points of the best.

## GRAIN MARKET.

Chicago, May 17.—(AP)—With light rains in the American and Canadian northwest and further moisture in the domestic winter crop belt, wheat prices went decidedly lower today. July delivery on wheat here fell to about 23 1/2c a bushel under the recent high level. Unfavorable wheat crop reports from India with the harvest in the united provinces and in Punjab yielding 25 per cent less than the official estimate were virtually ignored.

Wheat closed heavy, 2 1/4 to 1 1/8 net lower, corn at 3 1/4 to 1 1/8c advance, oats 1 1/8 to 1 1/4c off and provisions 2c to 2 1/2c up.

## STOCK MARKET.

New York, May 17.—(AP)—Marking up of the call money rate to 6 per cent, following the calling of about \$30,000,000 in bank loans, checked a spirited recovery in prices on the New York stock exchange today. Initial declines of 1 to 6 1/2 points had been largely recovered by noon, and in a number of instances replaced by gains ranging from 3 to nearly 15 points, but these were substantially reduced, or wiped out in the afternoon selling movement.

Stiffer call money also was accompanied by a raising of time money rates from 5 per cent to from 5 1/8 to 5 1/4, the highest since October, 1923. While U. S. treasury officials were reported having expressed the opinion that the expanding business activity was a factor in the lightening of credit conditions here, the ordinarily bullish effect of such a pronouncement was offset by fears that the New York federal reserve bank discount rate would be increased from 4 to 4 1/2 per cent after the close of the market.

American Telephone and Telegraph common was the outstanding individual feature in today's market, soaring nearly 35 points to a new high record at 211 on buying "influence" by the proposed increase in capitalization with the offering of valuable "rights" to shareholders.

Violent fluctuations again took place in the airplane stocks. Wright opened 6 1/2 points lower at 213, soared to 229 and then fell back to 212 1/2 on the outbreak of selling which followed the increase in call money. Curtiss opened unchanged at 150, Radio dropped from 191 1/8 to 184 and Jersey Central sold down to 352, or 8 points below the previous quotation. Collins & Altman sold down 3 points to a new 1928 low at 69 1/2.

Strong buying support was provided for Park and Tilford, International Harvester, Cushman's Bakery, Atlantic Gulf and West Indies, American Lined and National Tea, all of which either moved into new high ground or showed advances of 5 points or more above yesterday's final quotations.

Supporting orders turned the current of prices strongly upward again before the close. Total sales approximated 3,500,000 shares.

## Campaign Expenses In New Jersey To Be Probed by Reed

Washington, May 17.—(AP)—Expenditures in the Republican senatorial primary in New Jersey will come under the gaze of the Reed campaign funds committee.

Before the final returns were in from the Tuesday balloting, the senate late yesterday ordered the inquiry, adopting without a record vote a resolution offered by Senator Caraway, Democrat, Arkansas. The senator based his proposal on New Jersey newspaper accounts charging requests that the primary candidates list their campaign expenses and charges that one candidate had offered \$200,000 for a certain individual's influence.

Five candidates were in the Republican senatorial race and a most complete returns today showed Hamilton F. Kean, former Republican national committeeman for New Jersey, to have been nominated. His nearest rival was Edward C. Stokes, former governor, who, the newspapers related, had urged that all candidates bare their expenditures.

Caraway said the other candidates had not seen fit to answer Stokes.

Although the resolution seeks an investigation of both party races, it most likely will be confined to the Republican as Senator Edwards, Democrat, was unopposed for re-nomination.

Tokyo, May 17.—(AP)—The flag-ship Pittsburgh of the United States fleet in Asiatic waters sailed for Tientsin, China, today after an eight day visit to Japan. Admiral Mark L. Bristol will board the destroyer Pillsbury at Shimoneseki for Tientsin tonight.

Harris, Atlanta, president of the American Cotton Manufacturers' Association, in session here today.

"I am frank to admit that I believe there is room for improvement in the present method of future trading in cotton," he said. "I am opposed to the price of cotton being based on New York contracts with exclusively New York as the

This, in my humble opinion, is largely responsible for many of our troubles; and I urge southern cotton manufacturers to give this matter the full consideration it deserves, and I urge upon you to use your influence in bringing about a southern delivery contract. possible reactions, I am of the opinion that future contracts will more nearly reflect, at all times, the market for the actual, if deliveries were possible at designated southern points that are now and always will be large spot markets. I believe that our New England friends who now oppose southern deliveries on these contracts, would find much improved operating conditions, even though it required the elimination entirely of New York delivery. Certainly, New York is no more a spot cotton market, and

I fail to see how it is possible for any conditions to arise in the future through which New York could be made such a market."

SUNDAY MAKES GREAT APPEAL FOR HOME

I have often tried to imagine it, but at every attempt I have been forced to register a failure, if Noah and his wife, seated in the ark and the storm howling over the world, rain beating upon it, and finally he turns to his wife and says:

"Where are the boys?" "Where are the boys?" She says: "Oh, they will be out a little while. I set the lock so they can get in. They have gone down to the cabaret. They will be back in a minute."

I have tried to imagine father and mother seated in their home contented and their children gadding around—and the average boy and girl can learn more deviltry between sundown and 10 o'clock than all the Sunday school teachers can eradicate in a year.

"Would you have us keep our children in from morning to night?" said a woman.

"No. Keep them in the house from night to morning." And I will thank God Almighty when the curfew will ring in every city and hamlet in America, and if the parents don't keep their children off the streets that law will grab them by the back and anywhere else it can get hold of them and pitch them into the dooryard of the home.

Why, the average little frizzle-headed sissy that hasn't sprouted long skirts yet—well, you don't judge them, because some old dames have them short, too, you can't tell whether they are 12 or 15.

"Many people stop, right where they ought to go on, increasing in their desire to help in the world. You are interested in their education. Good! We have not the finest public school system in the world, and we tax the people and if a man has no children and he has property it is a just and right tax to educate the other people's kids.

"We have got the finest public schools on the face of this earth. We manifest great concern in their laws. I believe they ought to be in the school instead of in some underground workshop. They ought to be in school, they ought to be in the parks. I believe in a minimum scale of wages; I believe in all that. I believe in anything that is going to uplift humanity, make it easier, and living conditions better.

"All honor to the father and mother who will work and deprive themselves of even the comforts of life in order that their boy may get an education and not have to work all his life as you had to; the opportunities, and with great concern for their health; when they are sick, you will send for a doctor; that is if you have got any means. That is a good one, isn't it?"

"How About Souls?" "And you work to earn three meals a day for them. You will work to get them a bed to sleep in and worm clothes to wear when it is cold and cool clothes to wear when it is hot.

"All honor to you; but if your children walk the streets and if they can say that a stranger taught them to pray and taught them all they know of the Bible, and they go home and hear nothing but oaths and blasphemy and never hear the name of Jesus Christ except in profanity, what about that? You have got concern for their education, but what about their immortal souls?"

"You ought to pray for them; and spend too much time in society, too much time in business, too much in literature, too much in club life—and too little time with your children. You bring them into the world and then turn them over to some governess or nurse who is only interested in so many dollars a week. She takes care of them while you hit the cocktails and the Dutch lunches. Oh, no wonder the dogs turn out better than the kids; live right before them.

"Do you know if I wasn't a Christian and I had a boy and girl, I would give my heart to Jesus Christ tonight and I would go home and get them out of bed and awaken them from their sleep and they would hear my voice in prayer before they ever slept the night

through. That is what I would do—I'd start right now for Jesus. "Is it well with their child? I preached one time in Troy when I was with Dr. Chapman. There was a man there named Hector Hall, pastor of the Presbyterian Church. He told me this story: "He came from Scotland previously, either from Aberdeen or Dundee—I don't remember now—but this is the incident. There was a man over there an ex-drunkard, who was as noted as a preacher in that country as John B. Gough or John G. Wooley were here.

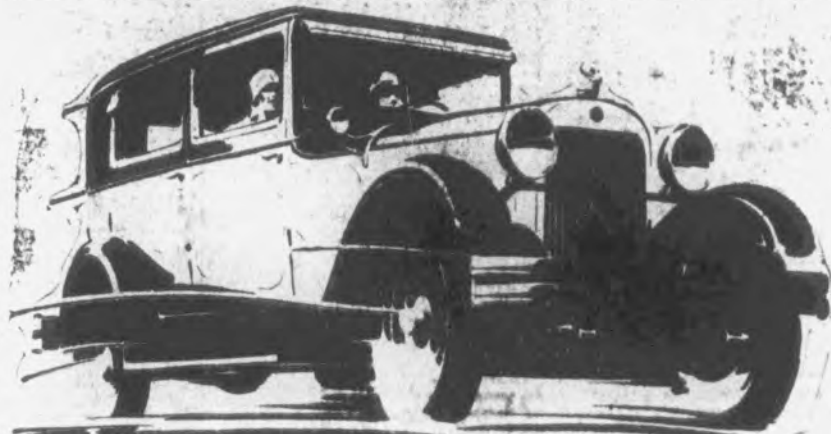
