## THINK CALLES MAY CONTINUE AS PRESIDENT

### Congress to Meet July 30 To Settle Question of Presidential Succession.

Mexico City, July 20.—(AP)—A Congress, made up mainly of supporters of Alvaro Obregon, will meet in special session on July 30, presumably to settle the question of presidential succession raised by his assassination.

It is generally expected that a way will be found to continue President Calles in office. A nine-day period of mourning will be observed throughout Mexico, in the meantime, for the slain President-elect, whose body today was traveling on a special train to his native state of Sonora for burial.

Twenty Catholic nuns from the town of Villa Guadalupe, where the shrine of Our Lady of Guadalupe, patron saint of Mexico, is situated, were arrested and the convent was closed. Police charged that they were operating secretly in violation of the religious laws. They were held at police headquarters where the slayer, Jose De Leon Toral, is in a dungeon.

A placard bearing the words: "You are avenged," was found on the tomb of the priest Miguel Pro, who was executed last November for being involved in the attempt to assassinate General Obregon with bombs. Police said a picture of the priest was found in the assassin's pocket.

The newspaper El Universal Grafico, said police were investigating reports, the source of which was not revealed, that some of the former leaders of the League for the Defense of Religious Liberty were recently involved in a plot against Obregon. The league had been most active in expression of opposition to the Mexican religious laws. It was suppressed by police about two years ago and its subsequent activities, if any, have been clandestine.

President Calles today was under a heavy military guard. The precautions were taken at the behest of his friends, although Calles has rejected any idea that his personal safety was in danger.

Special police guards were placed around the residents' residences of all prominent supporters of General Obregon. The guards were stationed after a suspicious character, found loitering near the home of Senator Thomas A. Robinson, Obregonist leader, had been arrested and questioned. A slip of paper found on the assassin at the time of the crime bore, among other words, "Robinson," and at that time it was assumed that these were the names of men singled out for death.

Police Chief Zertuche exhibited De Leon Toral to a group of Mexican and foreign newspapermen in police headquarters to put an end to reports that he had already been executed secretly or had been mutilated.

He was taken away without the reporters being allowed to ask him any questions.

The slayer's left eye was black and swollen, there were a few bruises on his face but all traces of blood had been washed away. It was intimated that the bruises had been sustained in the scuffle which followed the assassination.

The youth's face had an expression of extreme weariness and betrayed lack of sleep.

Indications were that supporters of Obregon would accept to continue President Calles as the head of the state, if it could be done with any shadow of legal sanction.

Newspapers polled members of the Obregon congressional bloc and found that at present they were ready to proclaim Calles their chief replacing Obregon.

Friends of President Calles believe that he does not desire to continue in his post. They feel that he has been anticipating with much pleasure his retirement to private life as a dairy farmer.

The country has settled down to every outward appearance of tranquillity. Censorship which became effective the night after the slaying, was lifted.

## Death Of Lowenstein Still Great Mystery

Calais, France, July 20.—(AP)—The remains rested today in a little grey casket beside the prison here awaiting the widow who is en route from Brussels. She will make the formal identification after which the body will be transferred to Brussels.

Finding of the body will permit immediately the preliminary work of winding up the vast Lowenstein estate. Had the body remained unrecovered legal experts feared that it would be years before this work could be completed and that his great holdings would be tied up indefinitely. A Belgian court had already refused to issue a death certificate.

The body was battered and decomposed when found by a fishing smack floating face downward ten miles off Cape Griz Nez. The sea had stripped it of clothing except part of the underwear and shoes. On a watch on the wrist was engraved: "Captain Lowenstein, 35 Rue De La Science, Brussels."

There was a deep wound in the abdomen and three gashes on the left breast and the left shoulder. It was thought probable that these had been made by the propeller blades of channel steamers.

Dr. Boulfroy, who examined the body, found nothing to show the exact cause of death, whether he was drowned or killed by the shock of the fall from a height of 4,000 feet. All he could do was to make absolutely certain of the identity of the victim by the dental work which he had known that Captain Lowenstein had done. It was considered probable that the case would be turned over to an examining magistrate shortly.

## BULGARIA IN QUARREL WITH JUGO-SLAVIA

### Sealing Of Frontier Between Two Countries Follows Strained Relations.

Belgrade, Jugo-Slavia, July 20.—(AP)—Civil war in the ranks of the Macedonian revolutionaries has caused the sealing of the frontier between Jugo-Slavia and Bulgaria, a dispute between the two governments, and a strict censorship at Sofia.

The quarrel in the Comitadj ranks is a sequel to assassinations of leaders in the Macedonian organization, particularly the killing of General Alexander Protogerov who was assassinated in Sofia on July 8. Ivan Mihailoff, prime mover in the Comitadj organization for four years was reported slain by partisans of Protogerov early this week.

Since then there have been daily bloody encounters between followers of these two men. The central committee of the revolutionary movement, deprived of outstanding leadership, has split over the division of power and spoils.

## PLANE TO DROP FLOWERS OVER TRAIN OF DEAD

### Hundred Army Planes to Escort Caranza Funeral Train To San Antonio.

Texarkana, Tex., July 20.—(AP)—The body of Captain Emilio Caranza, Mexico's good-will flyer, killed in a plane crash a week ago, crossed the Arkansas line into Texas early today.

After a change of crews here, the funeral train left for San Antonio from where it will continue to Laredo to be turned over to Mexican officials.

San Antonio, Texas, July 20.—(AP)—Military agencies of the state and nation were marshalled here today to pay tribute to the memory of Captain Emilio Caranza, whose funeral train arrives late today.

Plans called for an airplane to circle about and drop flowers on the train bearing the broken body of Mexico's premier aviator, who was killed in a crash in New Jersey last week, when it entered the state at Texarkana early today.

A hundred army airplanes were to assemble here and fly to New Braunfels, 30 miles northeast, to escort the train into San Antonio. Flowers were to be dropped as the train approached the station here.

A company of the Twenty-third Infantry was detailed to remain with the train as a guard of honor.

## HELD UNDER BOND FOR AUTO WRECK

Washington, July 20.—(AP)—W. A. Wells, alleged driver of the automobile in which Miss Mamie Smith of Windsor was fatally injured in an accident Wednesday was held at liberty today under bond of \$2,500 pending trial of charges growing out of the tragedy. H. B. Roberts of Salisbury, Md., said to be the owner of the car, remained in a hospital here with injuries received in the accident.

## Hall Dies At Halifax

Durham, July 20.—(AP)—Joseph S. Hall, 67, native of Halifax county, Va., and for the past 40 years a funeral director, died here yesterday following a brief illness.

Funeral will be held Sunday afternoon.

## TAKES OWN LIFE AFTER KILLING TWO

### Prisoner in N. Y. Jail Shoots Keeper and then Himself in Dash For Liberty.

New York, July 20.—(AP)—Faced with life imprisonment as a fourth offender under the Baumes laws, a prisoner in the Bronx county jail killed two keepers in a desperate effort to escape last night and then shot and killed himself.

Armed with two revolvers he had obtained in an unexplained way he shot his way through two tiers of cells and when two shots into the lock of a steel door leading to a fire escape failed to open a way to freedom he blew out his brains.

The convict was John F. McCabe, 25 years old, whose police record dated back fourteen years. The two keepers he killed were Morris Broderson and Daniel Horgan, neither of whom was armed.

Broderson had just unlocked the cells on the fourth tier of the jail to give the convicts an exercise period before locking them in for the night. This was being done because of the heat.

When he unlocked McCabe's cell the convict started to complain that he was not feeling well, as the guard turned to unlock the next cell door McCabe pressed a revolver against Broderson's abdomen and fired twice. The keeper grasped McCabe around the legs and was dragged to the stairway leading to the lower floor. Here this grip was broken. Unlocking the door to the fourth tier McCabe ran downstairs.

Horgan, keeper of the third tier, had heard the shots and ran for the stairs. Halfway up he met the escaping prisoner, who fired twice at close range, killing almost instantly.

Stepping over the prostrate body, McCabe ran down the cell tier to a door which opens on a fire escape. He twice threw himself against the door. Failing to budge it he fired two shots into the lock. Again he futilely shook the door and hearing the pounding of feet up the stairs he turned his gun against himself.

## Volcano Mayon Is in Eruption

Manila, July 20.—(AP)—A violent eruption of Mayon, the volcano in Albay Province which recently became unusually active, today terrified the populace for miles in all directions. Business in Legaspi and smaller towns near the base of the volcanic mountain was paralyzed.

Lava shot from the crater in a dense column of smoke, which cast a pall over much of the province. The activity was accompanied by a deep rumbling which intensified the terror of an already panic-stricken populace. A deluge of hot ashes was reported to have fallen over the villages of Tabaco and Malilipot.

Governor General Stimson announced he would leave Manila tomorrow aboard the cruiser Trenton for Legaspi to investigate the situation.

## Make Big Haul French Liquors At Wilmington

Wilmington, July 20.—(AP)—Several hundred cases of what was said to be fine French liquors were captured by coast guardsmen by the cutter Modoc last night at Woodside, near Topsail Inlet, according to information reaching here today.

One prisoner was understood to have been captured and an automobile confiscated.

According to meagre information reaching here, the capture was made as the liquor was being loaded into a freight car, presumably for consignment. Several barrels of potatoes found near the liquor were believed by officers to have been intended for camouflage.

## Four Trainmen Die As Freight Leaves Tracks

Omaha, Neb., July 20.—(AP)—Two engineers and two firemen were killed about 2 a. m. today when a double header Wabash freight train plunged into a rain swollen creek, near Mineola, Iowa, 14 miles east of Council Bluffs. The torrential rains of the night had filled the creek, washing out the central spans of the wood trestle. Six cars of the 54-car train piled into the creek following the locomotives.

The dead: D. D. Tucker, 44, engineer; George Wilson, 43, engineer; Jesse Davis, 23, fireman; John Batts, 23, fireman.

All of the victims lived at Stansberry, Missouri.

## Seize \$1,000,000 Liquor Cargo At New York Today

New York, July 20.—(AP)—A cargo of alleged pre-war rye whiskey, estimated to be worth \$1,000,000 at retail, was seized today by customs agents on the Red Cross liner Nerissa.

The contraband was in kegs under pickled herring which had been brought in large barrels from Halifax, N. S. The Nerissa docked in Brooklyn yesterday.

An agent of the appraisers' office was checking cargo to be delivered to truckmen last night when he found a ten gallon keg of whiskey at the bottom of the first barrel of herring, he explained. A hurried search showed that a similar keg was apparently at the bottom of each of the 501 fish barrels.

Smith and Anderson, Manhattan fish dealers, were the consignees of the fish and said they received shipments regularly from Halifax.

## HOOVER BACK IN OLD HOME STATE TODAY

### Republican Presidential Nominee Crosses Continent For Notification.

Aboard Hoover Train, July 20.—(AP)—Herbert Hoover was back in his home state today, having crossed the continent in order that he might receive formal notification of his nomination as the Republican presidential candidate at Leland Stanford University, from which he set out thirty-odd years ago to make his place in the world.

His coming was without ceremony elaborate receptions planned for him at San Francisco and Palo Alto have been postponed because of the death of Mrs. Hoover's father, C. D. Henry, funeral services for whom were to be held this afternoon in the University Chapel.

## TWO DROWNED WHEN PATROL BOAT SINKS

Cape May, N. J., July 20.—(AP)—Two coast guardsmen were drowned and five rescued today when the steamship Culbertson sank coast guard patrol boat No. 113 in a thick fog off the Delaware Capes.

## STEAMSHIP CULBERTSON RAMS COAST GUARD BOAT DURING FOG ON DELEWARE CAPES.

According to the story told by the survivors Delaware Bay was covered by a dense fog and the CG-113 was proceeding slowly along on patrol duty. Suddenly out of the murk loomed the high bow of the freighter. It struck the 75-foot government boat square amidships, cutting it in half as though with a giant knife.

The two missing men were in the engine room and are believed to have been rendered unconscious by the force of the impact while the other five men were hurled into the sea.

## GOVERNOR TRUMBULL IN FLAME WRECK

New London, Conn. July 20.—(AP)—Connecticut's "Flying Governor," John H. Trumbull, escaped injury this morning at the new state airport at Groton when two planes came together while landing. There were three machines in the air, one of which was piloted by the governor.

In landing two of the planes came to rest safely, but the third, on some mania, yet unexplained, crashed into the one in which the governor had made the flight. Two mechanics on duty at the field suffered minor injuries.

## Democrats Determined To Control Congress

Albany, N. Y., July 20.—(AP)—In their efforts to put Governor Smith in the White House, the Democrats intend to overlook no opportunities to capture control of congress.

The Democratic Presidential nominee himself already had discussed the Senatorial phase of the question with two Senators of his political faith—Tydings for Maryland and Hawes of Missouri—and before long he undoubtedly will be acquainted with the situation as it affects the house of representatives.

Tydings who is chairman of the Democratic Senatorial campaign committee, and Hawes, one of its members, gave Governor Smith a first hand insight into their contemplated activities at conferences which terminated here yesterday.

They proceeded to New York to confer with party leaders, determined to work in close cooperation with the Democratic national committee in an effort to overturn the slim Republican majority in the Senate.

As they prepared to make their fight to wrest congressional control from the Republicans, the Democrats are faced with the necessity of upsetting a minority of 39 in the house. The lineup in the Senate during the close of the last session was 47 Republicans, 46 Democrats, one Farm-Labor and two vacancies.

In all 35 Senatorial seats are at stake in the November elections. Of these the Democrats hold 20, the Republicans 14 and a Farmer-Labor 1.

Among the Democratic seats involved in the coming election are those of Ashurst of Arizona, Bayard of Delaware, Bruce of Maryland, Copeland of New York, Dill of Washington, Edwards of New Jersey, Gerry of Rhode Island, Hendrick of Wyoming, King of Utah, Locher of Ohio, Neely of West Virginia, Pittman of Nevada, Reed of Missouri, Walsh of Montana and Wheeler of Montana, with only one exception—Reed of Missouri—Senators now holding offices are seeking re-election, and the fact that they come from debatable states in the north and west is giving the Democratic Senatorial campaign no little concern.

In their efforts to build up a Democratic majority in the Senate party leaders are hoping to pick up seats in some of the states where Republican Senators are up for re-election. In this group are the seats of Cutting of New Mexico, Fess of Ohio, Frazier of North Dakota, Greene of Vermont, Hale of Maine, Howell of Nebraska, Johnson of California, LaFollette of Wisconsin, McLean of Connecticut, Reed of Pennsylvania, Robinson of Indiana and Vandenberg of Michigan, besides the seat formerly held by the late Senator Gooding of Idaho and that claimed by Smith of Illinois.

## MR. COOLIDGE IS TERROR TO RIVER TROUT

### President Performs Unusual Feat of Getting Two Fish on a Single Cast.

Superior, Wis., July 20.—(AP)—President Coolidge not only is catching fish every time he goes out on the Brule but, on an average of every other day, he is performing the unusual feat of getting two trout on one cast.

He thrilled newspapermen and photographers July 4 his fifty-third birthday, by pulling from the river two good sized fish on one throw of the line, but it was not known until today that he is repeating that stunt regularly by putting one fly on the line's dropper and the other on the end of the line.

The President made a double catch yesterday, getting a 1 1/2 pound brook trout and a 1 3/4 pound Lochlaven. He did the same thing the previous day.

Rain or shine, Mr. Coolidge is on the river six days a week, twice each day, except when he comes to the executive offices on Tuesdays and Fridays. In high white rubber boots, a dark oiled silk raincoat, and his inseparable ten gallon hat, he was out in the steady down pour nearly all yesterday.

After his morning's fishing, Mr. Coolidge has luncheon, then comes his nap, followed by the afternoon trip on the river. The morning's fishing is omitted on days he comes to Superior.

Sundays only finds Mr. Coolidge refraining from the pastime which has taken many of the wrinkles and the tired expression from his face. Routine then is changed to include church, more rest and during the week he averages four hours a day on the water about Cedar Island Lodge, and brings in an average of six trout each morning and twice that amount in the afternoon.

A light of pride showed in LaRoc's eyes when he told of the President's fishing.

## NATIONS ALL SET FOR END OF WARFARE

### All But Two of Fourteen Countries Report Favorably on Kellogg Proposal.

Washington, July 20.—(AP)—All but two of the fourteen nations to which Secretary Kellogg submitted his treaty for the renunciation of war have formally appraised the Washington government of their willingness to sign the compact.

Japan and Czechoslovakia alone remain to be heard from and the state department has learned through diplomatic channels that they, too, are favorably inclined and that their acceptances are expected within a few days.

It is a source of particular gratification to Secretary Kellogg that none of the nations have suggested changes in the text of the draft treaty as revised and submitted together with his explanatory note on June 23. He is pleased too with the promptness with which the replies have been received.

The number of countries approving the pact was brought to an even dozen by the acceptance of Great Britain and by Dominions, Canada, Australia, New Zealand, South Africa and India, replies from whom were made public last night.

A note transmitted directly from Ottawa over the signature of W. L. Mackenzie King, Secretary of external affairs, bespoke briefly the attitude of the Canadian government. Canada, it said, "cordially accepts the treaty as revised and is prepared to participate in its signature."

For the London government, Foreign Secretary Sir Austen Chamberlain, set forth the interpretation, places upon the provisions of the treaty and declared that "his majesty's government in Great Britain are glad to join with the United States and with all other governments similarly disposed in signing a definite treaty for the renunciation of war."

The note specifically stated the British understanding of the terms of the treaty, and of the provision for retaining the statutory nations of all obligations under this pact to any state violating the convention, and of Secretary Kellogg's understanding that the right of self defense is implicit in every treaty whether specifically alluded to or not.

The only suggestion of a reservation was in a reference to a passage in Sir Austen's note of May 19 which said that the welfare and integrity of certain regions constituted a special and vital interest to the London government.

"I need only repeat," the note of acceptance said, "that his majesty's government in Great Britain accept the new treaty upon the understanding that it does not prejudice their freedom of action in this respect."

Alluding to British obligations under the covenant of the League of Nations and the treaty of Locarno, objects of special consideration by Great Britain in her previous discussions of the proposed treaty, Sir Austen said that British government "concur in the view" that "those obligations do not contain anything which could conflict with the treaty proposed by the United States government."

The British secretary also transmitted the replies of New Zealand, Australia, South Africa and India.

# PLAN RAISING FUND TO PAY HOOVER FIGHT

## Republican National Committee Wants \$3,000,000 For Coming Campaign.

Washington, July 20.—(AP)—J. R. Butt, treasurer of the Republican national committee, is making plans for raising at least \$3,000,000 to meet the cost of the Hoover Presidential campaign.

This figure, he believes, cannot be considered excessive. In estimating the amount of to be spent, he referred to the fact that the Coolidge campaign of four years ago, entailed disbursements of that amount, and remarked, "We have a harder fight on our hands this time."

Arriving in the city yesterday, Nutt conferred with Chairman Work of the national committee on the financial aspects and organization of the campaign. Later, the appointment of Jeremiah Milbank of New York, as eastern treasurer was announced.

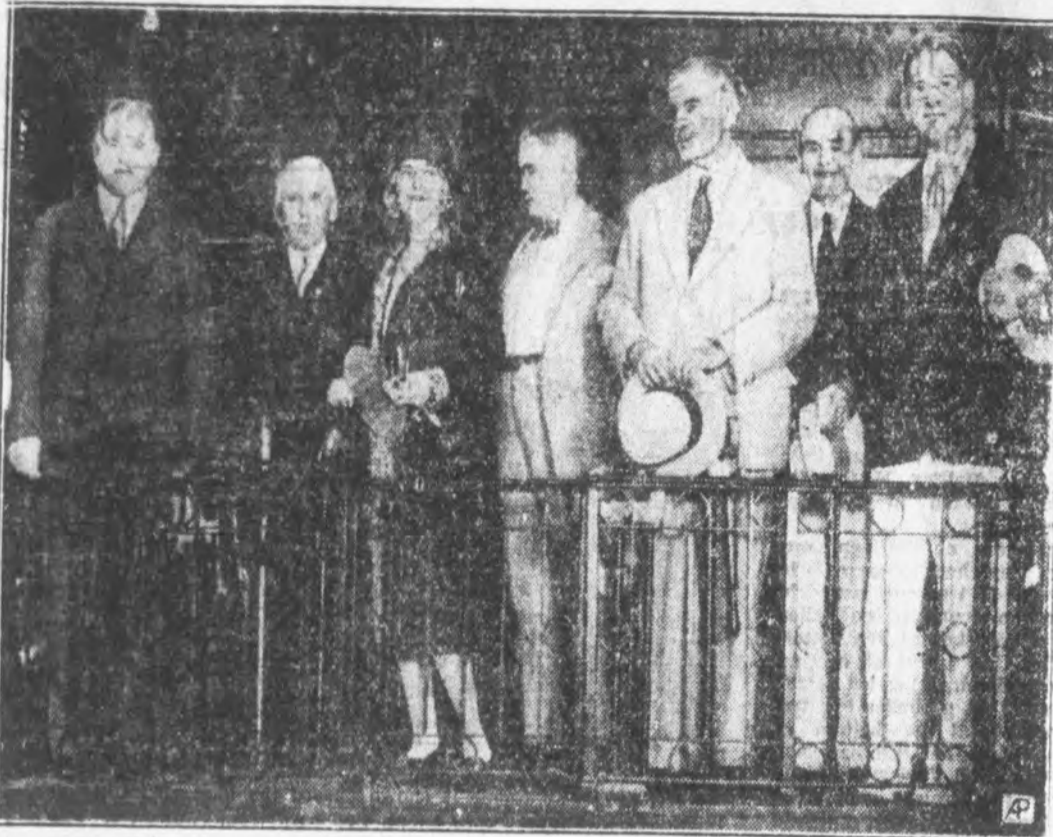

### Small Crowds At Opening of Davis Tennis Cup Play

Auteuil, France, July 20.—(AP)—Only an handful of spectators braved the cloudy, sultry weather and threat of rain to visit France's new Davis Cup stadium for the opening of the inter-zone Davis Cup finals, bringing the United States and Italy together. Only about 300 spectators were in the stands when Frank Hunter, who replaced Capt. Bill Tilden, went out to play Placido Gaslini, who replaced de Stefania as Italy's representative in the first match.

## Cotton Spinning Activities Off

Washington, July 20.—(AP)—The census bureau's analysis of cotton spinning activity for June, made public today, showed active spindle hours for the month totaled 7,247,726,545 or an average of 203 hours per spindle in place, compared with 7,139,112,795 and 222 for May this year and 9,191,907,036 and 249 a year ago.

Spinning spindles in place June 30 totaled 35,749,944, of which 28,624,488 were operated at some time during the month, compared with 35,814,390 and 29,060,360 for May this year and 36,765,872 and 32,753,428 for June last year.

The average number of spindles operated during June was 31,569,503 or at 88.3 per cent of capacity on a single shift basis, compared with 34,014,029 and 95 per cent for May this year and 30,265,932 and 109.2 per cent for June last year.

THERE ARE OTHER ISSUES

To those persons who are openly urging the election of Hoover because of Smith's personal attitude toward the liquor question, we would issue a word of warning lest in their haste to defeat Smith because of his views on this question they will overlook other issues that are equally or even more important to the nation at this time. In the first place, while Smith has openly declared that he is of the belief that the prohibition laws should be modified, we have confidence that should he be elected President of the United States he would, as he has declared, see to the enforcement of the dry laws so long as they remain a part of the constitution. With a dry Congress and a dry Senate, to block any effort at legislation to change the dry laws and to pass on appointments made by the President, we see little or no chance of Smith weakening prohibition either through legislation or the courts.

So far as Hoover is concerned, he has not declared that he is against any modification of the prohibition laws, in fact he has to this time, since his nomination, avoided a direct statement on the question and by his election we can at best see only a continuation of such enforcement as we have had under the Republican administration for the past seven and a half years, which needs no explanation from us, for we all know the farce of the Republican enforcement of the prohibition laws.

Therefore, with no assurance that we can better ourselves by defeating Smith because of his prohibition views, let us turn our attention to the other matters of great importance to the nation. Despite repeated efforts and attacks nothing has been brought to light that would place the Smith administration in New York in disrepute, while on the other hand, the records of the Republican administration of the affairs of our nation since 1921 reek with scandal. To defeat Smith and Democracy is to endorse this past record of the Republican party and return it again to power in order that special privilege and corruption might continue to rule the land at the expense of the people.

When the farmers appealed to the Kansas City convention for a platform plank that would assure some relief for agriculture their representatives were denied admission to the convention

and the party by its action in effect slapped the farmers of the nation in the face. On the other hand, the Democratic convention adopted a plank that assured the farmer of every effort by the party to give the necessary relief and Governor Smith has declared that if elected he will not wait until he reaches the White House to begin his efforts at legislation for the relief of the farmers.

Regarding flood relief, the tariff, conservation of water power resources and other measures of like importance to the nation, Governor Smith has clearly defined his attitude and declared to be for the masses of the people, while the record of the Republican administration clearly defines that party's attitude as being for monopolistic control and special privilege. And so it is all along the line with the issues that at this time are of importance to the masses of the people of the United States of America and we sincerely urge those who can only see the prohibition issue in the coming election to think carefully lest in their zeal to defeat Smith because of his views on the prohibition question, they also defeat the other important issues that are entitled to consideration. This is indeed, a time for caution.

ELECT "DRY" LEGISLATORS

Since Governor Smith professes to believe in State's rights as applied to prohibition, it remains for the country to make application of this principle in the selection of members of Congress and of the several State Legislatures. This course is earnestly and forcefully recommended to the country by Josephus Daniels, one of the best known Democratic leaders in the country and a "dry" first, last and all the time.

Mr. Daniels proposes to counterbalance the "wet" stand of the Democratic Presidential candidate through the election of "dry" Senators and Representatives. Of course, this strategy applies to the election of members of the State Legislatures also. Each state has the right to elect "dry" Senators and Representatives who will resist any and all efforts to modify the prohibition laws or to repeal them altogether.

Congress has been the stronghold of prohibition during the past eight years of melancholy prohibition enforcement on the part of the Republican administrations. It has heard the resounding verbal assaults delivered on the floors of the two Houses against prohibition without wavering. Control of the Senate by the "drys" is of added importance since this body has the prerogative of confirming new appointees to the Supreme Court. Thus far in the history of the Eighteenth Amendment it has been consistently upheld by the highest tribunal in the land. But every "dry" champion and leader realizes how easily prohibition could be weakened—perhaps overturned altogether—by a court inimical to the Eighteenth Amendment. — The Winston-Salem Sentinel.

The writer mentioned home-grown watermelons in this column a day or so, and ever since the employees of the office have been getting their lips all set for the first product.

We have been wondering what "crop" of the country is going to lead in the first melon this season. Last year Greenville township took first place and it was a luscious piece of fruit that found its way to the desk of this scribe.

Mr. Farmer, kindly bear in mind that we occupy the position of official sampler of watermelons. We are judge of fine art as it pertains to this particular branch of industry and always stand in readiness to offer our services to those desiring it.

"North Carolina has the largest peach crop in years," said a Pitt county grower today, commenting on an article dealing with the number of carloads of fruit shipped this year.

"The crop is so large that peaches are being hauled to various parts of the state on automobile trucks. Prices at the beginning of the season are good, and the decline has been slight the last few days.

This is the first time in a number of years North Carolina has produced such a bumper crop. People fond of canned peaches should get busy and put up their own goods for the fall and winter months.

"Some say they can be purchased just as cheaply from the stores. But you can't get a member of these county demonstration clubs to say so. They have familiarized themselves with the art of canning and preserving to such extent that countless numbers of homes realize splendid savings in the course of a year by having their own stuff to use.

"In case you don't know much about preserving get in touch with some of the club members and let them put you on the road to prosperity."

## FRANCE WANTS TO SEE TILDEN BACK ON TEAM

New York, July 20.—(AP)—The United States Lawn Tennis Association is to stand on its exclusion of Big Bill Tilden from Davis cup play, despite the request of the French tennis federation that he be reinstated.

American officials announced that the French request that Tilden be permitted to play in the inter-continental finals against Italy today, and if successful in that series, against France in the challenge round, will be received with every courtesy and consideration. But, it was added, there was virtually no chance that the order dropping Tilden from the team would be rescinded. He was dropped because he wrote about matches at Wimbledon in which he took part.

Paris, July 20.—(AP)—The disqualification of Big Bill Tilden from Davis Cup play made him a more popular figure in France today than ever. Always admired because of his surpassing ability as a player, Tilden now has won his way into the hearts of the French people.

The French believe that no praise can be too great for the dignified, unselfish way he met the blow which removed him from the field of action in the Davis Cup battle for the first time, in nine years, and jeopardized America's chances in the inter-continental final against Italy starting today and even more in the challenge round against France. After making his formal protest, Tilden's first thoughts were how he could best promote the fortunes of the American team. He decided at once to devote all his energy to training his younger comrades for the difficult task ahead of them.

Tilden realizes that the prospects of the American team are far from brilliant, and he deeply deplores, more than the decision itself, the way it was sprung without warning on the rest of the team. He feels that the greater injury to him and to the team lies in the fact that his disqualification came at the eleventh hour—after his long months of painstaking efforts to develop a strong American squad to try to wrest the trophy from France.

"The Davis Cup play without Tilden," says L'Auto, "would be like Mona Lisa without the smile."

The first two singles matches in the inter-continental final against Italy today found Francis T. Hunter pitted against G. De Stefani, second ranking Italian, and John Hennessey against Baron H. J. De Morpurgo.

## Tunney Enters Last Stage Of His Training

Spectacular. N. Y., July 20.—(AP)—Gene Tunney today entered the last stage of his training for defense of his world's heavyweight title against Tom Heenehy in better physical shape than he has ever been in his career.

In addition, he was probably better fitted mentally than he ever has been since he took up boxing for a livelihood. He has been training here for almost three months and during that time but two incidents have occurred which caused him any annoyance.

One was the attack on the New York Boxing Commission accented to Tunney and the other was a baseless rumor that he intended to retire from the ring after the Heenehy match, regardless of the decision.

Both of these incidents came up during the past week or so, but Tunney by his prompt denials overcame them without damage to his high strung temperament.

Late this afternoon Gene was slated to go through the first of his last three training sessions with his sparring partners, Harold Mays and Billy Vidabek, the Bayonne, N. J., heavyweights.

Tunney had a day of rest yesterday when his medical adviser, Dr. Robert J. Shea, a New York surgeon, gave him a thorough examination. It showed that Tunney was in splendid shape. His heart test indicated that he had accumulated much more reserve power than he has ever possessed before and the increased development of his shoulder muscles denoted greater punching ability.

Boston finally managed to end a one game losing streak by pounding out a 9 to 4 verdict over the Cincinnati Reds.

### STOCK MARKET.

New York, July 20.—(AP)—The stock market displayed a complete reversal of form today, selling off sharply at the opening and then rallying briskly. Early heaviness undoubtedly was due to speculative disappointment over the relatively small decrease of \$48,000,000 in brokers' loans, but the marking down of the call money renewal rate of 5 per cent, the lowest since May 7, revived bullish enthusiasm.

Wall Street apparently was pleased at the sharp decrease in federal reserve discounts in the New York district. Importation of \$1,000,000 in Canadian gold was more than offset by the withdrawal of \$14,000,000 in earmarked gold for shipment to France.

Fears of a stiffening of money rates later in the month still persist, and have a restrictive effect on trading.

Mercantile and mail order issues again attracted special buying on reports of large current business. McCrory Stores common and the B stock and Montgomery Ward all moved into new high ground. Steel shares reflected the optimistic trade predictions of better business in the last half of the year, gains of 1 to nearly 3 points being recorded by U. S. Steel common, Bethlehem, Republic, Vanadium, Gulf States and Colorado fuel.

Eastman Kodak ran up more than 7 points and Allied Chemical, American Inter-National and American Linseed sold 2 to 3 1-2 points higher. Case Threshing, Midland Steel Products preferred, Kelvinaor and American Express were under pressure.

The closing was firm. Total sales approximated 1,300,000 shares.

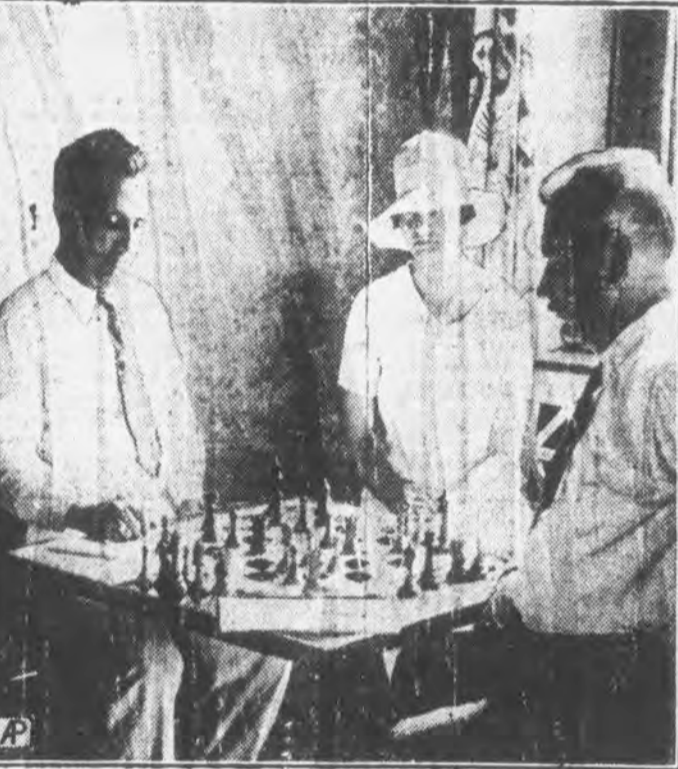
