

GOVERNORS OF SOUTH TO MEET IN MISS. SOON

Round Table Conference to Feature Discussion of Cotton Problem.

Jackson, Miss., Nov. 3.—(AP)—Governors and legislative committees of the cotton growing states are to meet here in round table conference, talk over the cotton situation and seek uniform action, Governor T. G. Bilbo of Mississippi said today.

Governor Harvey Parnell, of Arkansas and Governor Bilbo are to issue the invitations in accordance with an agreement made between the two governors and neither is to offer any arbitrary proposal, Bilbo said.

"We are just going to sit down at a table and talk this cotton situation over and try to get together, that's all," said Governor Bilbo.

Louisiana, which state passed a cotton holiday law for next year, will be presented at the conference along with the states which have adopted the acreage curtailment plan and those who have not acted yet.

The date for the conference is yet to be set.

Greenville, S. C., Nov. 3.—(AP)—Governors of Georgia and South Carolina, flanked by senators and other high officials, will gather at a banquet here tonight to celebrate the completion of a paved highway between Greenville and Atlanta.

Following the banquet, the party will adjourn to a grand ball which is sponsored by the Junior Chamber of Commerce.

A motorcade, left Atlanta early today in the celebration of the highway, was made at Toccooca, Ga.

Diamond Broker Kidnapped; Loses \$200,000 Jewelry

Chicago, Nov. 3.—(AP)—Joseph C. Newman, New York diamond broker, reported to police today that he had been kidnaped in the downtown district by two men, driven to the outskirts of the city, robbed of \$200,000 worth of jewelry and released.

Newman reported the theft to the detective bureau. He said the two men apparently followed him as he left his hotel. They accosted him at Congress and South Washington avenue, just south of the Loop, and forced him to drive to the South Side. He had intended calling on customers, Newman said.

League Pleased With U. S. Action on Arms Holiday

Geneva, Nov. 3.—(AP)—Great satisfaction was expressed today by officials of the League of Nations at the news that Washington regards the one-year armaments truce as already morally effective.

Now that the replies of 37 governments to the holiday proposal are being analyzed, league authorities believe that the "move or an arms truce may properly be considered to have accomplished something valuable in preparing for next February's disarmament conference.

Bulgaria sent its affirmative reply today. Rumania suggested the truce agreement embody a provision for penalties in case of failure to fulfill its engagements.

German Wheat Goes To Bad

Berlin, Nov. 3.—(AP)—Wet weather, which is causing millions of bushels of French and German wheat to sprout in the shocks, is eliminating some of the world's surplus wheat depressed markets during the spring and summer.

In German market circles, it was said that from 30,000,000 to 50,000,000 bushels would be unfit for milling because of the weather and would have to be used for fodder.

The same sources said Russian export organizations are trying to secure cancellations of some of their future commitments in England and that Russian exports dropped 2,000,000 bushels last week under the week preceding—a 50 per cent decline. An official at the Soviet embassy said the country's wheat supply is sufficient for home needs, with some for export.

Some statisticians compared Germany's present cereal crops with the poor years of 1924-25 and 1926-27. Whether these factors will result in the purchase of more wheat from the United States, or whether orders will go to Argentina, Canada, or elsewhere, can now be determined, grain authorities said.

MISSIONARY IS CAPTURED BY BANDITS

Nashville, Tenn., Nov. 3.—(AP)—The executive committee of foreign missions, Presbyterian church, south was advised by cable from Shanghai today that J. W. Vinson, missionary at Haichow, had been captured by bandits on Sunday. Vinson, a native of Fairfield county, S. C., was captured in a boat on the Yangtze river, and is being held in a cave in the mountains.

The cablegram from H. M. Smith of the associated missions treasurers in Shanghai, said the kidnapping occurred southeast of Haichow, but gave no further details.

C. Darby Fulton, field and candidate secretary of the executive committee of foreign missions, said a request for additional information had been called.

U. S. DEFICIT CONTINUES TO MOVE UPWARD

S. C. Presbyterians Advised of Kidnapping of J. W. Vinson Sunday.

Washington, Nov. 3.—(AP)—The government completed the first four months of the current fiscal year with a deficit of \$661,120,850.

From July 1 to October 31, the government income from all sources amounted to \$703,629,673. Expenditures were \$1,364,750,523.

A year ago, the government piled up a deficit of \$1,715,154,528 in the first four months and finished the fiscal year with a deficit of \$903,000,000.

The chief cause of decrease in income this year was the drop of \$243,000,000 in income tax collections. That tax has returned \$339,121,623 this year, as compared with \$582,262,864. Miscellaneous internal revenue produced only \$189,661,371 as compared with \$206,409,195.

General expenditures showed an increase of more than \$200,000,000, amounting to \$963,732,174, as against \$750,364,220. The Farm Board has spent \$86,383,447 in the one third year as compared with \$24,665,848.

The postal deficiency also has increased, jumping from \$40,004,582 to \$65,000,000.

Customs receipts, which increased in July, August and September, fell off in October with a total of \$35,178,422 as compared with \$39,192,247 in October, 1931. In the four months, however, customs receipts totaled \$148,000,000.

Motion for a new trial of Elmer Whitley and Rodney Cox, young Greenville men, sentenced to from 7 to 9 years each in State's prison for the highway robbery of Mrs. G. H. Ballard here during the last Christmas holidays, was argued before Judge N. A. Sinclair in the criminal term of Superior court here this morning.

Argument was completed shortly after the noon hour but Judge Sinclair reserved decision until sometime tomorrow.

Laval Receives Congratulations From Cabinet

Paris, Nov. 3.—(AP)—Premier Pierre Laval received the congratulations of his cabinet today at the end of a two-hour session during which he reported in detail on his conference with President Hoover.

The results of the trip to Washington, said a communique issued when the meeting ended, "demonstrated in particularly useful fashion the necessity of the amicable and confident cooperation of France and the United States."

The premier delayed his departure for a brief conversation with President Paul Doumer, who attended the cabinet meeting, then immersed himself in other business pending an appointment for this afternoon with Dr. Leopold Von Hoesrnch, the German ambassador, with whom he will discuss means of providing economic relief for that country.

Washington, Nov. 3.—(AP)—Riding to the sway of balloting today in five congressional districts is the thirteen year old domination of the House by Republicans.

From the results of these and other elections in a number of states, observers will seek to read political foreshadowing of events during the 1932 Presidential campaign.

Of the five special elections called to fill vacancies in the House, the outcome in two usually Republican districts is considered doubtful. They are the first Ohio and the eighth Michigan.

The Democrats, who have formed the House minority since 1918, have assailed the Hoover administration. Whatever the election results, they will be generally interpreted as the political sentiment toward the Chief Executive.

Should the Republicans return representatives from the three seats traditionally theirs, the most they could do would be to tie the Democrats at 216, as the Democrats have virtually been conceded victory in the other two districts which are normally in their column.

The present lineup gives the Democrats 214; Republicans 213; Farmer Labor one; vacancies seven. One vacancy in the fifth New Jersey district, usually Republican, will be filled December 1. It may be the decisive district, should today's elections go as in the past.

The seventh vacancy, in the first New Hampshire district, will not be filled until January 5, too late for the representative to participate in House organization when Congress convenes December 7.

The dispute in New York between Governor Franklin D. Roosevelt and Alfred E. Smith, the 1928 Democratic Presidential nominee, over a forestation amendment to the state constitution, has bothered the Democrats. Roosevelt looms as Presidential timber and Smith continues the titular party leader.

ABOUT TOWN

The courts of the nation have struck another blow in behalf of the law-abiding people.

This time it is in the case of Ralph Capone, brother of the famous Al Capone, noted Chicago gangster.

Convicted of making false statements in an attempt to compromise his income taxes, Ralph Capone was sentenced to three years in the penitentiary and fined \$10,000. He asked the Supreme court to review his case in the hope of getting a new trial.

The high tribunal failed to grant the request, and even now the jail doors are opening to receive the culprit.

The Capones and others of their ilk have dodged taxes long enough, and Uncle Sam, waging a relentless campaign against this violation of the law, determined that they must pay in full for the crime against society.

Other gangsters not nearly as influential as the Capones were watching the outcome of their attempt to lick the government, and it is needless to say action of the courts will have a salutary effect on the gang world as well as hundreds of others who have evaded income tax laws the last few years.

The series of evangelistic services is under way at St. Paul's Episcopal church, and first services of the week were attended by large crowds.

Rev. W. A. Lillyer, rector of the church began his fourth year Sunday, and it was fitting that he should have been remembered in the beginning of the series of services observing the diocesan-wide celebration of mission week.

The congregation has made remarkable progress under the splendid leadership of this devout member of the ministry, and that it will be continued in the years to come is assured.

The congregation experienced the realization of its greatest dreams during the last two years—the erection of the new building which it now occupies. It is one of the finest and best appointed structures in the diocese and has been highly praised by ministers and laymen from other sections.

The congregation and its rector are to be congratulated upon their achievements, and the entire community will join them in the first series of services held since completion of the structure.

Mayor Cermak of Illinois believes it is advisable to put out a "wet" Democratic platform to be just as wet as the candidate himself, believing this would be one of the most direct ways of gaining votes.

There are others who will disagree with the militant mayor of the Windy City, and they are the people who constitute the membership of the churches and other organizations fighting for the social uplift of the nation.

It will not be necessary for the Democratic party to put out a wet candidate to attract ballots. The period of depression caused by the Republican tariff barrier will do more to bring them votes than any one thing that has happened in years, and especially in face of the fact that the depression has resulted largely from this single action.

Mayor Cermak need not worry about the outcome of the next election. The party will not have to drench its platform in whiskey to win votes. Economic conditions have already done what a wet candidate never would be able to do.

Governor Gardner has called a conference of Governors at Charlotte November 12 in an effort to bring about an improvement in the economic and agricultural life of four states of the South.

The participating states will be North Carolina, South Carolina, Georgia and Virginia. The bulk of bright leaf tobacco is raised in these four states as well as a considerable amount of cotton and the governors will try to work out a plan to save the two crops from

the ruin of slumping prices.

Other states in the cotton growing regions have agreed to reduce crops the next two years, but North Carolina has taken no definite action along this line, hoping probably to be able to accomplish something tangible during the Charlotte meeting.

The four states involved will watch the conference with interest, ardently hoping the governors will be able to reach some decision whereby the economic condition may be improved. It is a stupendous task the officials have taken upon themselves, but one that is bound to be shouldered if the states are saved from the ruin so sure to follow with continued low prices for the main crops.

Two severe lives were taken by violent death in the South over the week-end, it was reported by press dispatches yesterday afternoon.

Twenty-two of the deaths resulted directly from automobile accidents. It was the heaviest toll taken on the highways of the Southland in several months, although from six to a dozen deaths occur each week-end.

The heavy toll of life and property brings us to the realization of the necessity of more education concerning the danger encountered on the highways of the nation. The people must be more forcefully impressed with the peril confronting them on every hand, and made to realize that careless or reckless driving not only jeopardizes their own lives but hundreds of others.

If everybody would observe traffic laws and regarding the prerogatives of the other fellow in this connection the weekly toll of death would be greatly reduced.

It is to be hoped every community will begin an educational drive against the continued loss of life on the highways, and in that way attempt to save the hundreds who find their way to untimely graves through accidents.

FARM NOTES

By E. F. ARNOLD, County Agent

Pitt county farmers have an abundance of feed this year and would do well to consider the possibility of increasing the value of this feed by giving same to livestock.

A good cow will pay \$1.20 per bushel for corn, 90c for oats, \$20.15 per ton for legume hay and \$2.00 per month for six months for good pasture, and in addition will pay for all cottonseed meal and wheat bran consumed at market price, when butterfat is only bringing 30c per pound. It is also interesting to note that hogs will pay 67c per bushel for corn at the present low price of 5c per pound for hogs. Some of our farmers are taking advantage of this situation to increase the value of feed grown this summer.

J. E. Winslow has between six and seven hundred hogs on his farms and some two hundred and fifty cows. He also has a flock of some six hundred hens. He is using livestock of this kind for the purpose of enhancing the value of large yields of feed crops on his farm this year. He has a sorghum mill running day and night and will make some eight thousand gallons of molasses this year.

Mr. J. C. Parker reports that he has received in the neighborhood of \$1,000 from his orchard, hogs and poultry and that each has made a good profit this year. He states that he will do well if he is able to break even on his cotton and tobacco. The income from his orchard, poultry and hogs was all produced on the farm and did not require other labor than that of his own family.

I have interviewed a large number of farmers and all of them state that pasture lands this year have paid well and that their intentions are to increase acreage along this line as well as the amount of livestock carried.

Some 50,000 bushels of sweet potatoes will go into curing houses this year in Pitt county. Nine new curing houses have been put into operation this fall. PUTS CHARGES BEFORE COURT

President Hoover Selects Committee to Hear Gardiner Allegations.

Washington, Nov. 3.—(AP)—The committee named by President Hoover to investigate the truth of statements by the Navy League regarding its naval policy ran into difficulties today at the outset.

John Hays Hammond, one of the members, could not be found. Two other members let it be known that they would not accept the chairmanship.

Assistant Secretary Jahncke of the navy, torn between loyalty to the president and long activity in league activities, will not have it. Undersecretary Castle of the State Department considers himself too close to Mr. Hoover.

The two other members, Admiral Hugh Rodman, retired, and Elliot Wadsworth, of Boston had nothing to say about the committee work.

The absence of Hammond prevented the formulation of immediate plans for a meeting. His home here knew nothing of his whereabouts. His New York office also was said to be uninformed.

The group will seek a "neutral place" to hold its sessions, to avoid appearing unduly influenced by administration or naval amendment sentiment.

Washington, Nov. 3.—(AP)— On the hastily hewed bench of a five-man court rests President Hoover's contention that the spokesman of a big-navy group spoke falsely and should apologize.

So swiftly did the President act, after receiving a membership list of the Navy League late yesterday, that not until today could the chosen committee lay plans for placing on trial disputed statements by William H. Gardiner, president of the league.

The five men named are Assistant Secretary Jahncke of the Navy; John Hays Hammond, retired mining engineer, and Elliot Wadsworth, of the President's emergency relief committee, all of whom were listed as members of the Navy League. The two non-league members are Undersecretary Castle of the State Department and Admiral Hugh Rodman, retired.

Their inquiry, a statement from the White House said, must be "solely into the assertions of fact" made by Gardiner, and not into his "opinions or conclusions."

The league president had accused Mr. Hoover of an "abysmal ignorance of why navies are maintained." The league pamphlet, under statements, too, which could be classed as opinions or conclusions.

Just about the time the President was pondering over his committee, Secretary Adams injected his views into the controversy for the first time. Earlier in the day he had conferred with Mr. Hoover.

Adams charged Gardiner with descending "from the high plane of dignified discussion to that of personal attack upon the commander-in-chief of the Navy, the President; a procedure which I deeply resent."

"Without going into details," he said, "I take the liberty of saying the pamphlet is full of misleading statements."

There is considerable speculation as to just how far the five-man court named by the President will go. For one thing, it was directed specifically to examine the accuracy of such statements by Gardiner "as may be reading determined from departmental records."

In addition, it was warned away not only from Gardiner's opinions and conclusions, but also from "budgetary or general policies of the navy."

"With my appreciation to those who have encouraged me to become a candidate, there goes also the assurance that my interest in the causes to which we are jointly committed will continue active and unabated. I invite them to share my confidence that my service in that respect will not be the less effectual by disassociating it from a personal ambition to become governor."

The attorney general was in Washington yesterday, and the statement was issued from his office in Oxford. He is expected to return here within a day or so.

Friends both here and in Oxford were at a loss, they professed, to explain Mr. Brummitt's decision, as he had been generally considered a "sure" candidate.

Joseph Daniels, former secretary of the navy and editor of the Raleigh News and Observer, had little comment to make, although the attorney general's announcement re-focused the attention of political observers upon him. Several weeks ago it was generally reported the editor, champion of a sales tax to relieve property during the last Legislature, would probably run, and this report was revived when Mr. Brummitt declined to file out a questionnaire for the primary.

Lieutenant governor R. T. Fountain, J. C. B. Ehringhaus of Elizabeth City, and A. J. Maxwell have already announced.

Mr. Daniels in an editorial in this morning's issue of his paper said the attorney general's statement came as a "surprise" and would be regretted by the people of the state.

Mrs. G. H. Ballard testified at the initial hearing of the robbery charge that \$4,200, which she alleged was taken from her during the Holdup, constituted all of her earthly possessions.

Since that time, however, it was discovered that she had over \$6,000 in a safe deposit box in a Wilson bank. The box was ordered seized by the court and the key placed in the hand of the clerk of court until final settlement of the case.

This evidence, attorneys for the defendants contend, throws an entirely new light on the case and entitles them to another hearing.

Whitley and Cox, although remaining in jail several weeks after conviction, were later released under bond.

A selective sales tax has been considered by the Treasury, but a decision is yet to be made, as against \$134,251,676.

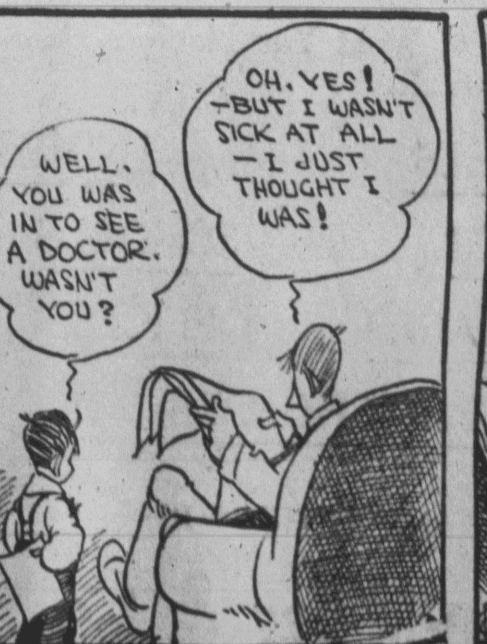

FIRE DESTROYS SCHOOL HOUSE

Fleming's School Building Burned to Ground Last Night; Was not Being Used

Fleming's schoolhouse, on the north side of Tar River, was completely destroyed by fire last night about 8 o'clock, according to information reaching the city this morning. The loss was estimated at \$1,000.

The building, a two-room wooden structure, was not being used this year, the pupils having been transferred to Belvoir consolidated school under the reorganization program brought about through passage of the new school legislation.

Although the cause of the fire had not been determined, it was believed to have been of an incendiary origin.

The fire caused considerable excitement throughout the community, and scores of people hurried to the school grounds to render assistance, but the building was doomed when they arrived.

Think Automotive Industry Will Be Prosperity Leader

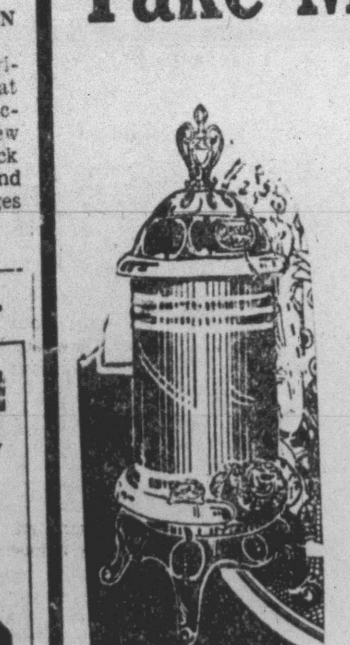

Improvement Noted in U.S. Business Area

Washington, Nov. 3.—(AP)—Improved business conditions in many sections of the world today brightened reports to the Commerce Department. The weekly review of cables and radiograms recorded stronger general tone of markets and sentiment

in Great Britain since the abandonment of the gold standard; better export conditions in Egypt during August and the unusual situation of a favorable trade balance for Italy during September.

Some sections of South America showed improvement. Higher cereal prices and better exchange conditions caused improved feeling in the interior of Argentina. Fundamental conditions in Chile were strengthened by the continued favorable trade balance although industrial activity was slow, retail trade inactive and the credit position strained.

Better movement of merchandise was found in Mexico, but the industrial position remained weak. There was further seasonal improvement in Quebec, British Columbia and the Prairie provinces of Canada where the steady rise in grain prices has created a more optimistic tone.

Seek Rehearing for Ralph Capone

Washington, Nov. 3.—(AP)—Undaunted by the refusal of the Supreme court to listen to the plea of Ralph Capone for a review of his income tax case, his counsel gave notice today they probably would ask for a hearing.

They asked the court to delay the mandate under which the brother of Al Capone would be committed to jail so that they might file a petition for rehearing.

Yesterday the Supreme court refused to review his sentence for three years in the penitentiary and a fine of \$10,000 for making false statements in an attempt to compromise the government's income tax claims upon him.

The court is not in recess and a petition for rehearing could not be submitted until November 23, to be acted on the following Monday, November 30. Should the stay of mandate be granted, Capone under

these circumstances would be assured that he could remain at liberty under bail until the end of the month.
