JAPS DEMAND RECOGNITION OF TREATIES

Draft Note to League Insisting that China Recognize Validity of Pacts.

Tokyo, Nov. 4.—(AP)—While its troops moved farther into Manchuria and encountered Chinese machine guns in one instance, the Japanese government tonight began drafting a note to the League of Nations insisting that China recognize the validity of treaties under which Japan operates in the Chinese territory.

The Japanese note will be in reply to that of Aristide Briand, acting president of the League council, setting forth his views regarding the five fundamental principles to which the Tokyo government previously had asked China to subscribe as a prerequisite to the withdrawal of Japanese troops from the Manchurian occupied area.

Tokyo will contend that one essential point must be China's recognition of the 1915 treaty under which Japan was given certain rights in Chinese territory.

China contends that this treaty, originating out of the "twenty-one demands," was signed by the Chinese under duress and therefore illegal. Japan maintains that the treaty was legitimate and binding and as nearly perfect as numerous others not in effect.

It was understood here that Briand had suggested Japan should agree to the Chinese proposal to refer existing Sino-Japanese treaties to the Hague for adjudication. This Tokyo considers improper and unfair.

Regarding the League council's insistence upon withdrawal of Japanese troops from the occupied zones in Manchuria, the Tokyo government holds that unconditional withdrawal would mean a return to the previous unsatisfactory and unsafe status quo and an opening of the way for the return of the "irresponsible authority" of Chang Hsueh-Liang, governor of Manchuria under the Chinese regime.

Japan believes Chang's return would mean the presence of "trouble" troops—an intolerable prospect from Tokyo's point of view.

The Japanese government is keeping the League informed of all troop movements in Manchuria, particularly outside the Japanese treaty zone of the South Manchurian Railway.

A detachment of Japanese troops advancing to the Nonni River bridge south of Taitshar, strategic city in northwestern Manchuria, was reported to have encountered machine gun fire from an independent Chinese army commanded by General Mah Chan-Shan.

Mr. Brummitt was in Washington when the statement in which he announced he would not seek the Democratic nomination as governor was issued and only returned to his offices here today.

Cox and Whitley Are Granted New Trial Here Today

Rodney Cox and Elmer Whitley, young white men of this city, who were sentenced to from 7 to 9 years each in the penitentiary for the highway robbery of Mrs. G. H. Ballard during the last Christmas holidays, were granted a new trial by Judge N. A. Sinclair, of Fayetteville, presiding over the criminal term of Superior court here today.

Motion for a new trial was argued before Judge Sinclair yesterday morning, but decision was reserved until today.

The defendants appealed to Supreme court following their conviction, but several days ago the high tribunal upheld the action of the lower court.

In vacating the judgment of the former court, Judge Sinclair stipulated that the defendants would be given trial at

some subsequent term of court, although no specific date was set.

The motion for the new trial was based on evidence which attorneys for Cox and Whitley obtained since their trial and conviction here last April. At that time Mrs. Ballard, who contended that \$4,200 which she alleged was taken from her during the holdup, was all the money she had in the world.

In an investigation this summer it was discovered that she had over \$6,000 in a safe deposit box in a Wilson bank. The court ordered the box seized and the keys placed in the hands of the clerk of court until settlement of the charge. Mrs. Ballard contended that this sum belonged to a relative, Whitley and Cox have been out under bond for the last several months.

TWO INJURED IN ACCIDENT

Mrs. N. S. Tyson and Dan Calhoun Hurt as Oil Truck Hits Car Near City.

Mrs. N. S. Tyson was painfully injured when the car in which she was riding was struck by a Sinclair Oil Truck on the Greenville-Farmville highway, about three miles from Greenville, late yesterday afternoon. Dan Calhoun, driver of the truck also received minor injuries.

Mrs. Tyson's baby escaped injury when it was thrown clear of the car.

Mrs. Tyson was rushed to the hospital in an unconscious condition but was reported to be getting along all right today, although still confused from shock of the crash.

The accident occurred as the truck attempted to pass the car driven by Mrs. Tyson. Seeing a horse-drawn vehicle approaching from an opposite direction, the driver was said to have attempted to again get on his side of the road when he collided with Mrs. Tyson's car.

Both truck and automobile were badly damaged by the impact. Calhoun was carried to the hospital for medical attention. His injuries consisted mainly of bruises.

BIG RALLY ON ARMISTICE DAY

Legion to Observe the Closing of World War with Appropriate Celebrations.

Dismiss Suit Against Mouzon

Charlotte, Nov. 4.—(AP)—Another echo of the rumblings within the Methodist Church after the 1928 presidential campaign was cleared from the Federal court docket here with dismissal by Judge E. Yates Webb of the \$50,000 libel and slander suits brought by Rev. Rembert Smith of Sparta, Ga., against Bishop Edwin D. Mouzon.

The case was ordered dropped when attorneys for the Georgia minister failed to complete within the regulation 90 days their appeal from an adverse decision rendered by Judge Webb at a hearing in Asheville last July.

Mr. Smith based his charges against the bishop on remarks made at the church's general conference in Dallas in 1930, when Bishop Mouzon was alleged to have referred to the Georgian as an "honest but eccentric minister."

The court held the statement not libelous or slanderous.

NEGRO GIVEN TERM IN PEN

Two White Men are Released Under Suspended Sentence on Assault Charges.

Convicted of second degree murder in connection with the slaying of a negro by the name of Black several months ago, Simon Watson, colored, of the Bethel community, was sentenced to not less than ten nor more than 15 years in the penitentiary in the criminal term of Superior court here yesterday.

The case occupied most of the afternoon session, but two other actions were disposed of before adjournment for the day.

Edgar Breedlove and Reid Little, two young men of the Rocky Mount section, pleaded guilty to a charge of attempted criminal assault upon two young women living in the upper section of Pitt county during the summer, and were released upon payment of cost with a suspended sentence hanging over their heads.

The alleged attack was said to have taken place while Breedlove and Little were bringing Misses Bettie and Bertha Little home from the Rocky Mount district where they had been teaching. The young women reported they had received rough treatment at the hands of the men, who were arrested, brought to Greenville and placed in jail.

They were later released under \$5,000 bond each pending final disposition of the case in Superior court.

Dave Smith, colored, convicted of a charge of manufacturing liquor, but sentence was not pronounced.

N. C. Man Dies At Hollywood

Los Angeles, Nov. 4.—(AP)—Robert Williams, who ran away from his North Carolina farm home when 11 years old to trade the path from tent show to Broadway and Hollywood, died last night of peritonitis following an appendicitis operation.

The young state motion picture actor was rehearsing for a picture with Constance Bennett when he was taken ill. He first came to Hollywood to play his original stage role in the screen version of "Rebound."

He made his first Broadway appearance with Marjorie Rameau in "Eyes of Youth," later appearing in "Able's Irish Rose," "The Trail of Mary Dugan," "Love, Honor and Obedience," "Friendly Enemies" and "Trade Winds."

On leaving North Carolina with the tent show he turned to Mississippi show boat work and midwest stock companies before rising to Broadway.

His wife was the former Nina Penn, New York actress.

CONVICT DIES IN ATTEMPT TO MAKE ESCAPE

Five Others Get Freedom at Caledonia as George Cashwell is Killed.

Raleigh, Nov. 4.—(AP)—George Cashwell, convict sent to state's prison from Alamance county, was shot and killed late yesterday at Caledonia prison farm, it was announced at state's prison today, and five other prisoners escaped as six men working in a field attempted to gain their freedom.

Two of the five who escaped were serving terms of 22 1/2 years each for murder, C. C. Cranfield of Forsyth, and Varnell Gates of Haywood, and neither has been in the prison six months.

The six men were working in the same squad, Capt. N. E. Raines, Caledonia supervisor, reported, and apparently in a pre-arranged plot three suddenly broke for woods in one direction and three in another.

Guards immediately opened fire when it was seen that a concerted effort to secure their freedom was being made by the six prisoners. Cashwell was fatally wounded.

This morning Captain Raines reported the other five were still free but said he believed that a posse (Continued on Page Three)

MOVE TO STOP BEAR RAIDING

Chicago Board Trade Perfecting Machinery for Improving Conditions.

Washington, Nov. 4.—(AP)—The perfecting of machinery capable of combating bear raids in the grain markets was reported to President Hoover today by delegates from the Chicago Board of Trade.

President Hoover in July charged that bear raids of grain speculators were depressing prices and causing farmers to lose profits they otherwise would have gained.

Silas Strawn, president of the Chamber of Commerce of the United States, who accompanied the group today, said the president appeared satisfied with the steps being taken by the business conduct committee of the Chicago Board of Trade to halt the bear raids.

"The president asked us to come down and talk over this matter with him," Strawn said. "We have no quarrel with the president about it."

"Mr. Hoover did not criticize short selling. That sometimes is necessary and has to be. What he did criticize was bear raiding and we assured him we had a machine that would turn over to combat this when necessary."

DEMOCRATS GIVEN BIG BOOST BY VICTORY IN ELECTION IN MICHIGAN

Democrats Virtually Win Control Of House

Washington, Nov. 4.—(AP)—The Democratic push begun last November, attained greater proportions in yesterday's election to virtually shove the party into control of the next House of Representatives and reclaim the governorship of New Jersey.

The revolt of district 8 in Michigan, abandoning Republicanism for the first time since 1898, gave the Democrats a house majority of one and with it the best chance for control in 13 years.

ALSO WIN IN OTHER AREAS

Democratic Mayors Elected in Several Cities Formerly Ruled by Republicans; Fail Shake G. O. P. from Control of N.Y. Legislature; Roosevelt Programs Wins; Hart Victorious in Eighth Michigan District.

Louisville, Ky., Nov. 4.—(AP)—Judge Ruby Laffoon, Democrat, led Mayor William B. Harrison, Republican, by 2,051 majority on reports from 71 of Kentucky's 4,178 precincts as the count got underway today of yesterday's gubernatorial race. The totals were: Laffoon 7,577; Harrison 5,526.

The chances of the Democrats controlling the next House of Representatives received a boost in yesterday's election from an unexpected section—the rock-ribbed Republican eighth Michigan district.

On another sector—the state of New Jersey—the Democrats dug deeply into Republicanism, electing a governor and, on the basis of incomplete returns, captured the State Assembly.

In a lesser degree the Democrats were successful in other sections, electing several mayors in cities which have been under Republican regimens. They failed, however, to make the Republican party from control of the New York State Legislature. The Democrats lost three seats and gained the same number.

In New York State, too, Governor Franklin D. Roosevelt's personally sponsored reforestation amendment won without difficulty. Former Gov. Alfred E. Smith had opposed it, though the amendment was supported by Tammany Hall.

Tammany scored almost complete victory in New York City, re-electing Borough President Tevy and other of its candidates to major offices. It was, notably unsuccessful, however, in the "silk stocking" 15th assembly district where it failed in its vigorous effort to unseat Abbott L. Moffat, Republican, as assemblyman. Moffat is a member of the Hofstadter joint legislative committee which is prying into New York City affairs.

In this same "silk stocking" district Republicans re-elected Minority Leader Baldwin to the board of Aldermen. The Republicans appear, however, to have lost their three other representatives.

The Democratic victory in the eighth Michigan district—where the late Congressman Fordney served for so long as an exponent of the principals of Republicanism—was Michael J. Hart. He campaigned as an advocate of prohibition modification, defeating Foss O. Eldred, Republican, who did not stress prohibition. The fact that he is a resident of Saginaw, which long has been the home of congressmen from this district, led many to believe that party lines gave way in some instances to the desire to maintain the Saginaw tradition.

The congressional seat made vacant by the death of Nicholas Longworth went to another Republican, John B. Hollister. The strongly Republican second Pennsylvania district (Philadelphia) went, as had been expected, to Edward L. Stokes, Republican. The Democratic New York seventh went to Joseph L. Delaney, and another Democrat, Martin L. Sweeney, took the congressional seat from the twentieth Ohio district by a wide margin of votes.

In Cleveland, Ohio, the city manager form of government which has withstood repeated attacks, appeared finally to have bowed to its critics.

Detroit re-elected Frank Murphy mayor by one of the largest votes ever given a mayoral candidate.

Kentucky will not know until late today who was elected governor there, as the count of votes, under the state law, was not to start until this morning. The voting was unusually heavy, the conduct of the highway department being the major issue between Judge Ruby Laffoon, Democrat, and Mayor William B. Harrison, Republican, of Louisville.

U. S. BUSINESS IS IMPROVING

Several hundred Men to Go Back to Work in Harvester Company Plants.

(By The Associated Press) Chicago—Several hundred men will be back at work by the end of the week in plants of the International Harvester Company, which has resumed active operations in all of its United States and Canada factories. Wages range from 10 to 20 per cent under former rates.

BRITAIN BUYS FREELY IN U.S.

United Kingdom Supplies Canada As America's Best Customer in September.

Washington, Nov. 4.—(AP)—The United Kingdom supplanted Canada as America's best customer in September, purchasing \$34,589,023 in American goods as against \$28,001,653 for the dominion.

Both the export figures, however, showed sharp declines from the same month last year when the United Kingdom took \$57,845,532 and Canada \$51,978,595 in American shipments.

Commerce Department reports today gave the United States a favorable trade balance for September of \$9,853,581 and showed trade with Asiatic countries holding up better than those on other continents.

Imports from Great Britain were \$13,379,213 in September compared with \$17,017,363 and from Canada \$21,927,618 against \$32,522,475.

Shipments to Russia continued to hold up well, amounting to \$10,500,292 against \$4,923,093.

Posey Case Nears The Jury Stage

Bryson City, N. C., Nov. 4.—(AP)—The case of Ben Posey, 23 charged with murdering Judd Pilkington, 45 after a dispute over advances made by Posey to Pilkington's daughter, was expected to get to a jury in Swain county superior court today.

Posey testified yesterday, after the state had rested, that he had been avoiding Pilkington for some time prior to the fatal meeting, and that he fired at the elder man only after he himself had been fired at on a lonely mountain road.

Posey, who fled to Seattle, Washington, after the shooting, said he had been informed a warrant had been drawn against him charging criminal assault on Pilkington's daughter, and swore he knew Pilkington as a "violent and dangerous" man.

State's witnesses testified Posey fired from ambush after Pilkington, seeing him hiding behind rocks along the road, had fired first. The state announced it sought to show Posey was waiting with intent to slay the elder man.

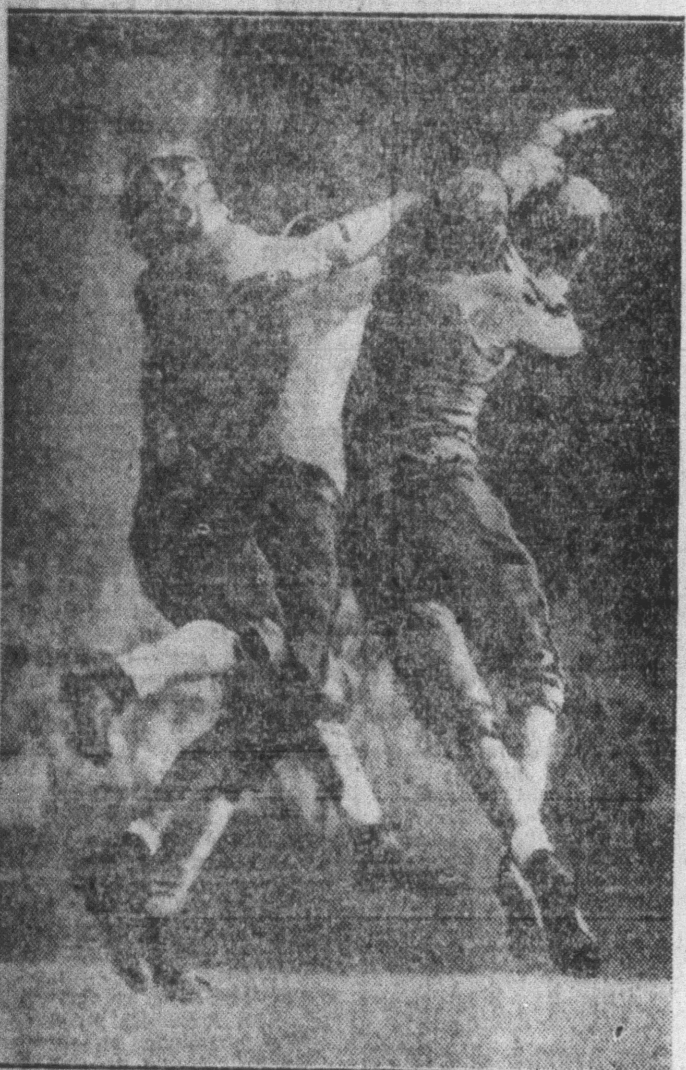

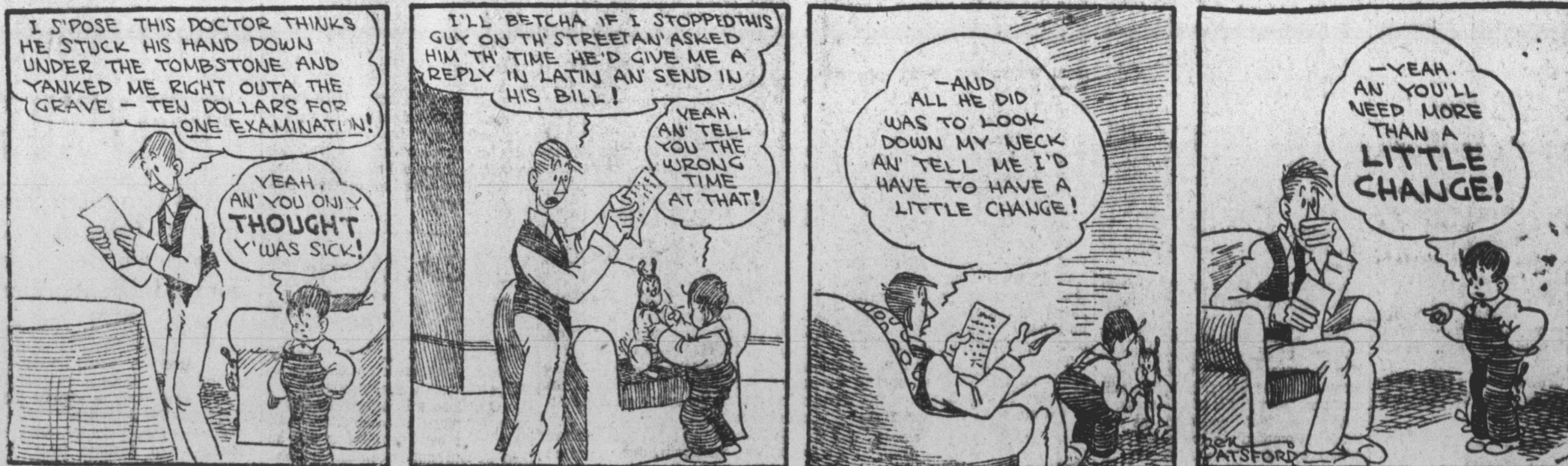

Prison records showed Cashwell to be 22 years of age. He reported that his father, Robert Cashwell, lives at Abbottsburg, N. C., and that his widow, Mrs. Mamie Cashwell, lives at Hasty, S. C.

Cashwell was sent to prison in February, 1930 to serve four years for bigamy.

"Nowhere did the Democrats lose anything they had held, while the Republicans lost the eighth Michigan seat in the House of Representatives which has been theirs for 30 years, and in addition lost one governorship—in New Jersey—certainly, another probably in Kentucky, where under the state law the count is not made until the day following the election.

"The majority of the House of Representatives is definitely Democratic now, and I think we are safe in assuming that any changes in that line-up will be merely in the direction of further Democratic gains.

"In short the picture shows that the trend away from the Hoover administration, which was so marked in the election of 1930, continues and so gives a clear indication of what may be anticipated for the national election of 1932."

In addition, Shoups said, the Democrats continued to hold all the important majorities where where Democrats have been in office and in addition "have gained many and councils in various cities, notably in New York, Connecticut and Massachusetts, which have been under Republican rule."

Senator Fess of Ohio, chairman of the Republican National committee, made the following comment on the election:

PLAN BETTER COTTON DRIVE

Movement for "Quality Cotton" Started by Leading Farm Organizations.

New Orleans, La., Nov. 4.—(AP)—The prospect of sharp curtailment of cotton acreage in the south next year as a price stimulant has brought about a new movement for "quality cotton."

Officials of the American Cotton Cooperative Association and United States Department of Agriculture experts have announced plans for an intensive drive to better the product in the southeastern states. The campaign is to be shaped through the county agents.

The movement has already been started in Texas and Louisiana and the experts have outlined the plan for Mississippi at a conference in Jackson. Other conferences are planned at the state universities of Georgia and Alabama and in the cotton growing sections of the Carolinas.

The program contemplated is a one variety project designed to establish a certain cotton staple in a certain section and to maintain its production there year after year by pure seed and standardization in ginning to prevent mixing staple lengths.

sey gubernatorial race, the Democratic candidate went to the polls in search of a rebuke to the national Republican administration.

Another strategic position, the first Ohio congressional district represented so long by the late Nicholas Longworth, remained in the Republican column by a substantial vote after a campaign fought on local issues.

In New York, where the controversy of Governor Franklin Roosevelt and the former Governor and Presidential nominee, Al Smith attracted national-wide interest because of the personalities involved, Roosevelt won a sweeping victory. The dispute centered upon a Roosevelt sponsored amendment to the state constitution providing for public reforestation.

Over the elections hung the omnipresent shadow of prohibition, and to the opposition went the fruits.

Each of the five new Congressmen elected in the day's voting—three Democrats and two Republicans—travel under the standard of either the repealists or the modificationists. In three years, the net bloc in the House has grown from less than 70 members to about 150 now.

Unless the congressional situation changes again in the short time between now and the first Monday in December, when matters start up on Capitol Hill, it practically assures that President Hoover will have during the remainder of his term a politically hostile House.

Also, it foreshadows the election as speaker of Republican Garner of Texas, and designation of southern Democrats to chairmanship of many powerful committees.

Turnover of the organization at the same time would give the Democrats benefit of the tradition they have quoted so often, that a shift of power in Congress in an off-year is prophetic of a change of administrations.

The lineup now is Democrats 217; Republicans 215; Farmer-Laborite one; vacancies 2.

One vacancy in the fifth New Jersey district traditionally Republican, is to be filled before Congress convenes, but the other—in New Hampshire—will remain vacant until January.

Dashiell, who formerly lived in Hollywood, said his information came first hand and from friends in the movie colony.

"Psychologists have long classed adults who are only 12 year old mentally, as morons."

The Violets of N. Y. U. have labored greatly to overcome the defects shown in their defeat by Oregon Saturday. And the Georgia team, at Athens, was cheered by news that Captain Anshel Downes, and Backfield-Star Homer Key, he who made two touchdowns against Yale, will be in the line up for the Violets.

Louisiana State goes northward with the threat of Coach Russ Chan to put some "60-minute scrappers" in the lineup against Army. L. S. U. lost to Sewanee in last week's big upset, and the squad probably will be severely shaken before another lineup is put on the field.

The Cavaliers of Virginia make their second straight trip northward Saturday, this time playing Columbia at New York. Last week the Cavaliers were defeated by Harvard.

Georgia Tech's reserves are not as plentiful as the Golden Tornado's coaches desire, so a system of training linemen to play two or three positions has been installed. For instance, if a guard is injured in the game with North Carolina, Captain Neblett will move from center to that guard's place and a reserve center will be hurried into the breach.

The Tar Heels spent most of yesterday's practice on signals, passing and punting. Vanderbilt and Maryland, opponents in what probably will be the feature southern conference game this week-end, have non-scouting agreement, and the Commodores worked yesterday without the knowledge of at least some of the old line plays. The Commodores concentrated on the offense.

Auburn, billed against Tulane, suffered a terrific blow in the loss of the heaviest man on the squad—Mark Holmes, 240-pound tackle. Holmes was operated on for appendicitis yesterday.

Alabama, looking at the forthcoming game with Florida with a great deal of caution, went through a rough workout. The sign pointed to the same backfield that managed to beat Kentucky by a two-point margin taking the field against the Gators.

Two Teams In Way Of Final Moccasin Win

Atlanta, Nov. 4.—(AP)—Andy Moore's Chattanooga Moccasins, Southern Intercollegiate Athletic Association football champions in 1928 and 1929 and now leading the current title hunt, must hurdle Mercer and Centre in a row to claim the 1931 flag.

This admittedly is one of the hardest assignments given any southern team this year. Until Saturday, Mercer, with its strongest team in years, led the S. I. A. A. with five successive wins. A field goal gave Centre a 3-0 victory over the Bears and established the Praying Colonels as a real threat.

Chattanooga expects a romp Saturday with Transylvania but Mercer and Centre will force the Moccasins to the limit to win.

Kentucky fans are already talking in terms of a championship for the Danville team if it can get past Chattanooga. Centre will be a heavy favorite over its other association foes, Georgetown, Transylvania and Louisville.

The Chattanooga games with Centre and Mercer also will have direct bearing on the championship in the Dixie conference, composed of nine S. I. A. A. teams, and now on its first season.

Chattanooga now leads with two conference wins while Centre has one. Southwestern also has won one game but also has a tie game with Howard.

A leaflet containing characteristic photographic flashbacks on the life of Rockne, a repetition of his record and tributes to it, was distributed with the program.

There were no ceremonies. Notre Dame said it with touchdowns after some early trouble getting into motion. That was what Knute himself would have preferred.

It was a deadly serious business however, for those ten young men on the sidelines, Senior Coach Hunk Anderson and Junior Coach Jack Chevigny.

There isn't much relaxation for them in the task of carrying on. They have great material to work with. Everybody knows it and for that reason will expect a great deal to be accomplished.

The inspiration of Rockne's memory, it seems obvious, will have no beneficial effects unless the boys know and carry out their blocking assignments properly.

Moreover, it may become increasingly apparent as the season progresses that all the brain work can't be accomplished from the sidelines.

The development of a first string quarterback with anything approaching the all-around qualifications of Frank Corde, All-American star of 1929-30, is the most difficult task in Notre Dame's camp.

Replacing ball carriers and blockers like Brill, Savoldi, O'Connor and Mullins is far from easy, but it's a cinch with all the talent at South Bend this year, compared to the job of locating another little Napoleon.

Wabash Blues
Pat Page, as a parting gift, left Indiana university one of its toughest gridiron schedules, starting off with Ohio U. and then Notre Dame, followed after a week's rest by engagements with Iowa, Chicago, Ohio State, Michigan, Northwestern and Purdue.

That's six successive Big Ten conference games, including the 1930 co-championship teams on successive week-ends, for the new Crimson mentor, E. C. (Billy) Hayes, who has succeeded Page at Bloomington.

Indiana has a good looking squad with two sets of fast backs, but it will be lucky to win one or two of its remaining games.

Hayes has already made progress. His boys gave Notre Dame a good argument, at least for the first half, before yielding to superior manpower and the heat.

They may surprise some of the conference favorites. Vic, the elder of the Dauer brothers, both quarter backs, looks like a real triple threat.

Giant Killer
The talk of the early gridiron campaign, conflicting as it has been doing with the world's series, is Ship Madigan's double-barreled blast with St. Mary's out on the coast against Southern California and California.

Notre Dame men with whom I talked at Bloomington were especially interested in Madigan's early and sensational successes.

They pointed out that Madigan was an product of the same Notre Dame football class as "Hunk" Anderson, the 1919 group that first attached fame to the Rockne regime.

The late George Gipp was in the same outfit.

"Bat" Battalino to Fight Mastro

Chicago, Nov. 4.—(AP)—Bat Battalino, the busy boy from Hartford, Conn., risks his prized world's featherweight crown against the flying fists of the dangerous Earl Mastro in the punch bowl of the Chicago stadium tonight.

As the hour approached for their 10 round battle, which promised to be a stirring struggle between force and science, the betting windows swung so furiously that it was impossible to distinguish the favorite. Backed by his Chicago friends, who have watched his rise to power in the featherweight world Mastro held the champion at least even in the heavy wagging.

The battle stretched the imaginations of Chicago's fight rials and else of 17,000 were expected to watch the first Chicago fighter in 37 years take a shot at the crown. Battalino has successfully protected since he captured it from Andre Routis of France in 1929.

From the standpoint of sheer punching ability, the champion was given a wide edge over the challenger. But Mastro's hopes rested in his ability to outpoint Battalino, a task possible for him to do by a wide margin unless the champion is at his best. In his fights since he started out only five years ago, Mastro has more than made up for his lack of punch by a whirlwind attack that gave him victory after victory on points.

Battalino, always a great champion when his title is at stake and a poor one when there is no title to risk, was confident of making Mastro look like just another challenger. He finished his workouts leisurely and was expected to make the limit of 126 pounds without any difficulty. He outmeasured Mastro in almost every way physically although only a pound of flesh separated them on the scales.

Market Report Cotton--Stocks--Grain

N. Y. COTTON

New York, Nov. 4.—(AP)—Cotton opened steady today at a decline of 2 to 10 points on liquidation and southern selling. Trading was quite active, and December sold off to 6.47 and March to 6.72 in the first few minutes of trading.

There was trade buying and covering which absorbed the early offerings, but prices worked off to about 6.47 for December and 6.69 for May or 11 to 13 points net lower on the active position. This decline brought in a little more trade buying, but prices were within 2 or 3 points of the lowest at the end of the first half hour.

Liverpool cables were relatively steady and there was some Liverpool buying here, but local traders paid very little attention to the fluctuations abroad. Private cables reported hedging and liquidation absorbed by Bombay buying in the Liverpool market and said there was a fair business in cotton cloths for the British home trade and the Argentine.

A private crop report was published, placing the indicated yield at 16,748,000 bales and ginnings prior to November 1 at 11,612,000 bales.

STOCK MARKET

Chicago, Nov. 4.—(AP)—Late rallies hoisted wheat prices more than 3 cents a bushel today from a low point touched early. The upturn swept the market to well above the season's previous highest quotations. Insistent buying which sprang up after declines accompanied expression of belief on the part of trade experts that Europe was becoming more and more dependent upon imported wheat, the remainder of this year, and that the only material source of new supplies was in North America. The drought affecting 1931 fall shown domestic wheat southwest was also a bullish factor.

GRAIN MARKET

New York, Nov. 4.—(AP)—The securities markets displayed a persistent inclination toward higher levels today, despite a morning setback in shares.

Oils and coppers pulled the stock market out of a mild slump after midday and bonds worked almost steadily higher, the Argentine issues recording the best levels in weeks, presumably as a result of improvement in wheat.

In shares, rails and a few miscellaneous industrials weakened after a higher opening. Rails remained rather sluggish, but morning losses of a point or two in such industrials as American Telephone, American Can, Allied Chemical and Johns Manville were soon recovered. U. S. Steel held fairly steady. In the afternoon gains of 1 to 2 points appeared in such coppers as Kennecott, American Smelting and Cerro de Pasco, and oils were generally up fractionally, Phillips rising a full point. Trading was in light volume. Ward Baking preferred jumped 9 points.

Speculative quarters showed some disappointment over the news that the union employees of Canadian Railways had declined to acquiesce in a proposed voluntary wage reduction of 10 per cent, but the decision of the heads of the American Railway Brotherhoods to invite railway executives to a conference to discuss wages in connection with unemployment was regarded as encouraging evidence of a conciliatory attitude.

The weekly report of freight car loadings showed a somewhat larger than seasonal gain, and the report of electric power consumption was a little more favorable than last week's.
